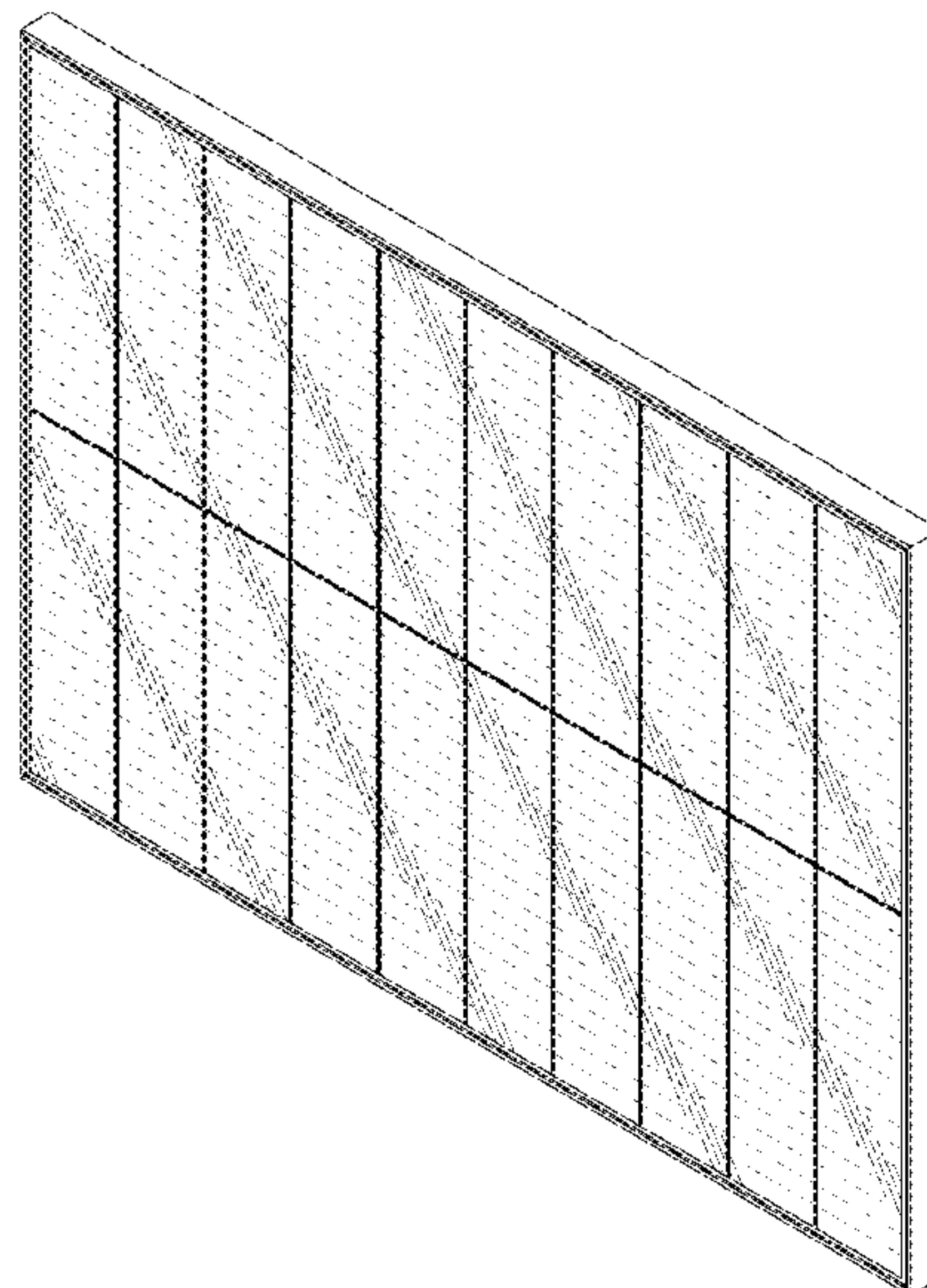
The ornamental design for solar module, as shown and described.

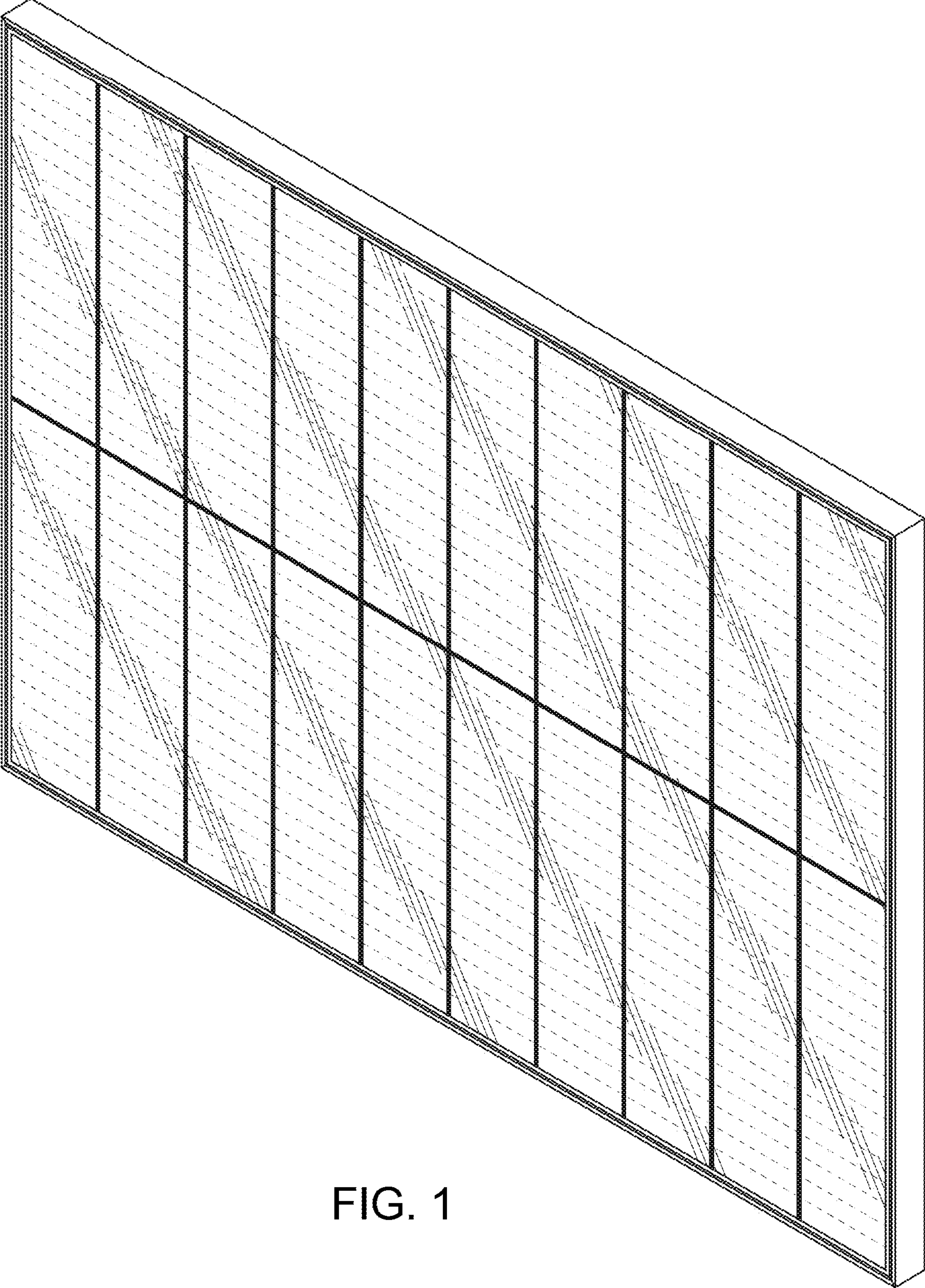

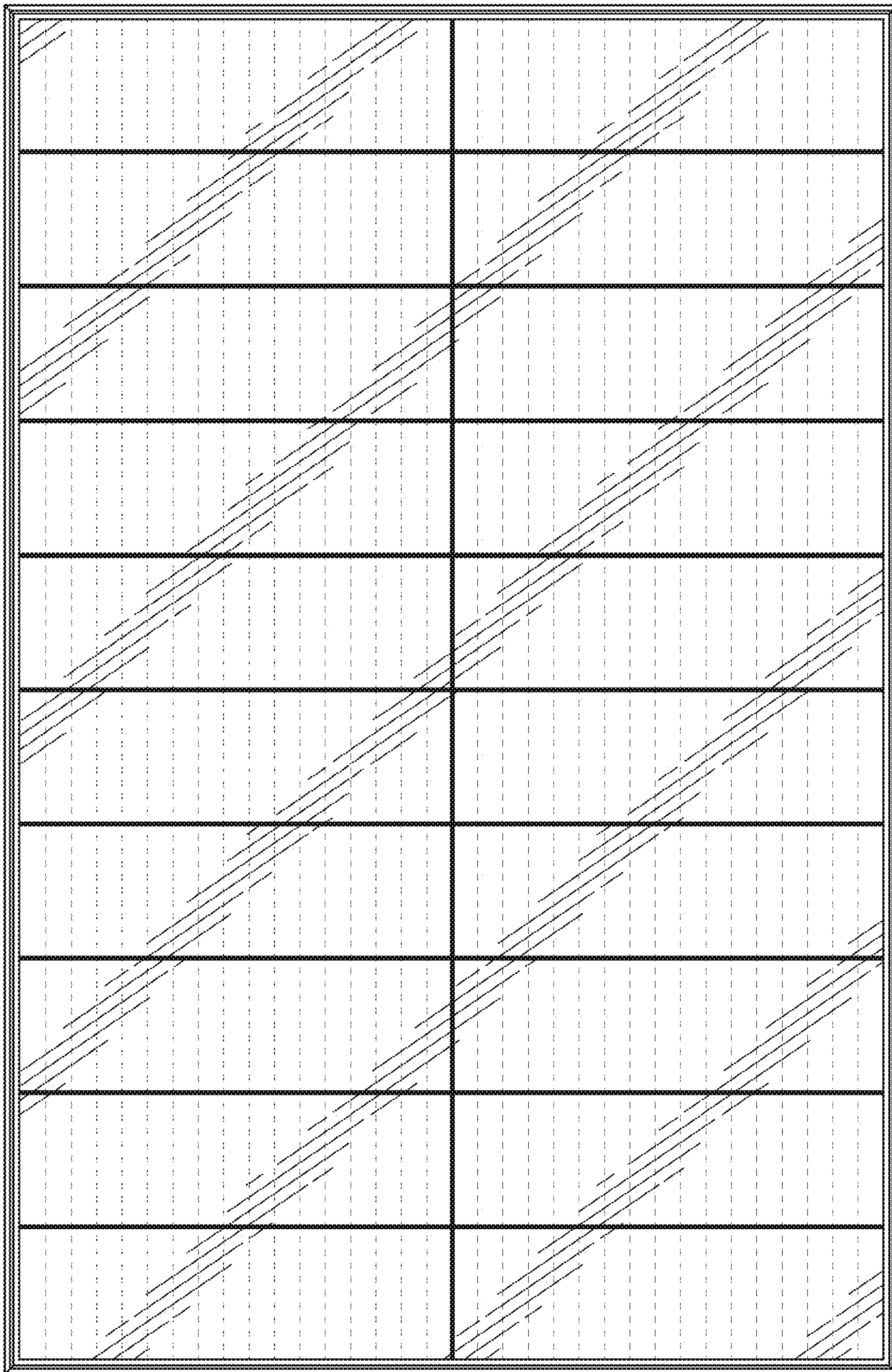

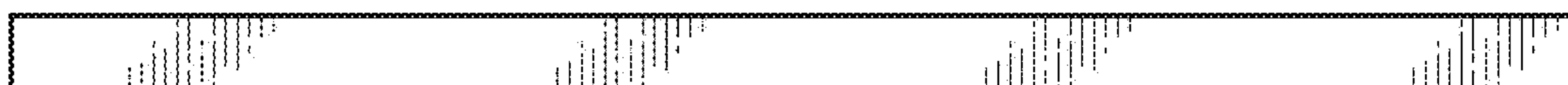

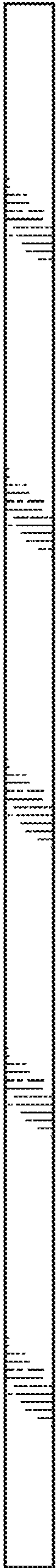

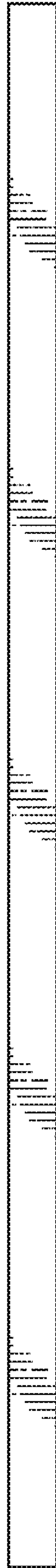
