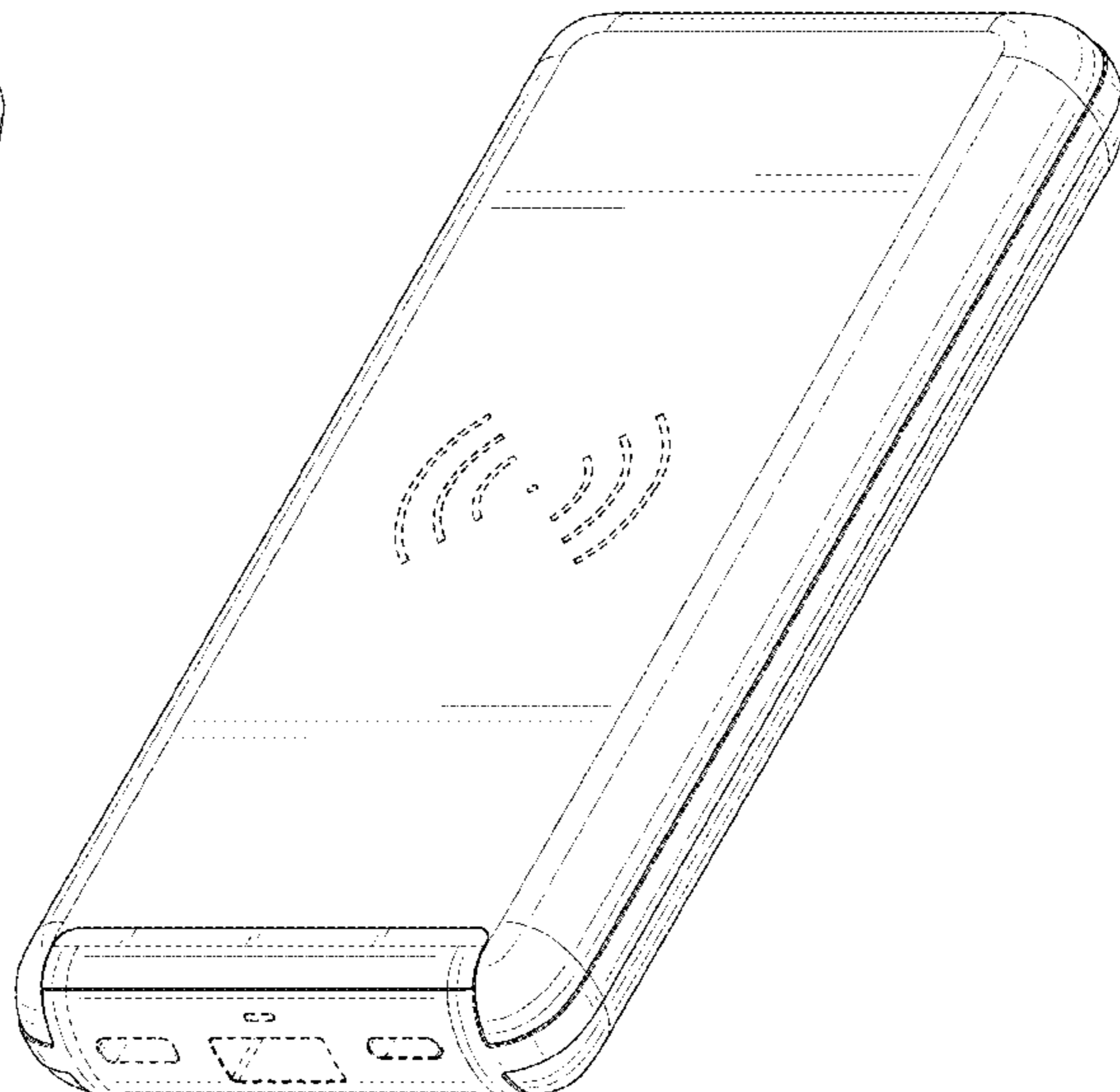
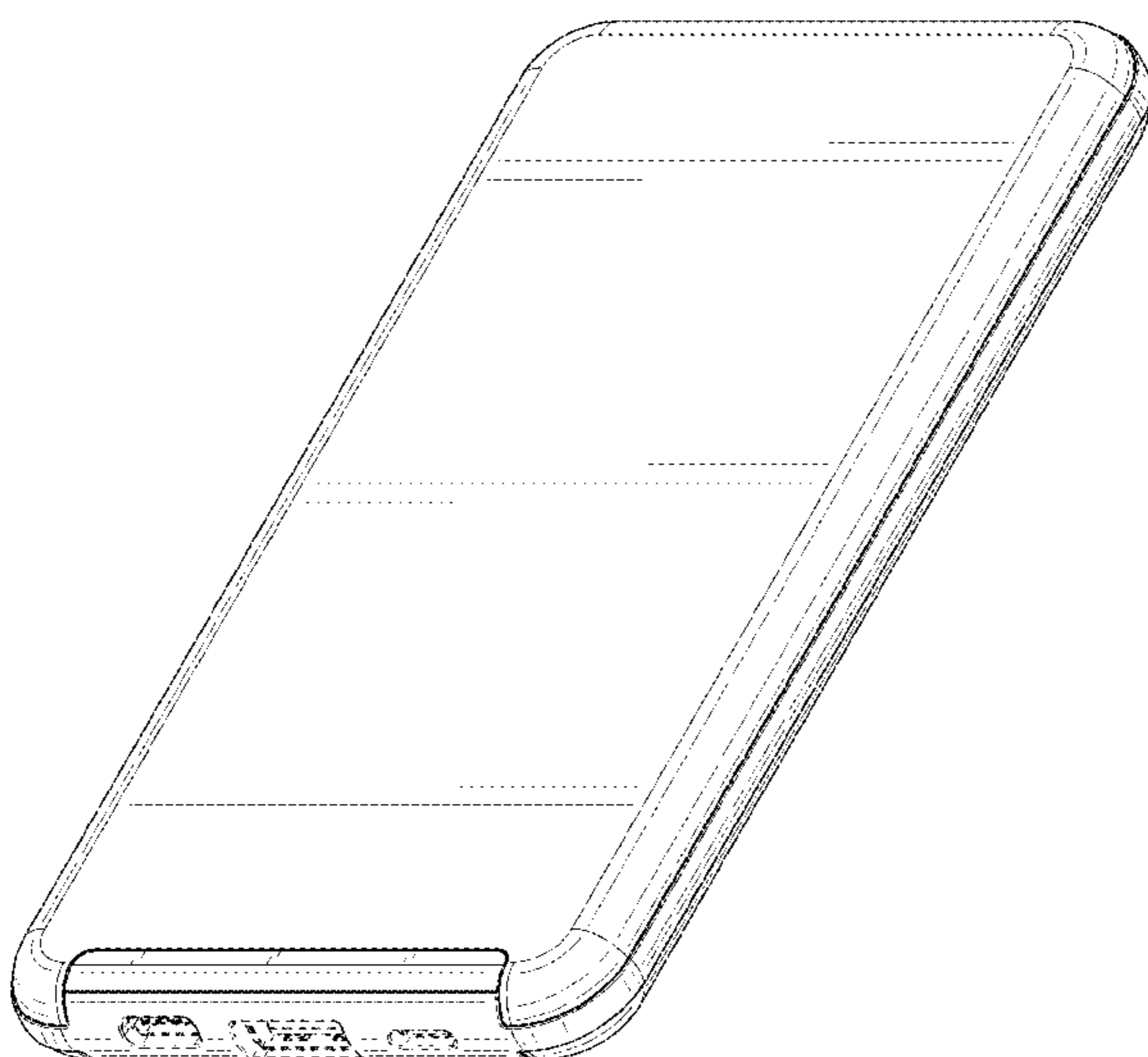
The ornamental design for a power bank, as shown and described.

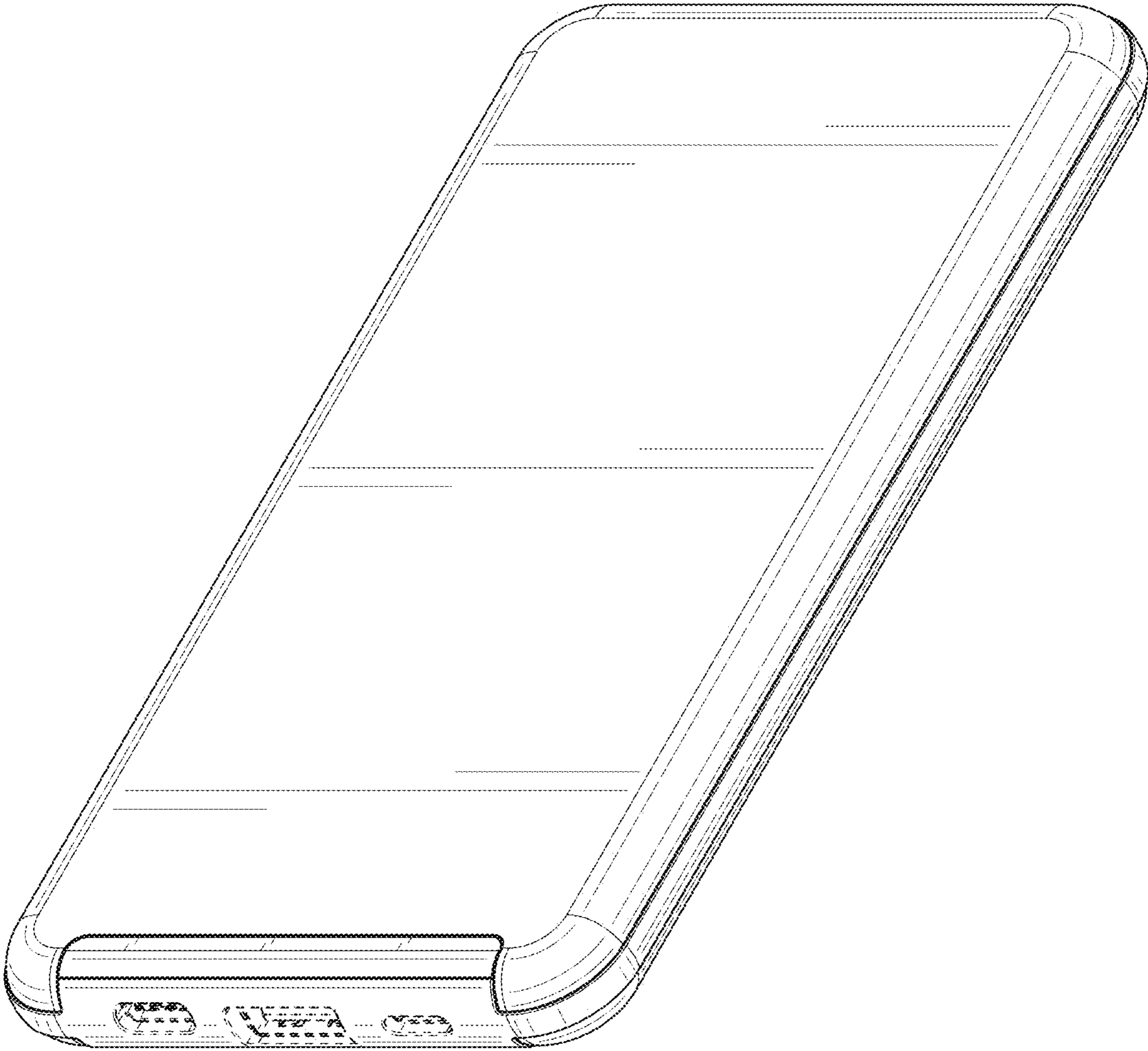

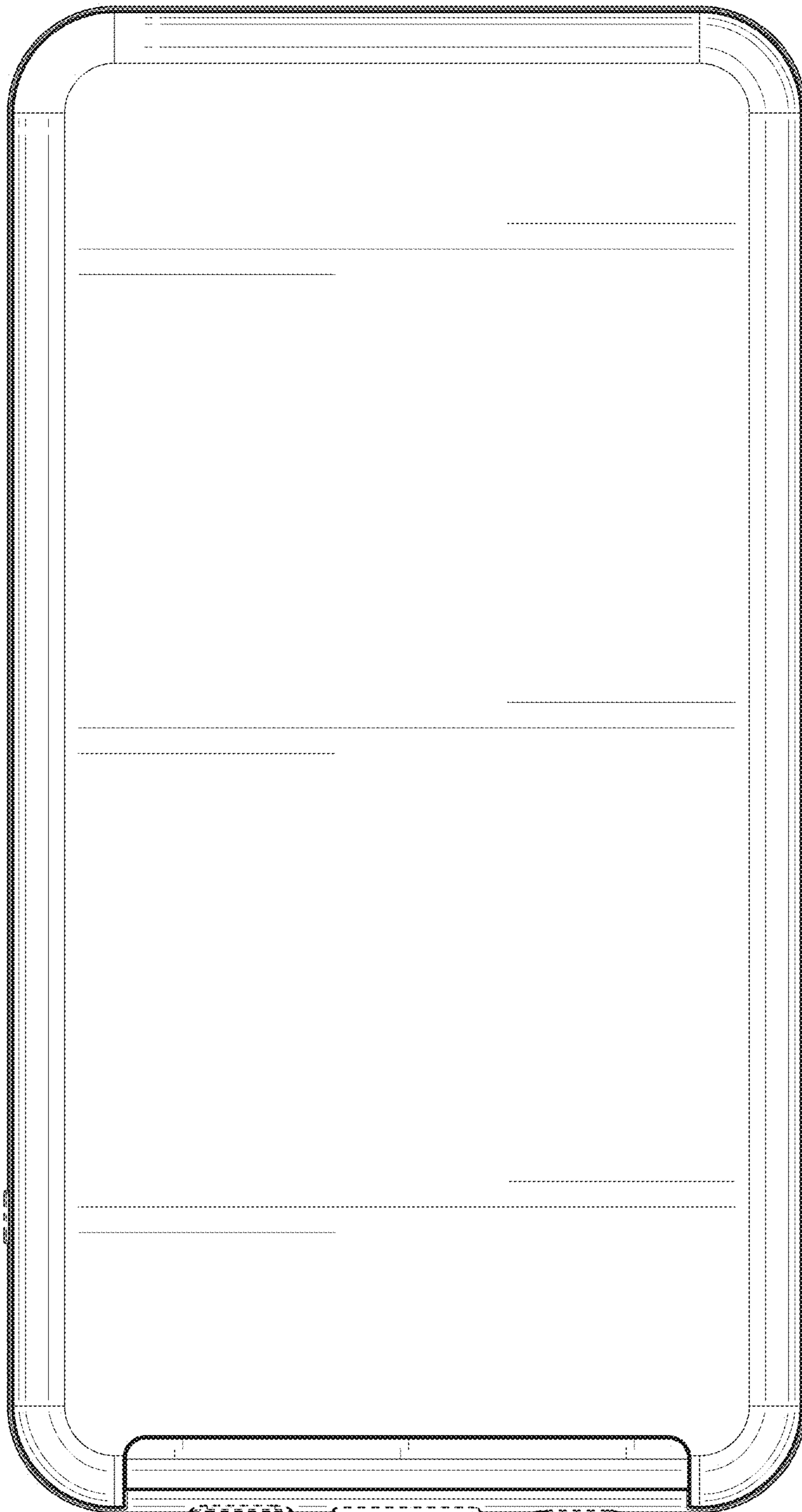

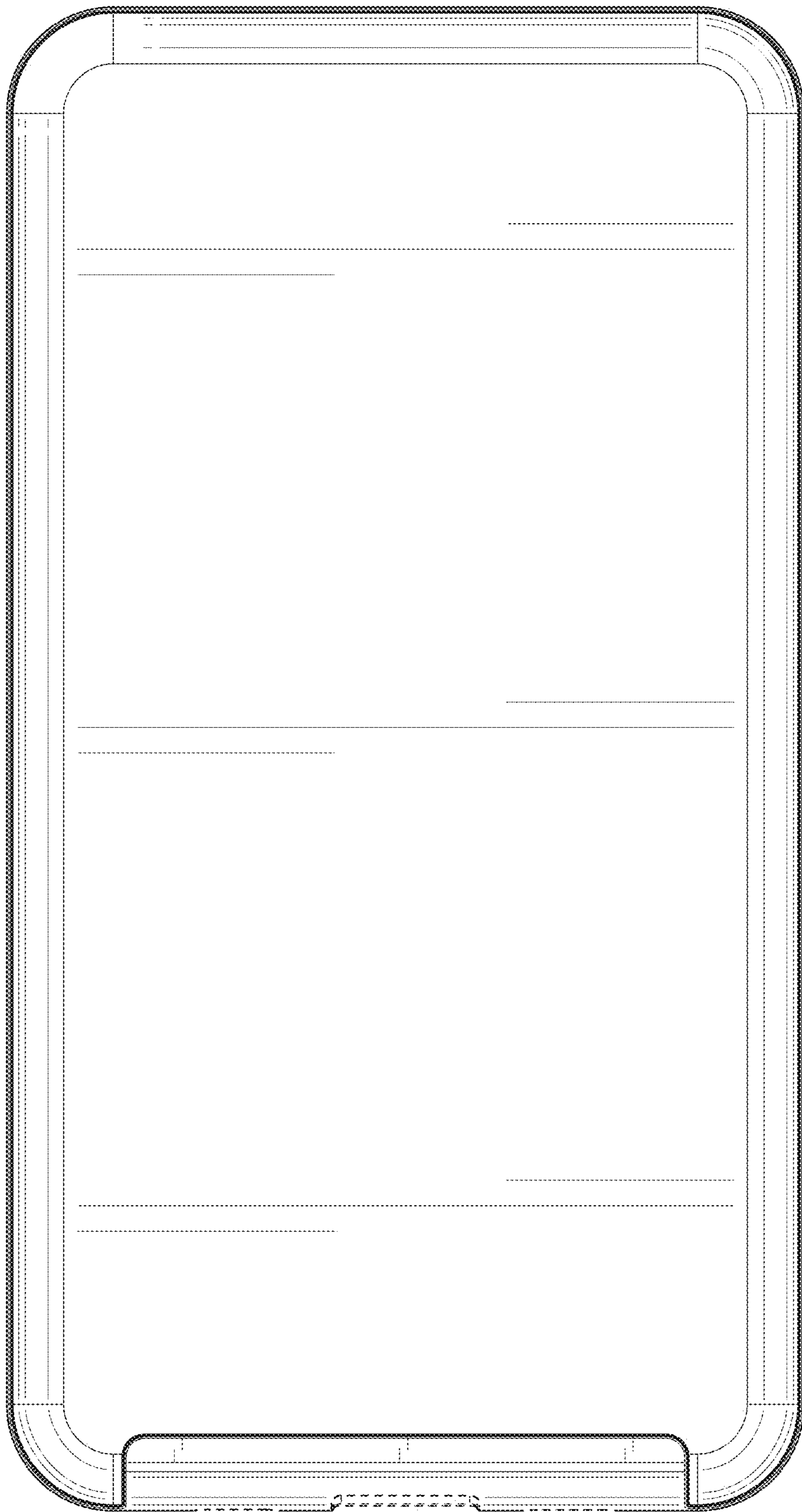

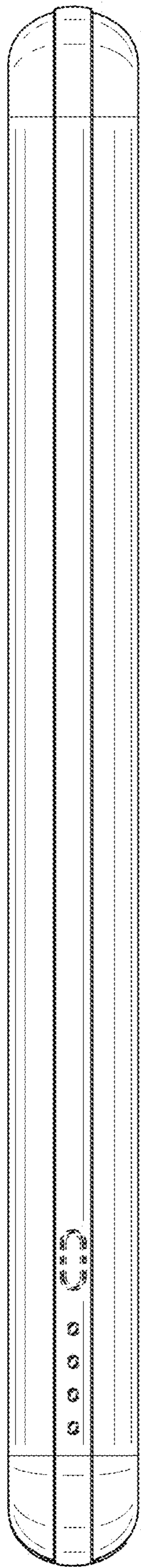

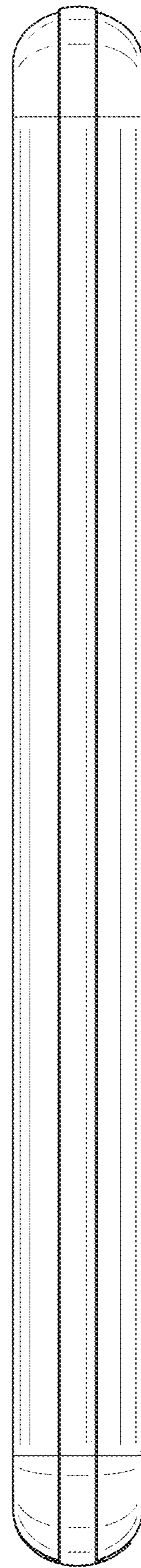

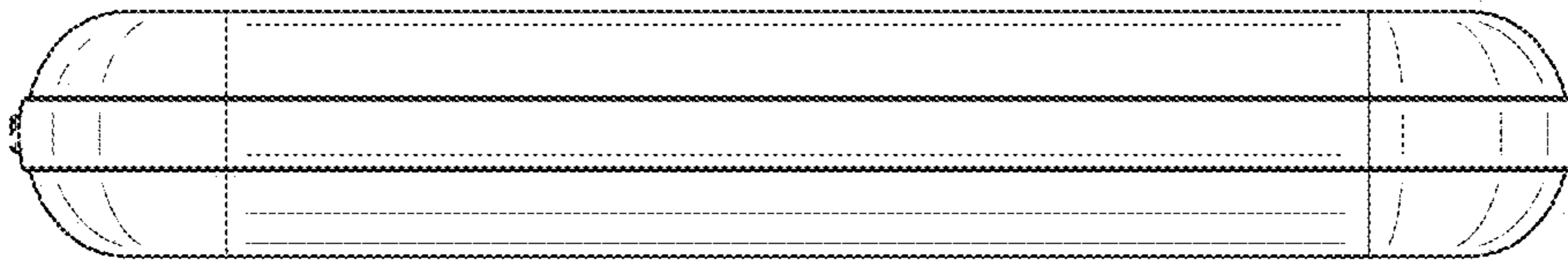

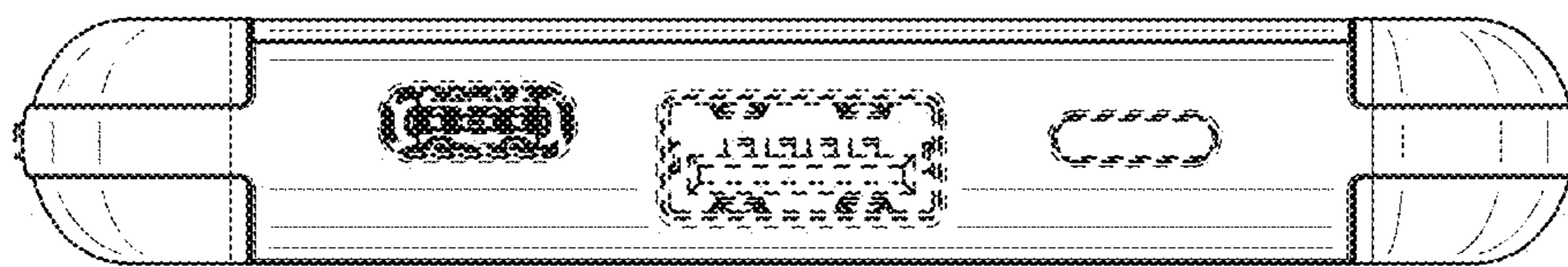

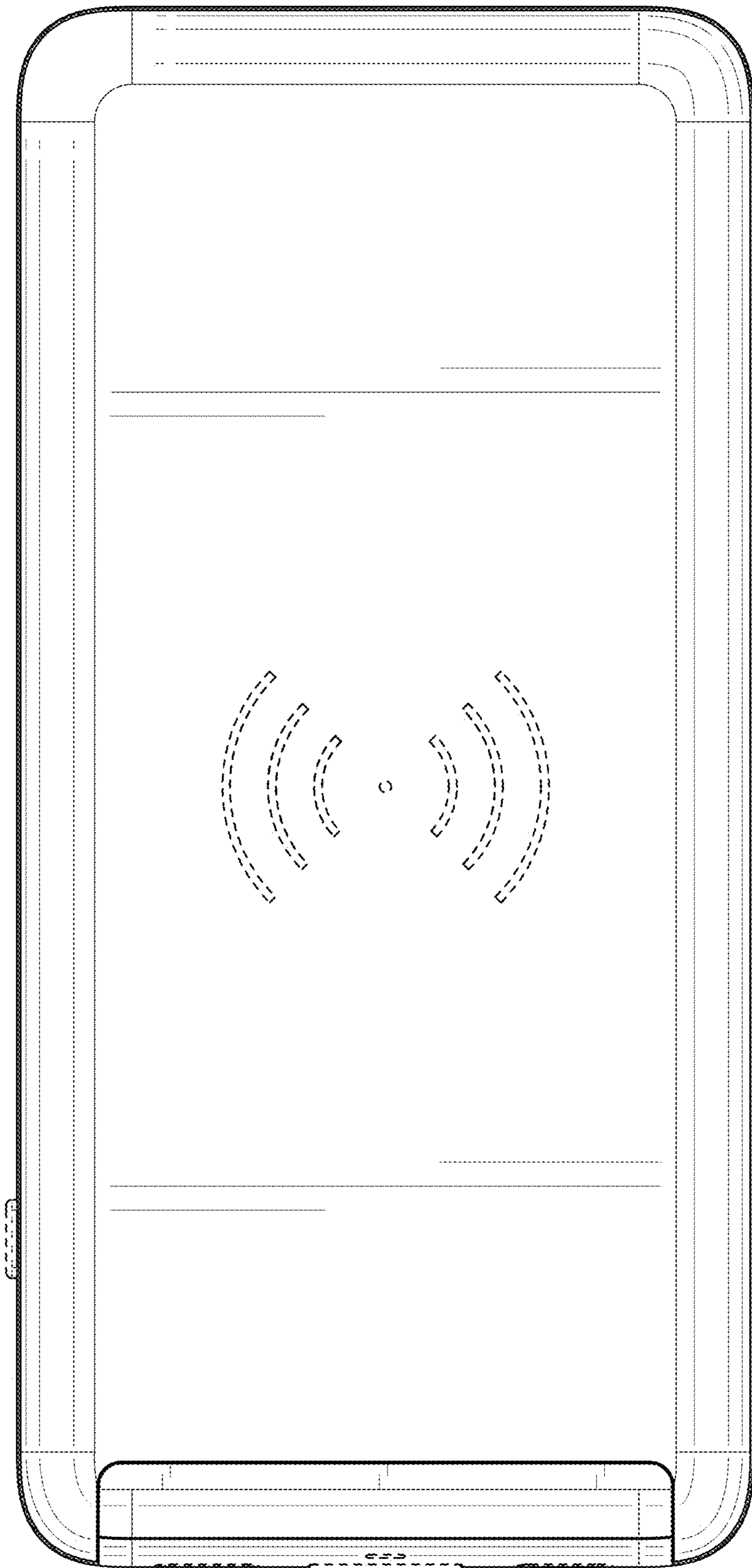

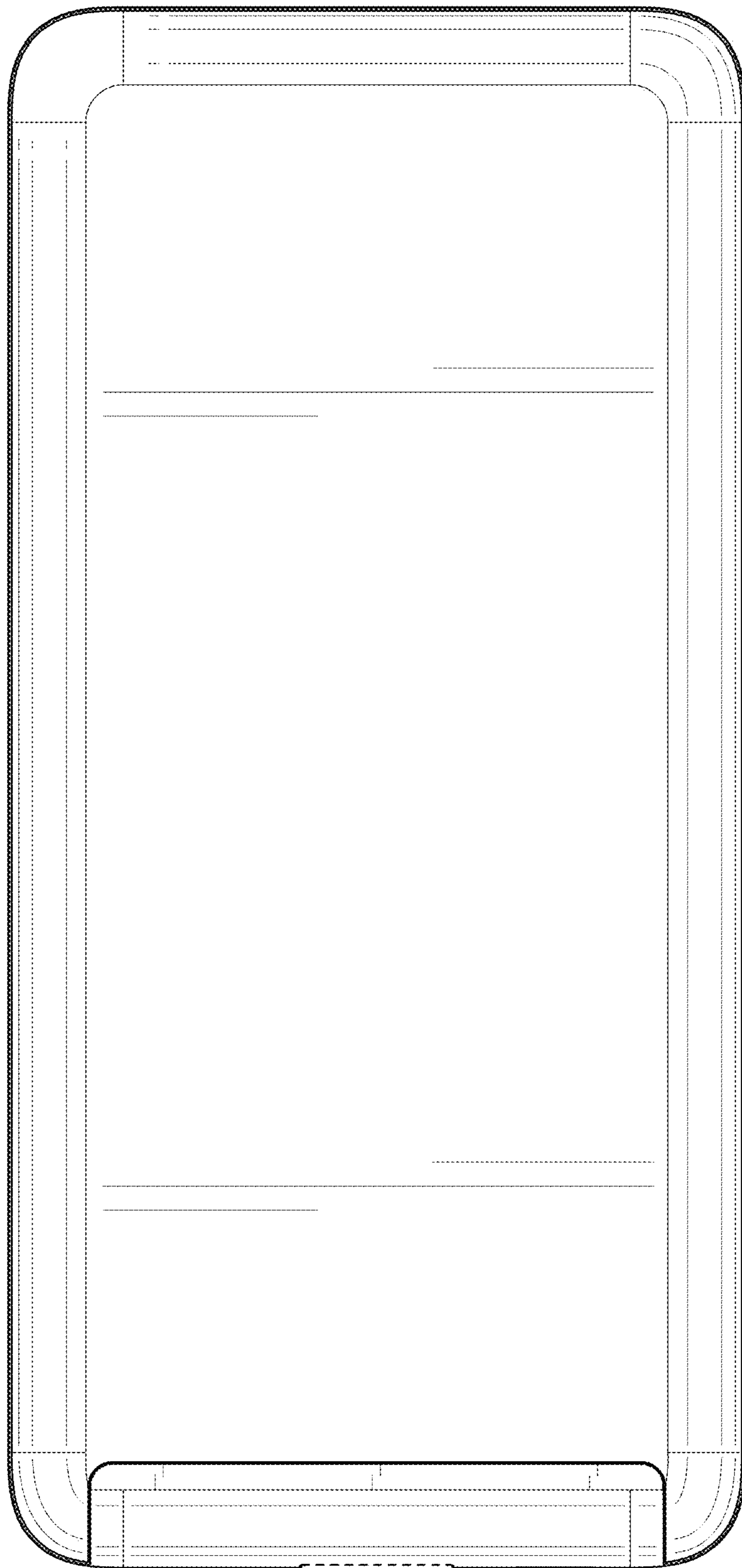

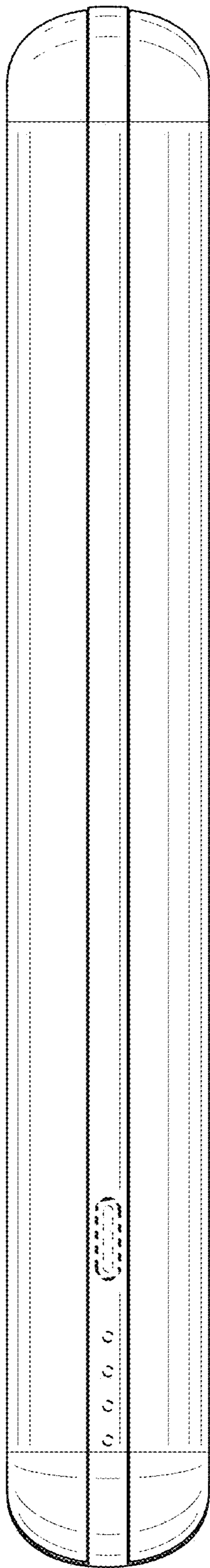

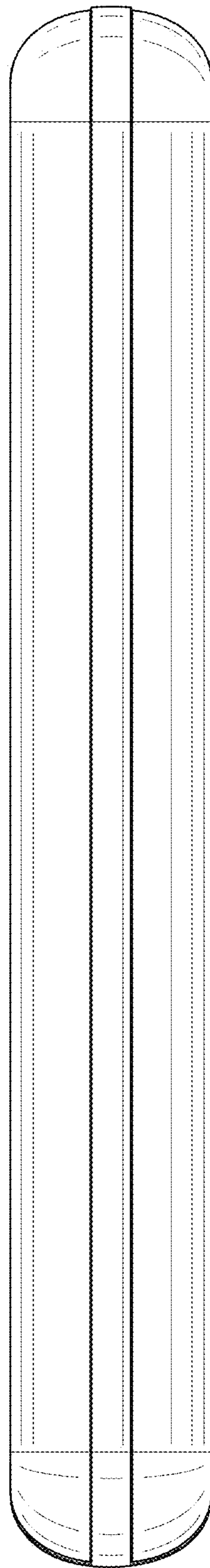

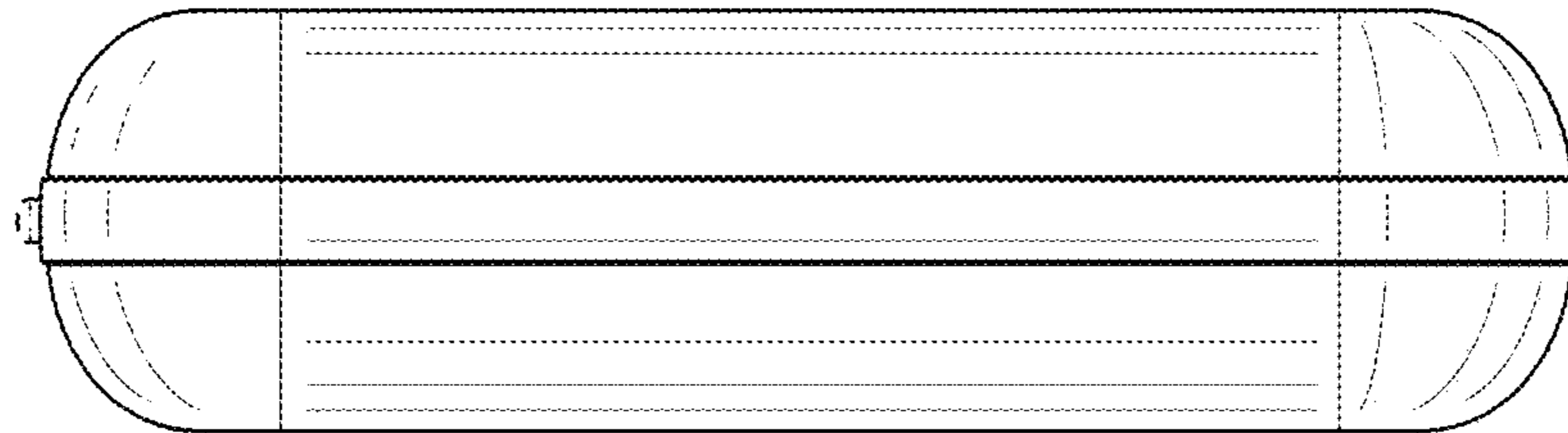

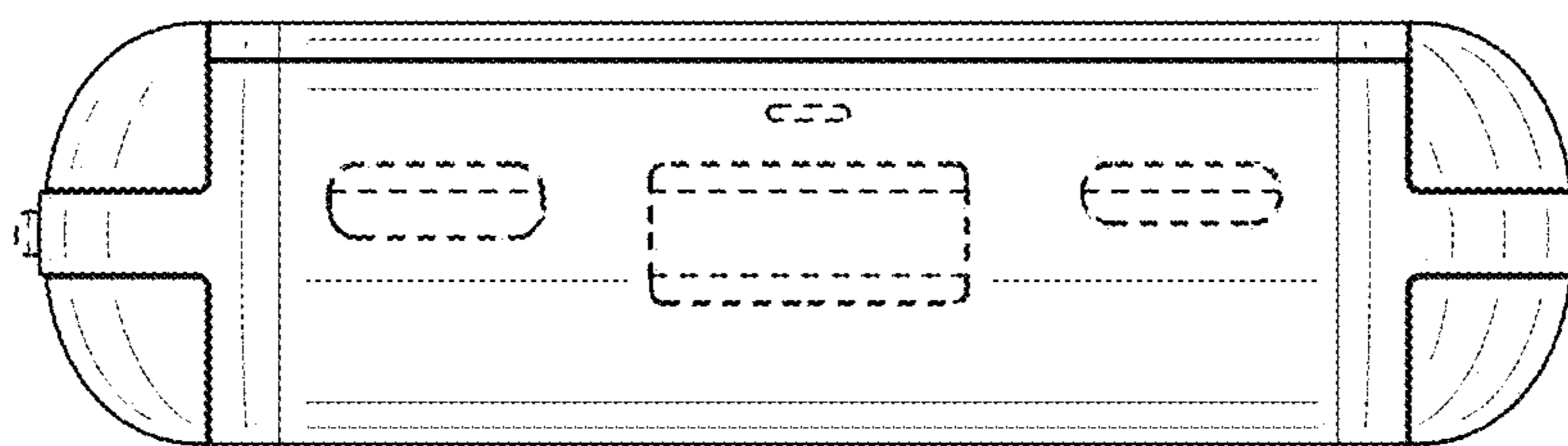

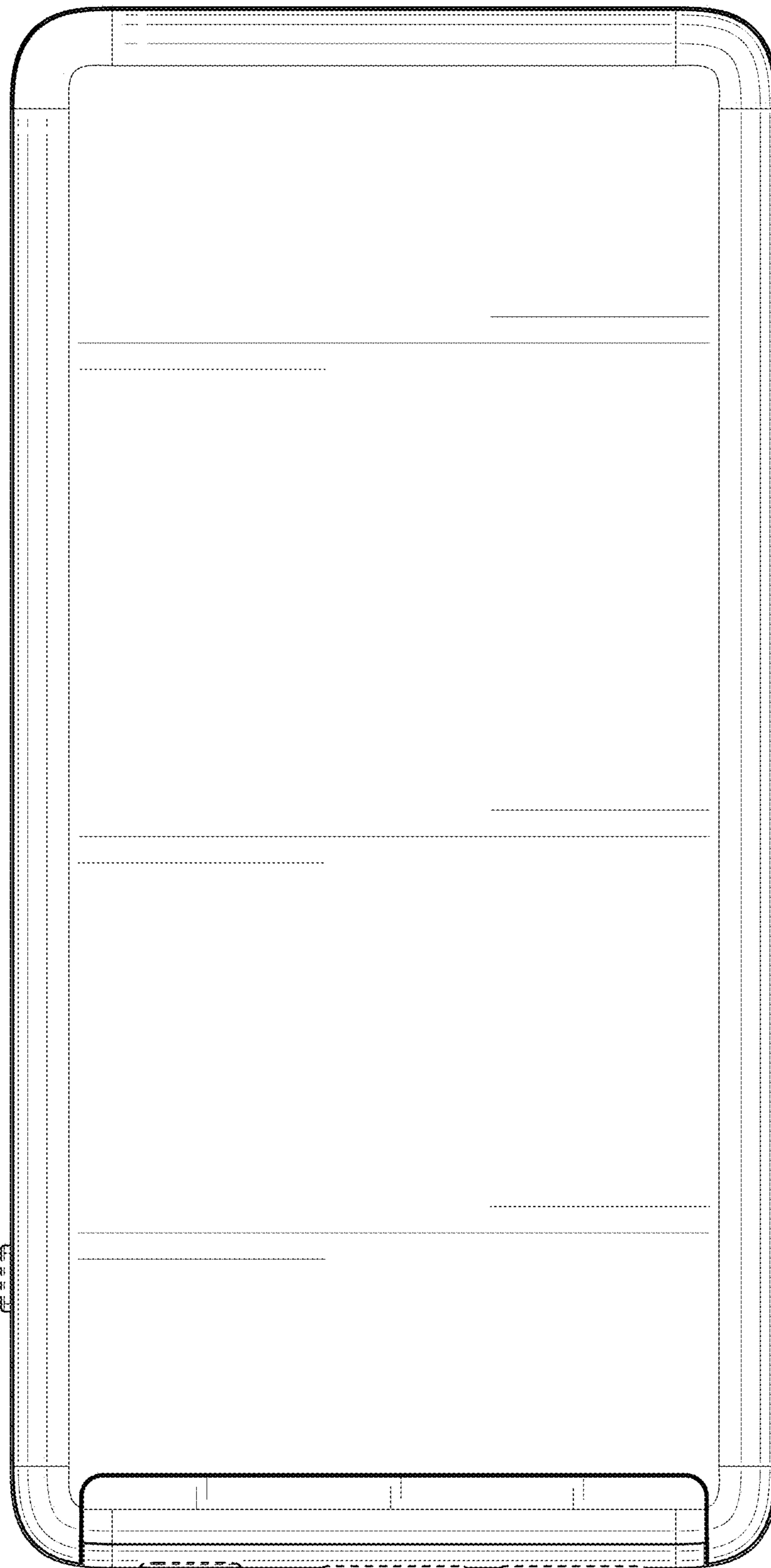

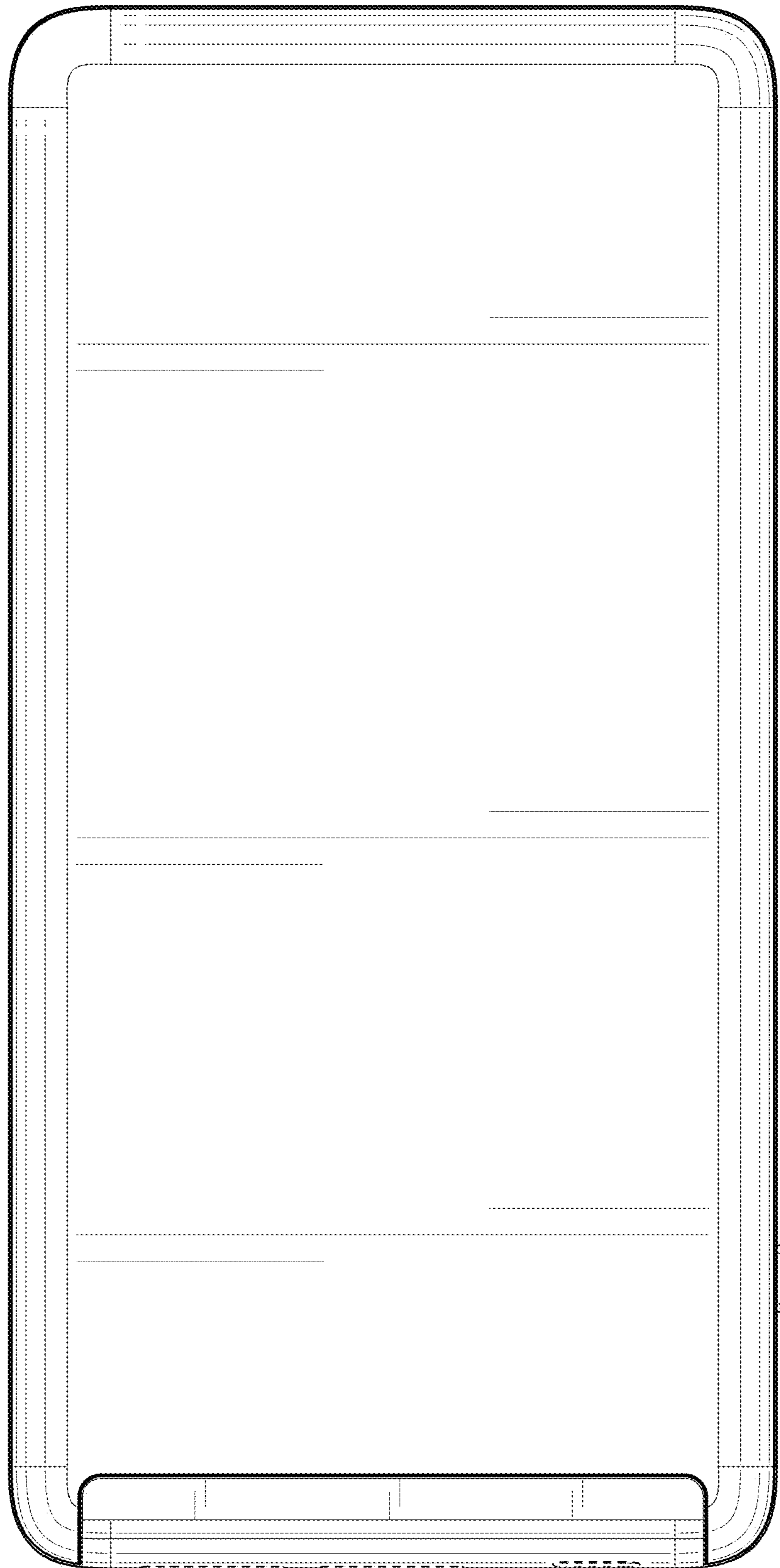

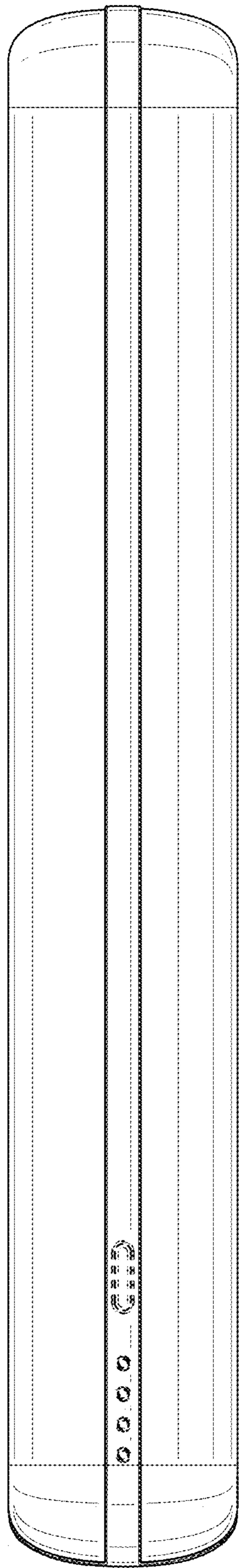

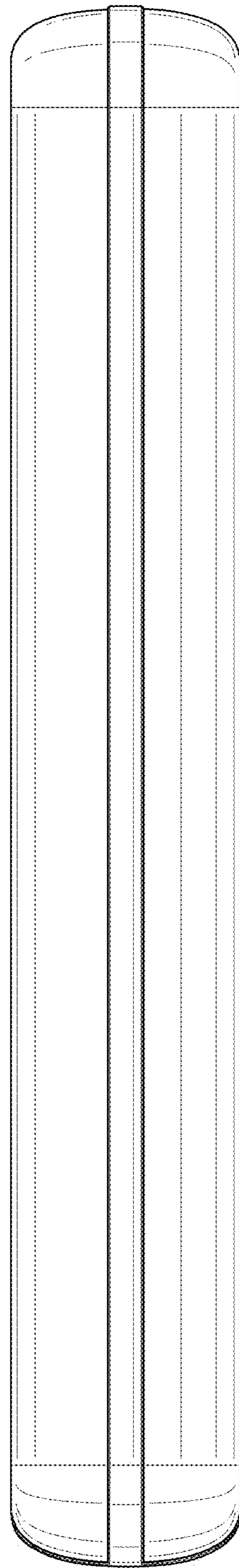

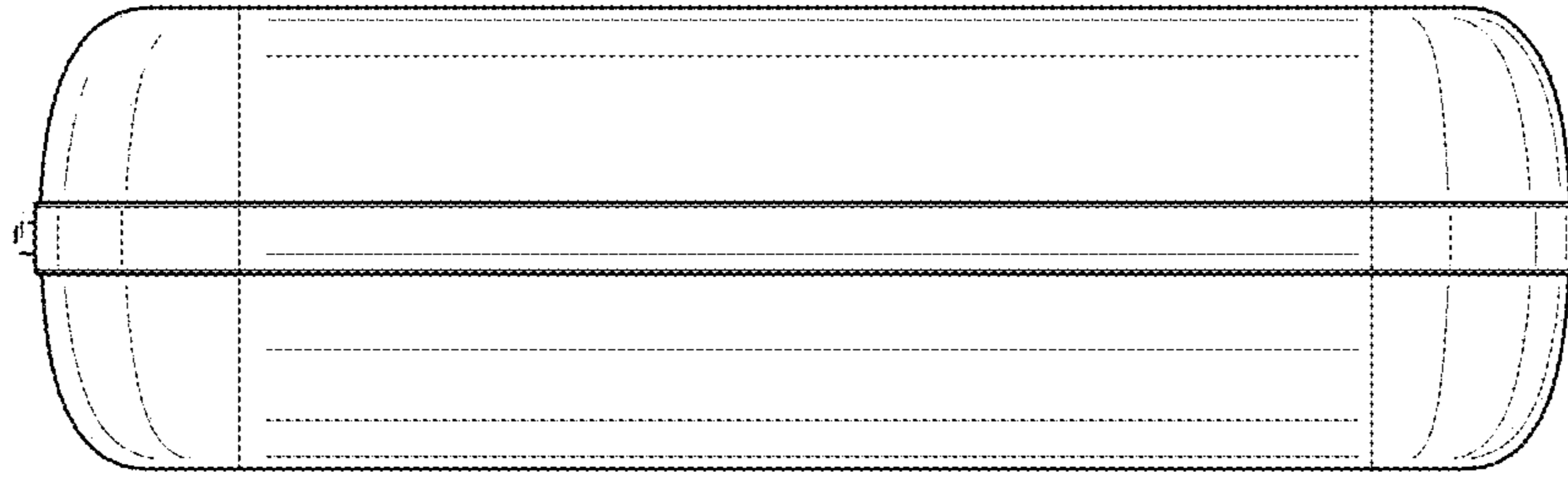

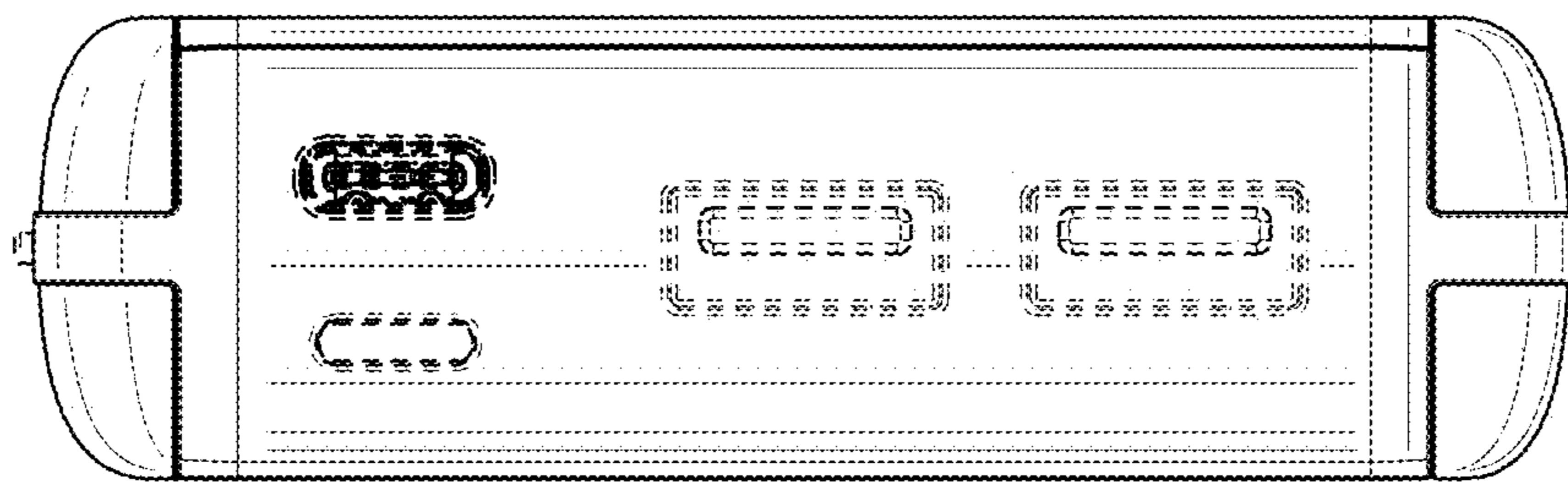
