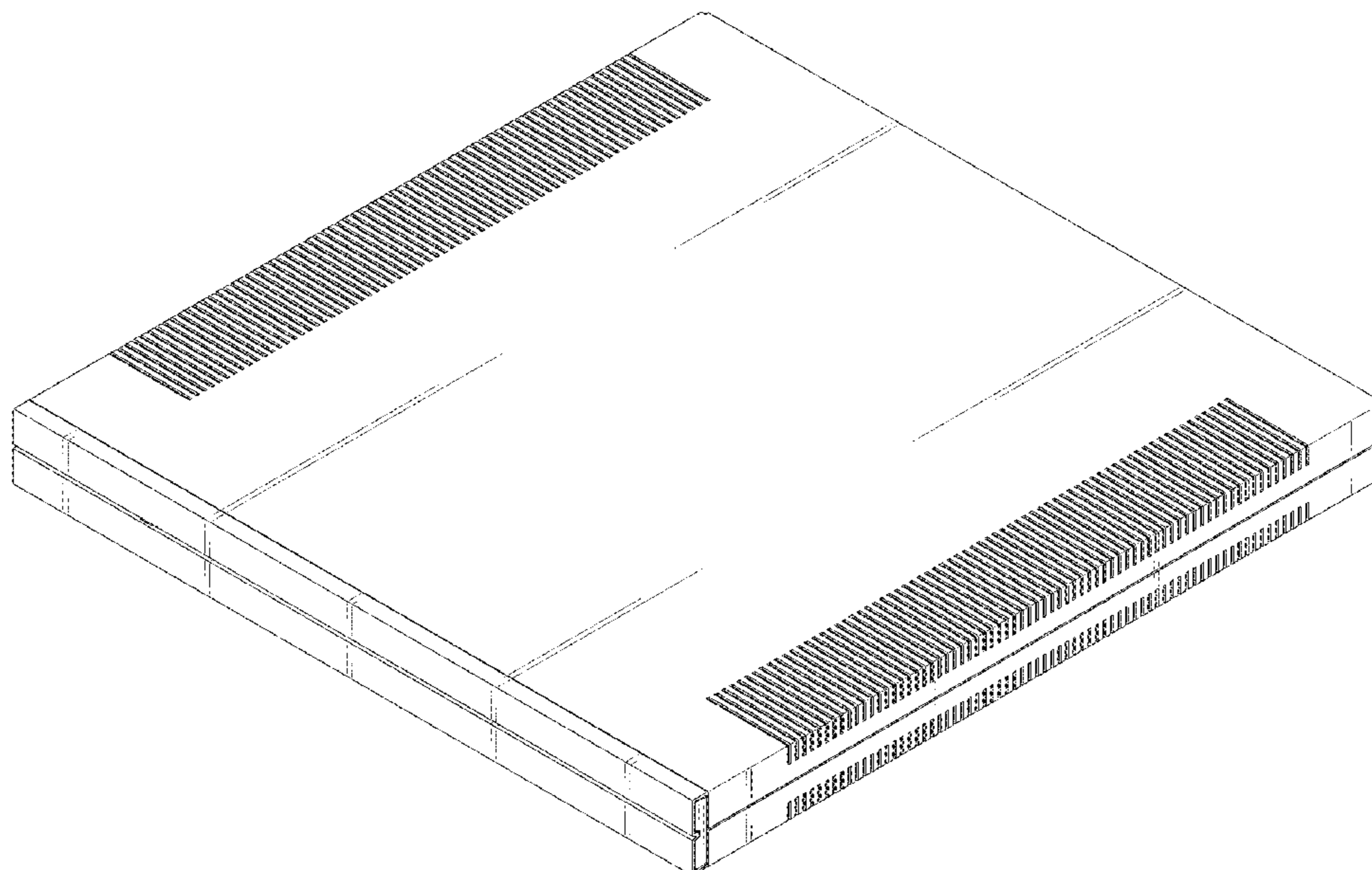
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the front, top and right side of an amplifier showing my new design;

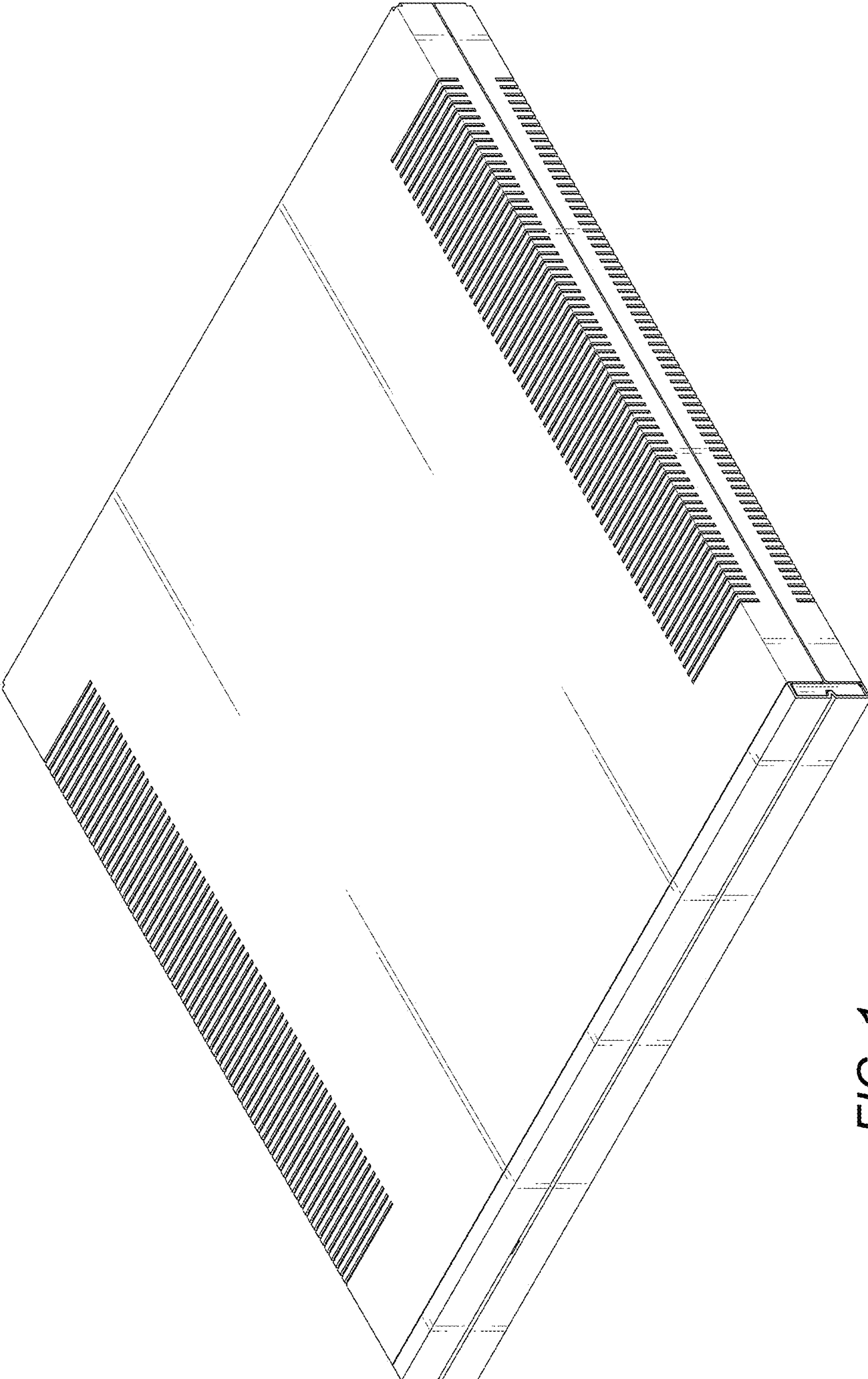

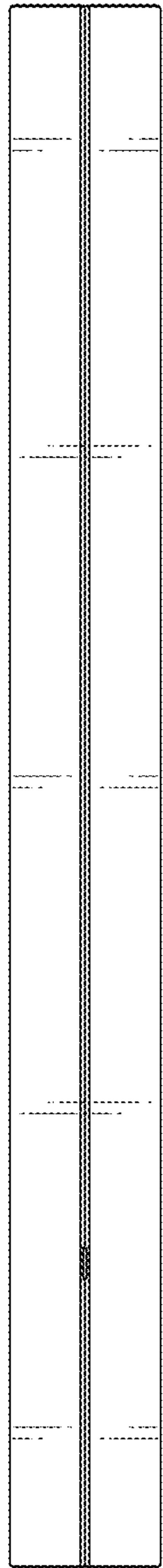

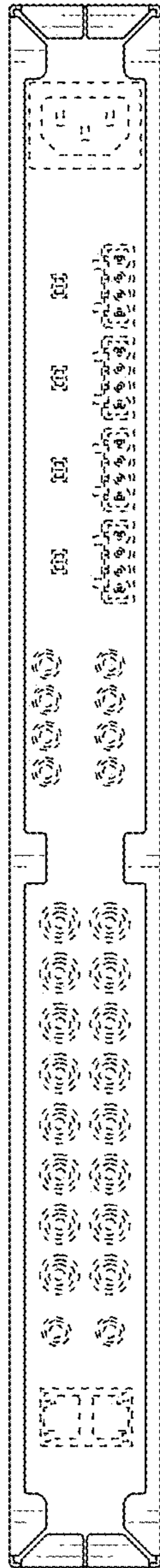

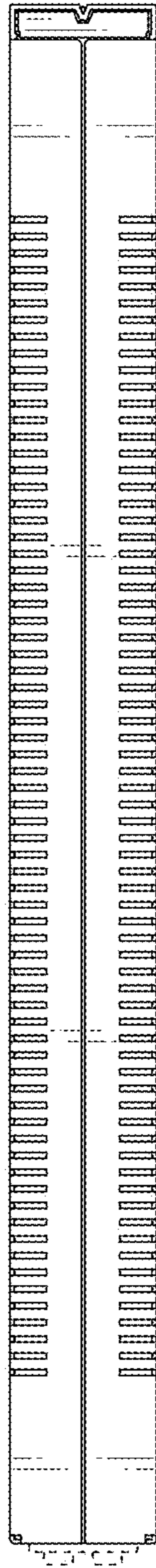

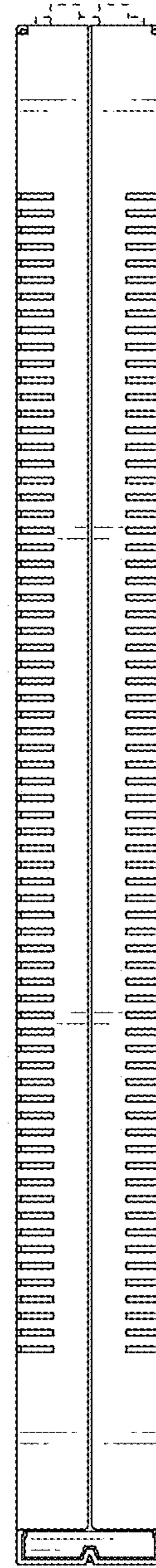

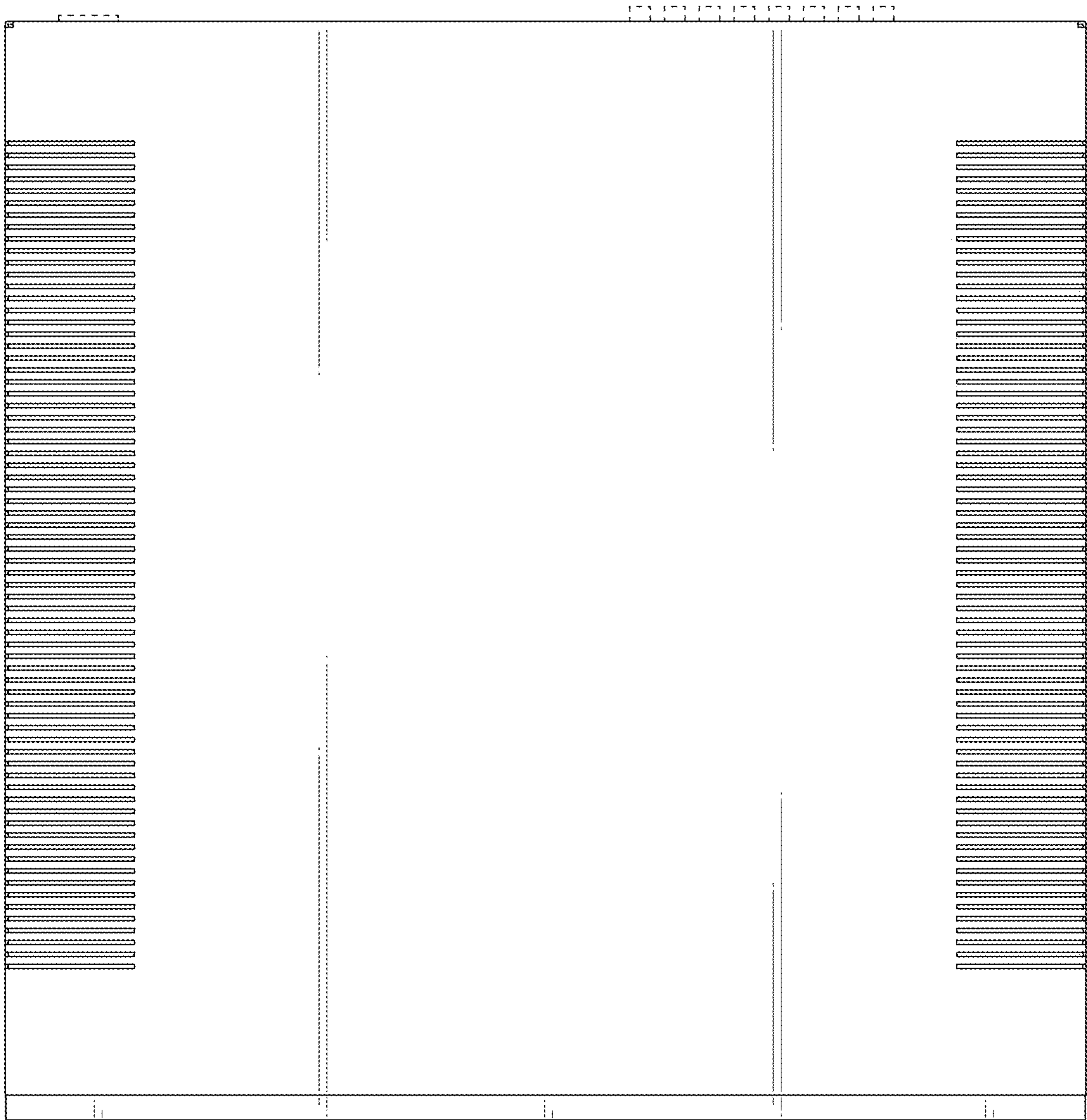

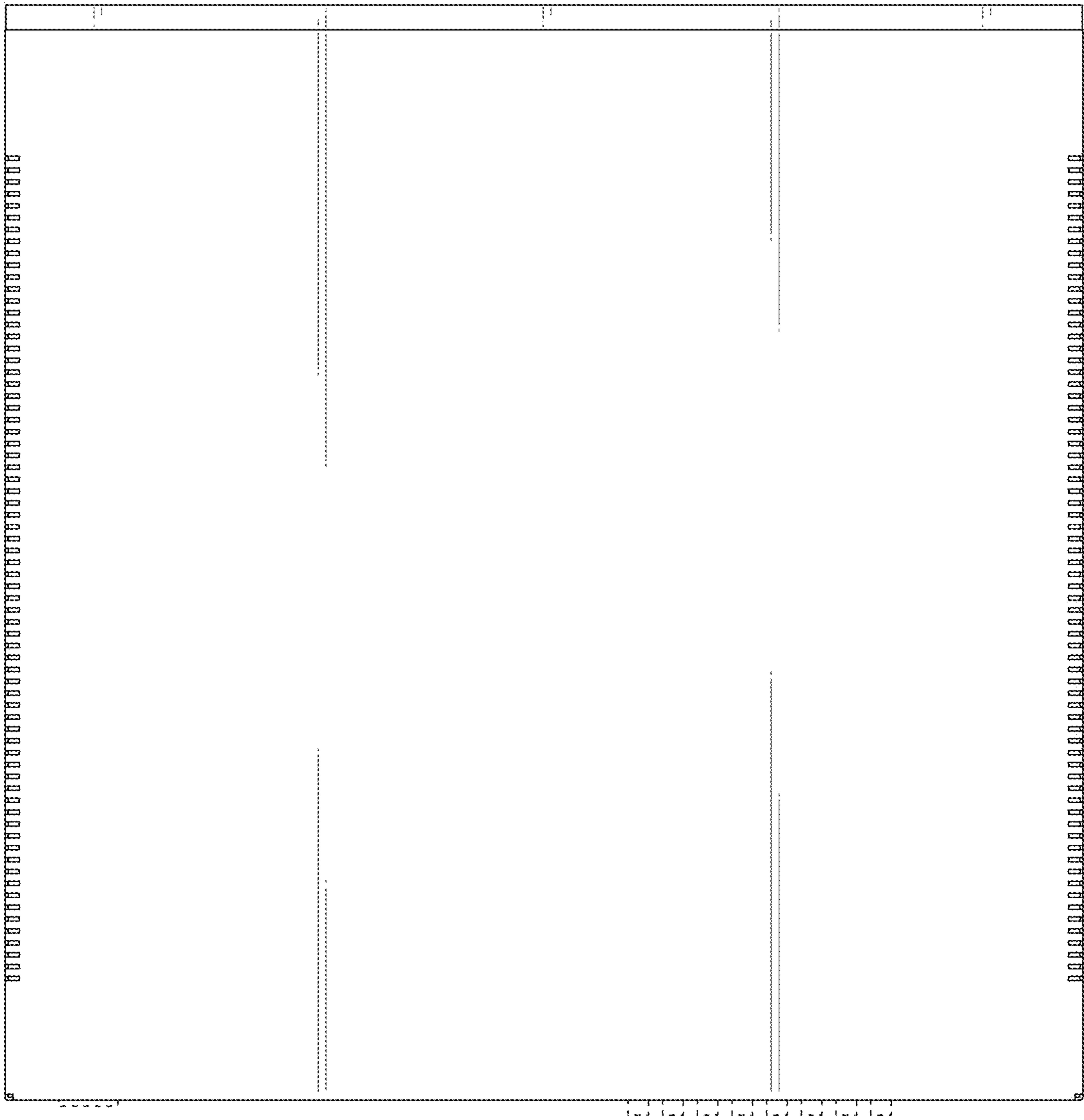
