The ornamental design for a protective case for mobile device, as shown and described.

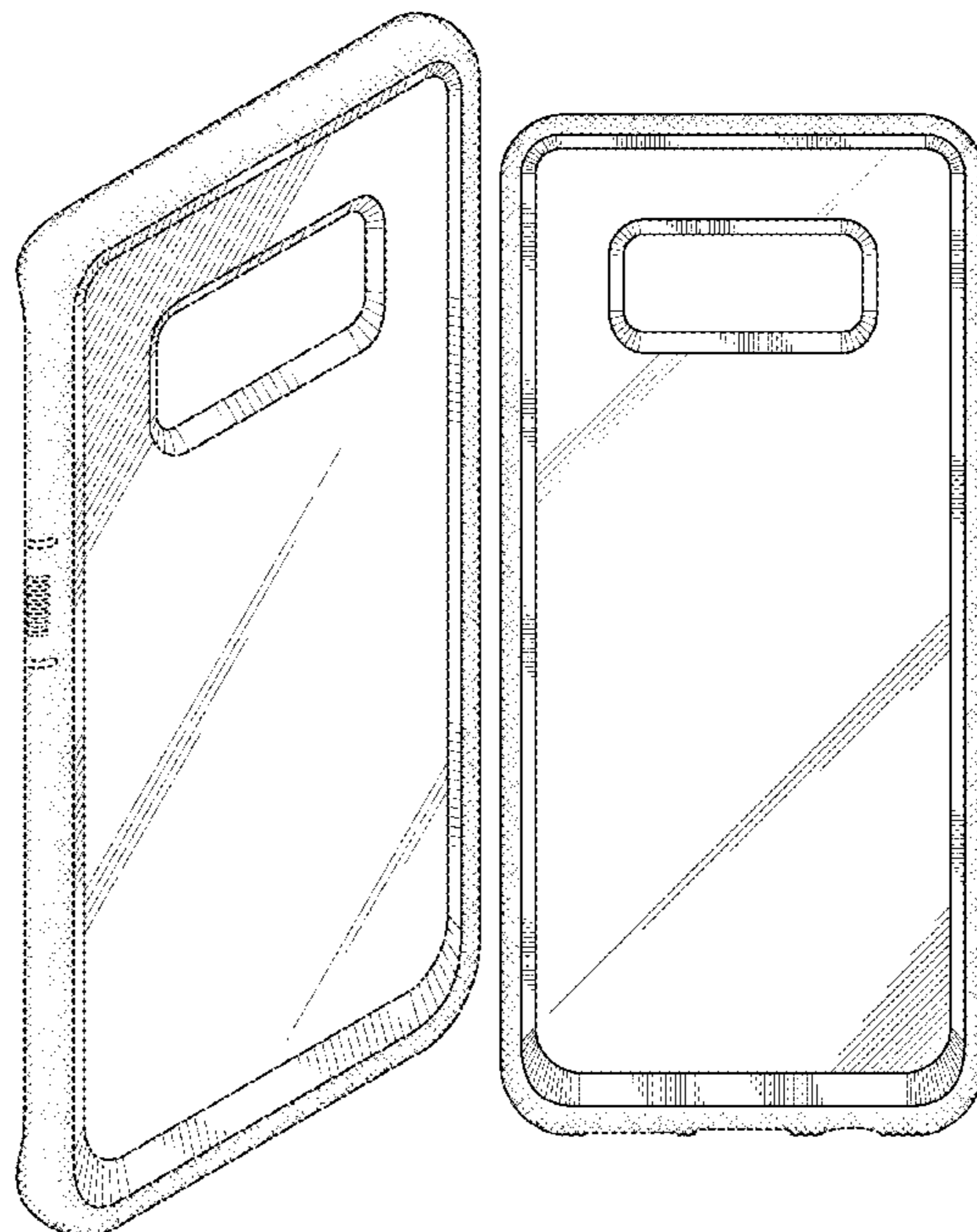
**DESCRIPTION**

FIG. 1 is a perspective view of a protective case for mobile device, showing my new design;  
FIG. 2 is a front view thereof;

FIG. 6 is a top view thereof;  
FIG. 7 is a back view thereof;

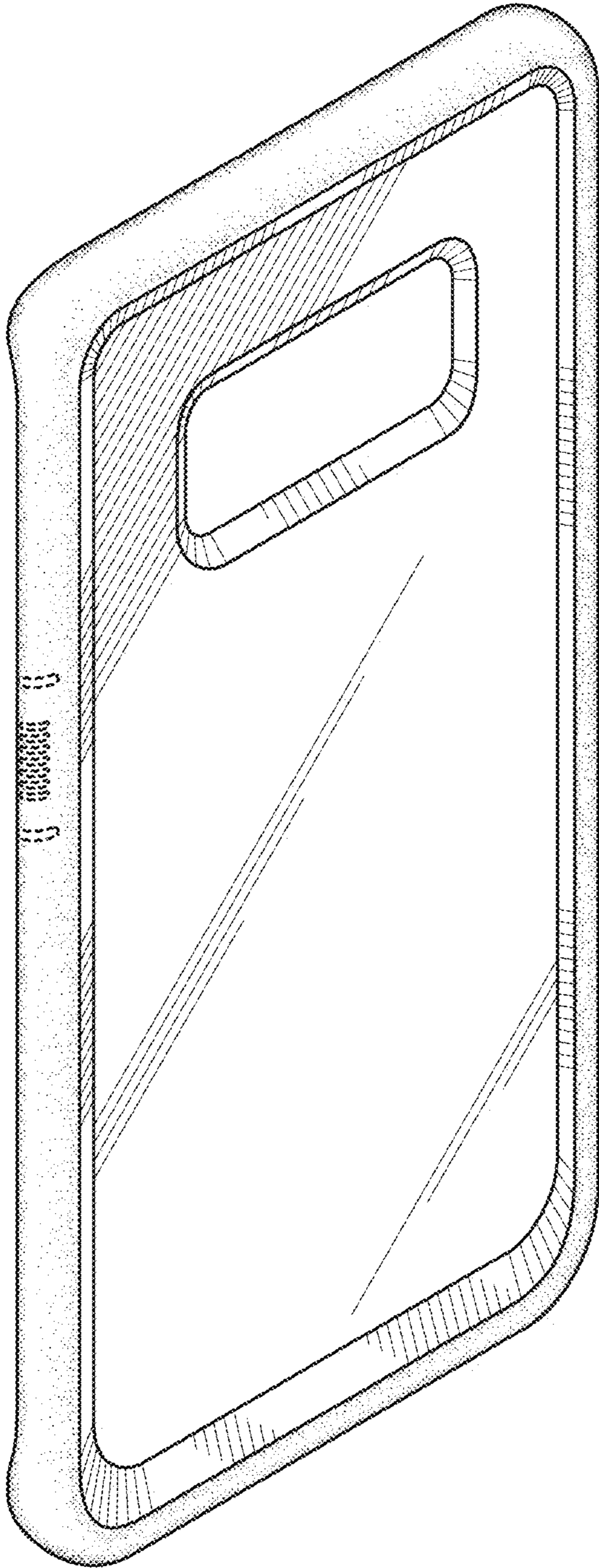

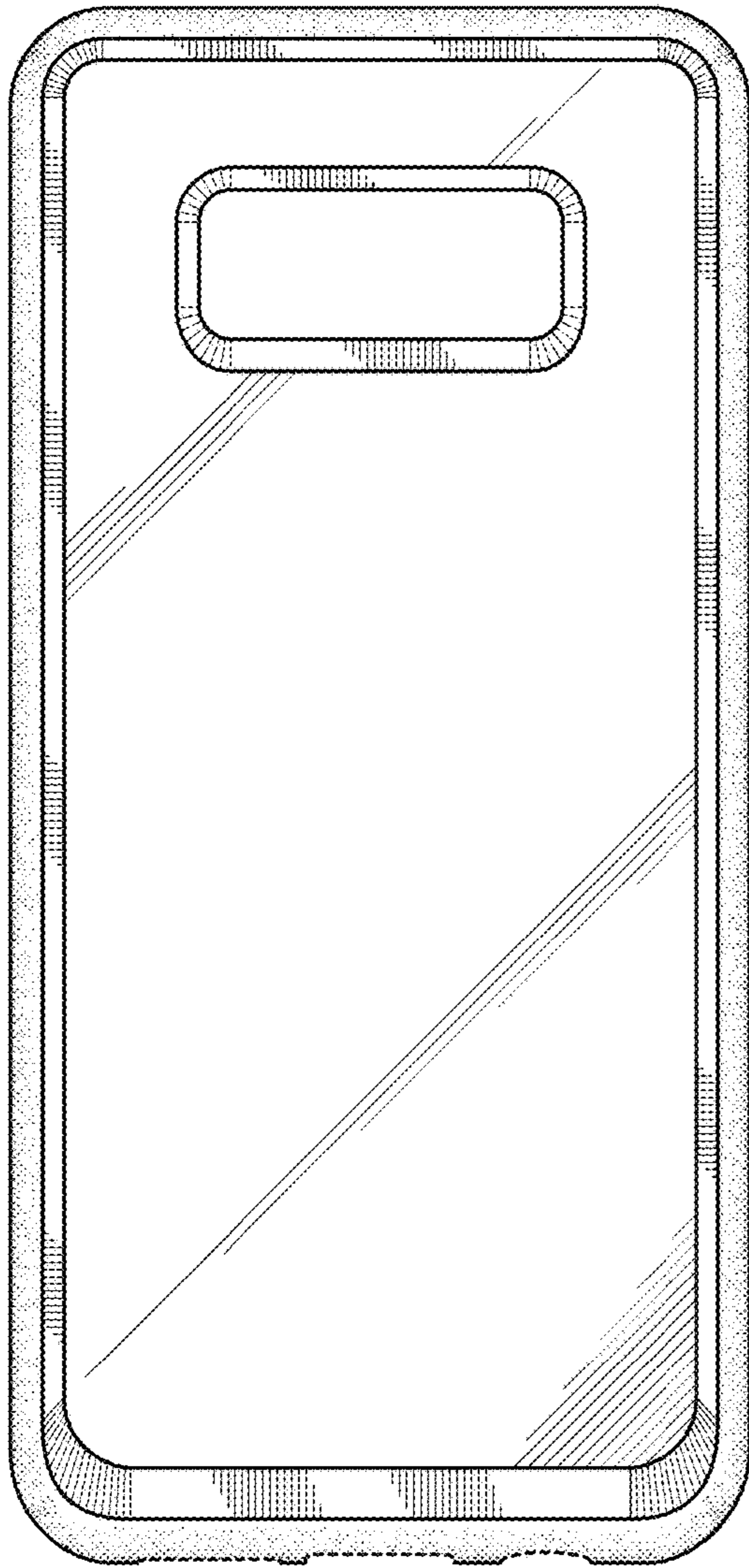

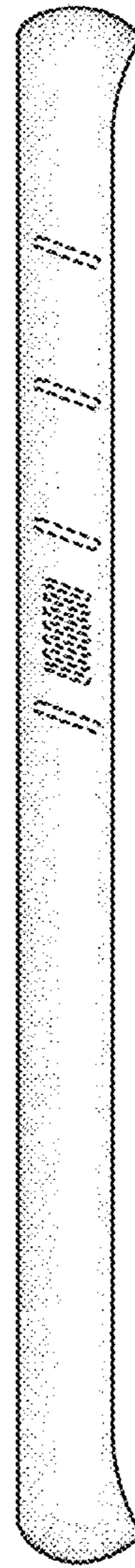

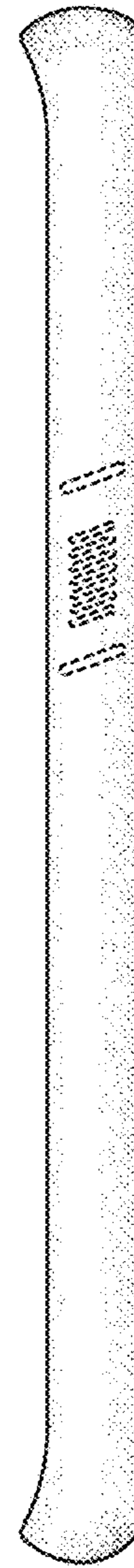

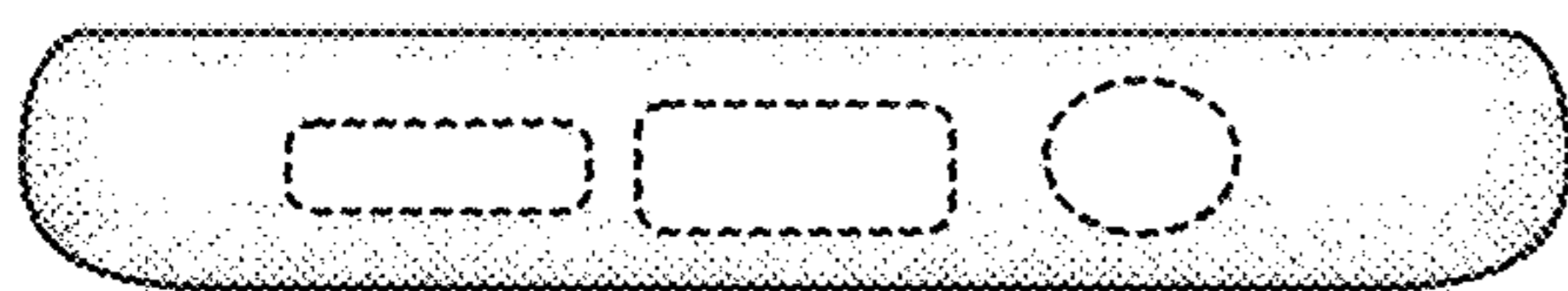

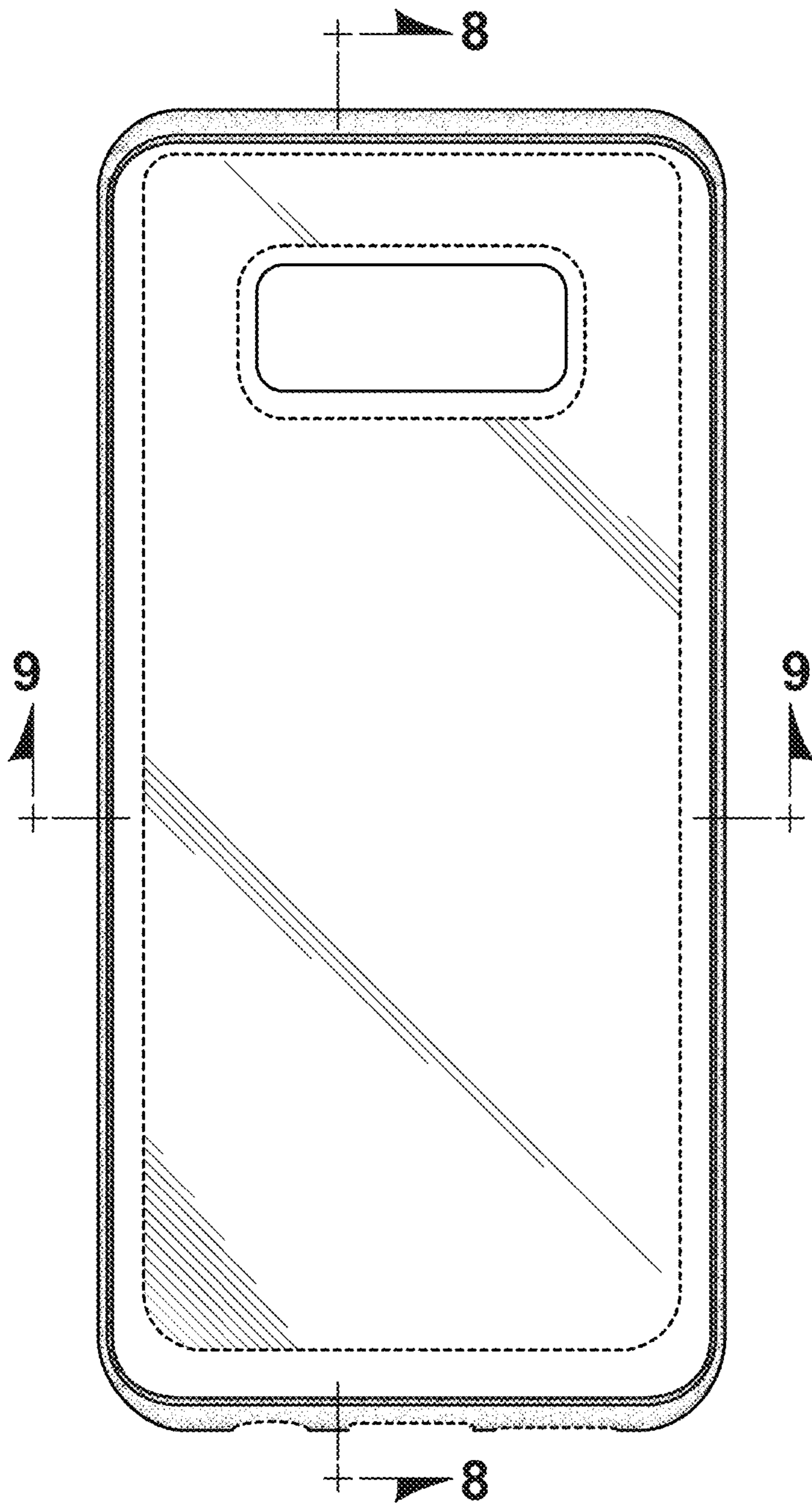
