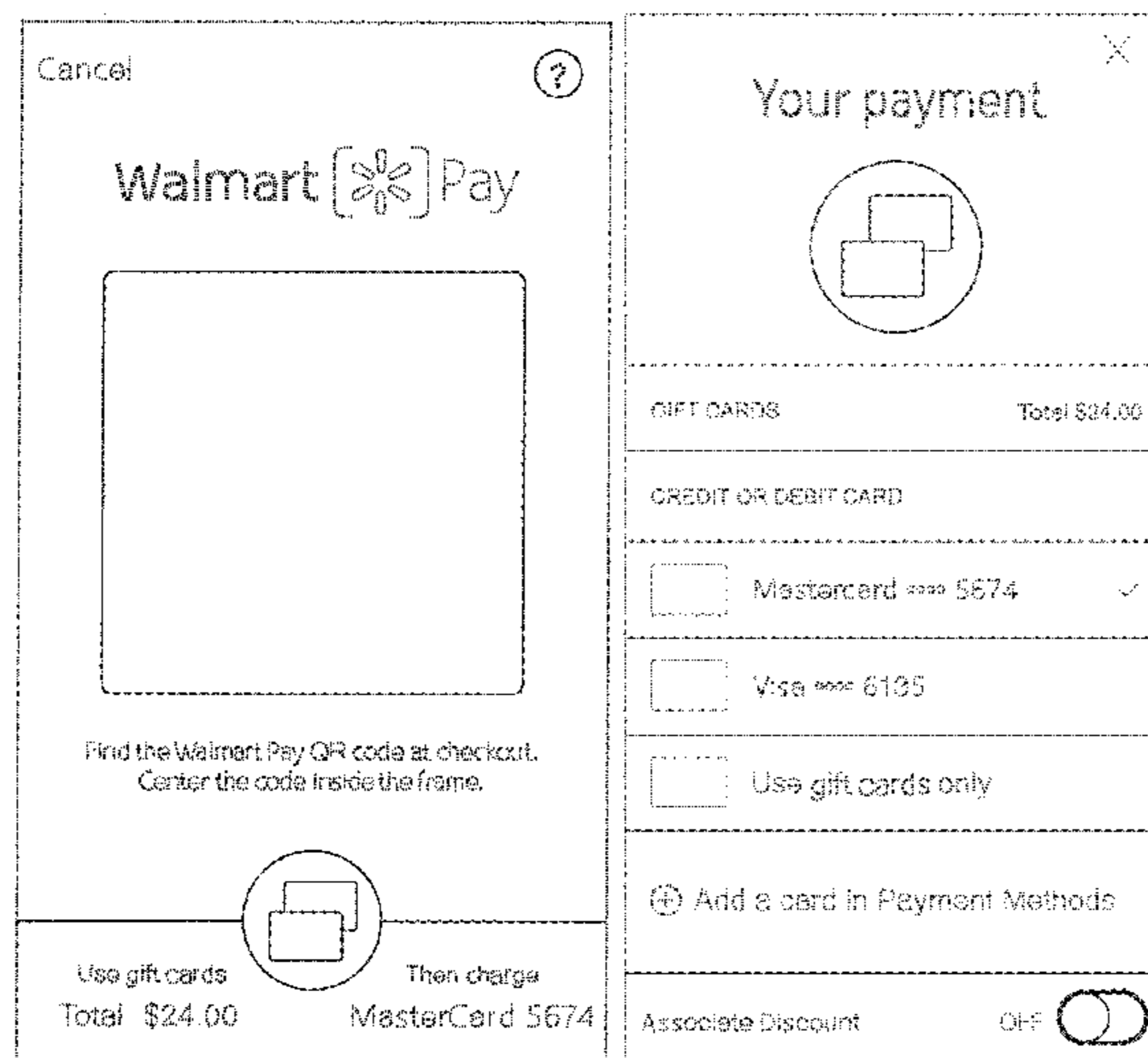
(57) **CLAIM**

The ornamental design for a display screen portion with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image of a display screen portion with graphical user interface; FIG. 2 is a front view of a second image of a display screen portion with graphical user interface; and, FIG. 3 is a front view of a third image of a display screen portion with graphical user interface. The broken line showing of a display screen portion and graphical user interface is included for the purpose of illustrating portions of the article and forms no part of the claimed design. The appearance of the transitional image sequentially transitions between the images shown in FIG. 1-3. The process or period in which one image transitions to another image forms no part of the claimed design.

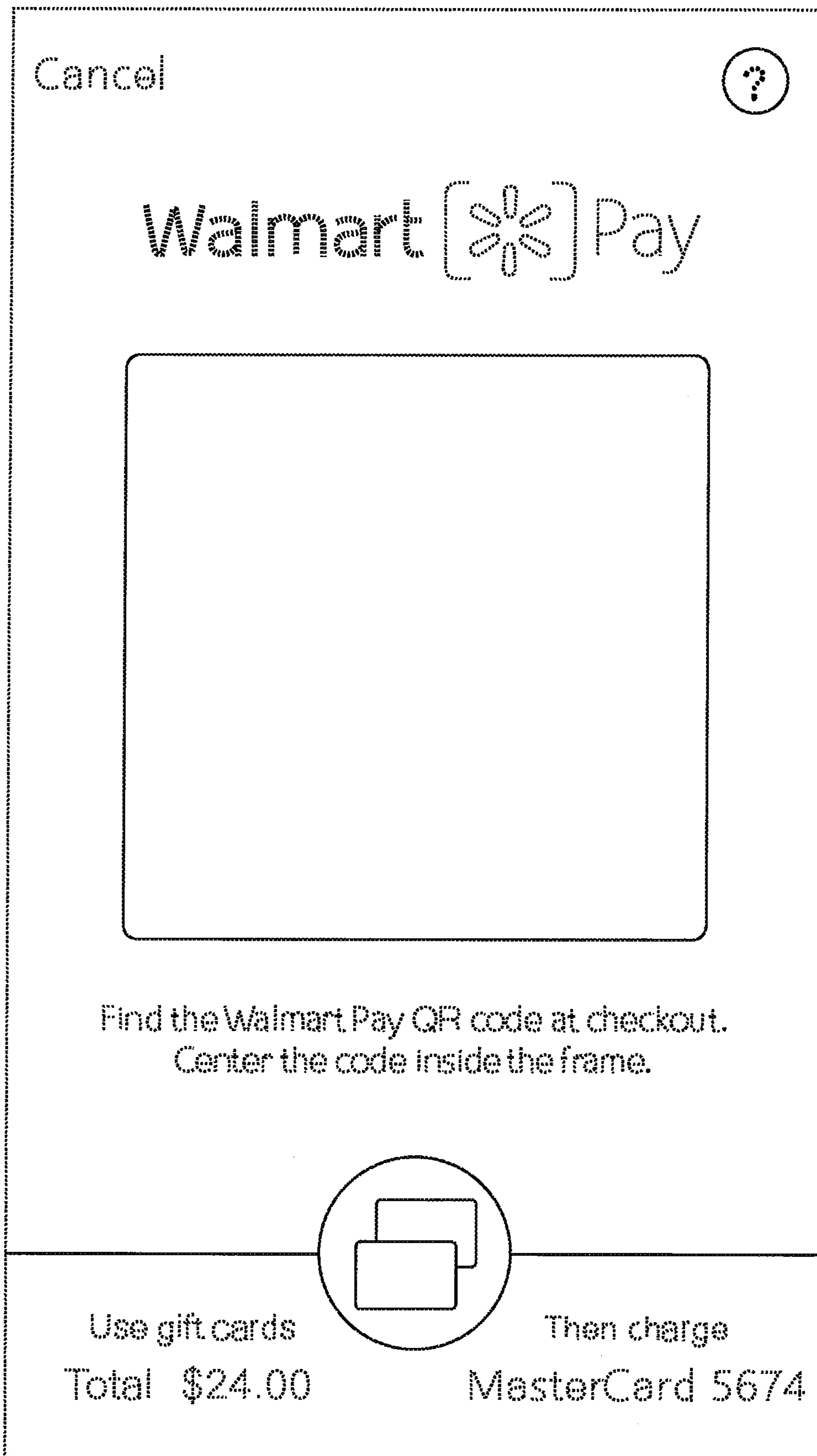





