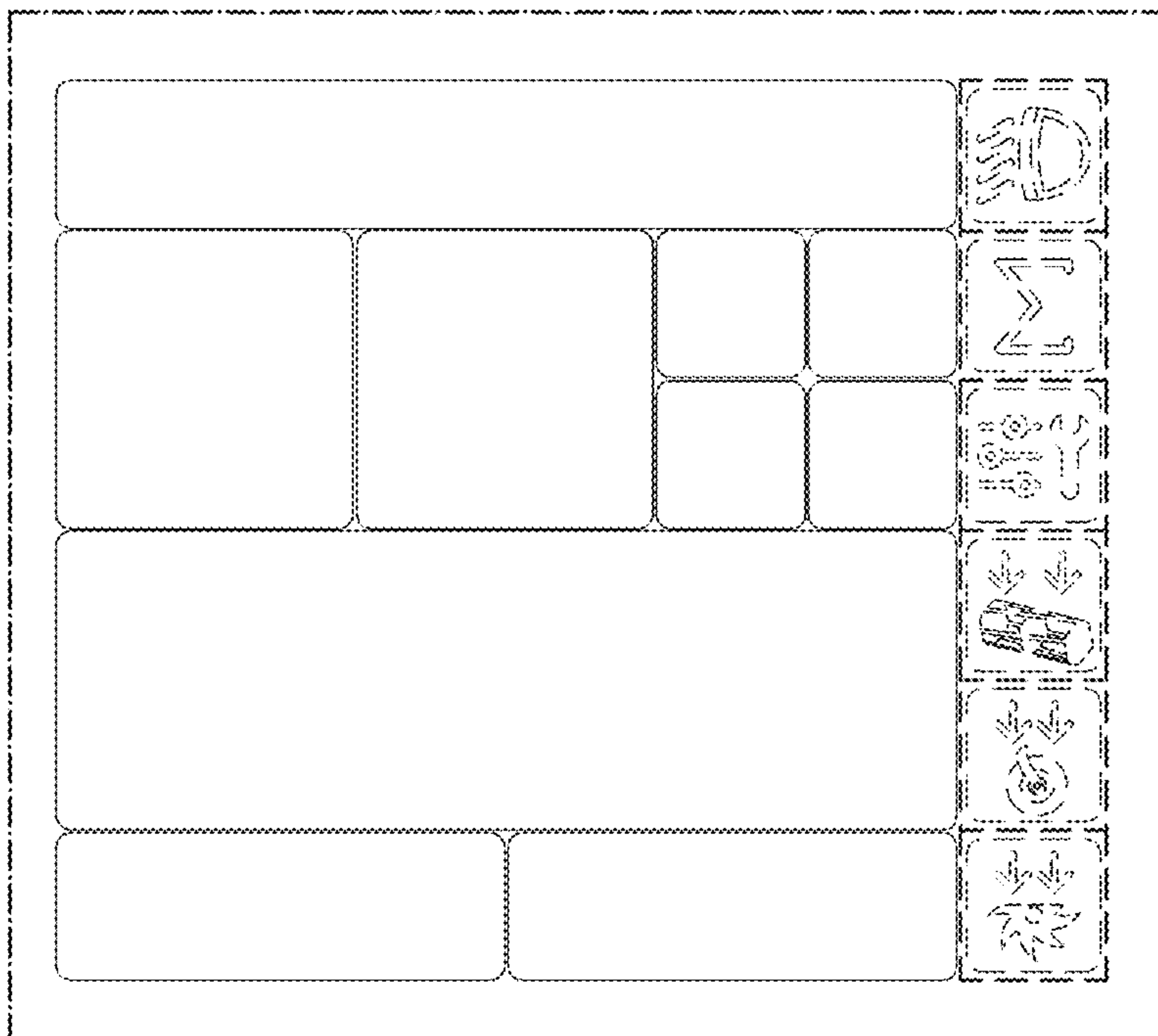
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing our new design; FIG. 2 shows a second embodiment thereof; and, FIG. 3 shows a third embodiment thereof. The dot-dash lines depict a display screen or portion thereof and form no part of the claimed design. 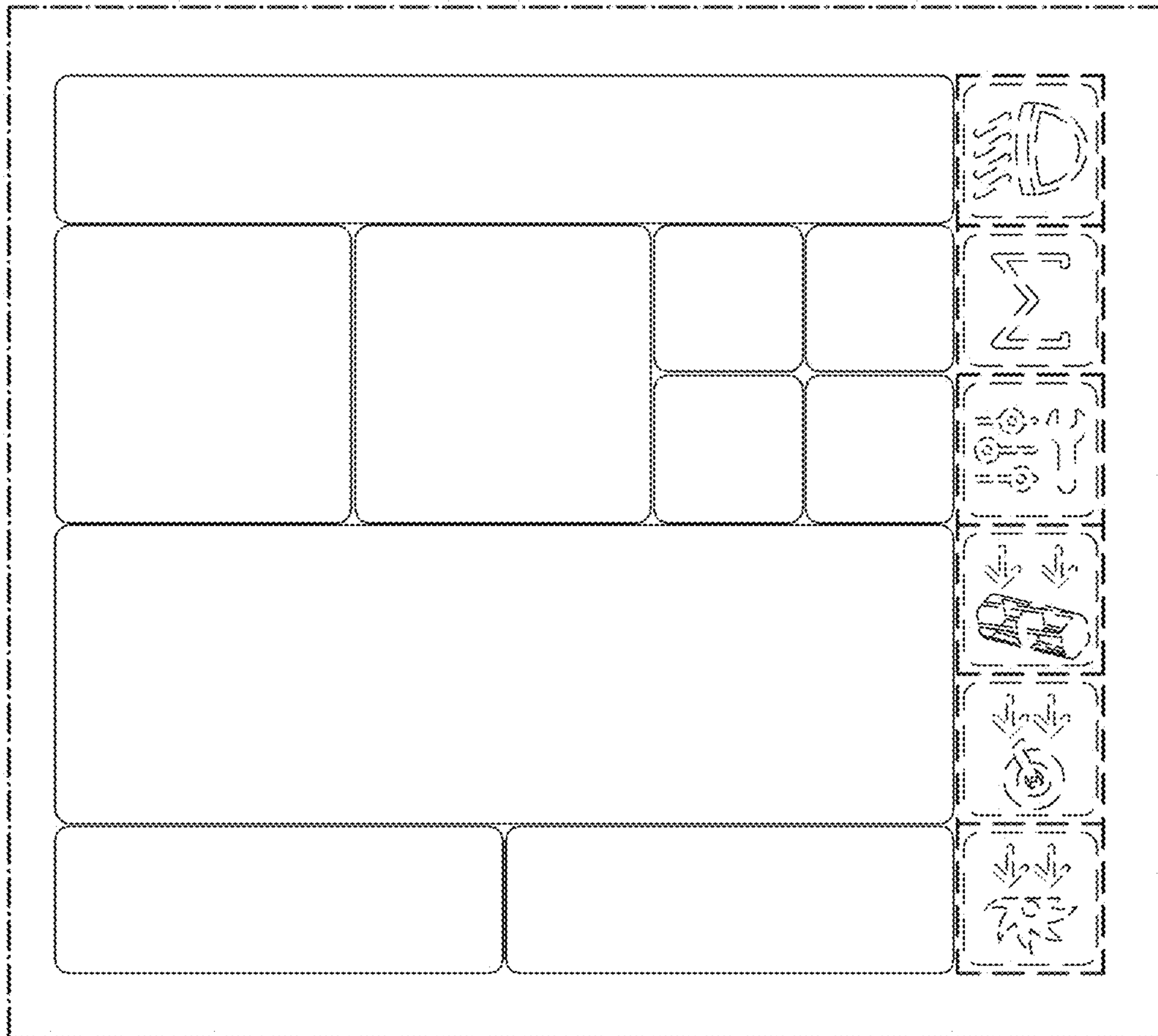

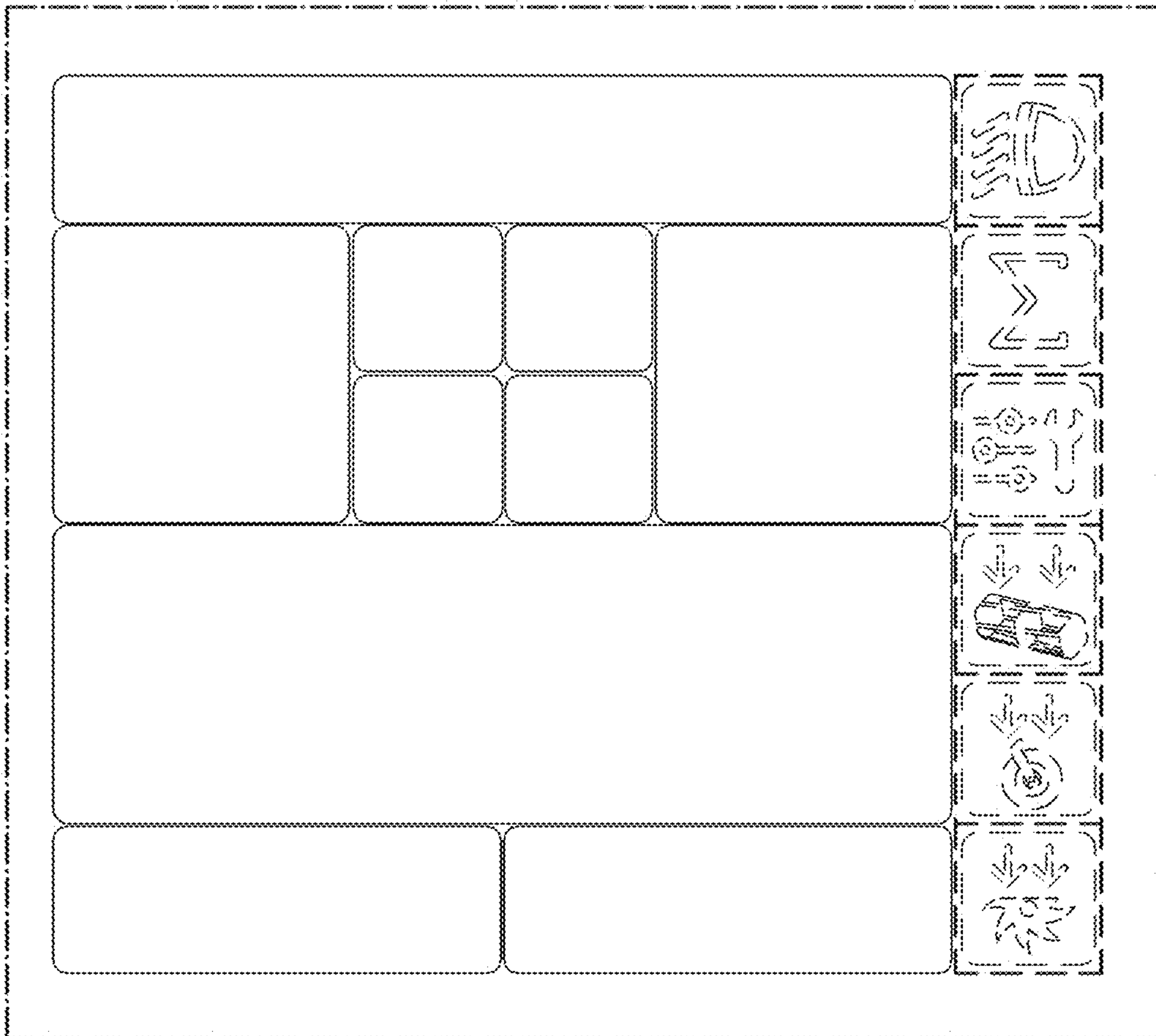

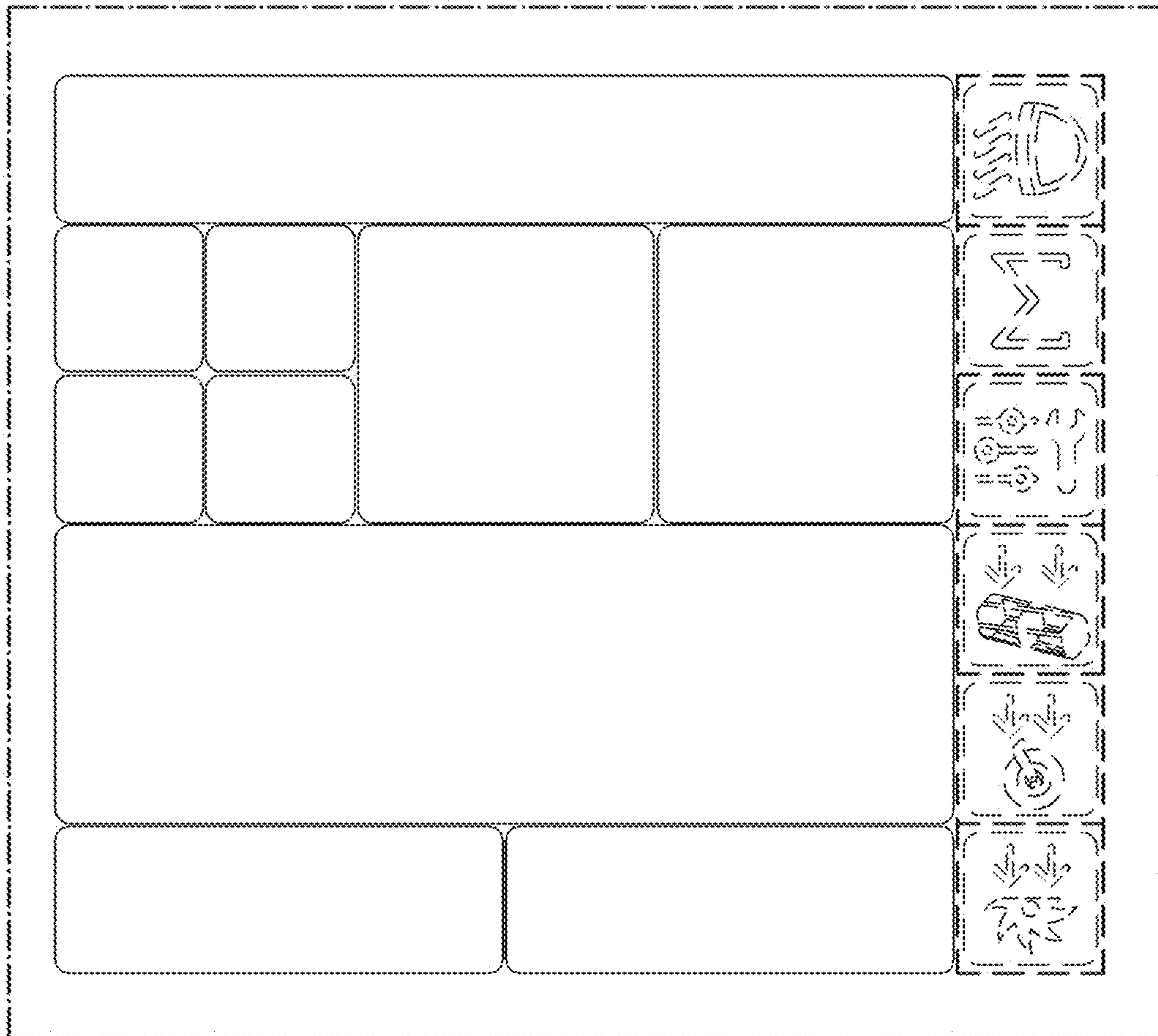
