(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with animated graphical user interface showing a first image of a sequence for my new design;

FIG. 2 is the second image thereof; and,

FIG. 3 is the third image thereof.

The appearance of the display screen with animated graphical user interface sequentially transitions between the images shown in FIGS. 1-3. The process or period in which one image transitions to another image forms no part of the claimed design.

The outer broken line showing the display screen and all other broken lines showing portions of the graphical user interface are included for the purpose of illustrating portions of the article that form no part of the claimed design.

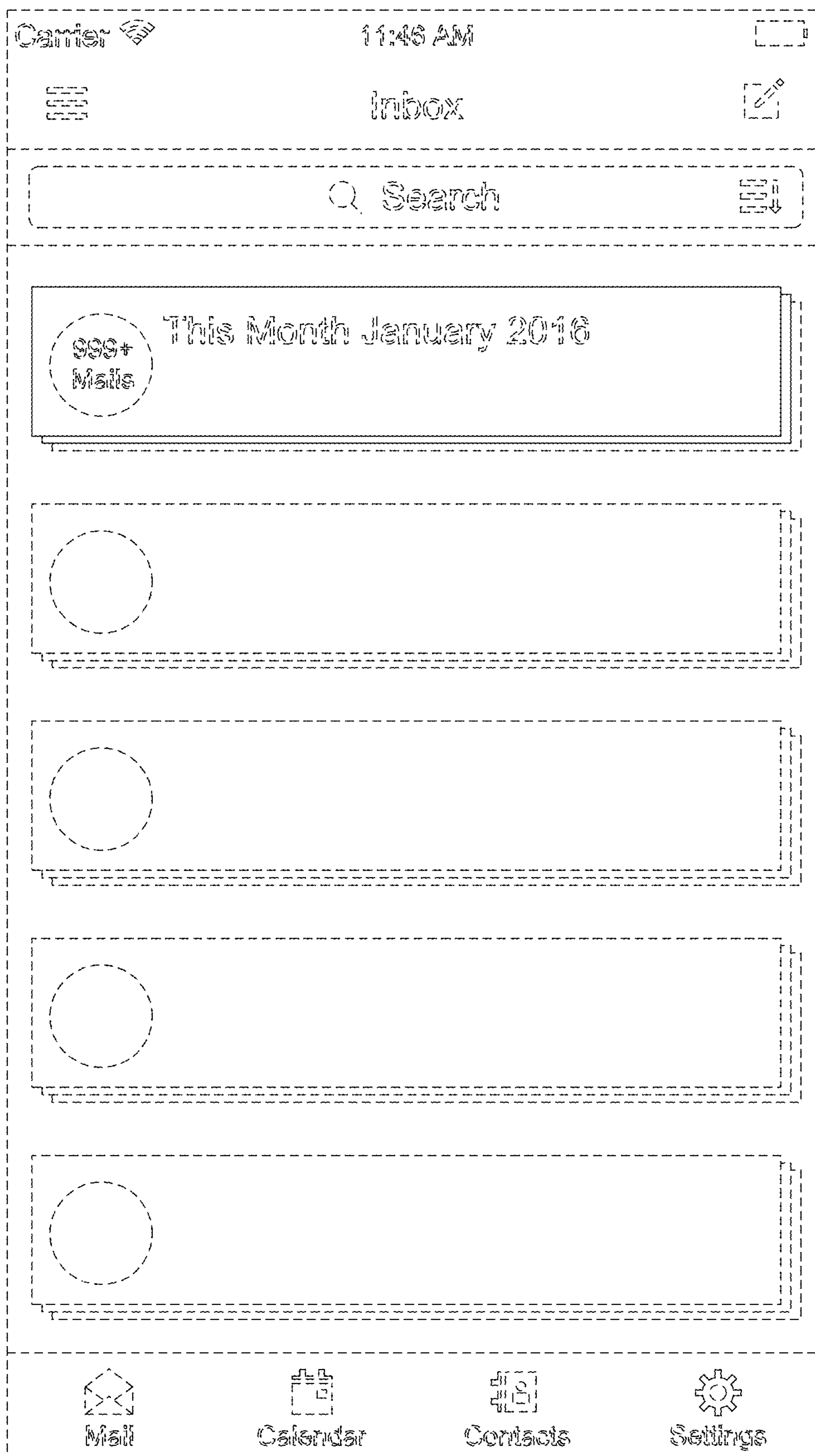

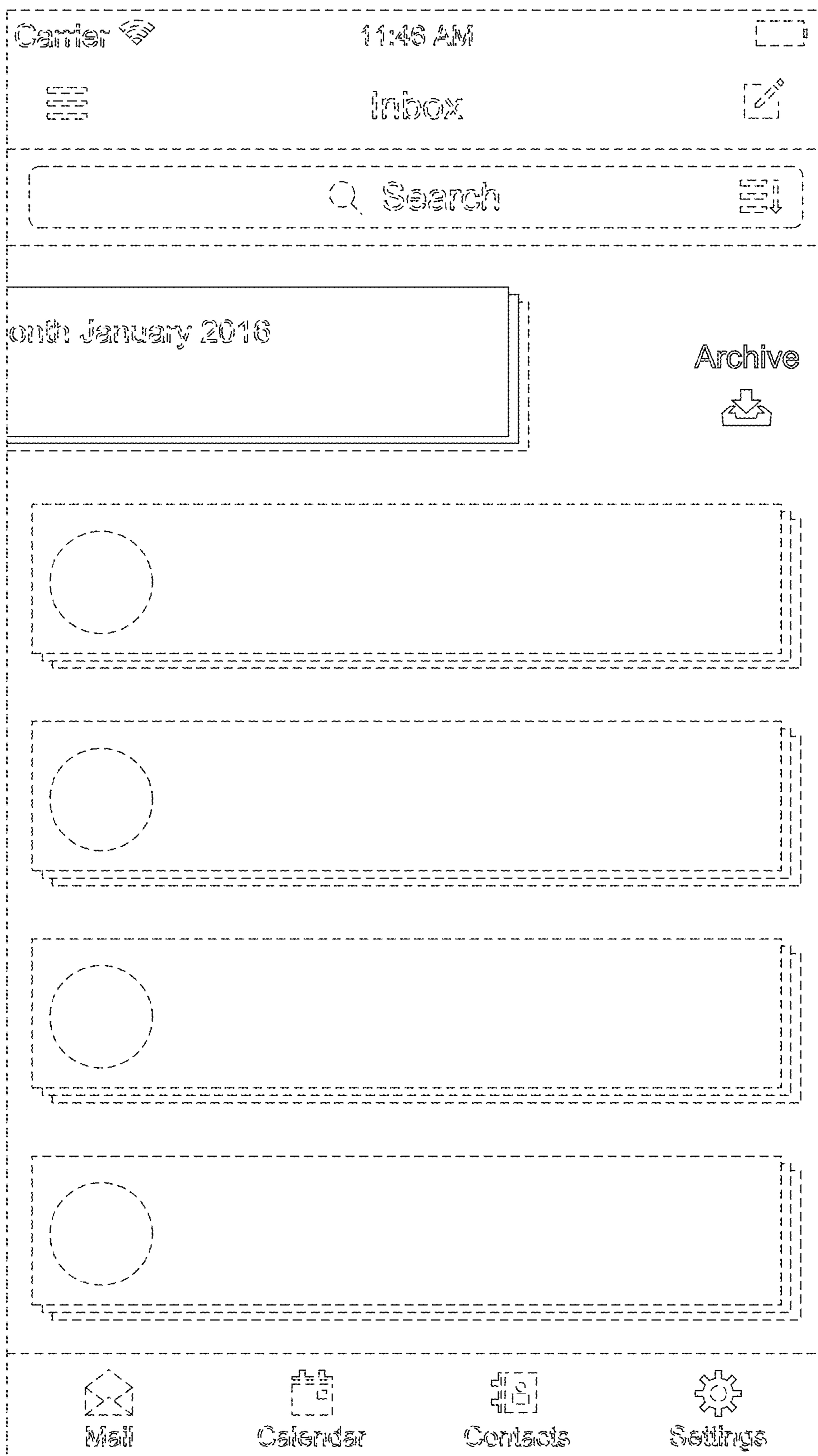

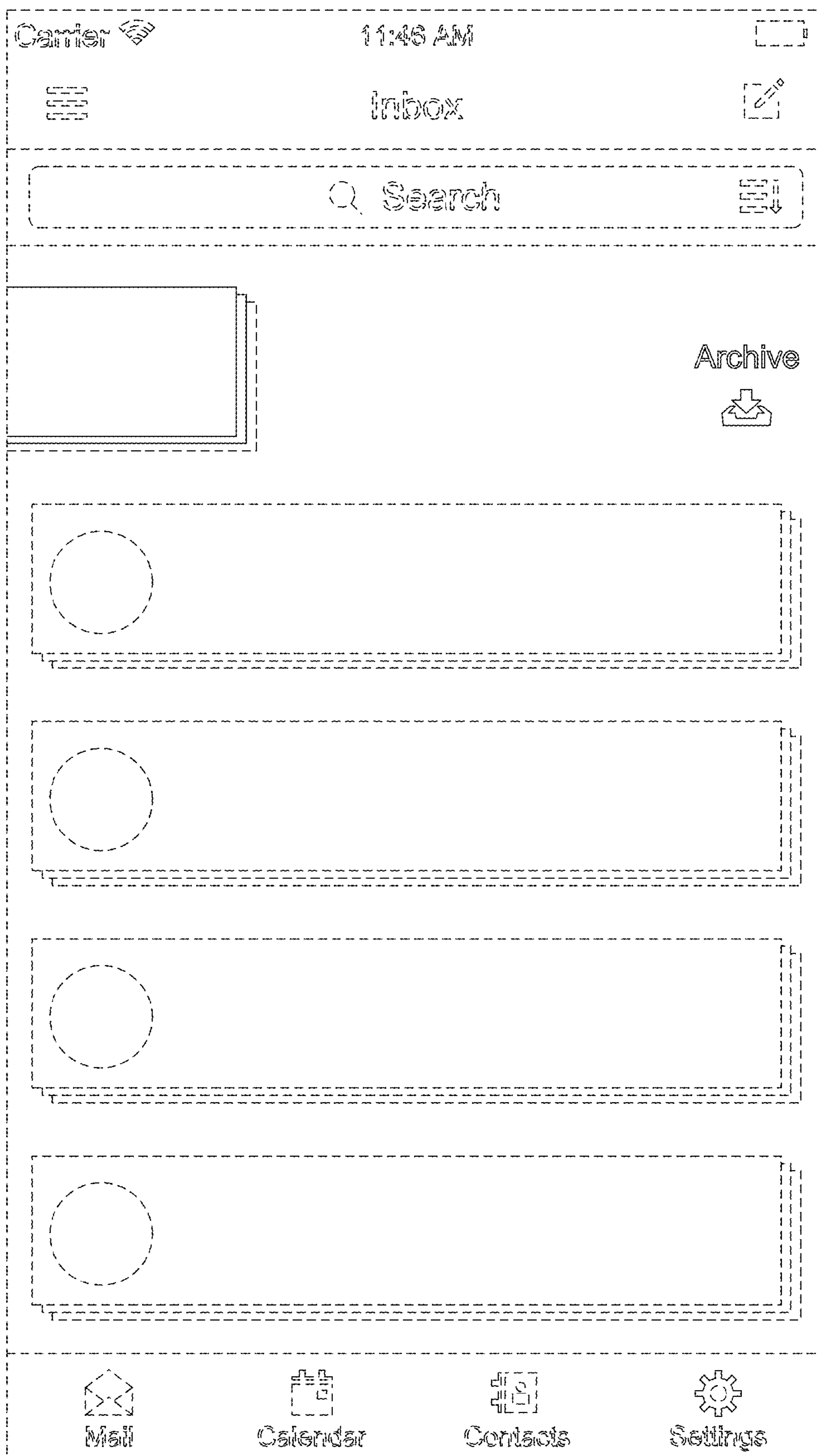
