The ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

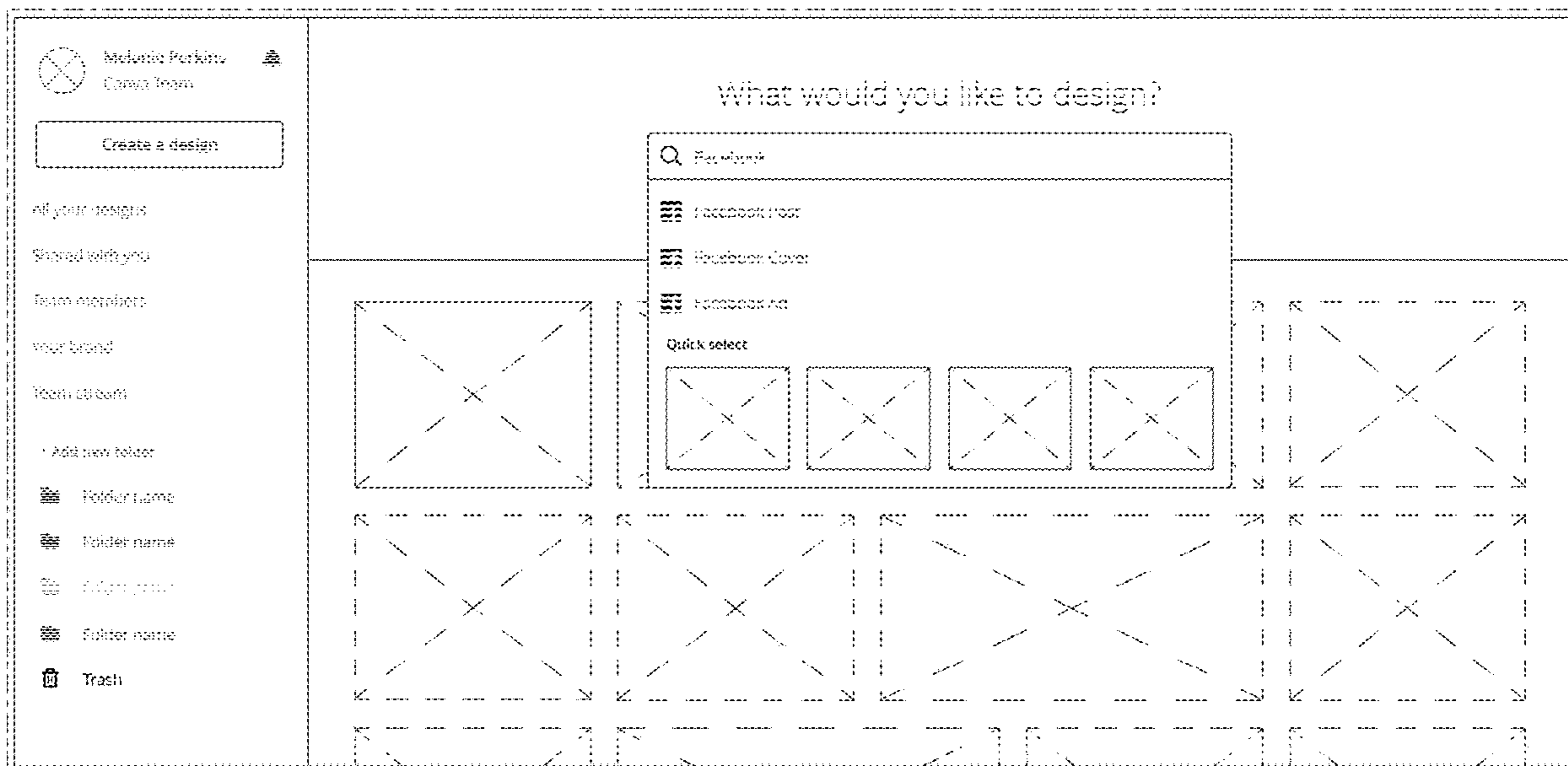
**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with a graphical user interface in accordance with a first embodiment; and,

FIG. 2 is a front view of a display screen or portion thereof with a graphical user interface in accordance with a second embodiment.

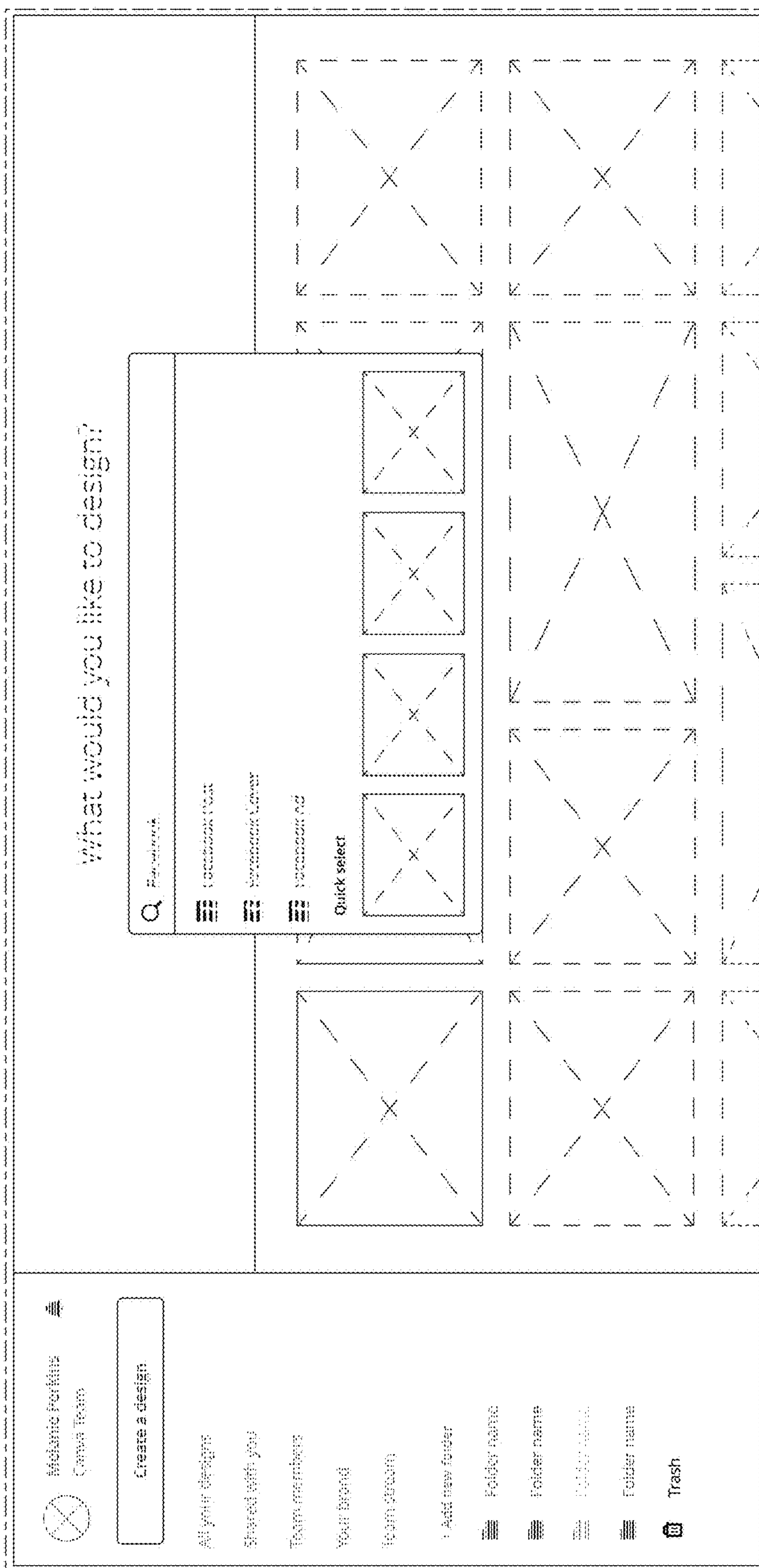

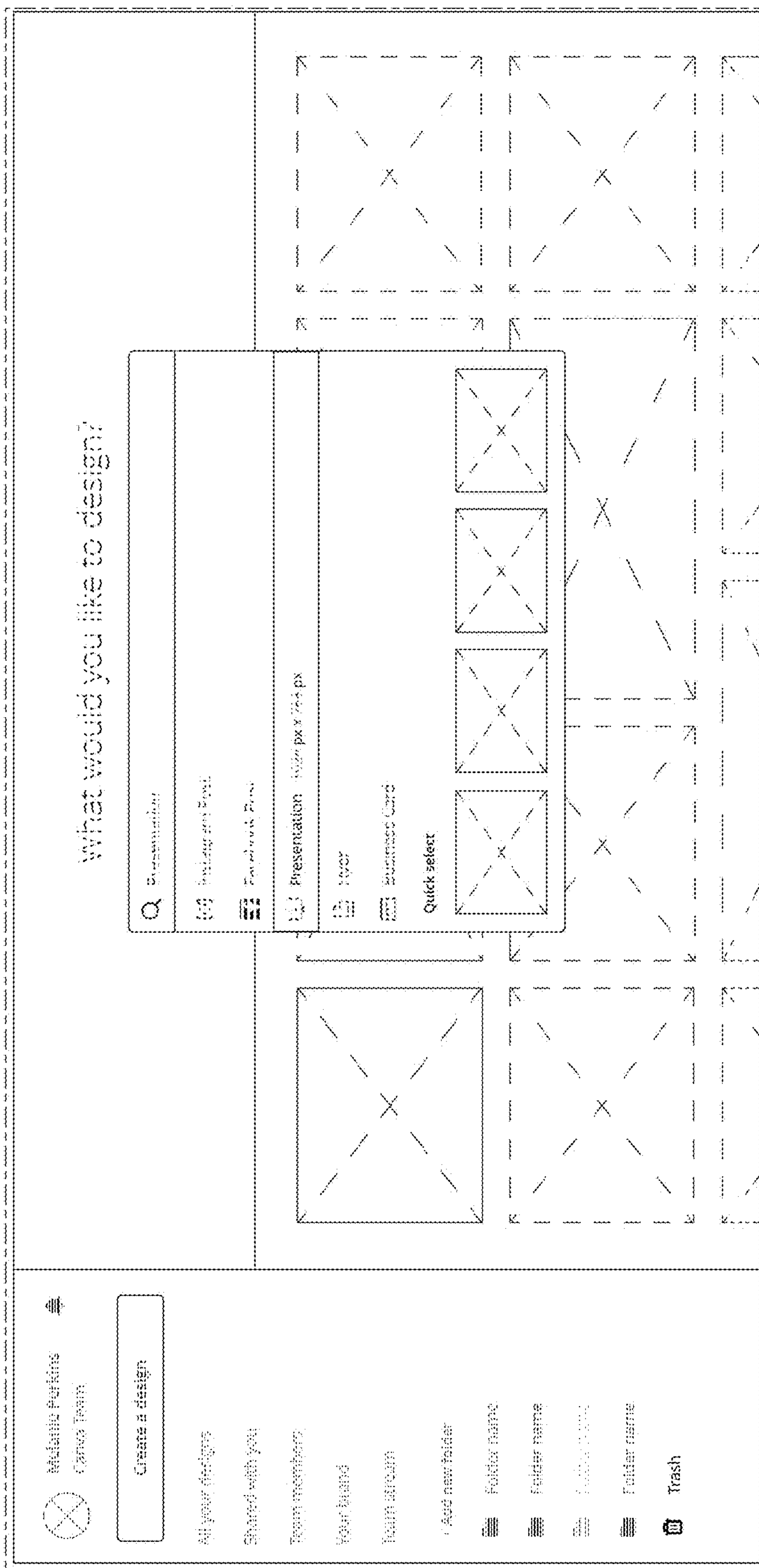
