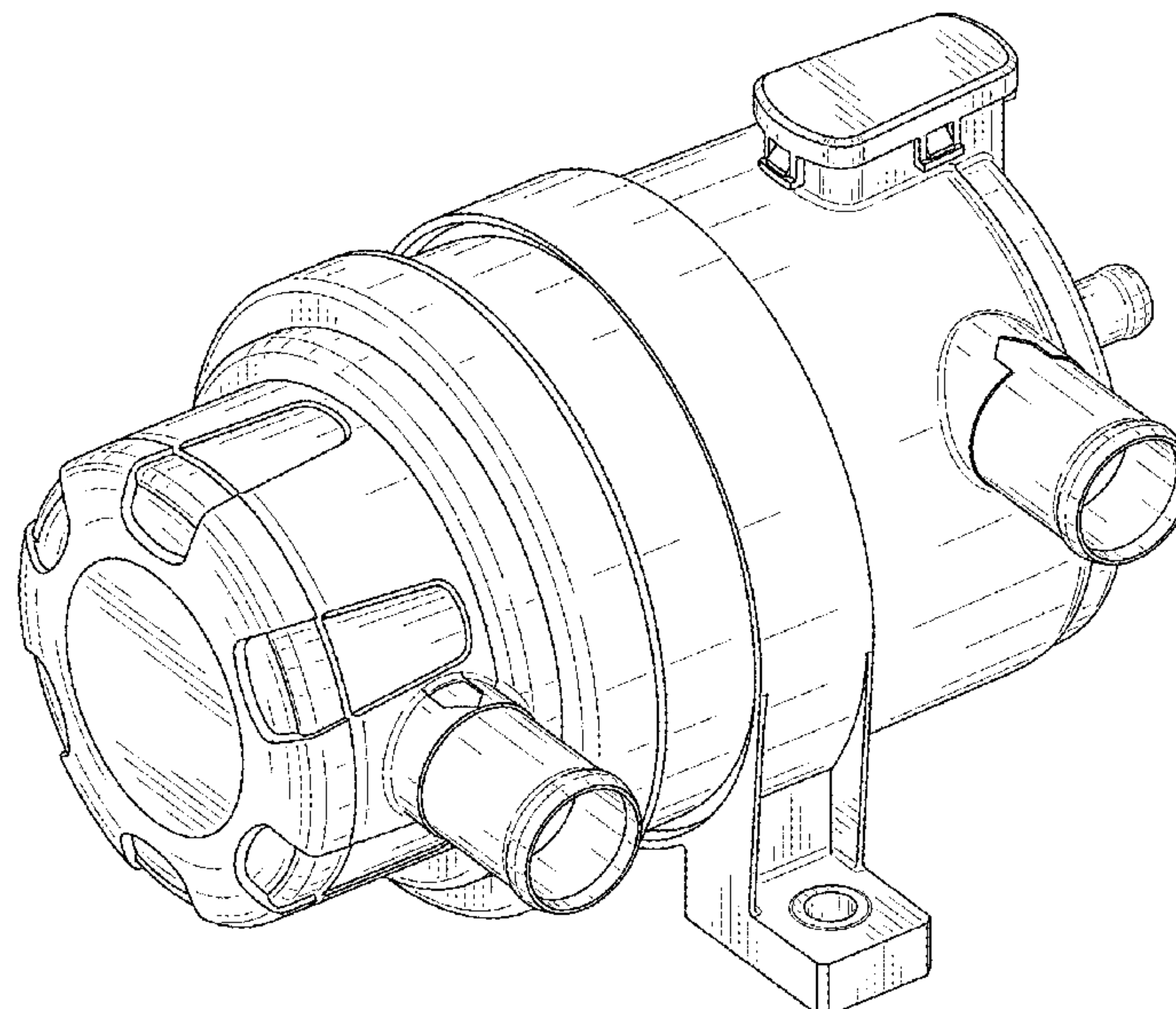
(57) **CLAIM**

We claim the ornamental design for a crankcase ventilation device housing, as shown and described.

DESCRIPTION

FIG. 1 shows a left front perspective view of a crankcase ventilation device housing showing our new design; FIG. 2 shows a left side elevational view thereof; FIG. 3 shows a right side elevational view thereof; FIG. 4 shows a front elevational view thereof; FIG. 5 shows a rear elevational view thereof; FIG. 6 shows a top plan view thereof; and, FIG. 7 shows a bottom plan view thereof. The broken lines illustrate the portions of the crankcase ventilation device housing that forms no part of the claimed design.

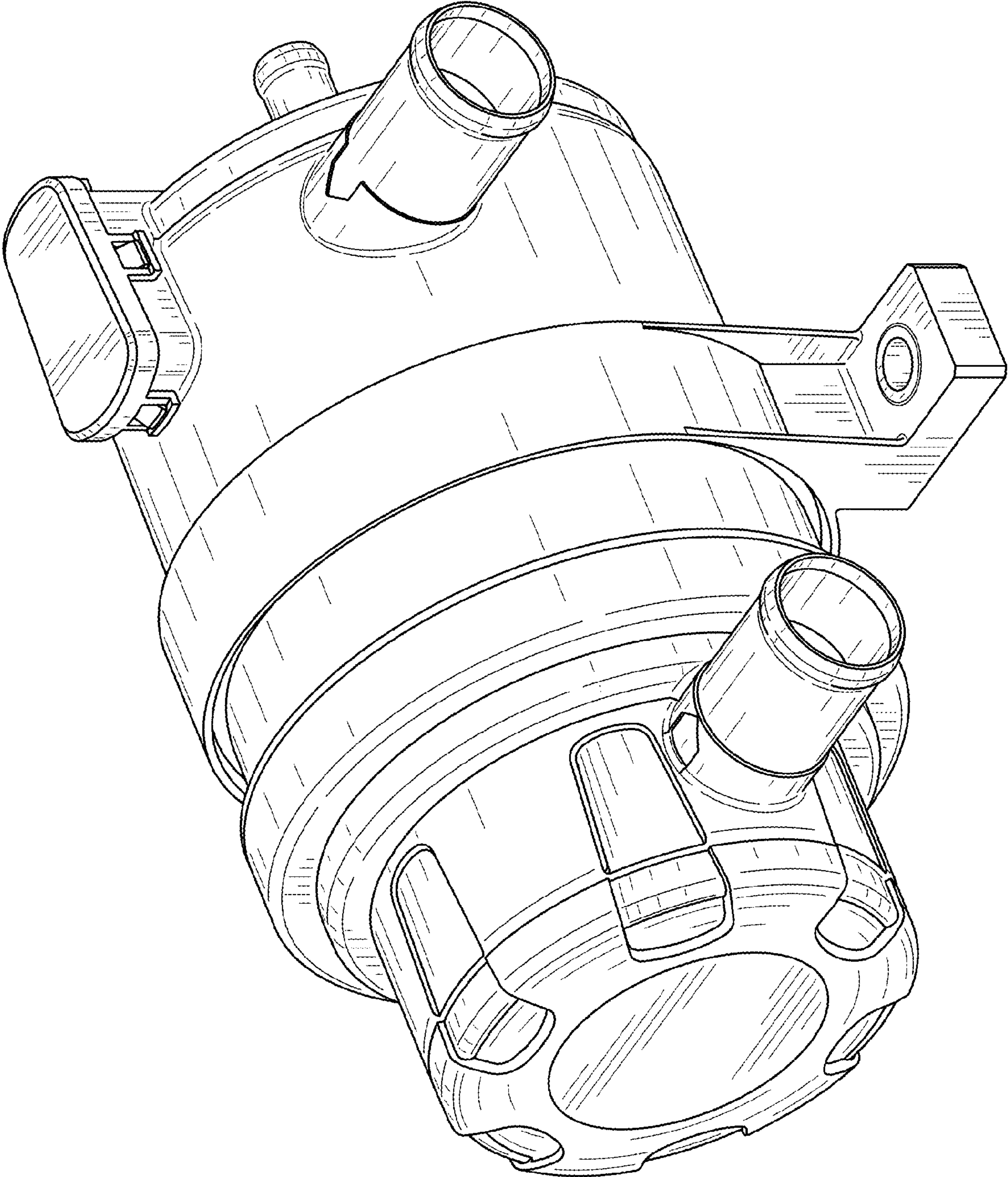

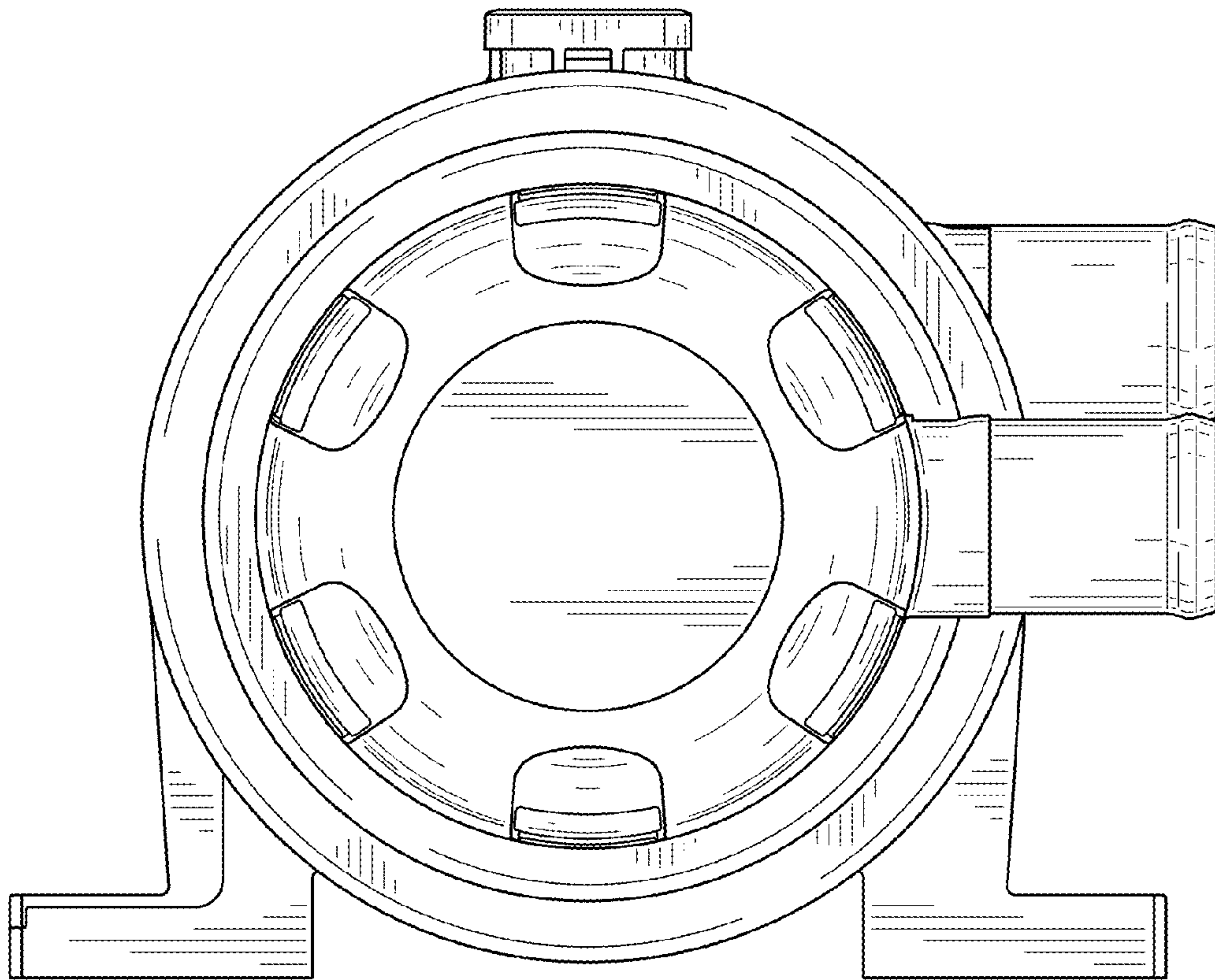

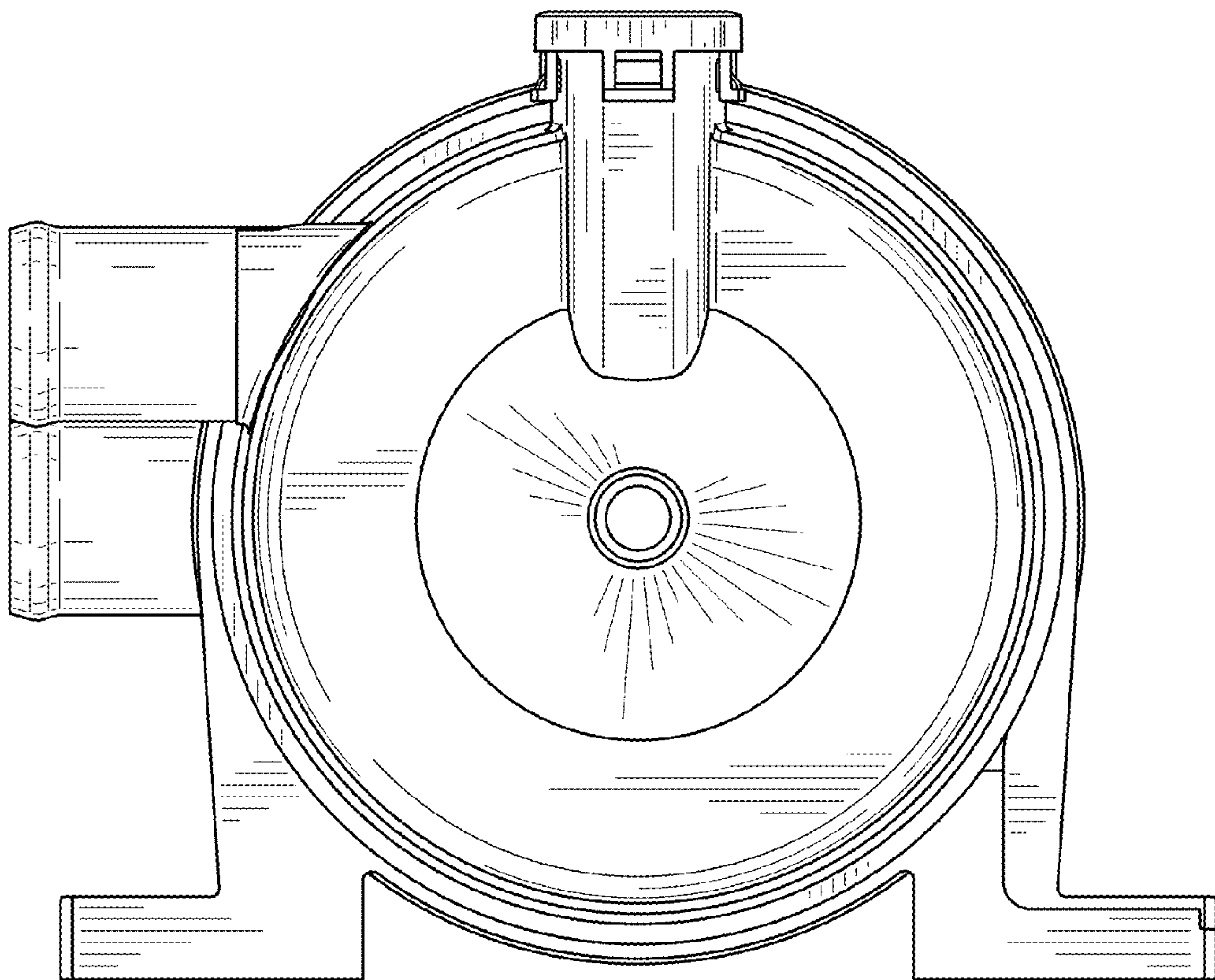

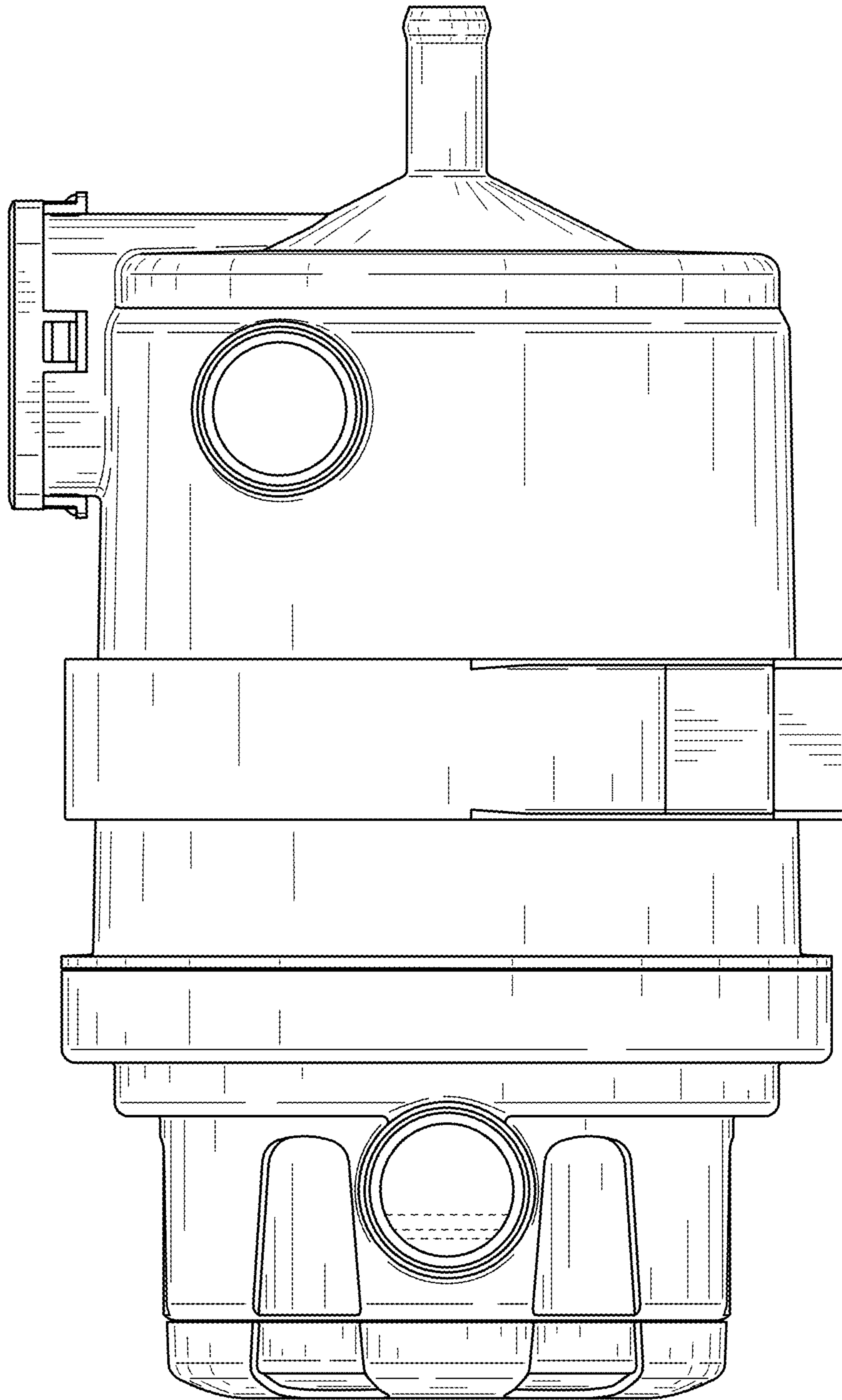

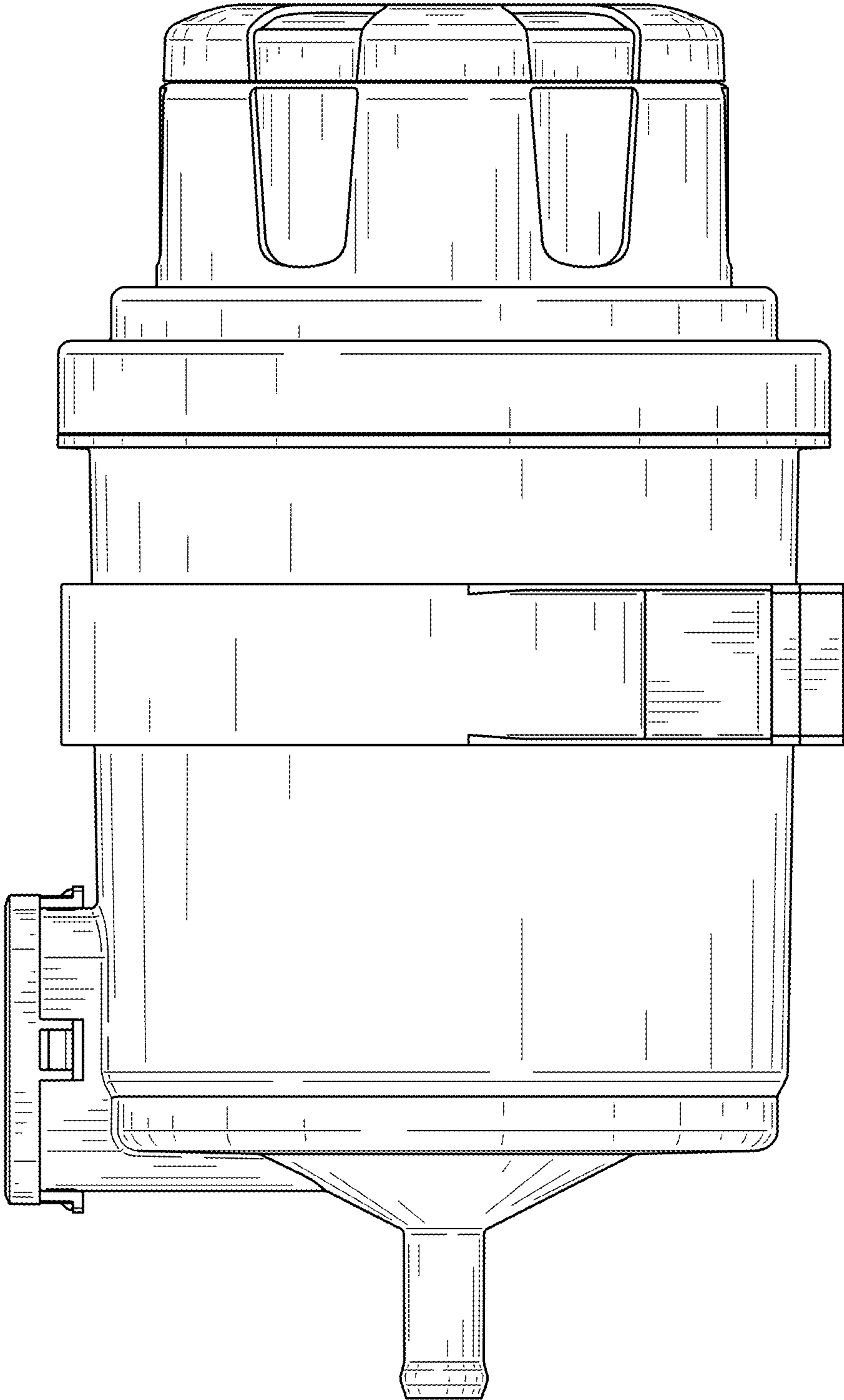

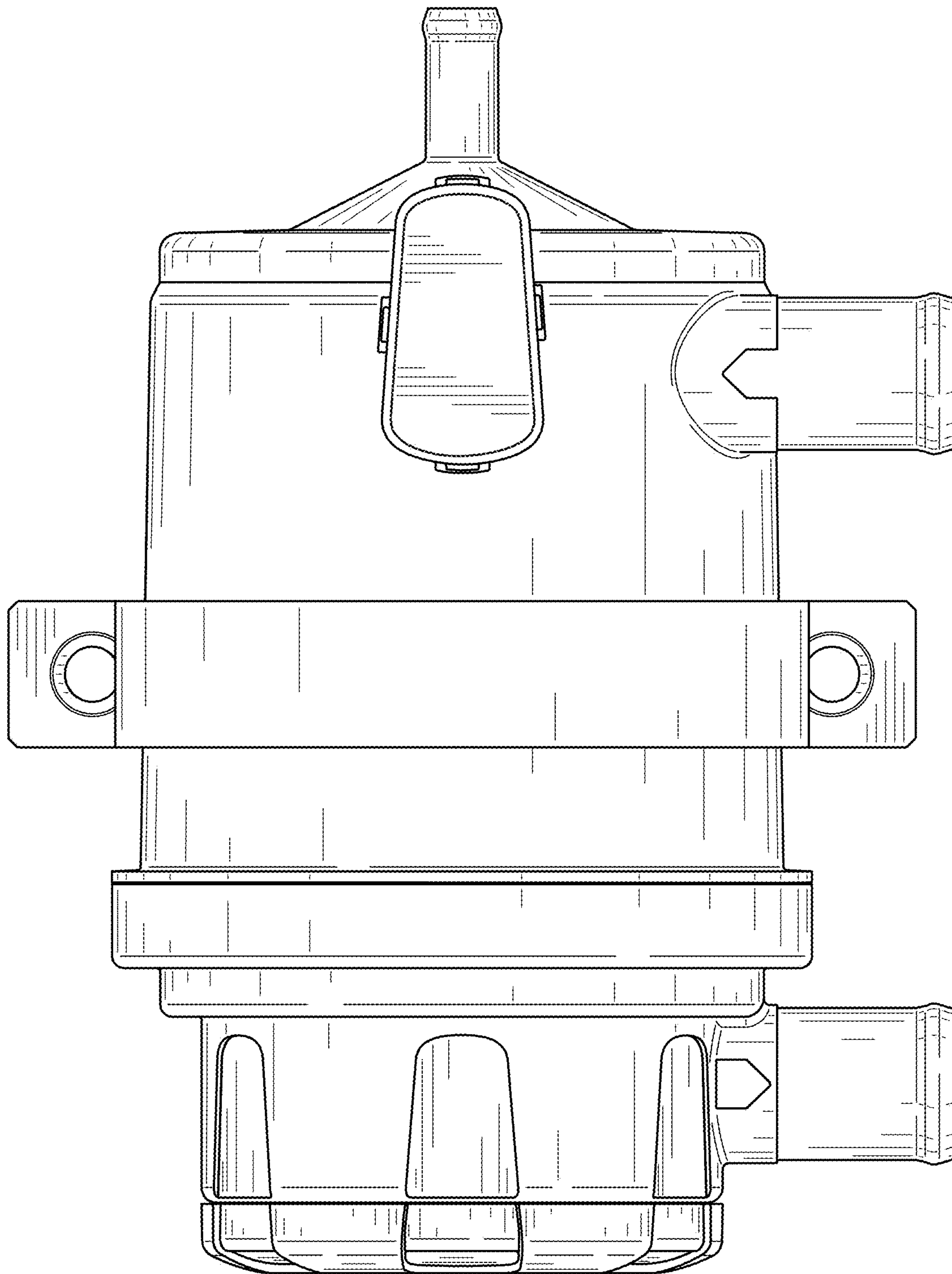

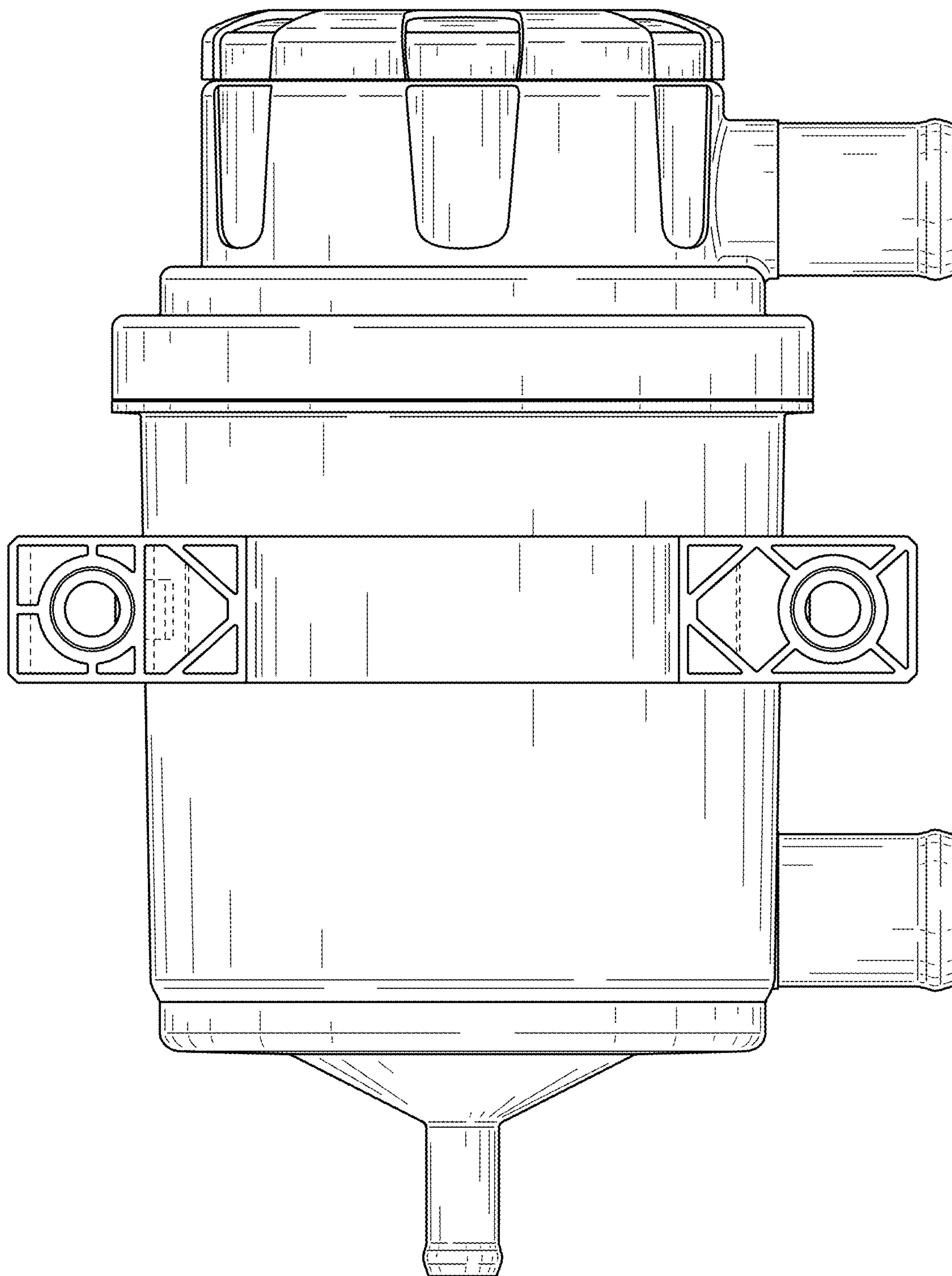
