DESCRIPTION

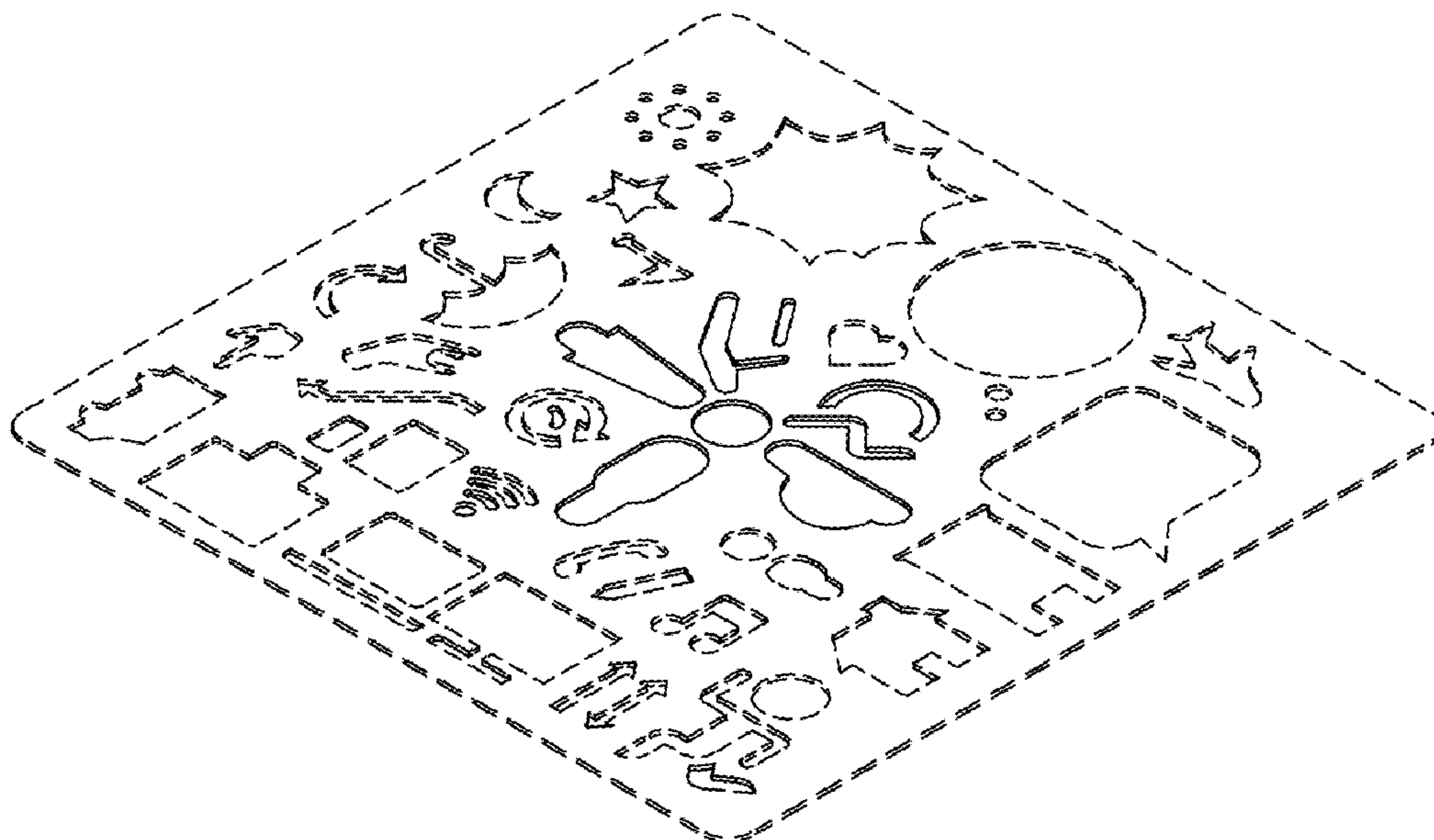
FIG. 1 is a perspective view of a drafting template showing our new design;

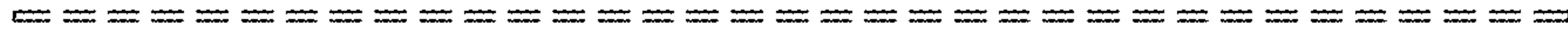

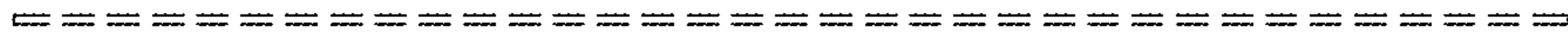

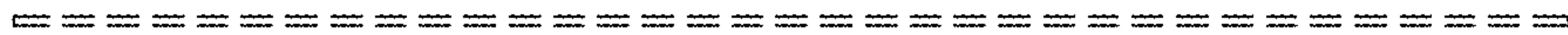

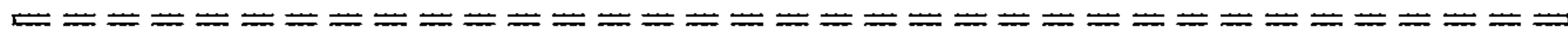
