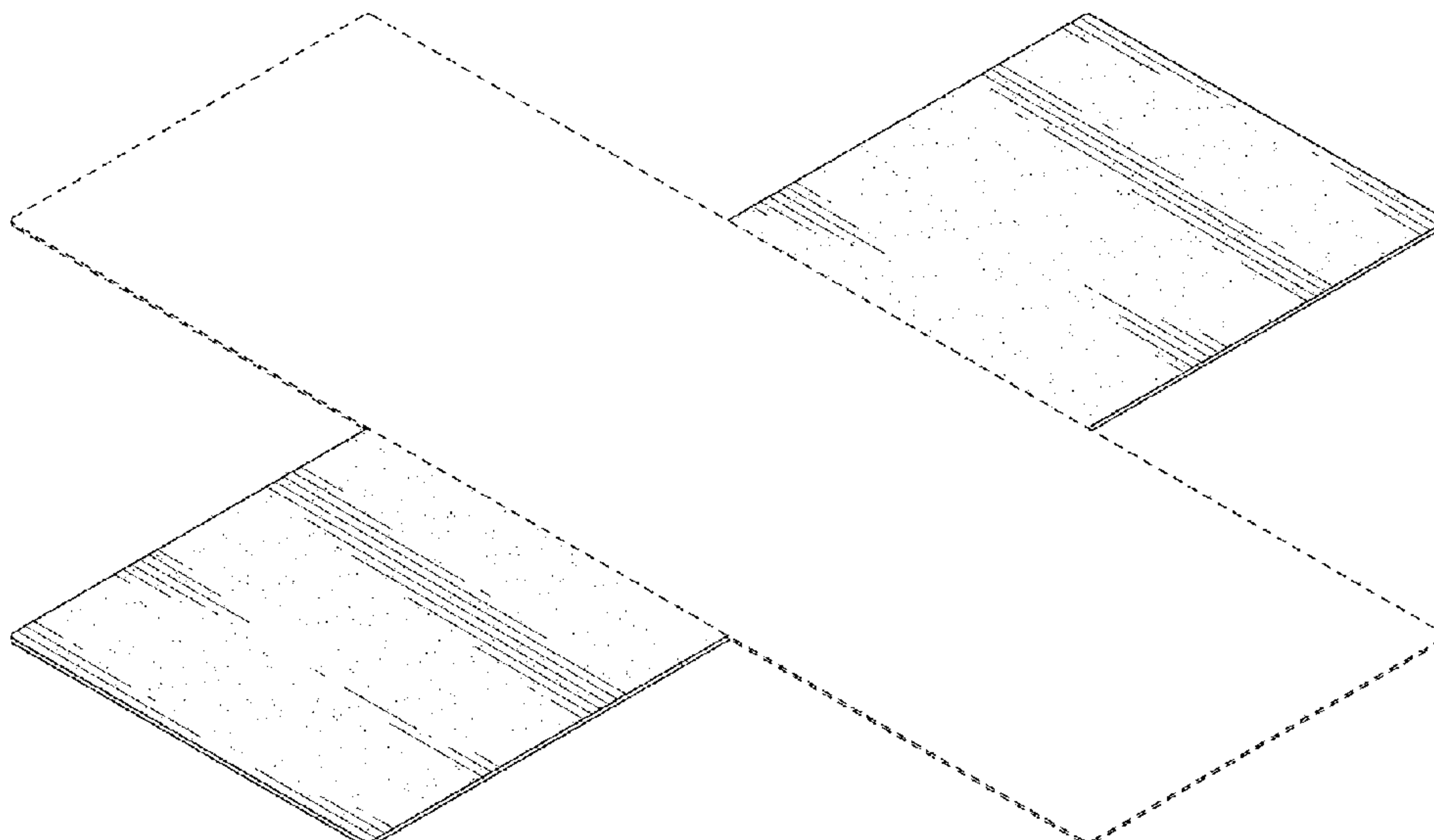
(57) **CLAIM**

We claim the ornamental design of the exercise mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first configuration of the exercise mat embodying the new design shown with an environmental exercise mat;  
FIG. 2 is a perspective view of the exercise mat of FIG. 1 without the environmental exercise mat;  
FIG. 3 is a front view of the exercise mat of FIG. 2;  
FIG. 4 is a detail view of a portion of FIG. 3 as indicated;  
FIG. 5 is a left side view of the exercise mat of FIG. 2, the right side view being a mirror image thereof;  
FIG. 6 is a top view of the exercise mat of FIG. 2;  
FIG. 7 is a bottom view of the exercise mat of FIG. 2;  
FIG. 8 is a perspective view of a second configuration of the exercise mat embodying the new design shown with an environmental exercise mat;  
FIG. 9 is a perspective view of the exercise mat of FIG. 8 without the environmental exercise mat;  
FIG. 10 is a front view of the exercise mat of FIG. 9;  
FIG. 11 is a detail view of a portion of FIG. 10 as indicated;  
FIG. 12 is a back view of the exercise mat of FIG. 9;  
FIG. 13 is a left side view of the exercise mat of FIG. 9;  
FIG. 14 is a right side view of the exercise mat of FIG. 9;  
FIG. 15 is a top view of the exercise mat of FIG. 9; and,  
FIG. 16 is a bottom view of the exercise mat of FIG. 9.

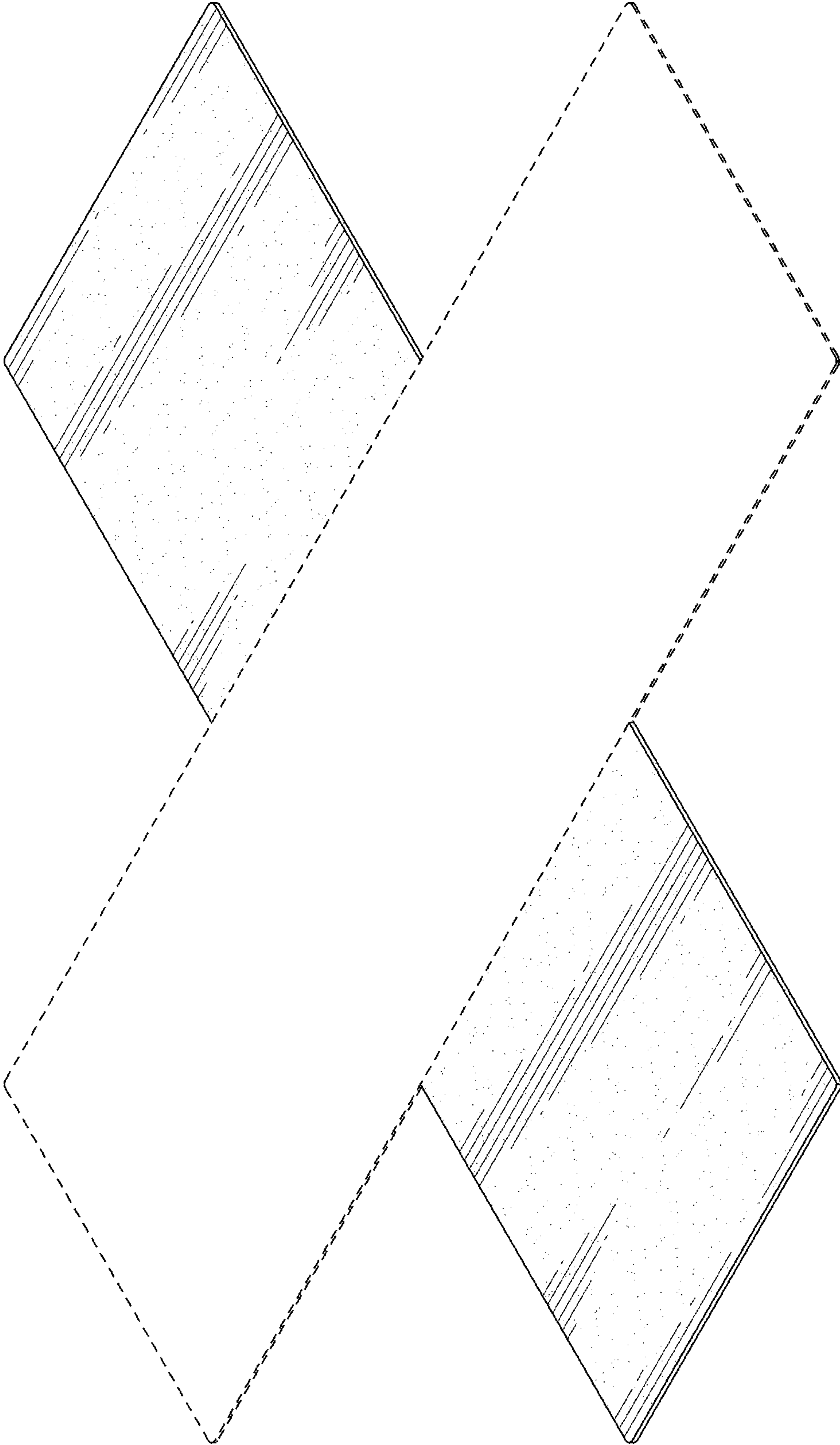

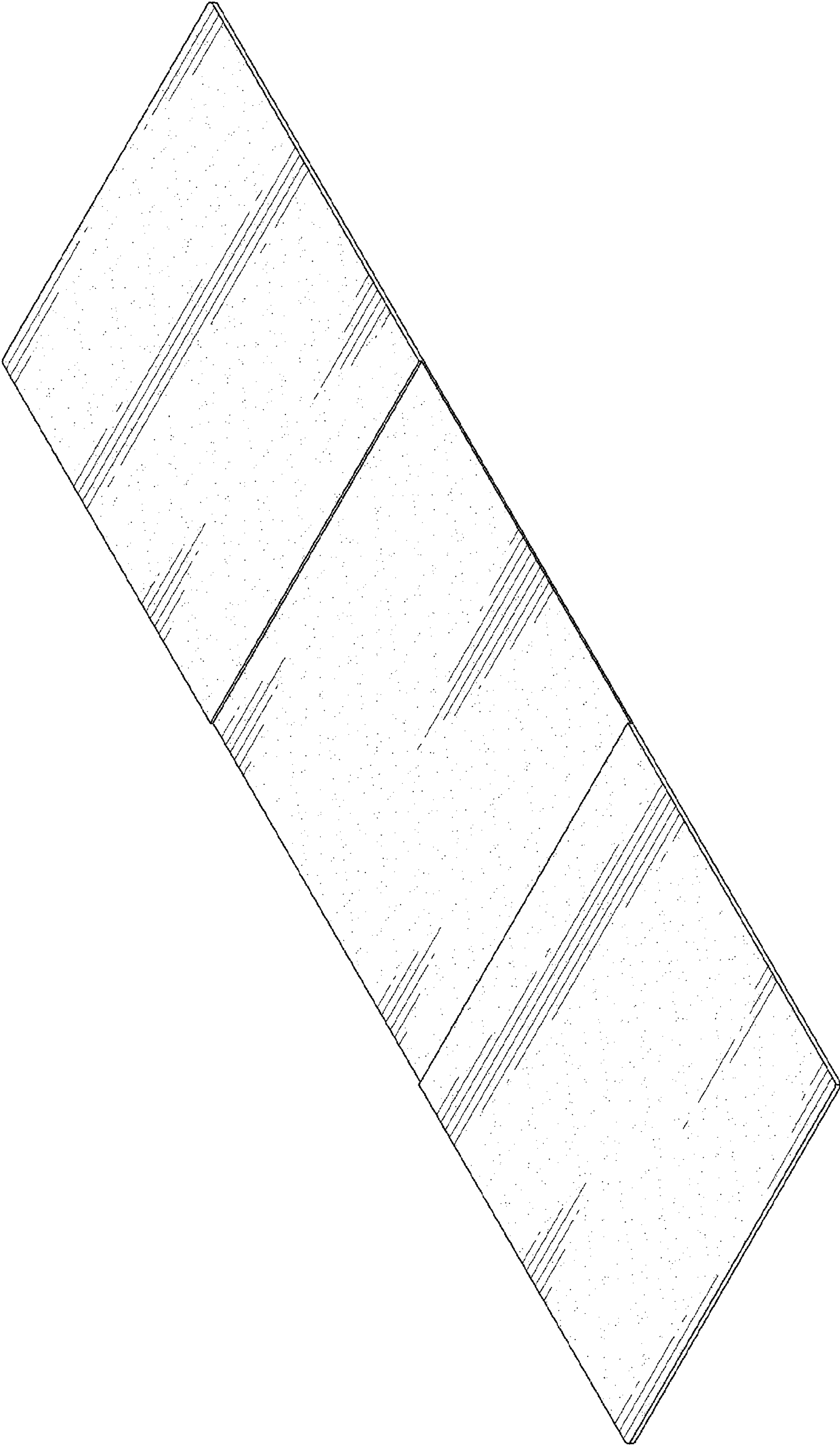

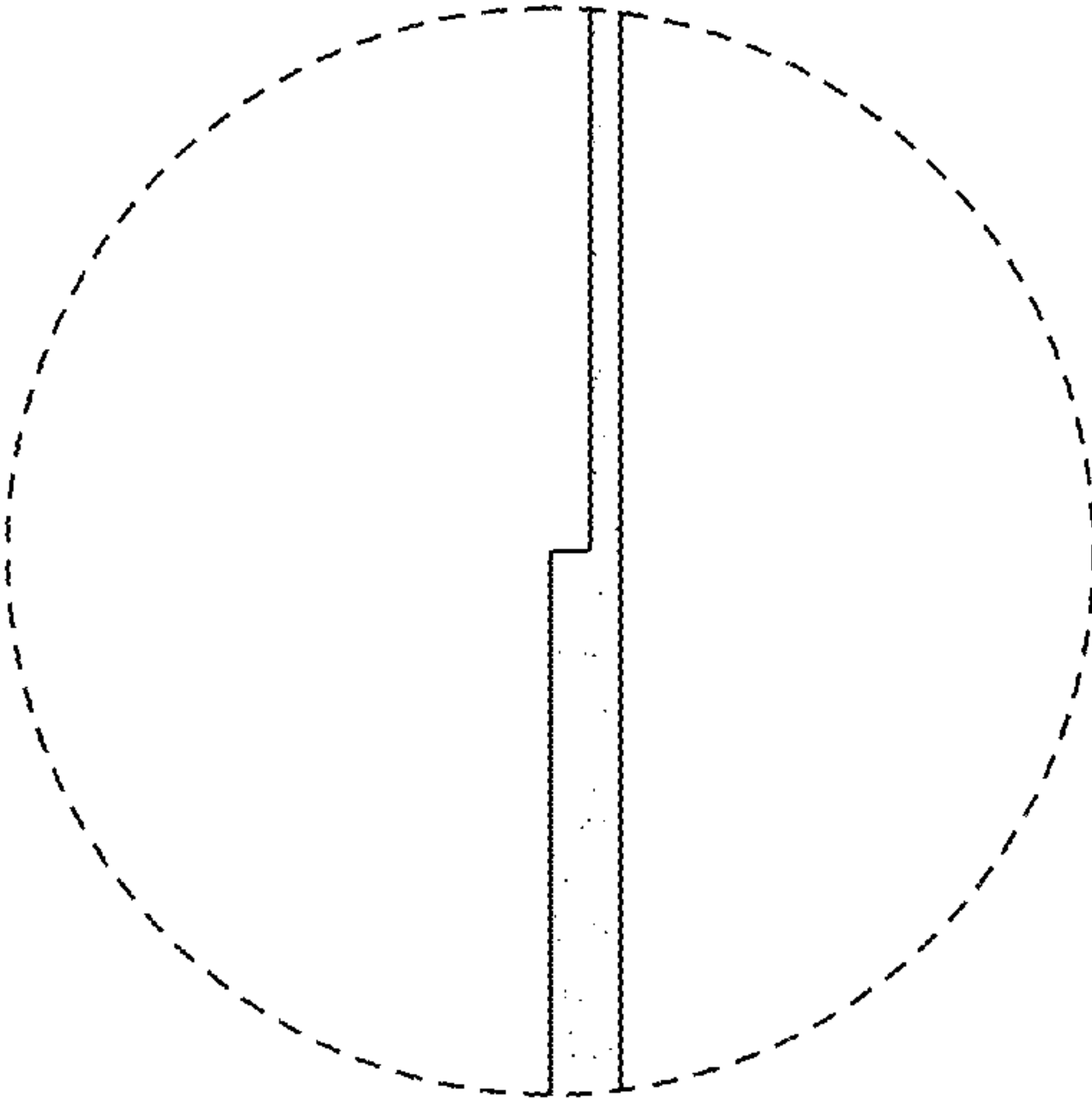

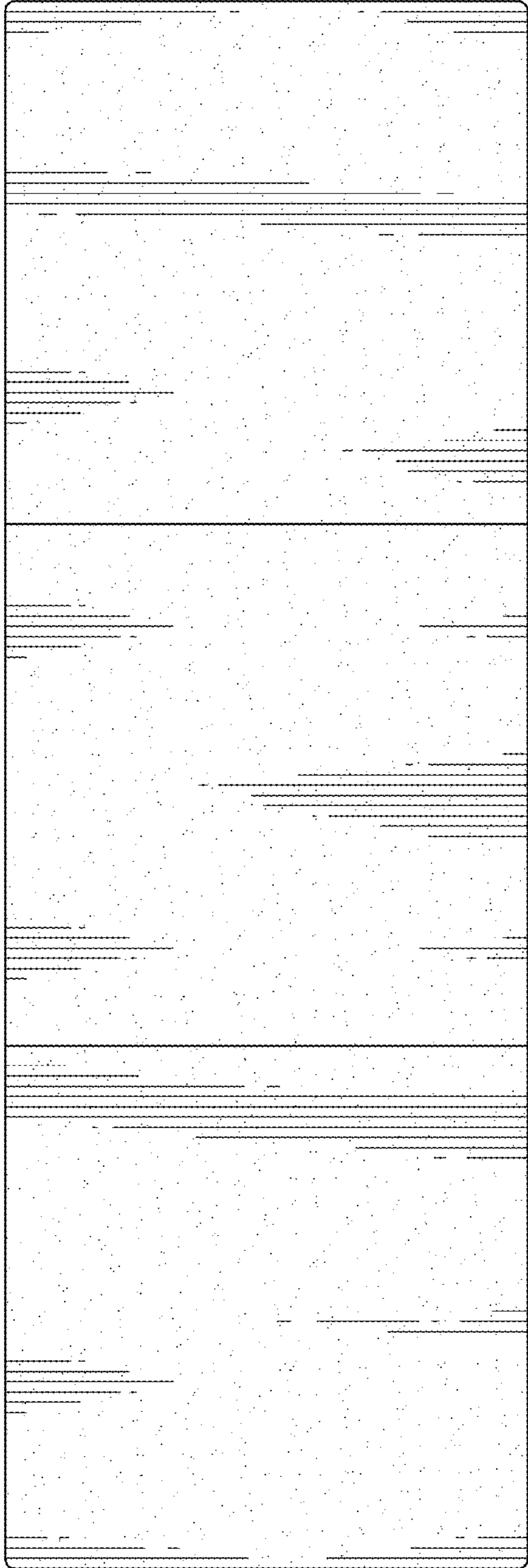

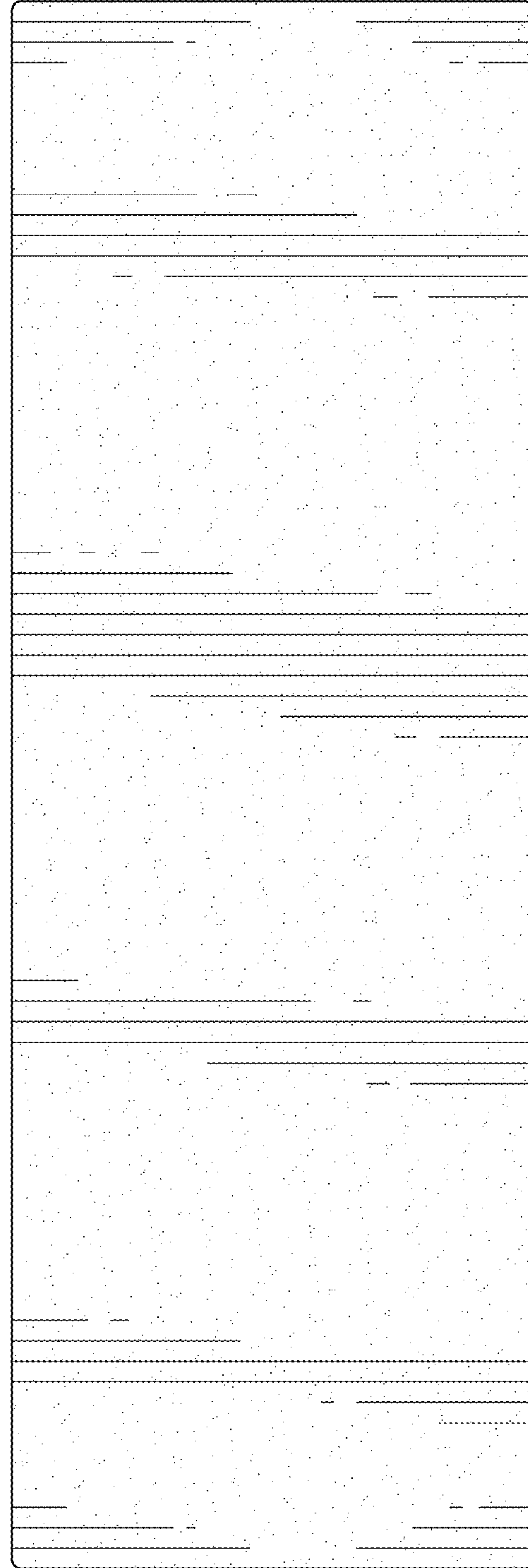

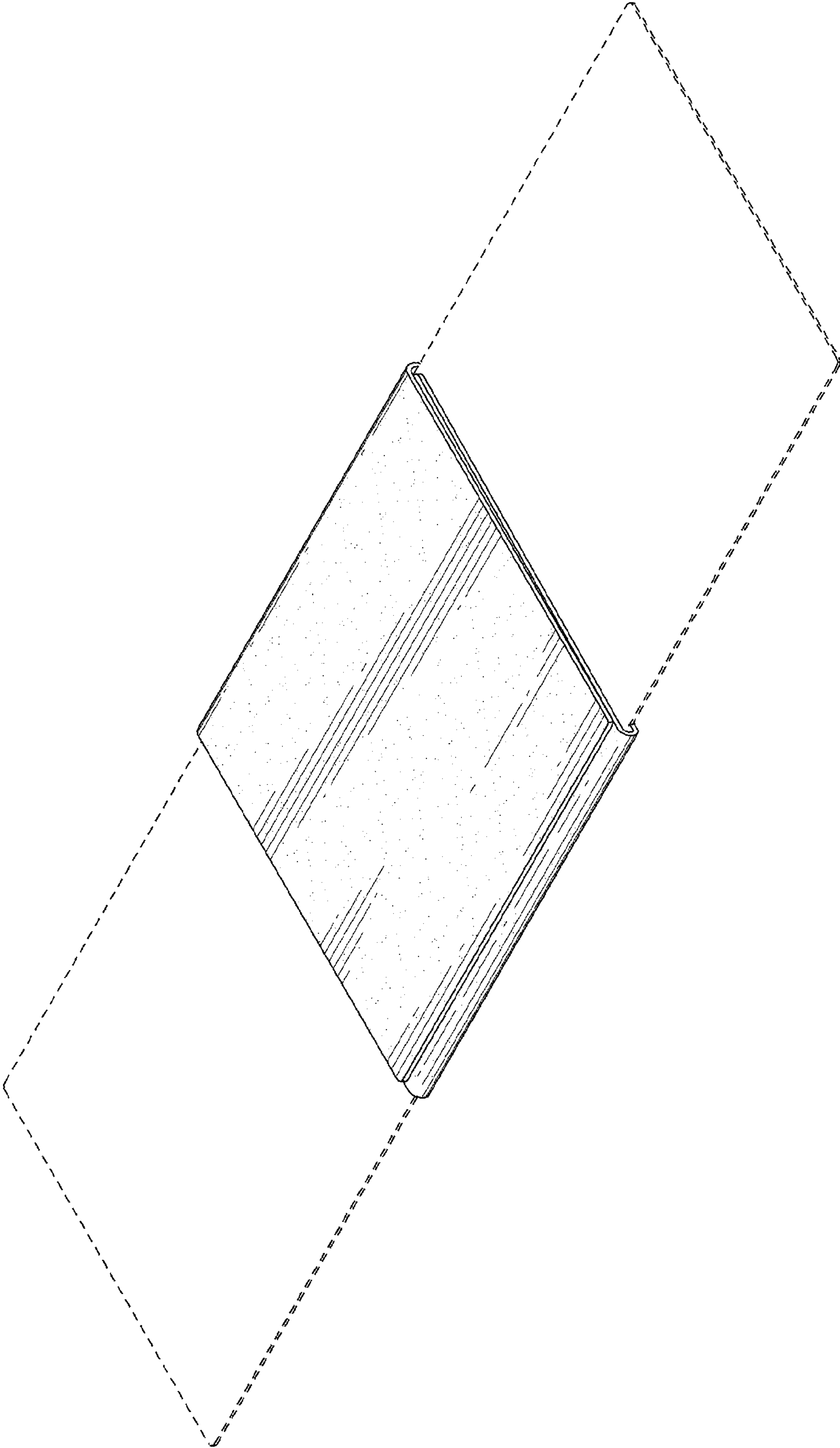

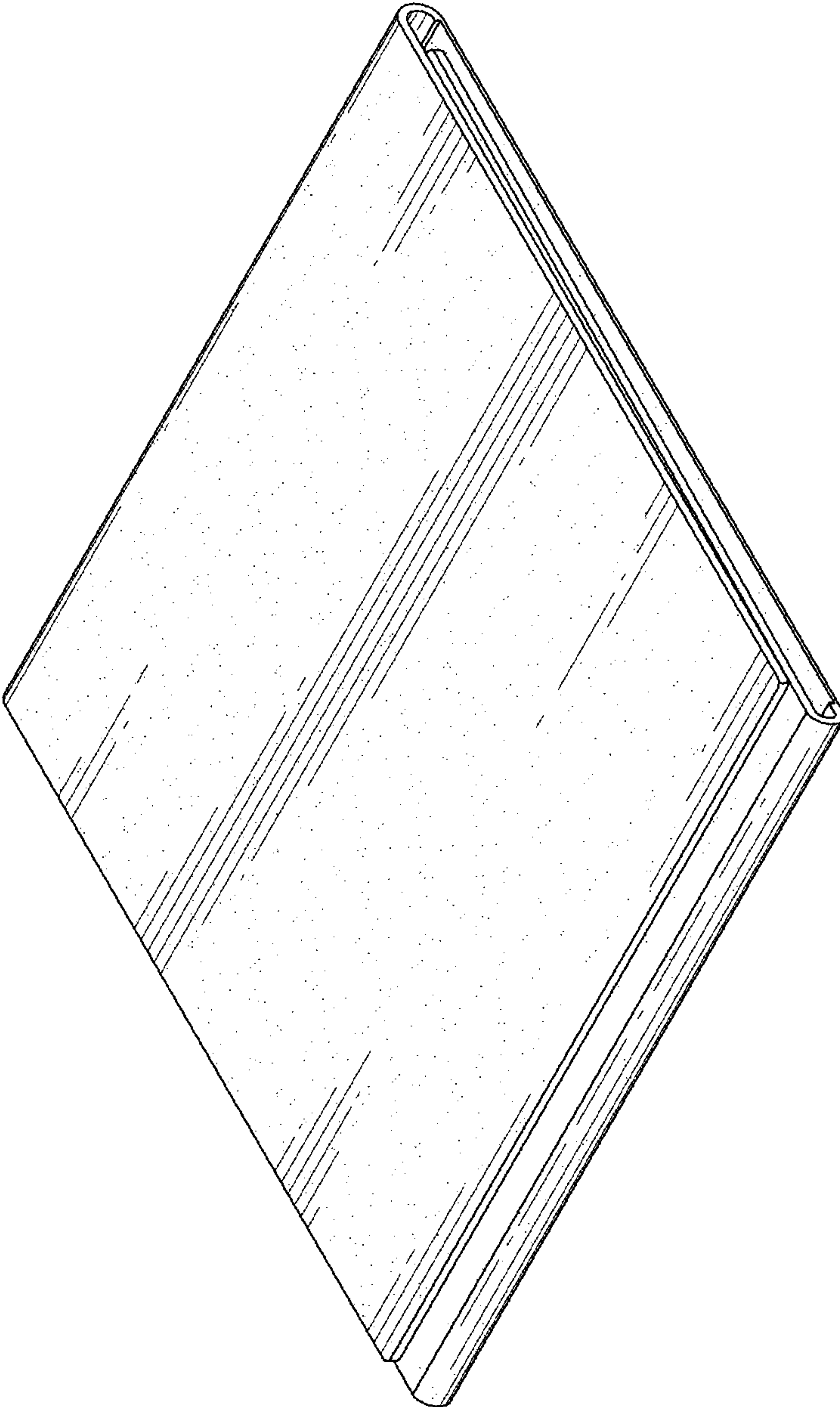

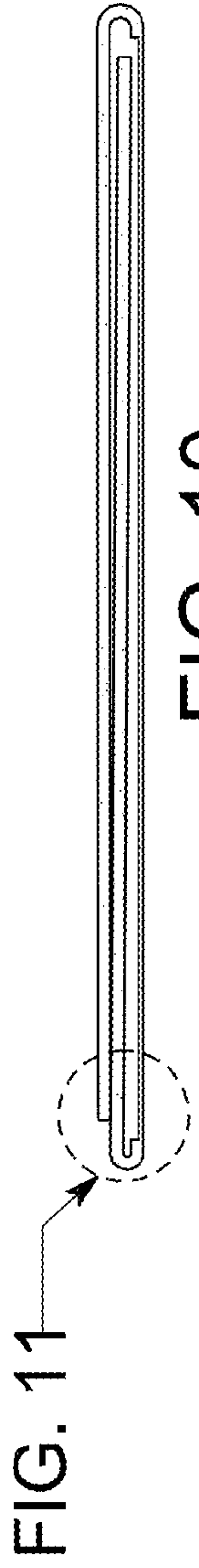

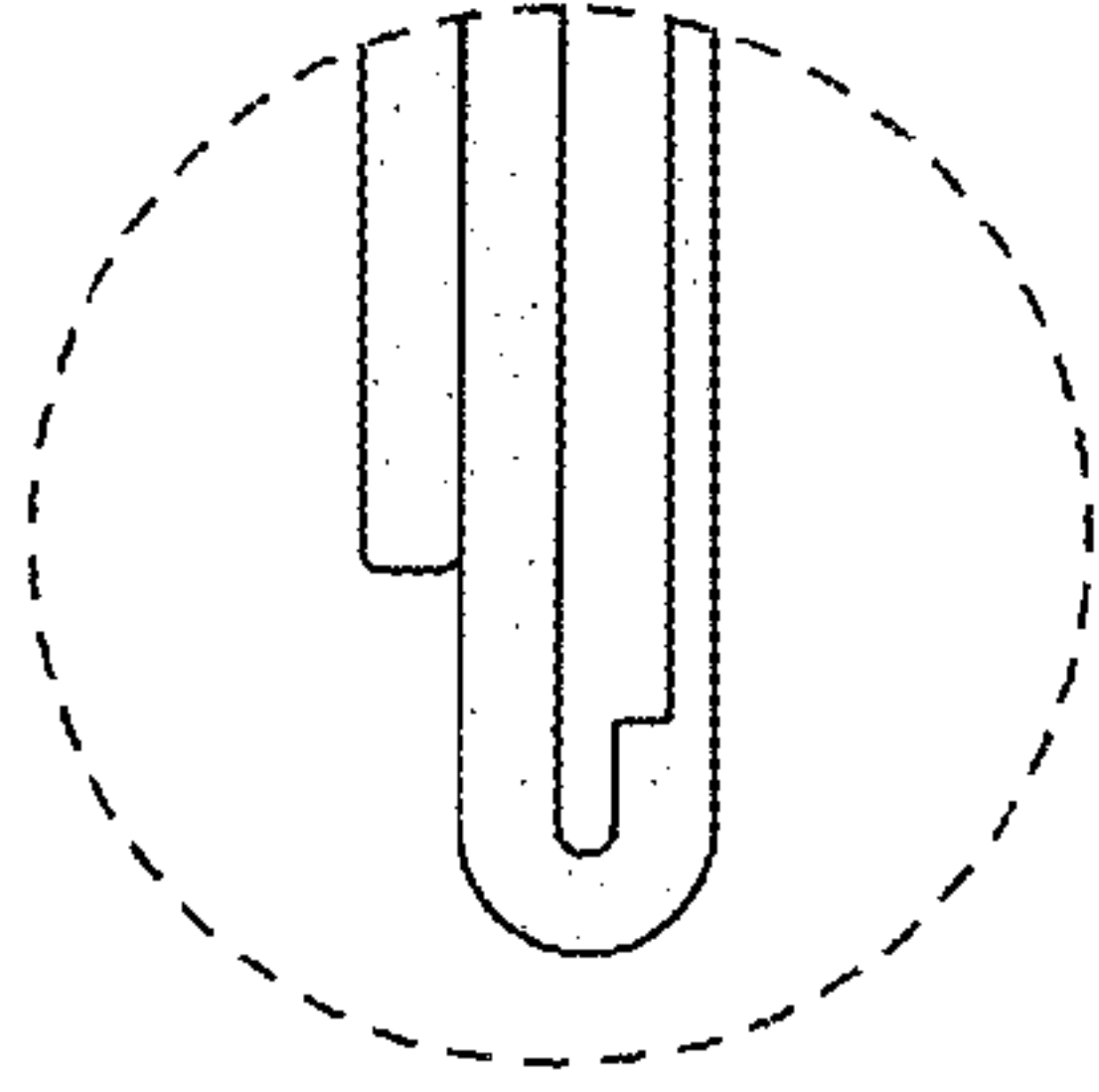

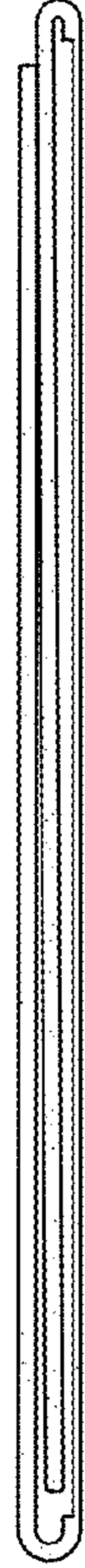

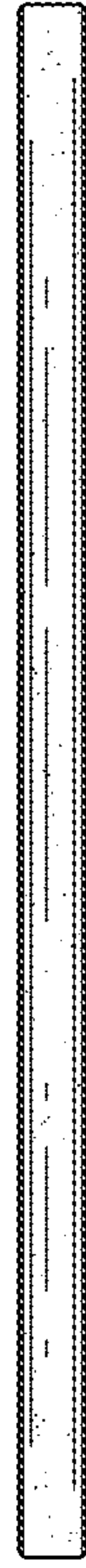

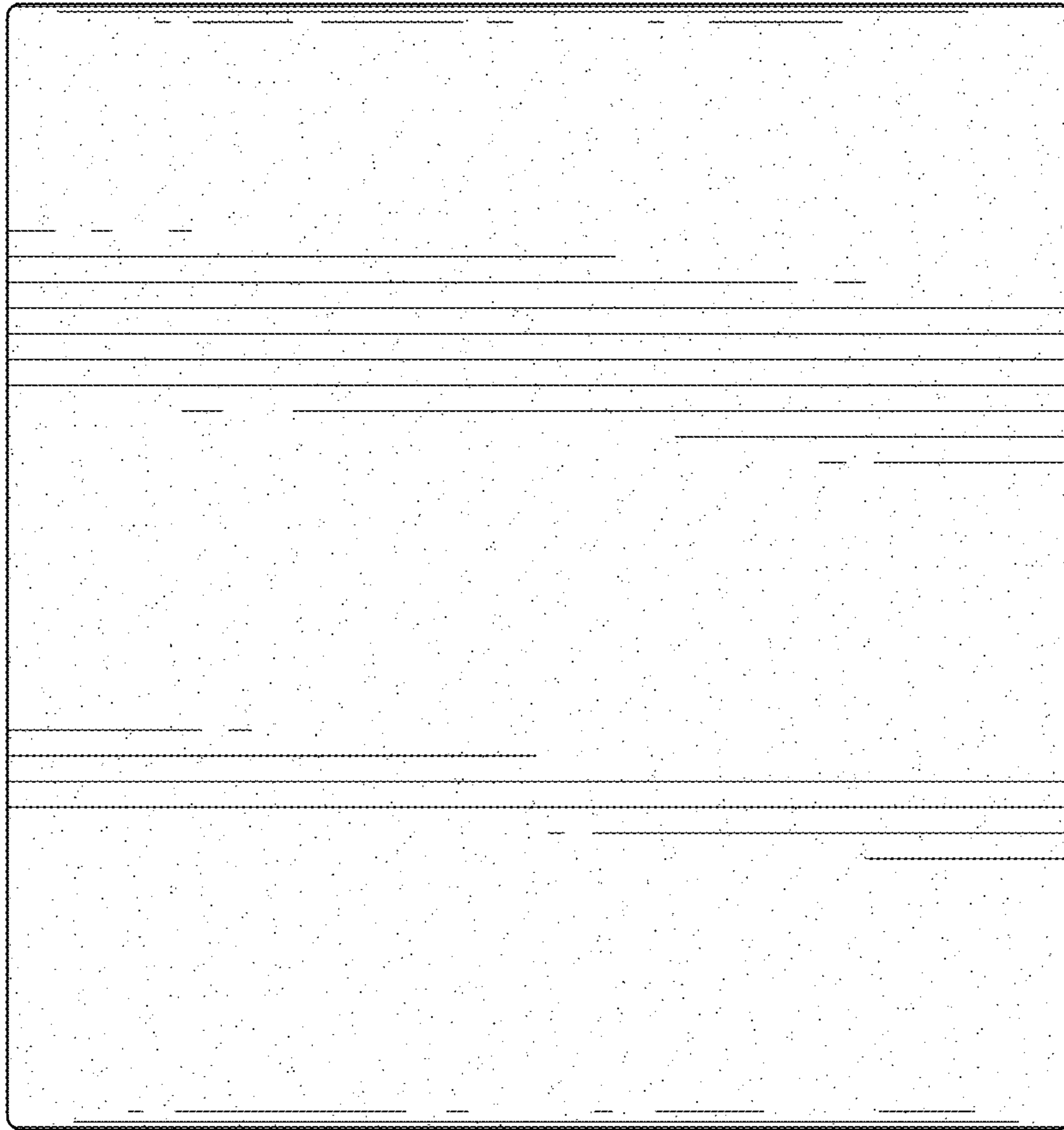

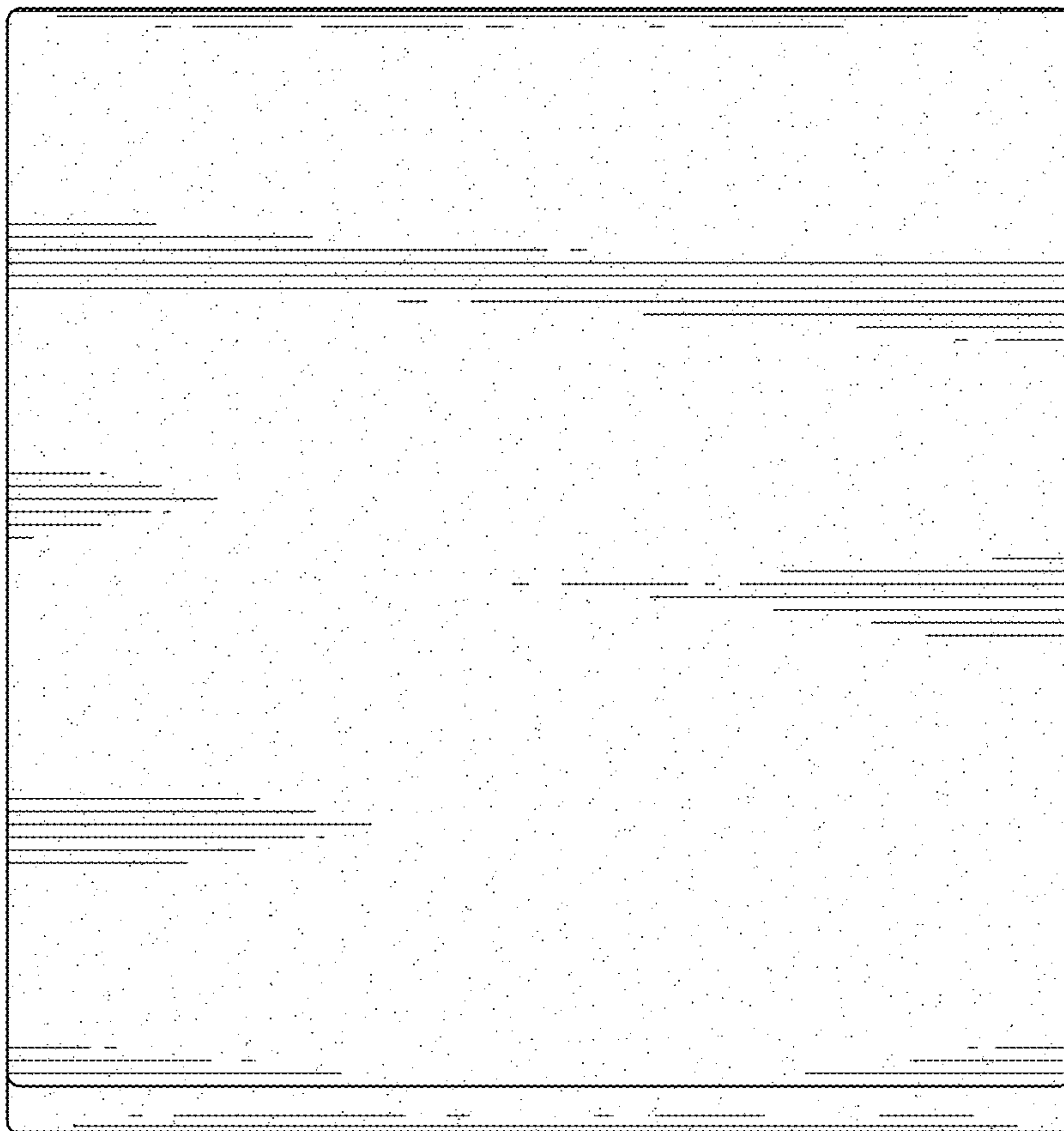
