DESCRIPTION

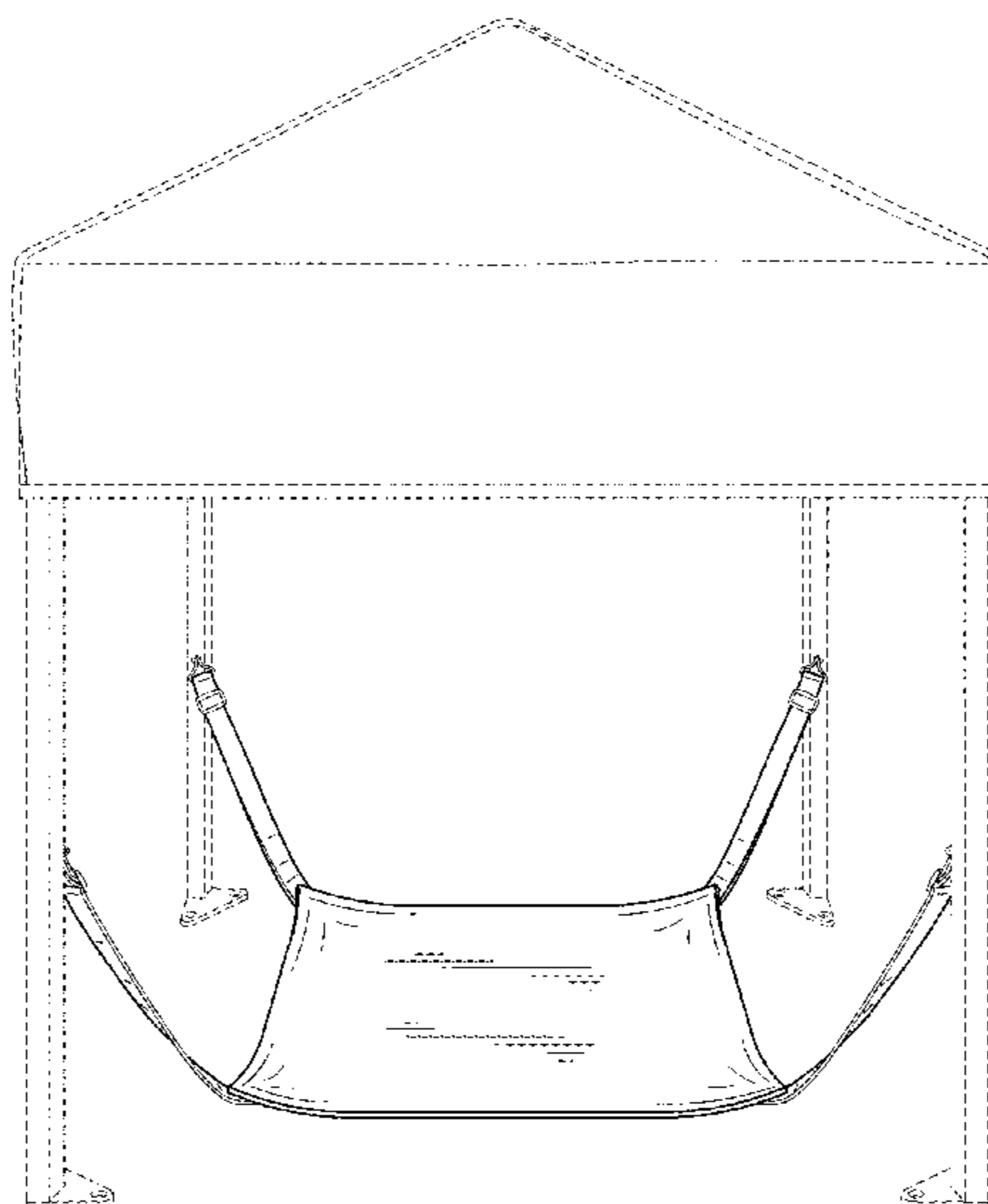
FIG. 1 is a front perspective view of a canopy anchor according to our new design;
 FIG. 2 is a front side elevational view thereof, of which the back side elevational view is a mirror image;
 FIG. 3 is a right side elevational view thereof, of which the left side elevational view is a mirror image;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a top plan view of a canopy anchor thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a front side elevational view thereof, of which the back side, right side, and left side elevational views are mirror images.
 The broken lines are for the purpose of illustrating portions of the article that form no part of the claim.
 The broken away symbols in FIGS. 6-8 indicate the appearance of any portion of the article between the break lines forms no part of the claimed design.

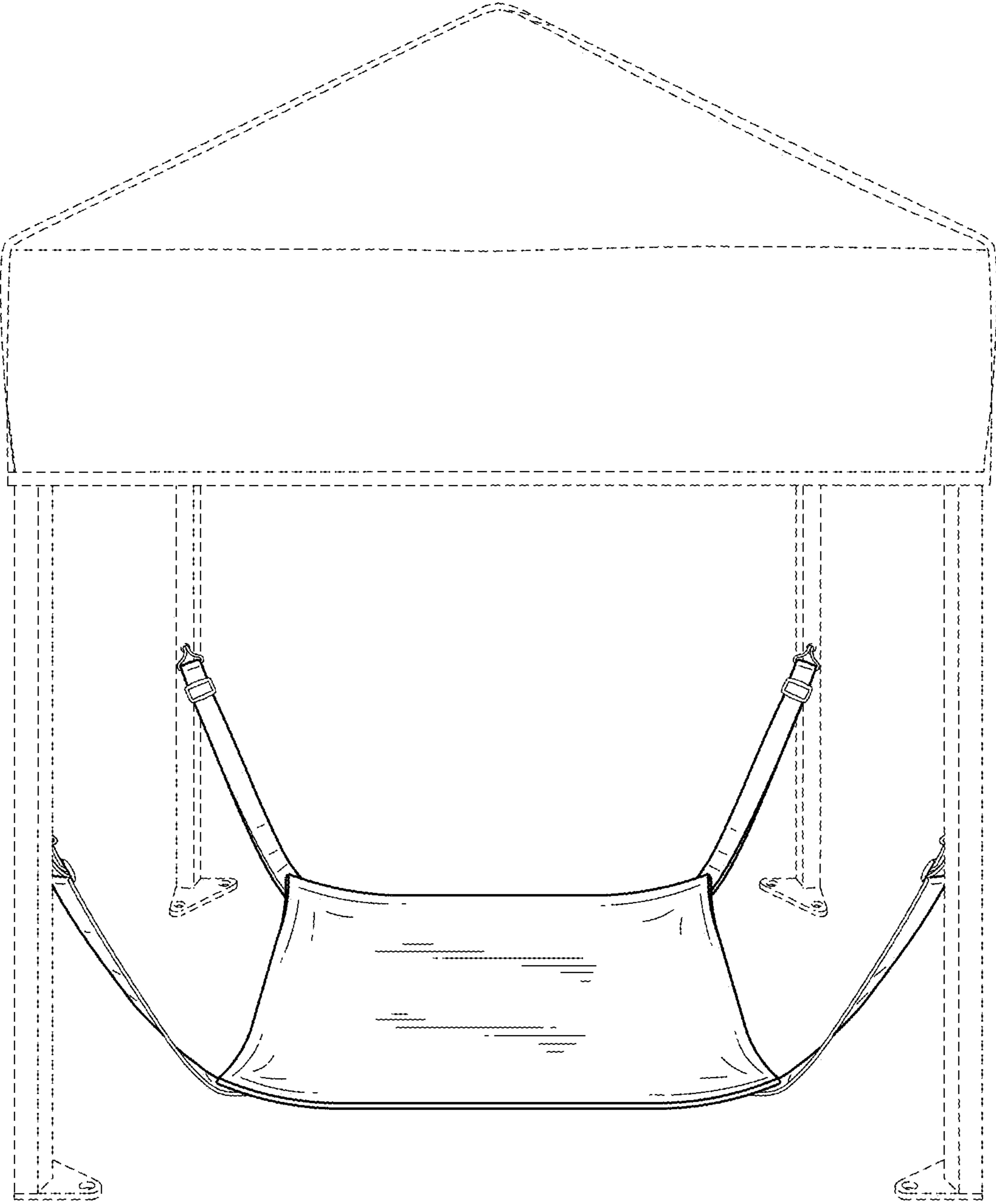

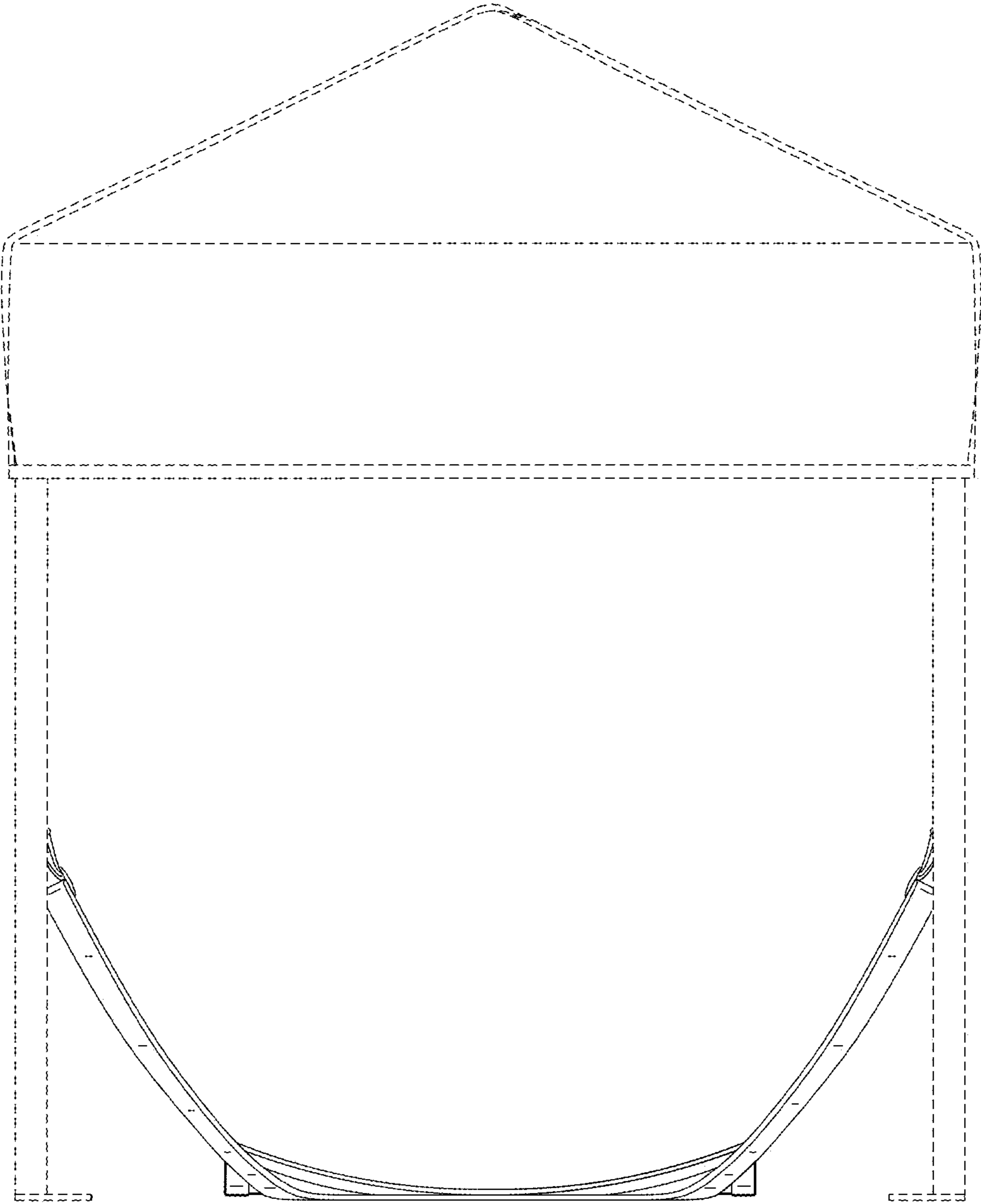

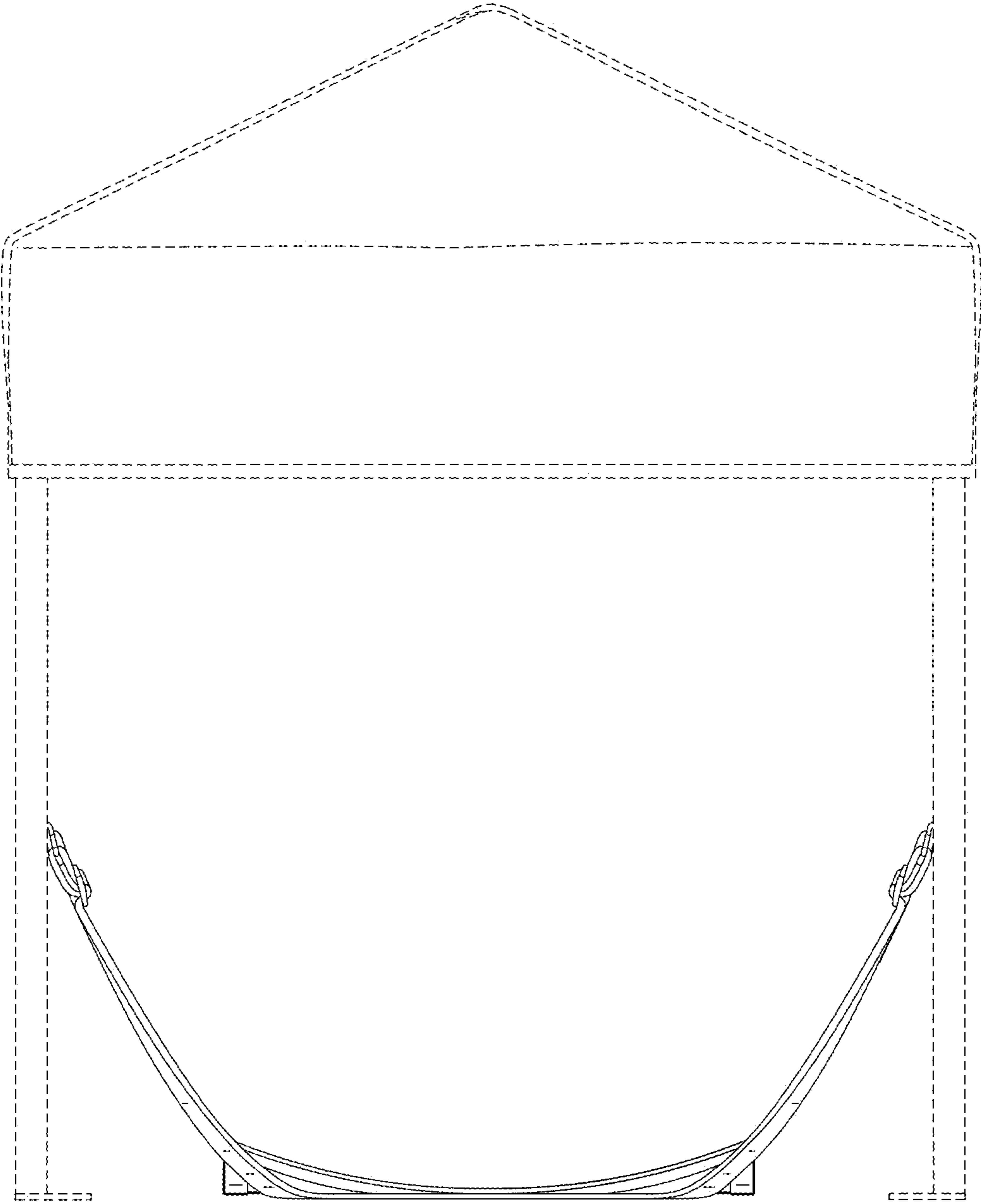

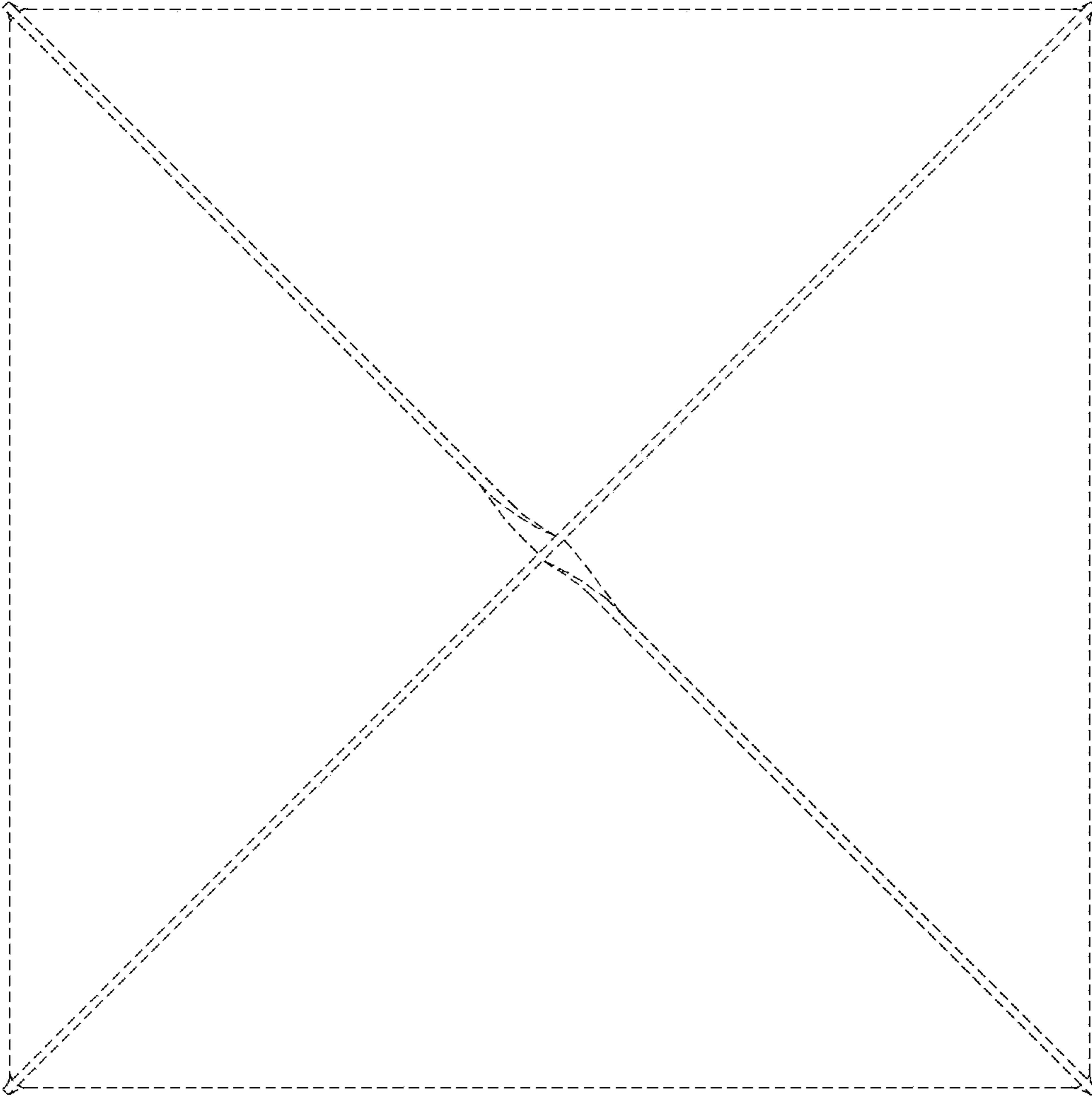

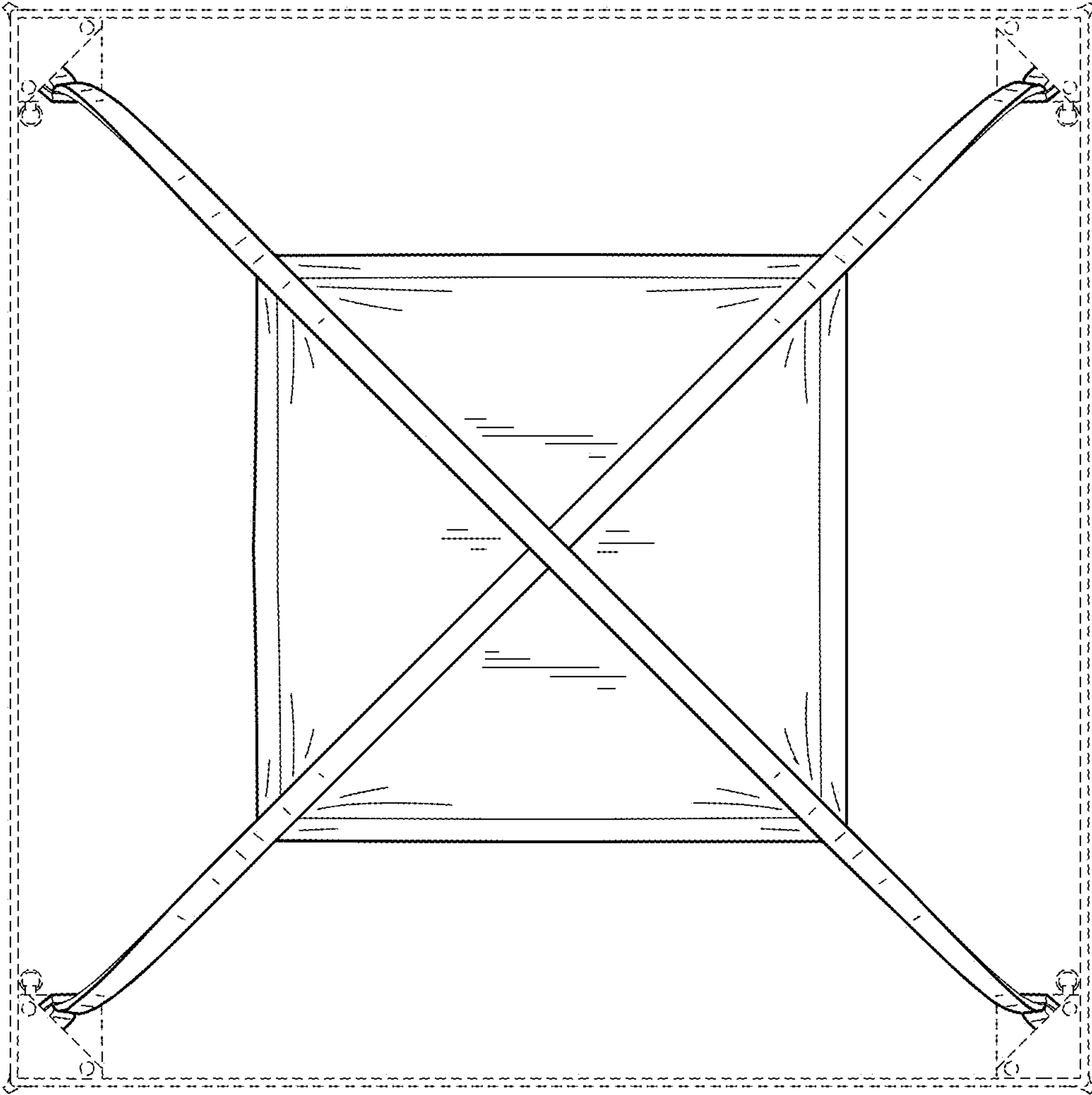

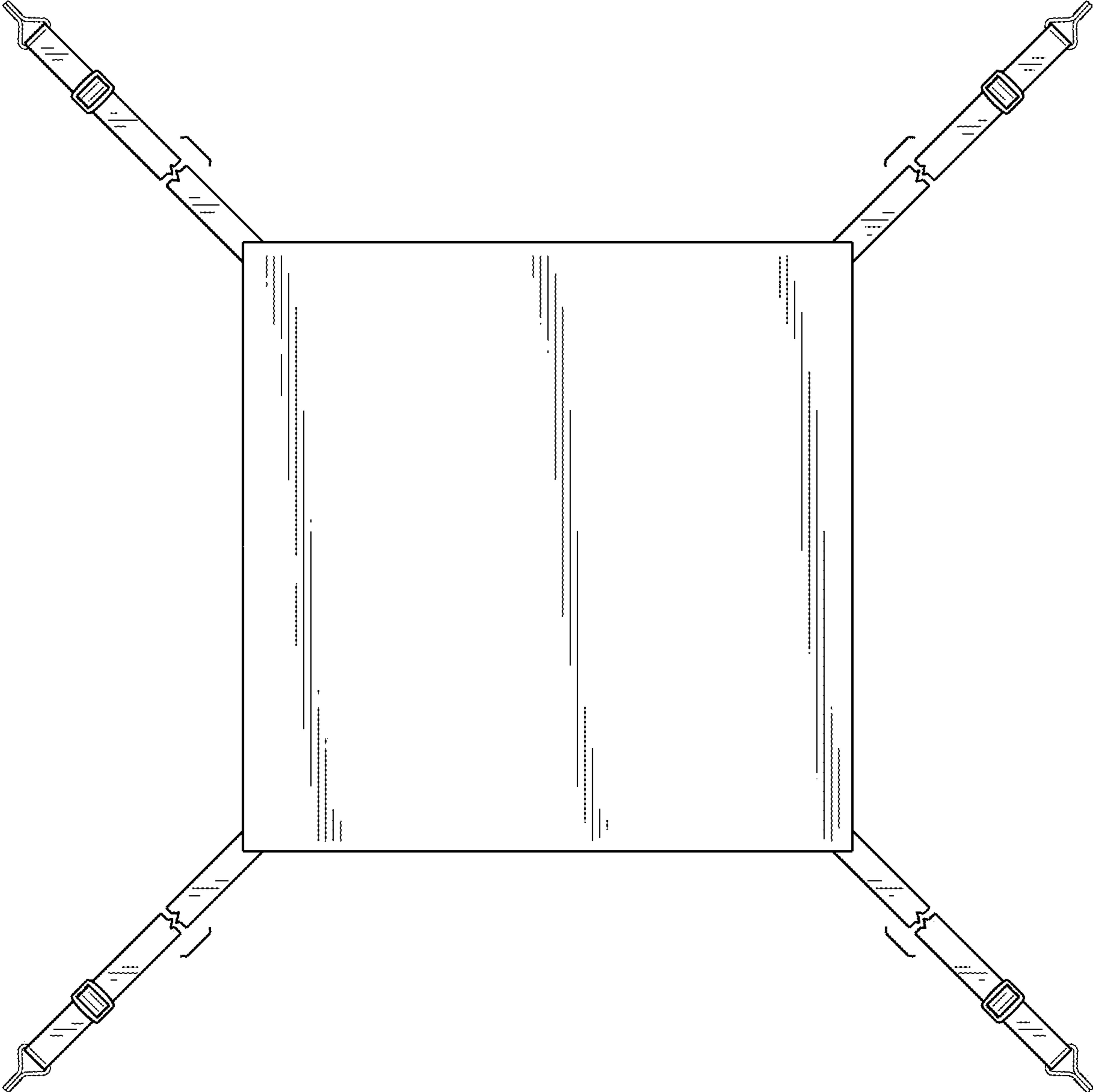
