FIG. 11 is a rear view thereof;

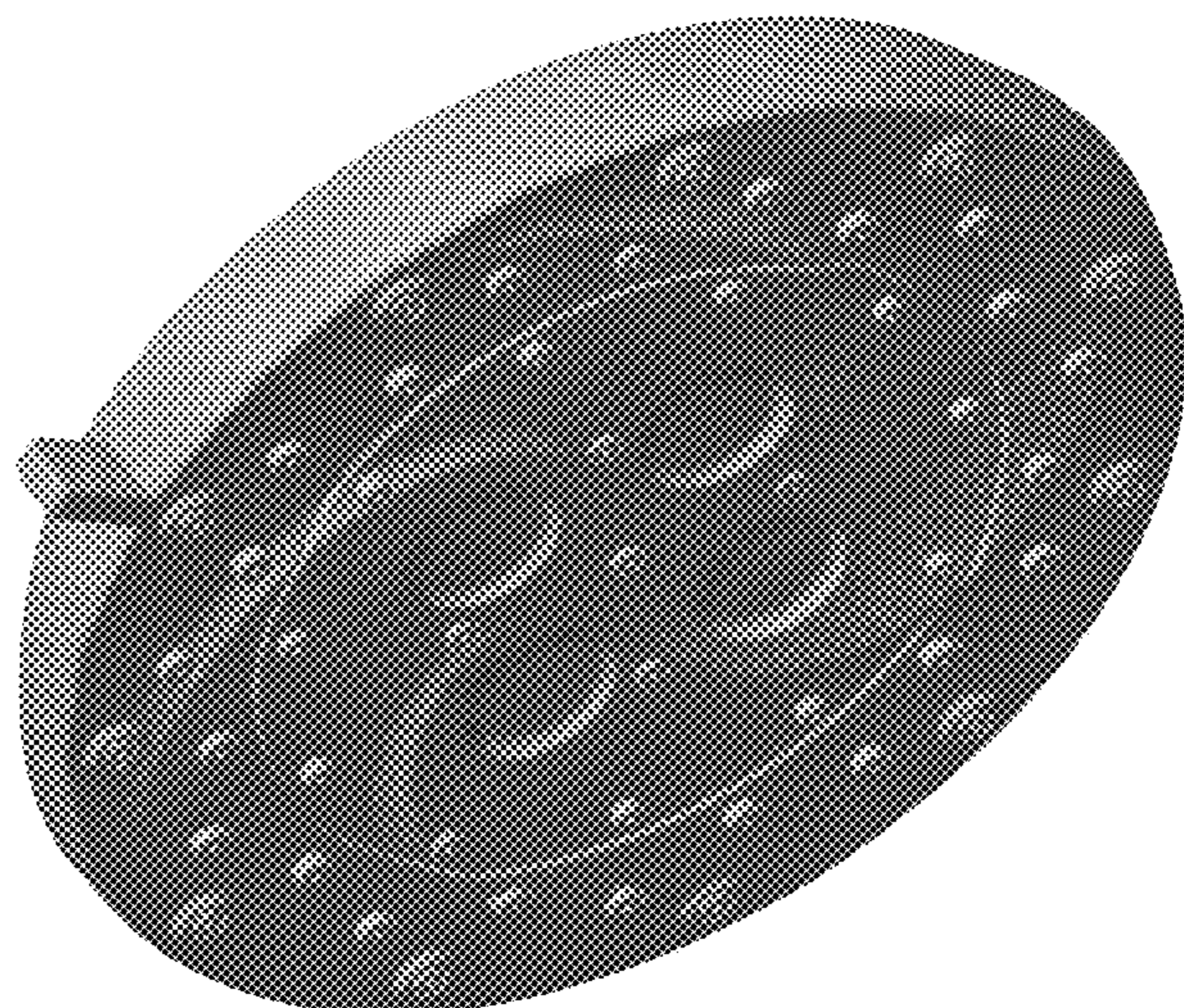
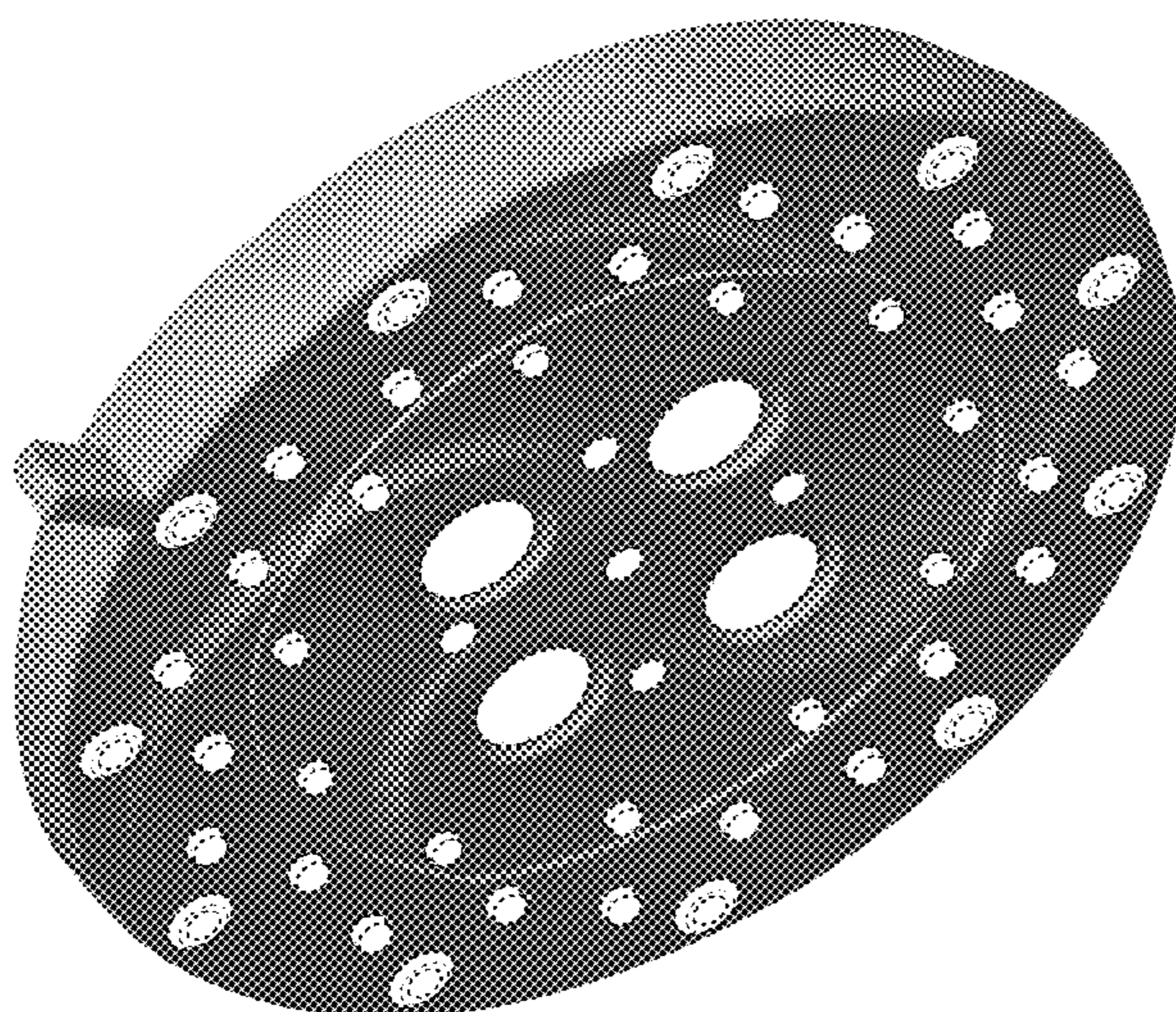
FIG. 12 is a right side view thereof;

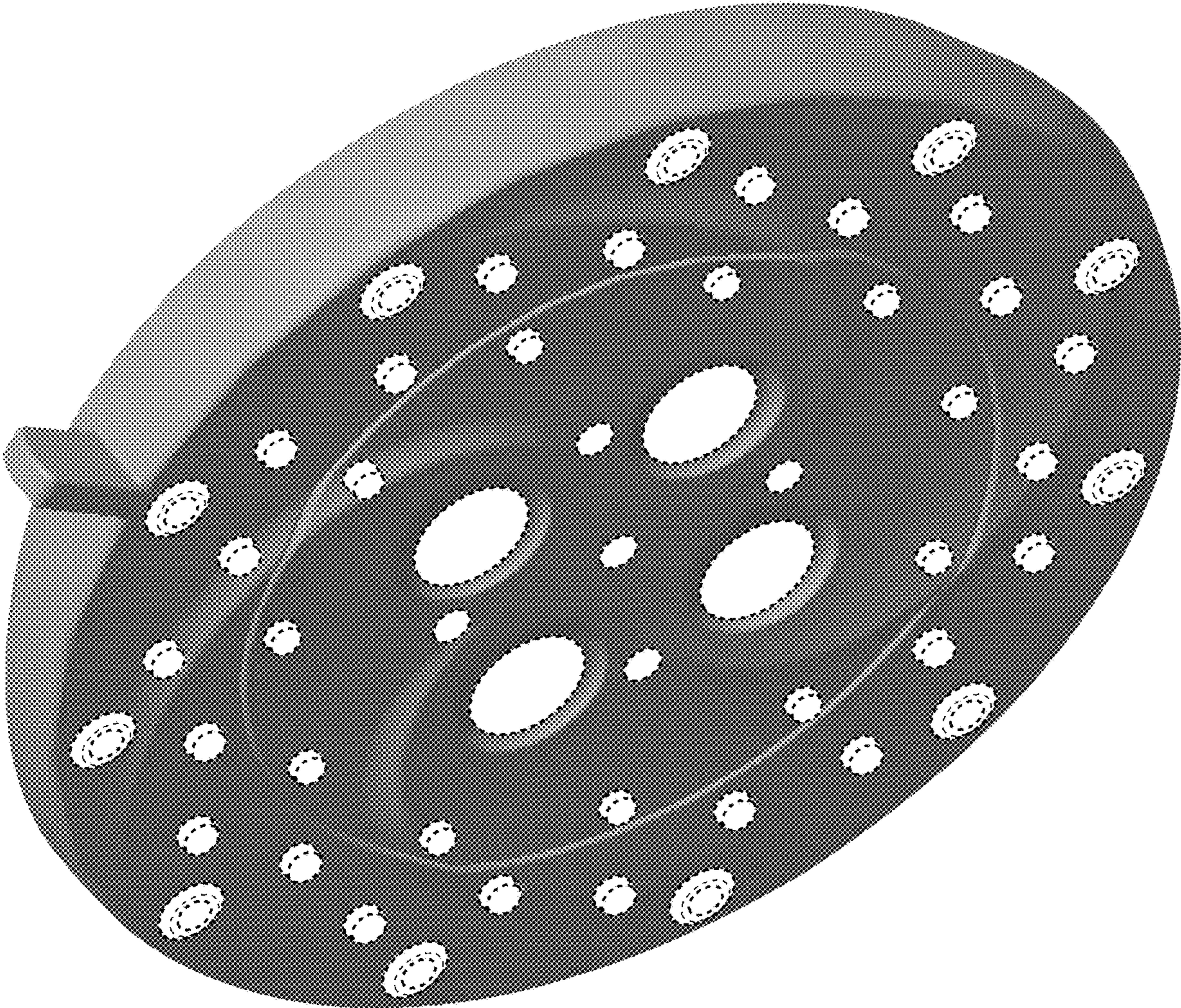

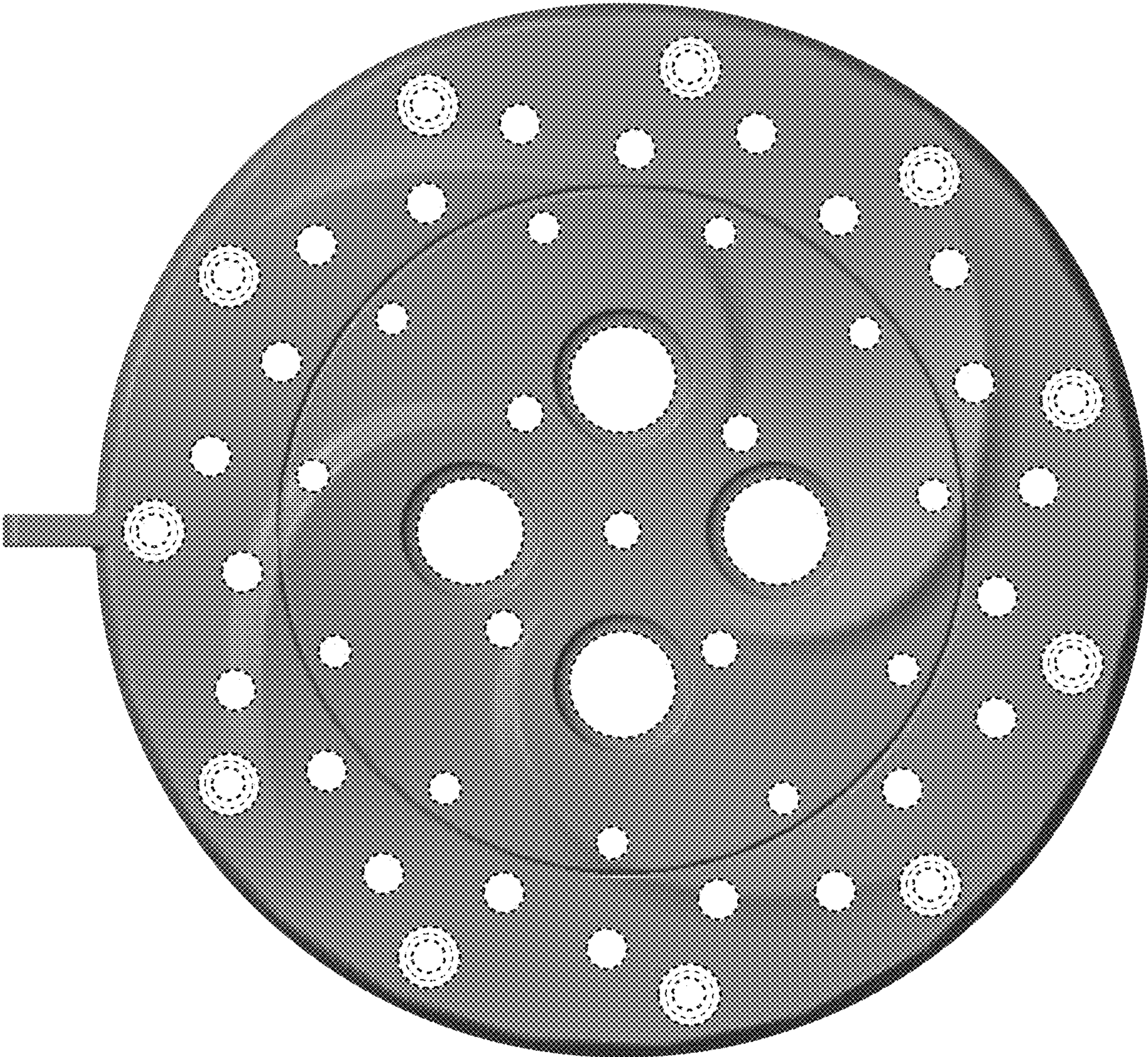

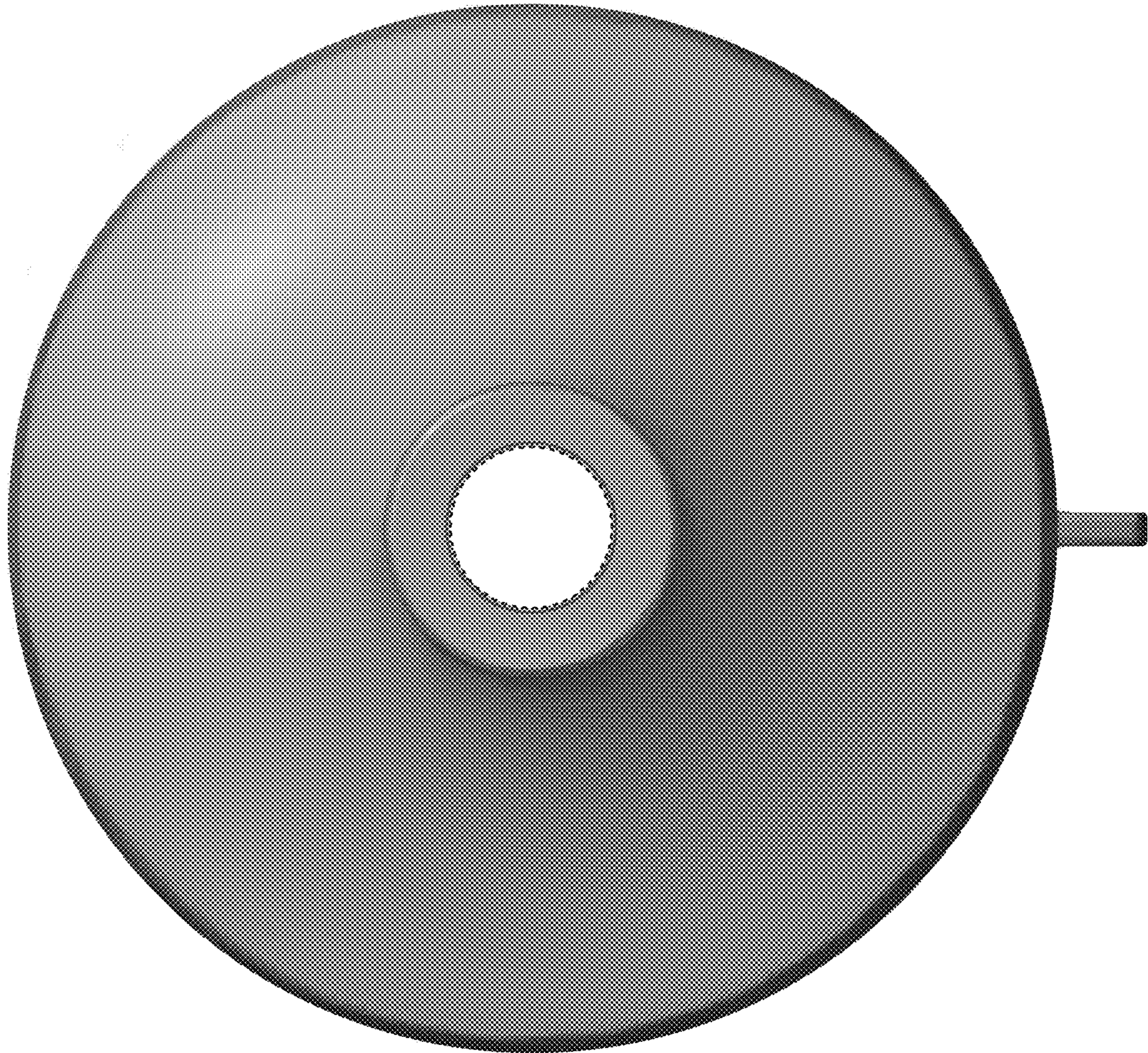

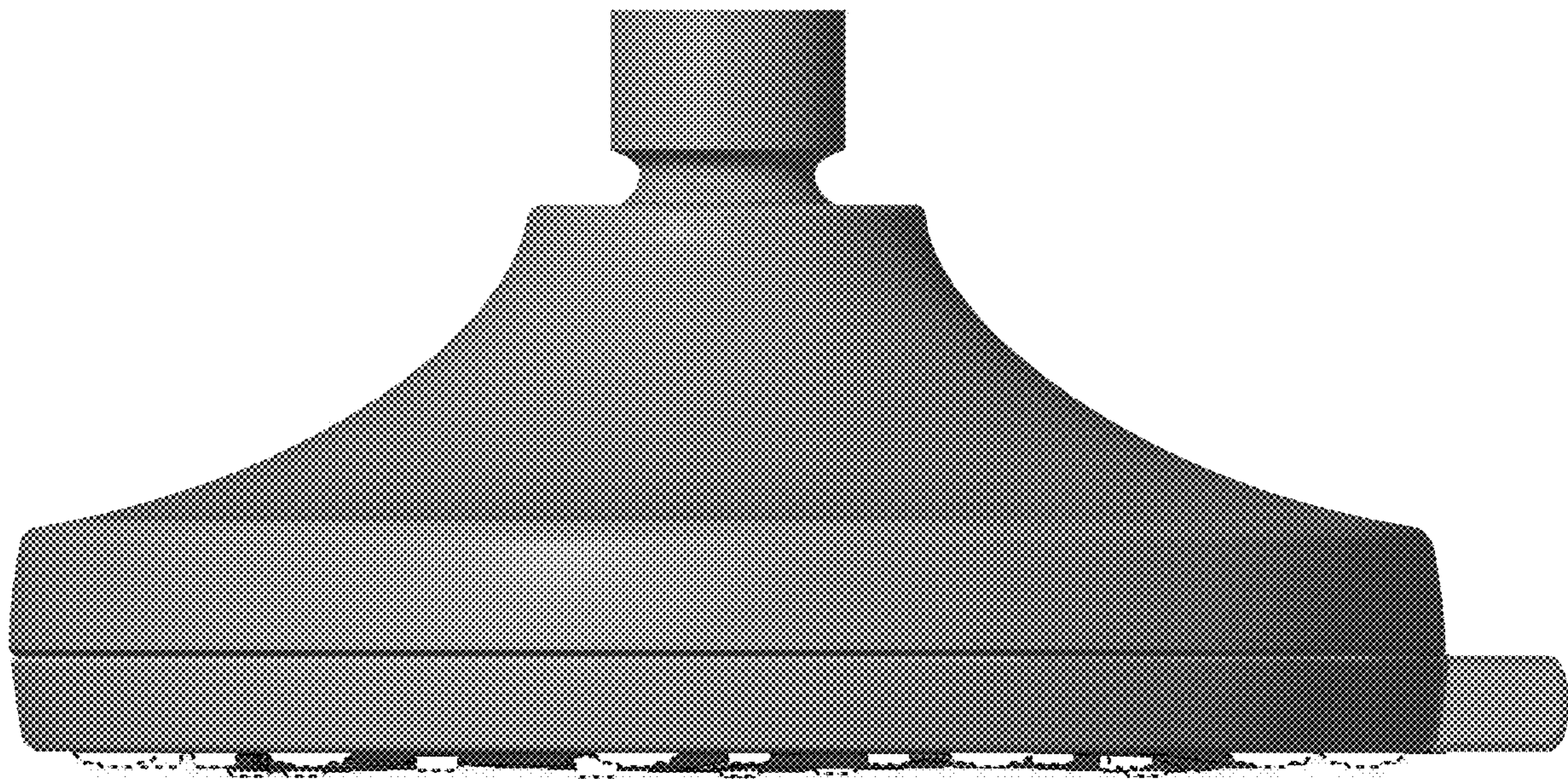

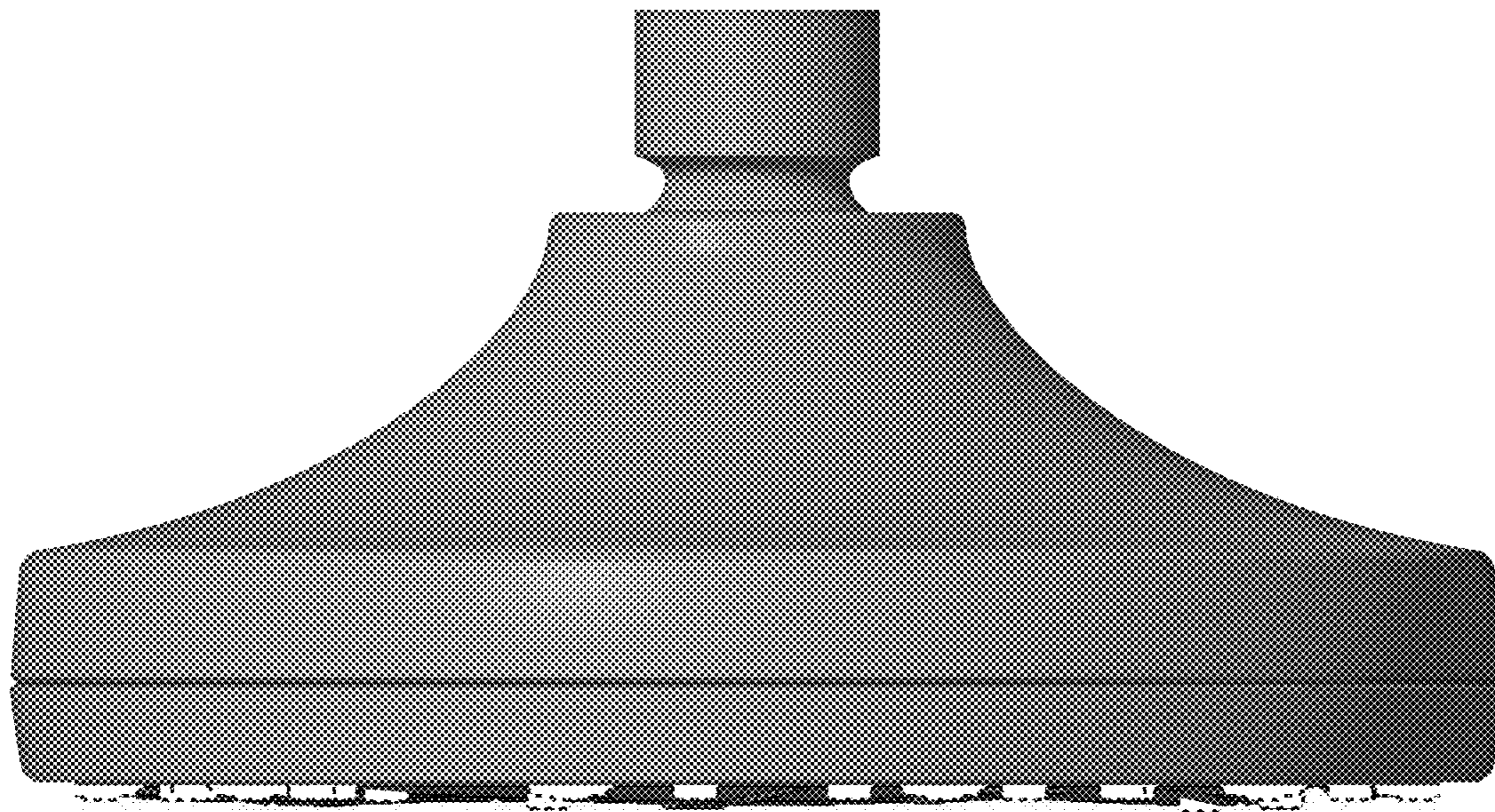

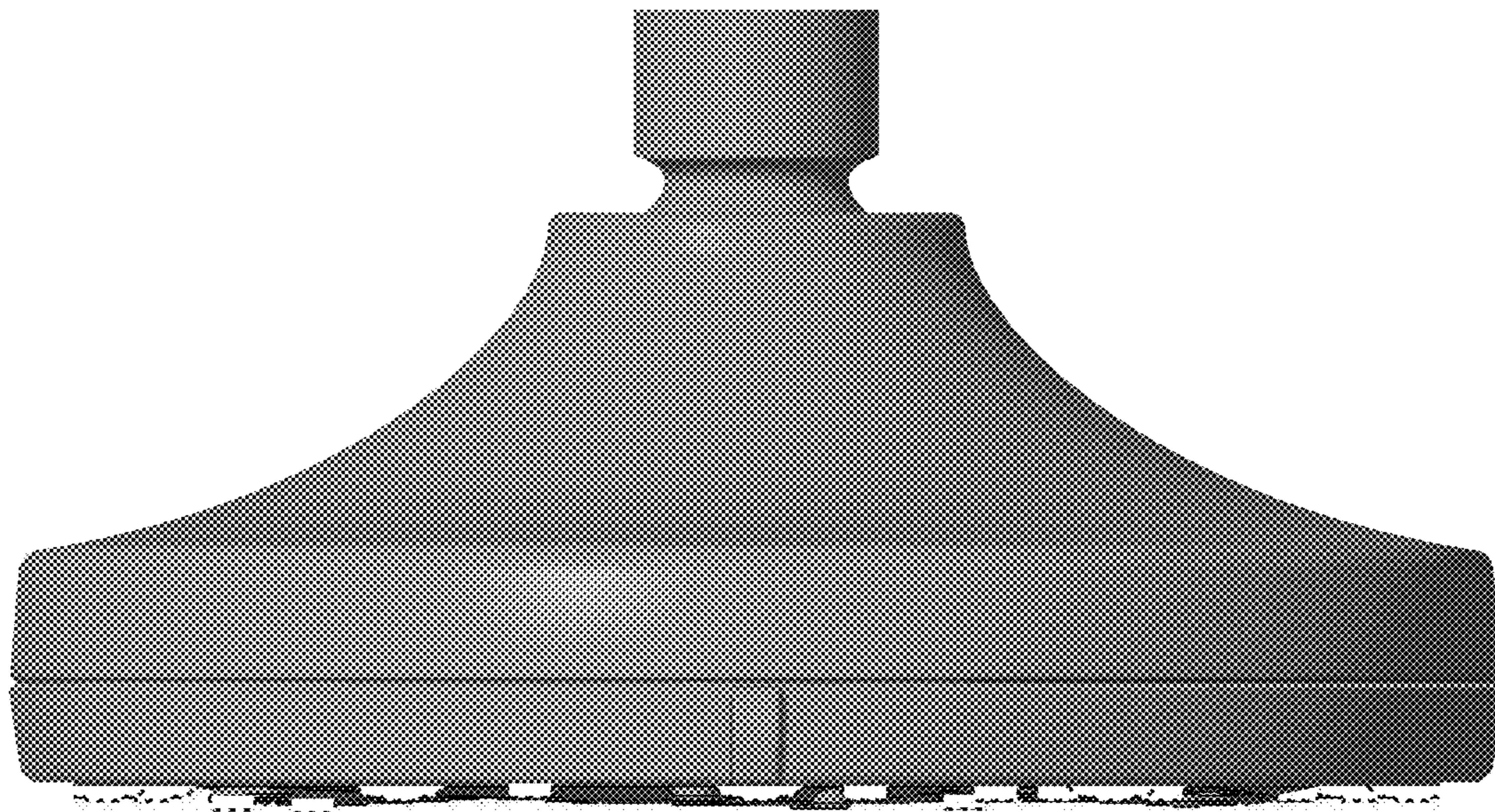

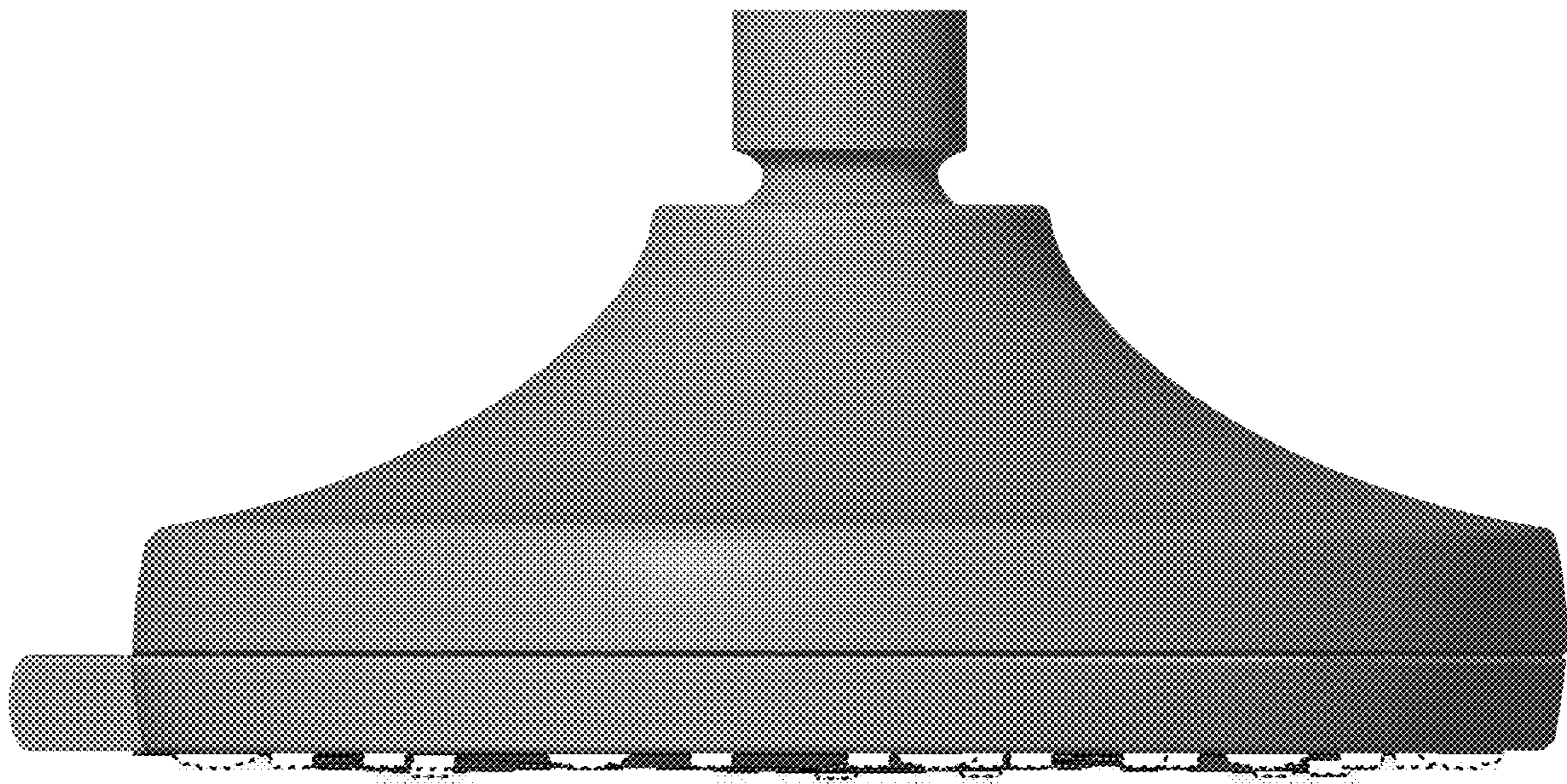

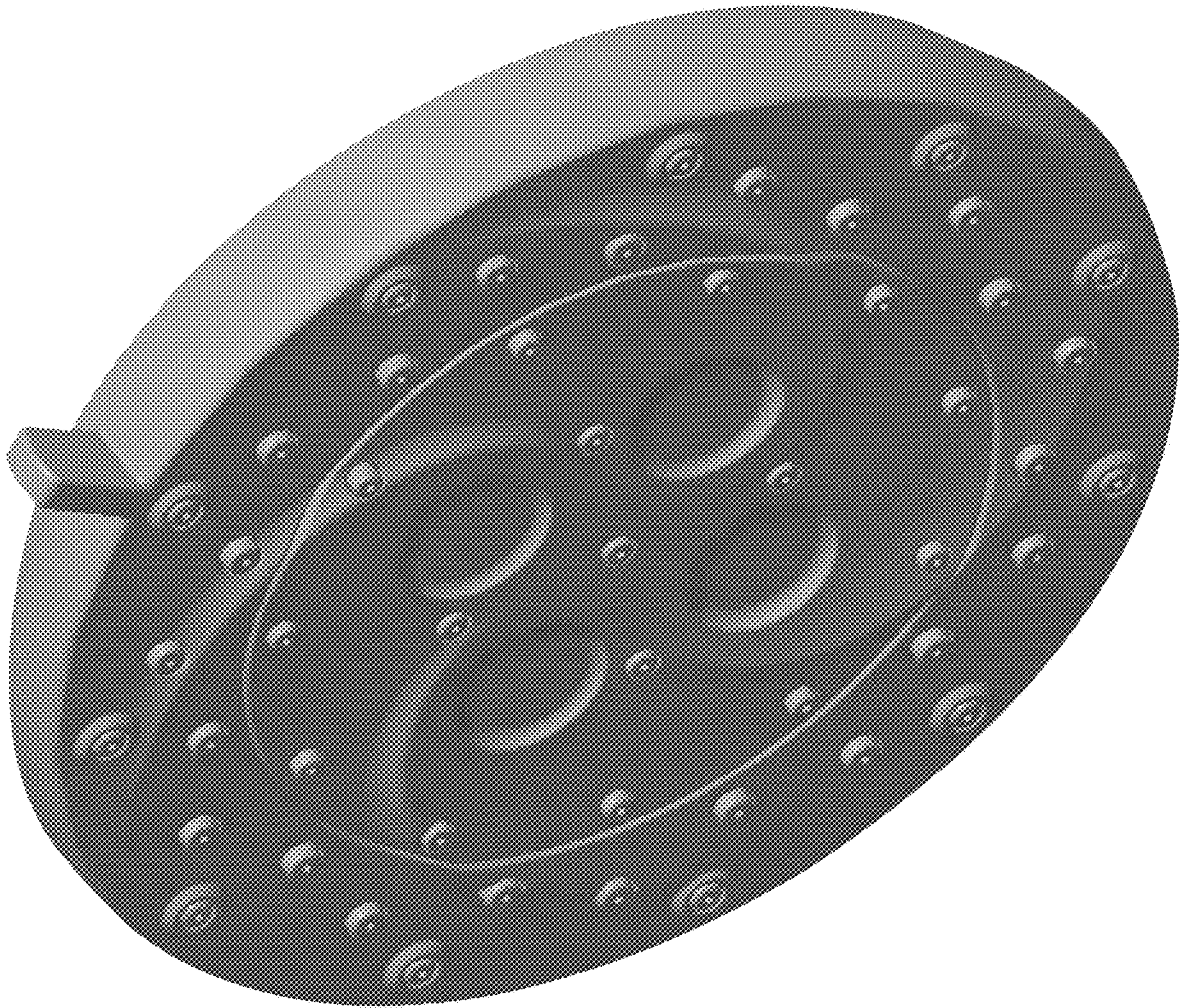

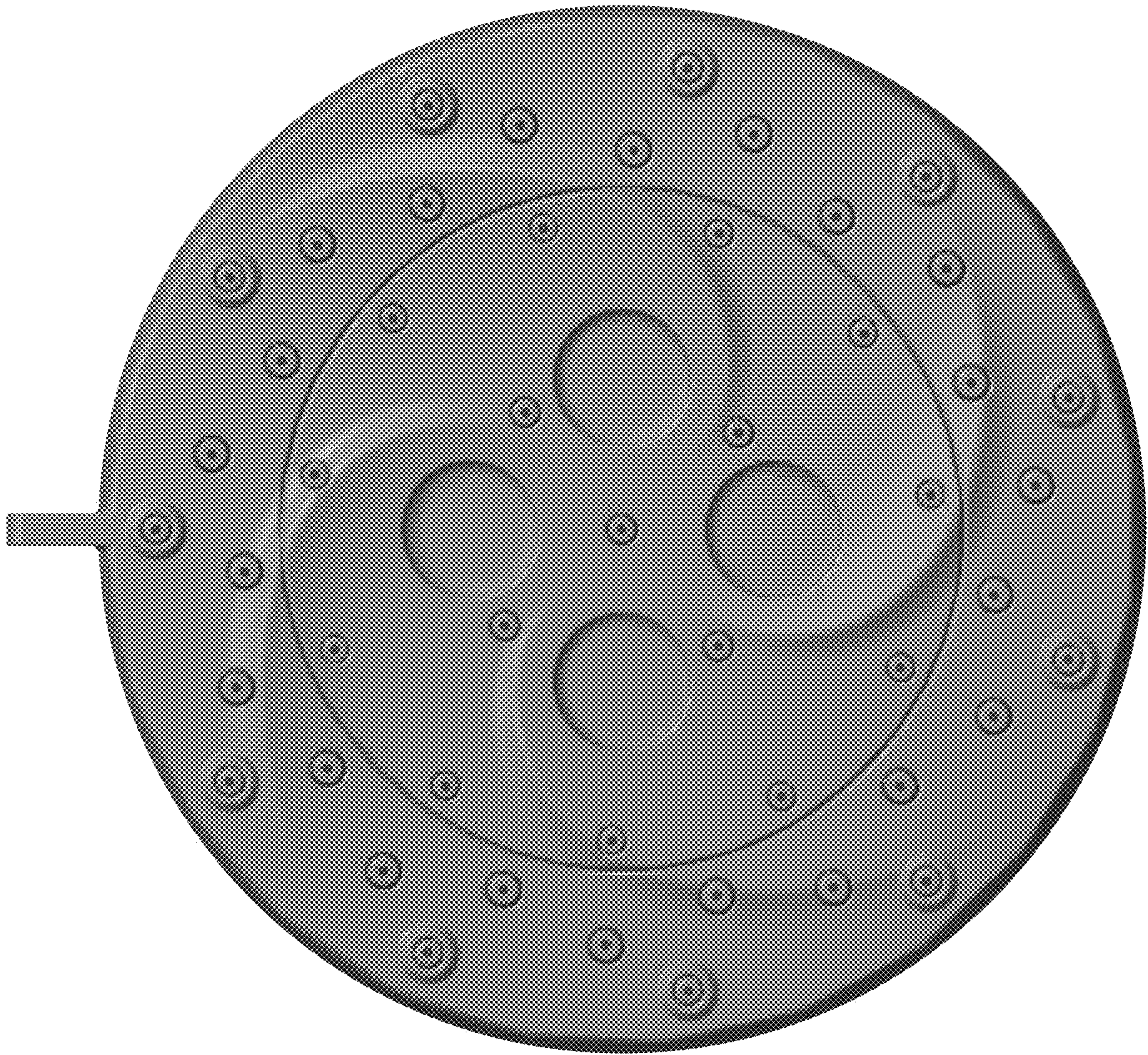

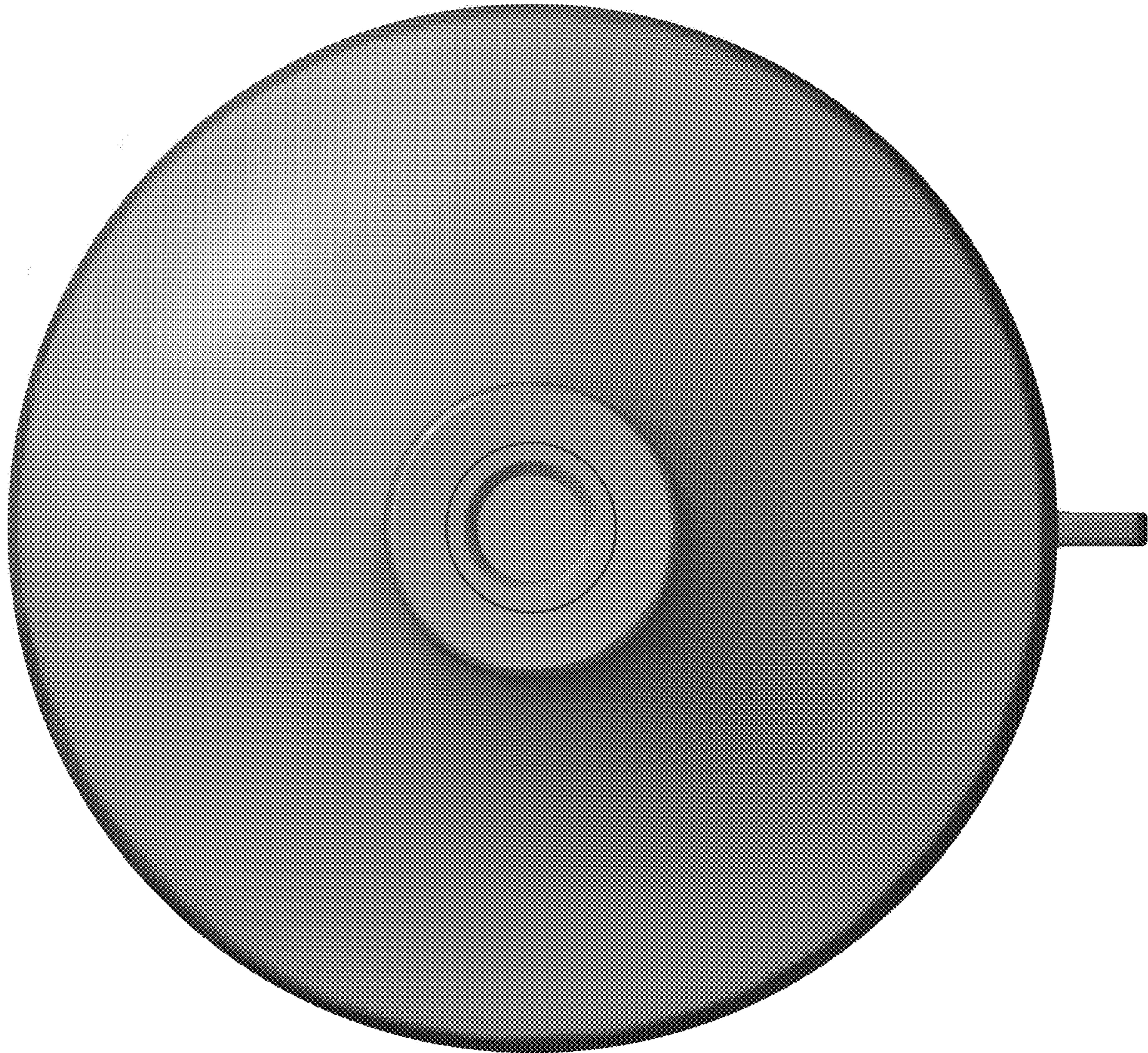

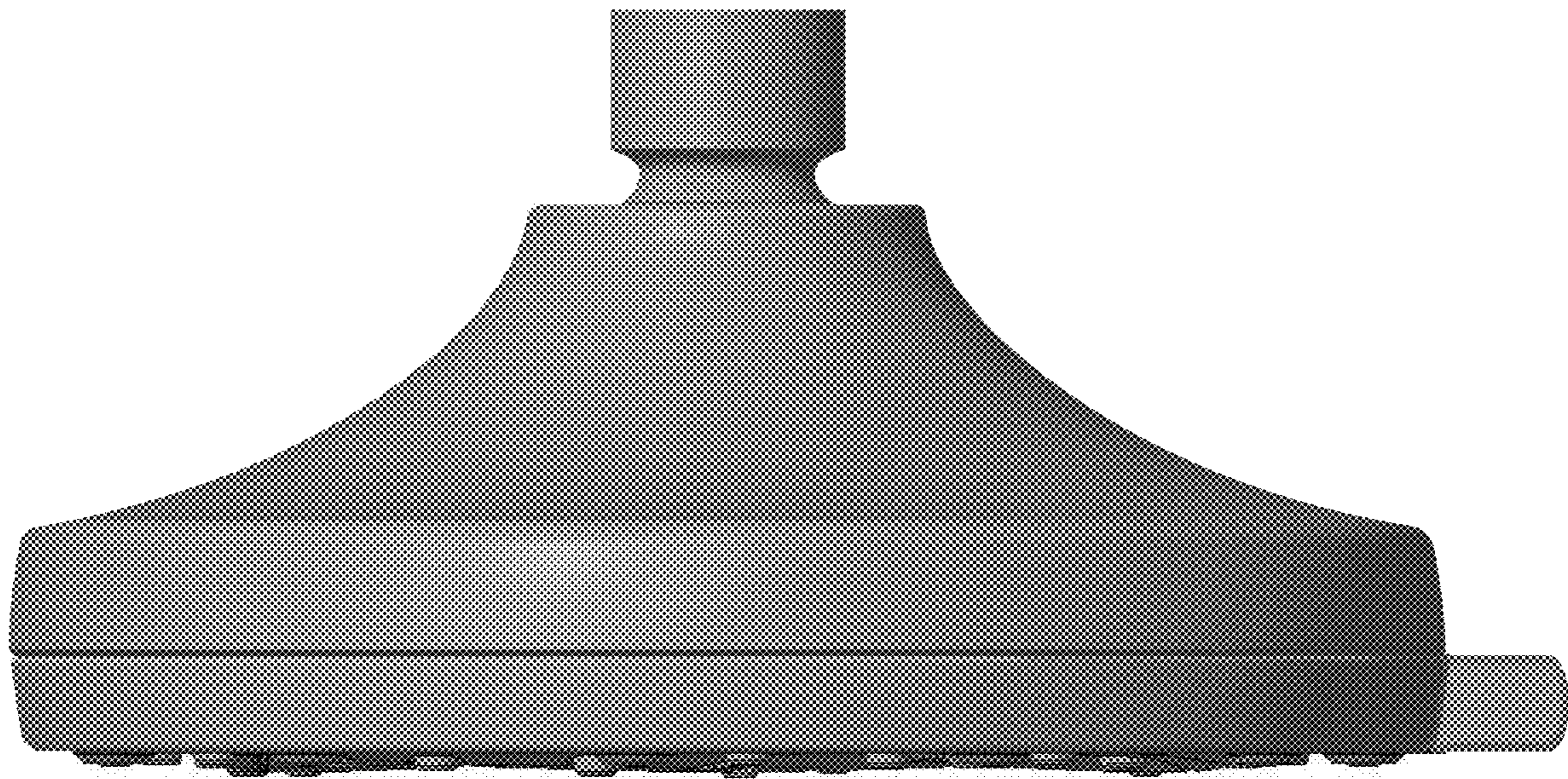

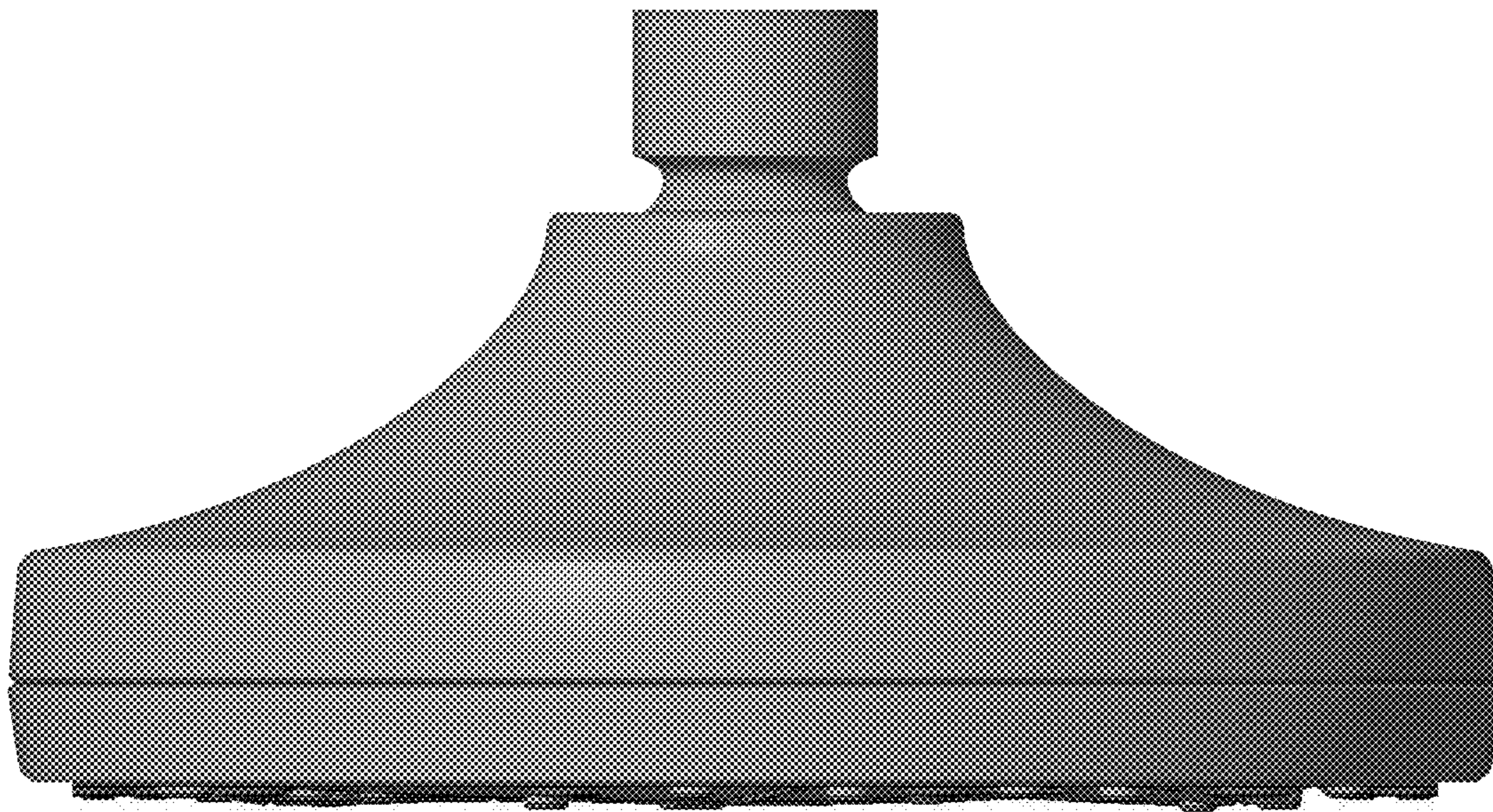

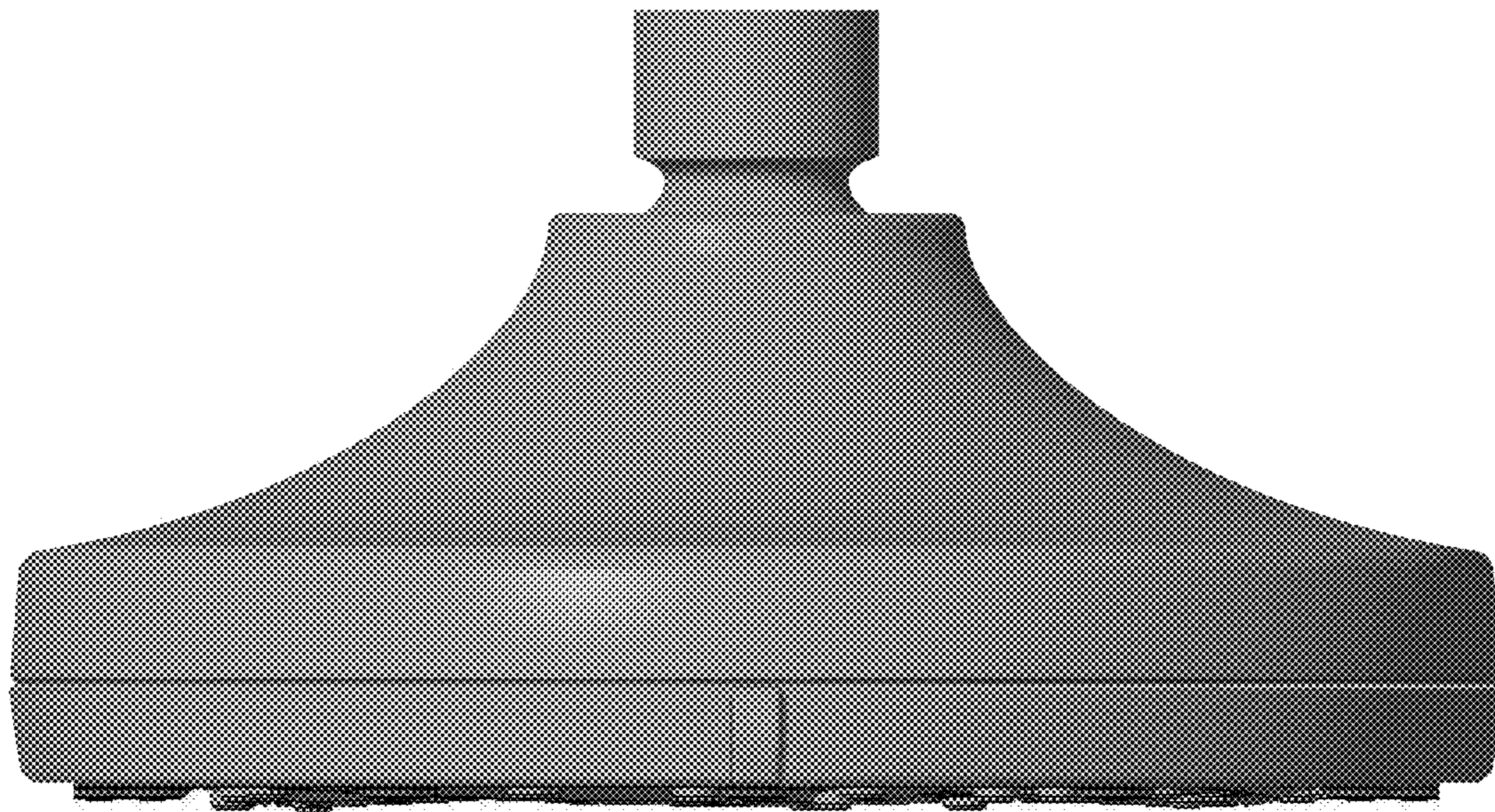

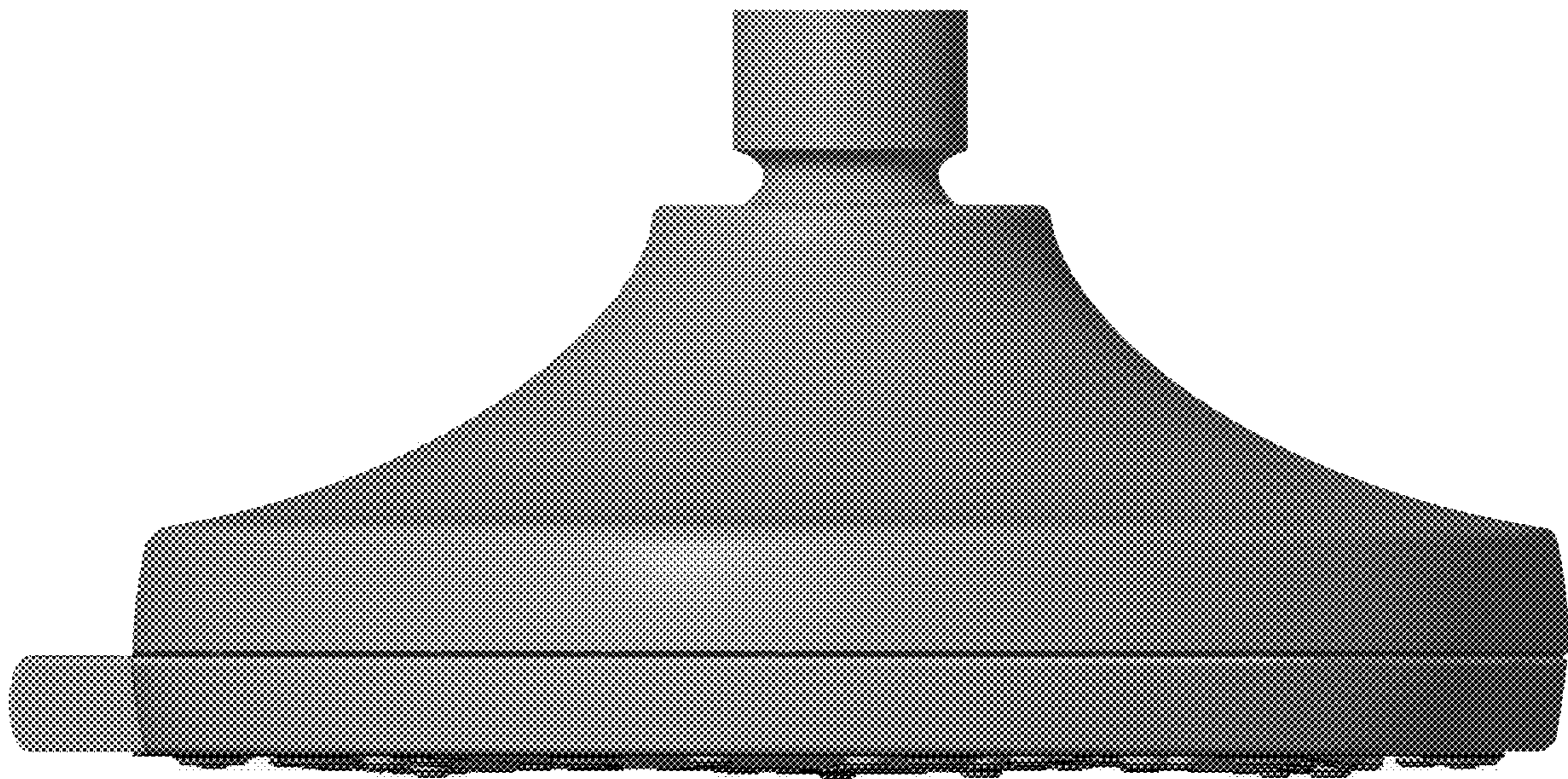
