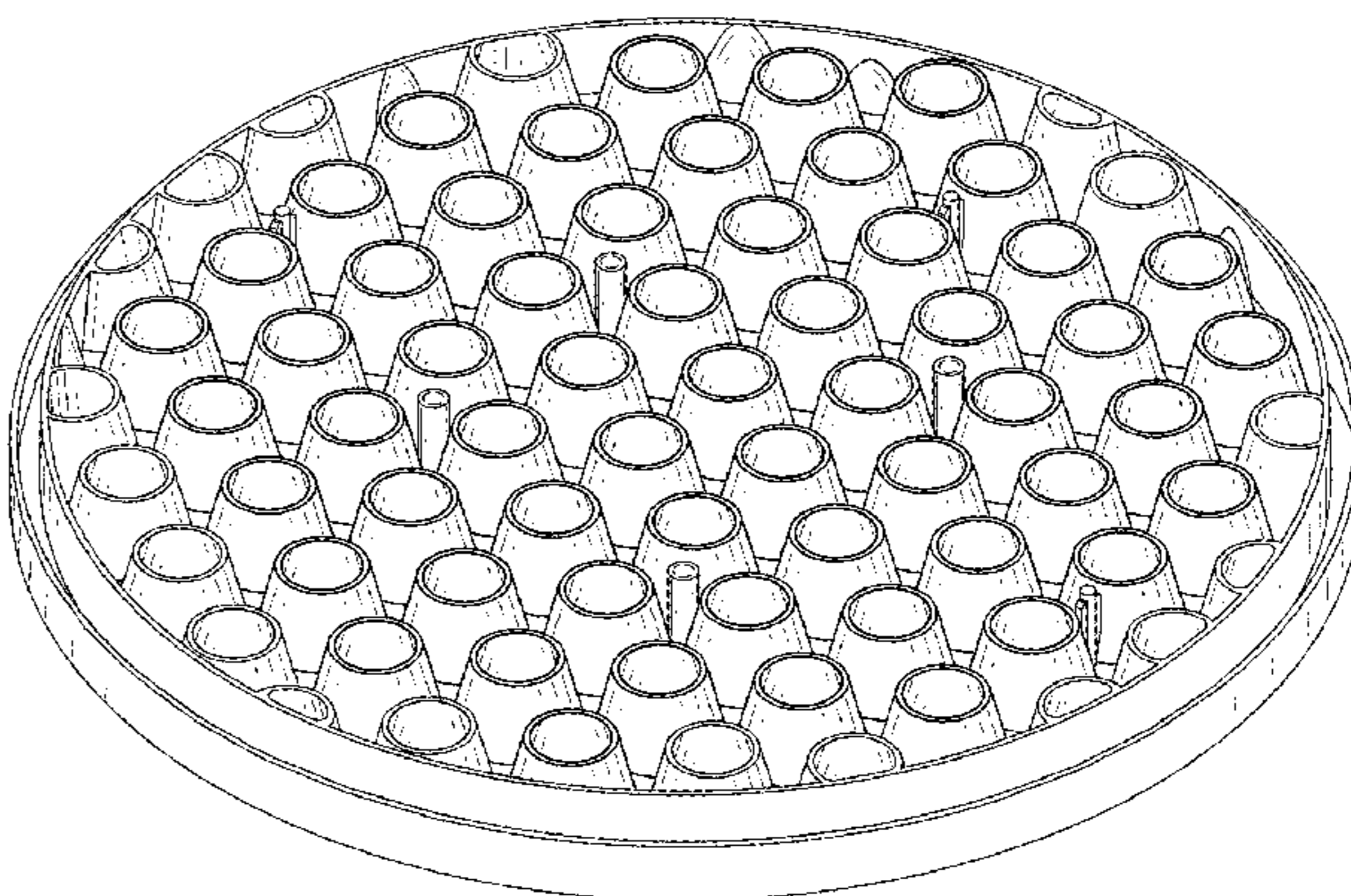
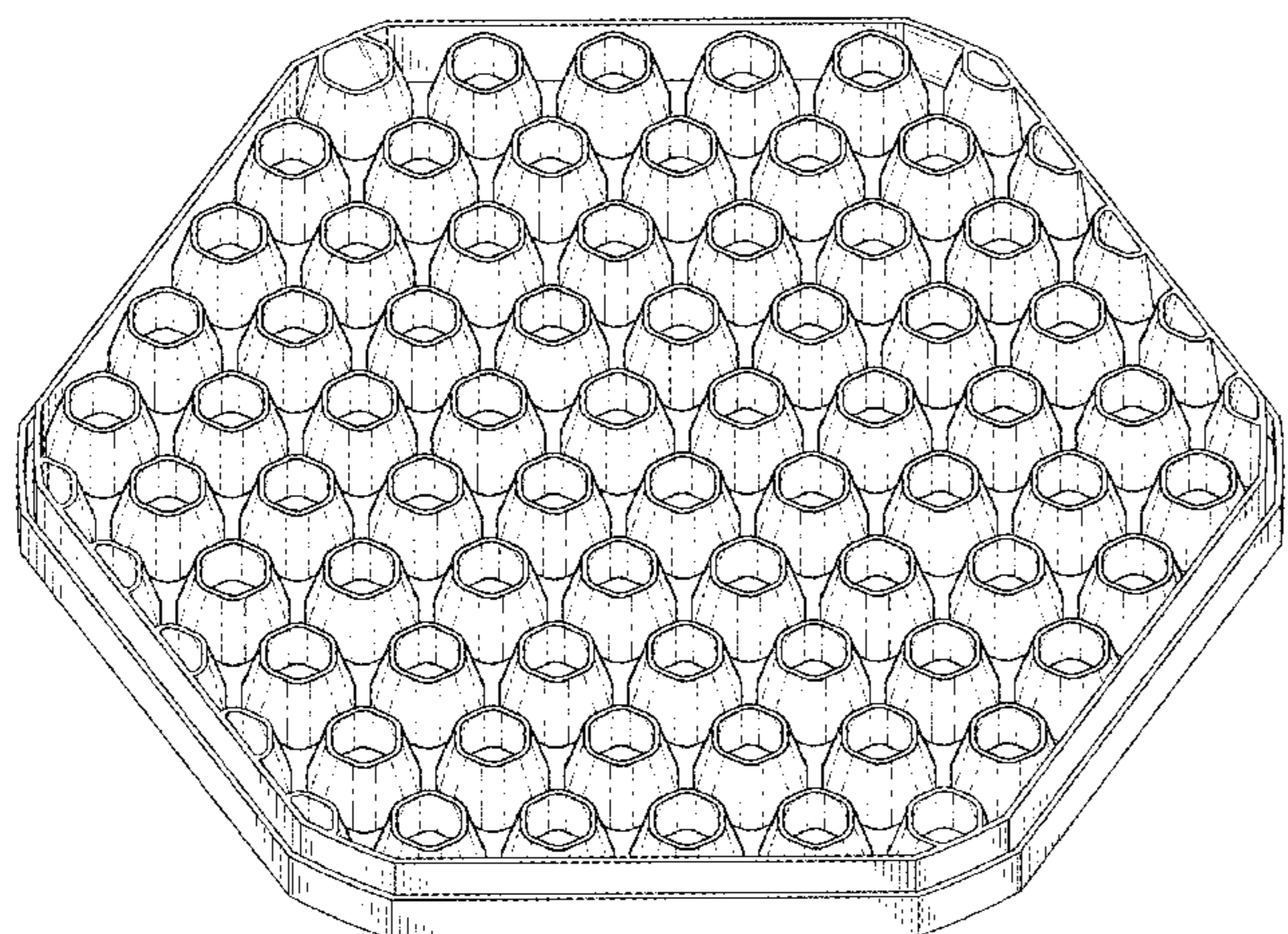


FIG. 34 is a bottom perspective view of the high bay light, according to the fifth embodiment;

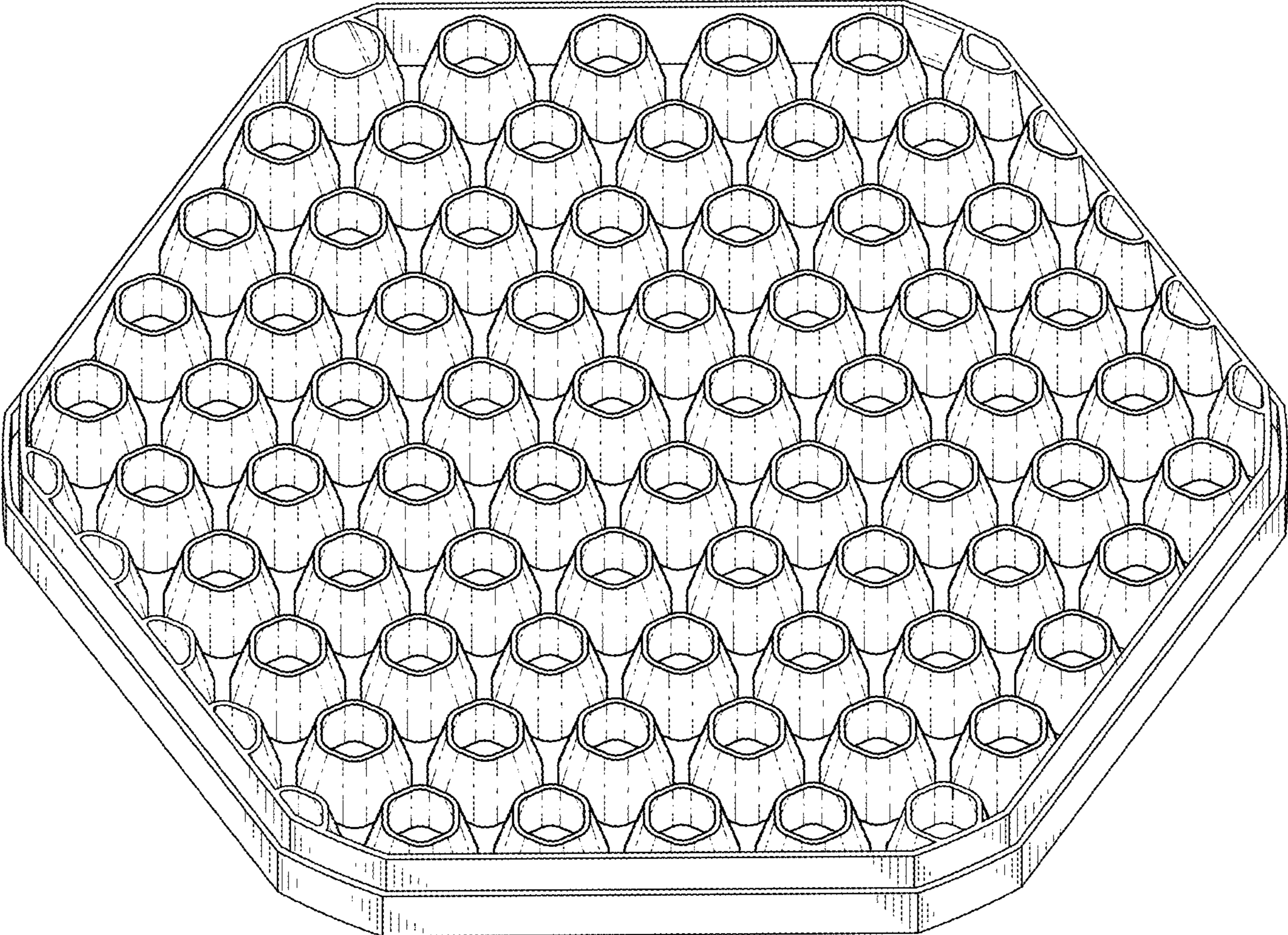

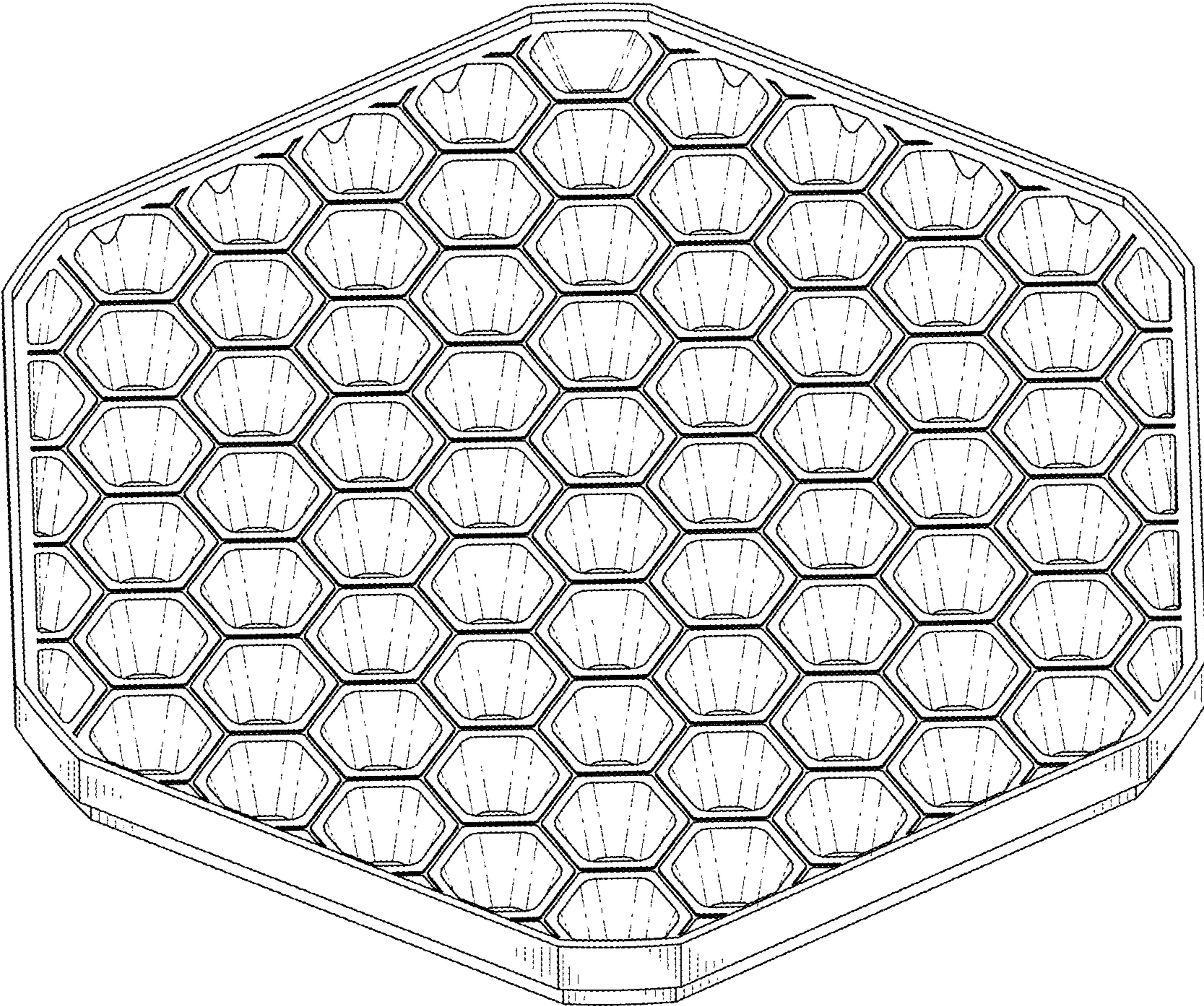

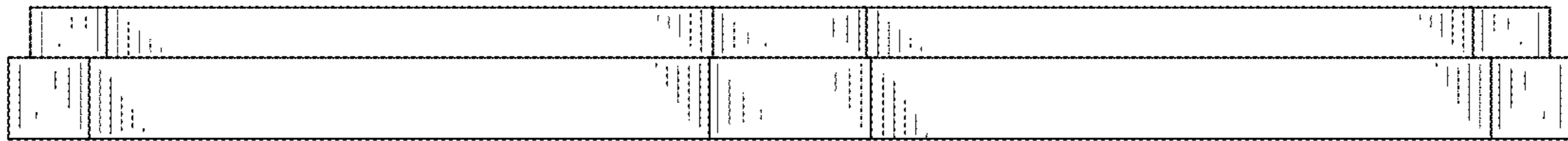

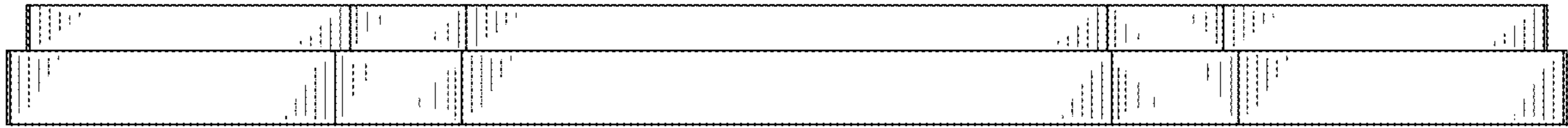

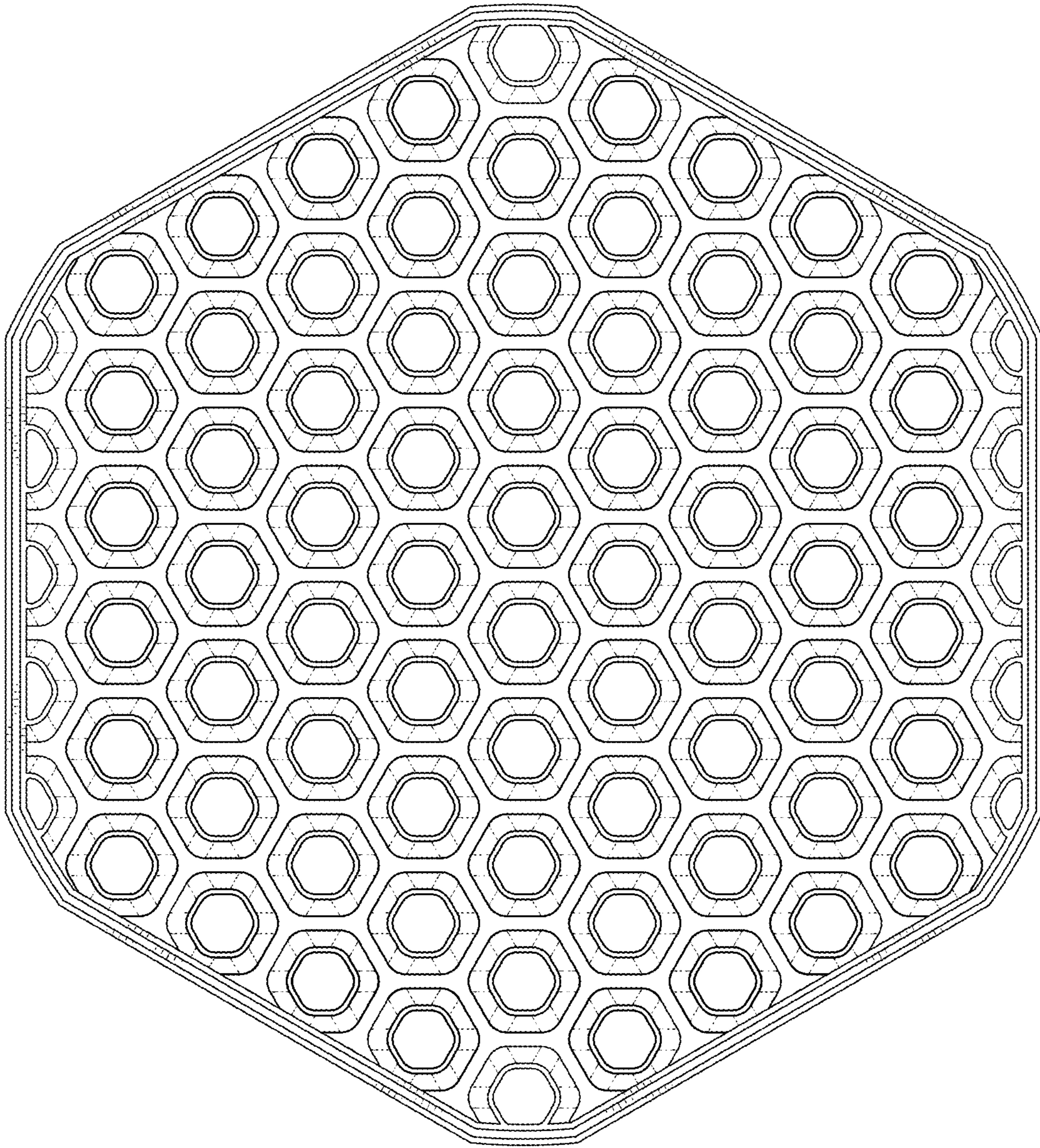

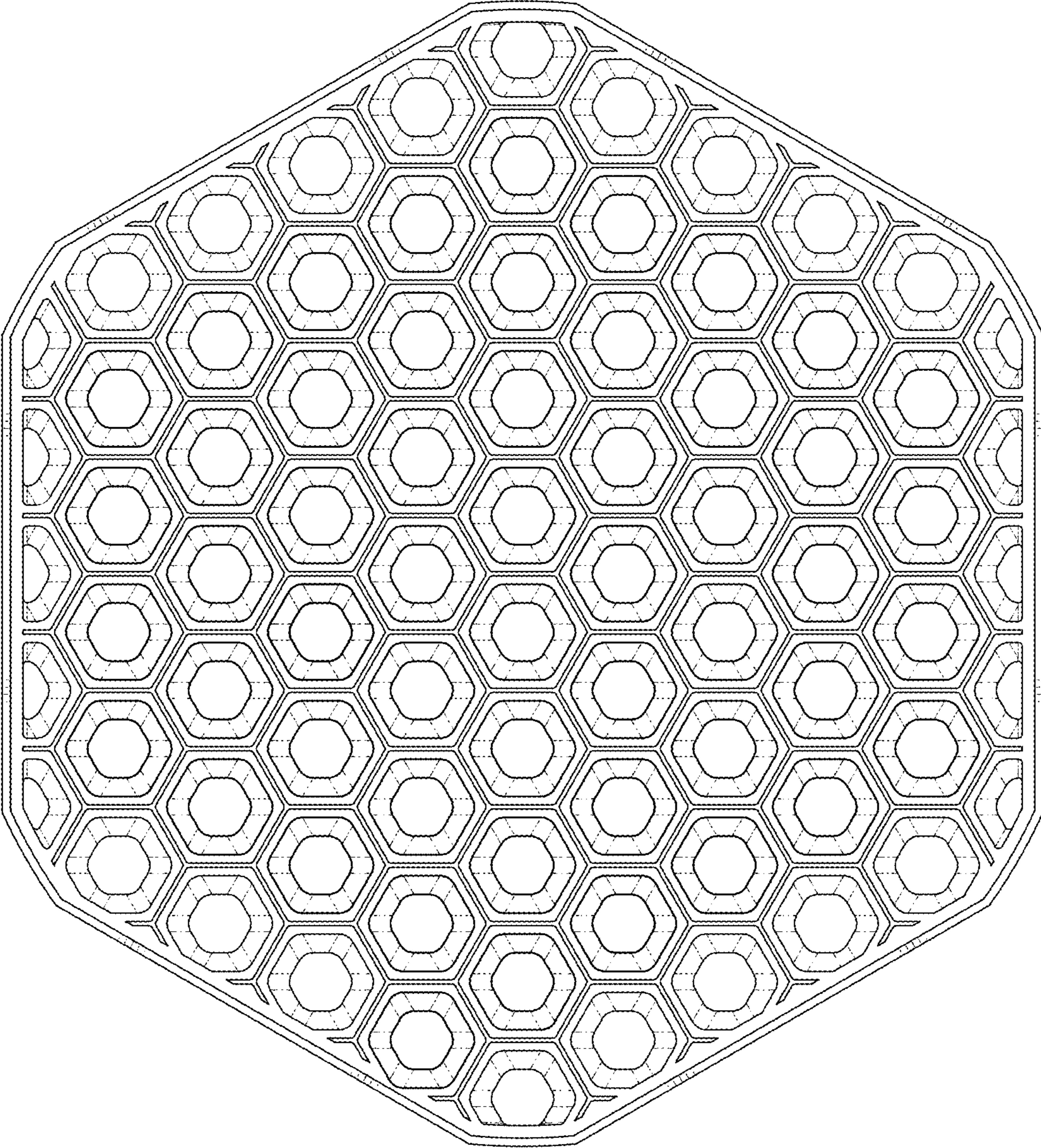

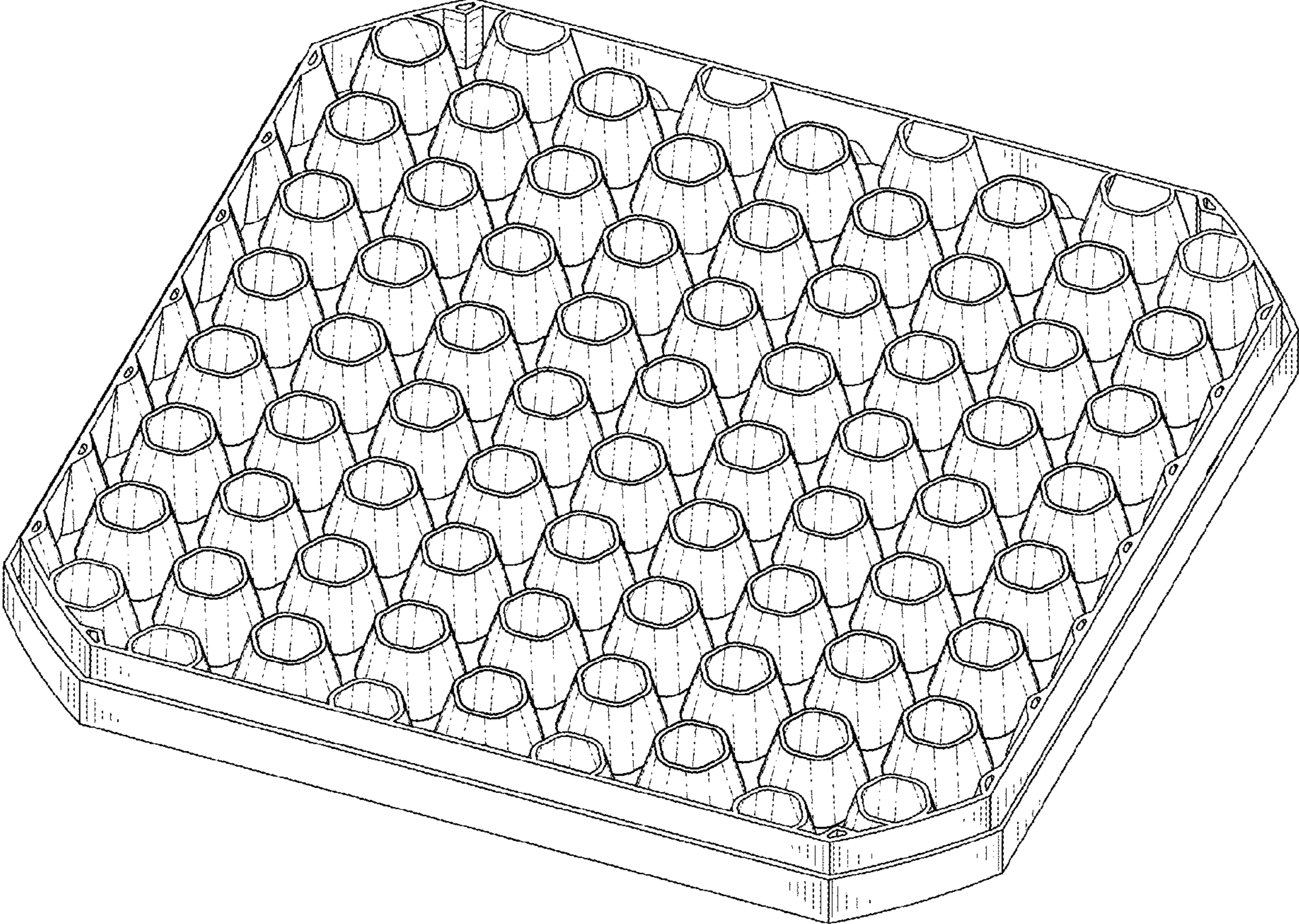

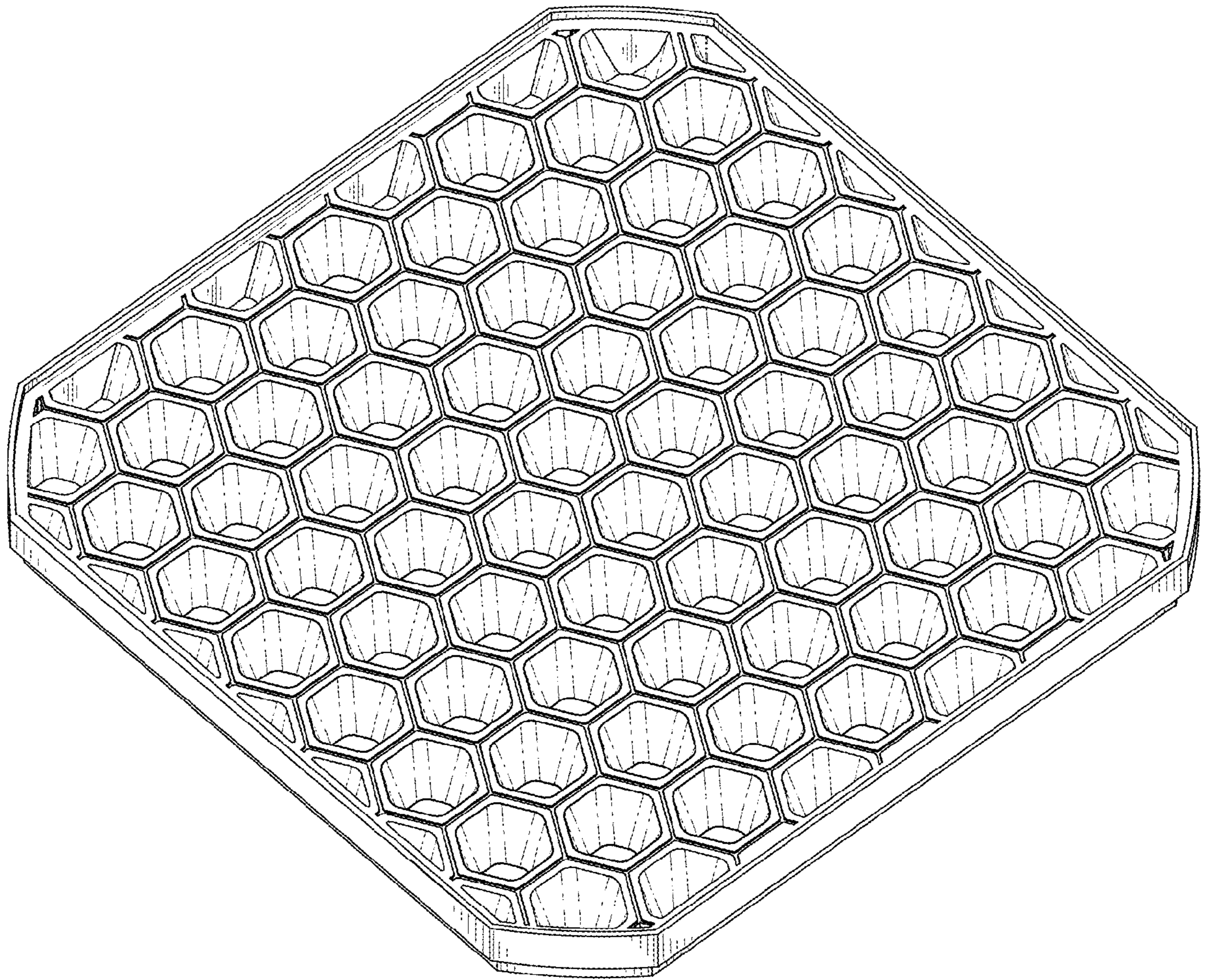

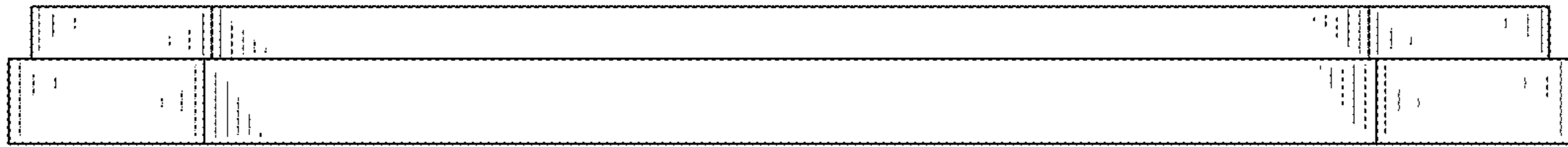

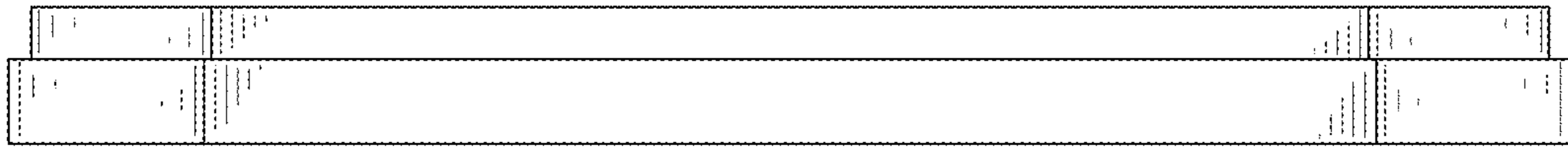

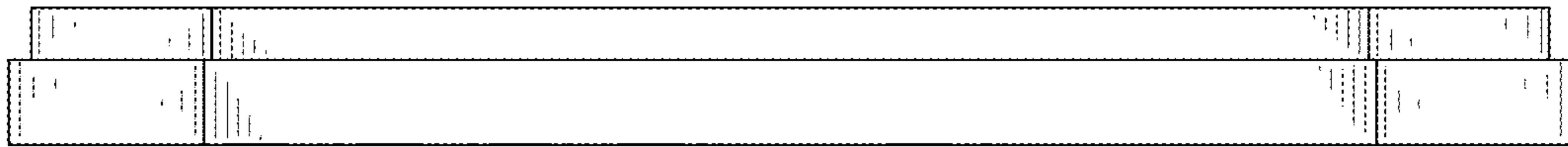

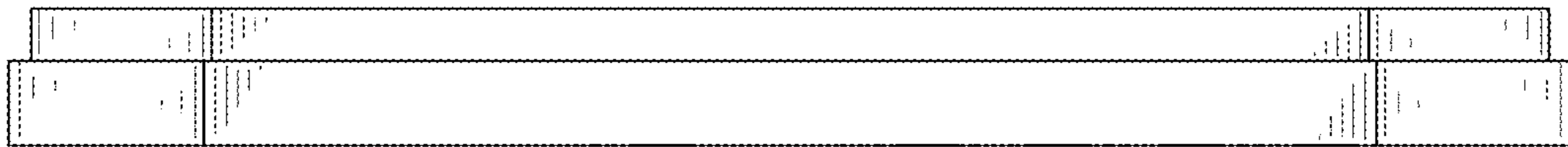

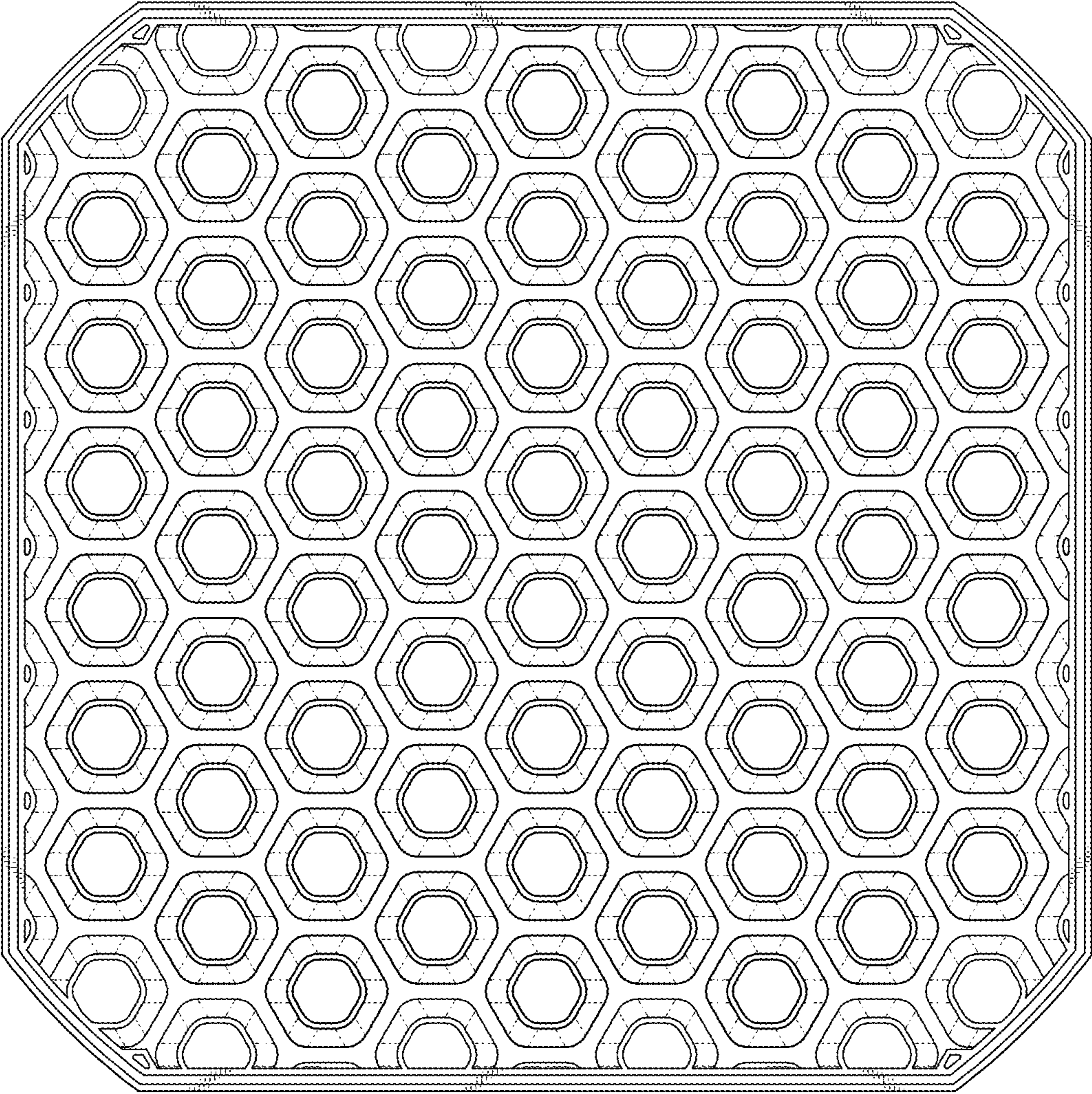

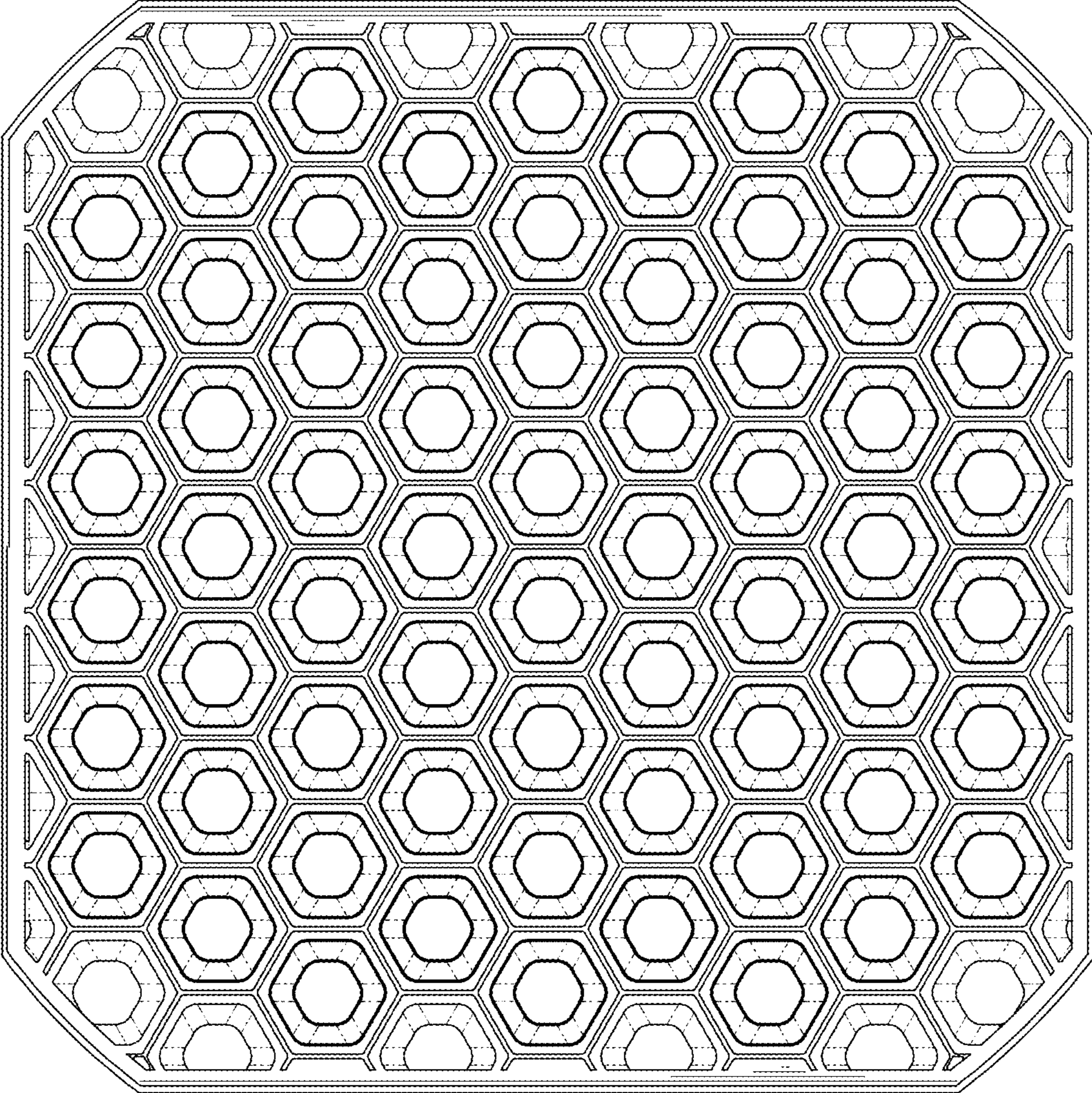

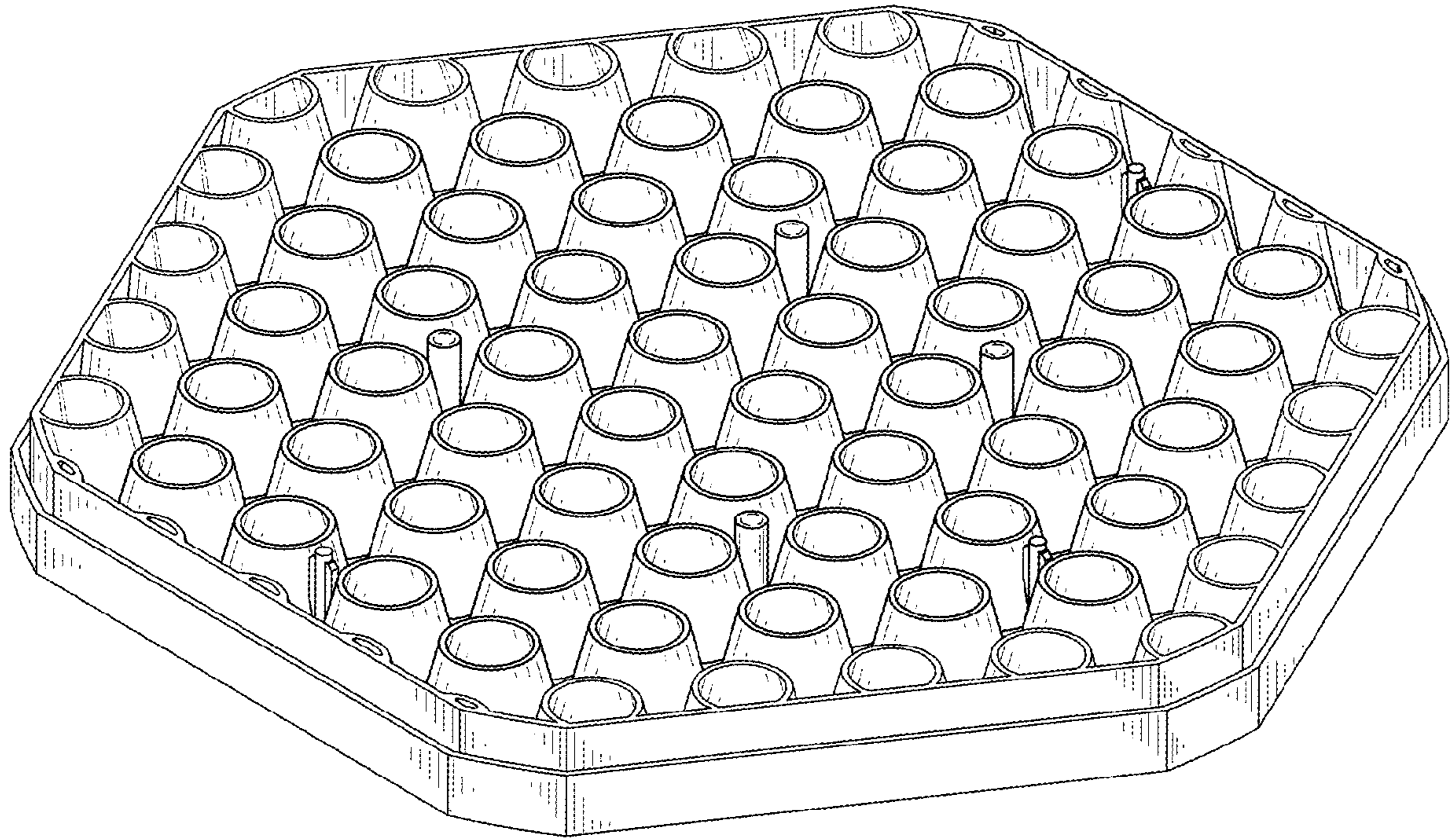

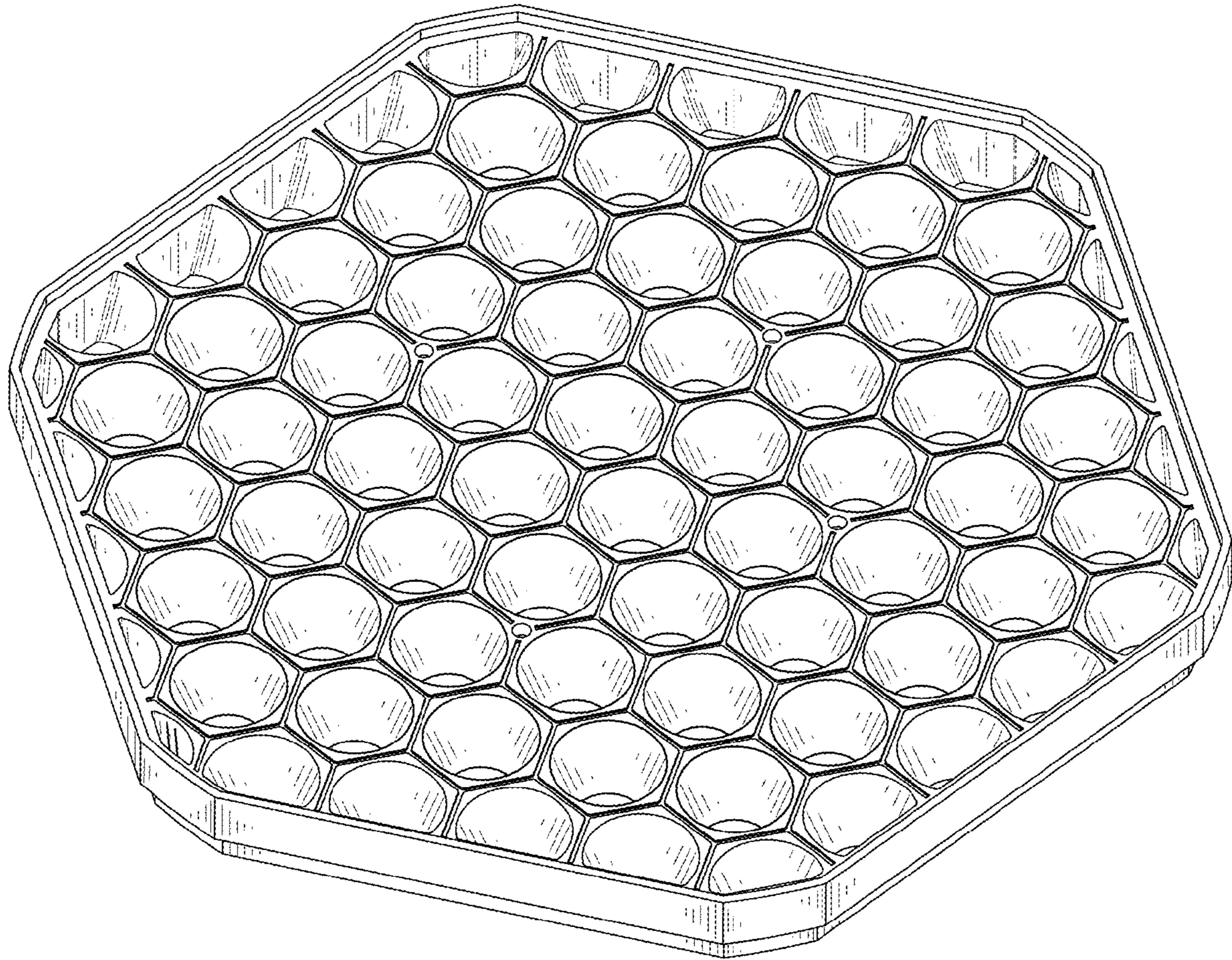

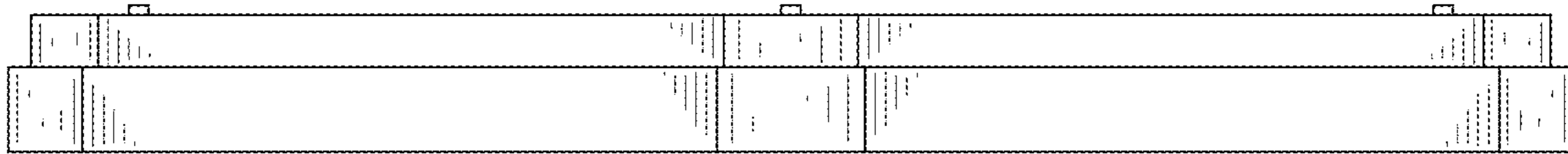

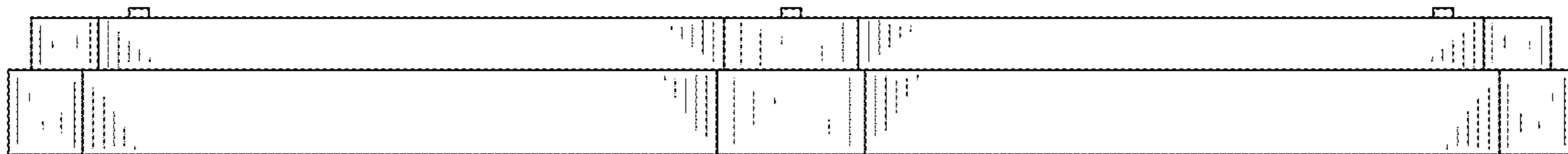

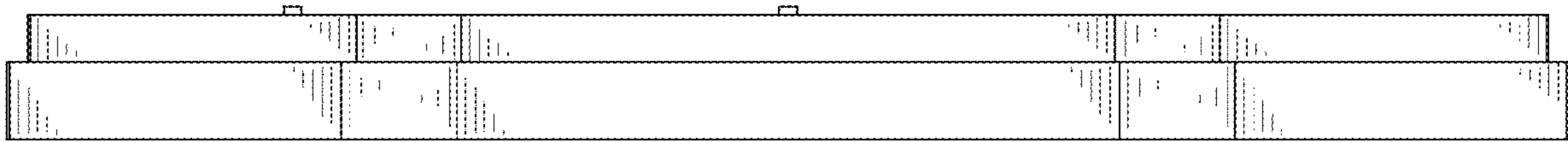

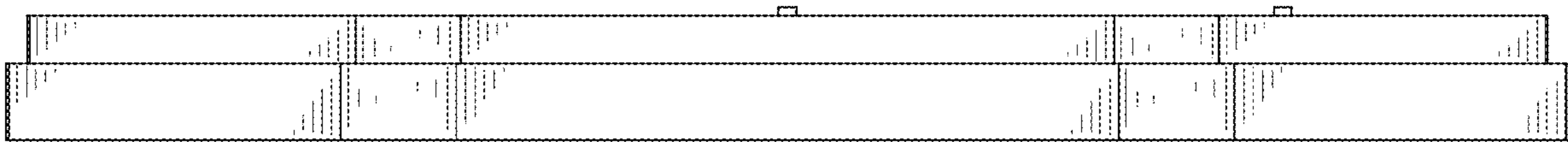

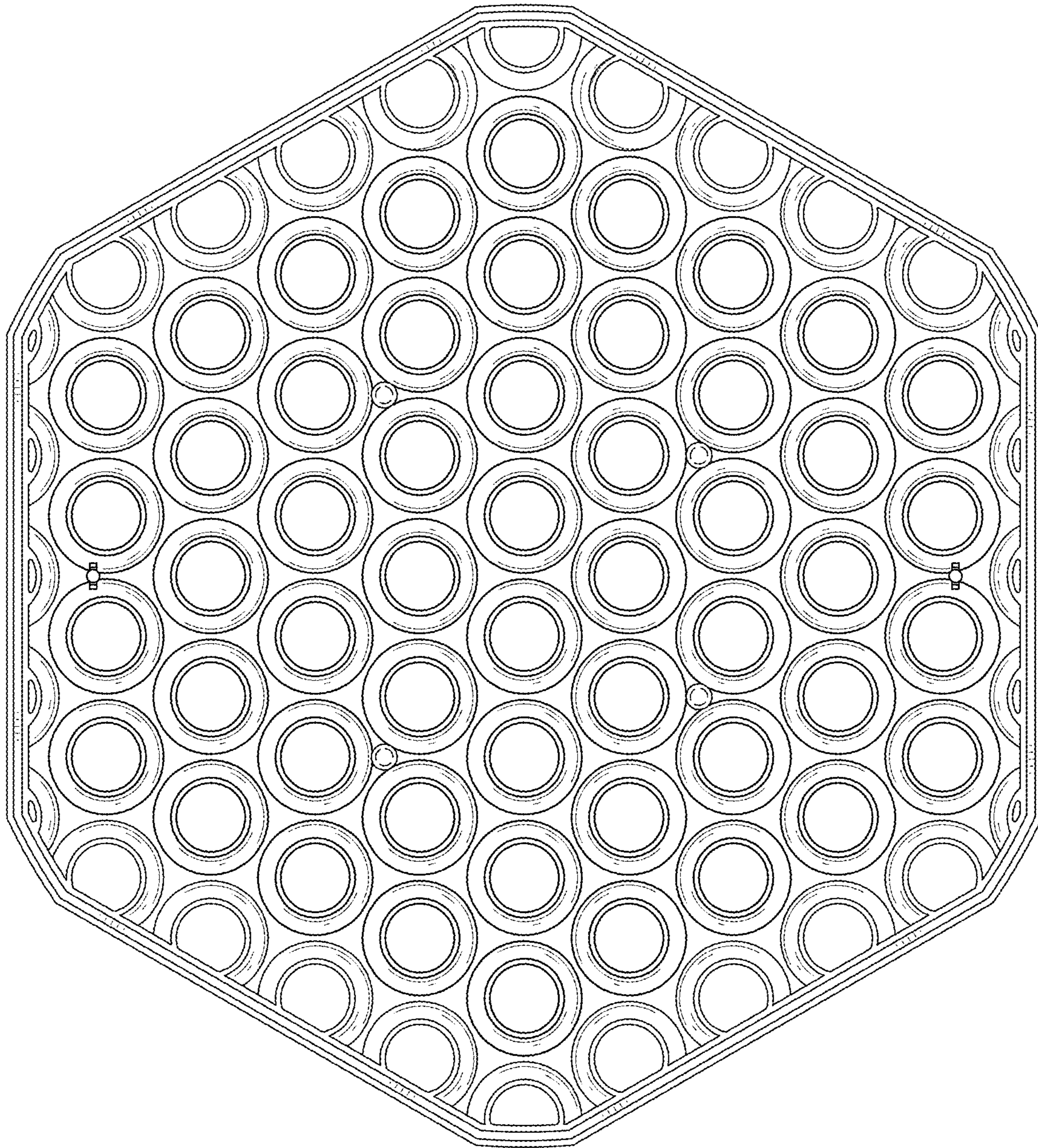

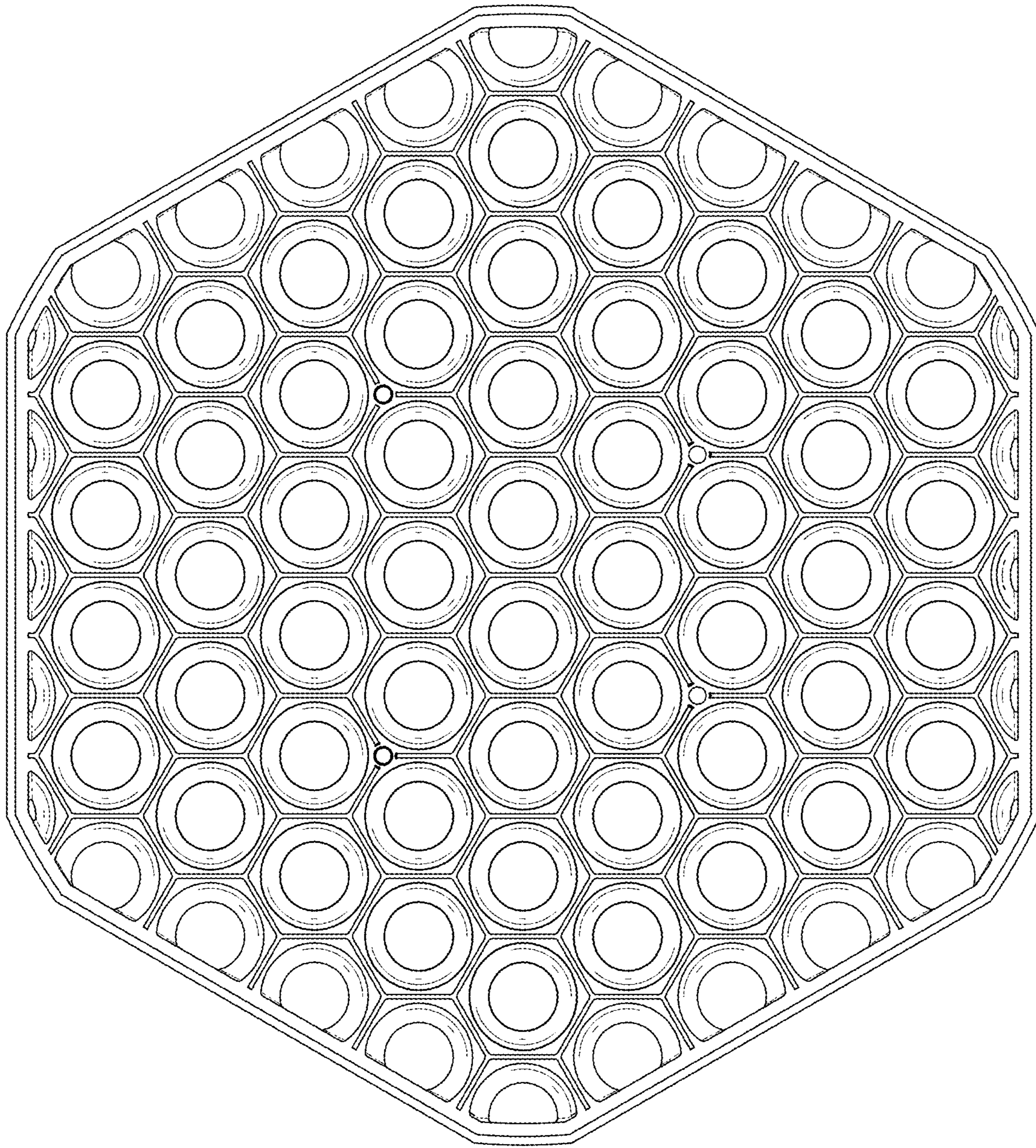

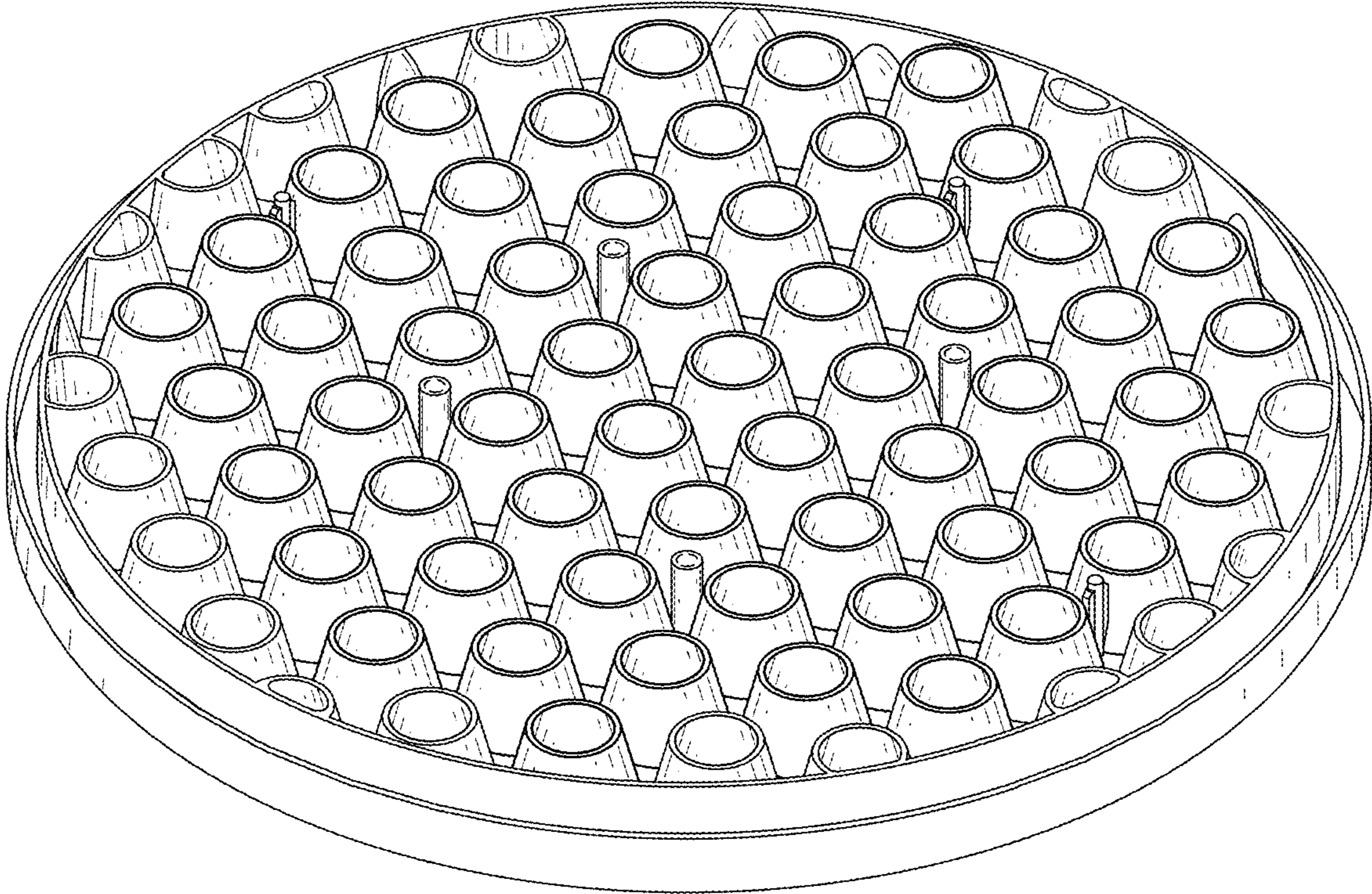

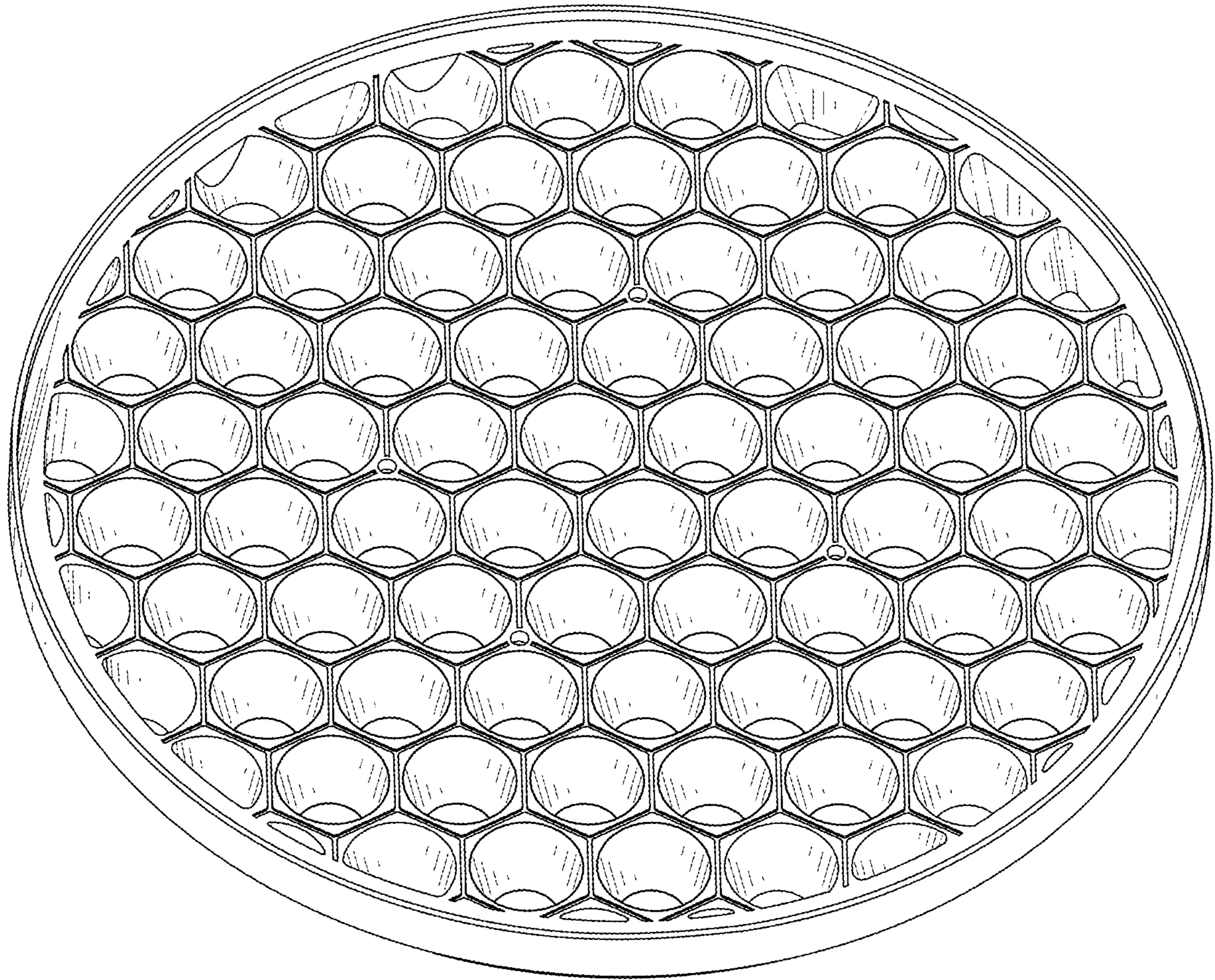

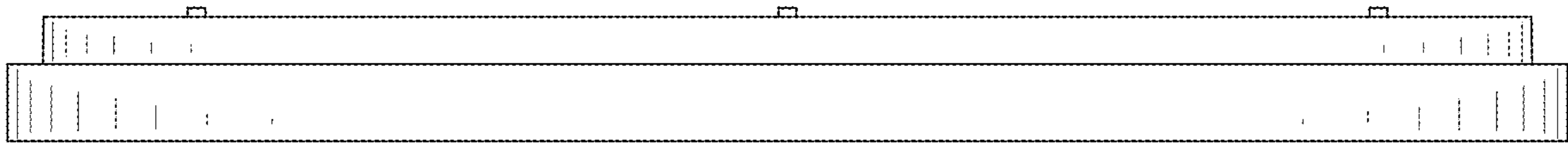

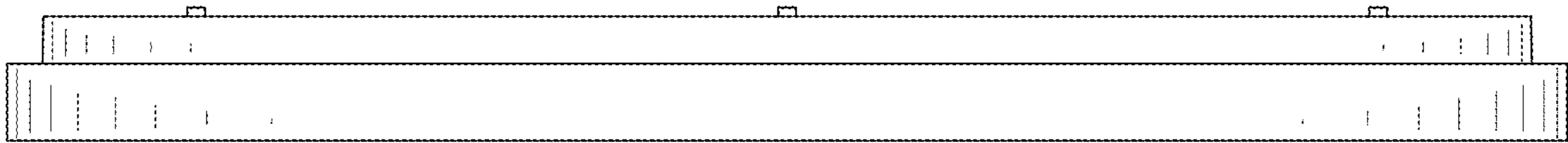

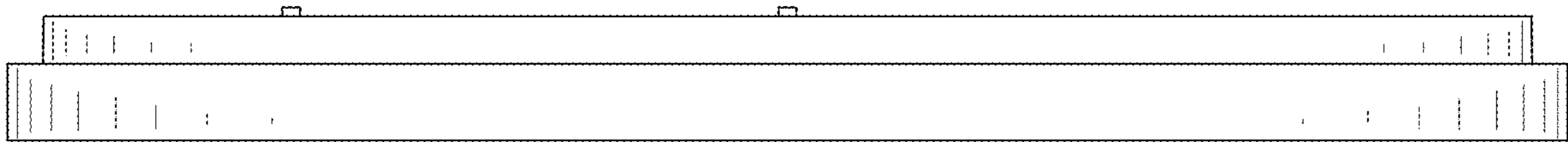

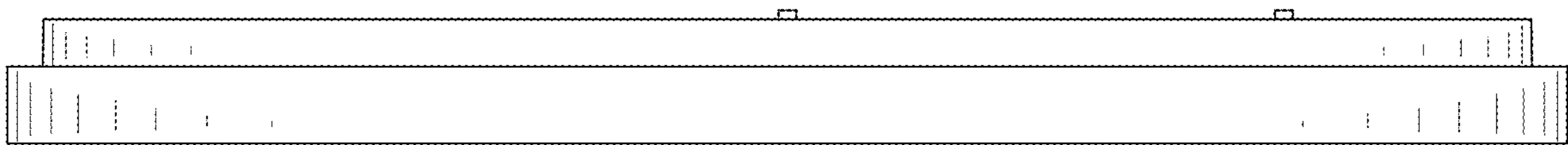

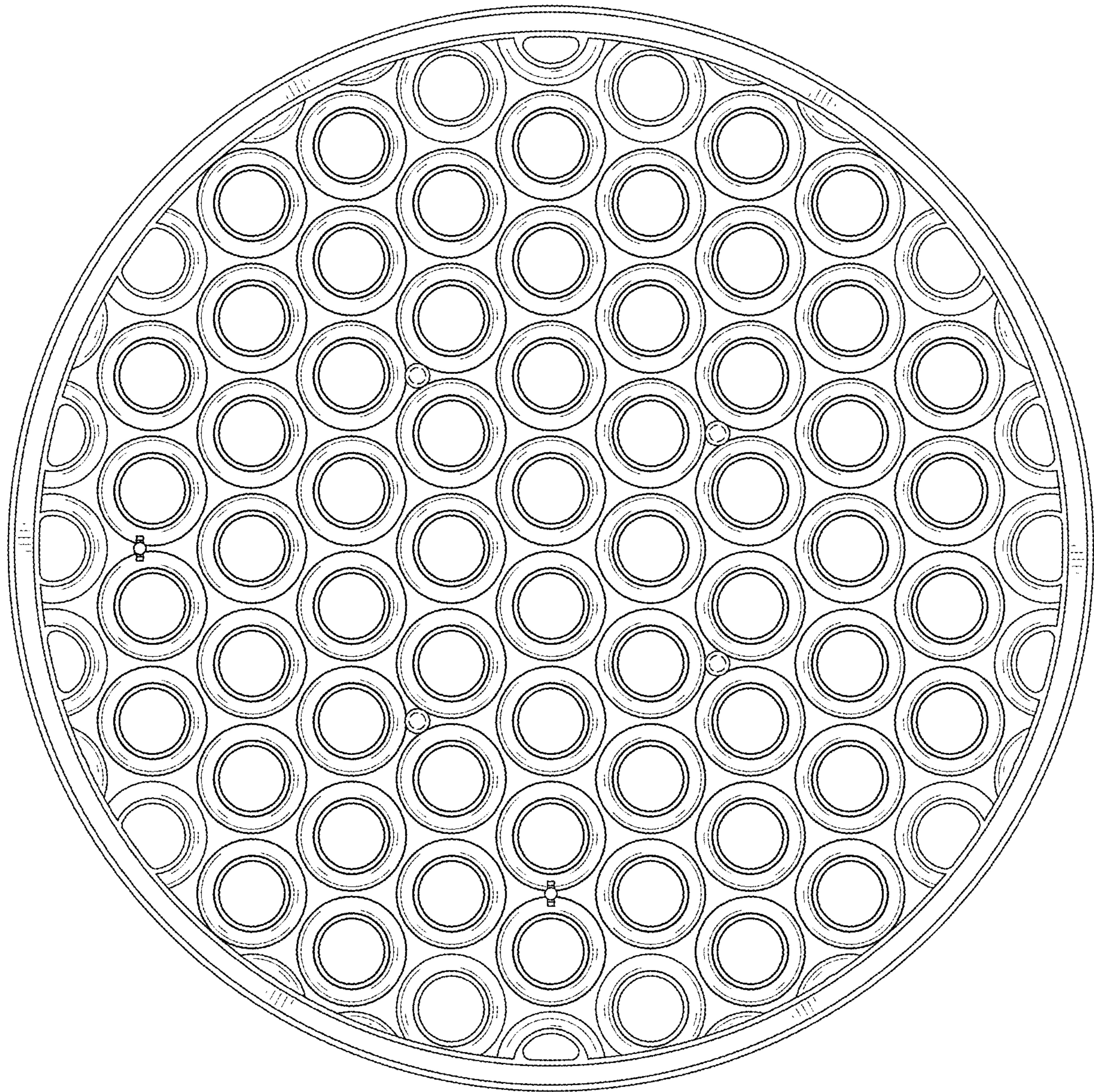

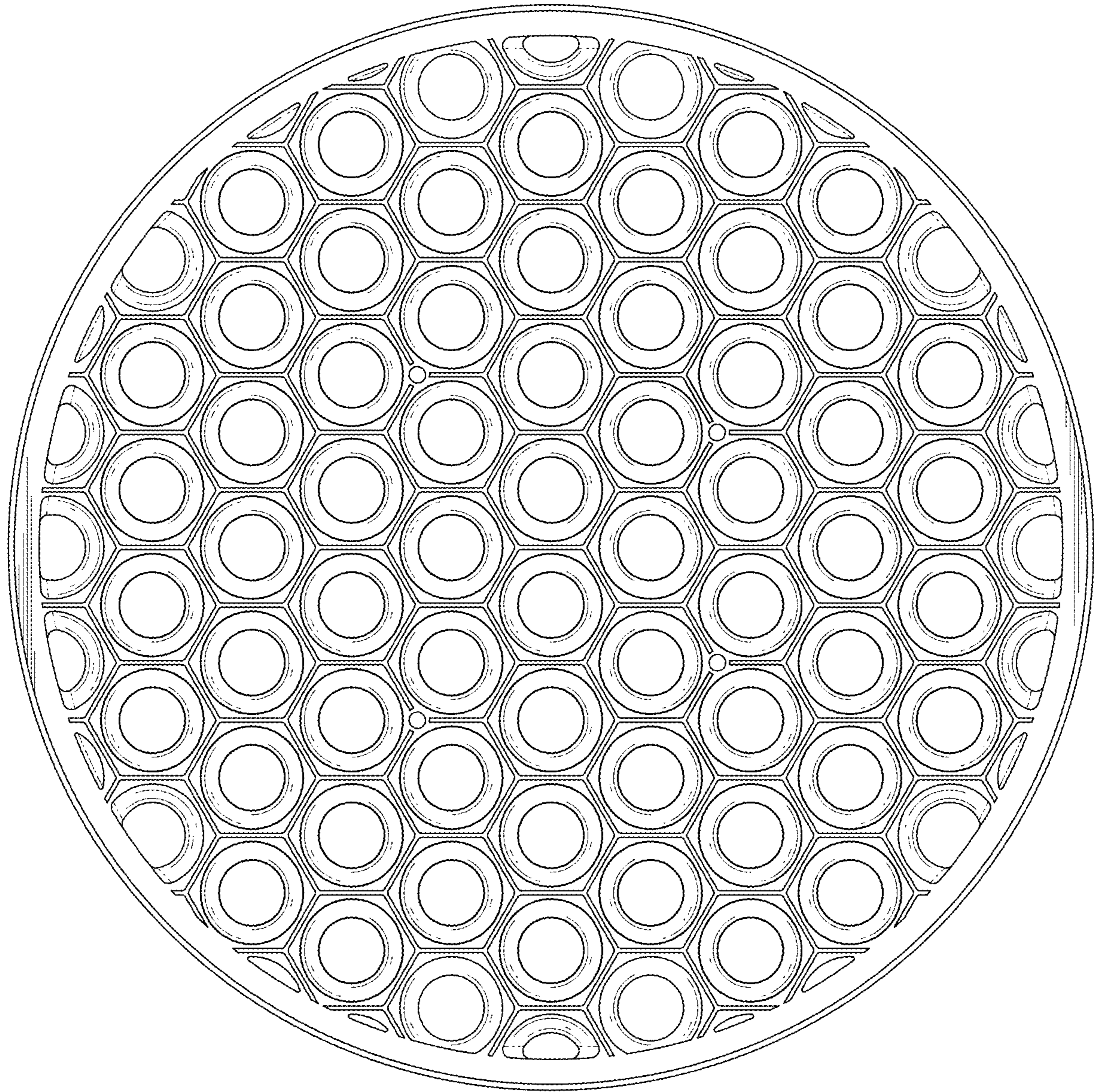

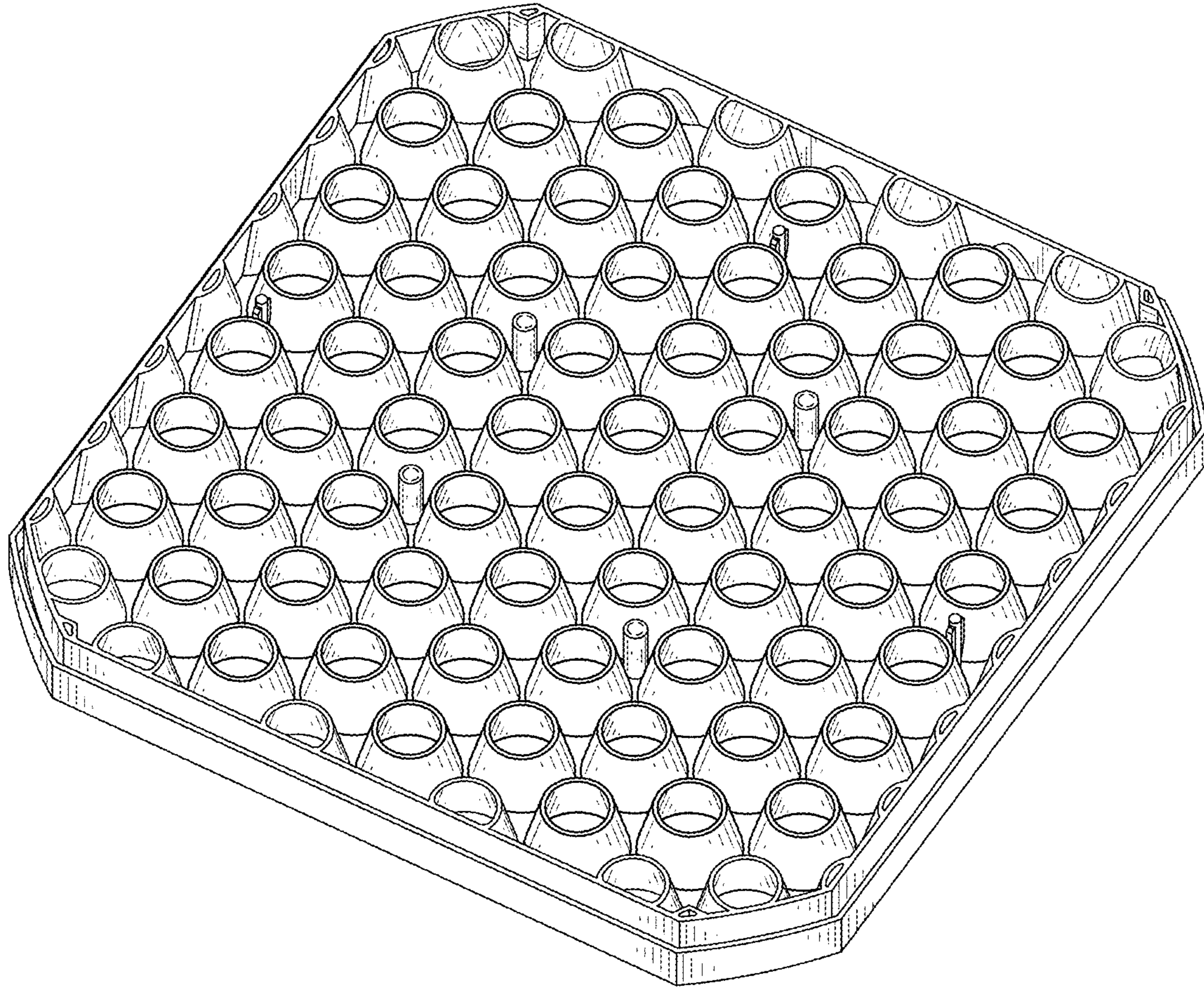

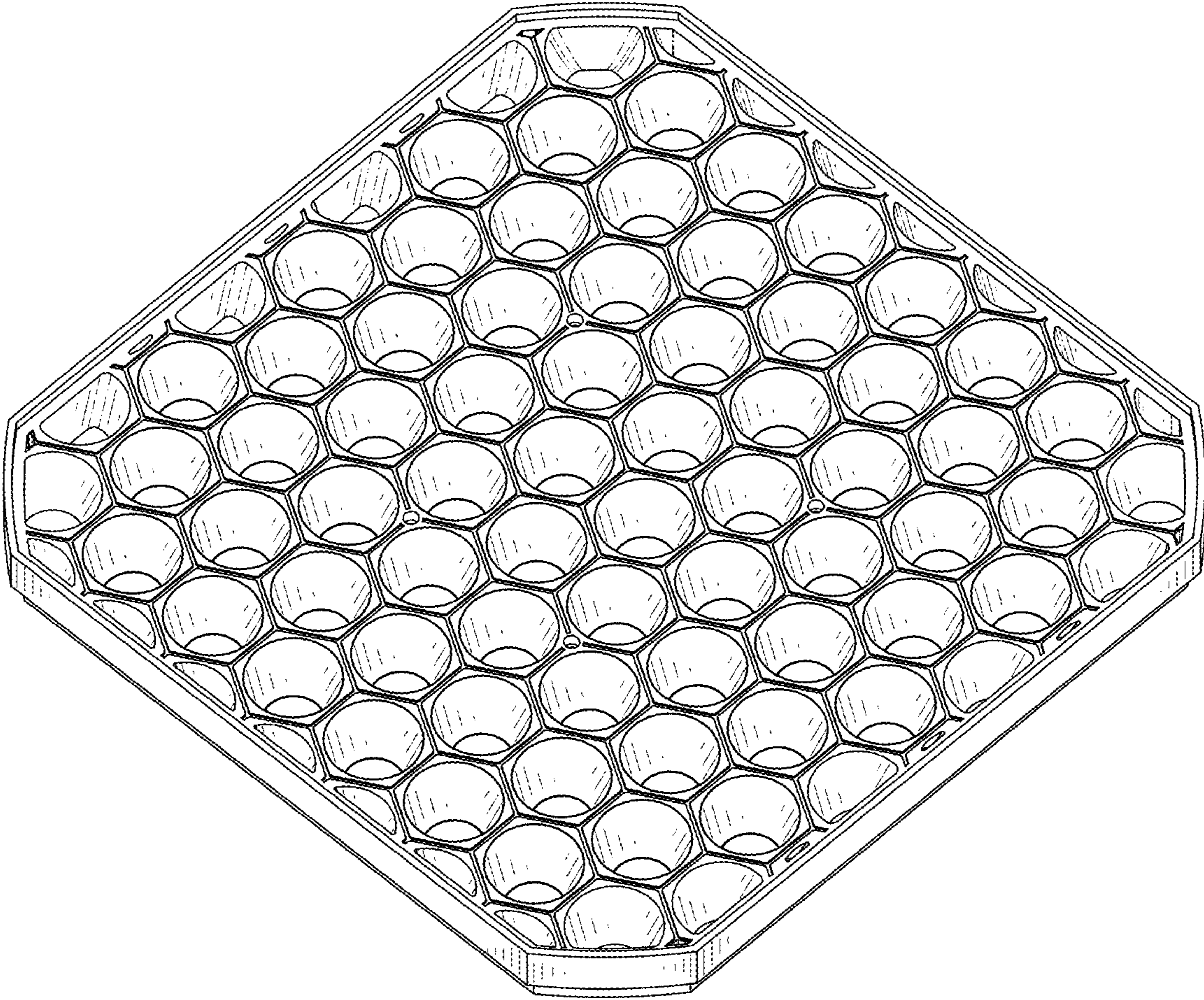

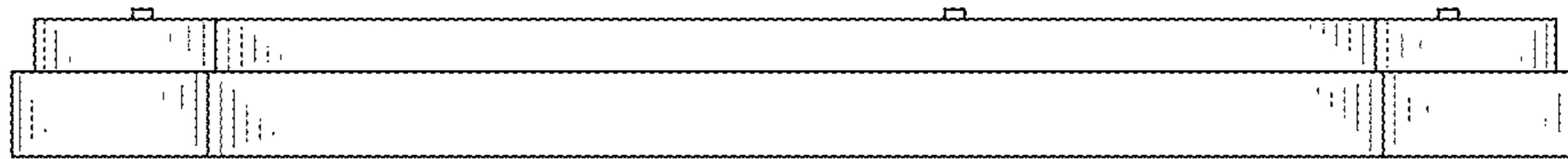

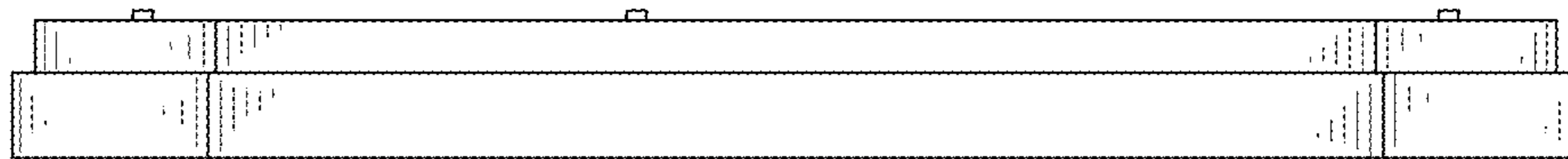

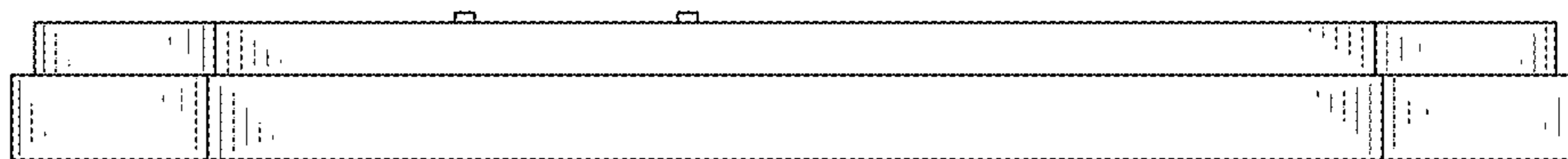

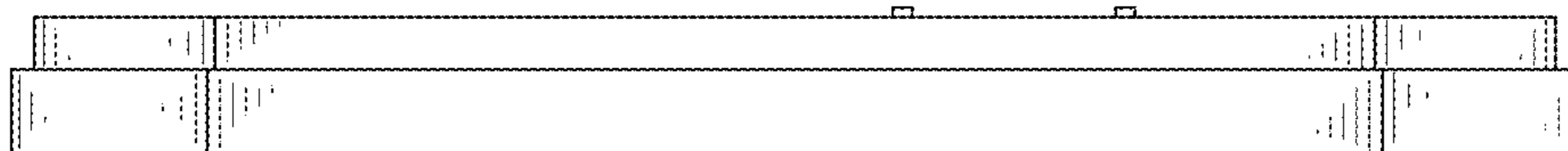

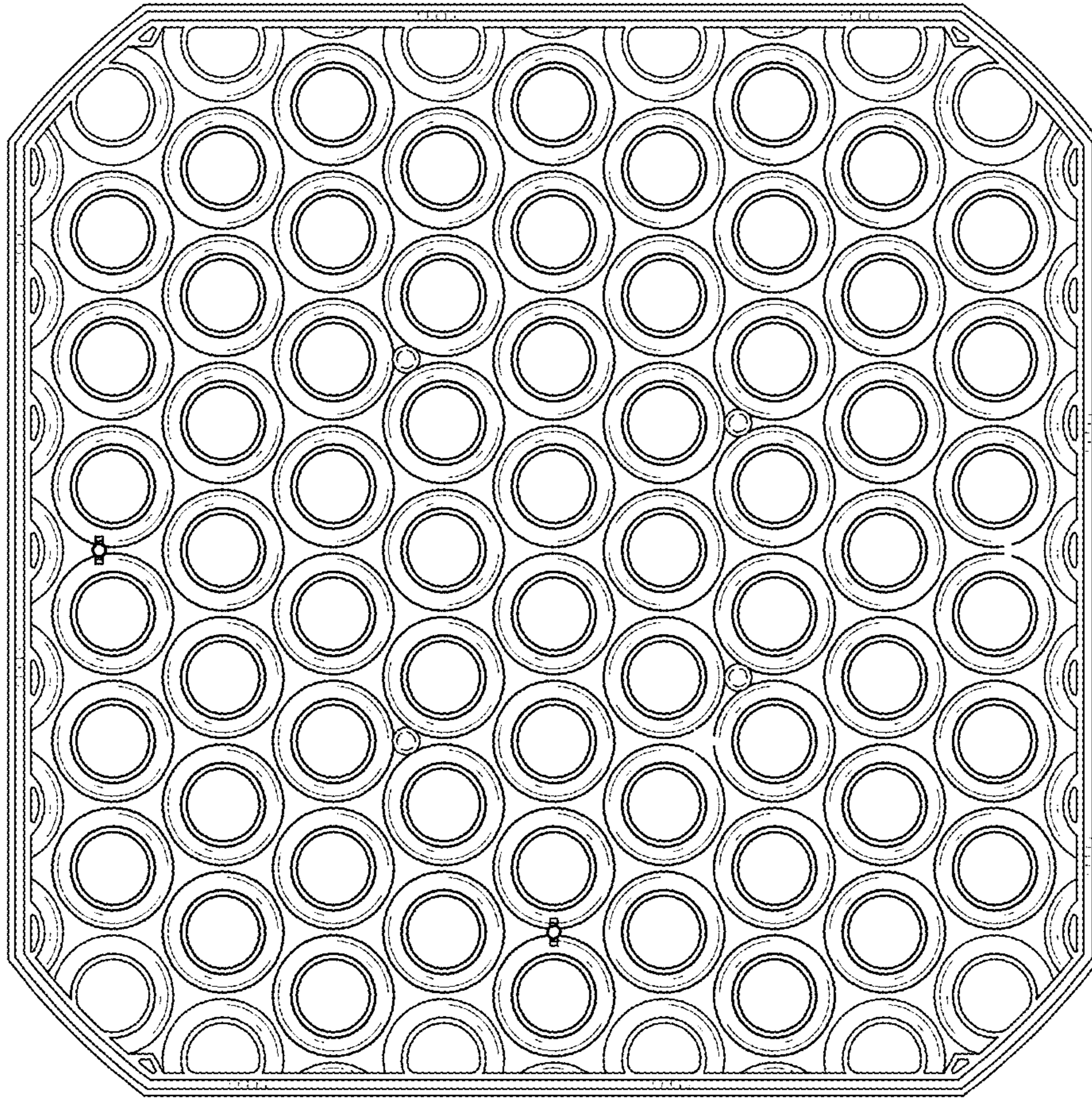

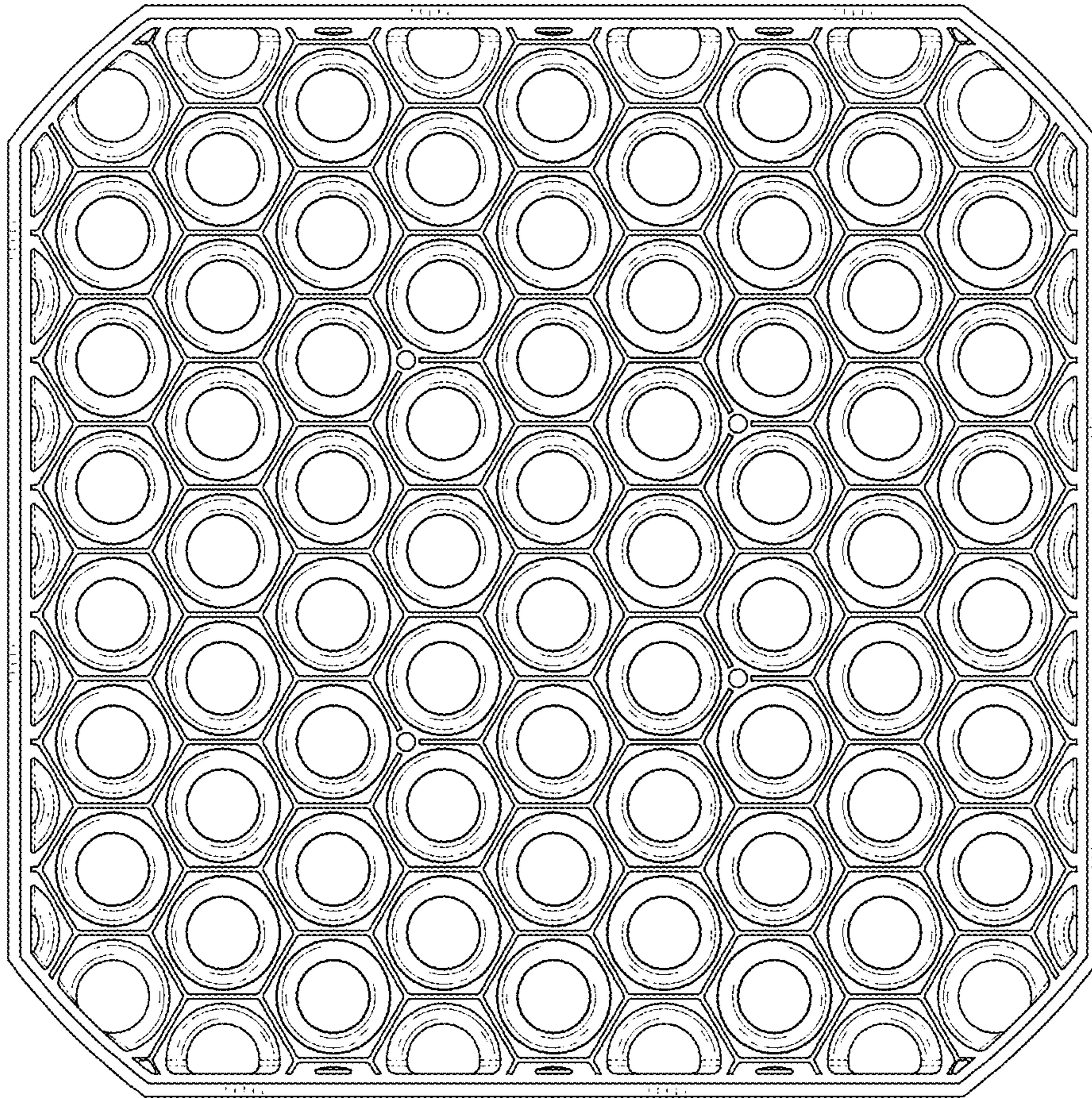
