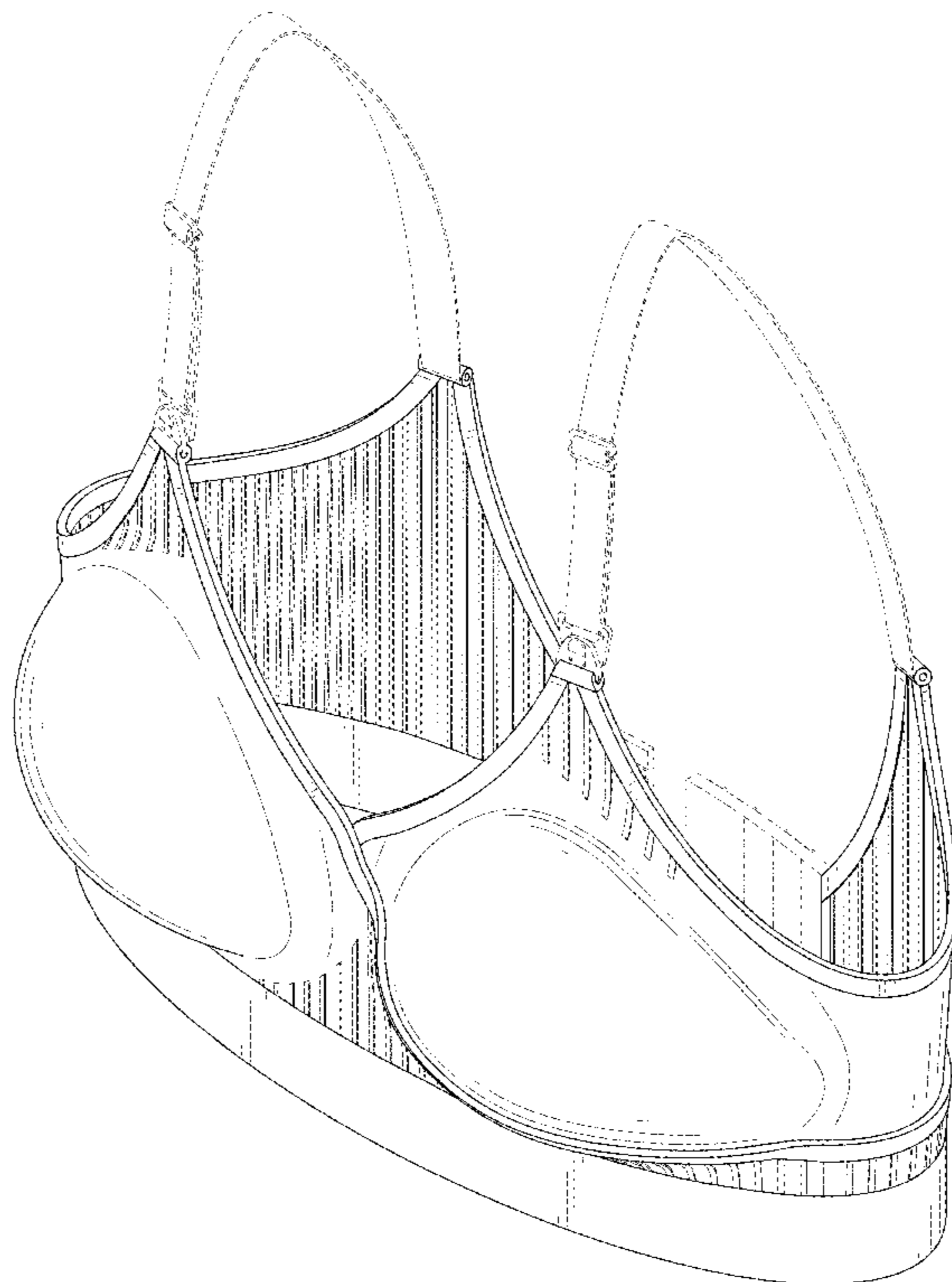
(57) **CLAIM**

I claim the ornamental design for a brassiere, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a first embodiment of a brassiere, showing my new design;

 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof;

 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is another front elevational view thereof showing the first embodiment of the brassiere when worn;

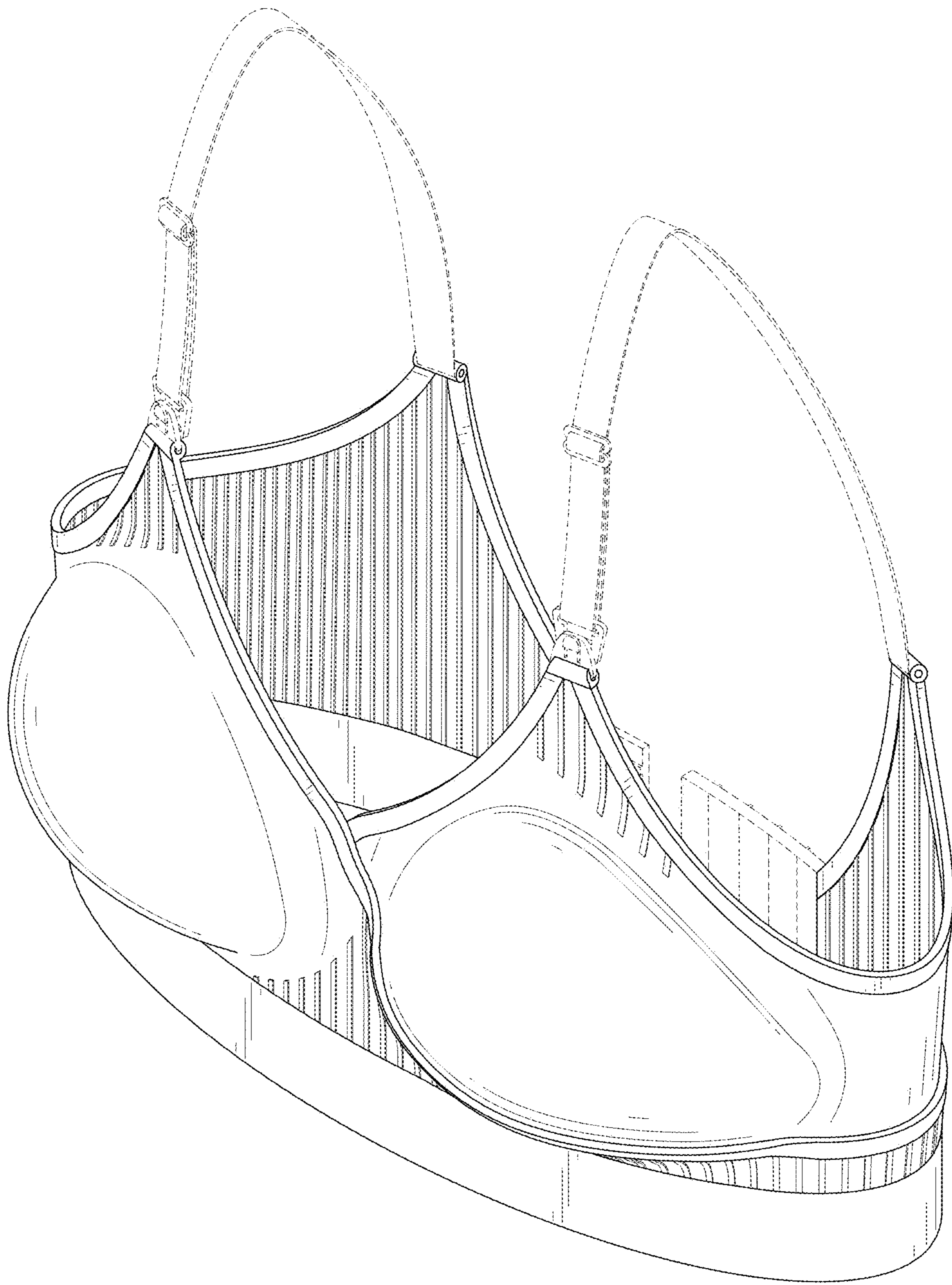

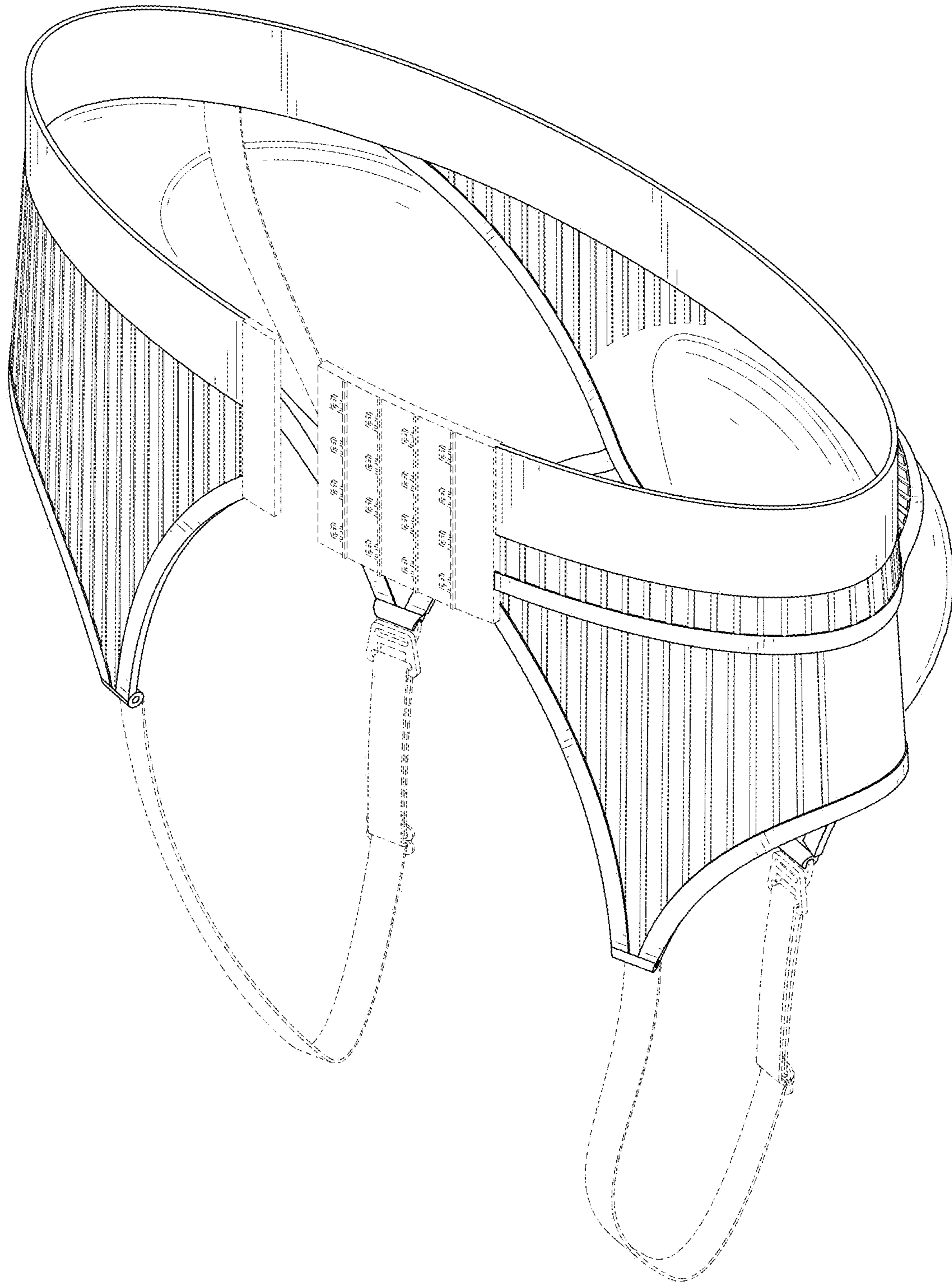

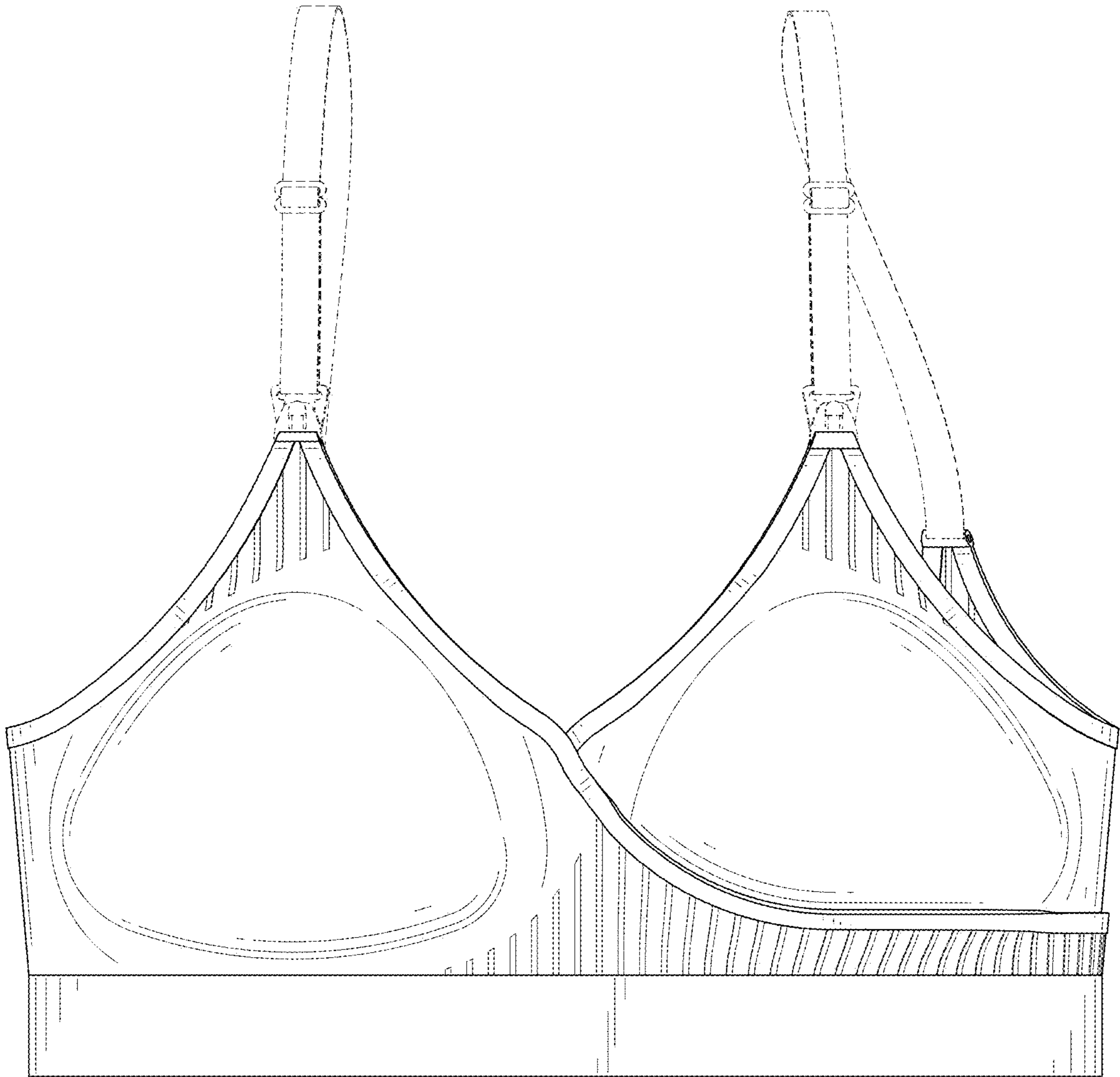

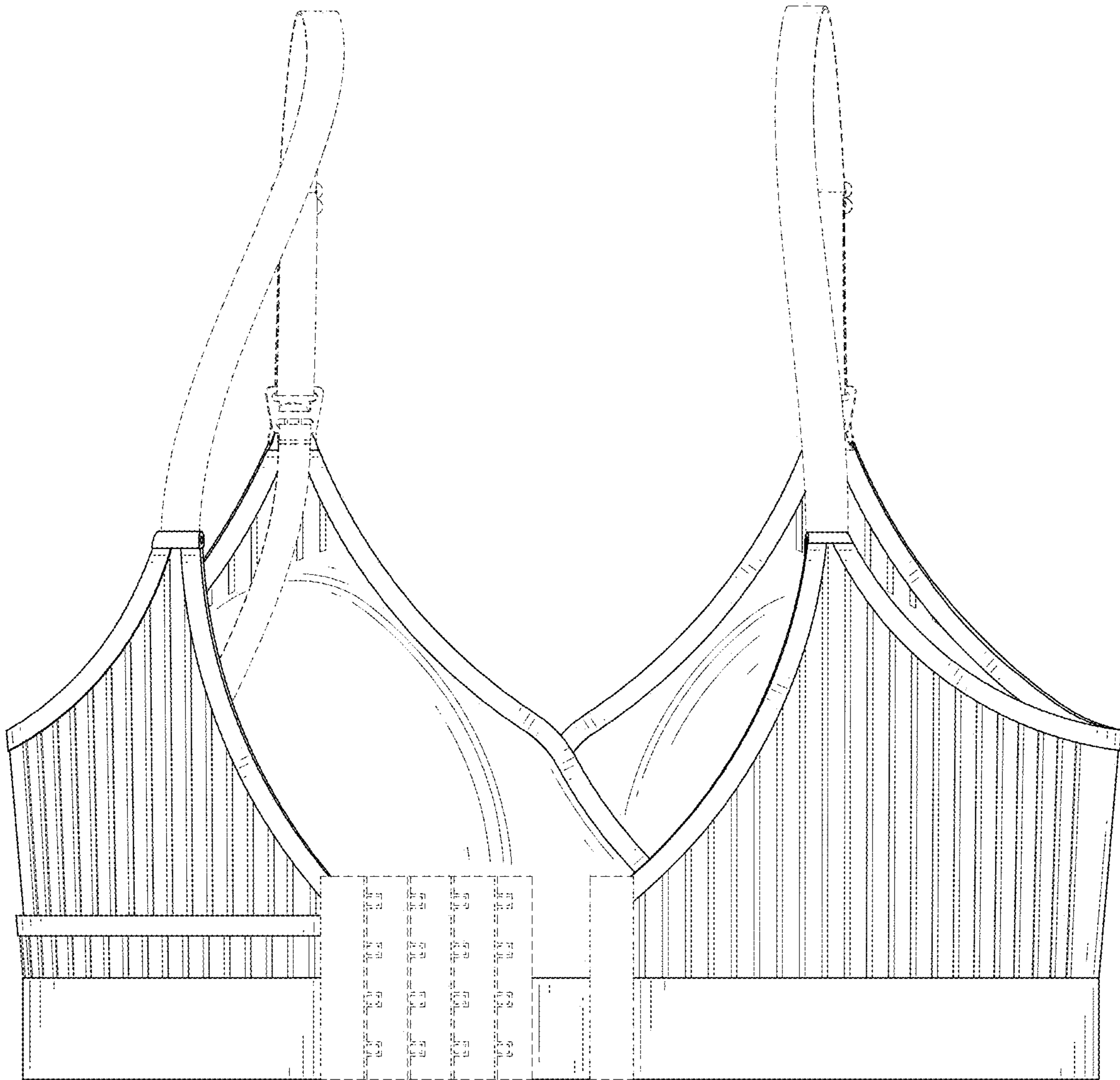

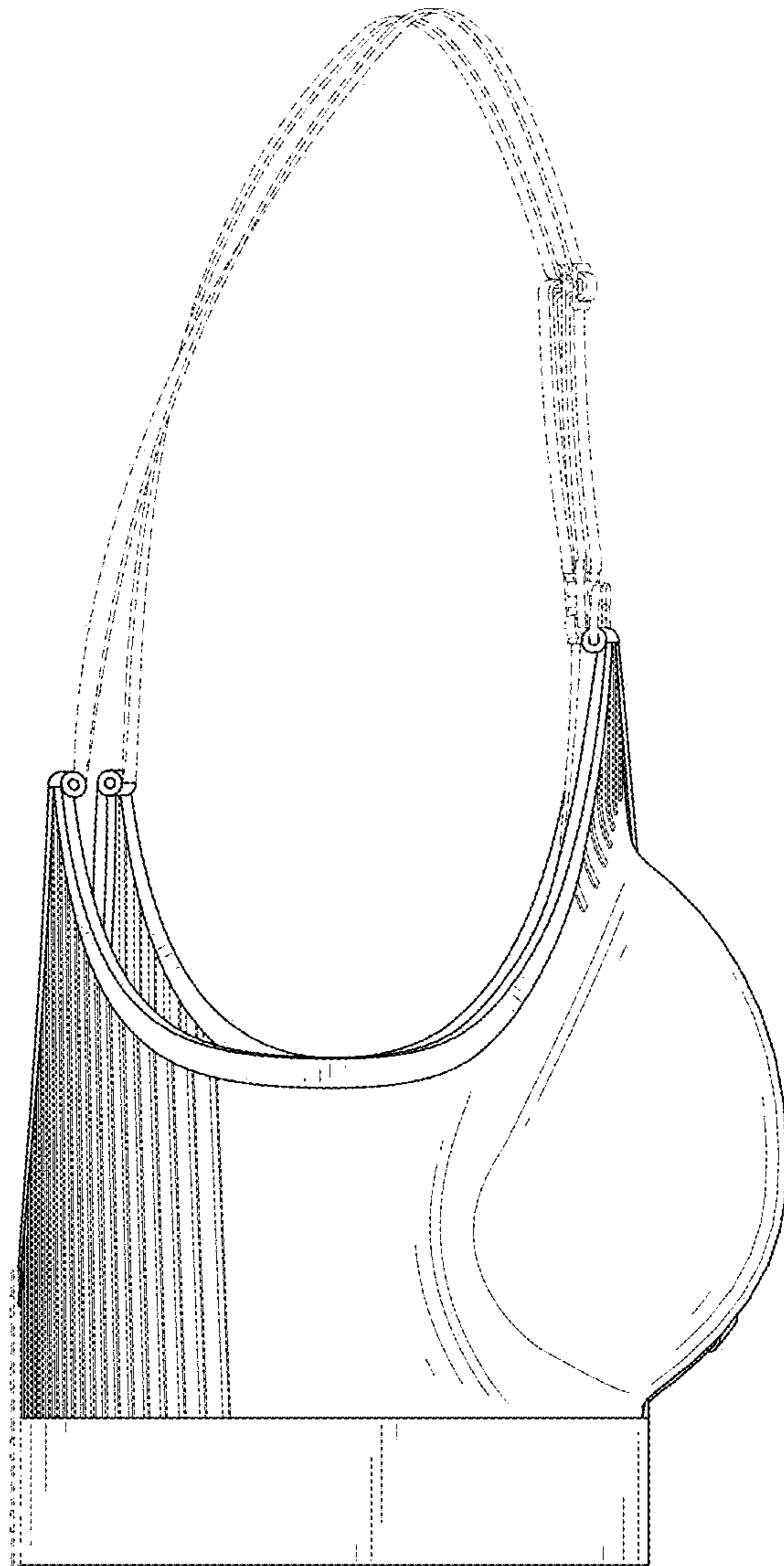

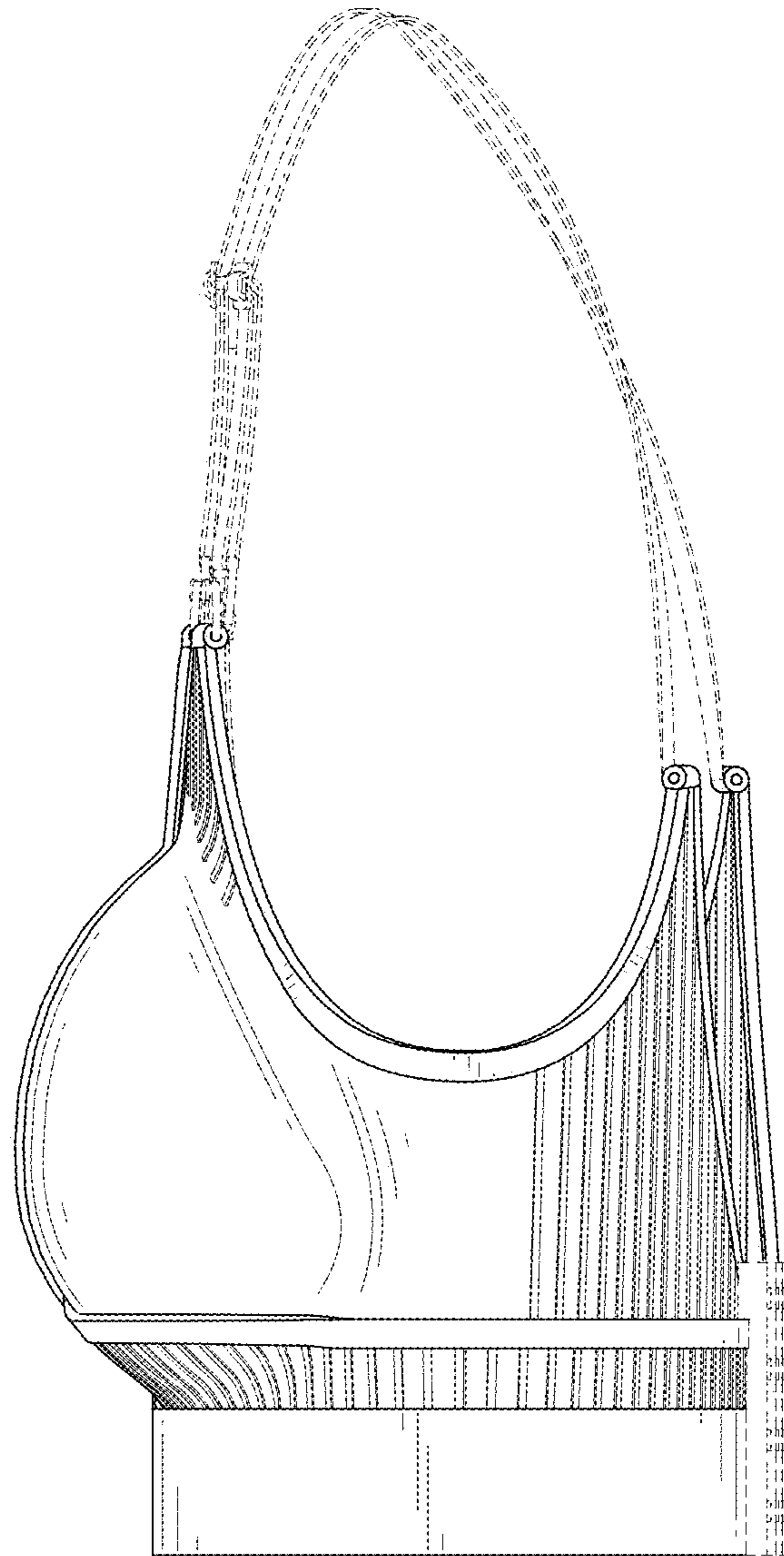

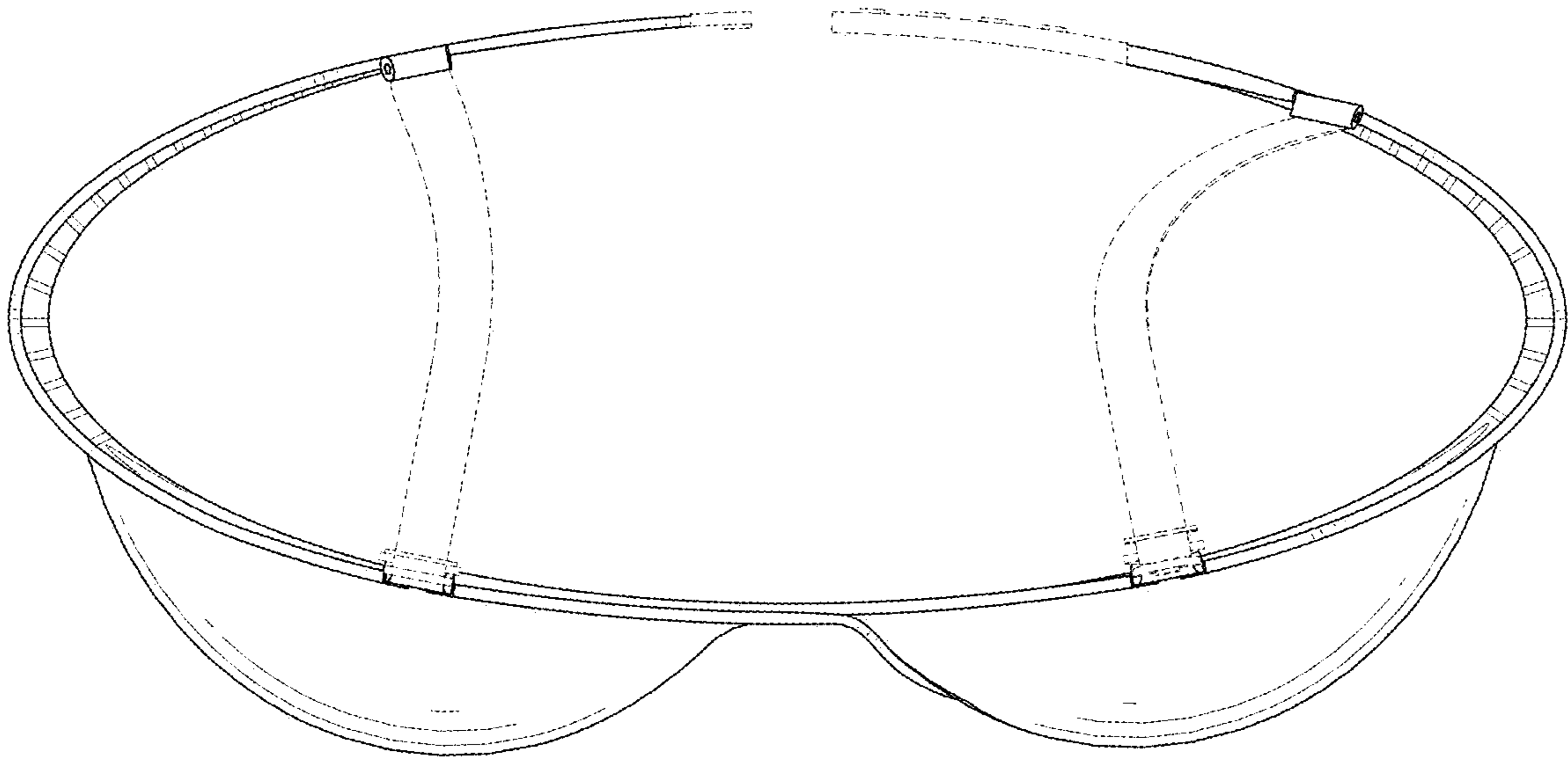

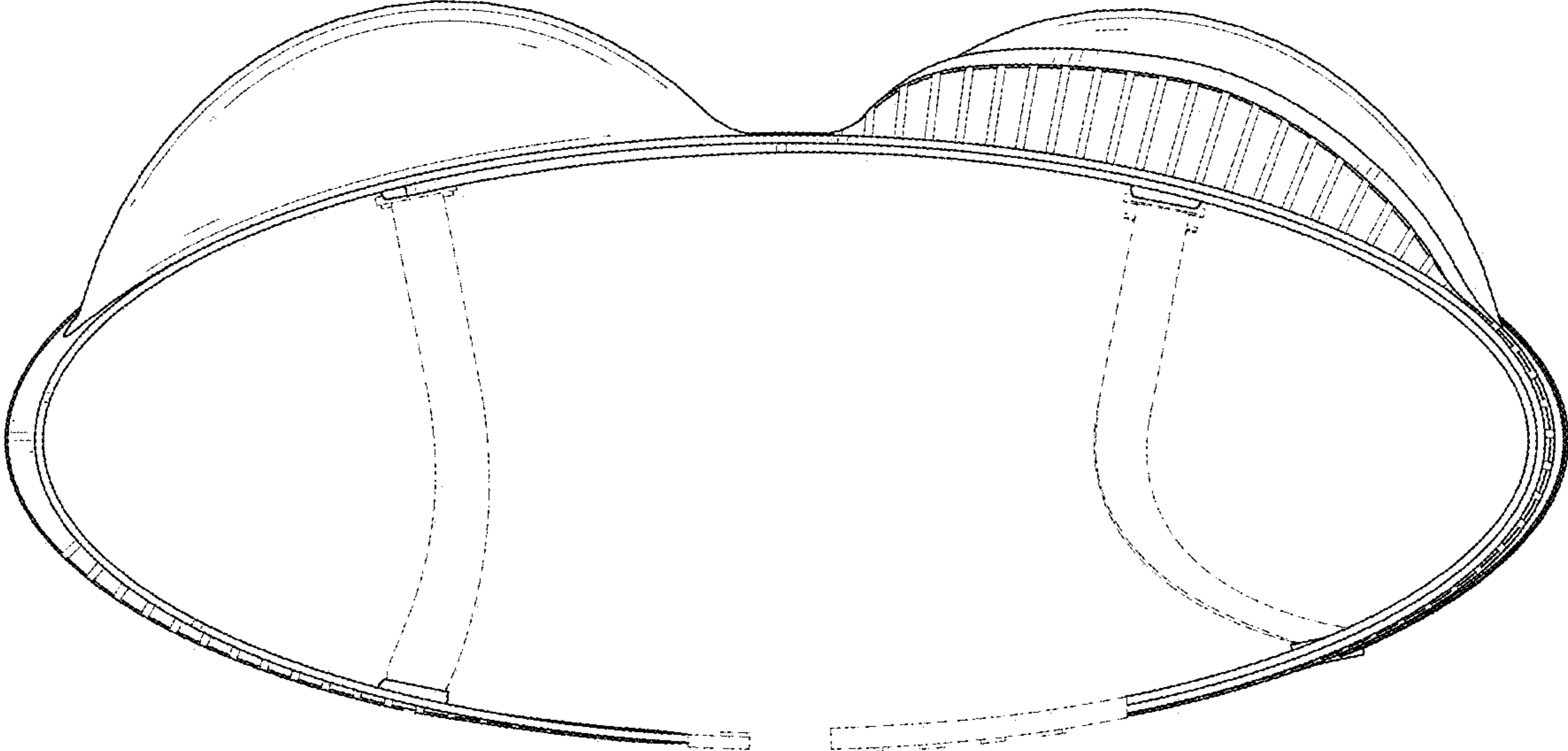

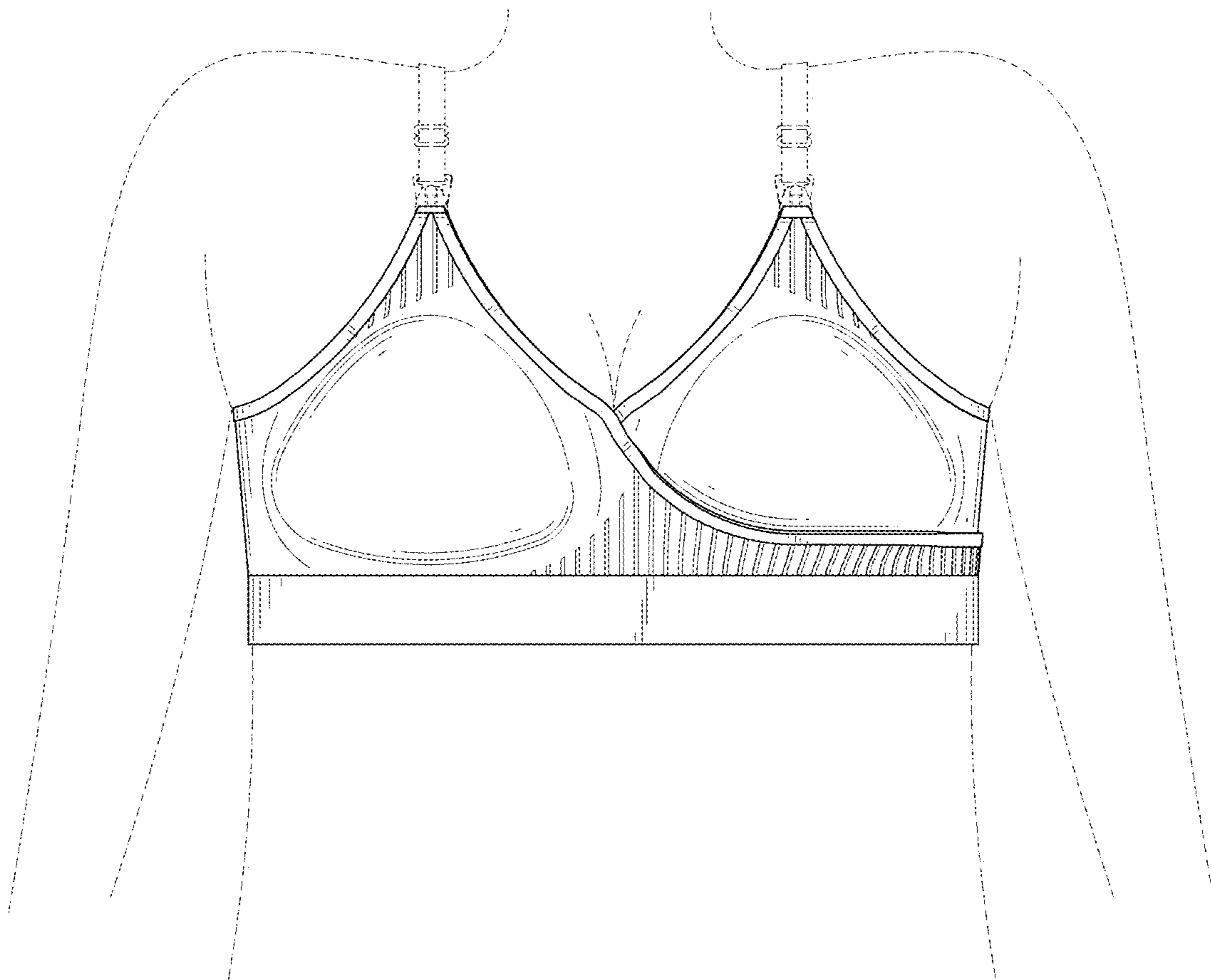

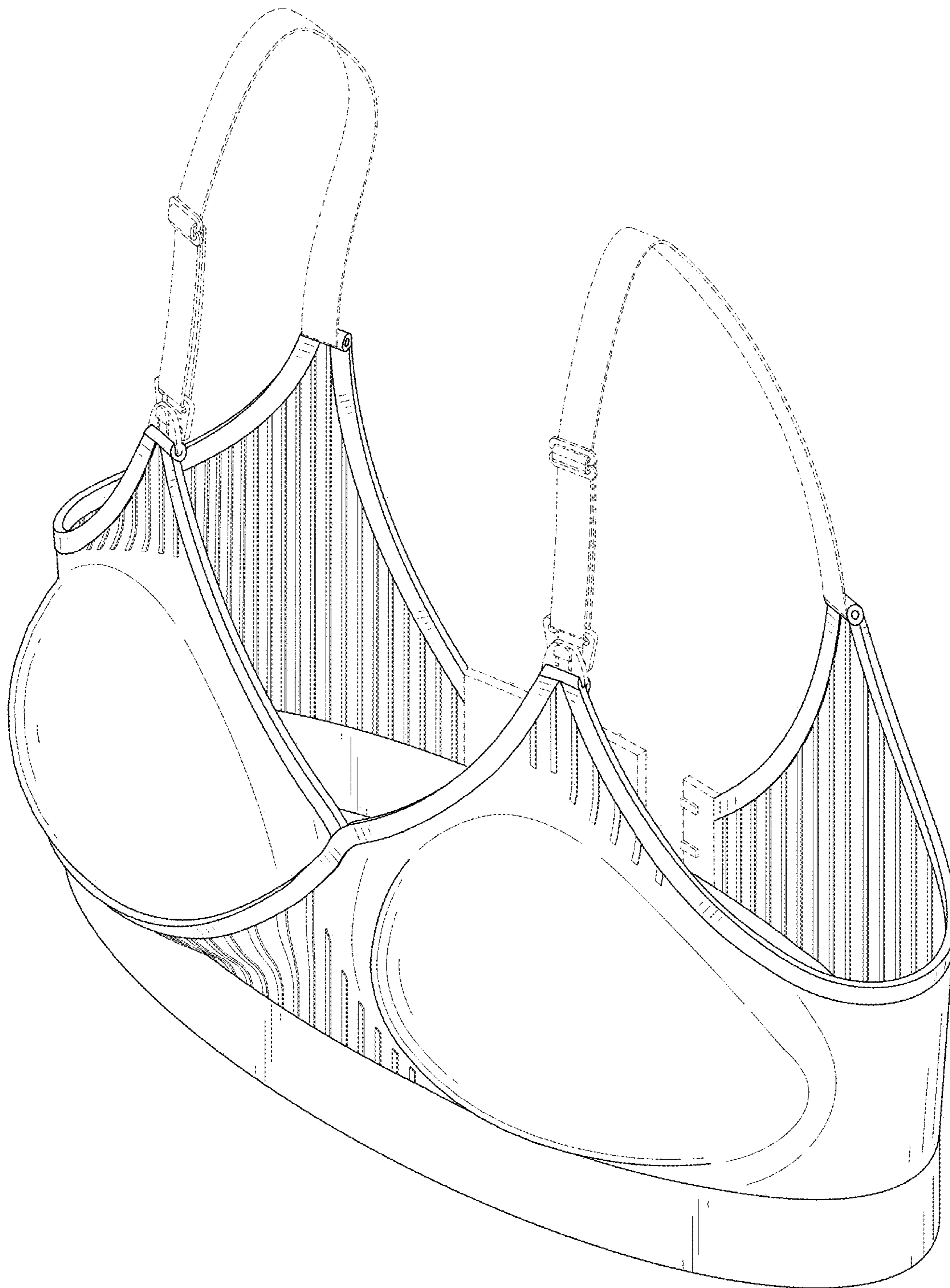

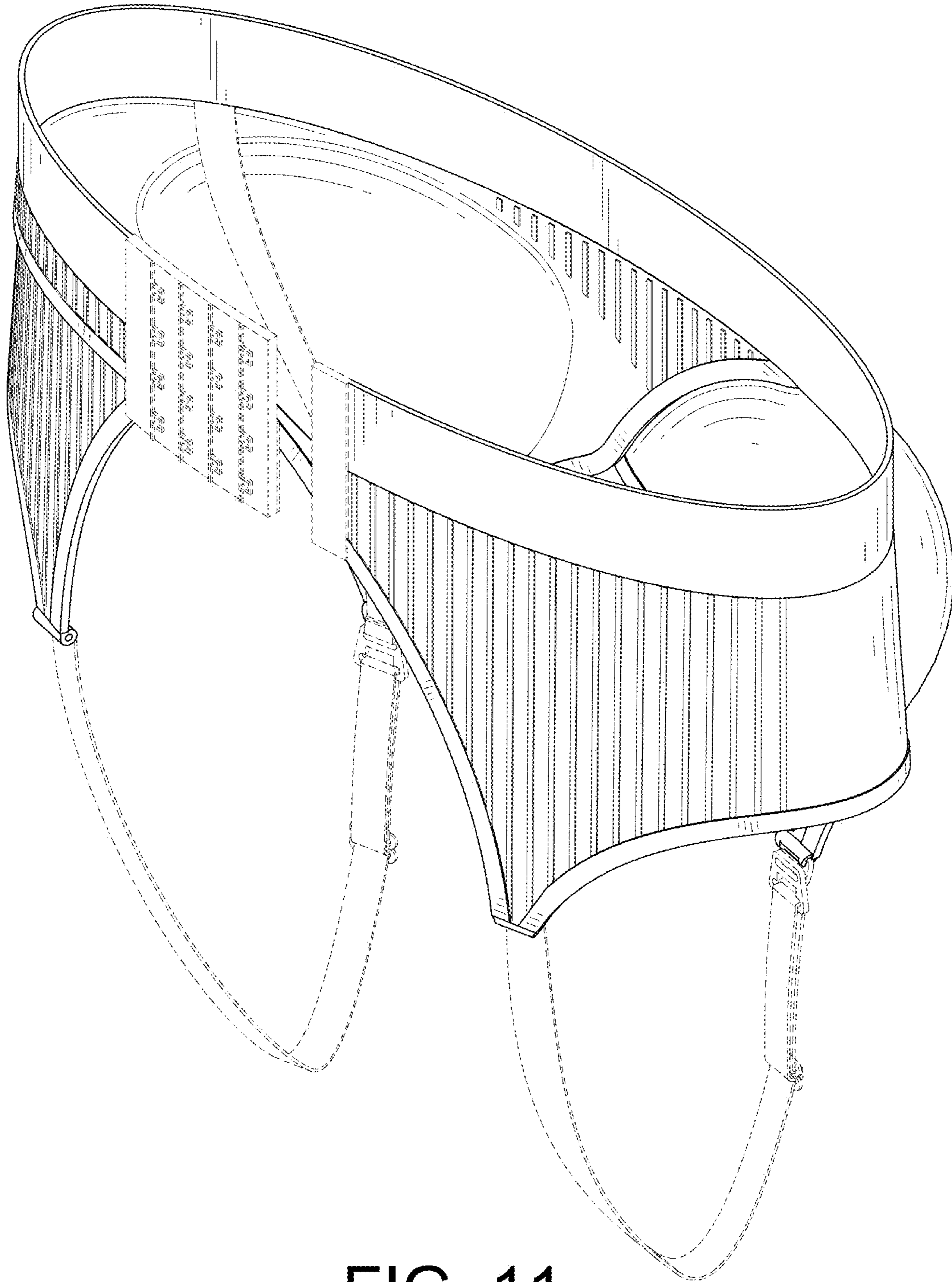

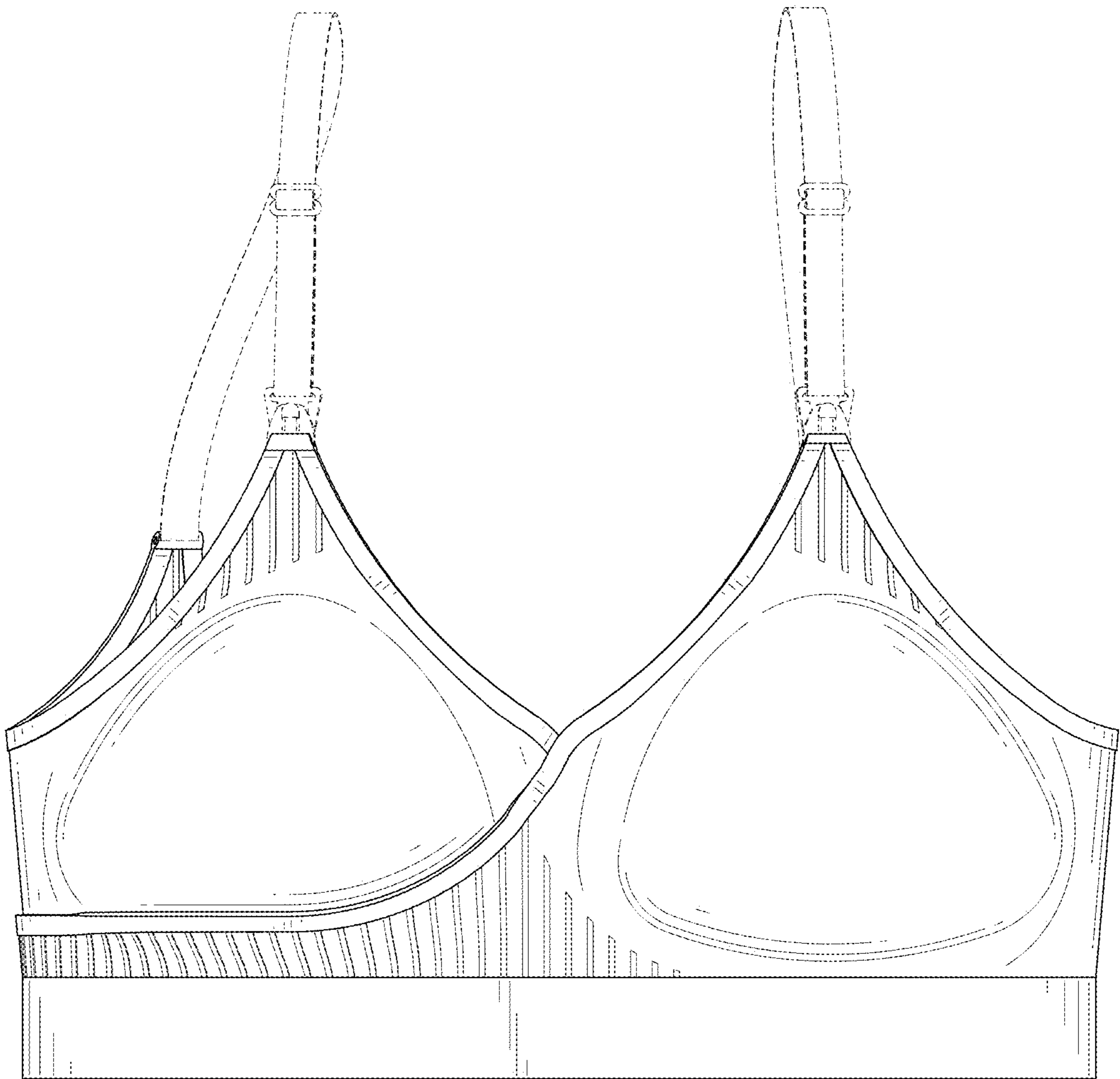

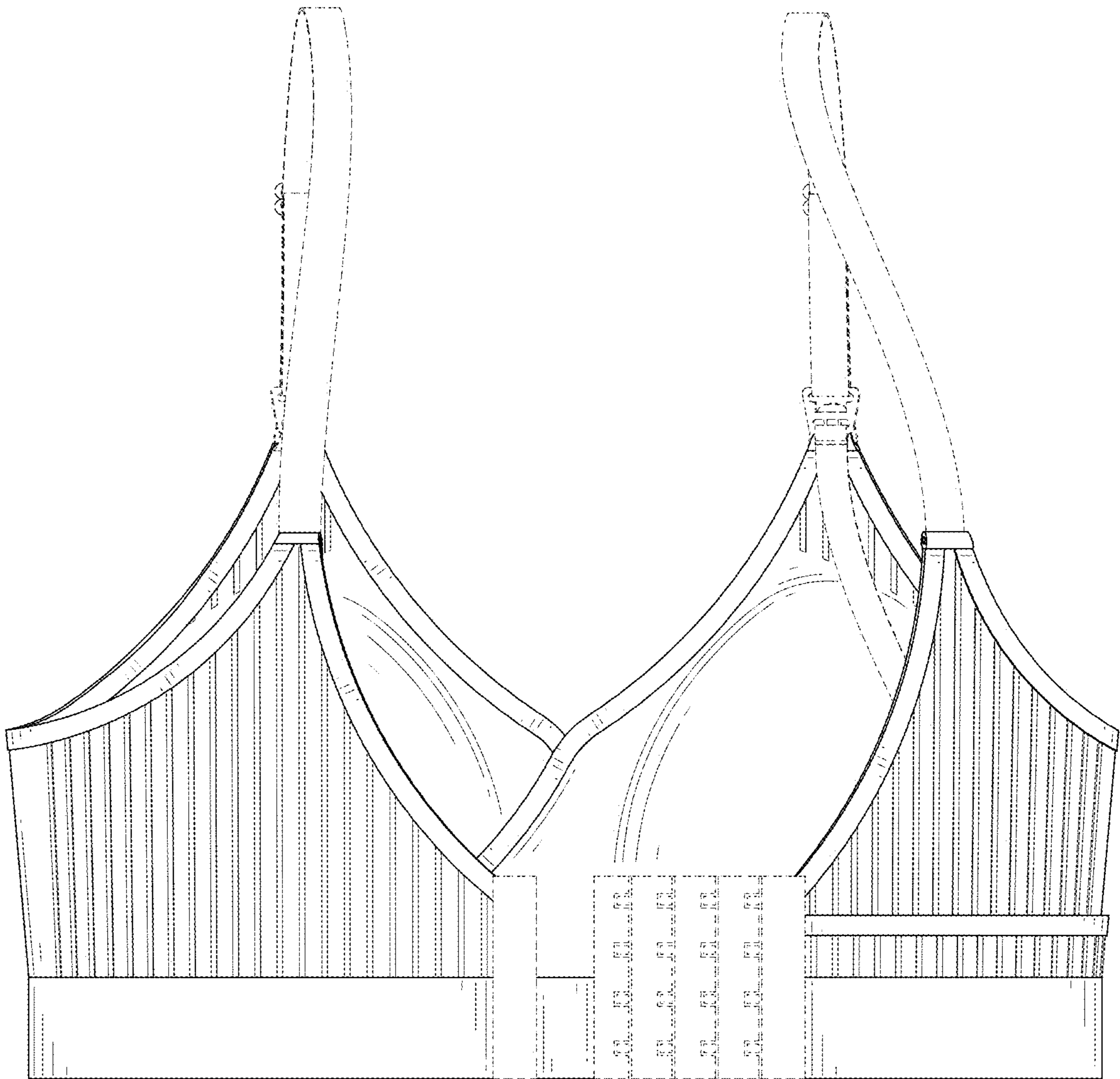

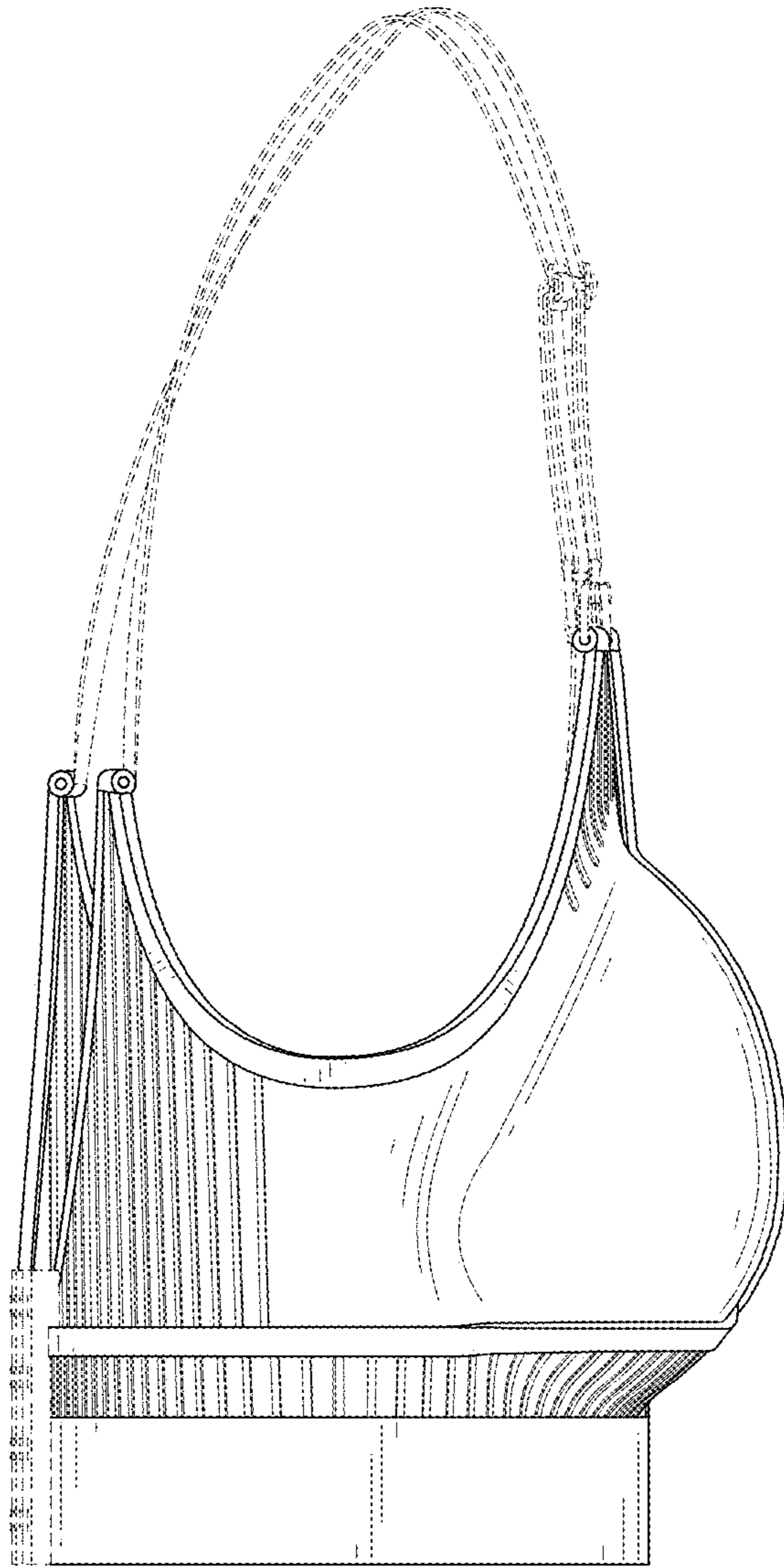

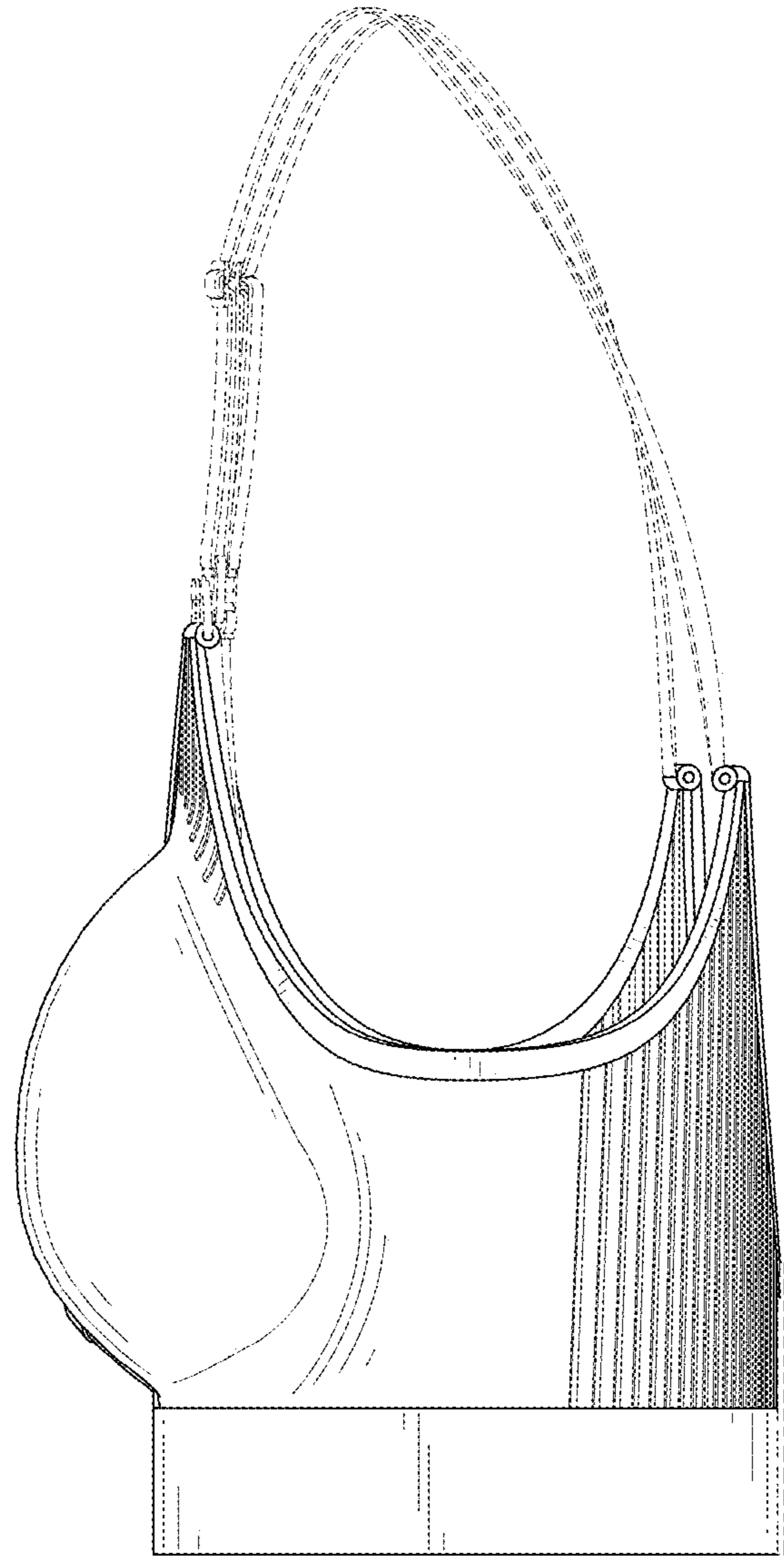

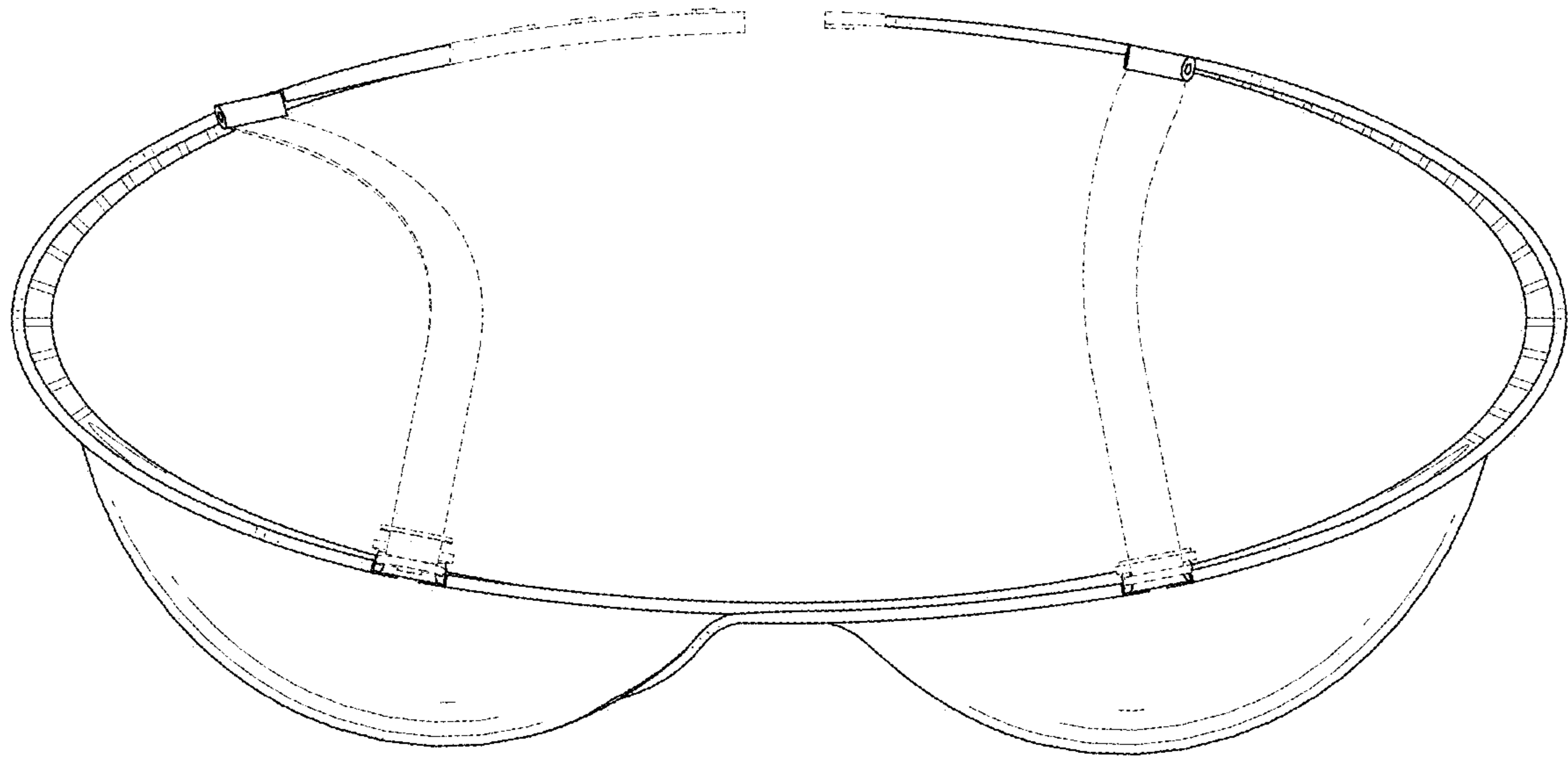

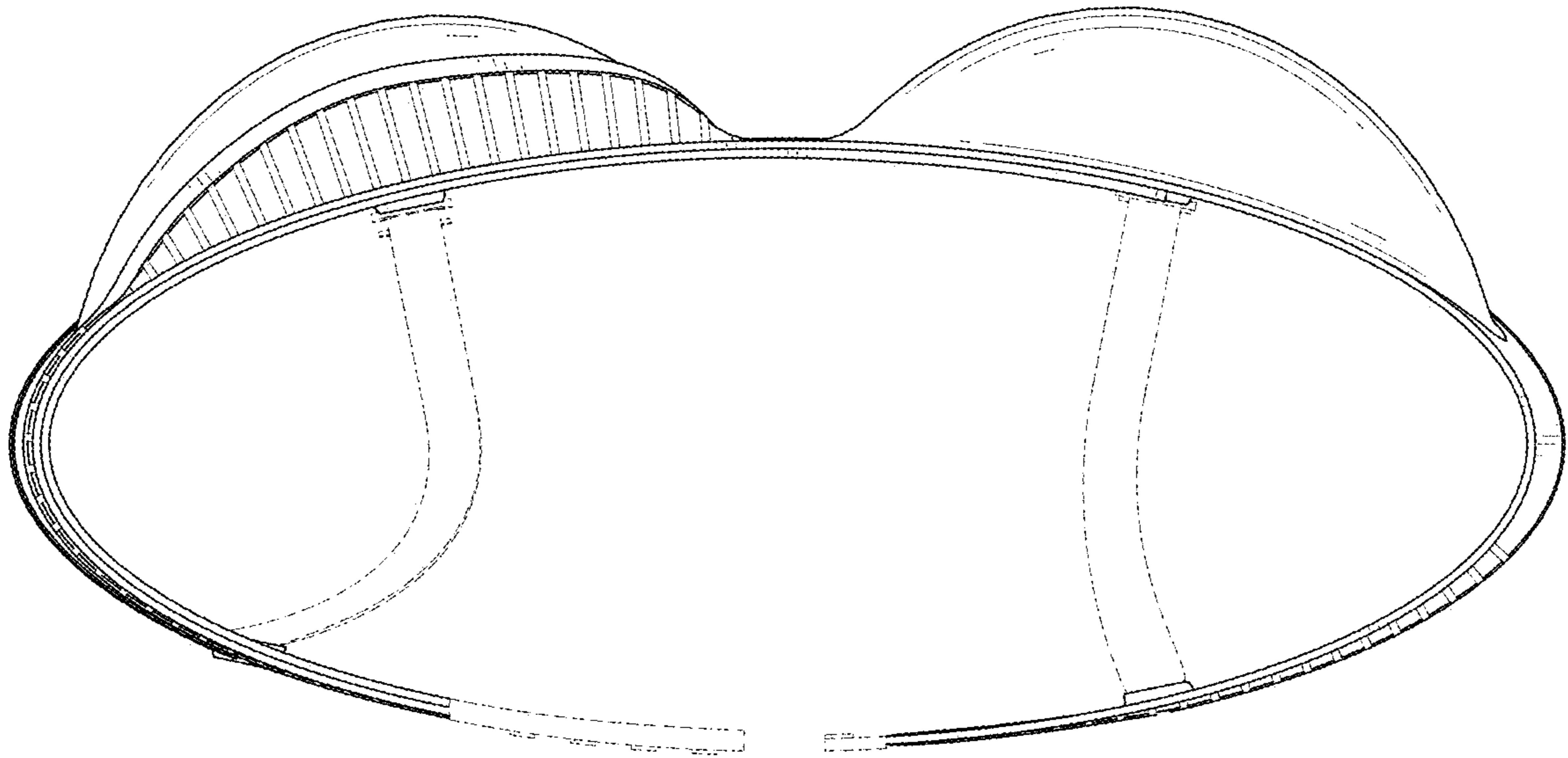

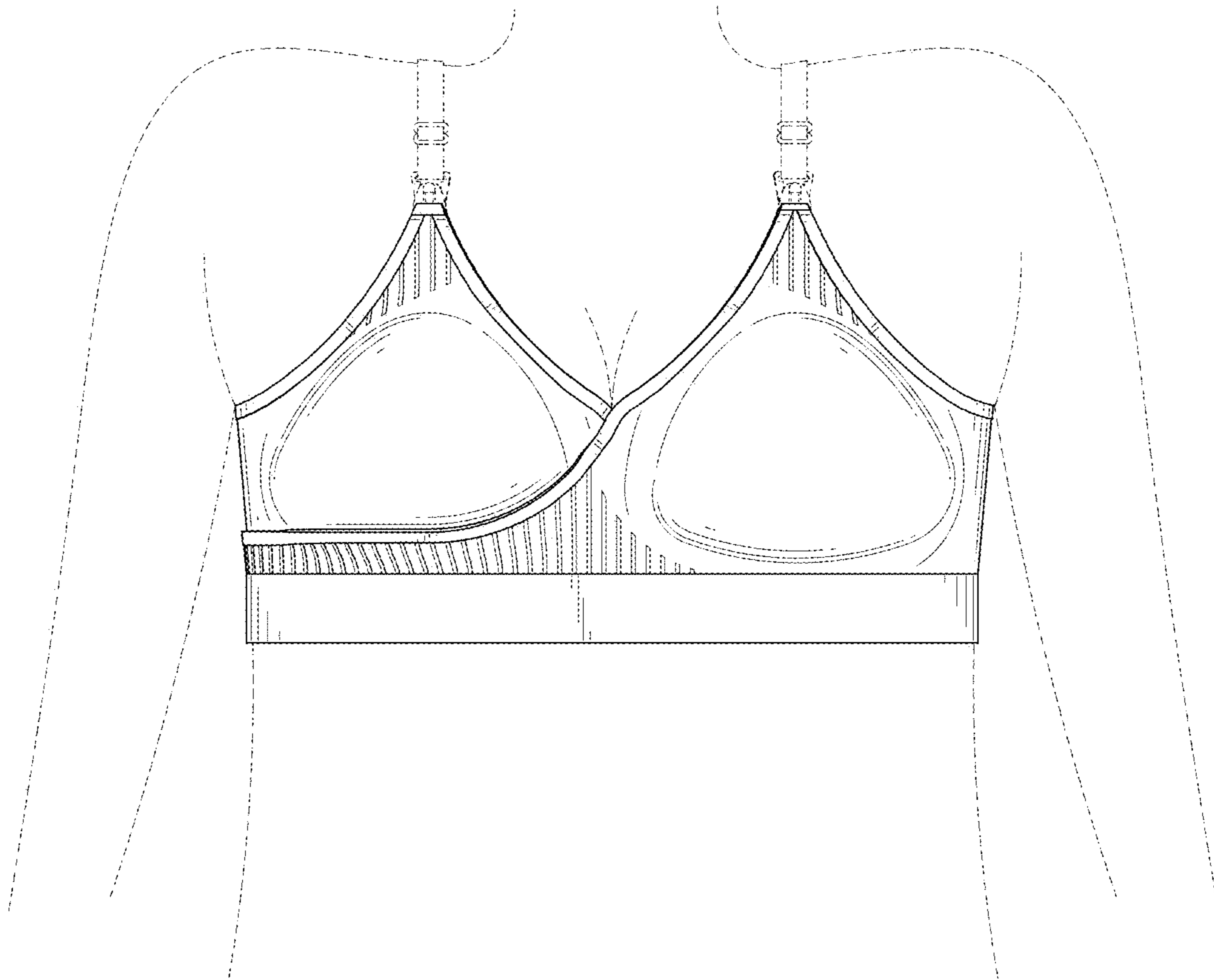
