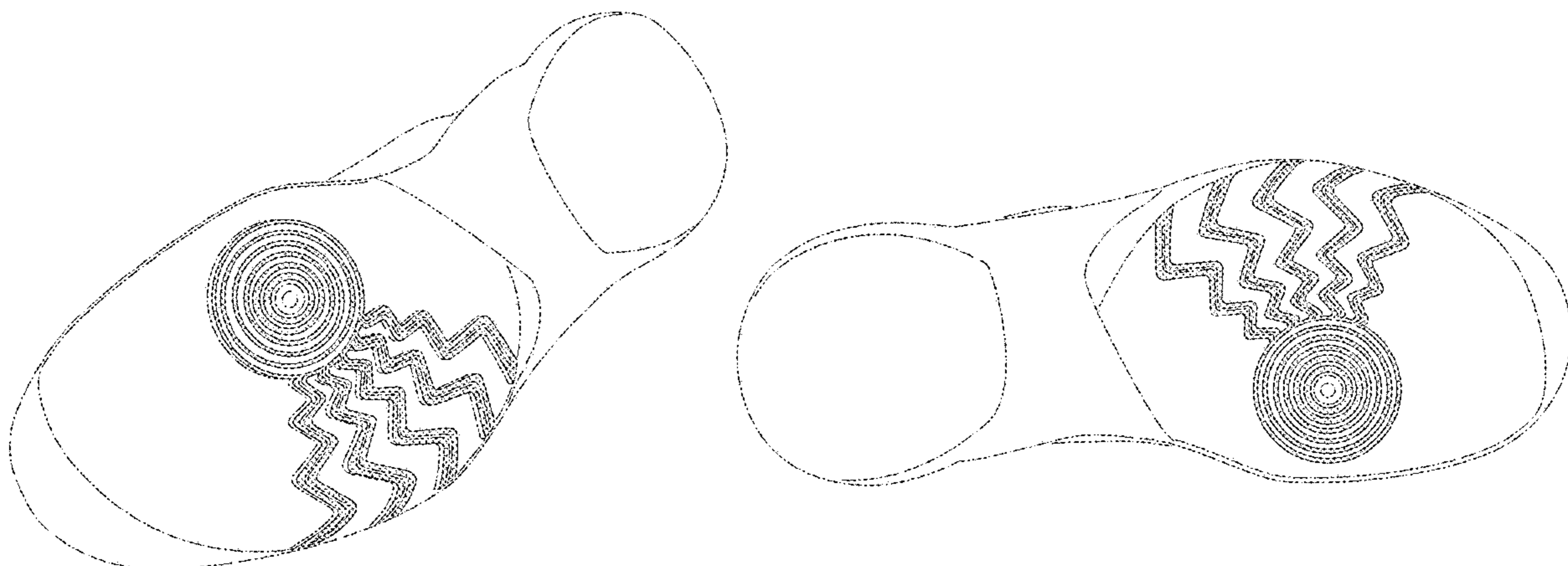
(57) **CLAIM**

The ornamental design for a shoe as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a rear perspective view thereof.
The two circular broken lines within the shaded area represent features that form no part of the claimed design. The unshaded regions between the circular rings form no part of the claimed design. The five pairs of wavy broken lines and the unshaded areas there between form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

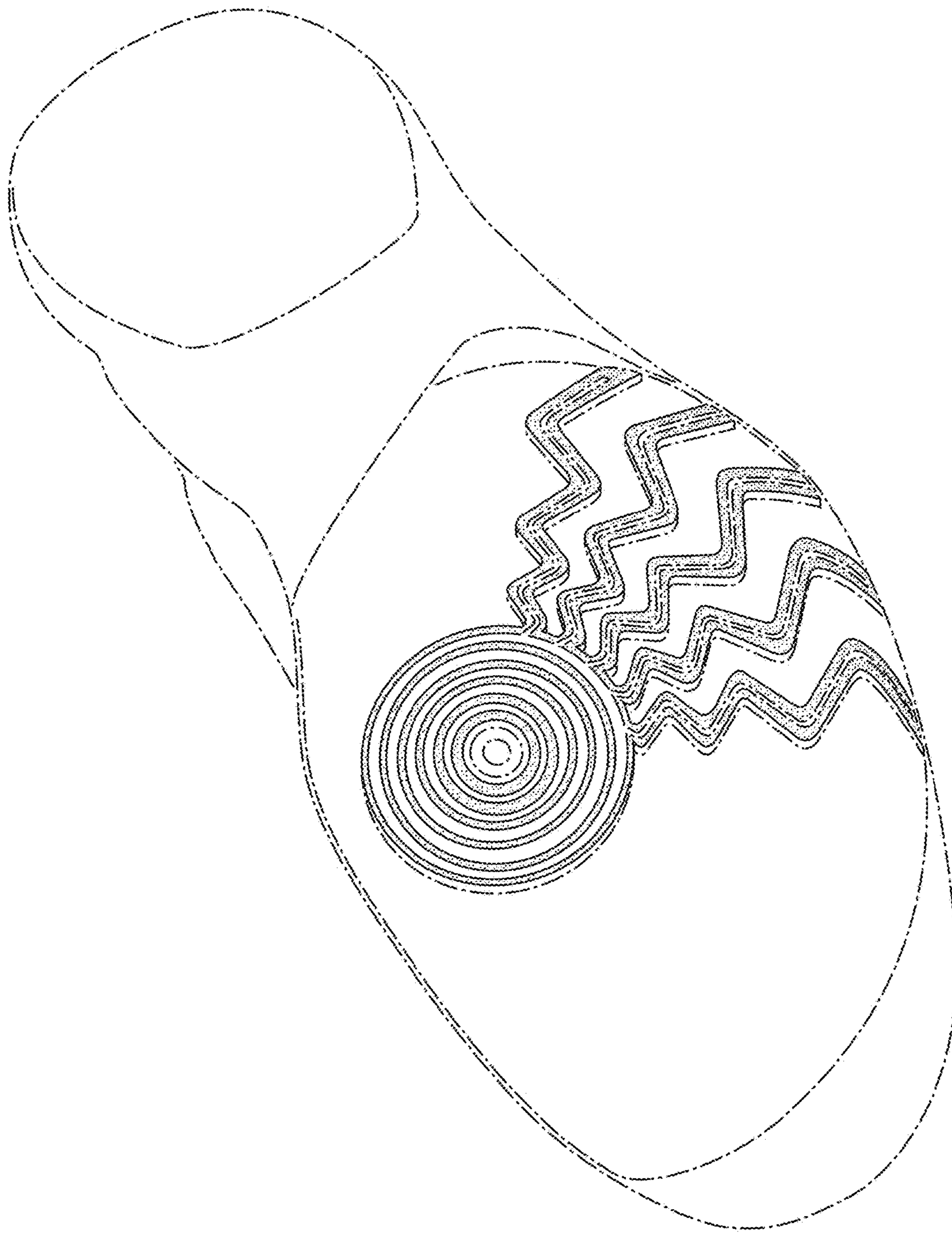

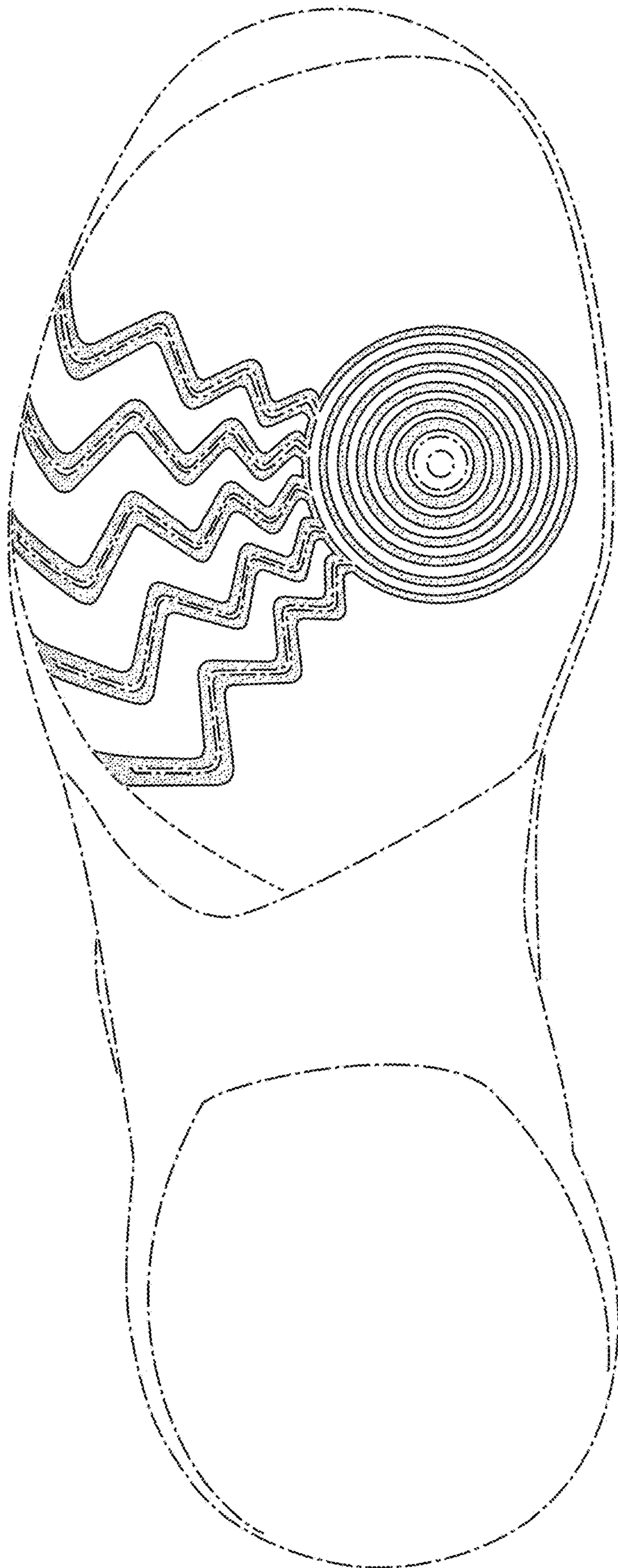

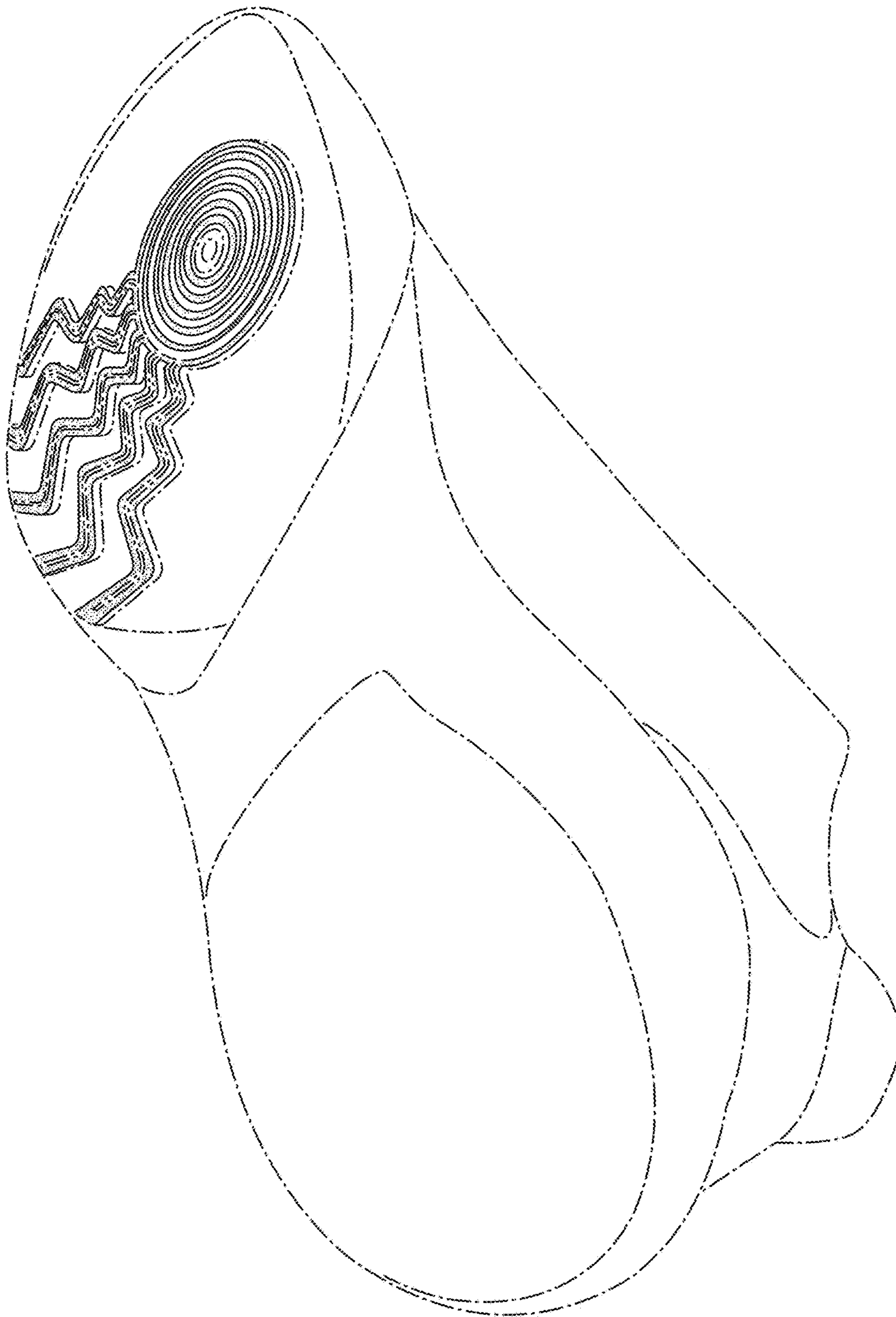
