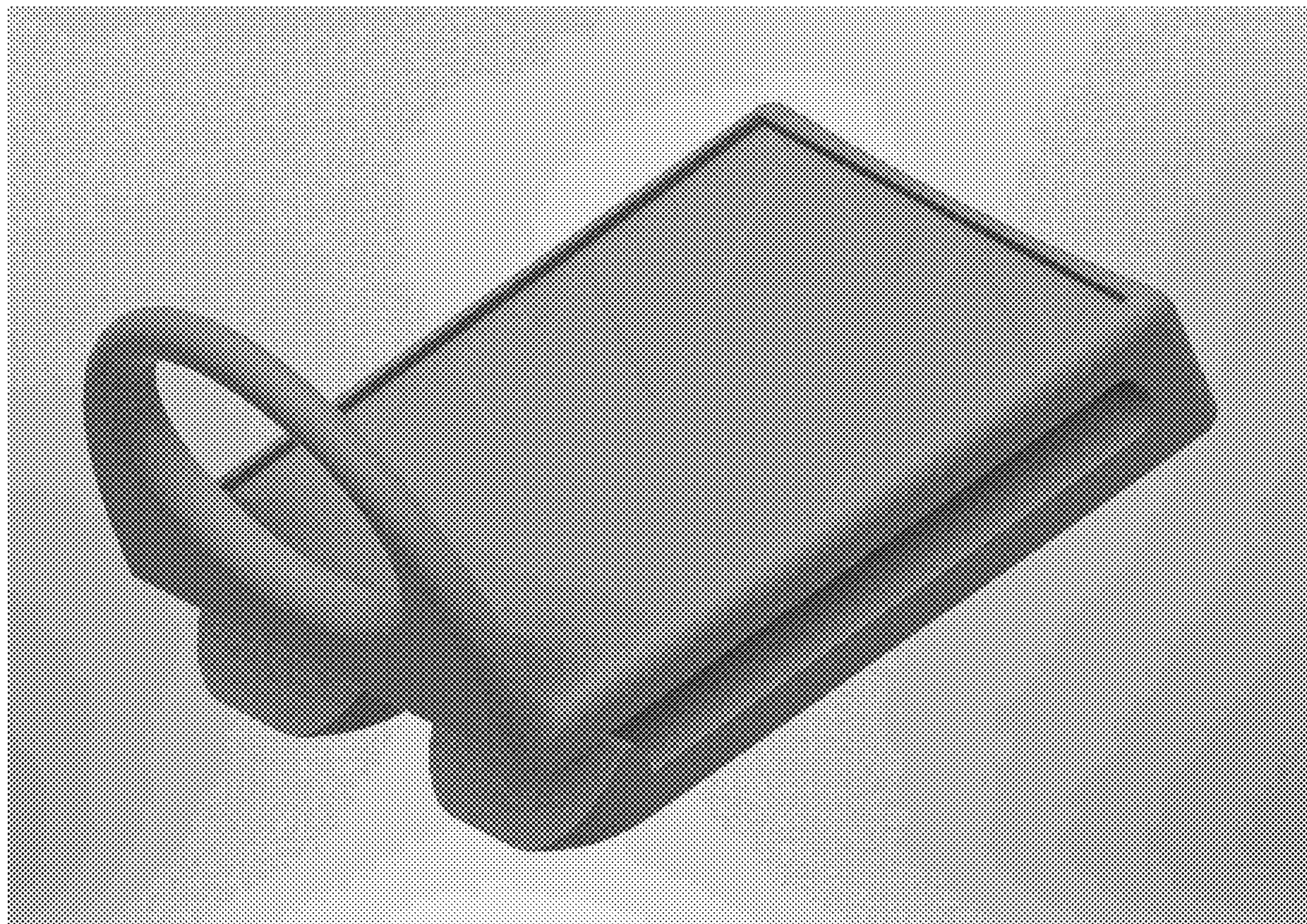
(57) **CLAIM**

The ornamental design for a clip-on personal effects holder, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a clip-on personal effects holder showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front elevational view including an insert thereof. The broken lines shown in FIG. 8 depict an insert and form no part of the claimed design.

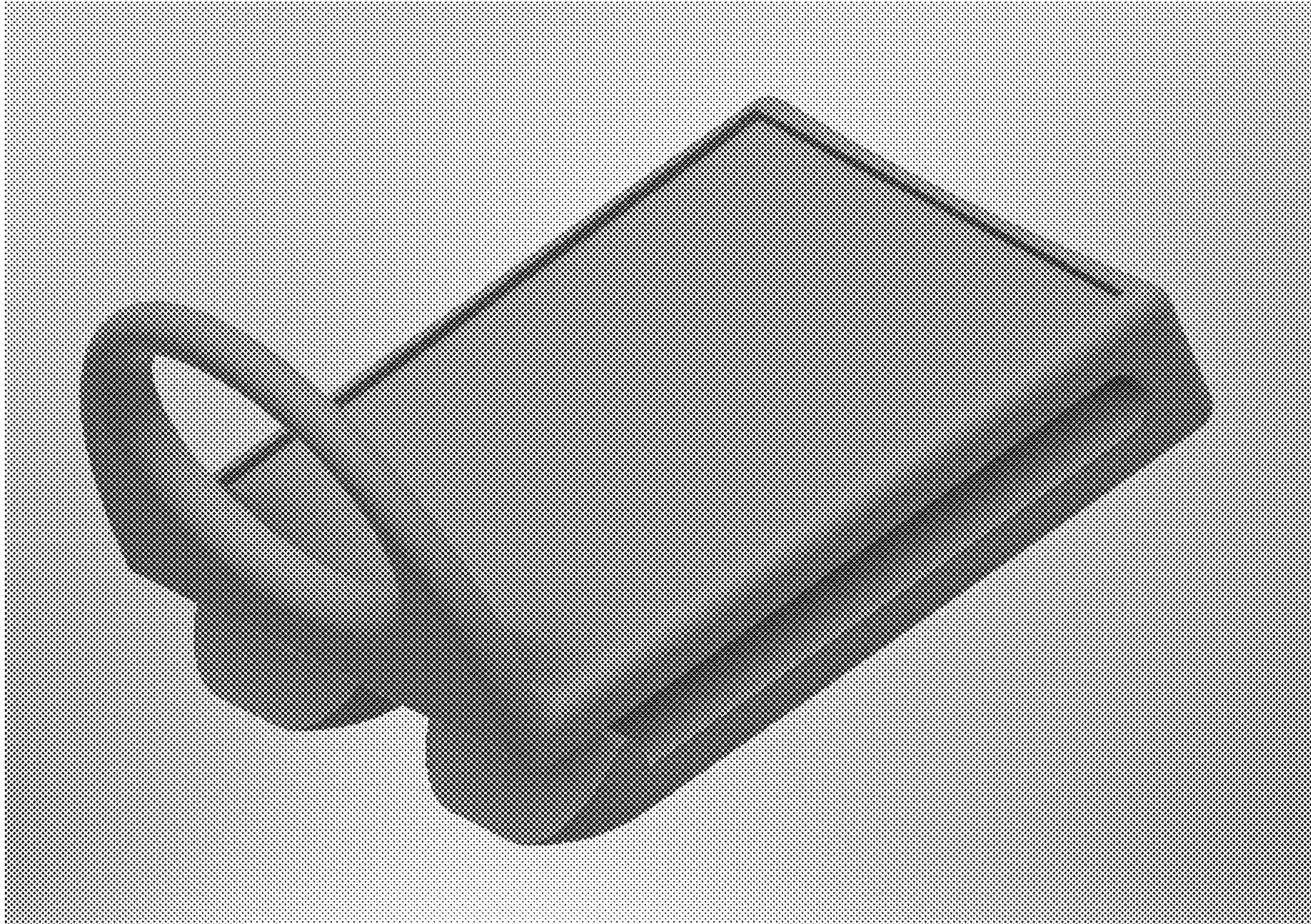

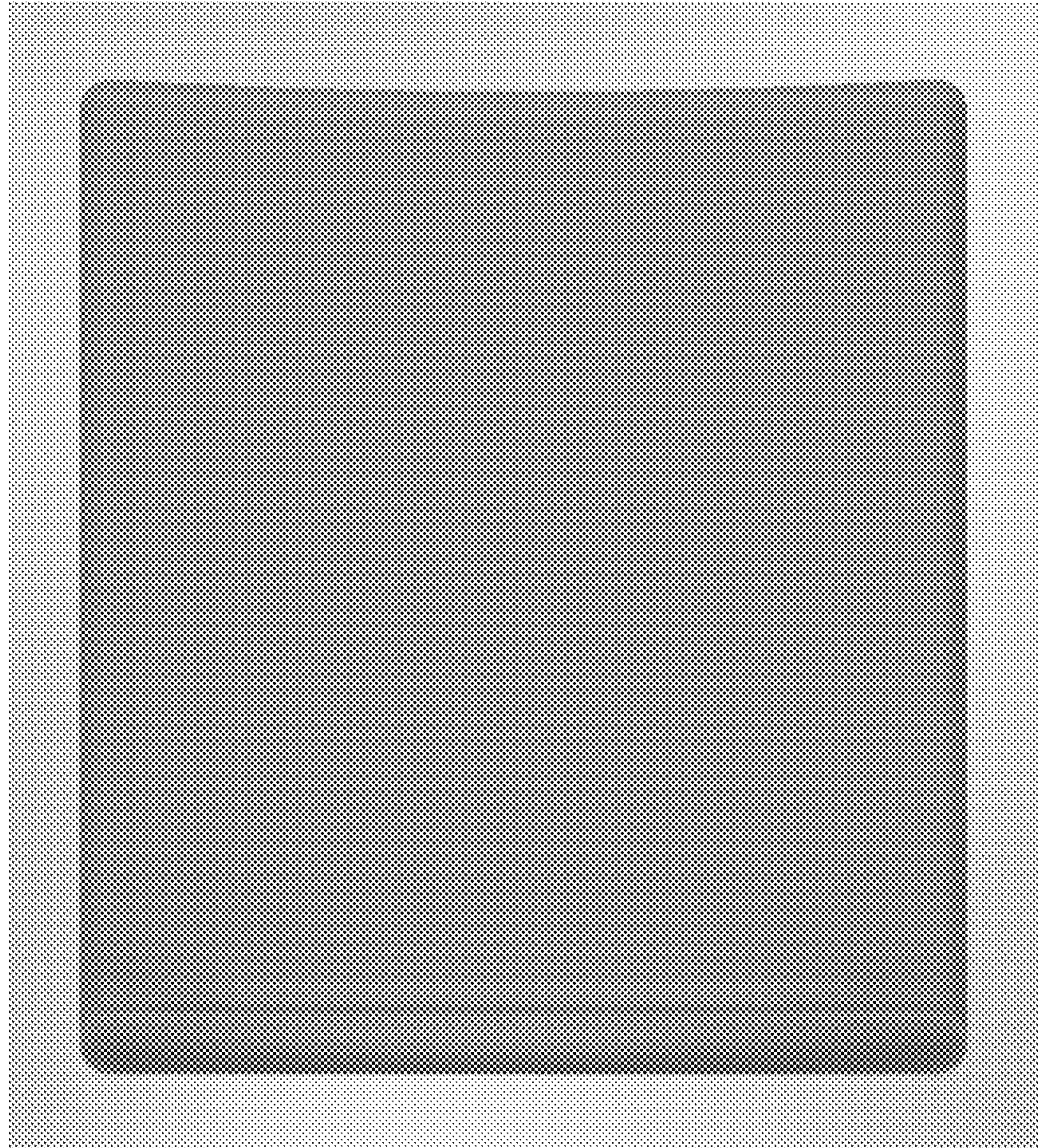

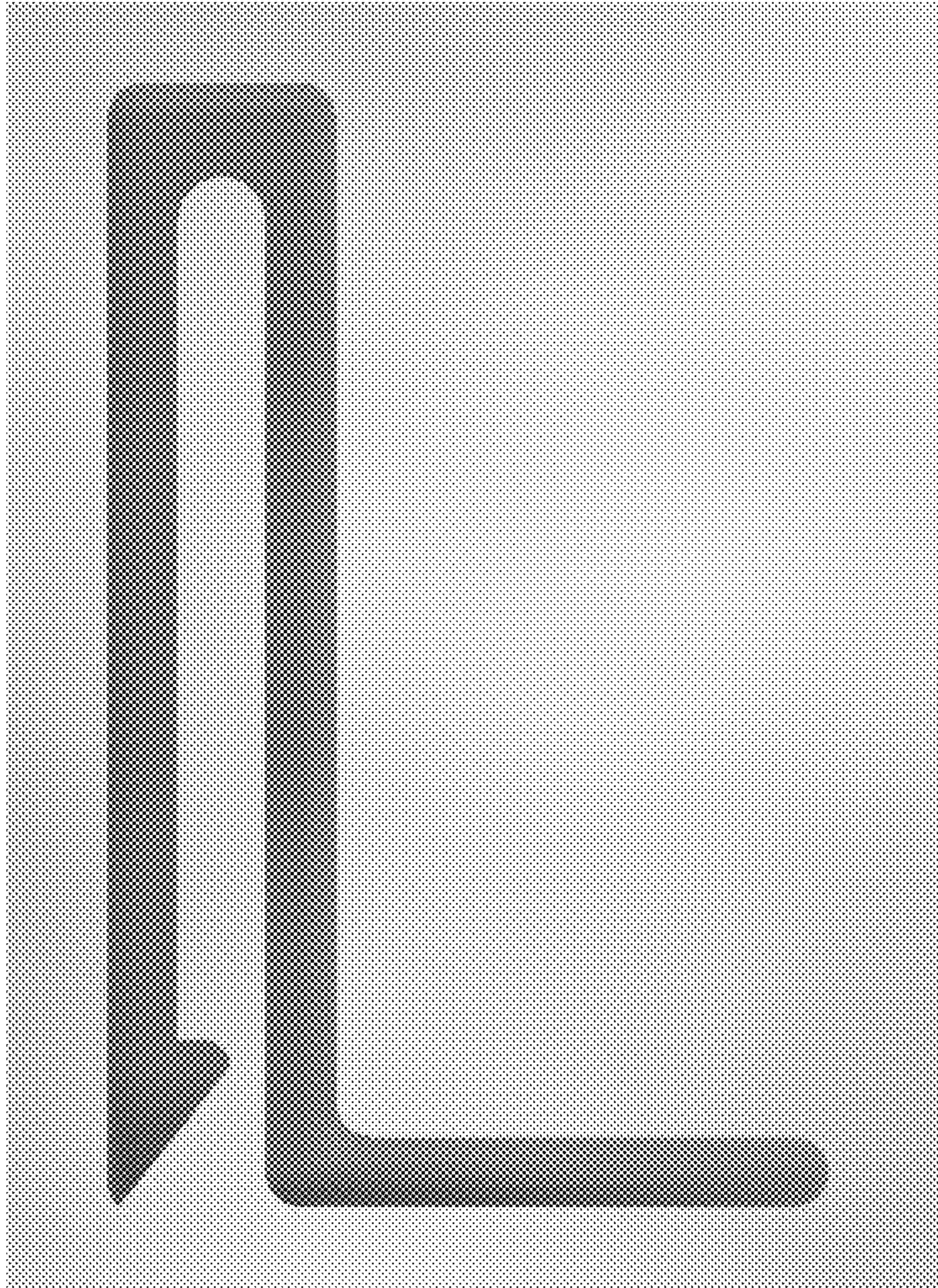

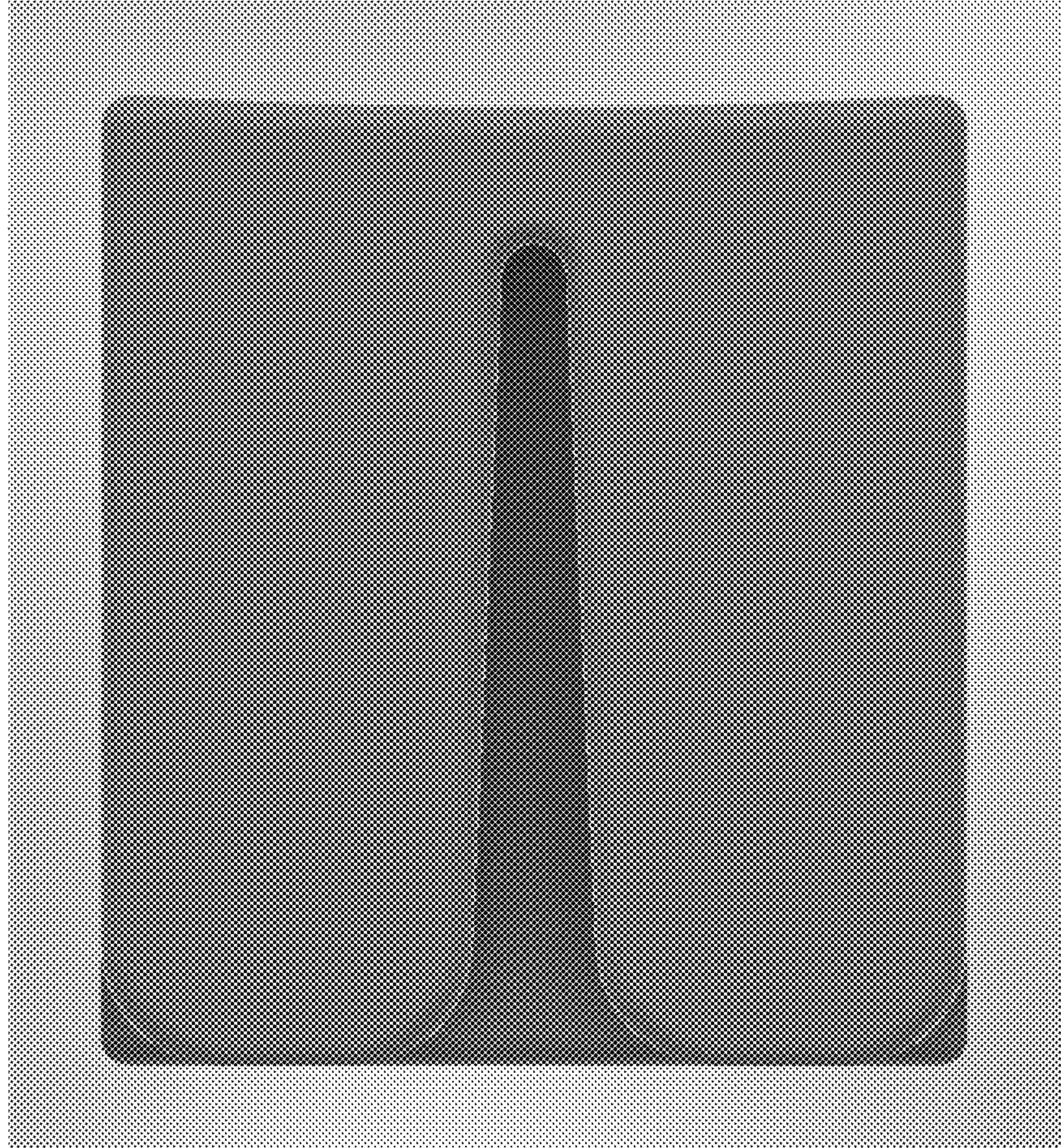

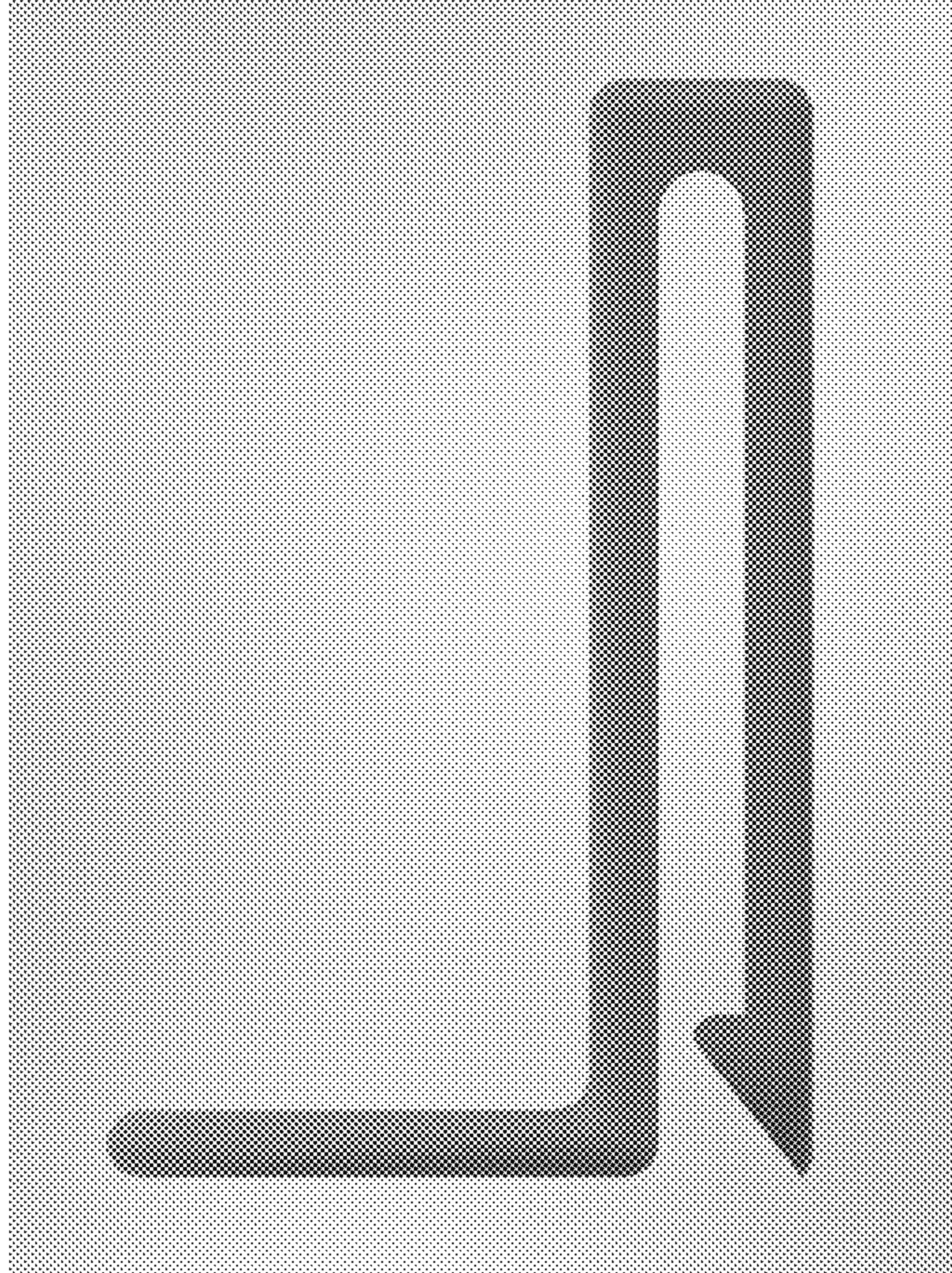

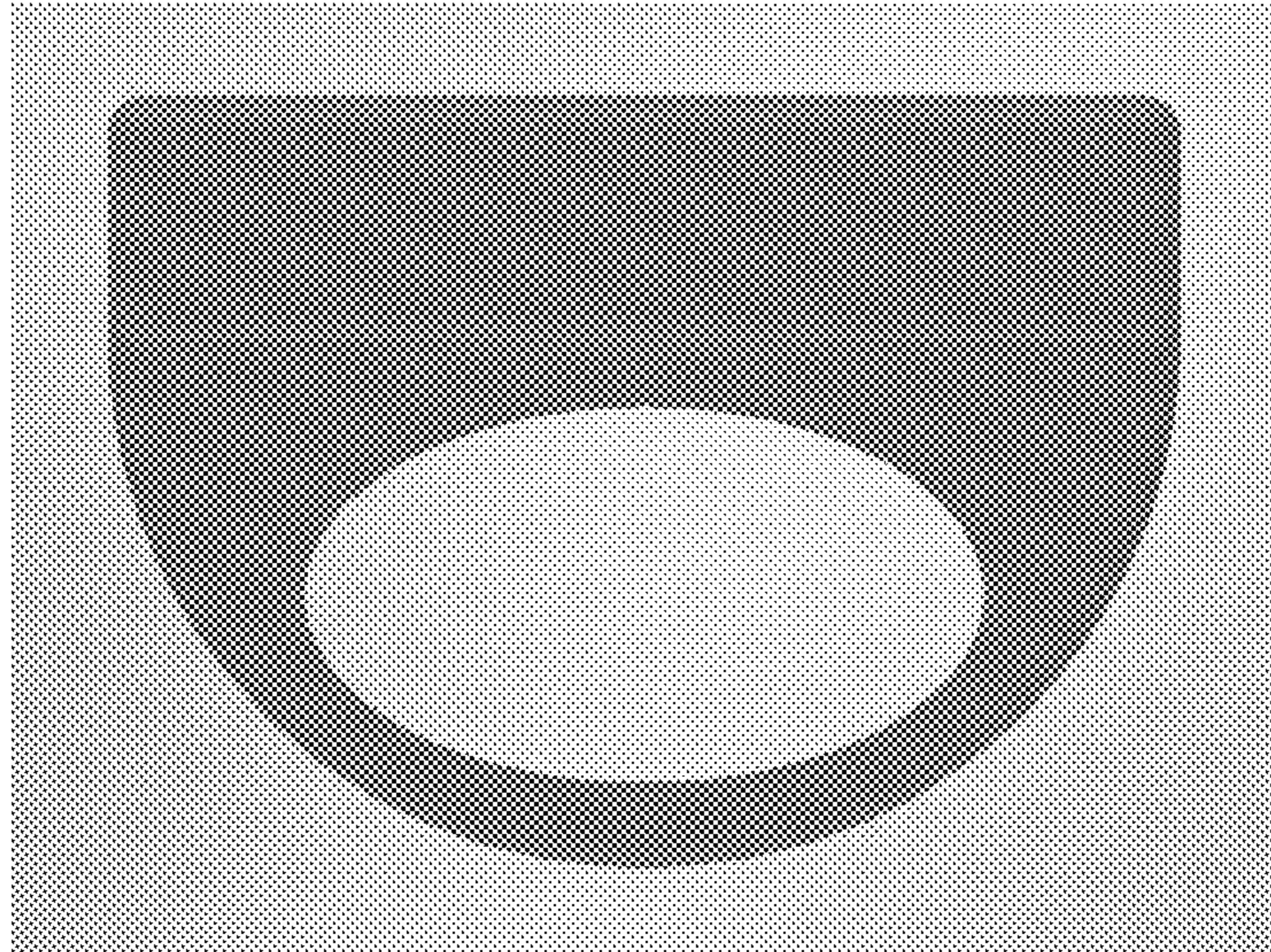

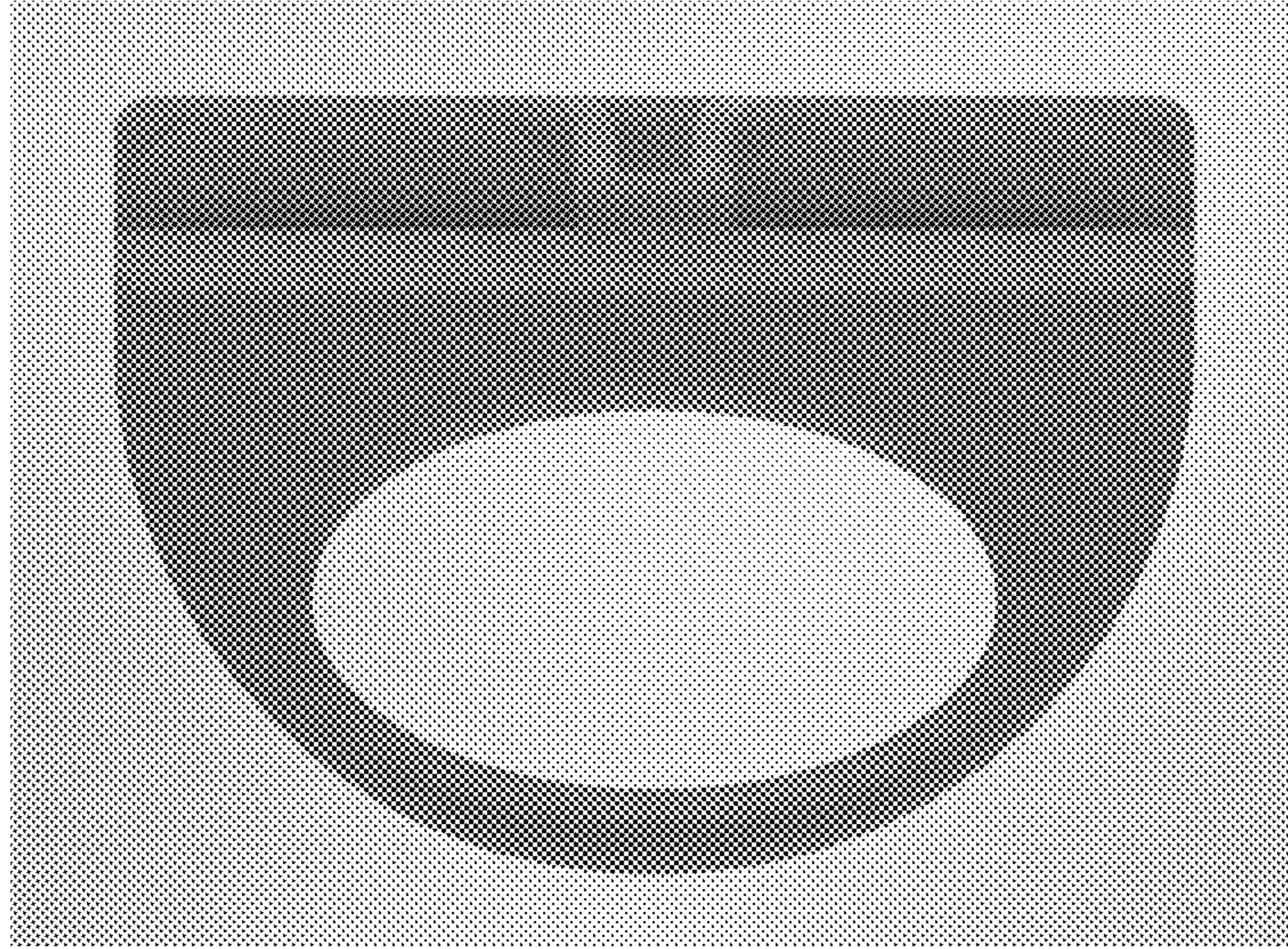

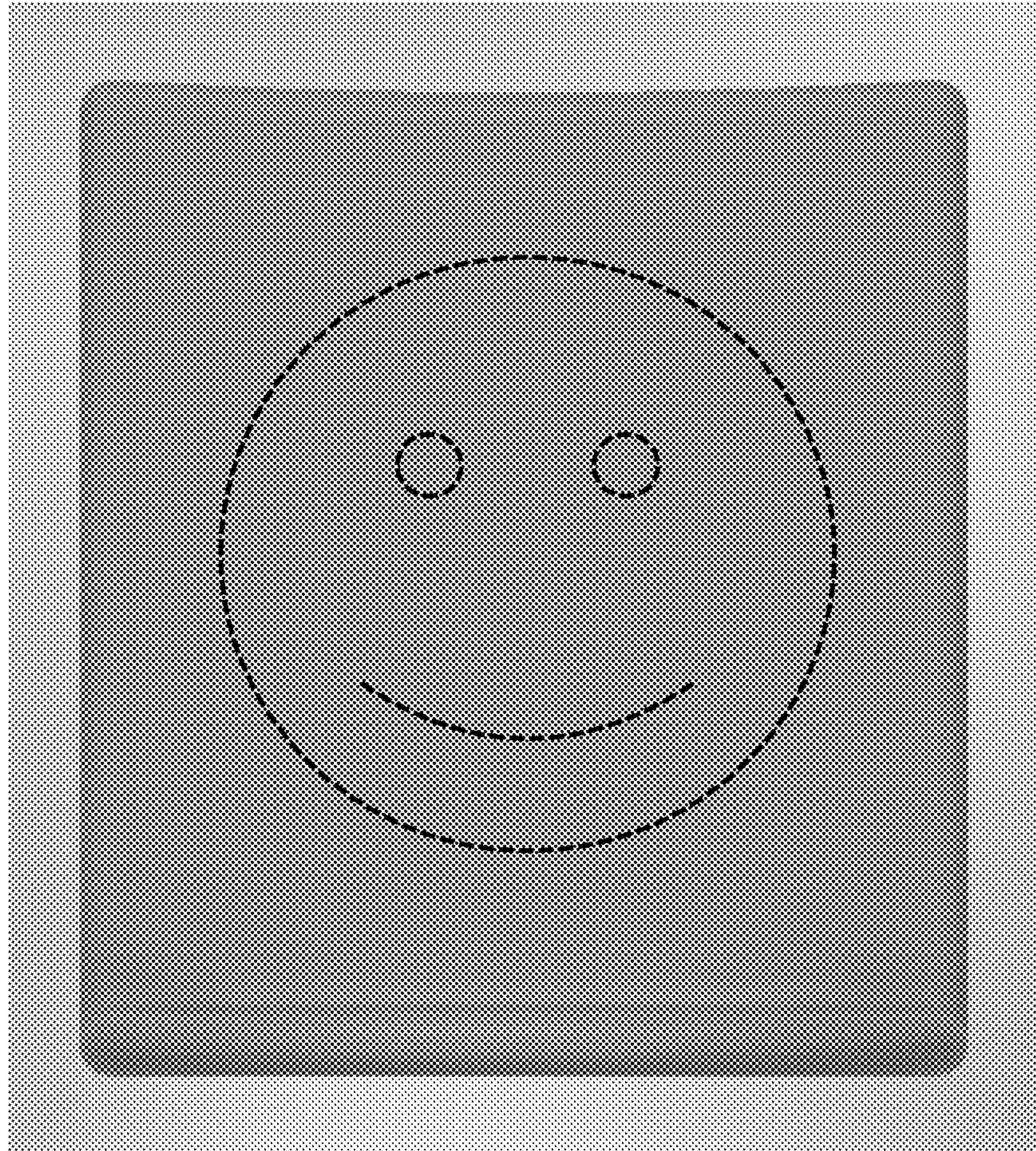
