The ornamental design for a handbag, as shown and described.

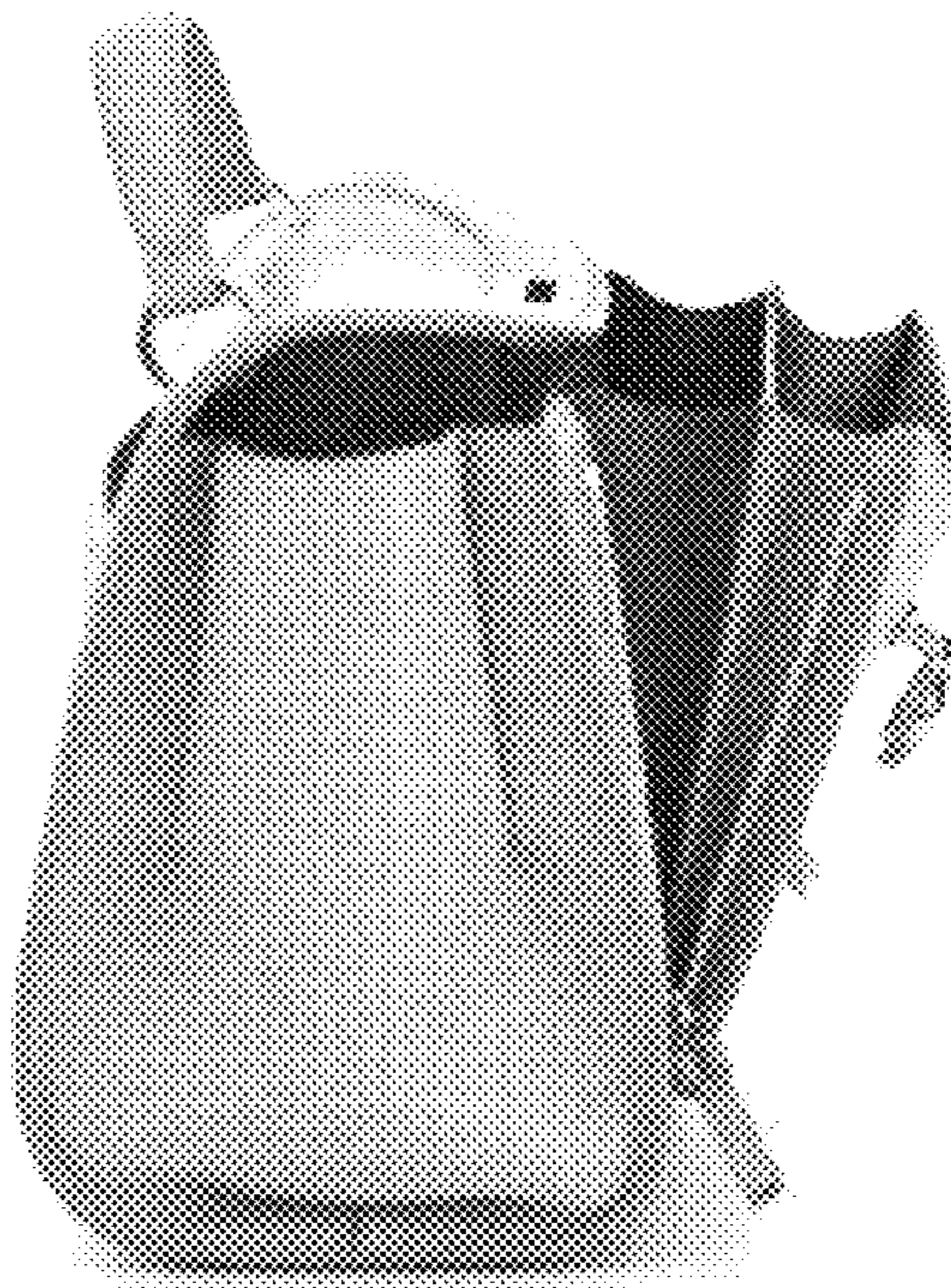
DESCRIPTION

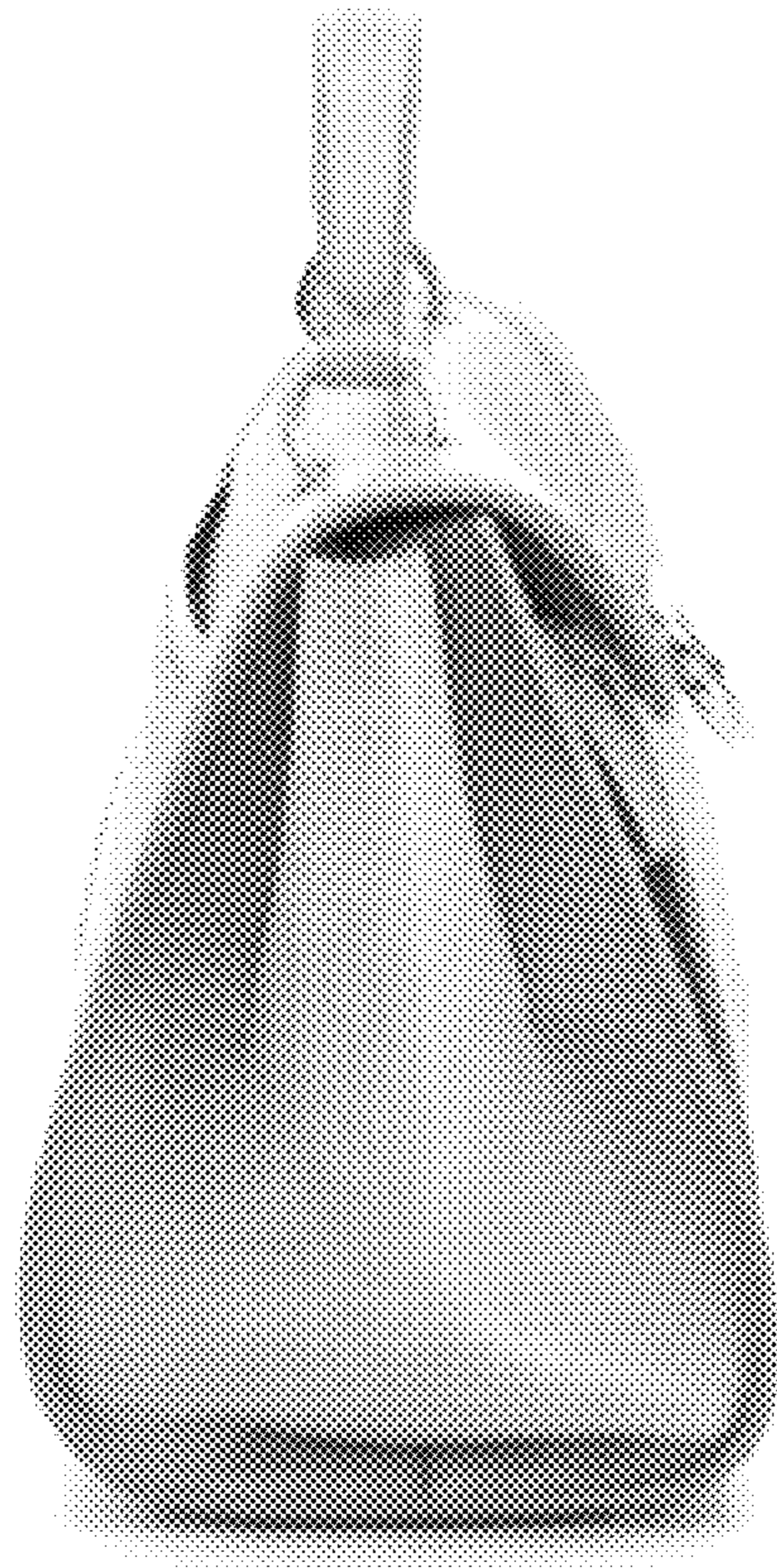

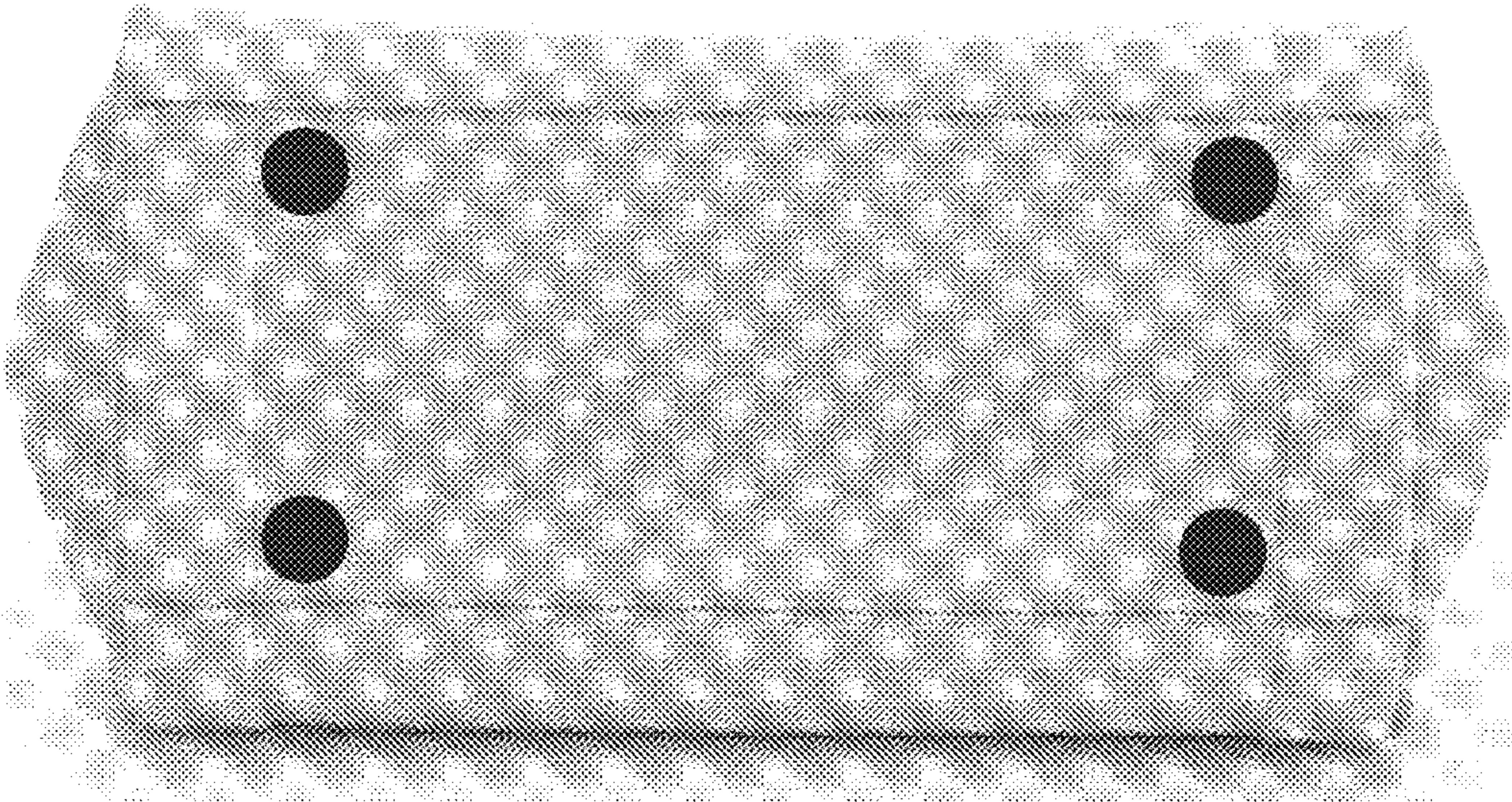
