FIG. 7 is a bottom view thereof.

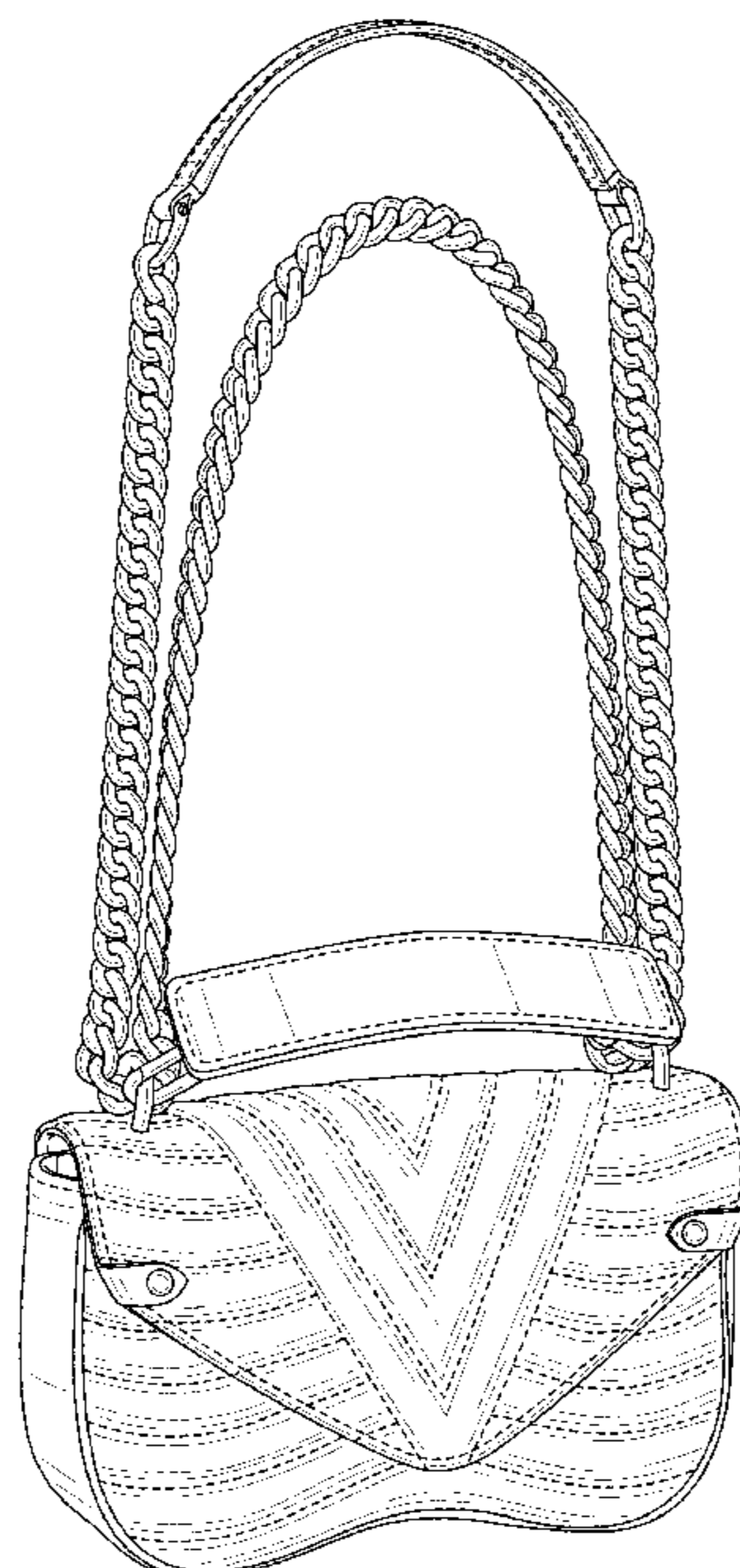
The broken lines under the top flap portion of the bag form no part of the claim. Otherwise, the dashed lines in the drawings illustrate stitching and are part of the claimed design.

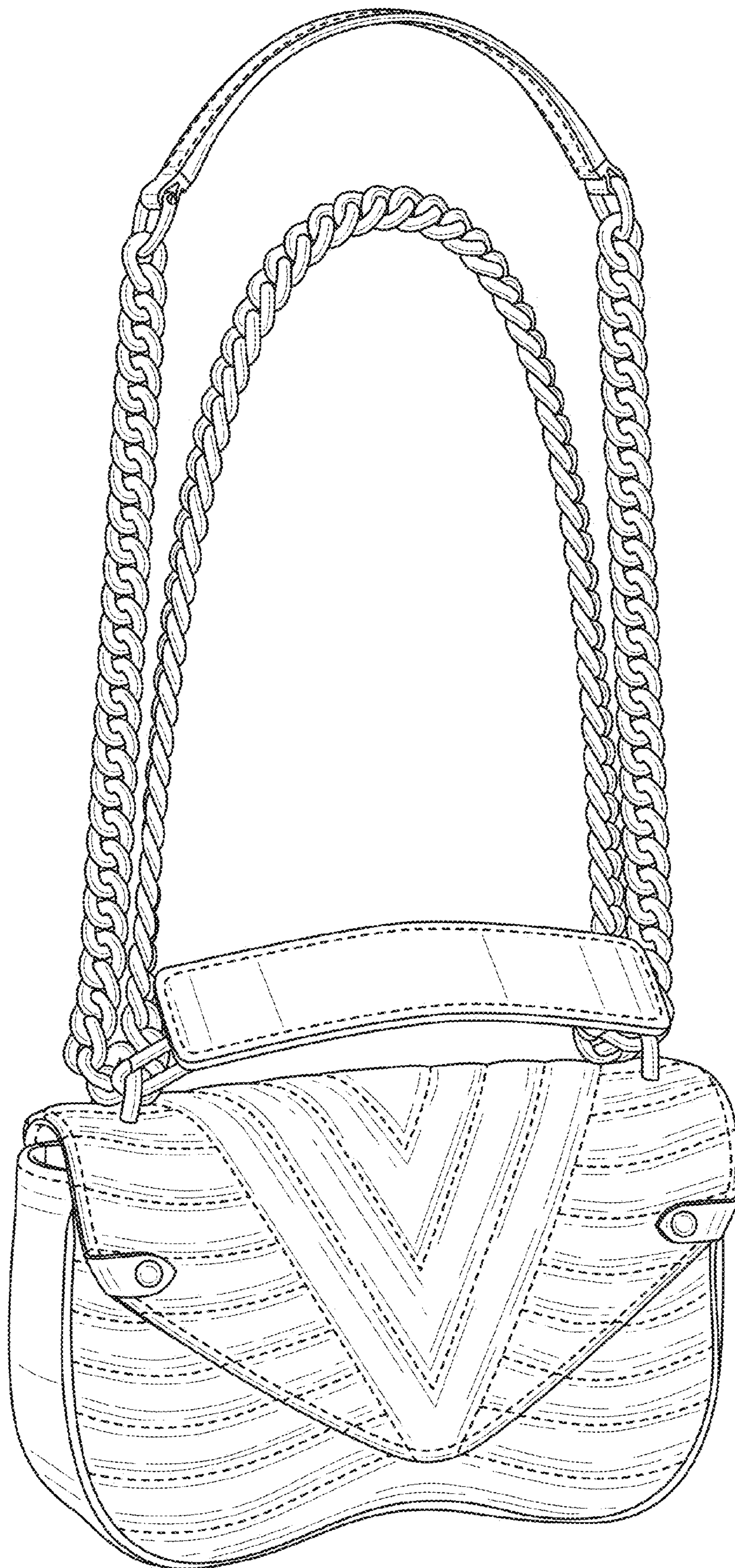

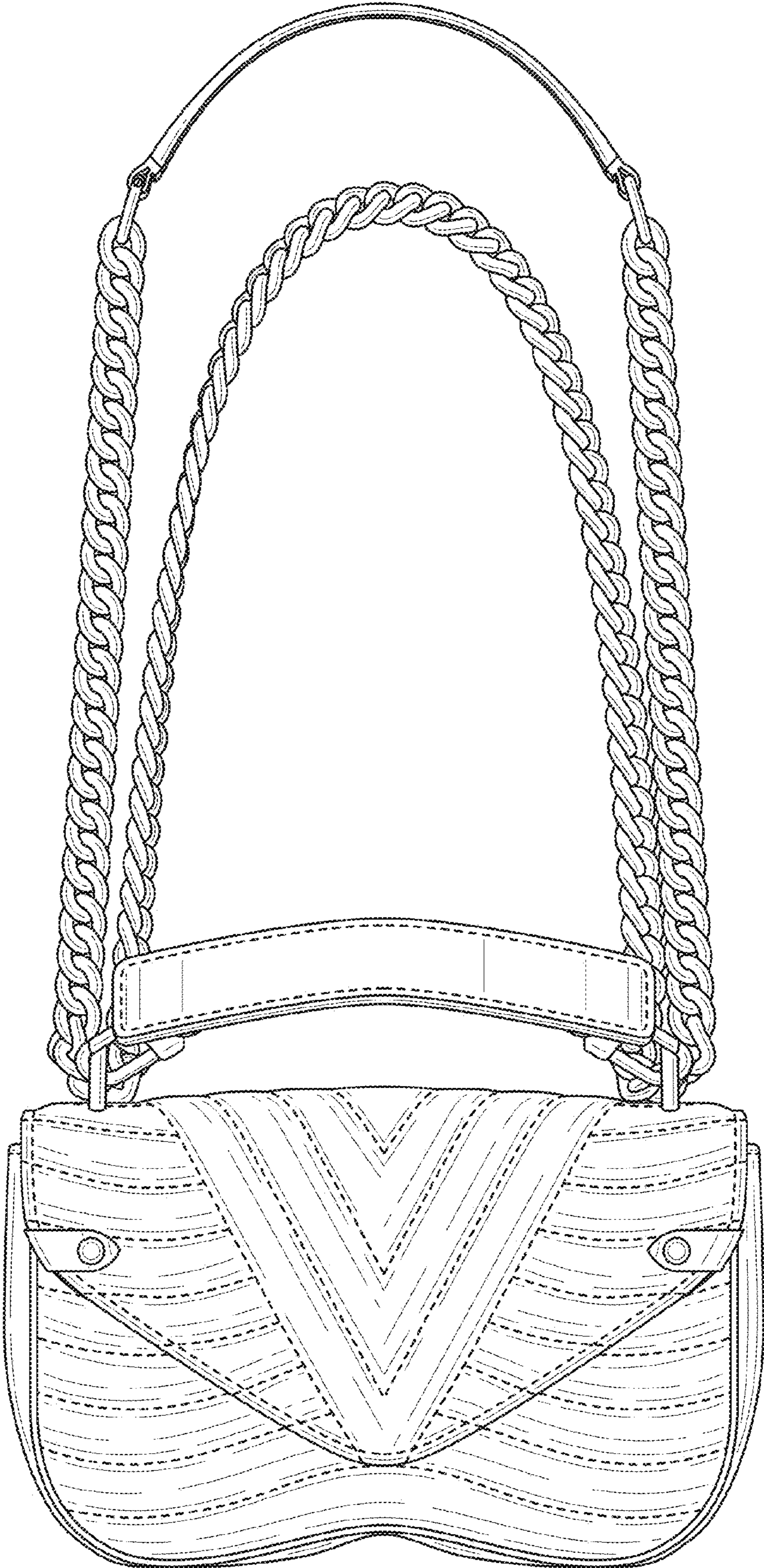

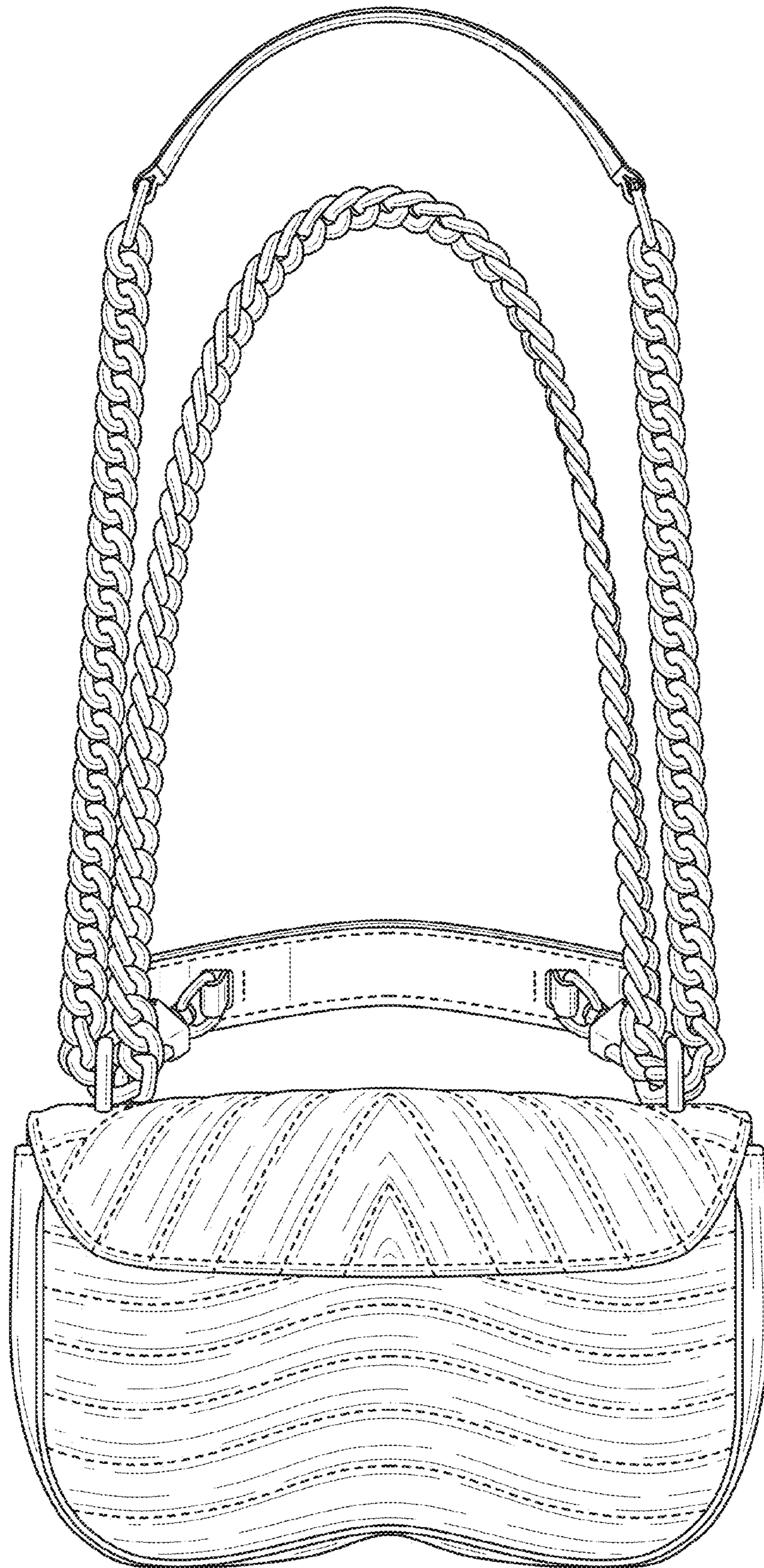

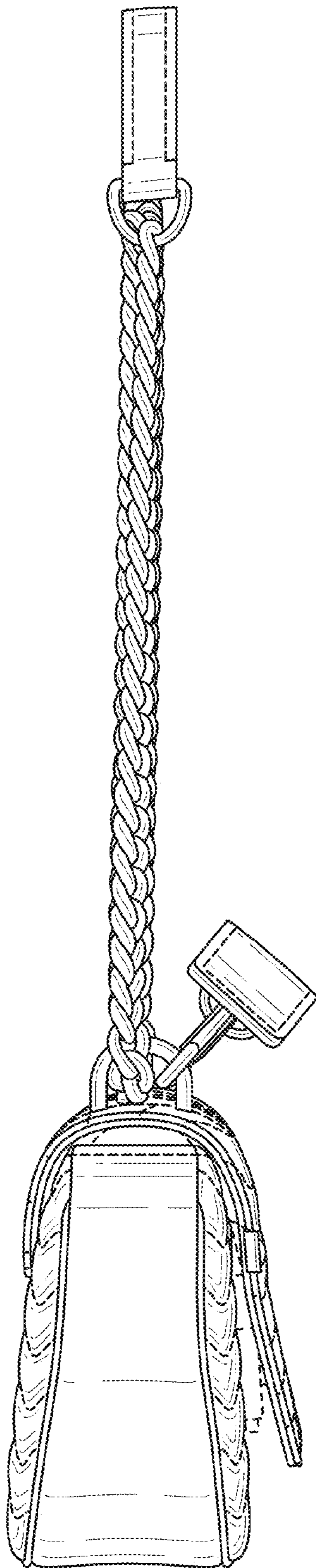

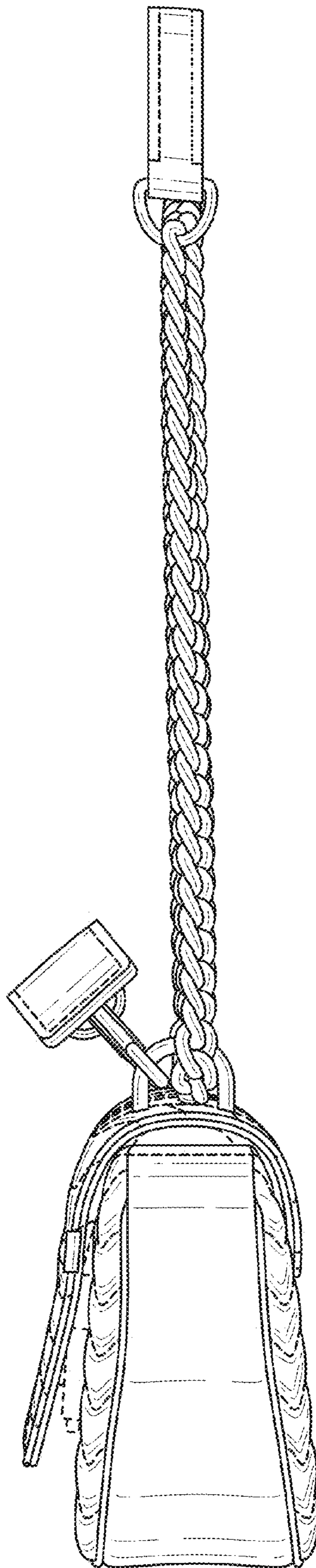

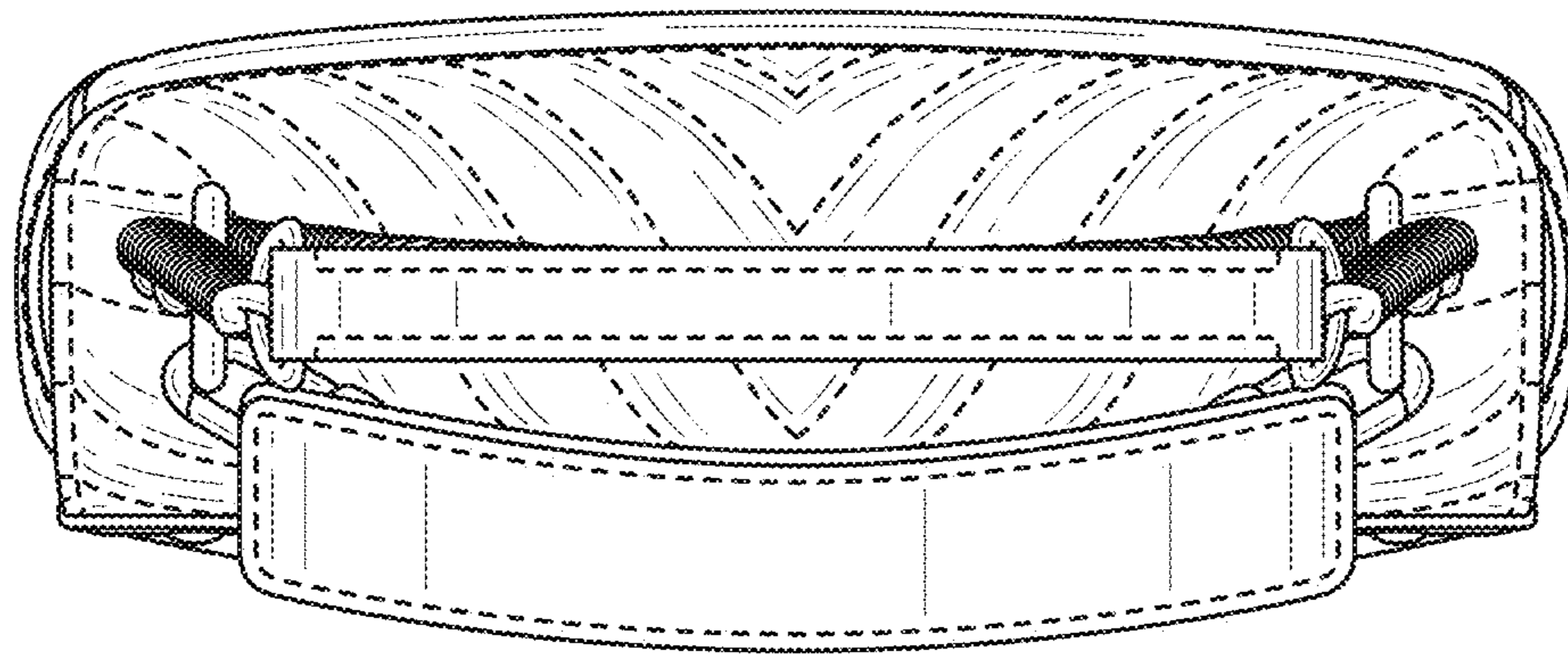

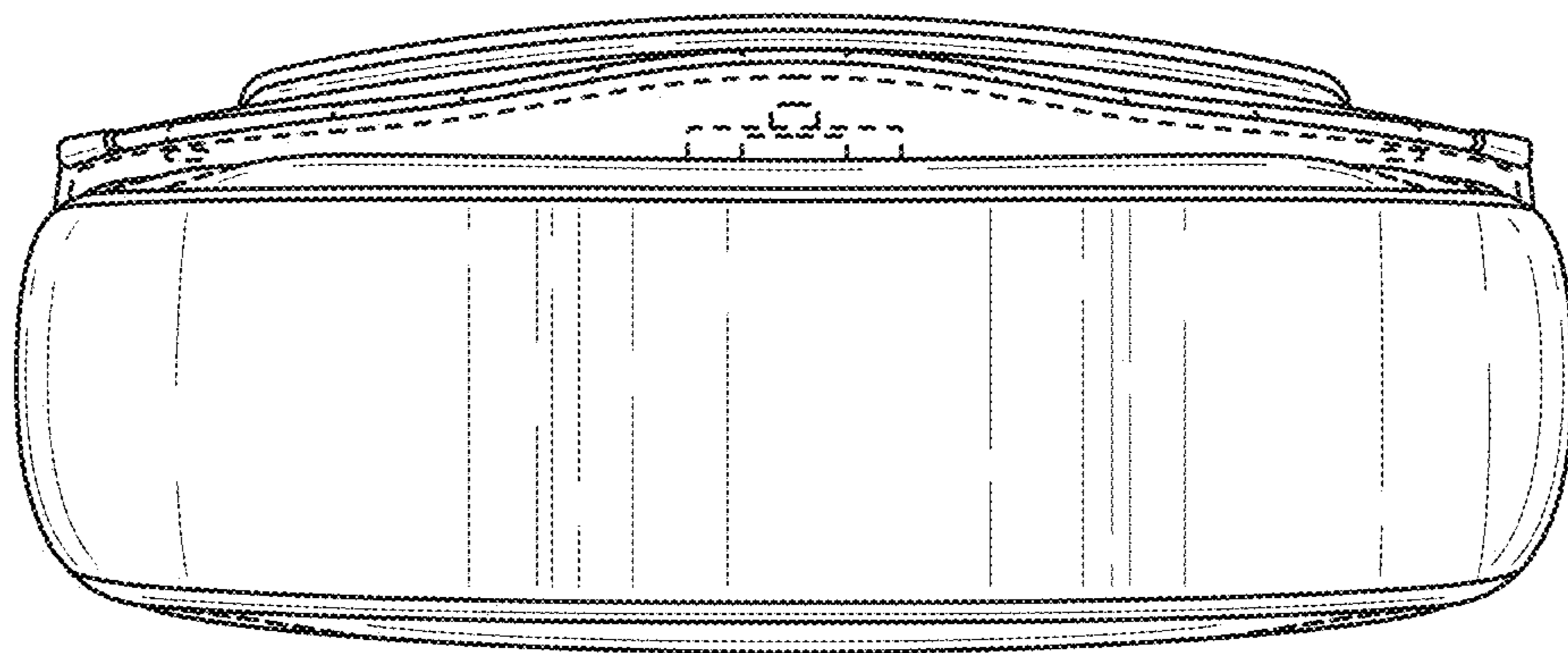
