(57) **CLAIM**

I claim my ornamental design for my in-wall toilet paper container and dispenser, as shown.

DESCRIPTION

FIG. 1 is a front elevation view of the first embodiment of an in-wall toilet paper container and dispenser with no top door showing my new design.

FIG. 2 is a side elevation view thereof.

FIG. 3 is a side elevation view of the second embodiment in-wall toilet paper container and dispenser with a top door in the open position.

FIG. 4 is a side elevation thereof with a top door in the closed position.

FIG. 5 is a front elevation view thereof.

FIG. 6 is a rear elevation view thereof.

FIG. 7 is a front elevation view thereof.

FIG. 8 is a side elevation view thereof.

FIG. 9 is a top-front perspective view thereof.

FIG. 10 is a top plan view thereof.

FIG. 11 is a bottom plan view thereof.

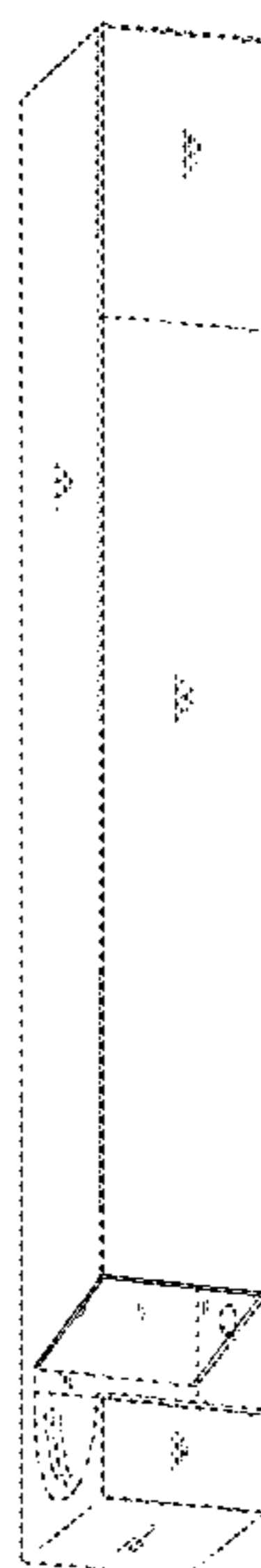
FIG. 12 is a bottom-front perspective view thereof.

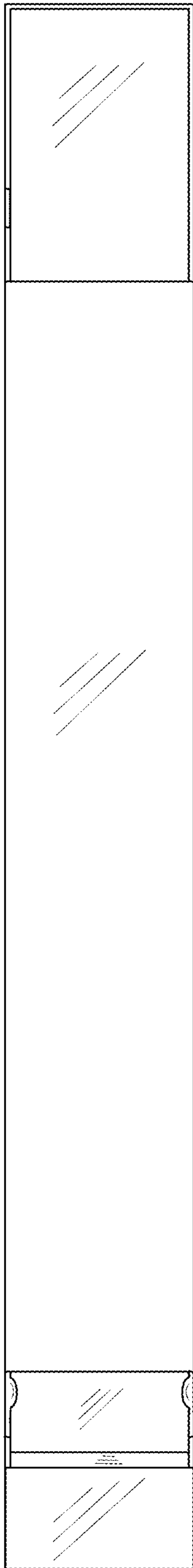

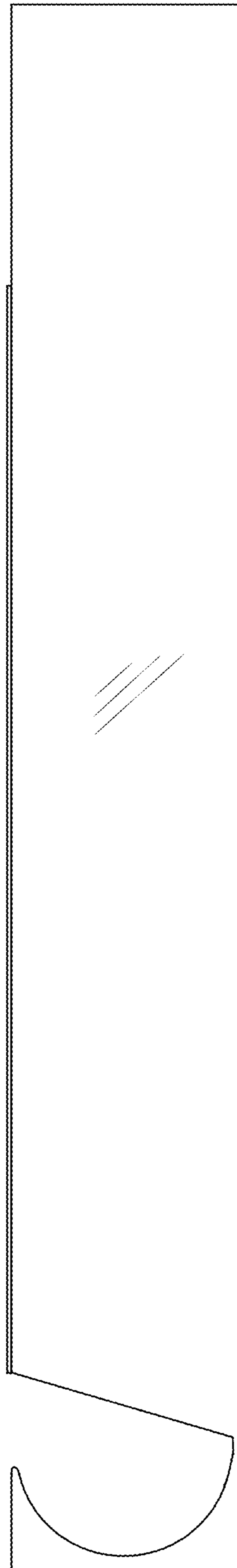

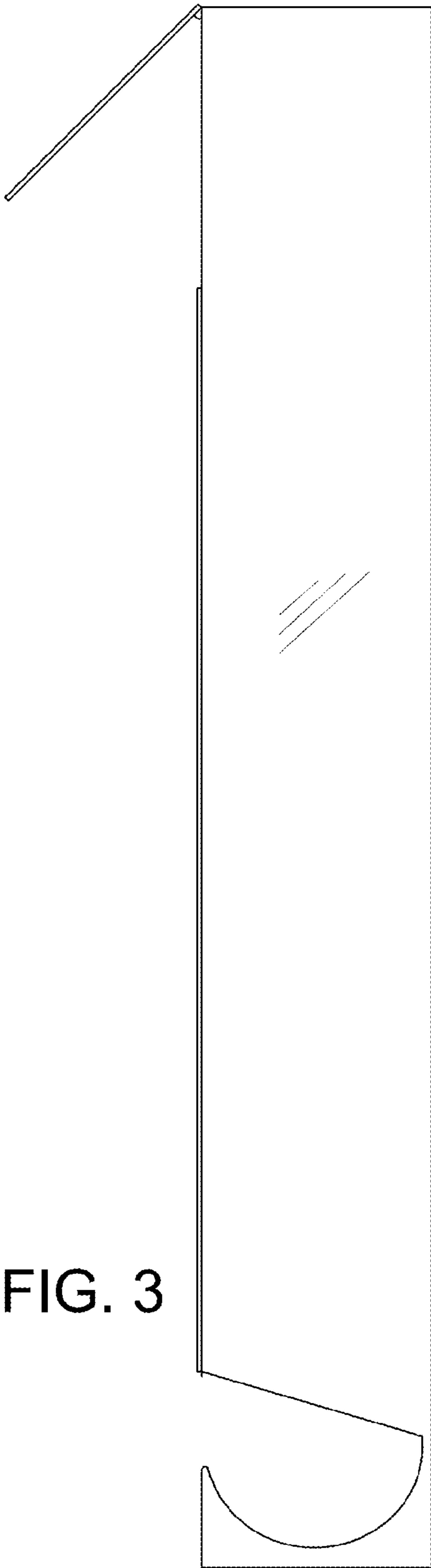

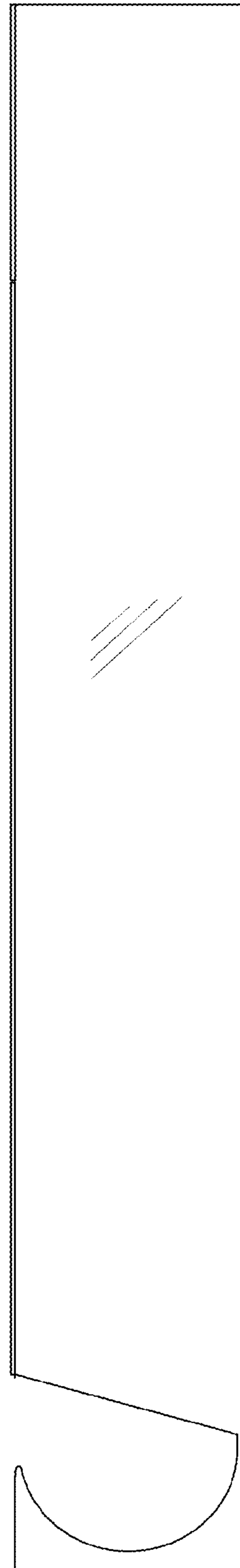

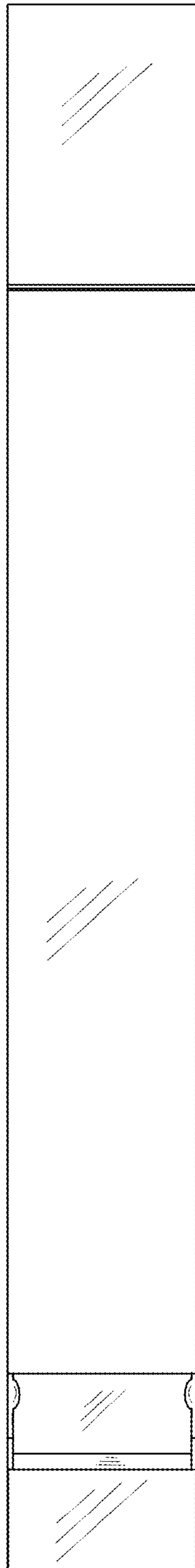

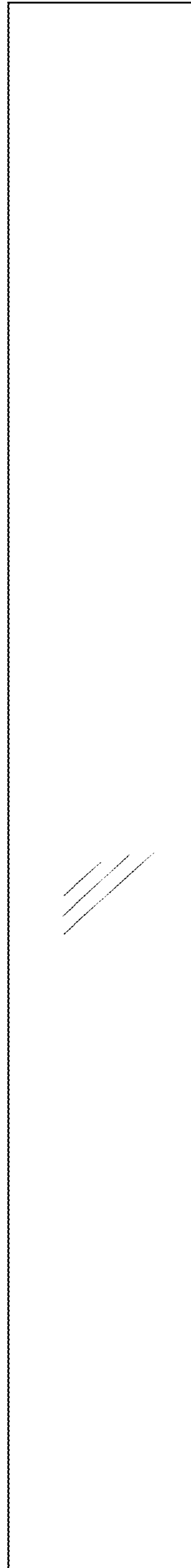

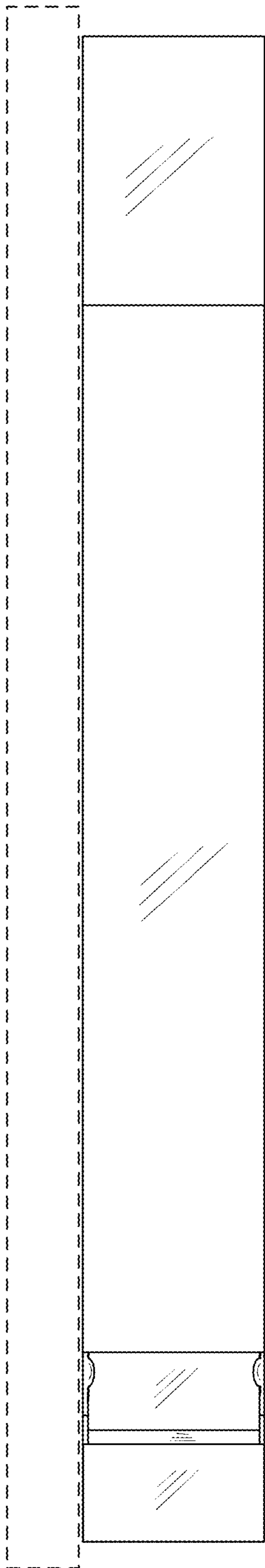

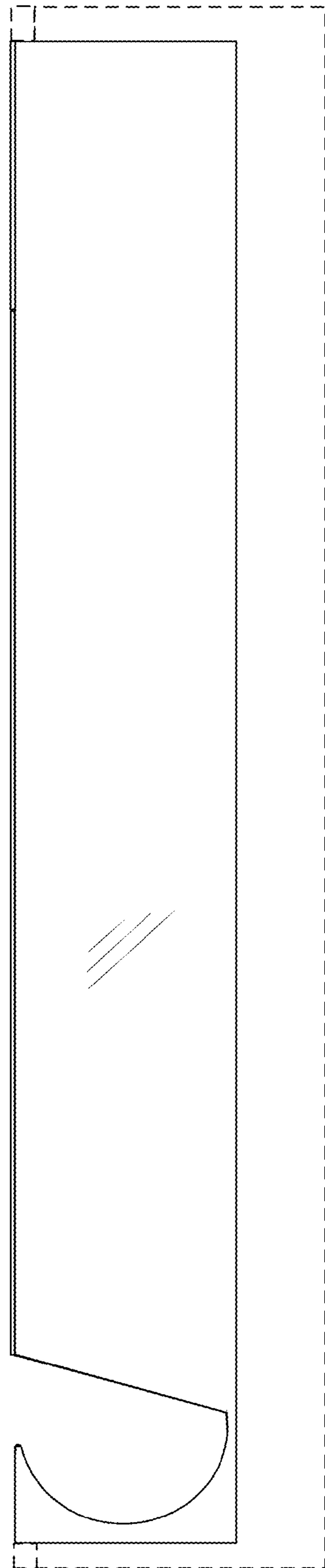

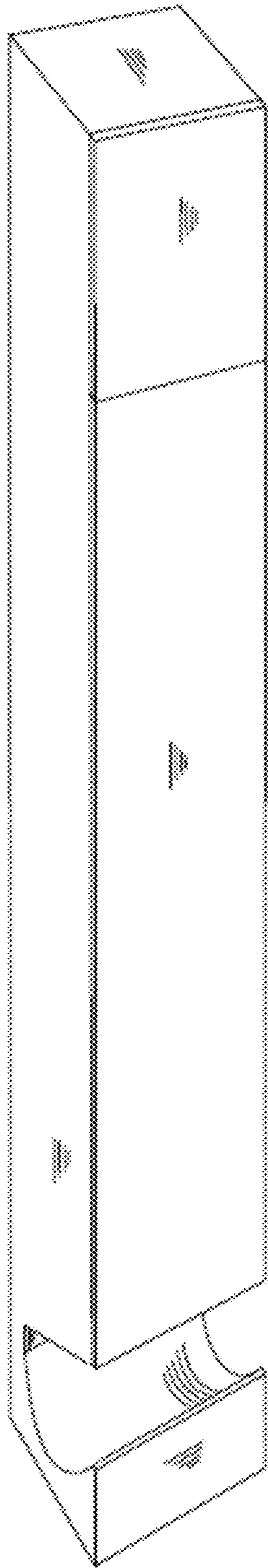

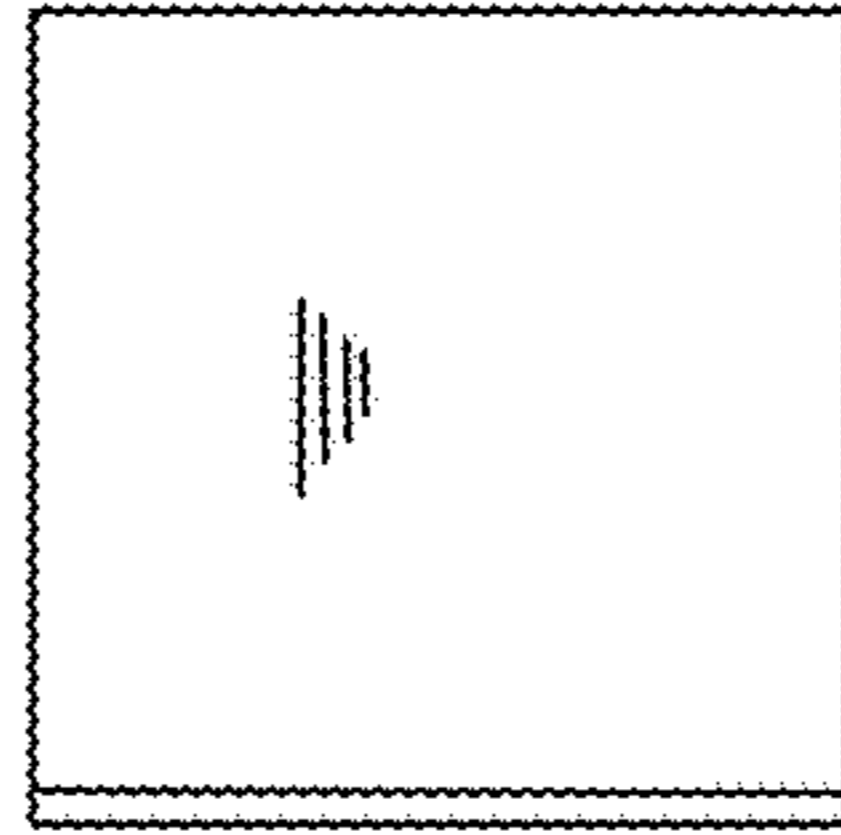

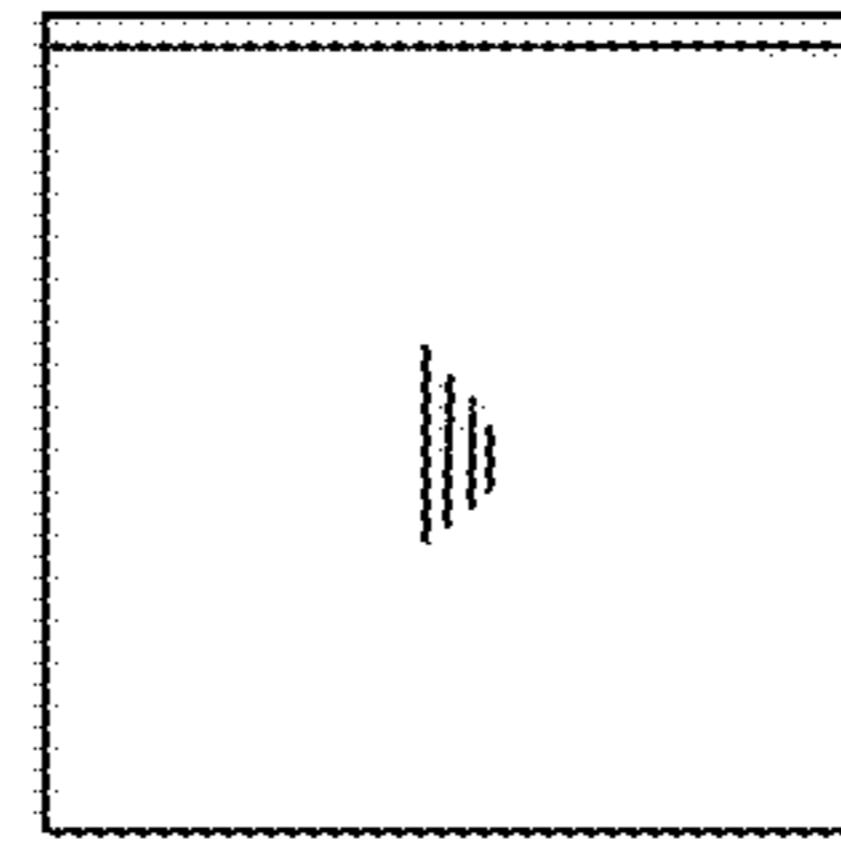

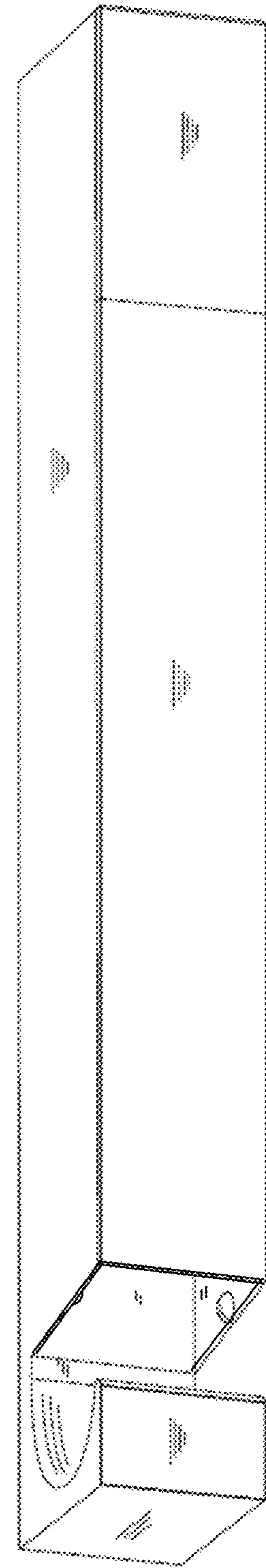

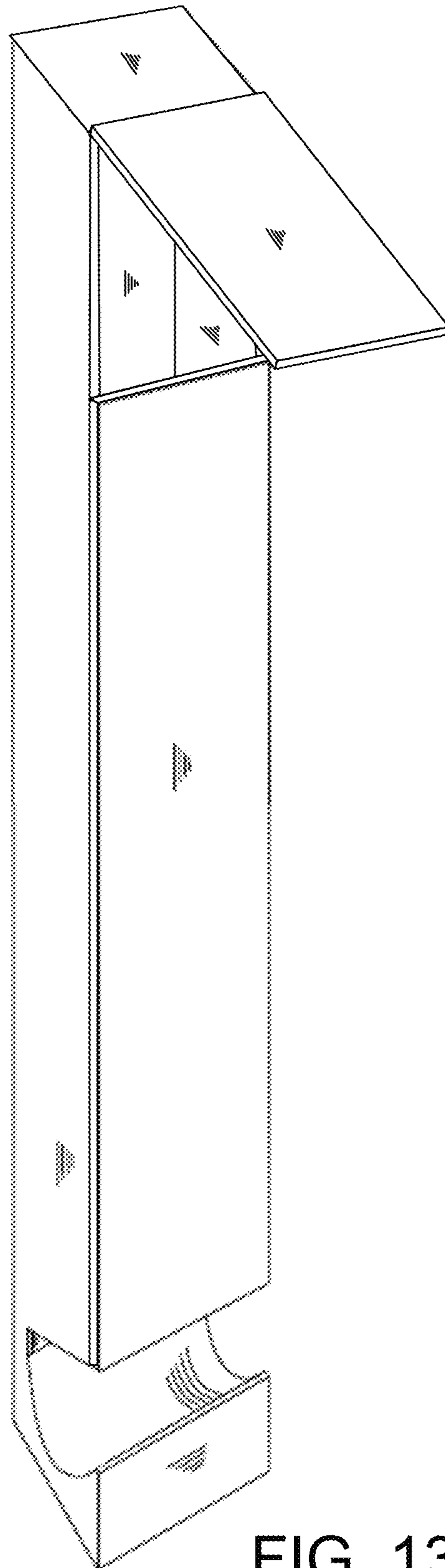

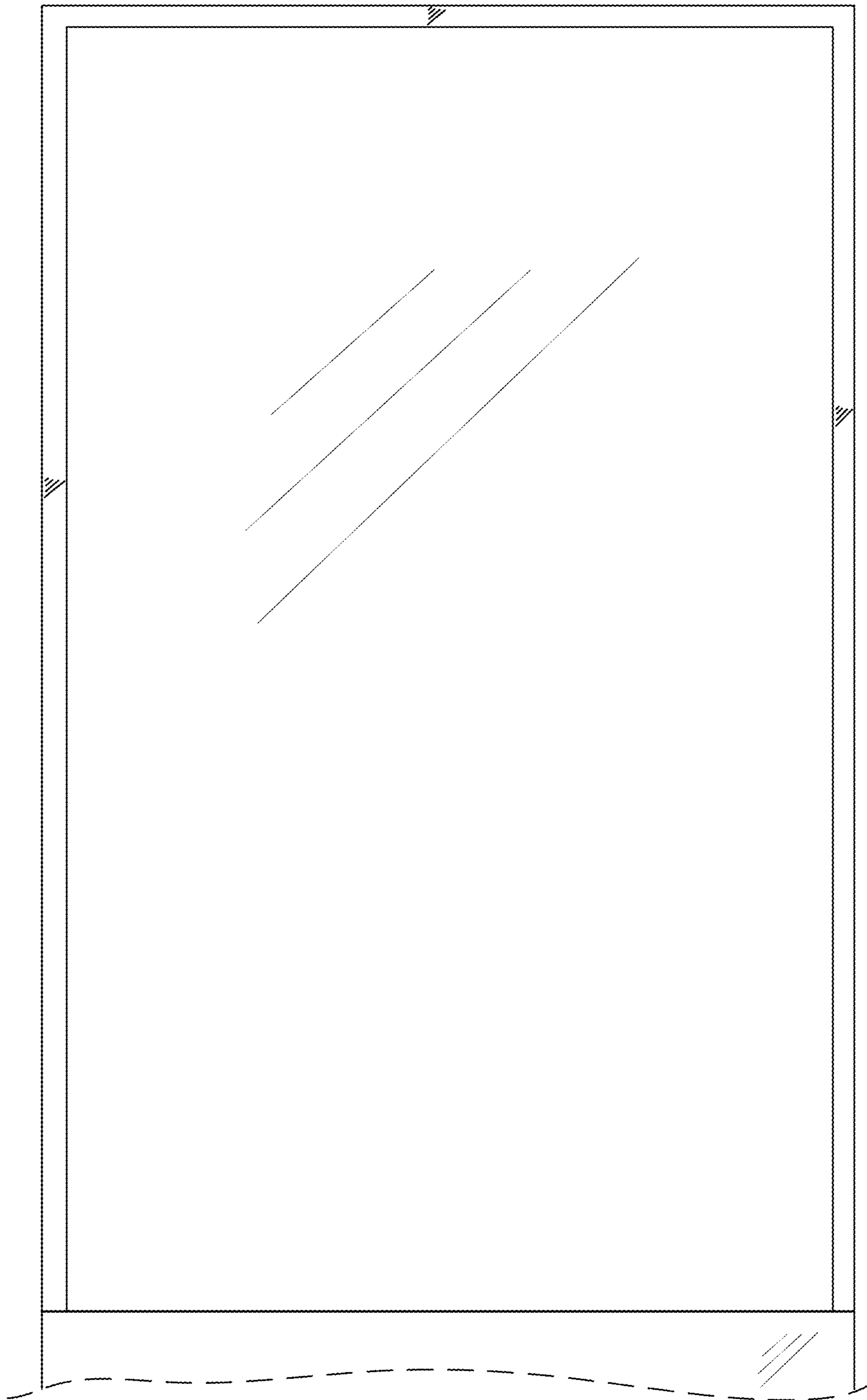
