DESCRIPTION

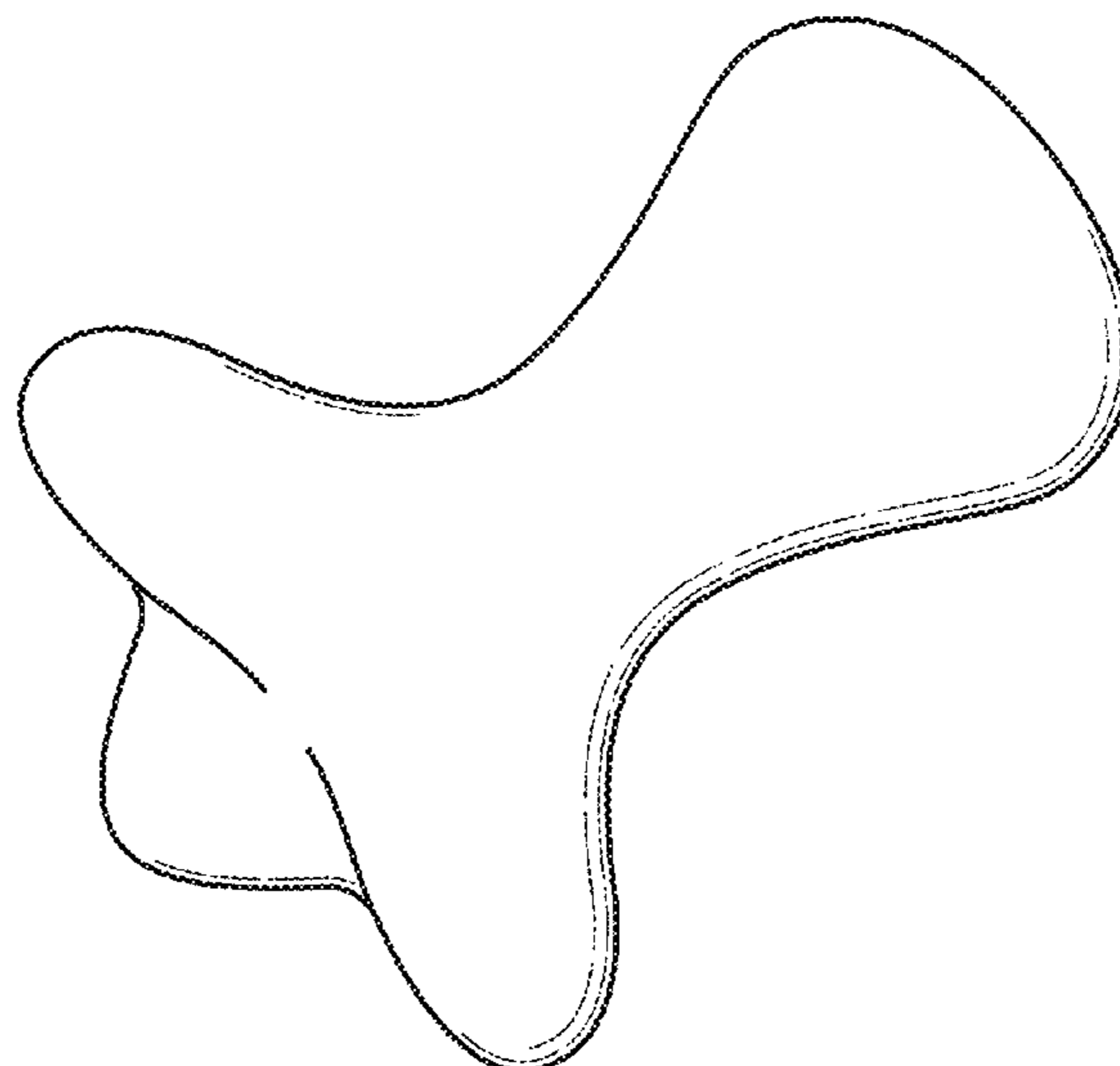
FIG. 1 is a perspective view of the neck pillow of the present invention.

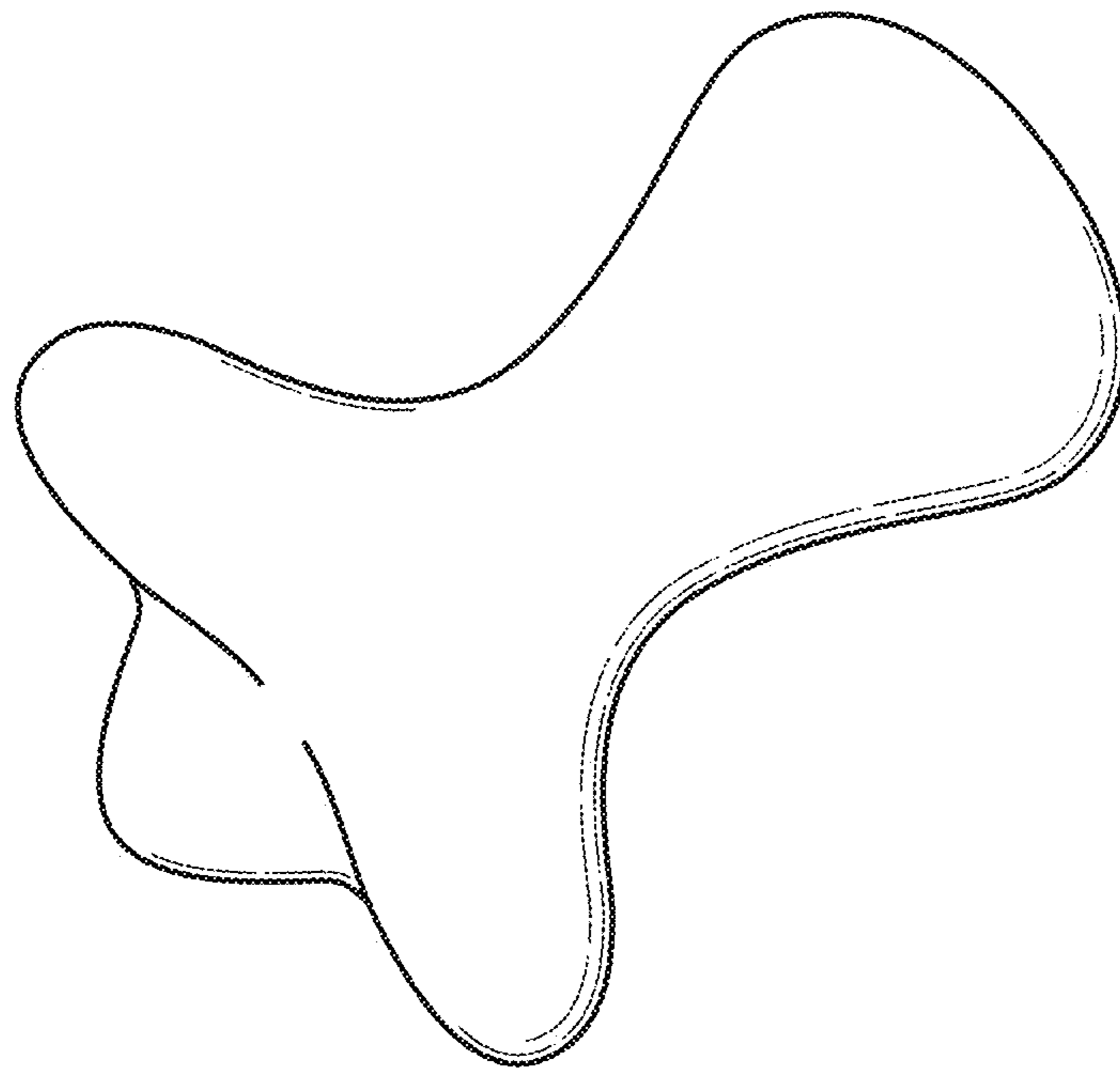

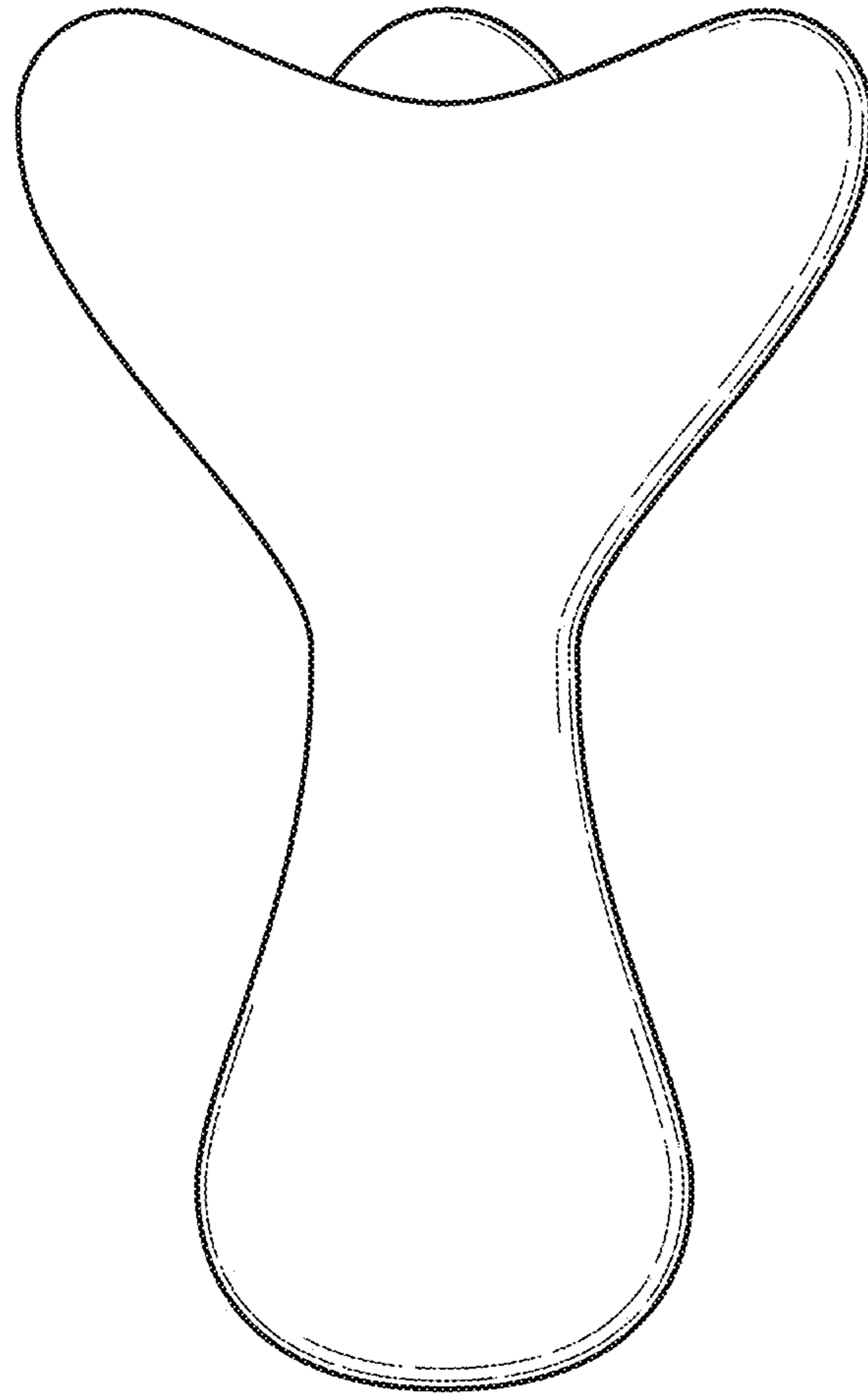

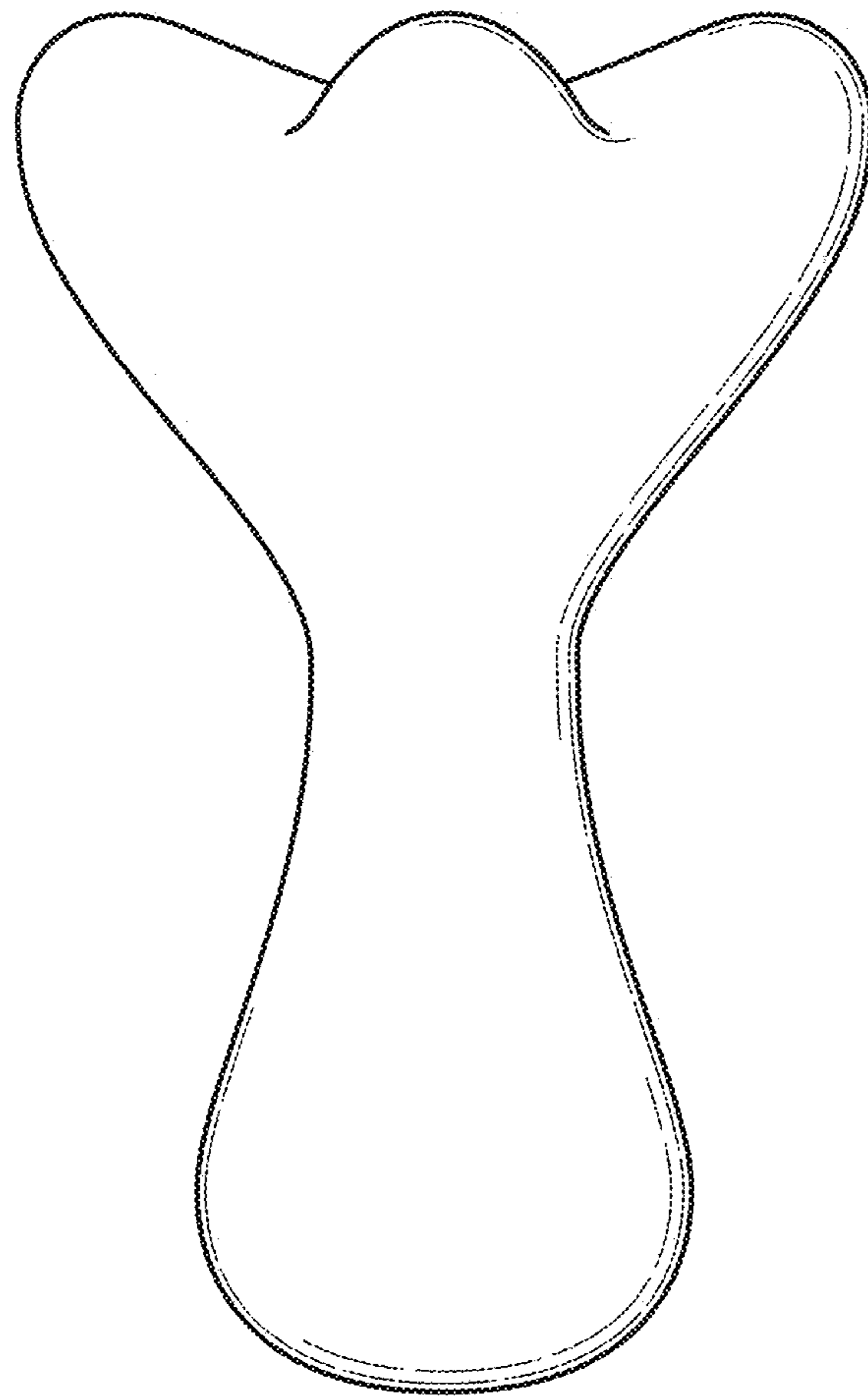

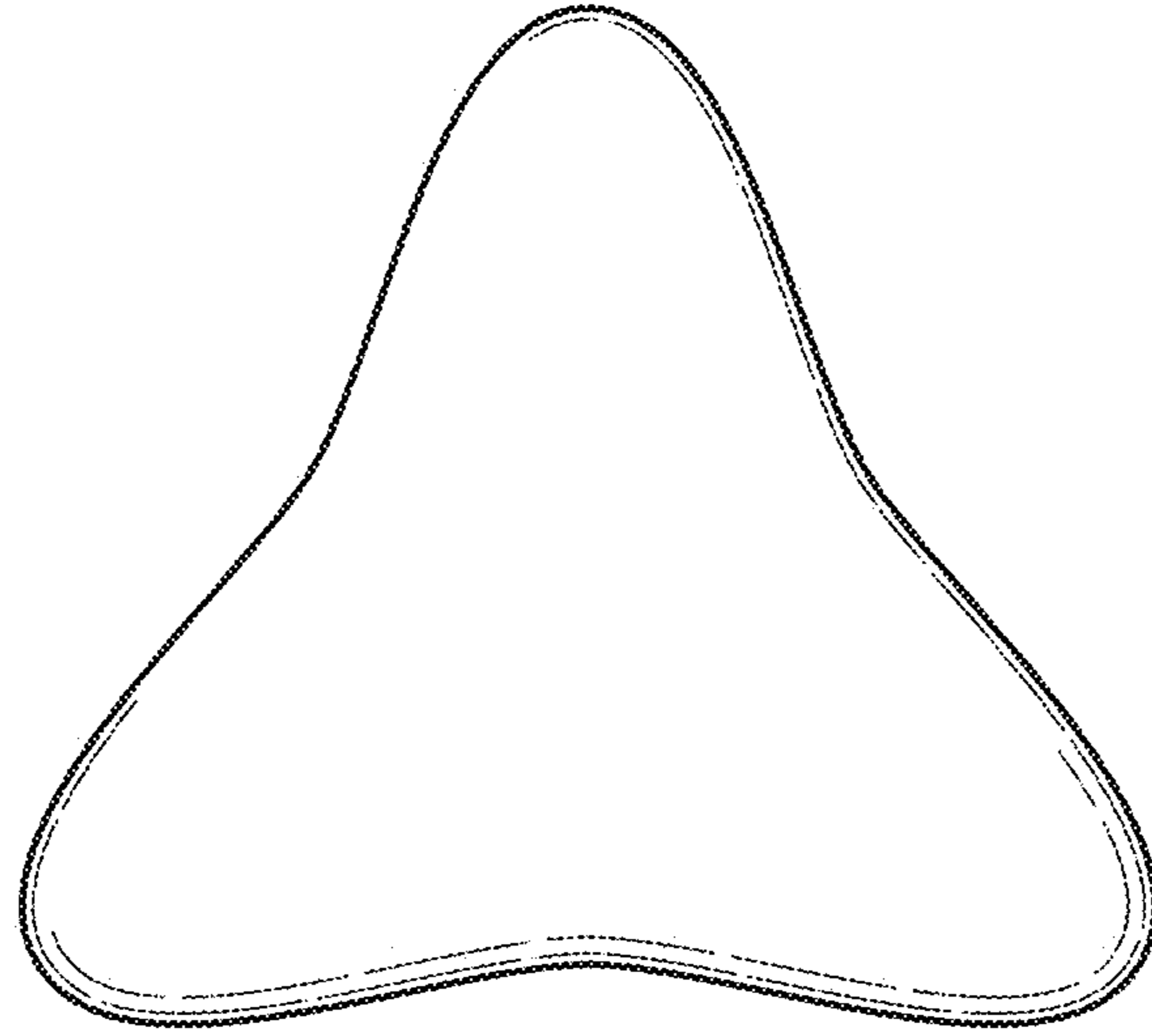

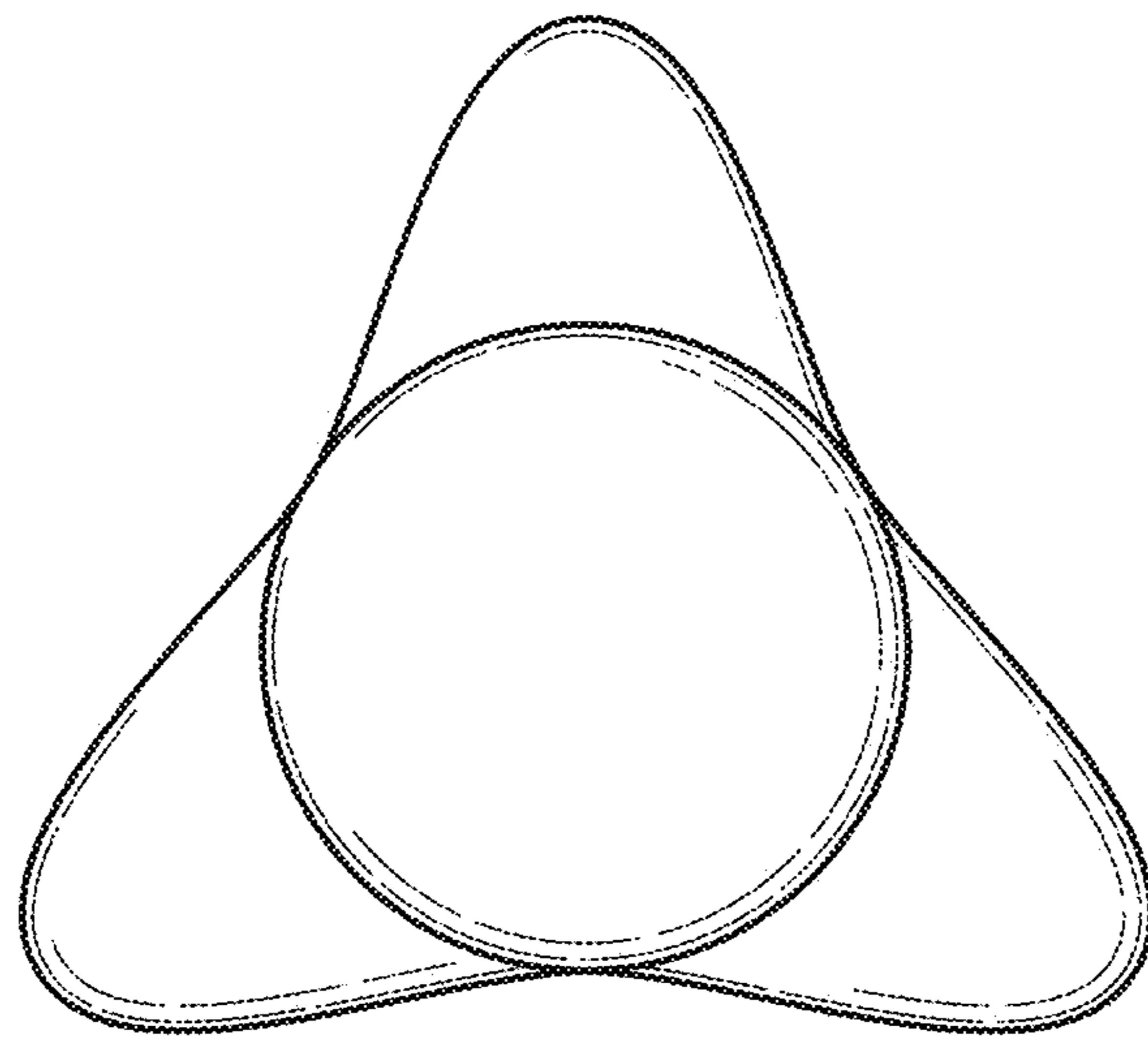

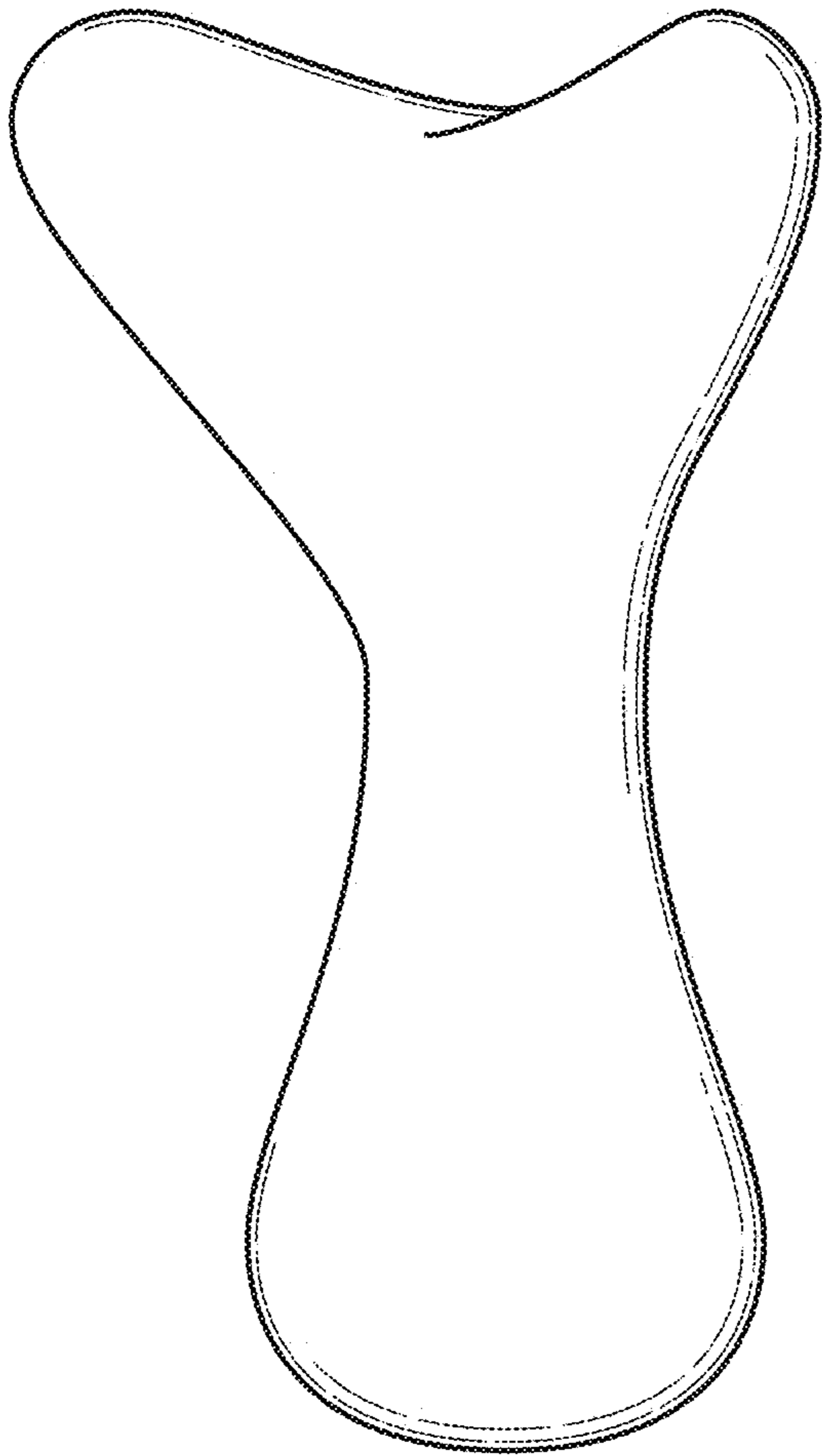

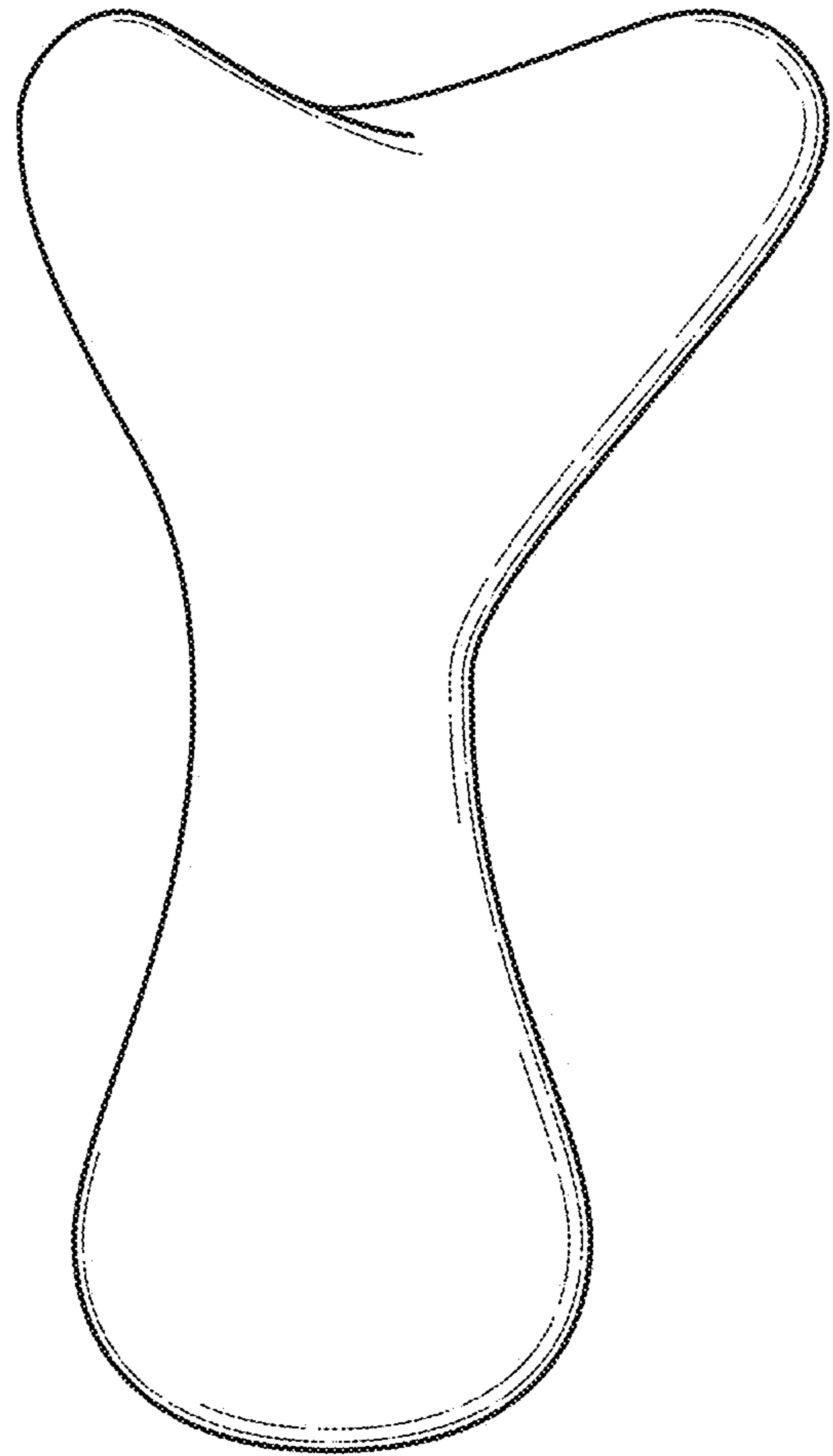
