The ornamental design for a beverage glass, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a beverage glass showing my new design;

FIG. 2 is a side view thereof;

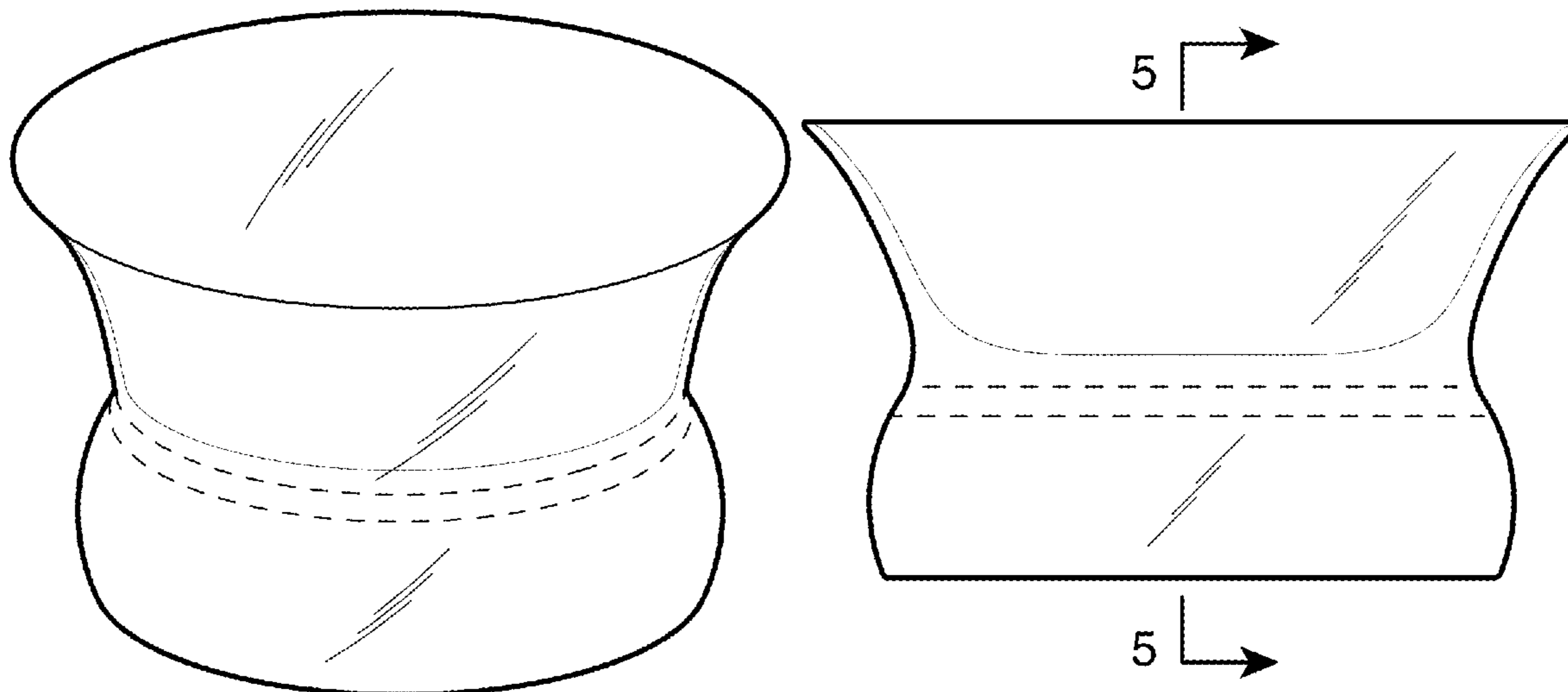
FIG. 3 is a reduced scale top view thereof;

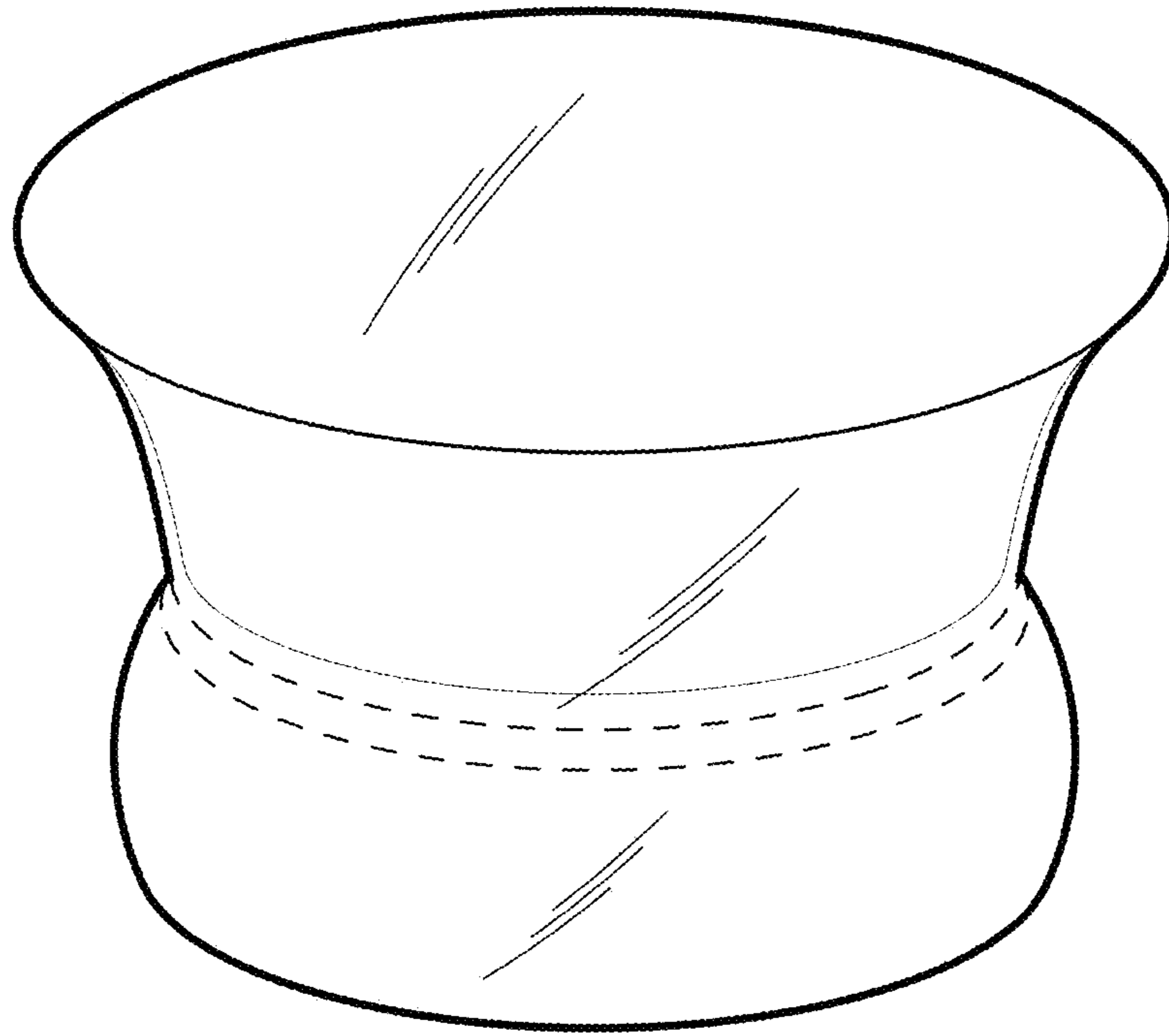

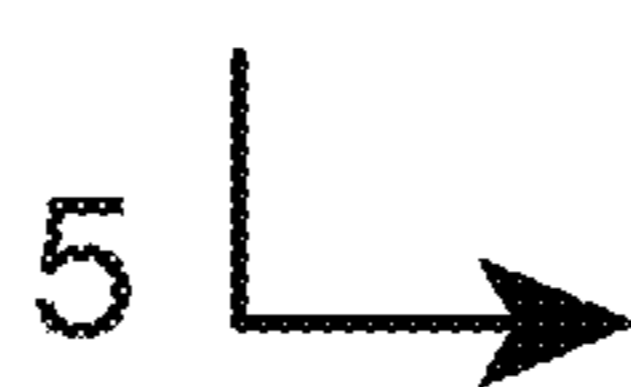
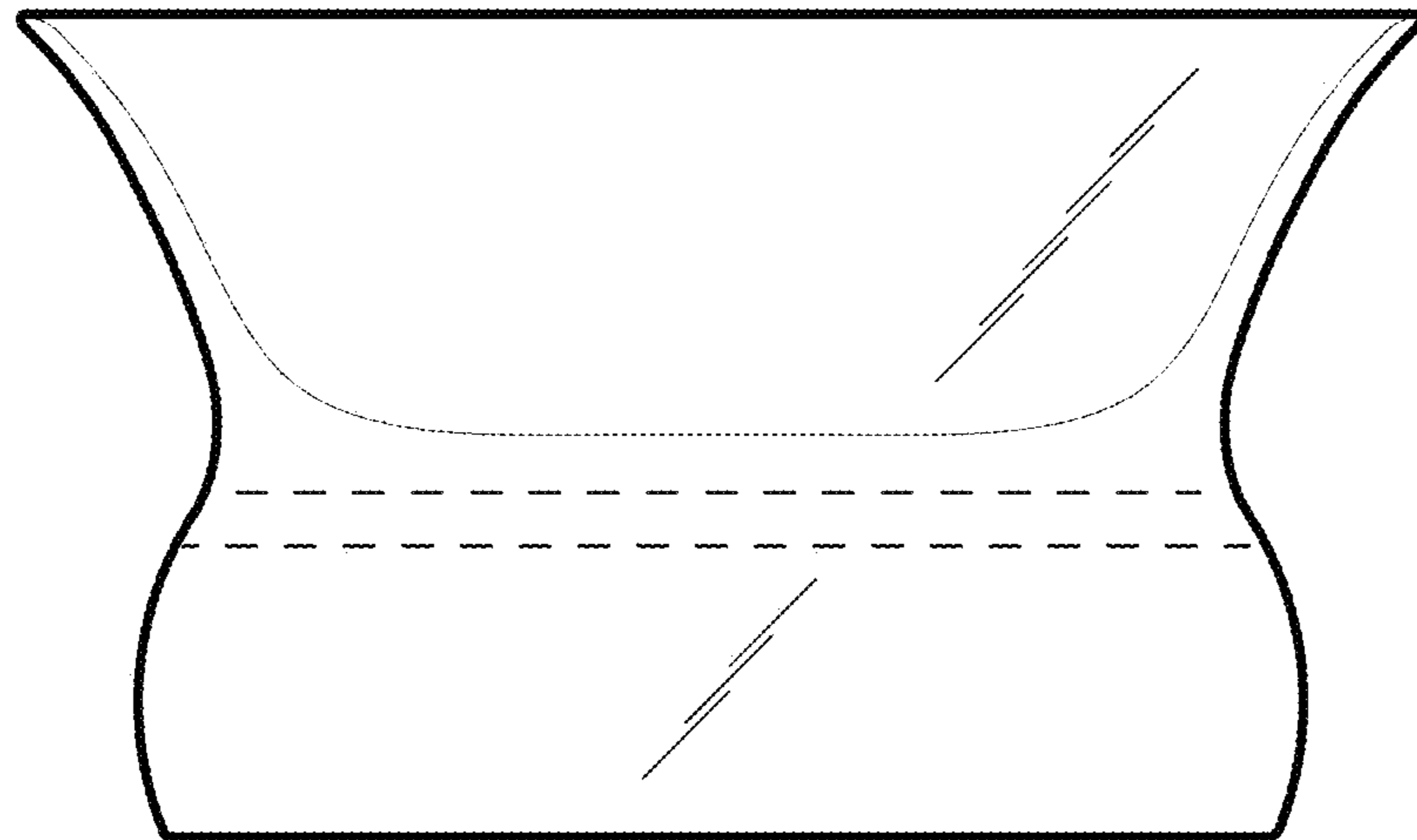

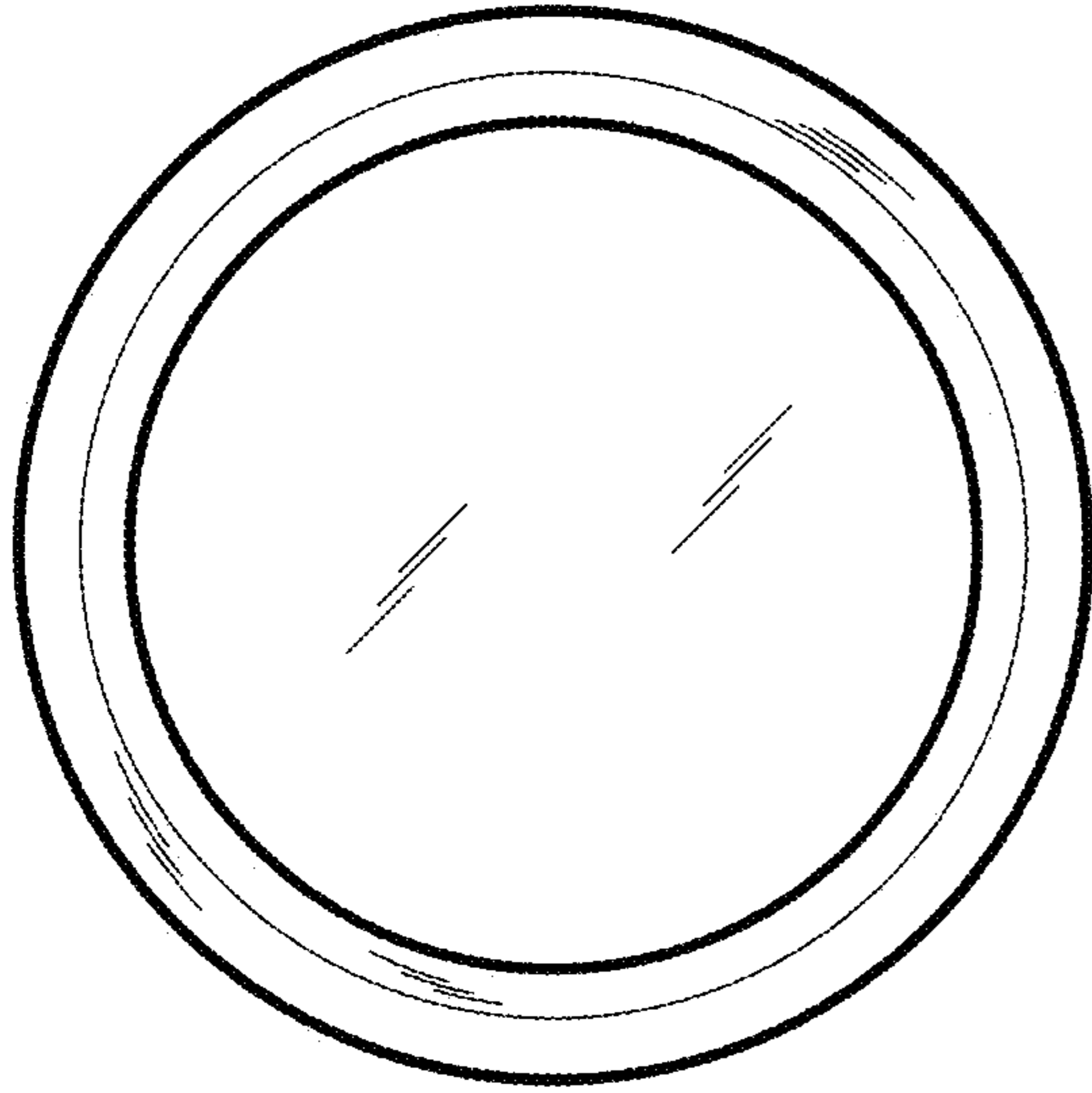

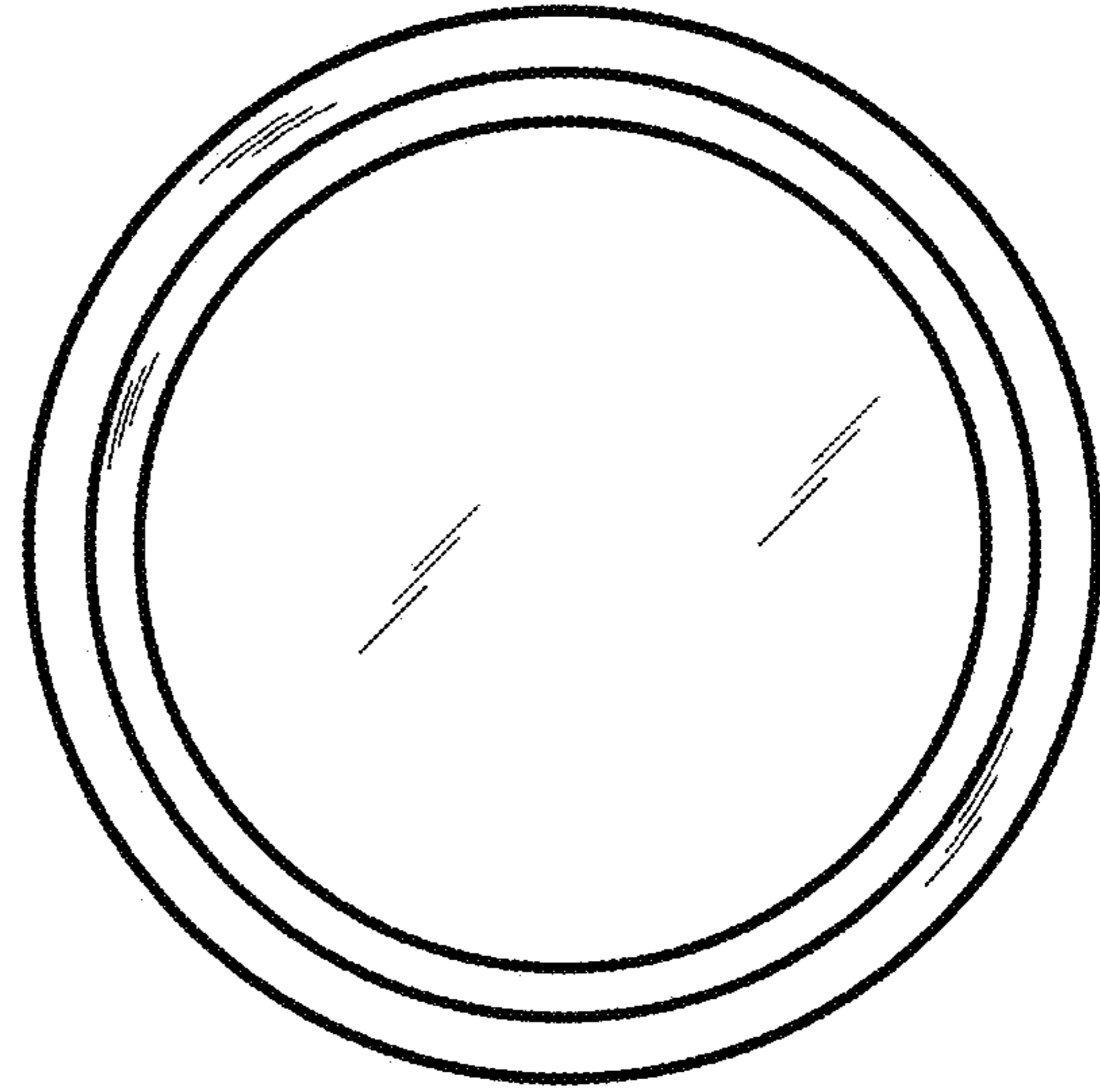

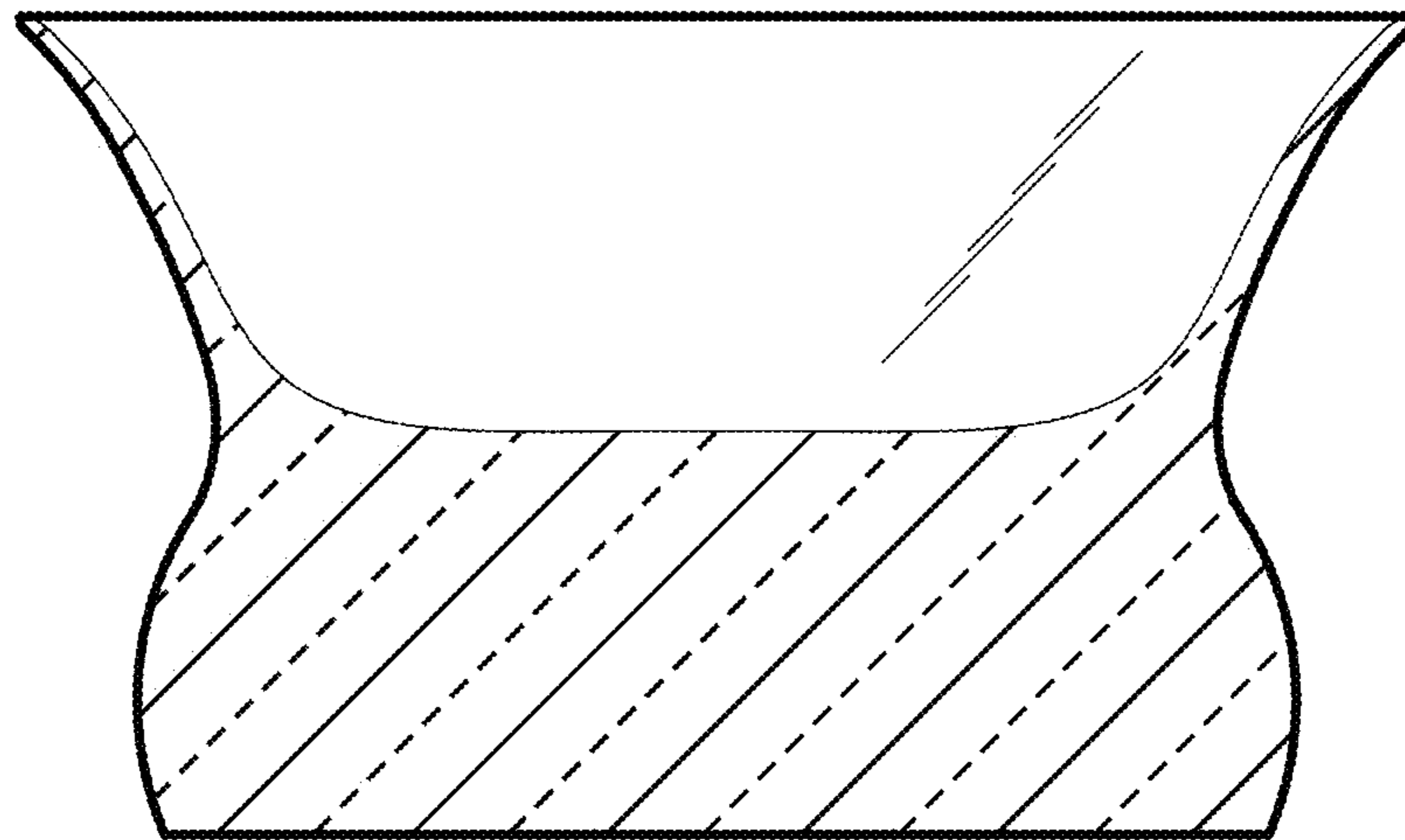
