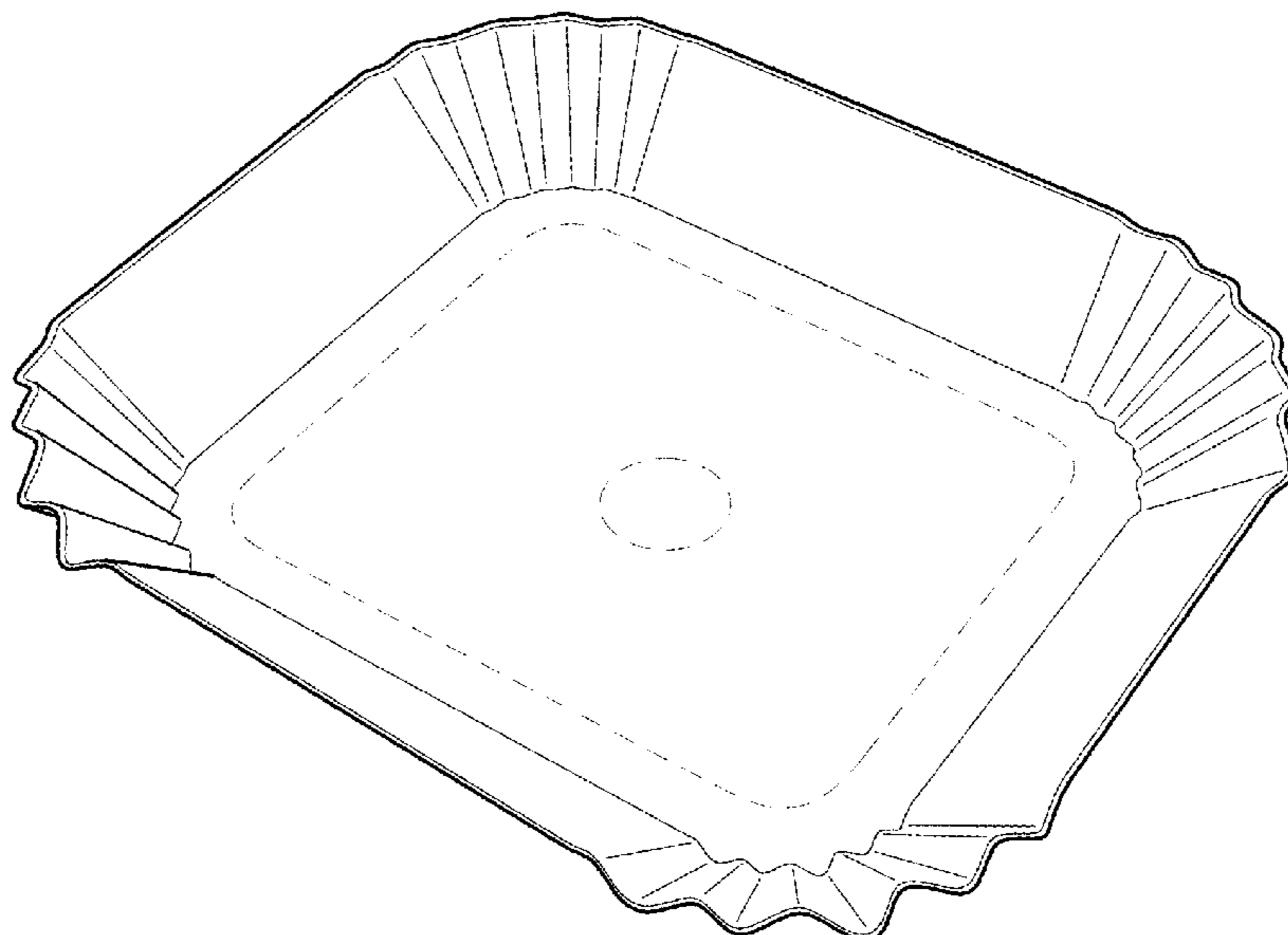
(57) **CLAIM**

The ornamental design for a tray, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of a tray showing my new design in accordance with a first embodiment of the present invention;  
FIG. 2 is a left side elevation view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a front elevation view thereof;

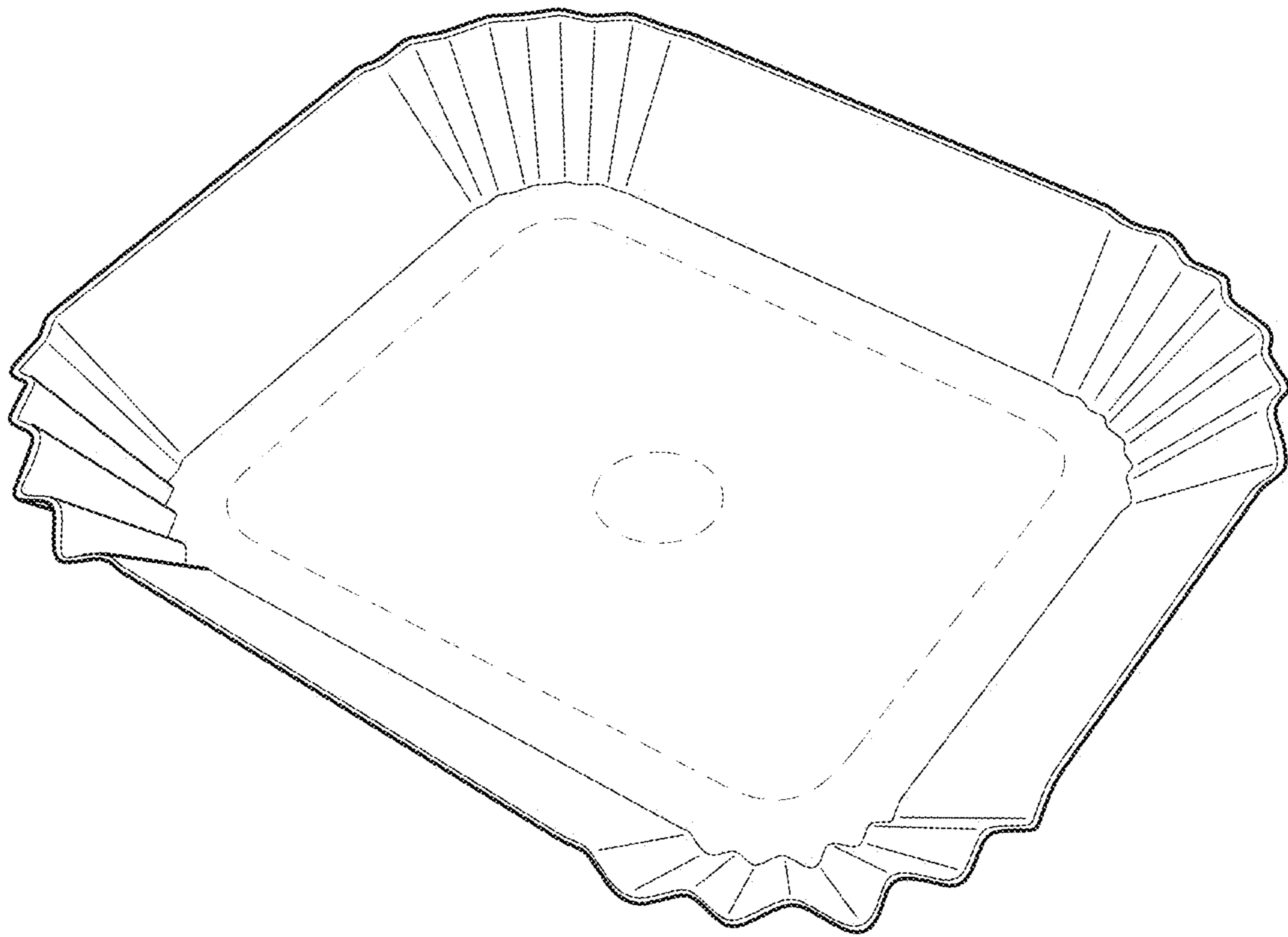

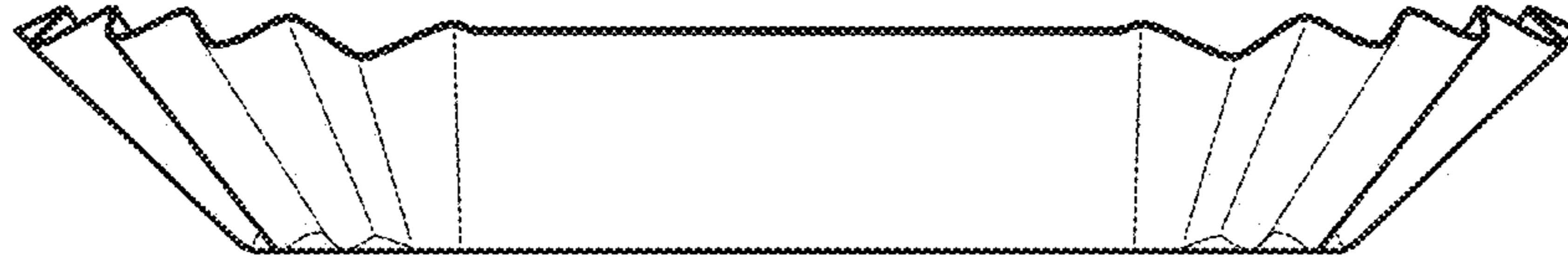

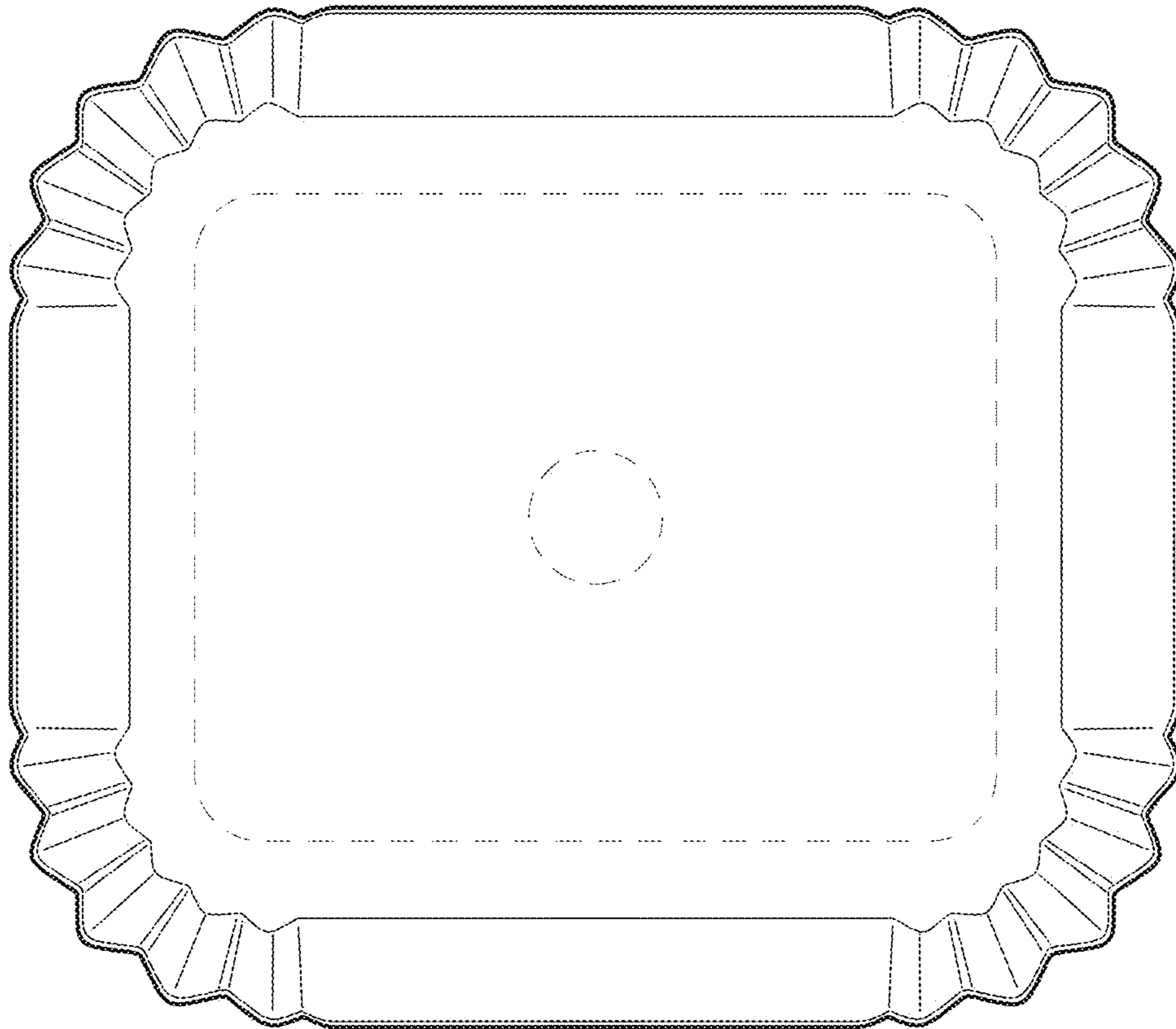

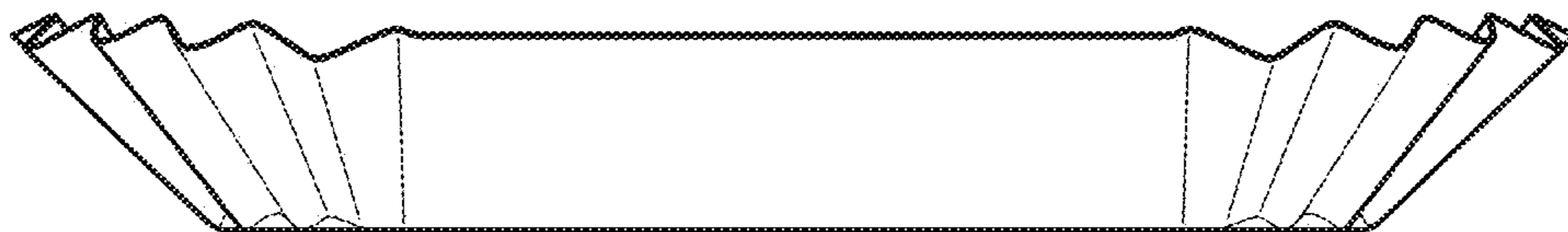

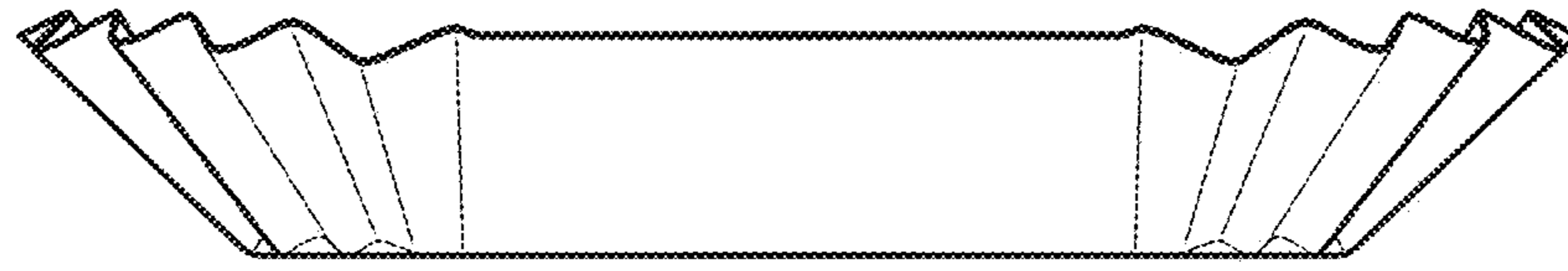

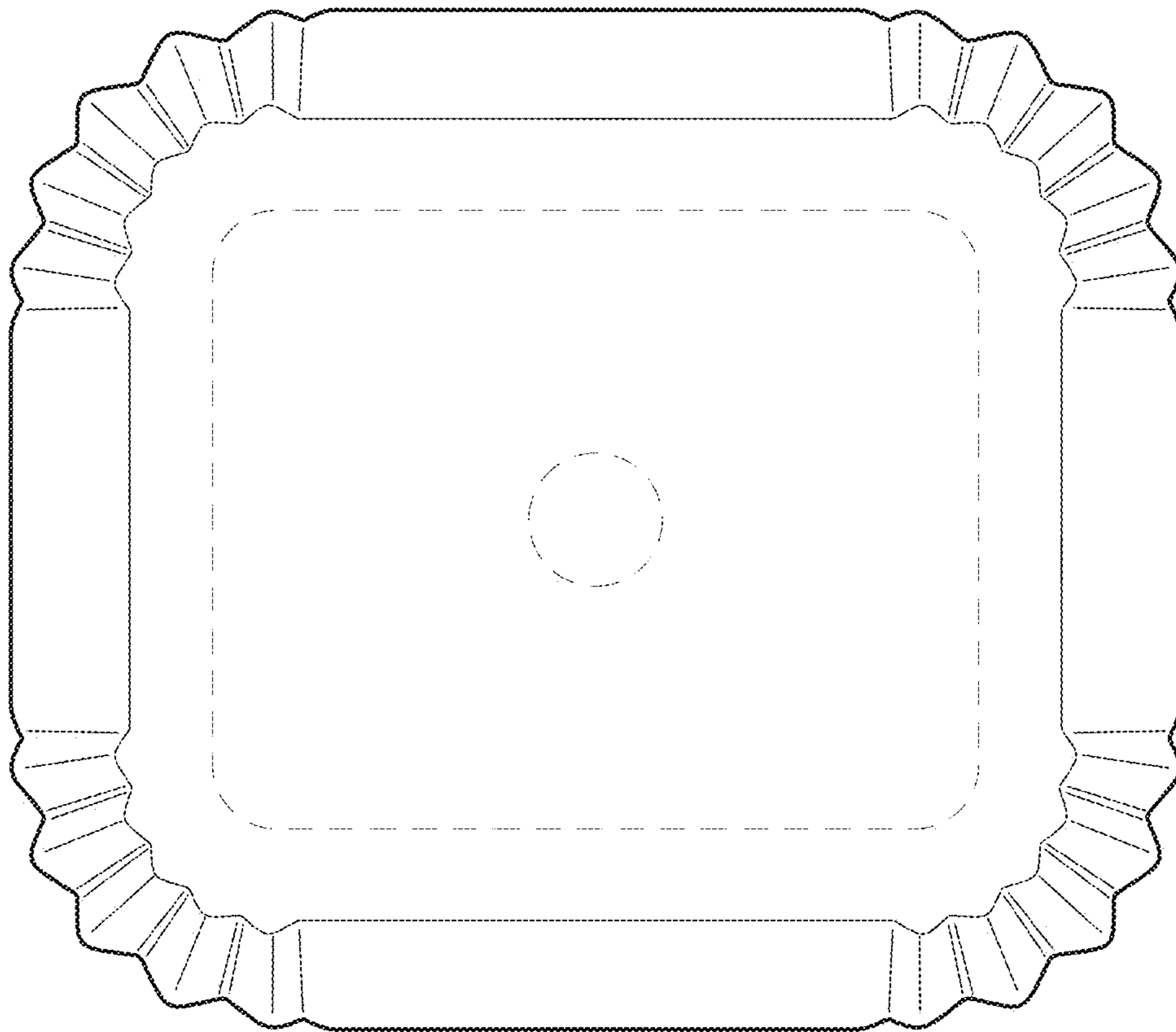

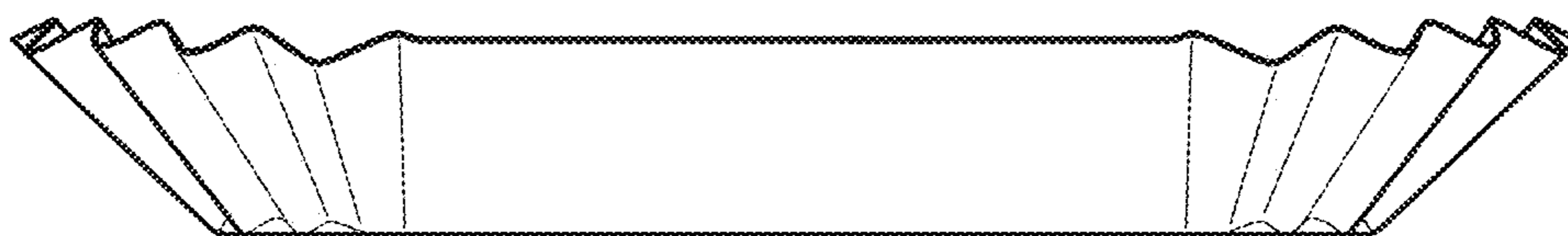

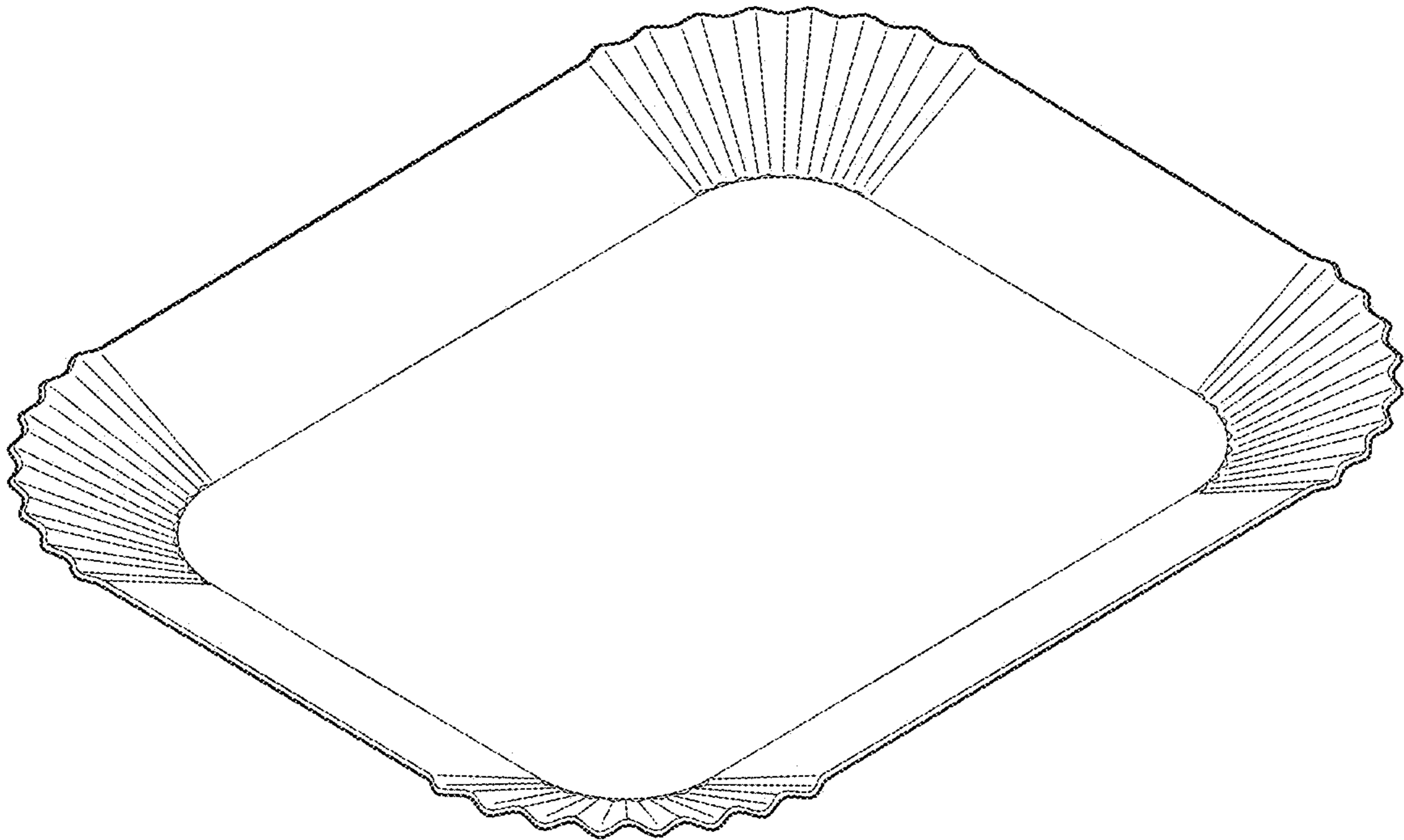

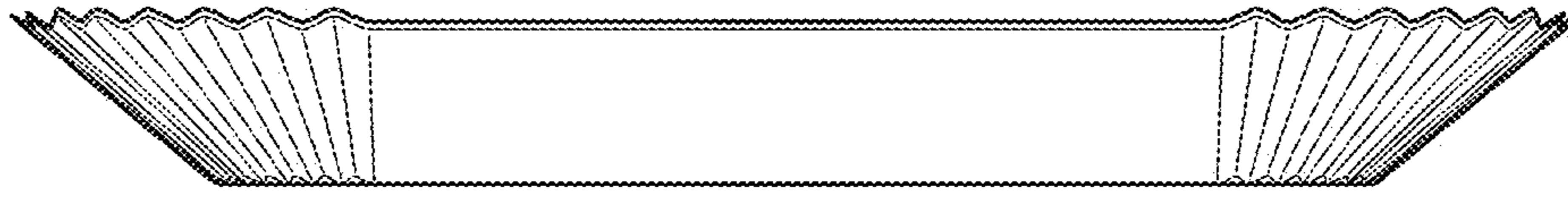

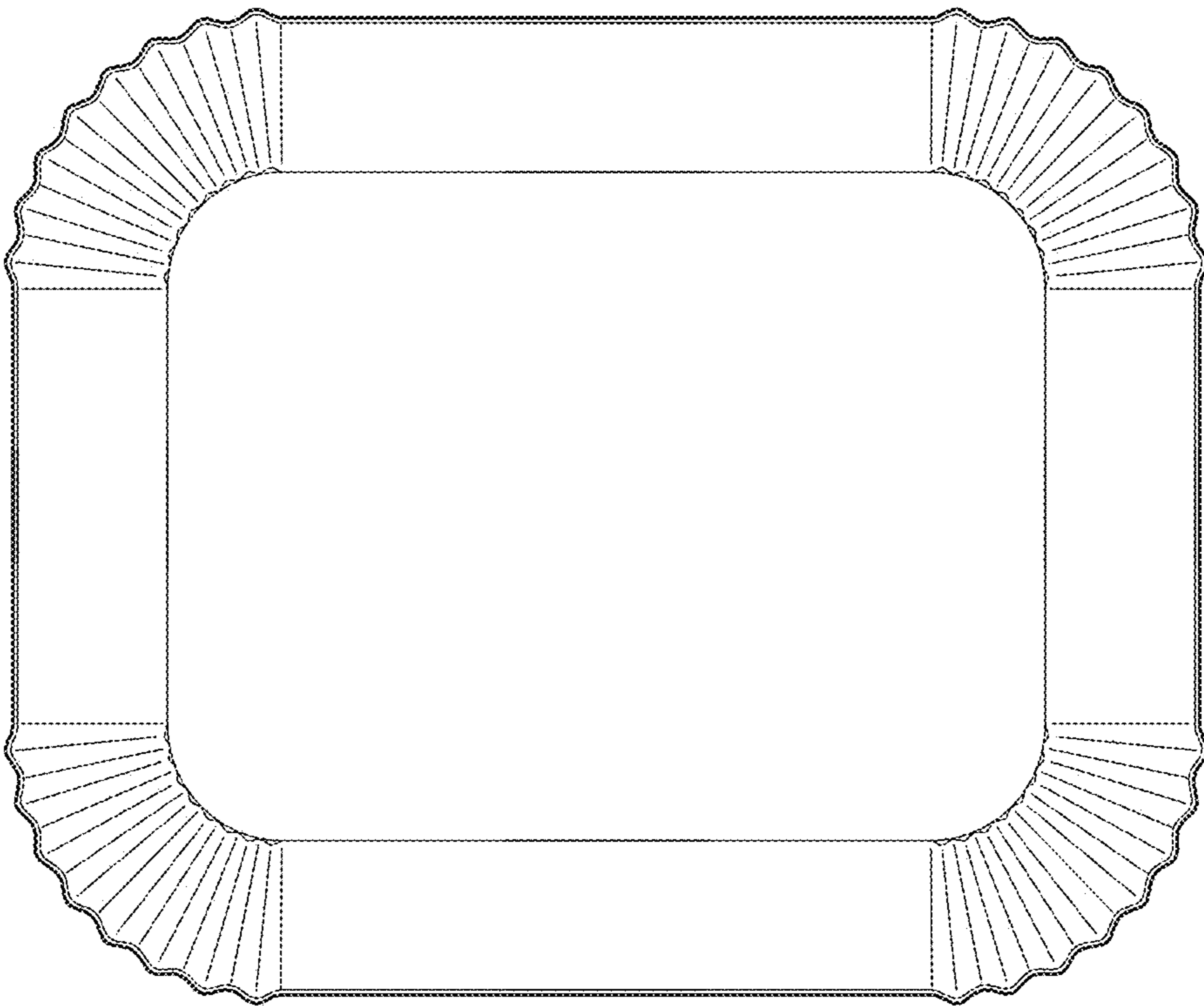

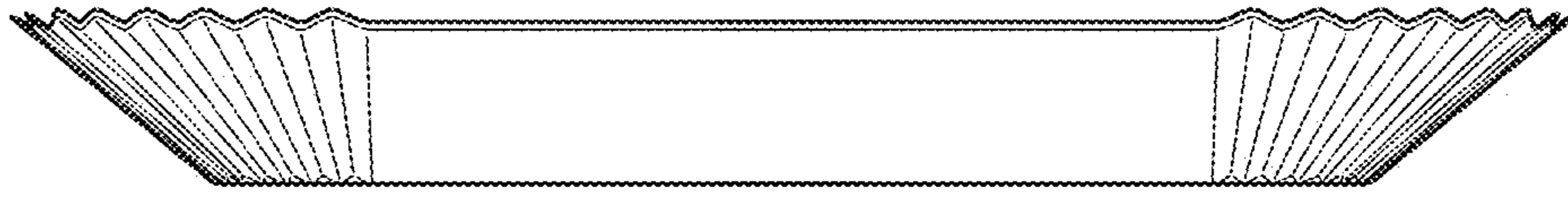

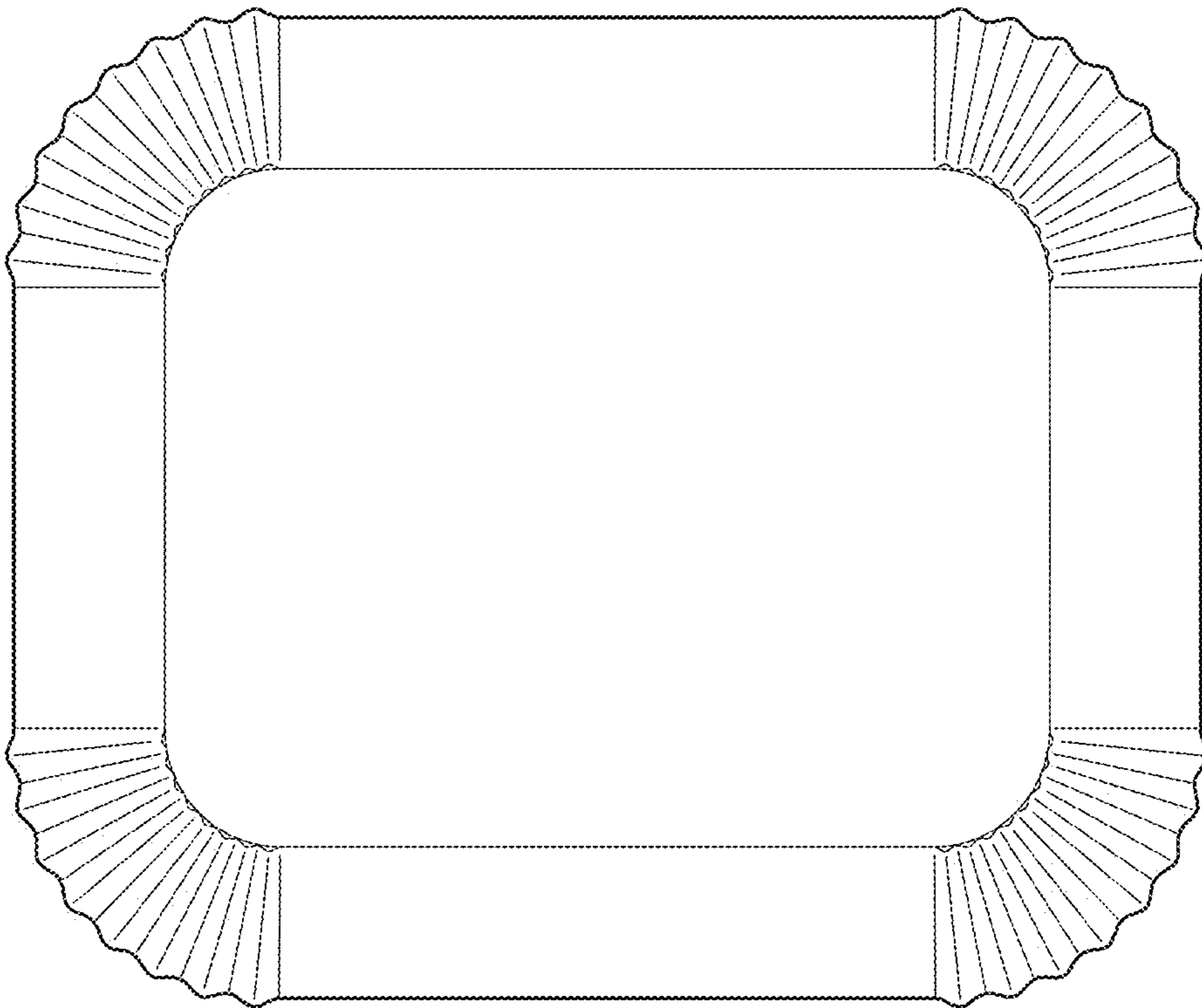
