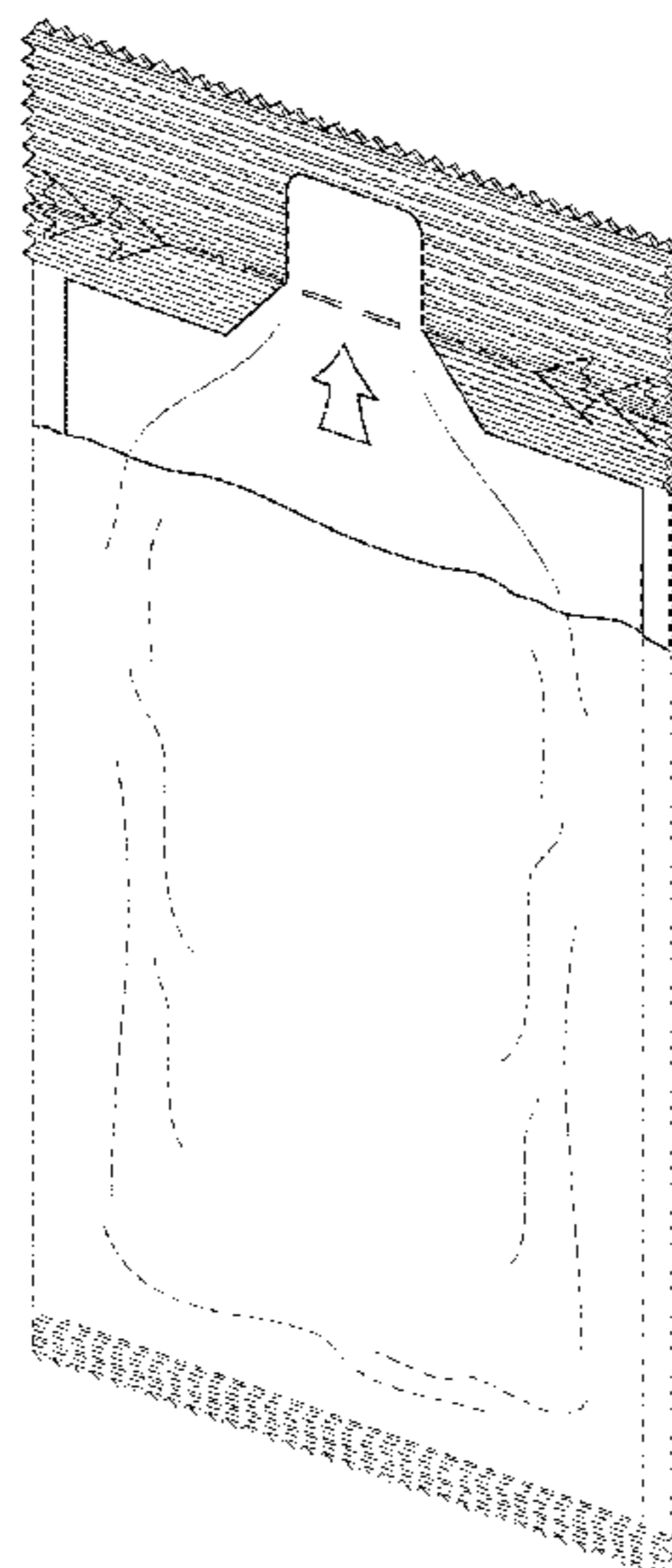
(57) **CLAIM**

The ornamental design for a spouted sachet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the spouted sachet showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a rear elevation view thereof.
The broken line showing of portions of the spouted sachet is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

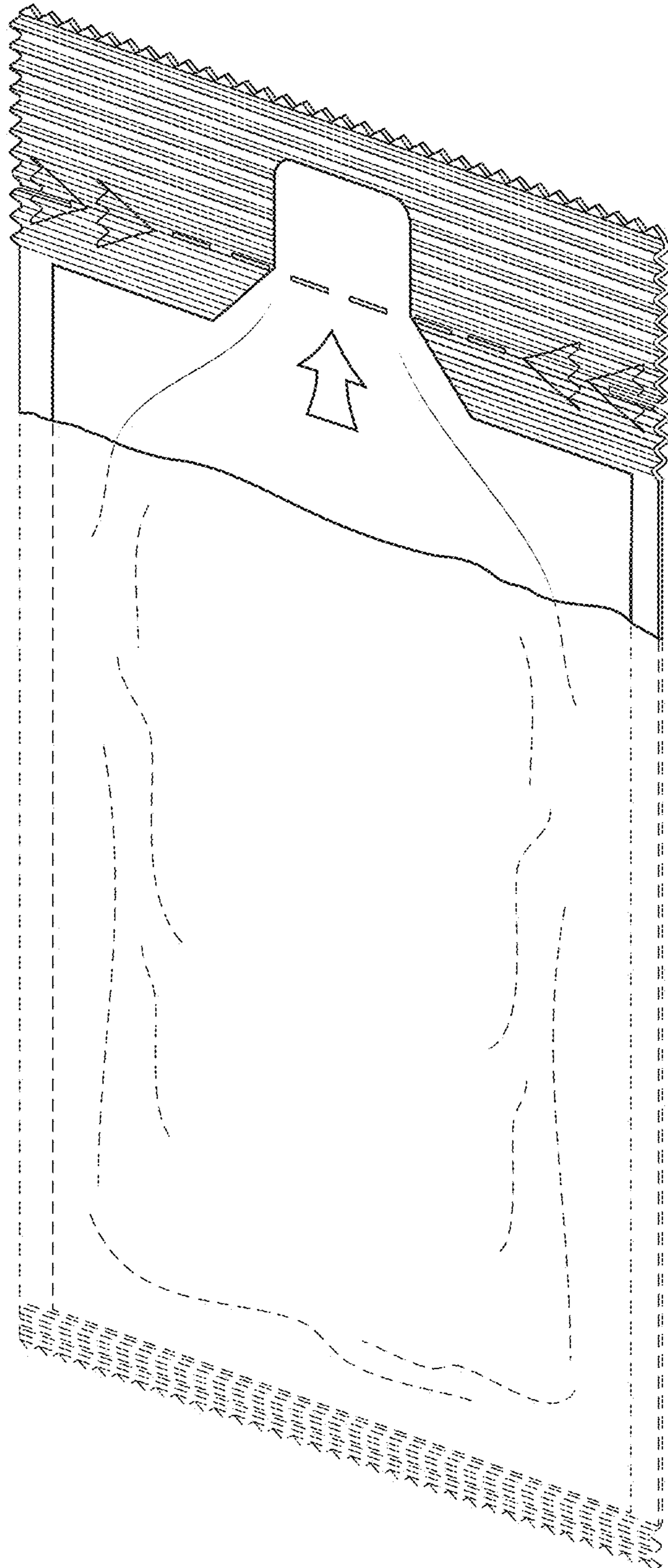

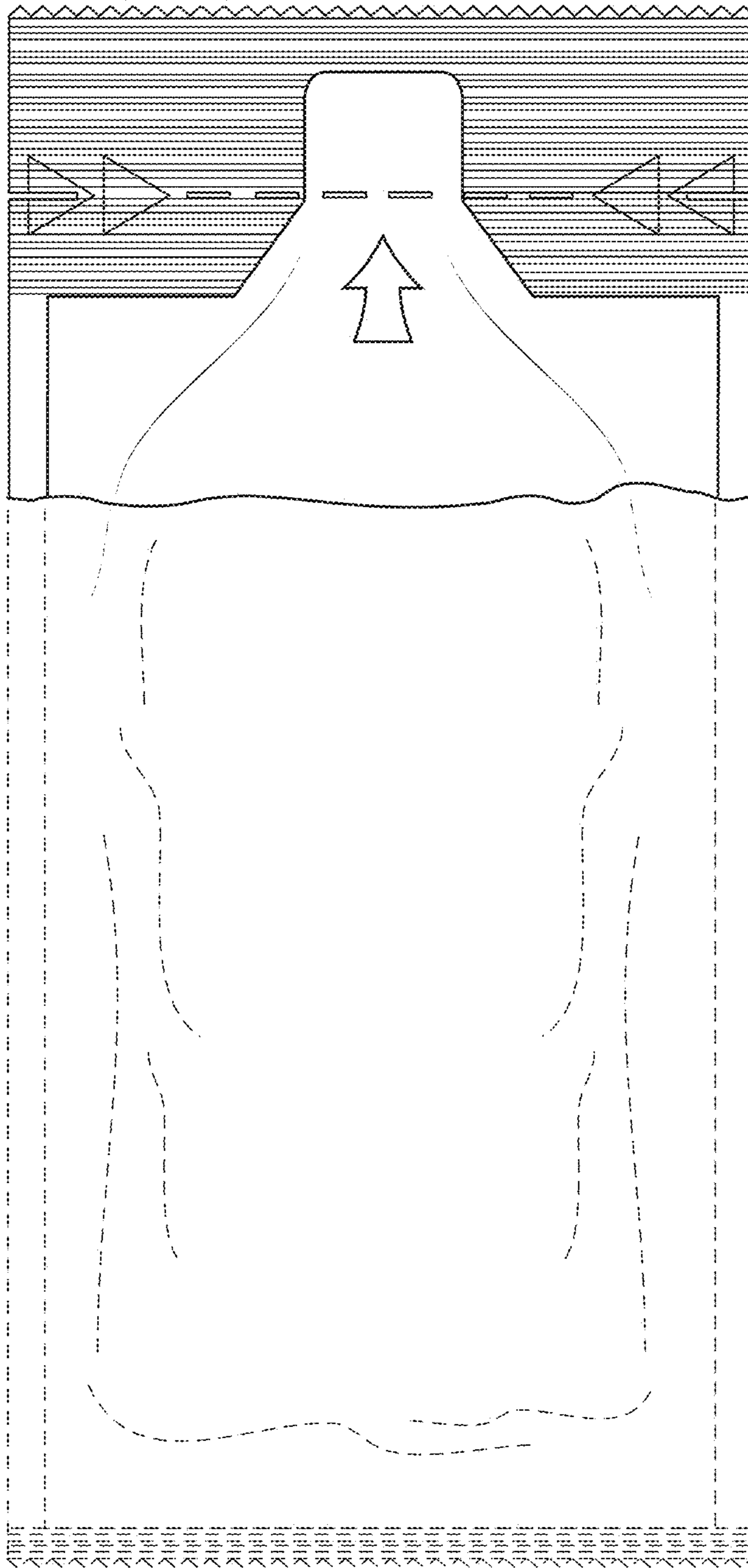

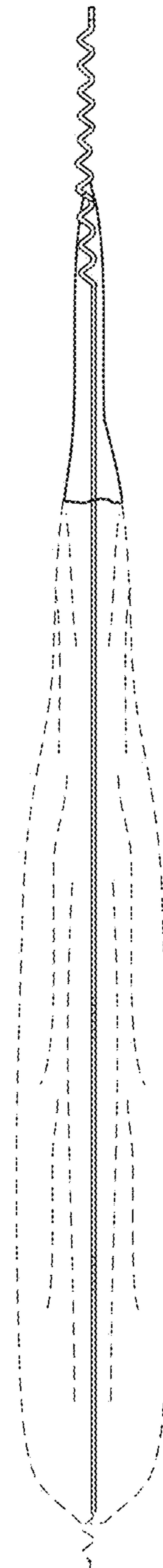

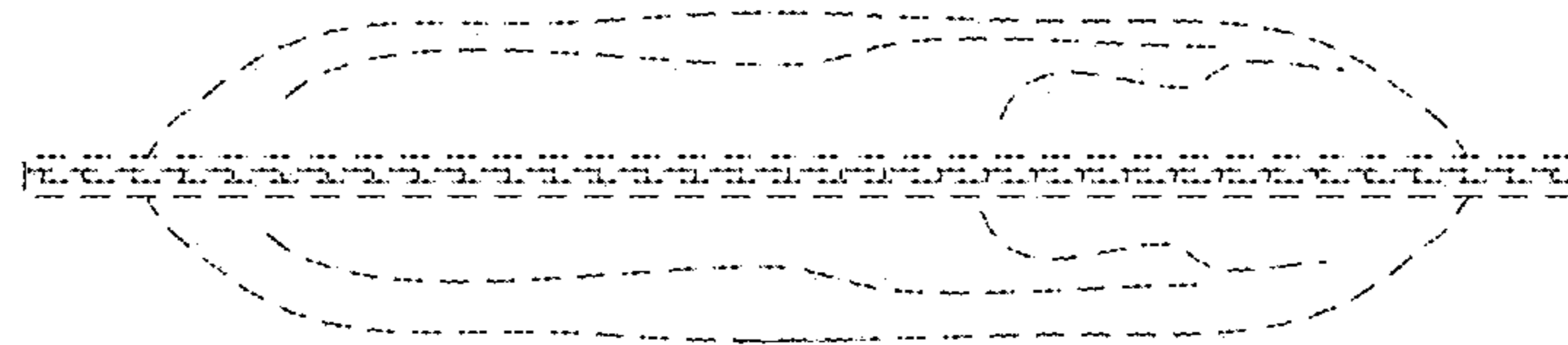
