The ornamental design for an aglet for clothing and bracelets, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an aglet for clothing and bracelets showing my new design;
FIG. 2 is a front view thereof;

FIG. 4 is a right side view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is an over top view thereof; and,

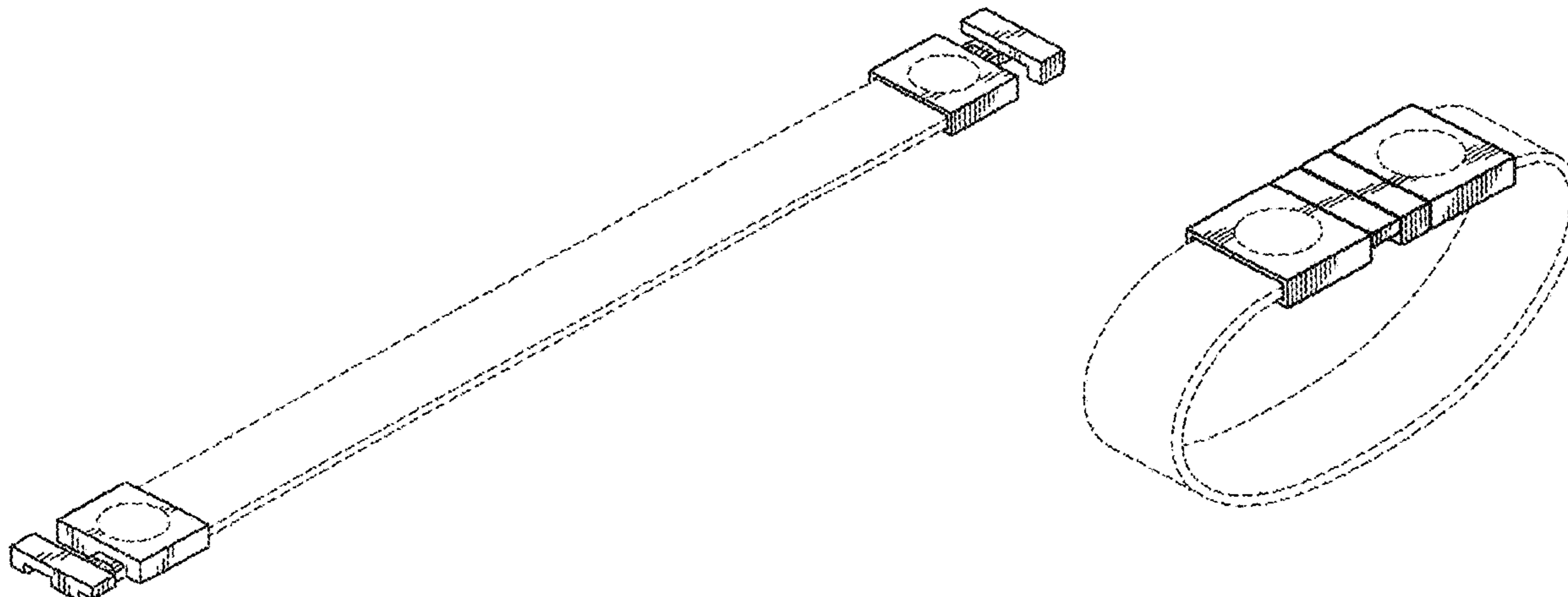

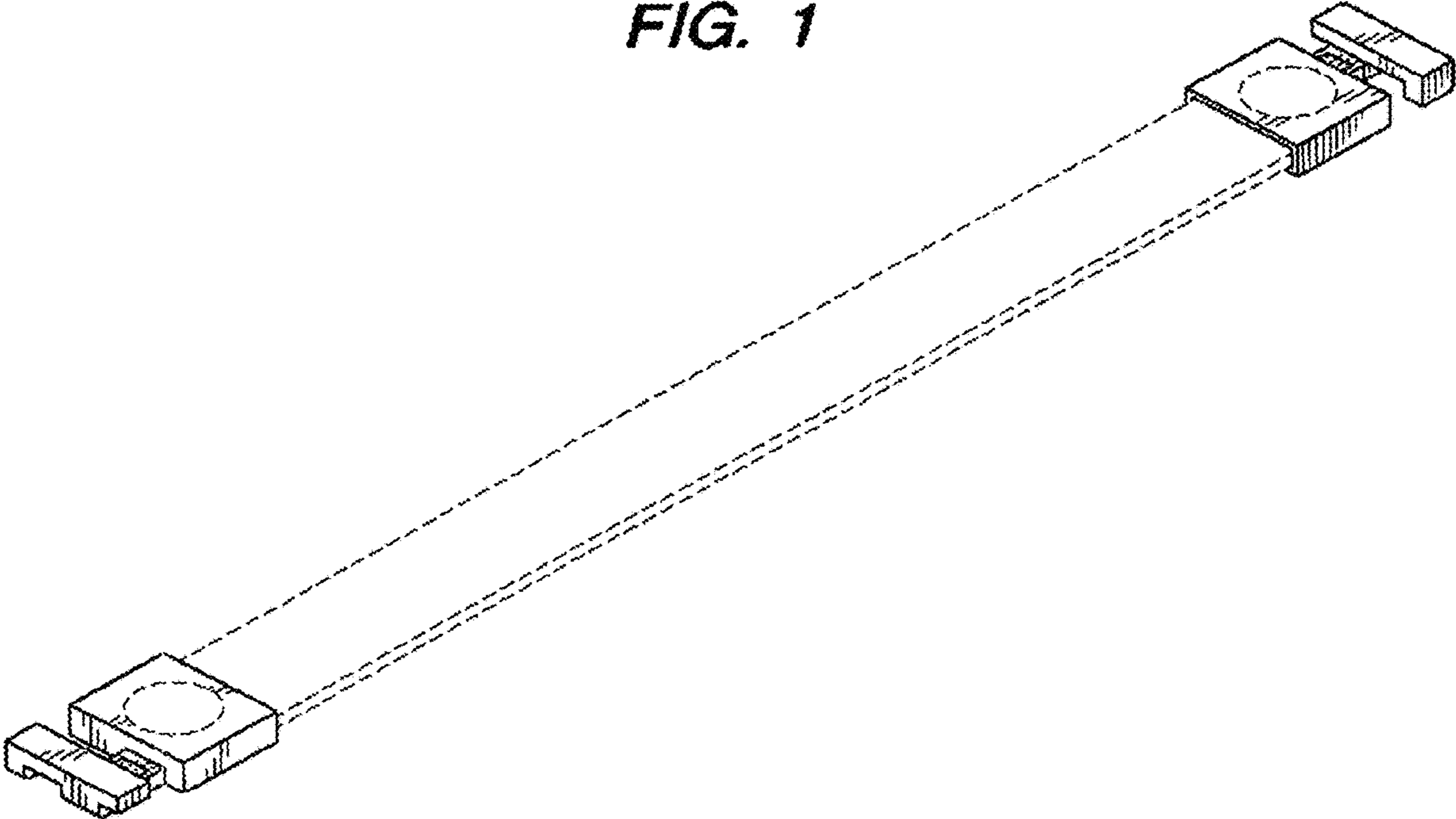

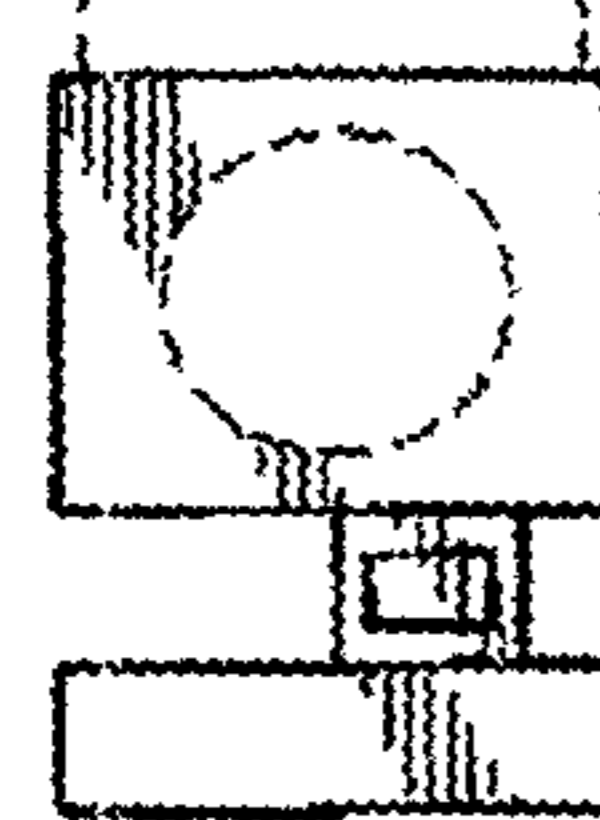
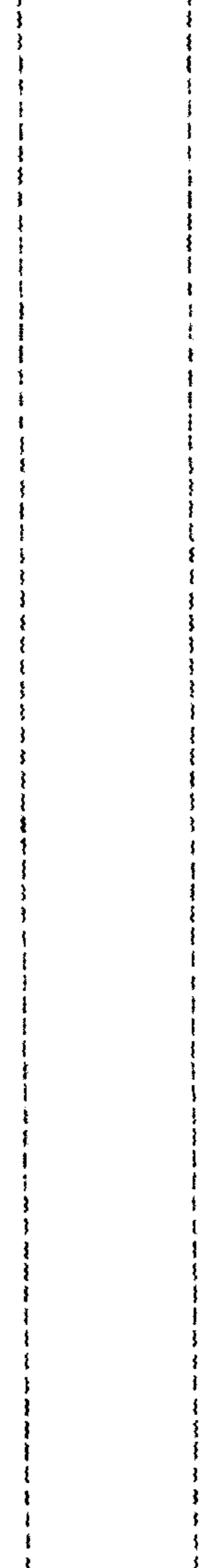
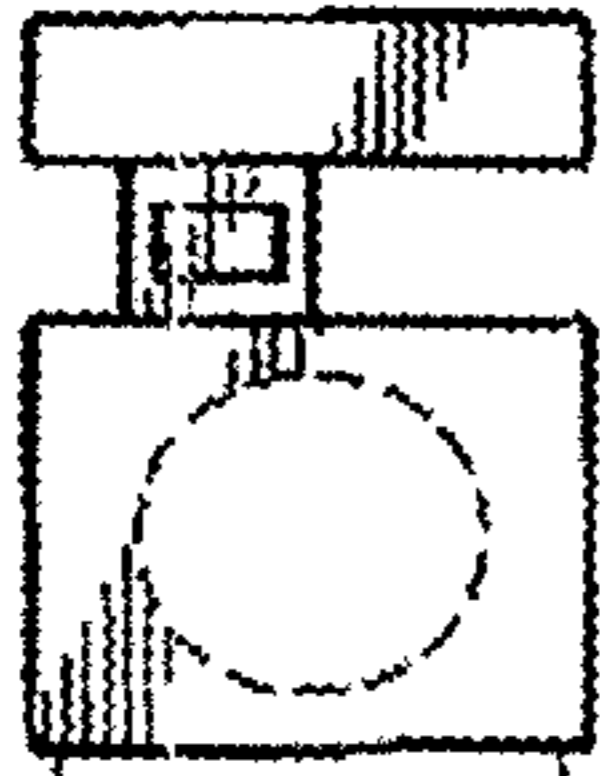

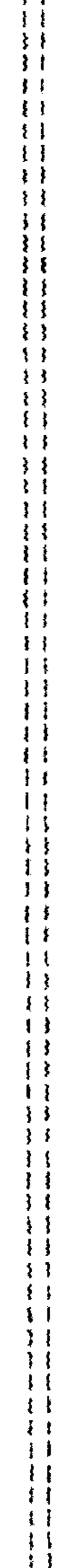

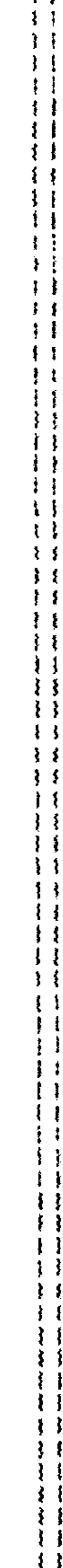

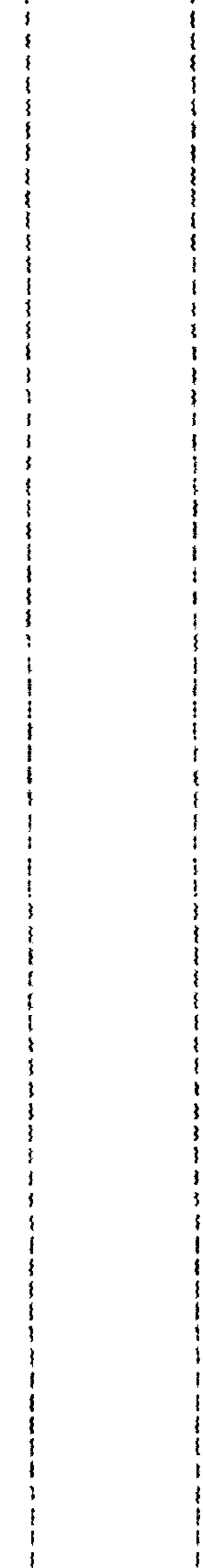
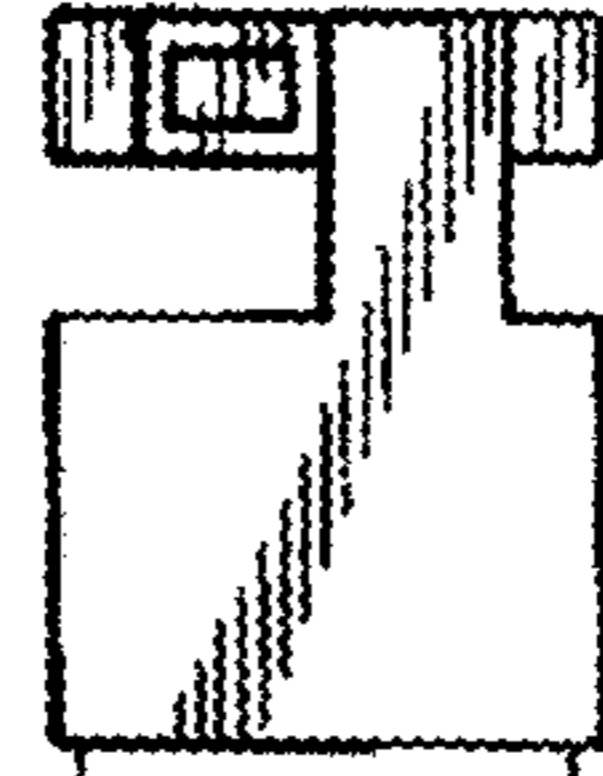
