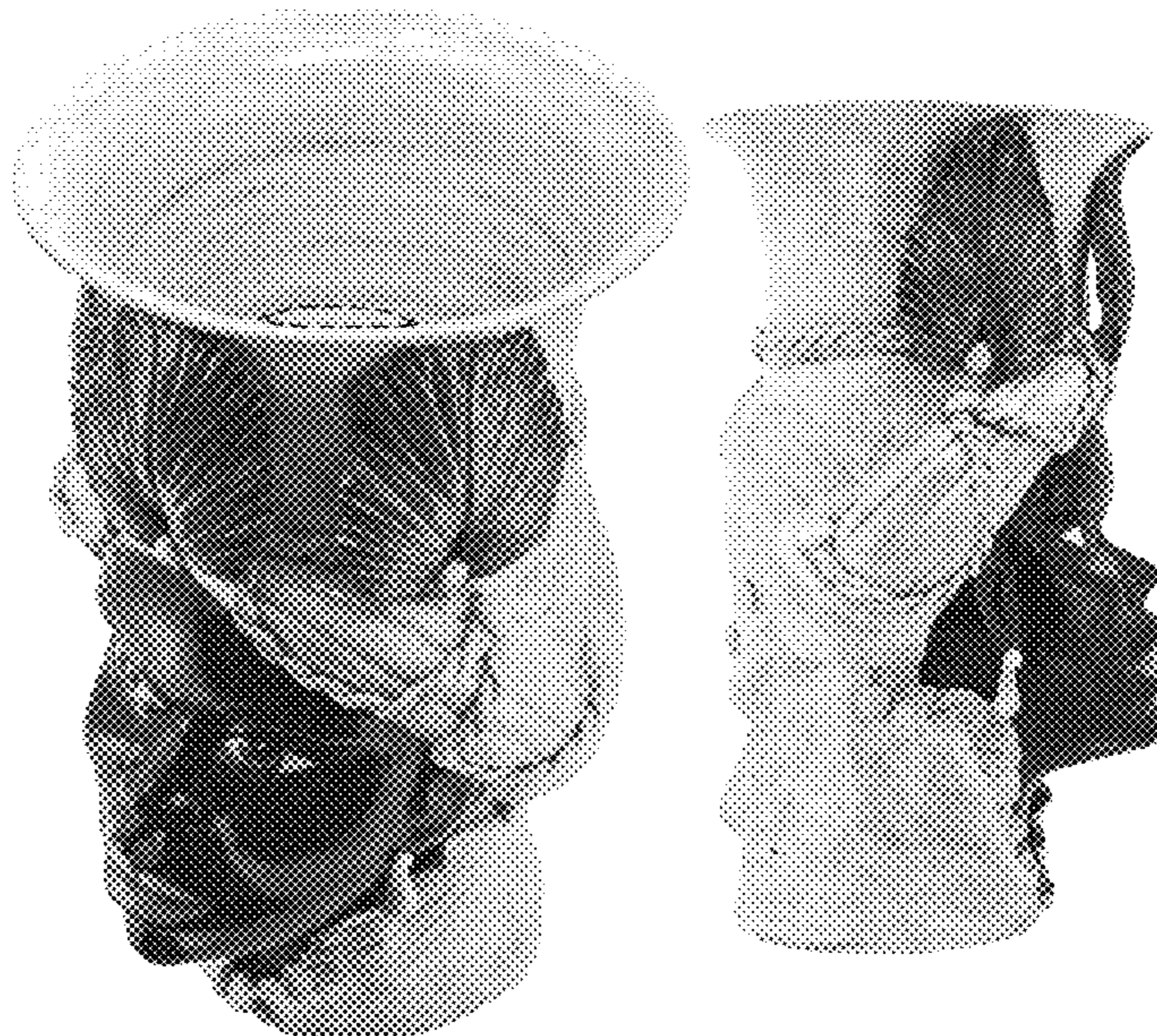
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a vase showing my new design;
FIG. 2 is a front perspective view from the right thereof;
FIG. 3 is a perspective view from the back thereof;
FIG. 4 is a back view thereof,
FIG. 5 is a view from the left thereof;
FIG. 6 is a top perspective view thereof; and,
