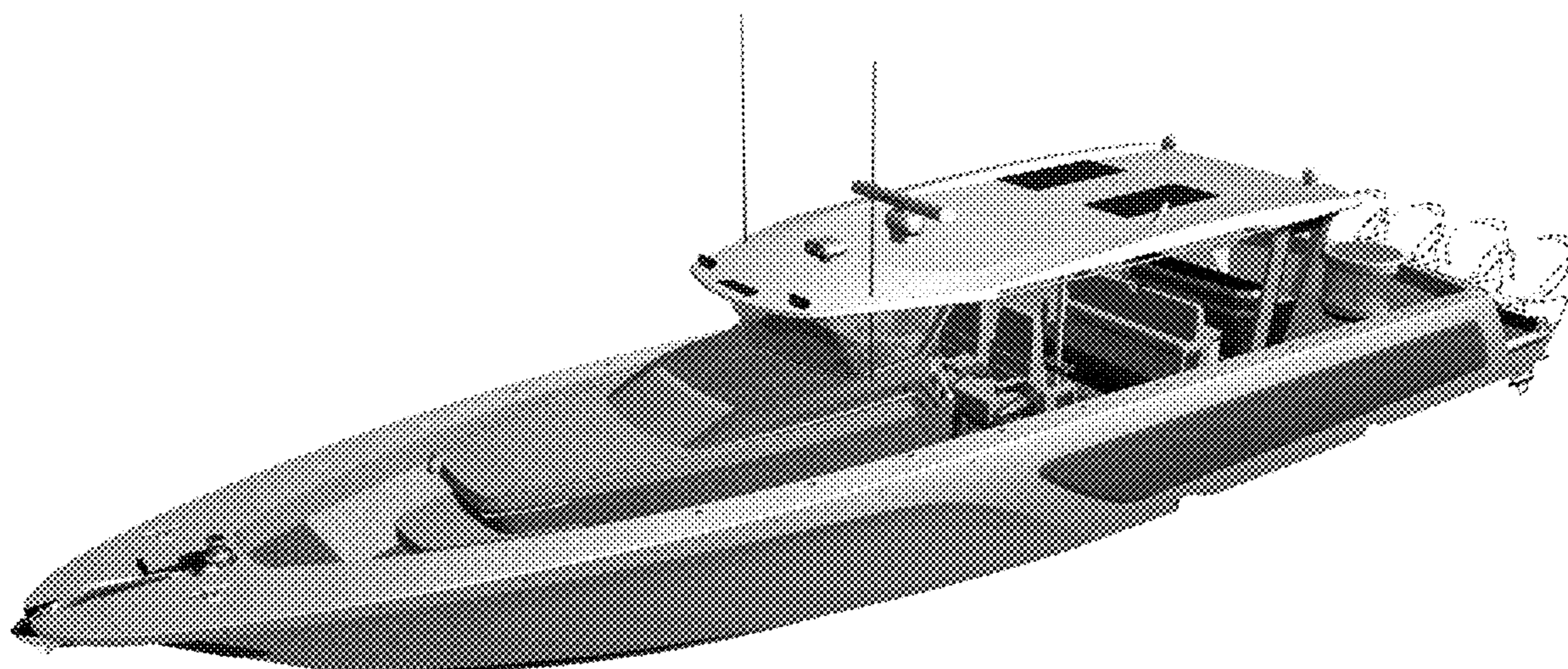

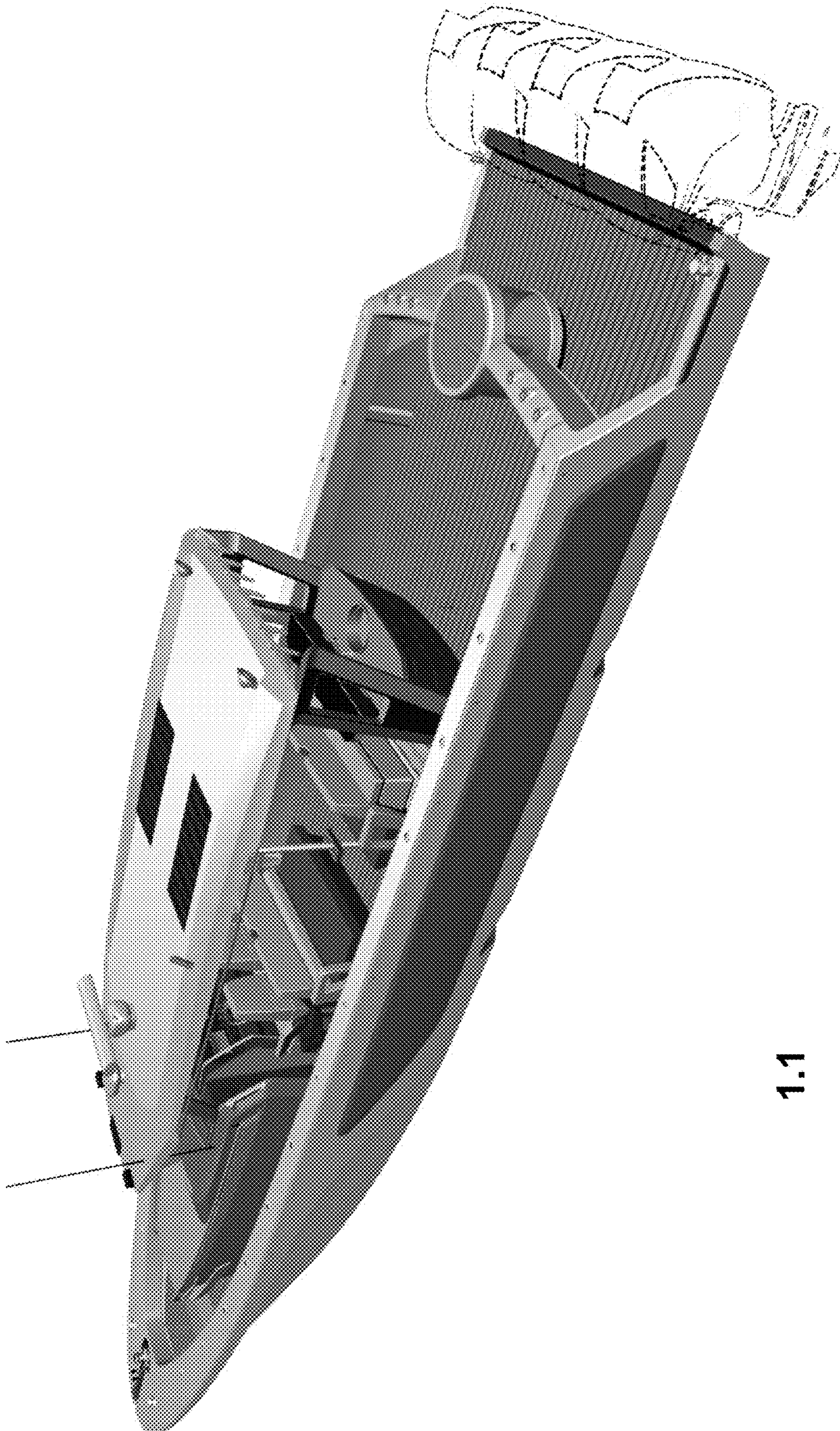
The ornamental design for a motor boat, as shown and described.

DESCRIPTION

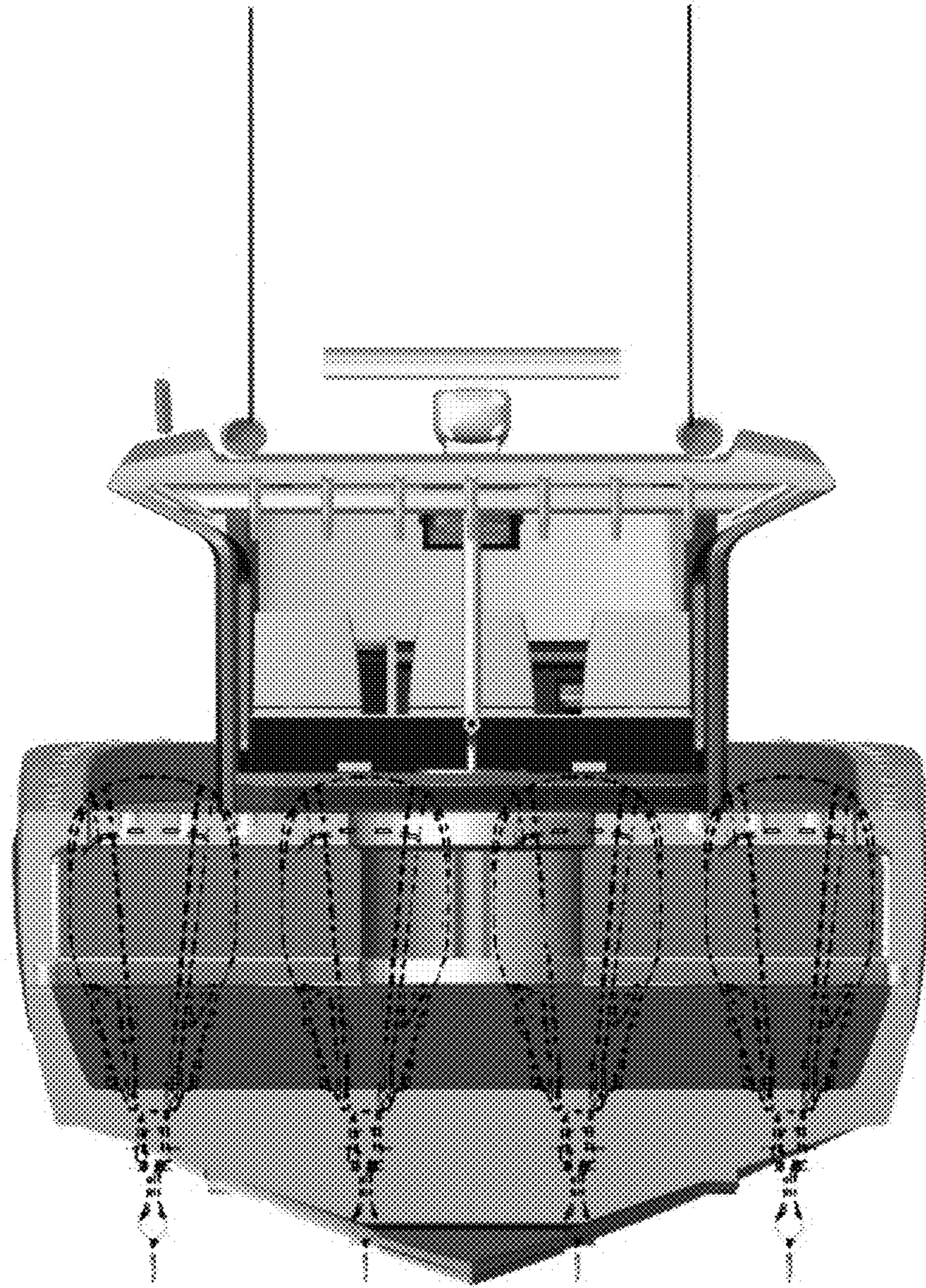
Fig. 1.1 is a first perspective view of a motor boat according to our new design;

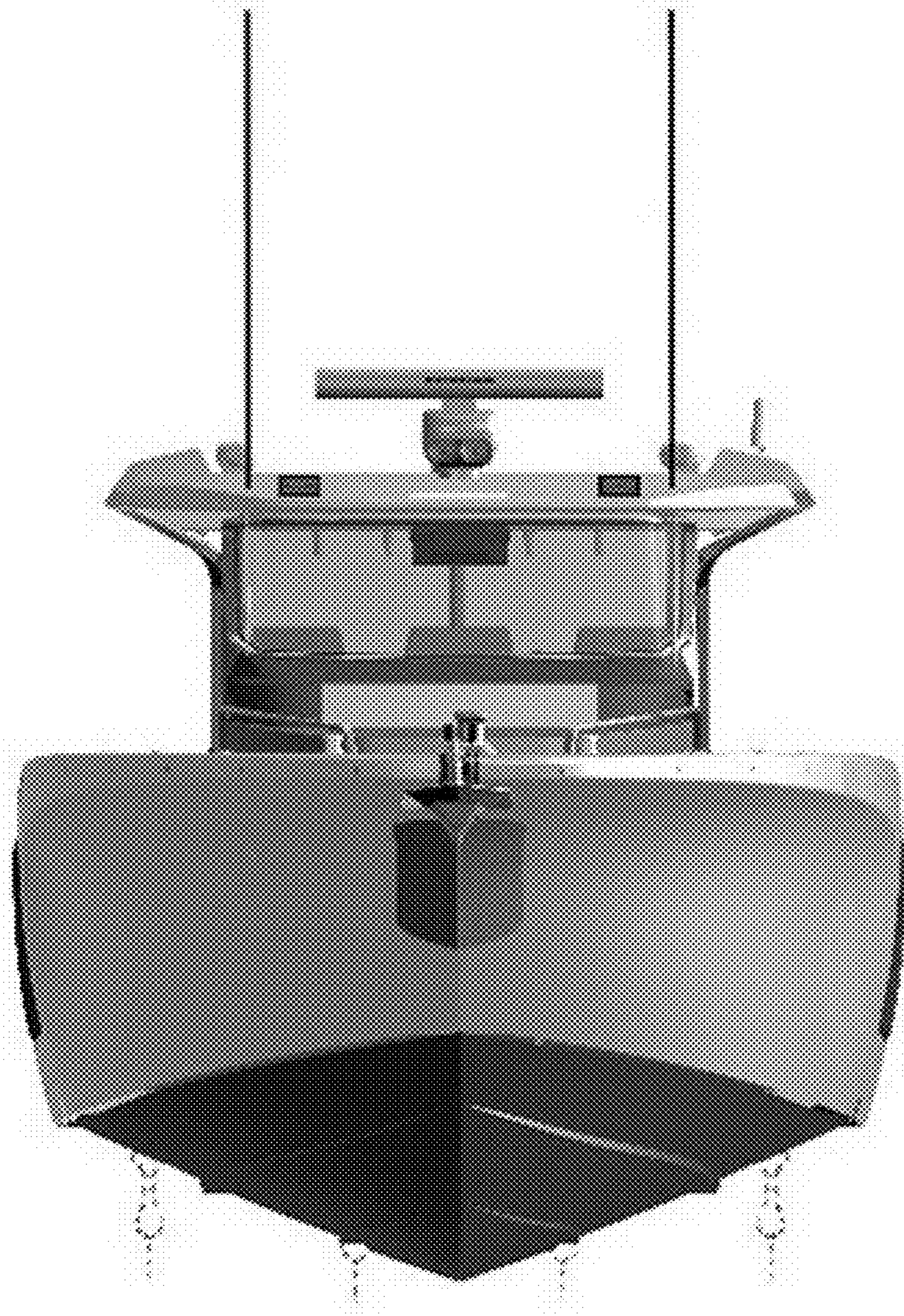

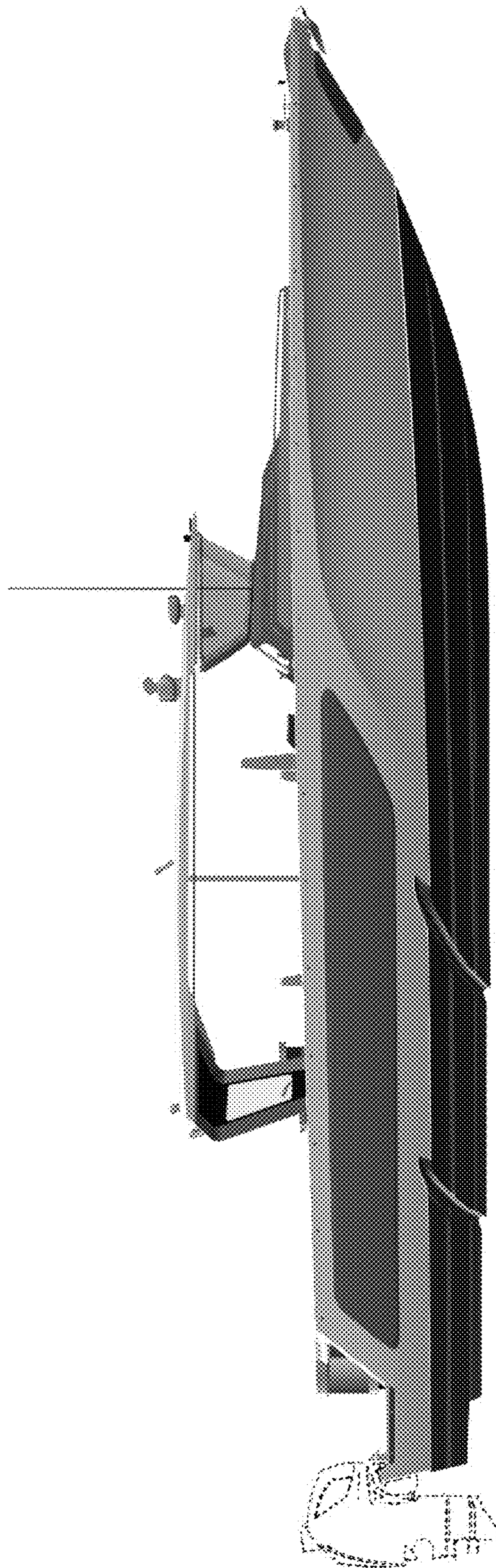

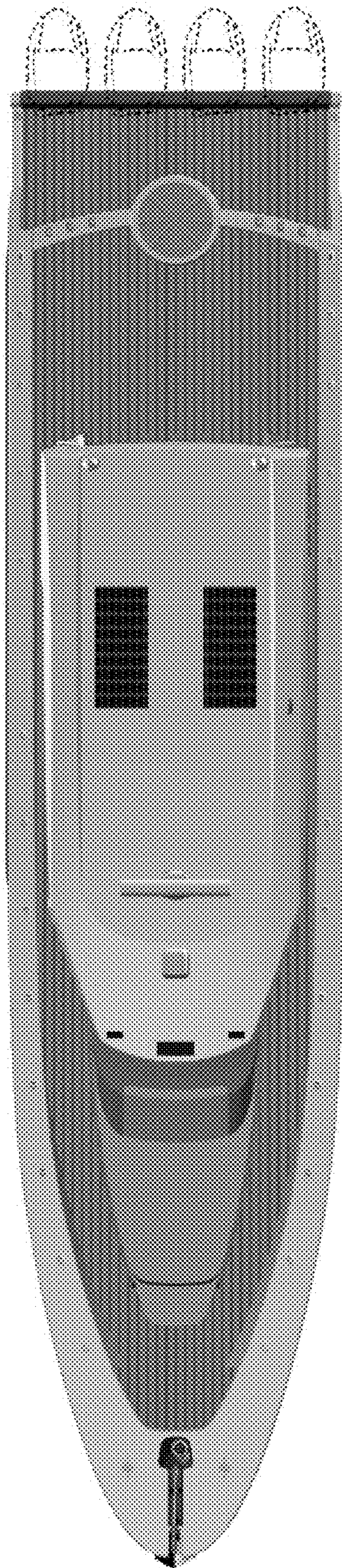

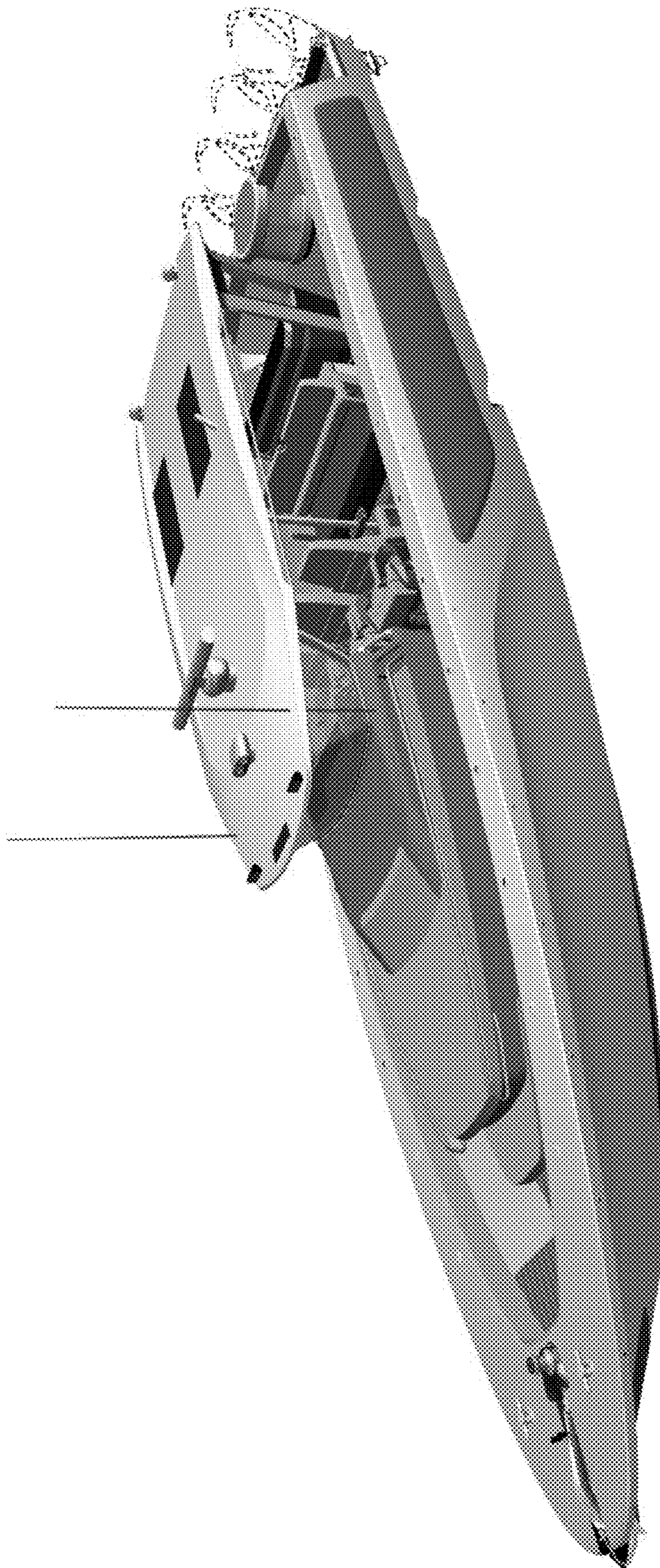
