DESCRIPTION

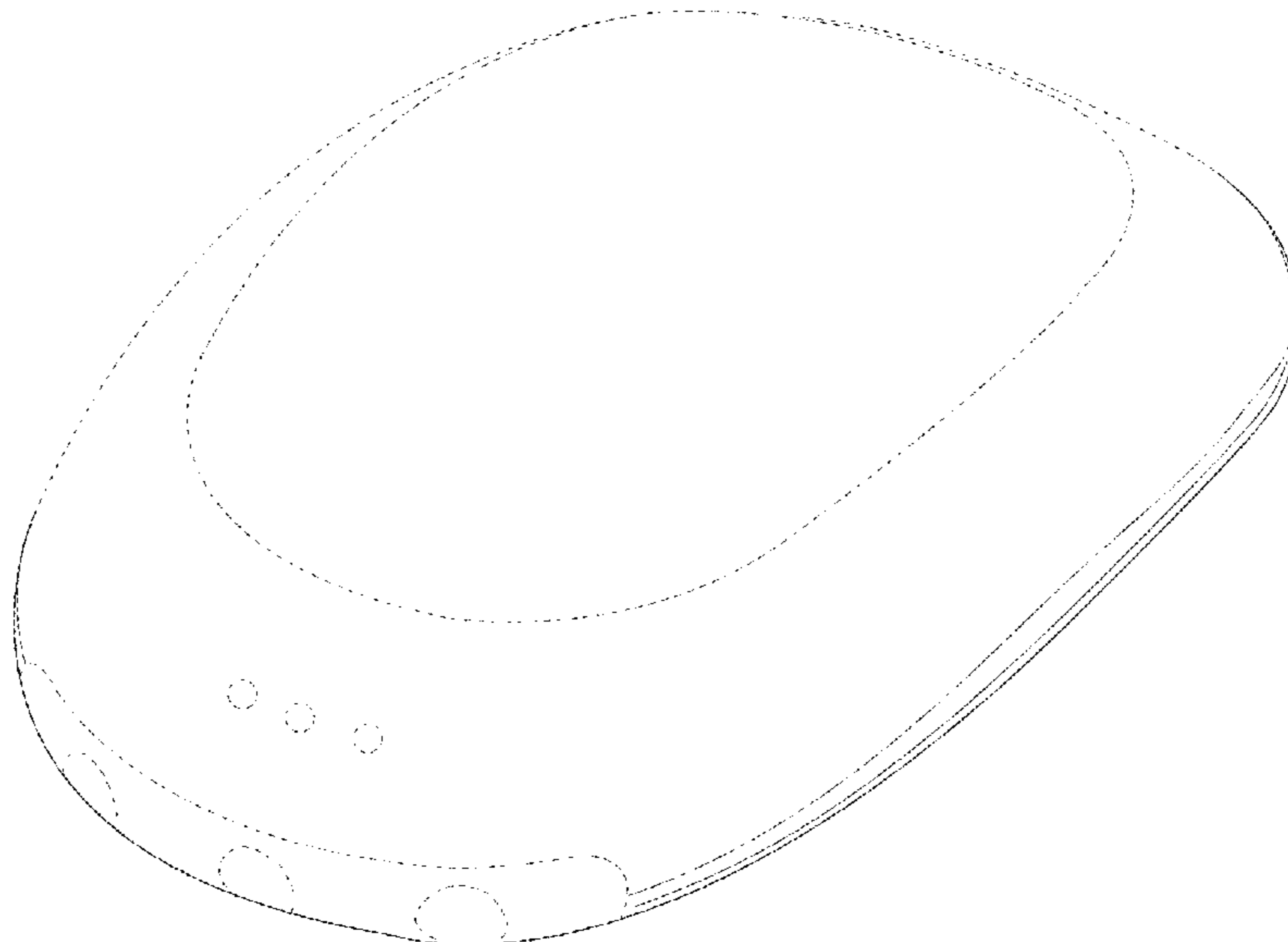
FIG. 1 is a perspective view of an information terminal showing our new design;

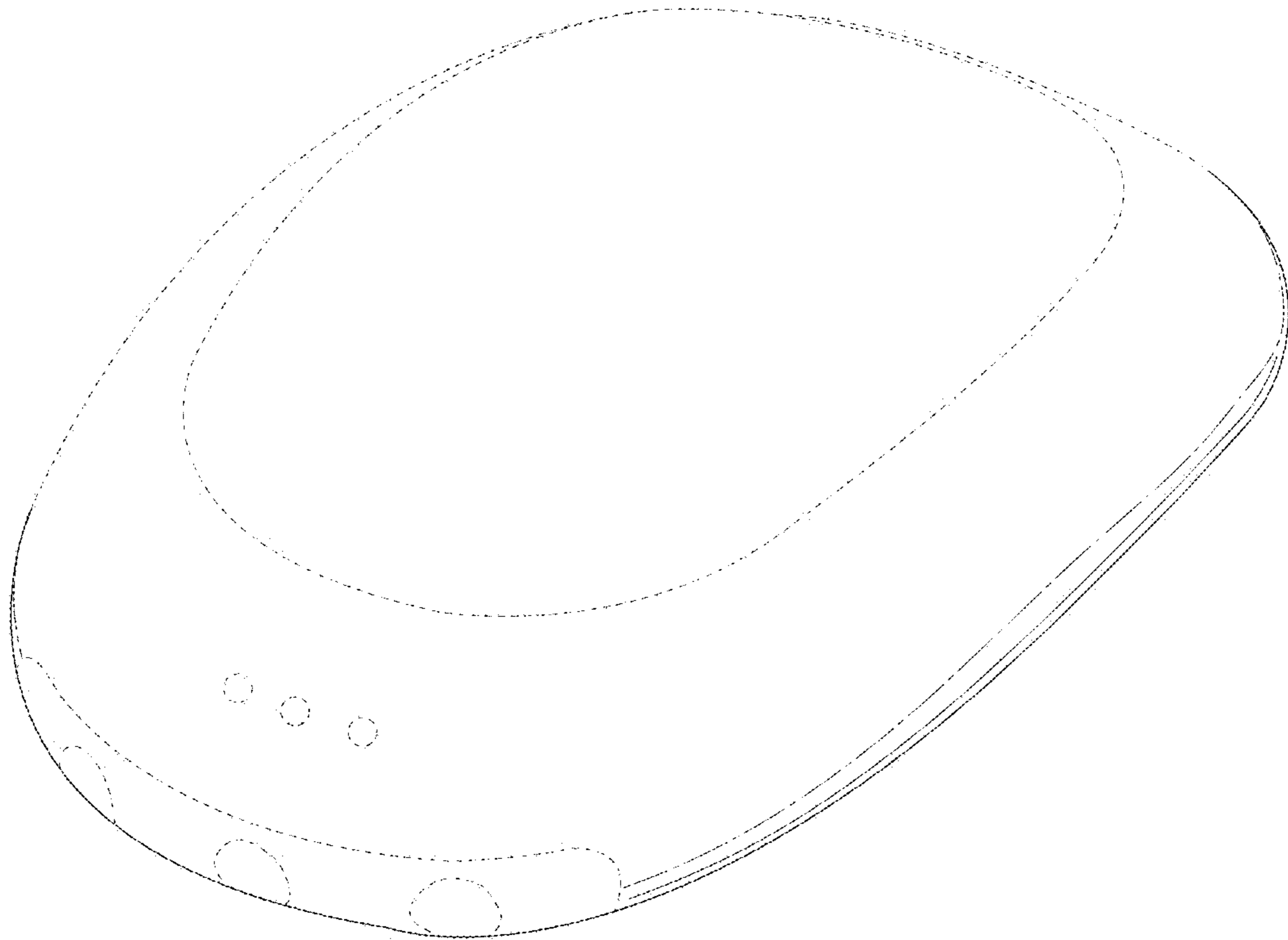

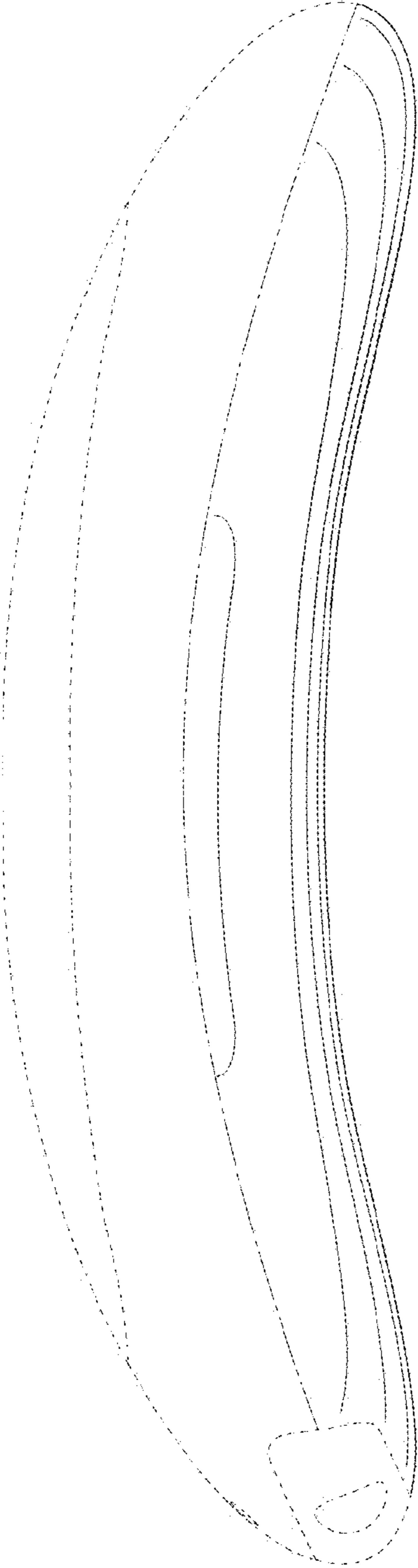

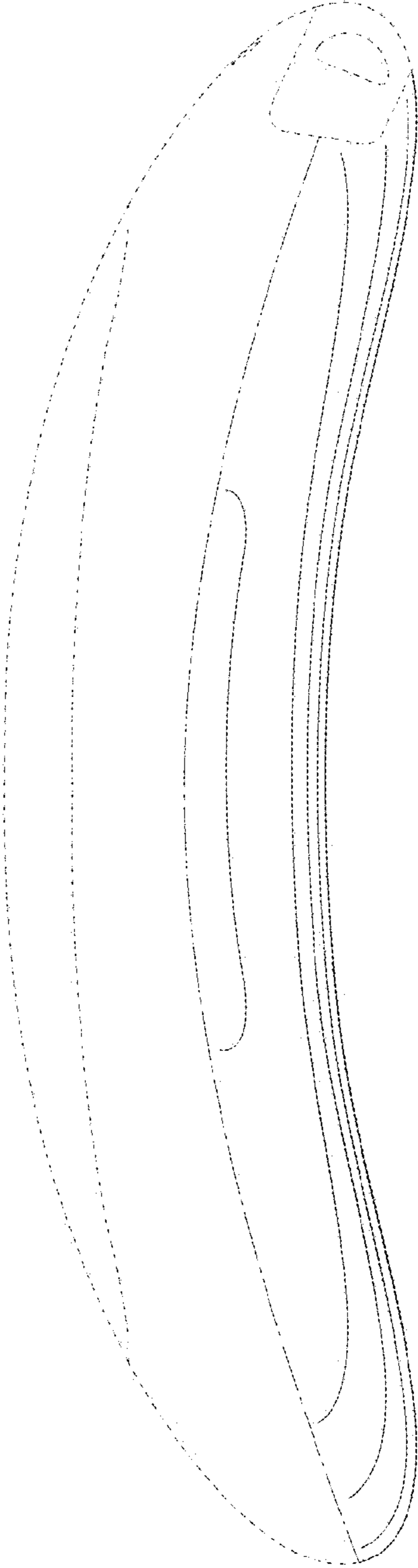

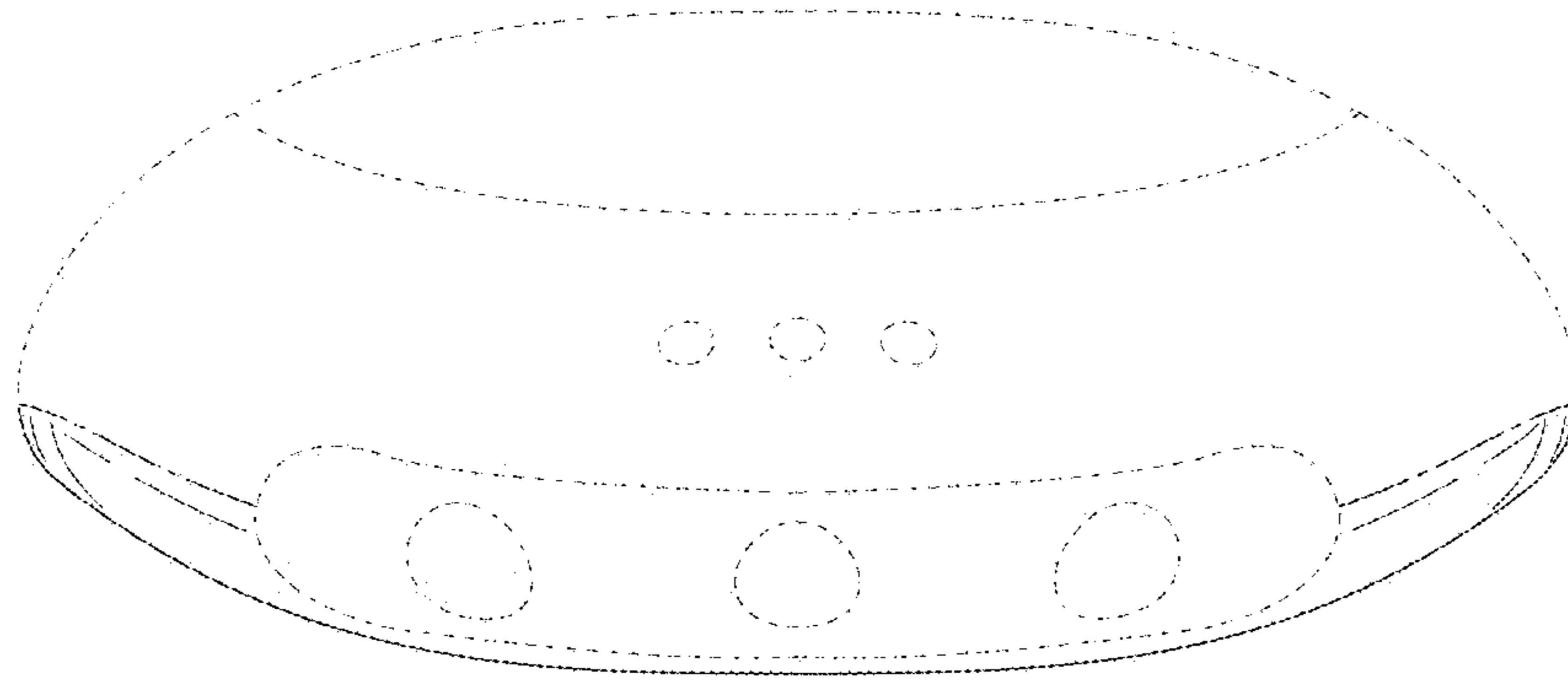

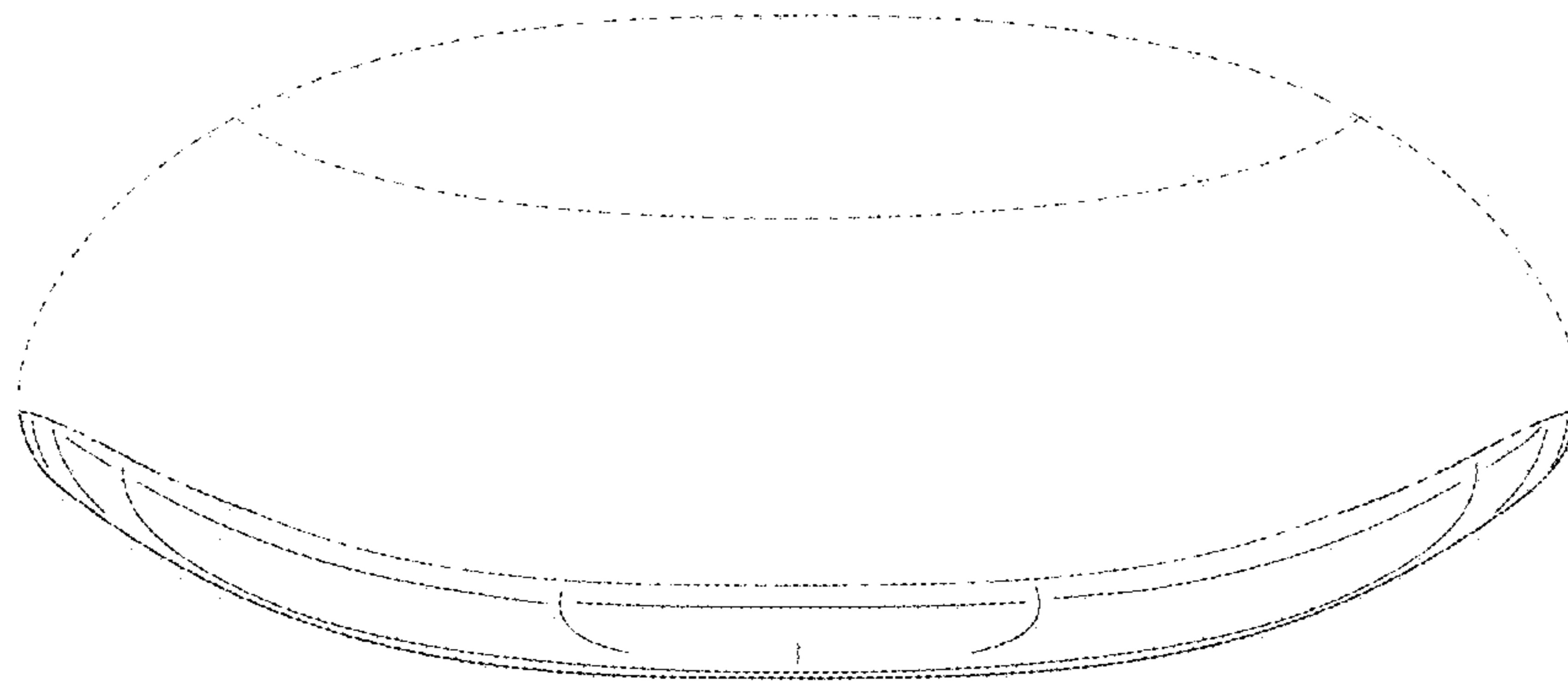

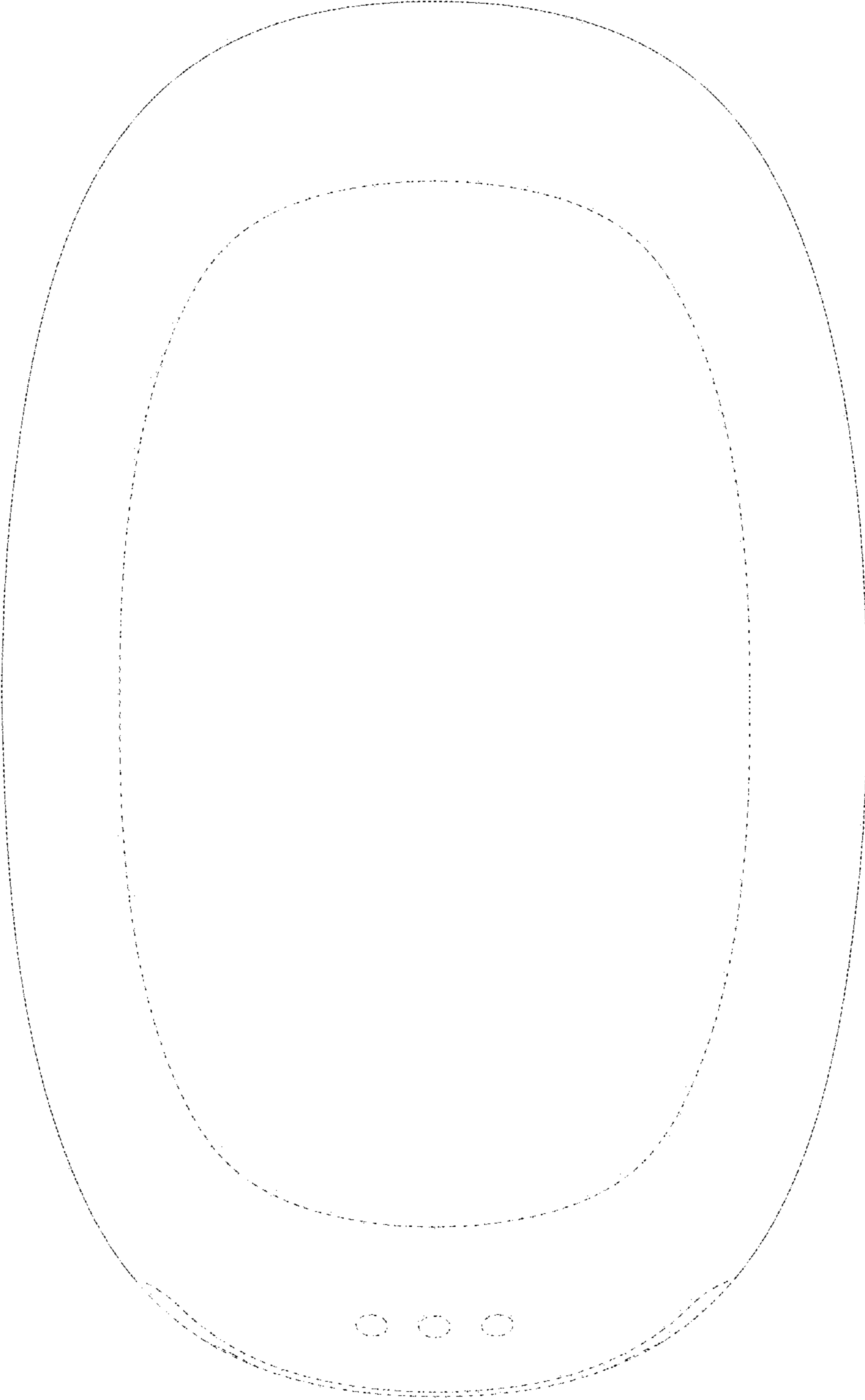
