FIG. 4 is a back plan view thereof, the side being the side opposite of the side shown in FIG. 3.

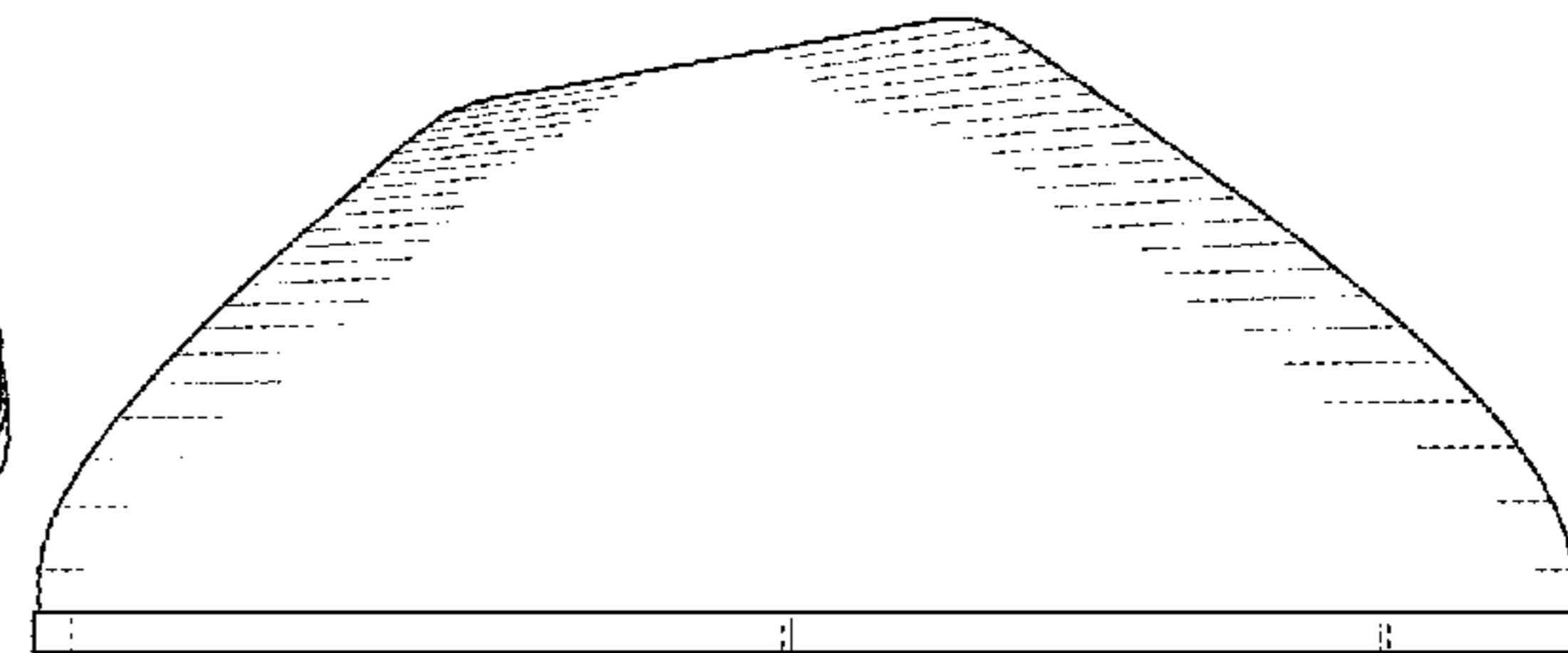
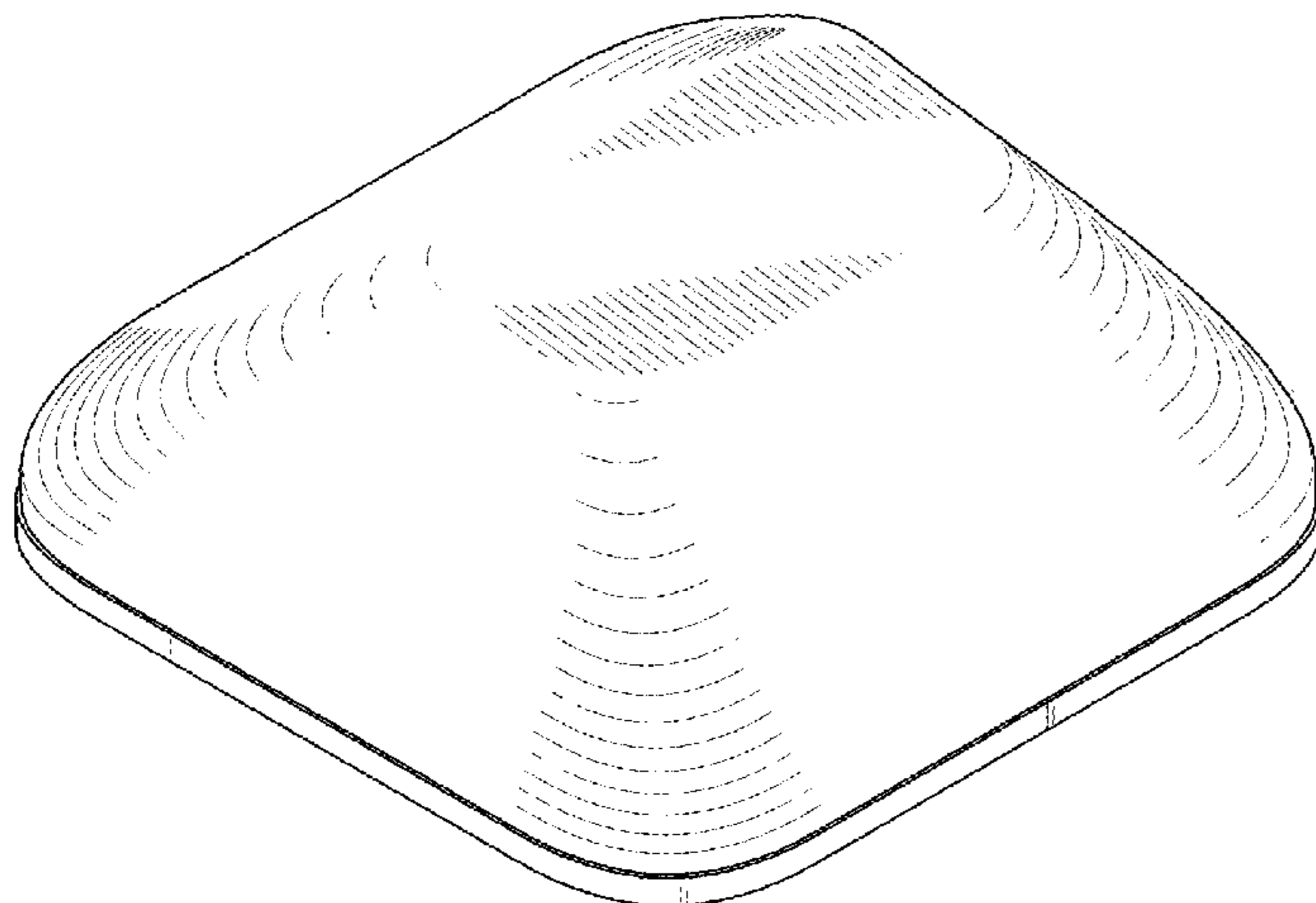
FIG. 5 is a side plan view thereof.

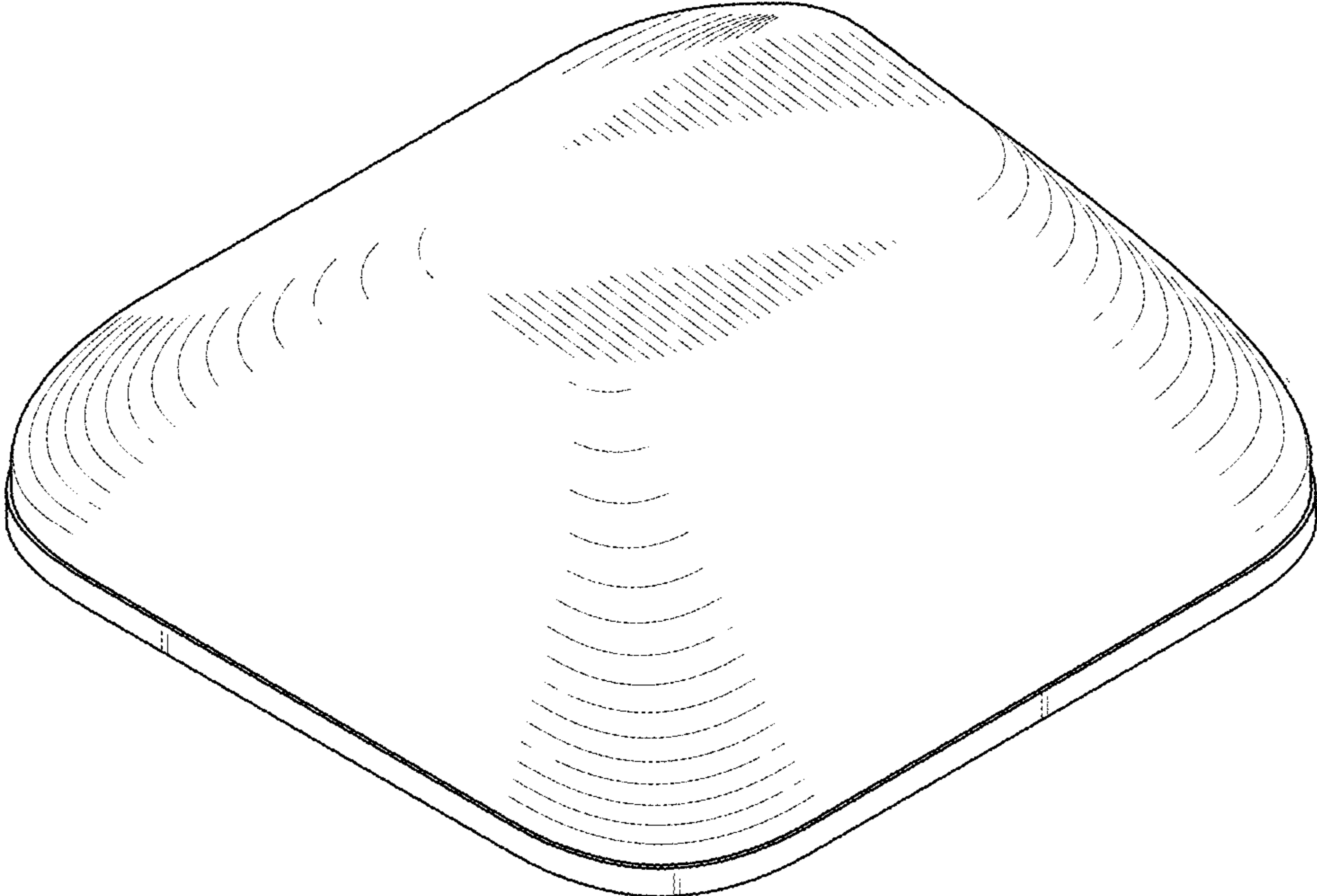

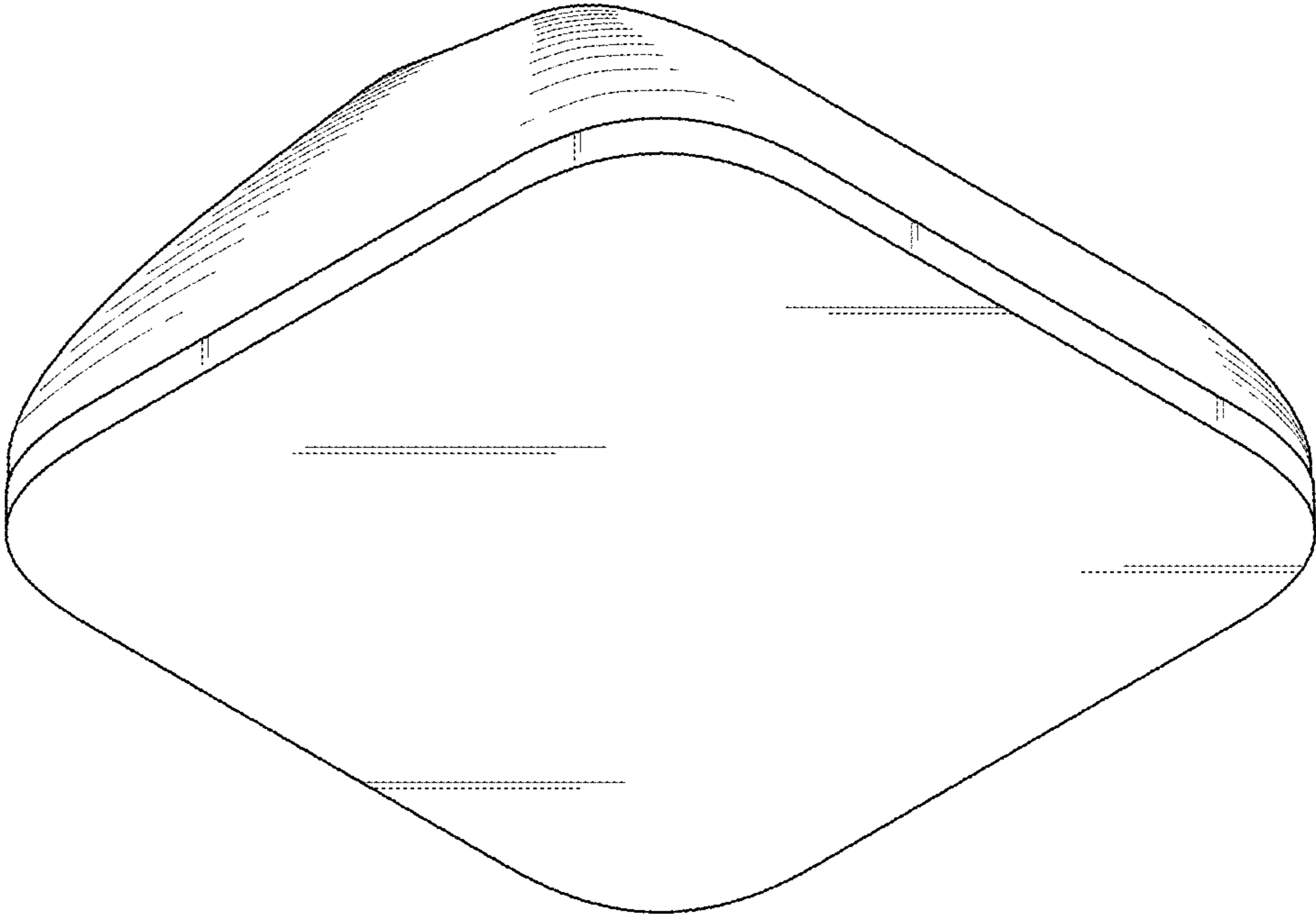

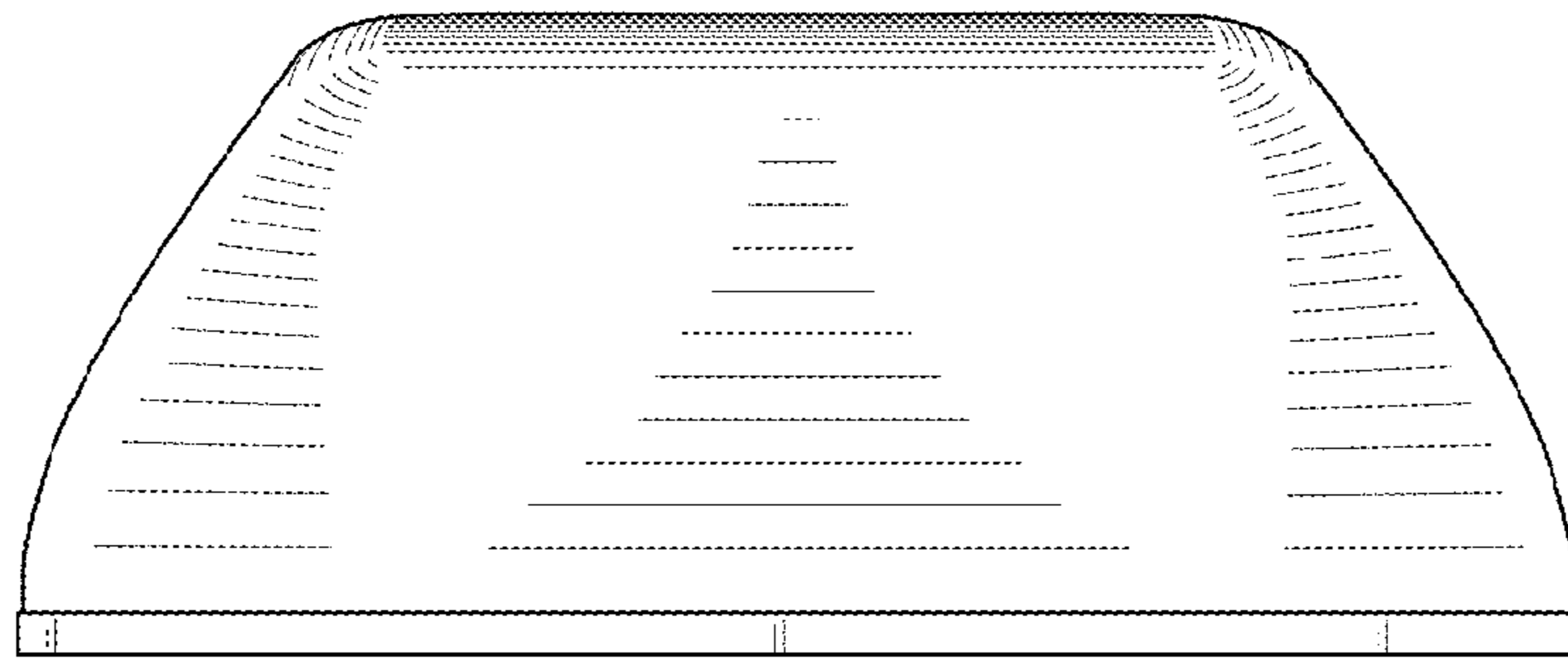

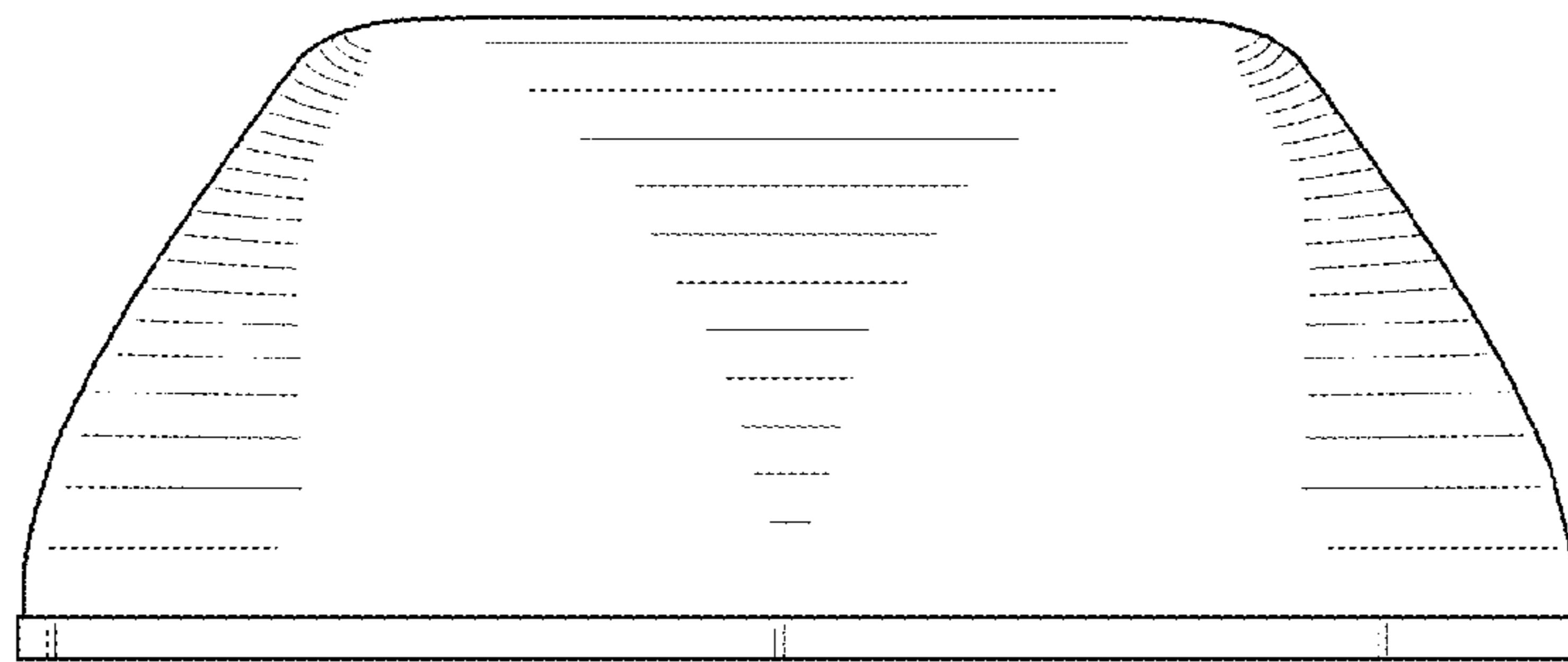

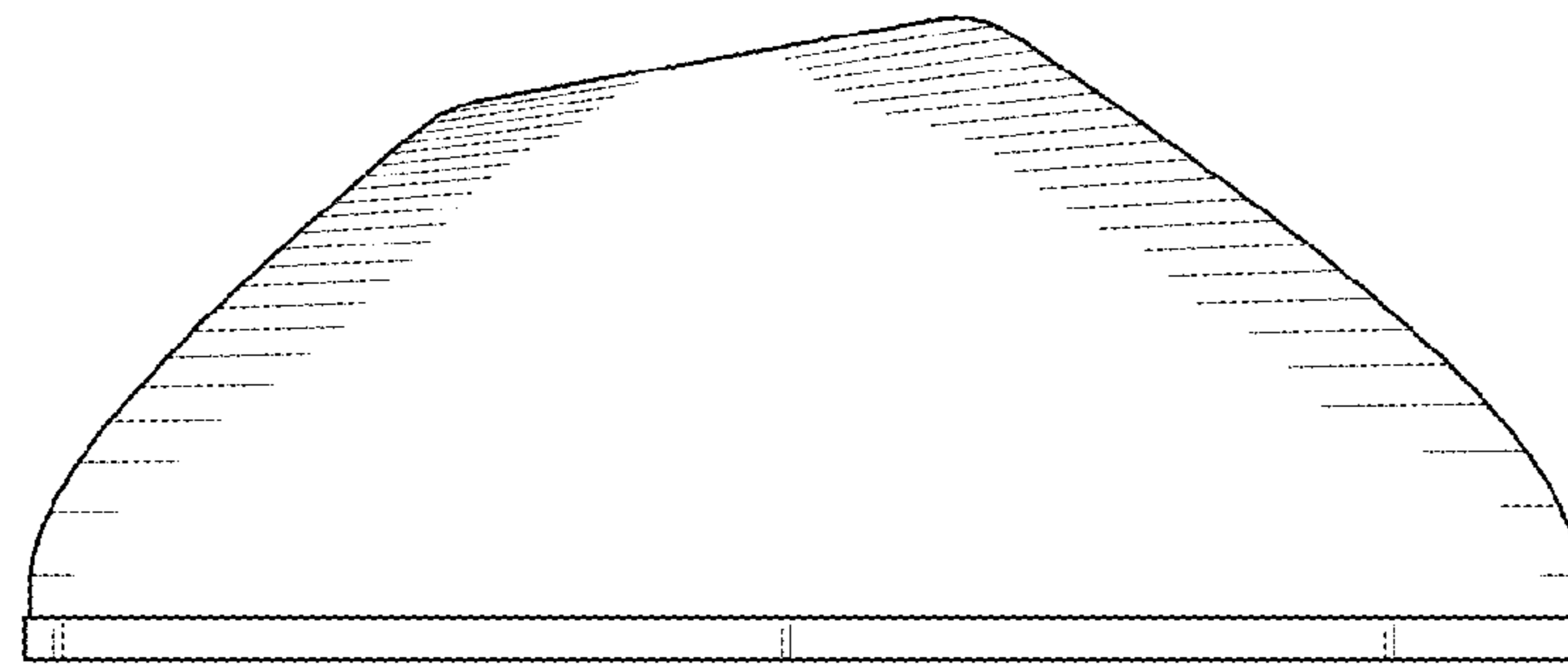

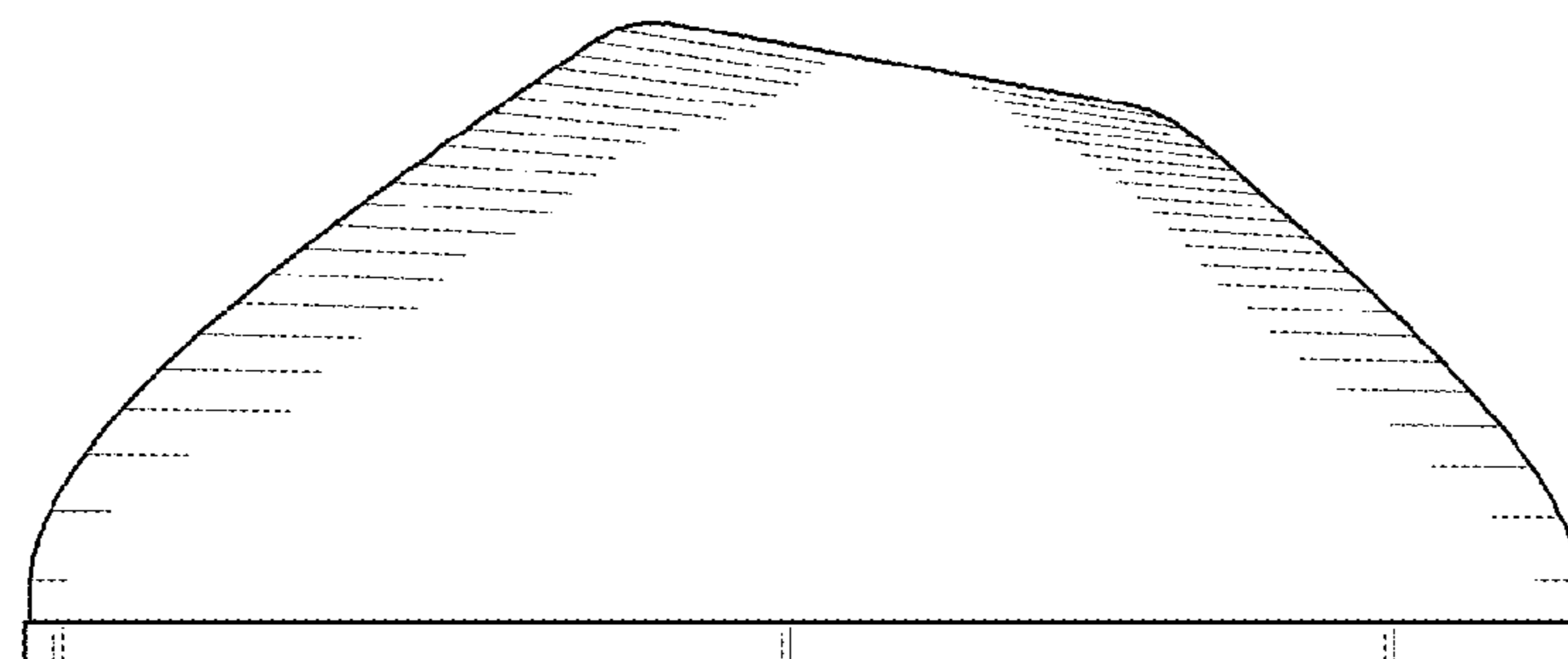

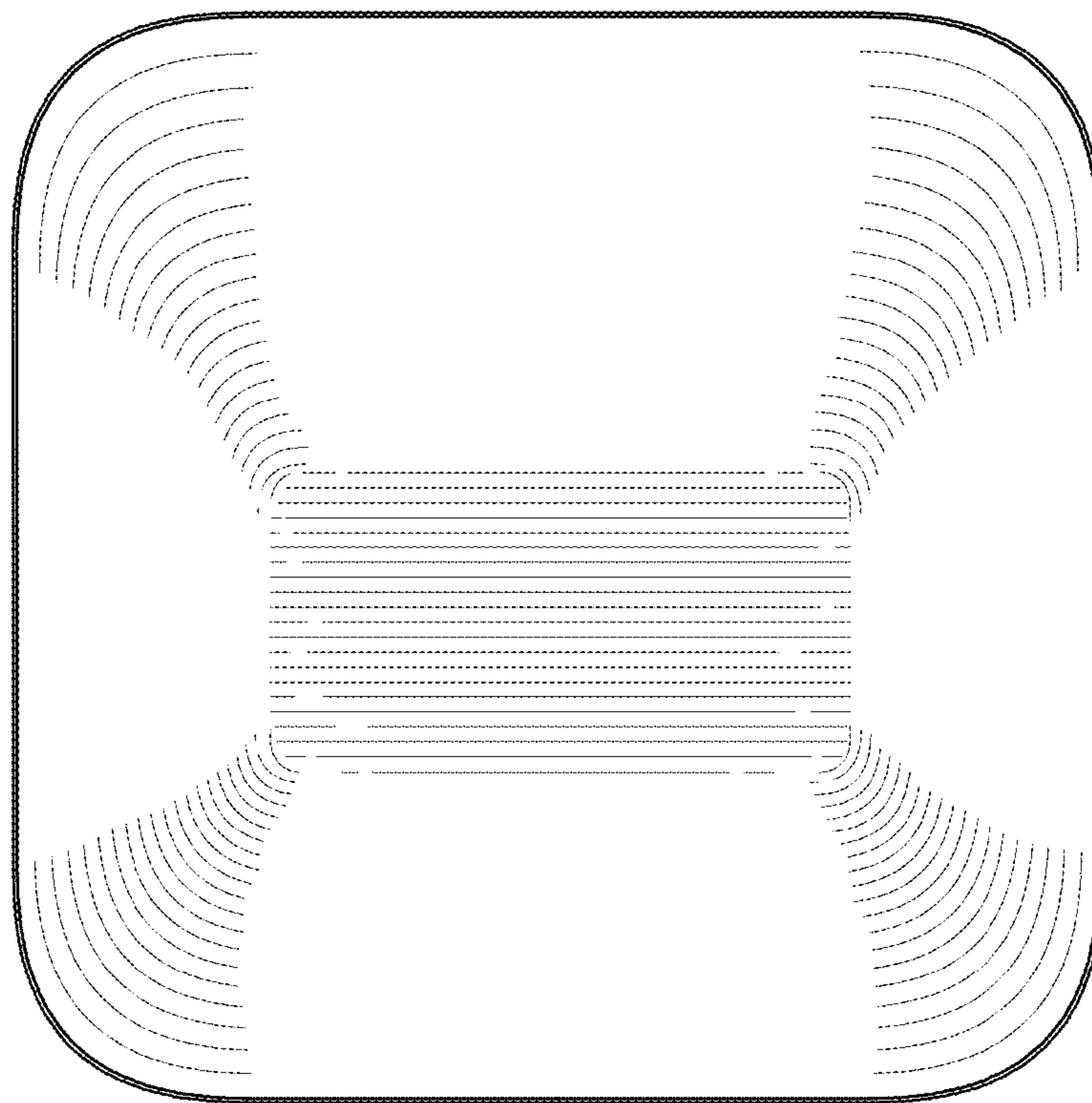

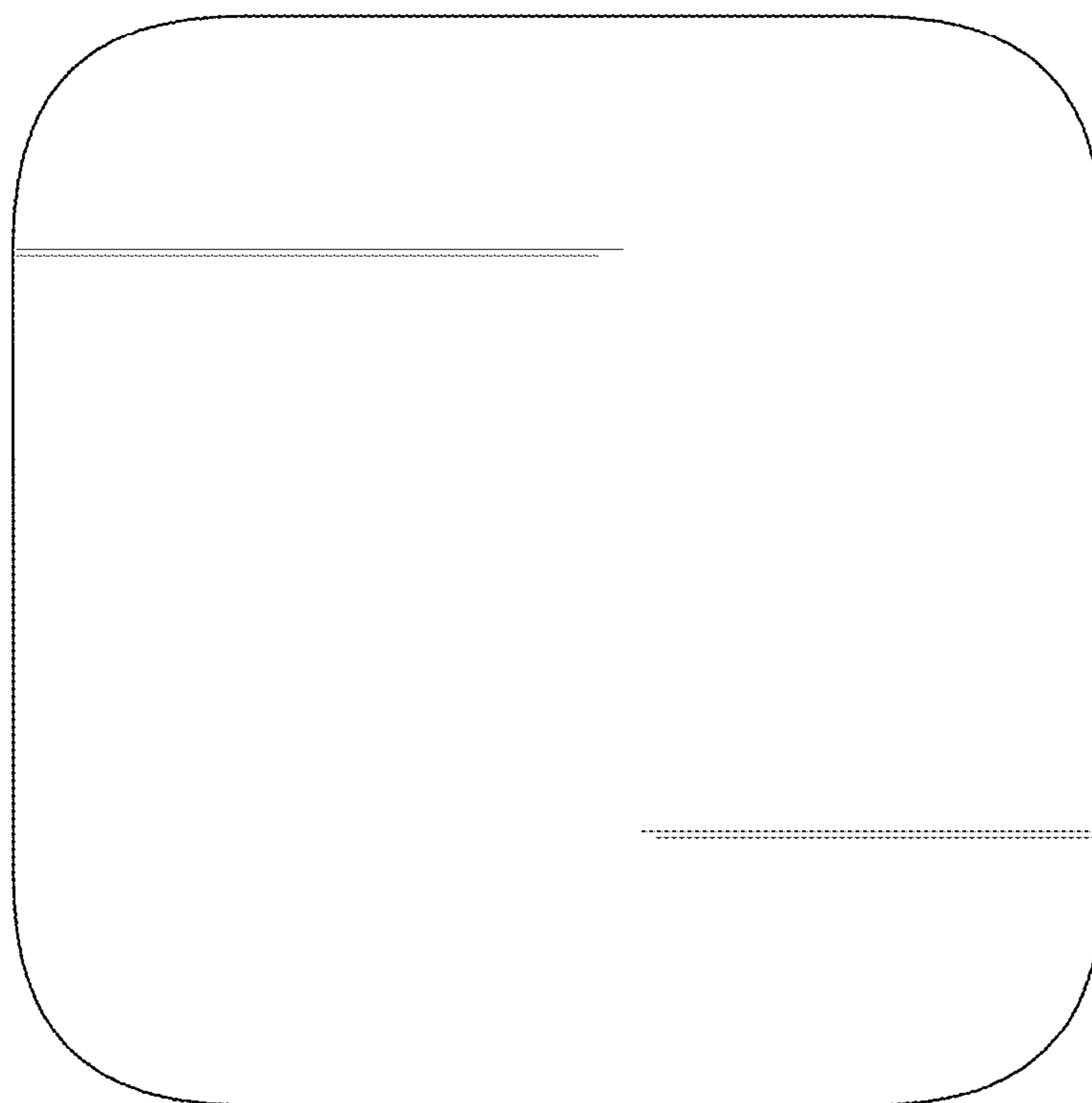
