DESCRIPTION

FIG. 4 is a left side view of the snowshoe of FIG. 1; and

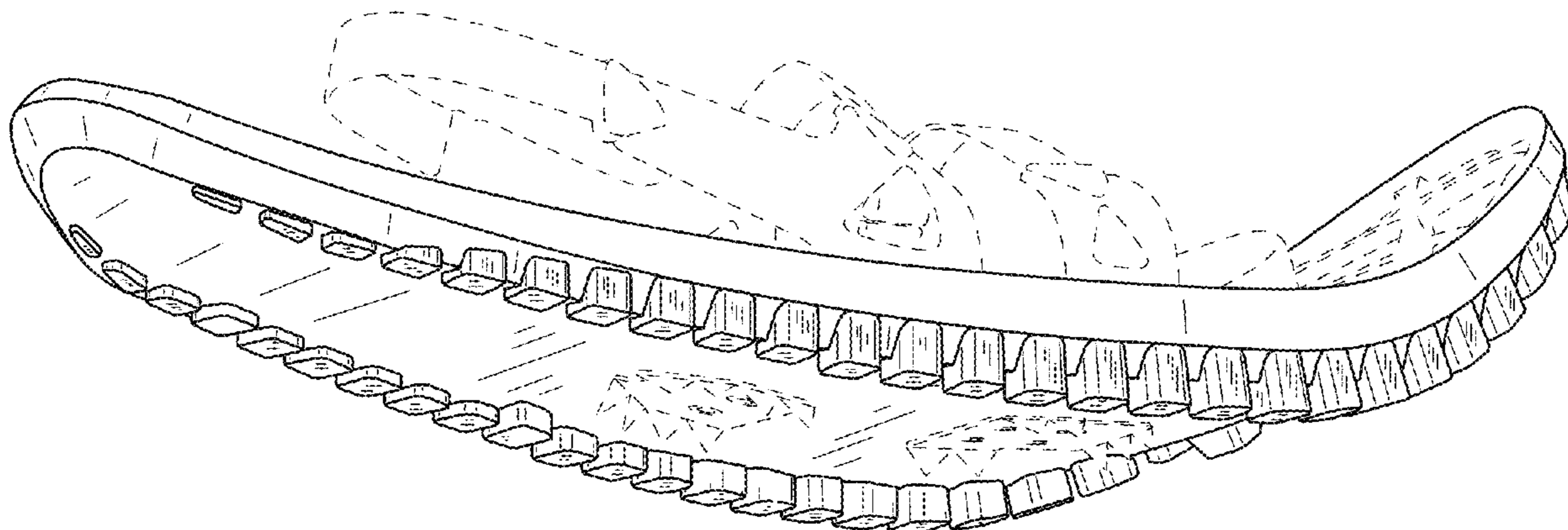
FIG. 5 is a right side view of the snowshoe of FIG. 1;

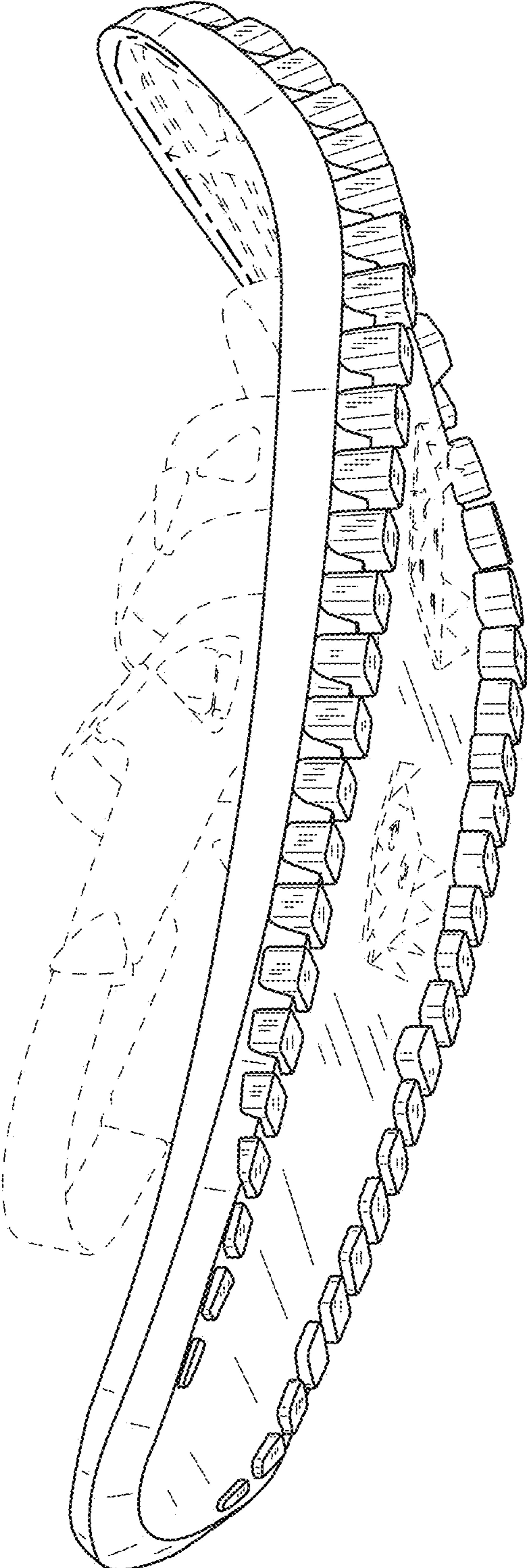

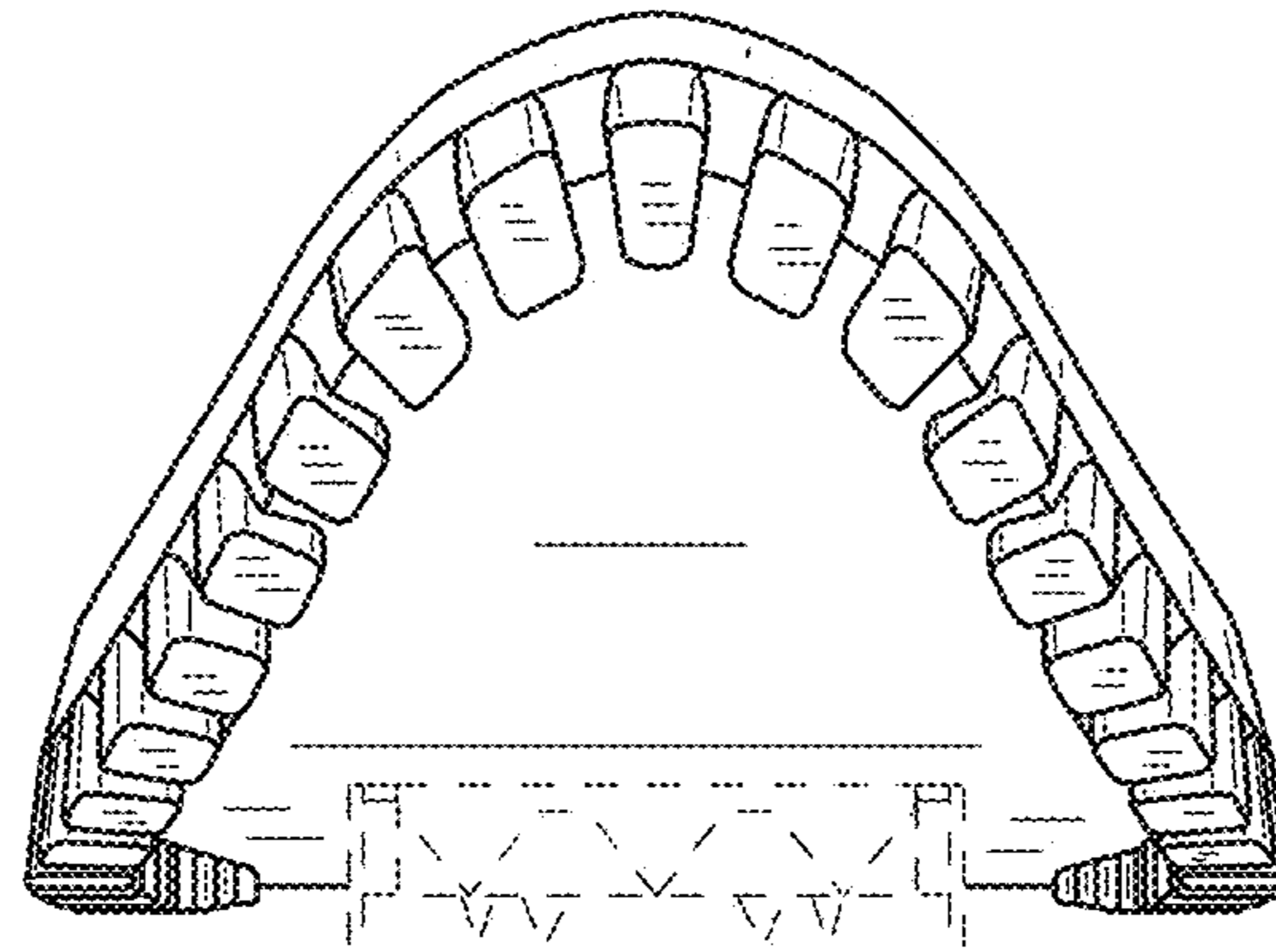

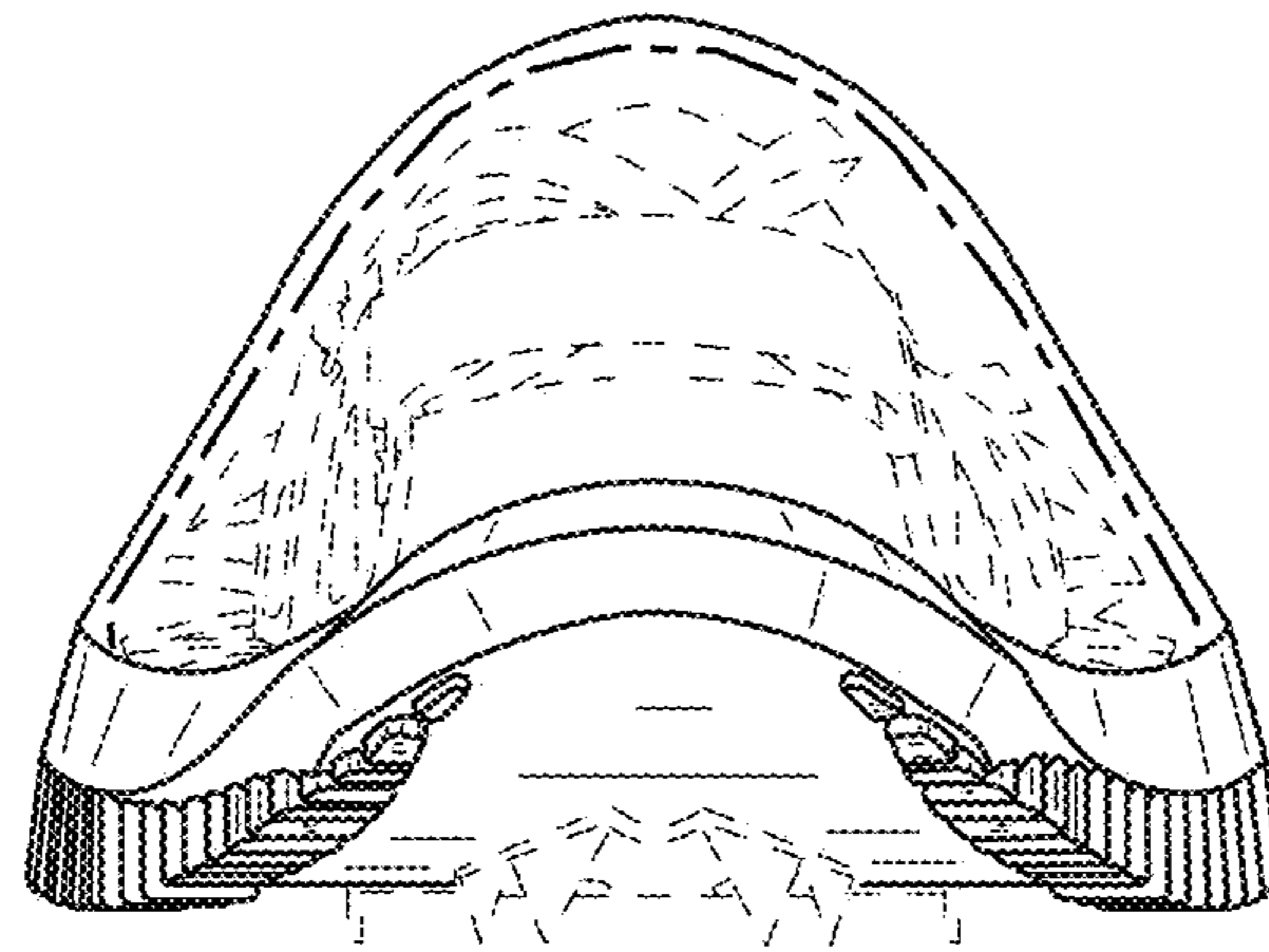

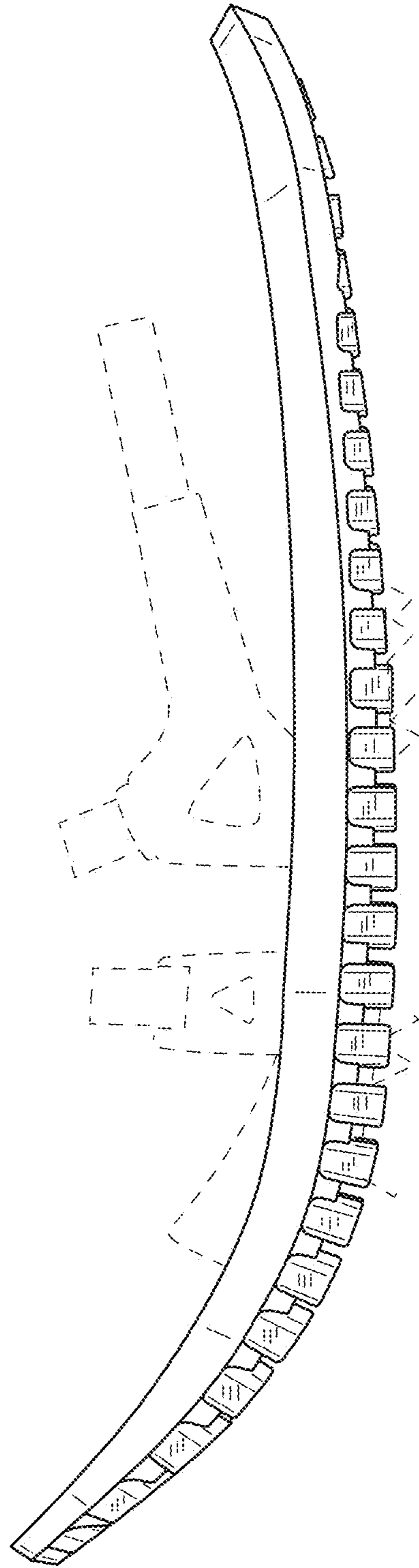

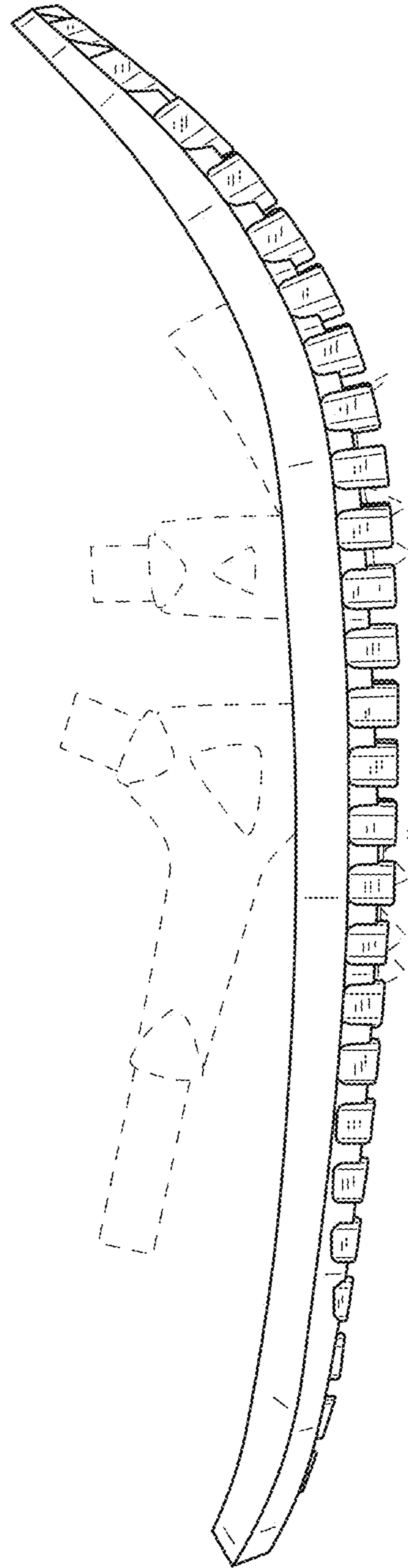

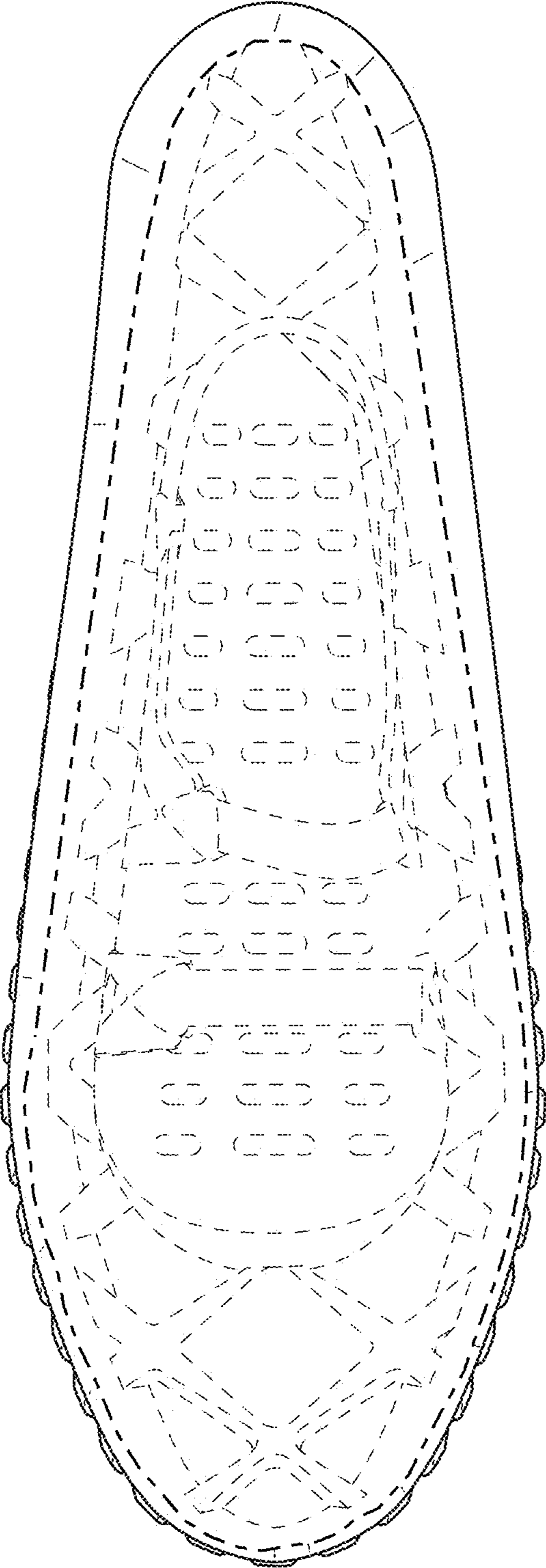

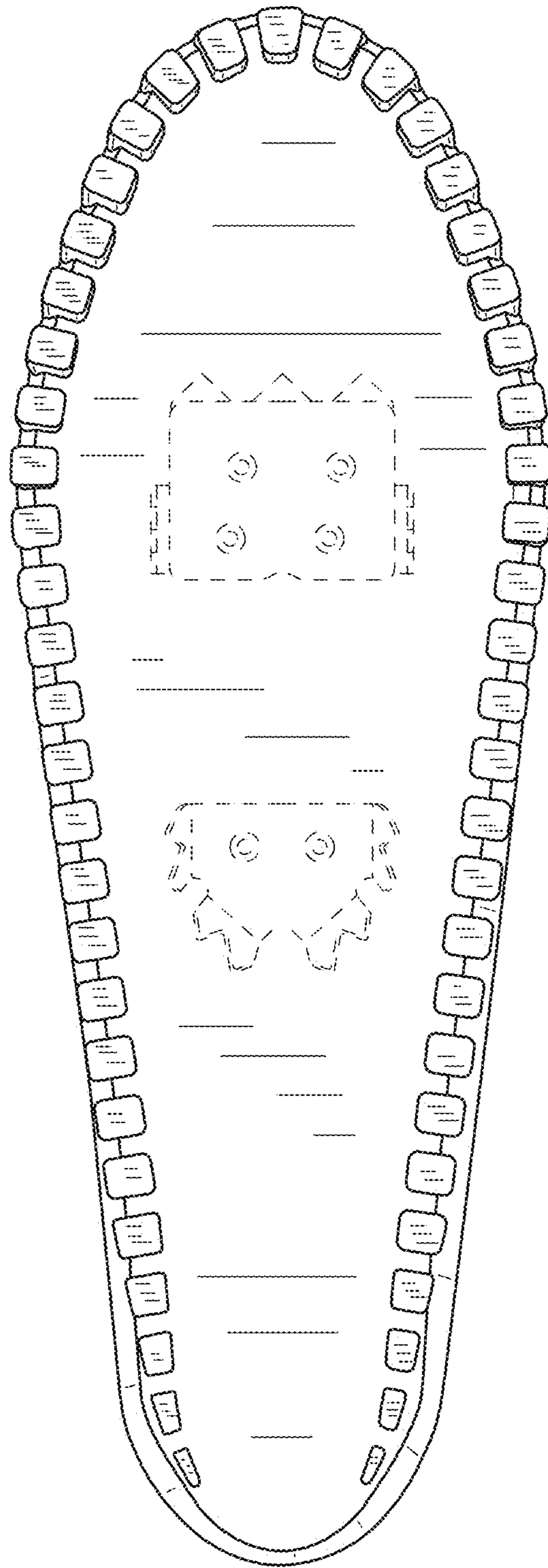
