DESCRIPTION

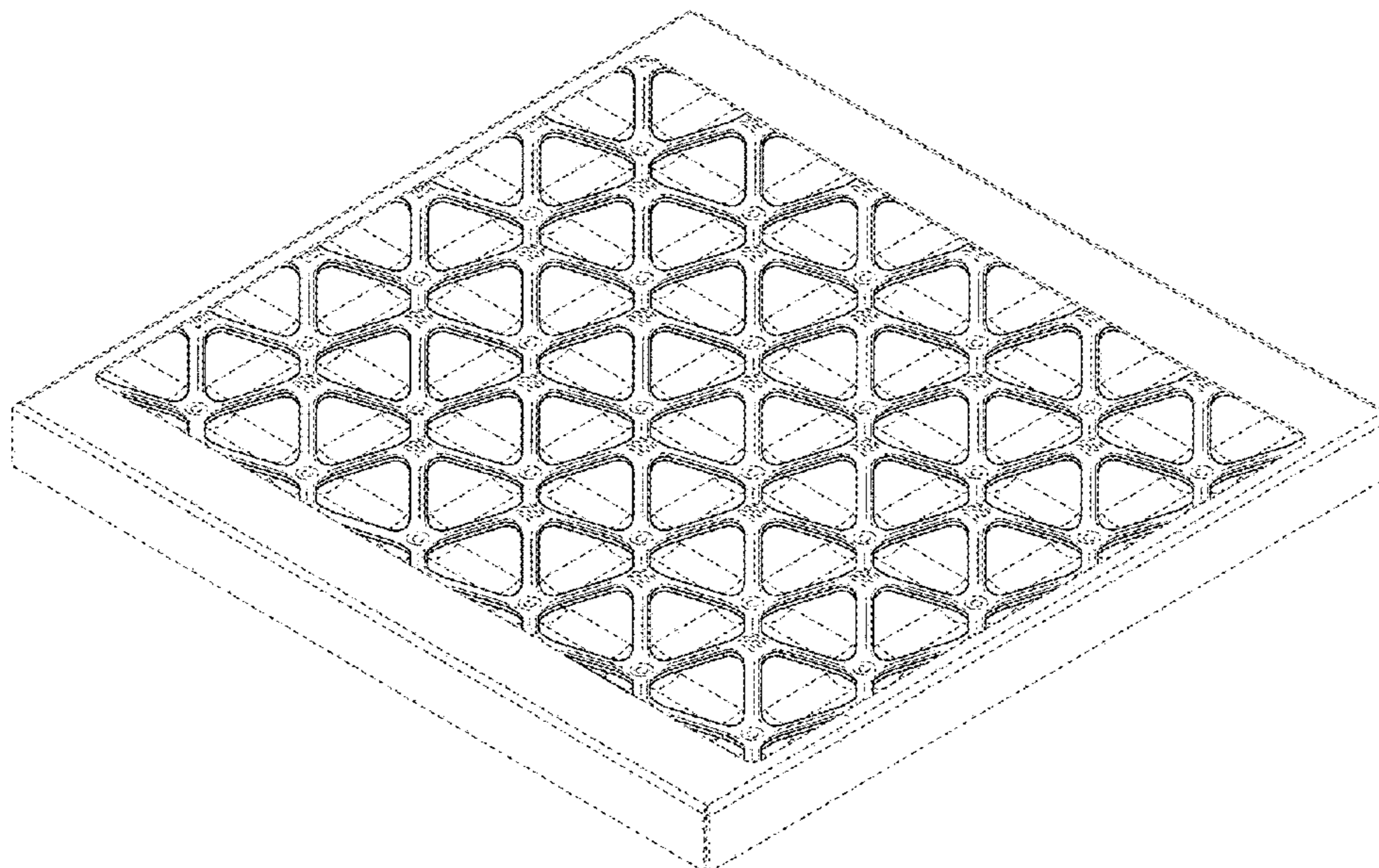
FIG. 1 is a perspective view of showing the new design for a three dimensional filter frame.

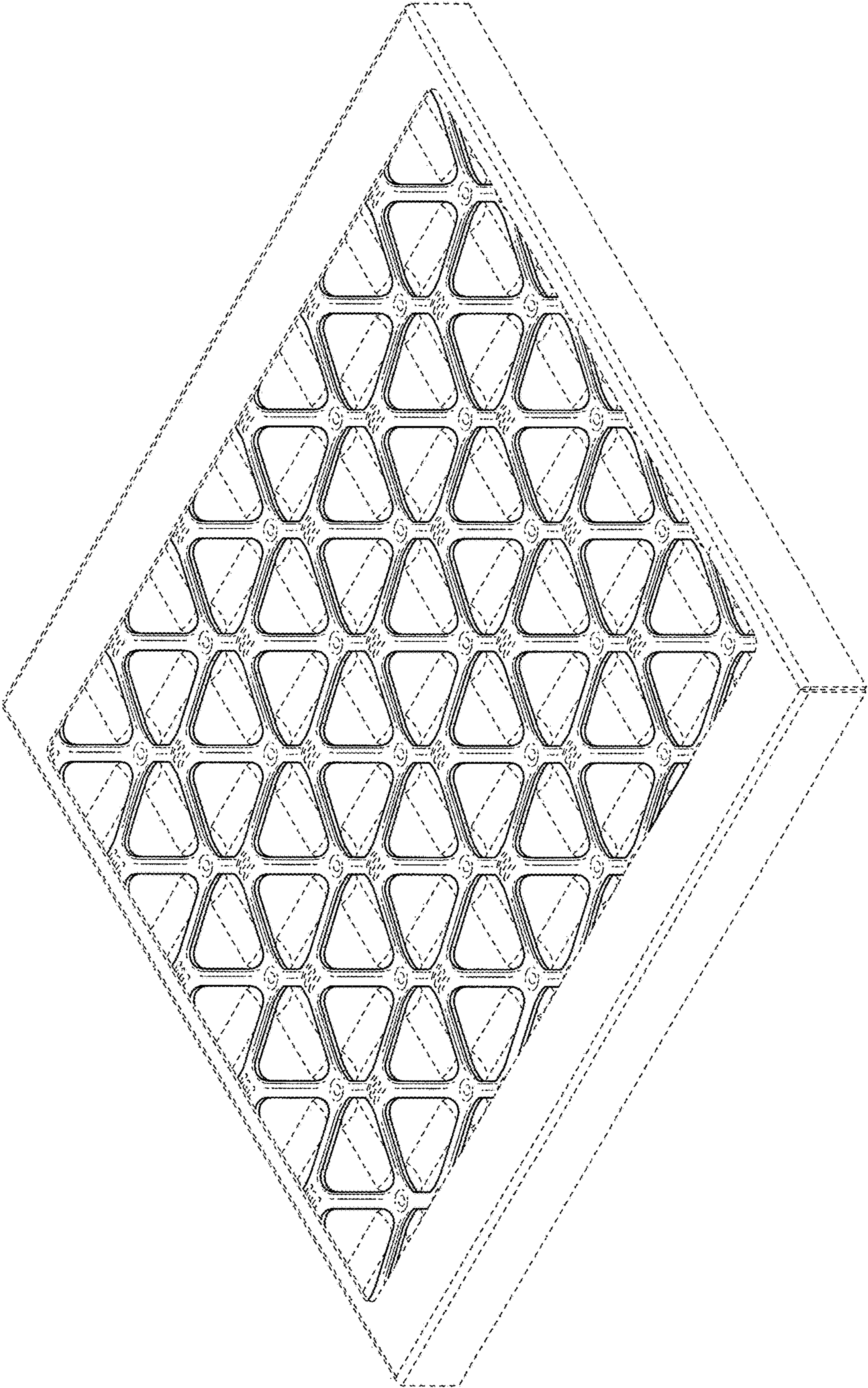

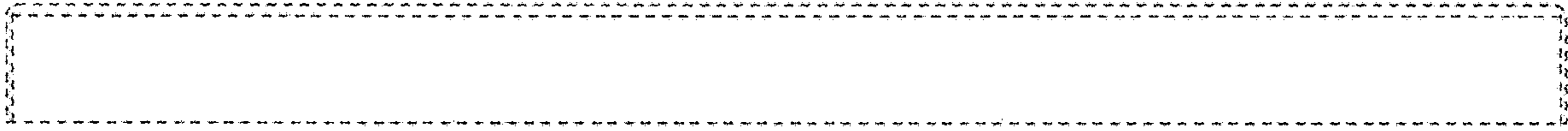

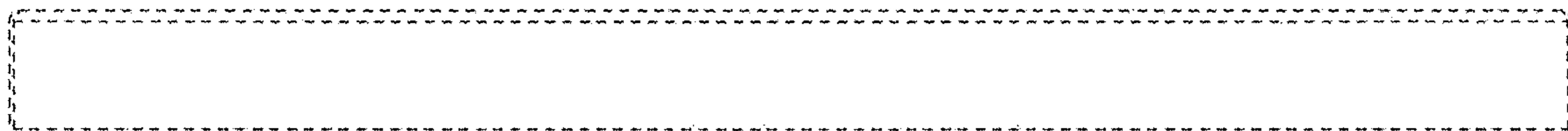

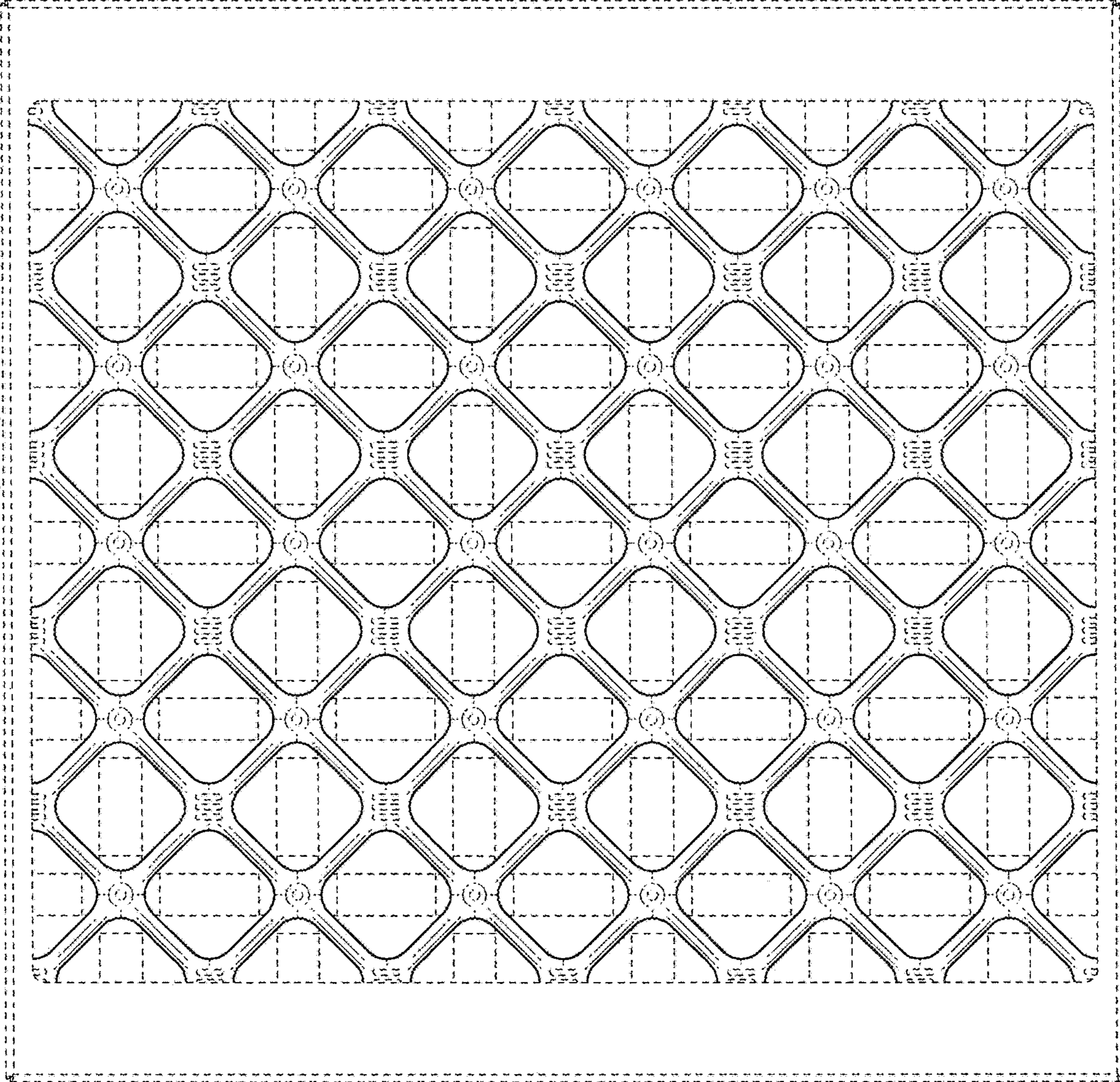

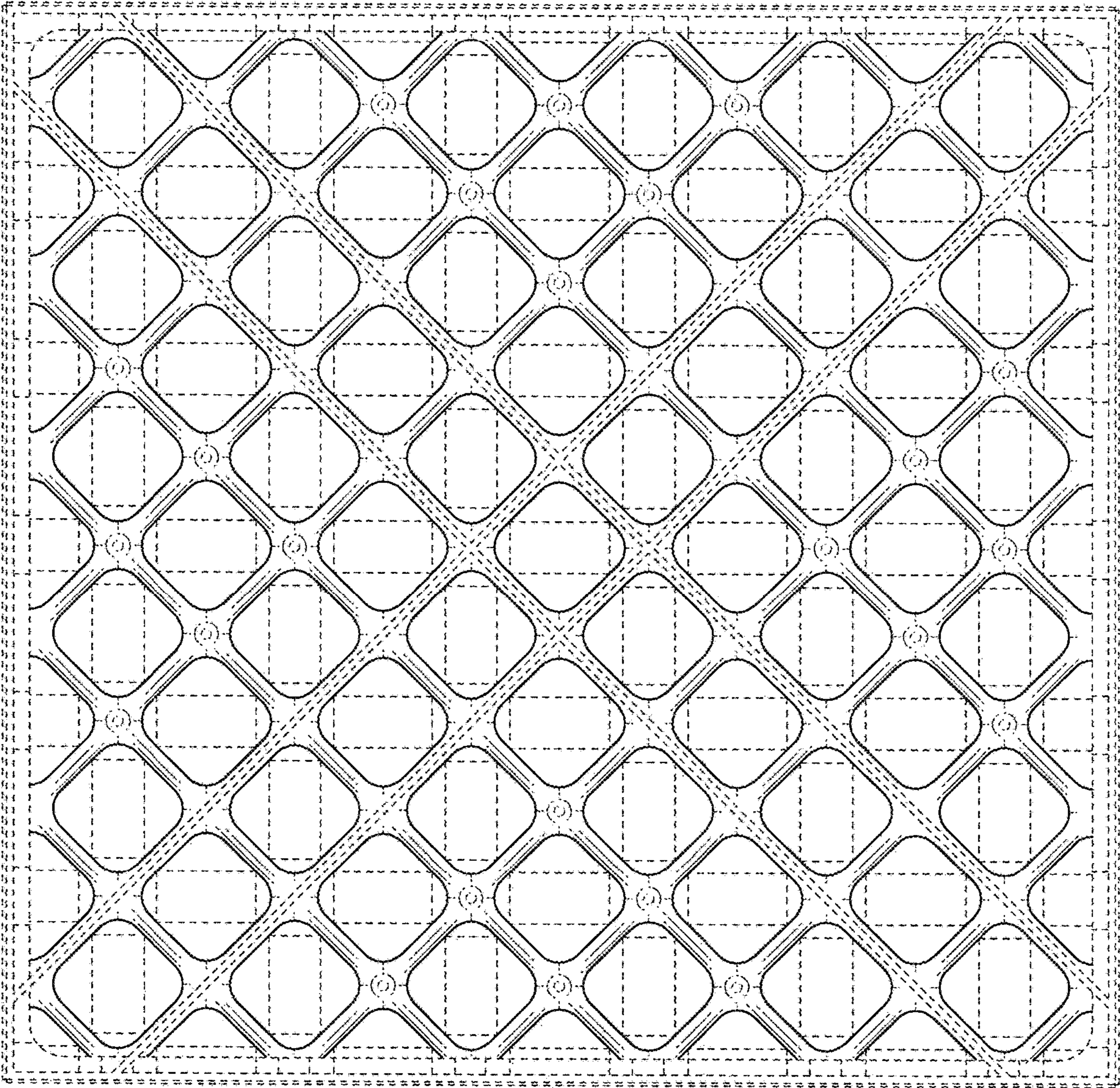
