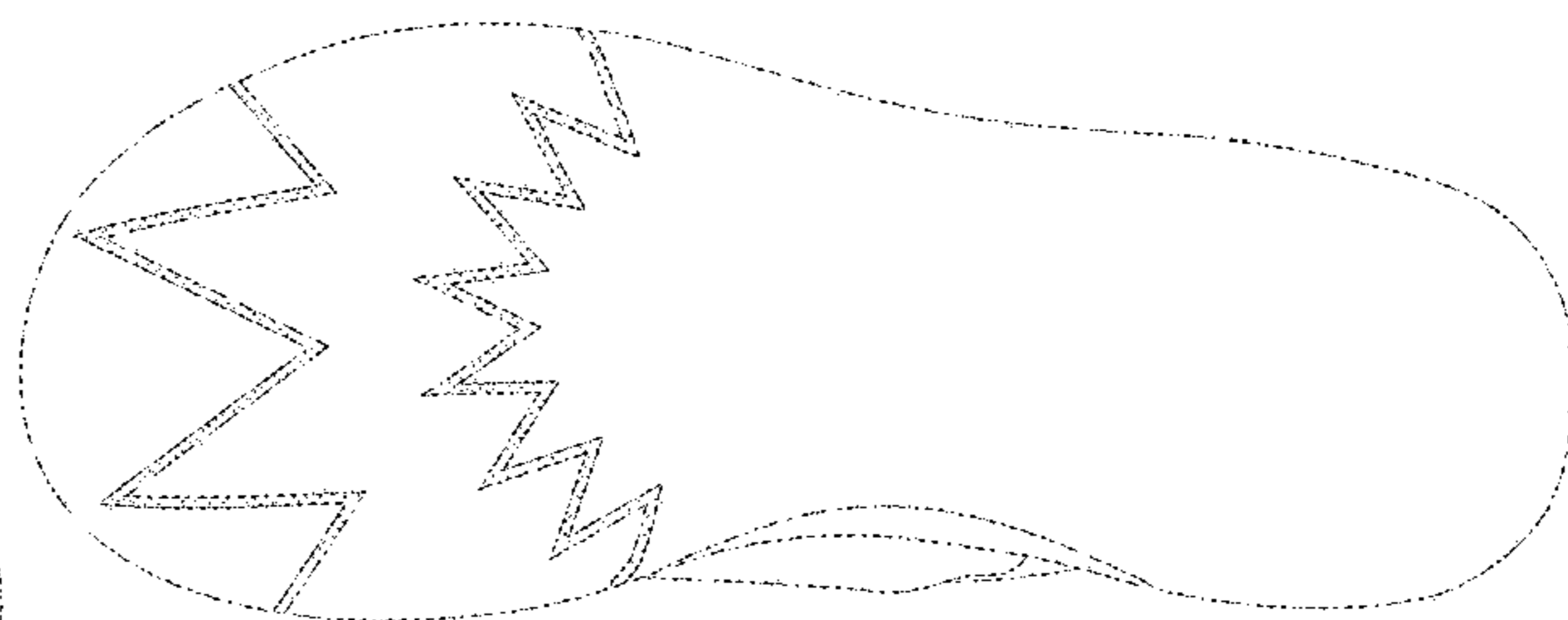
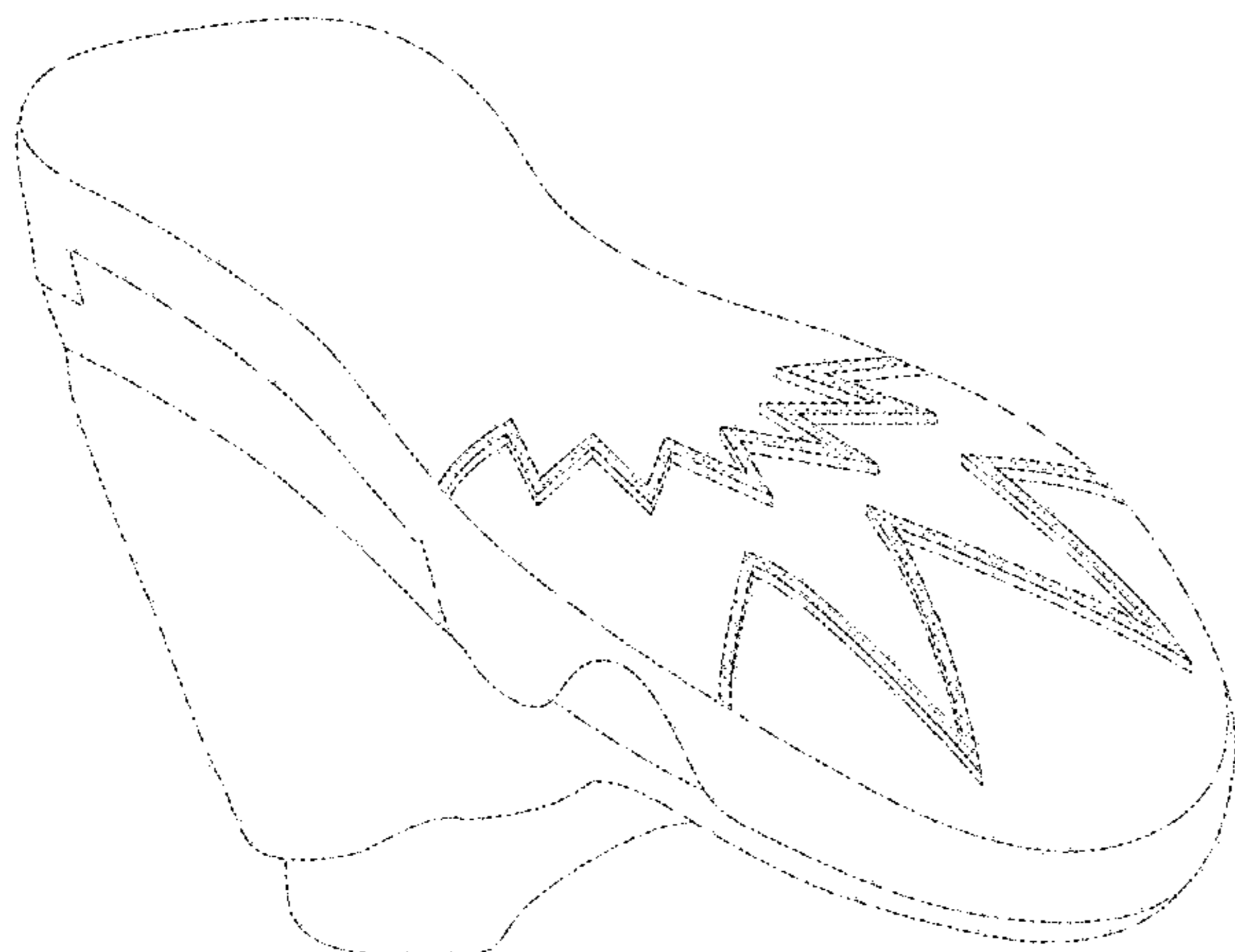
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is an opposite front perspective view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a rear perspective view thereof; and,
FIG. 5 is an opposite rear perspective view thereof.
The broken lines immediately adjacent to the shaded areas define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

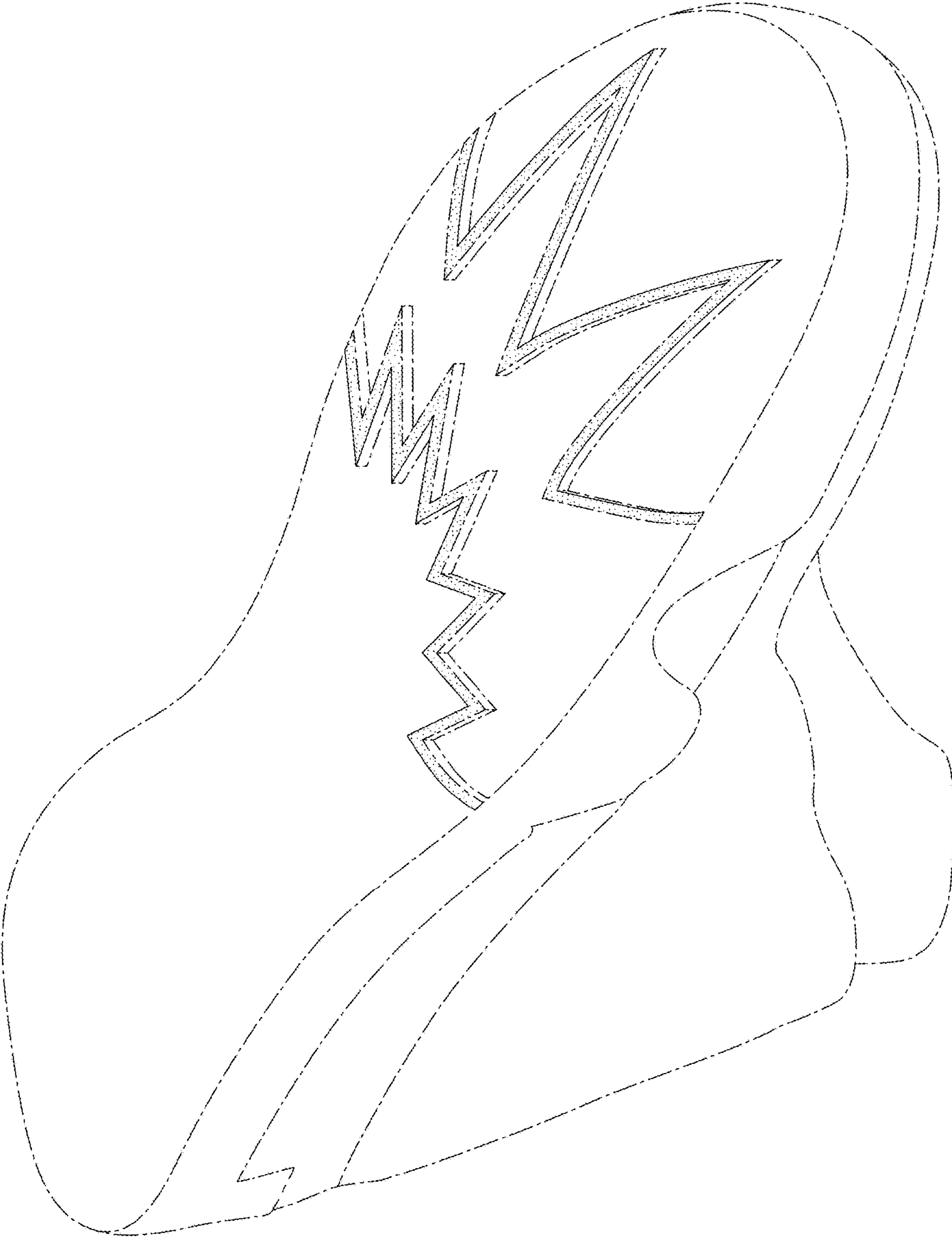

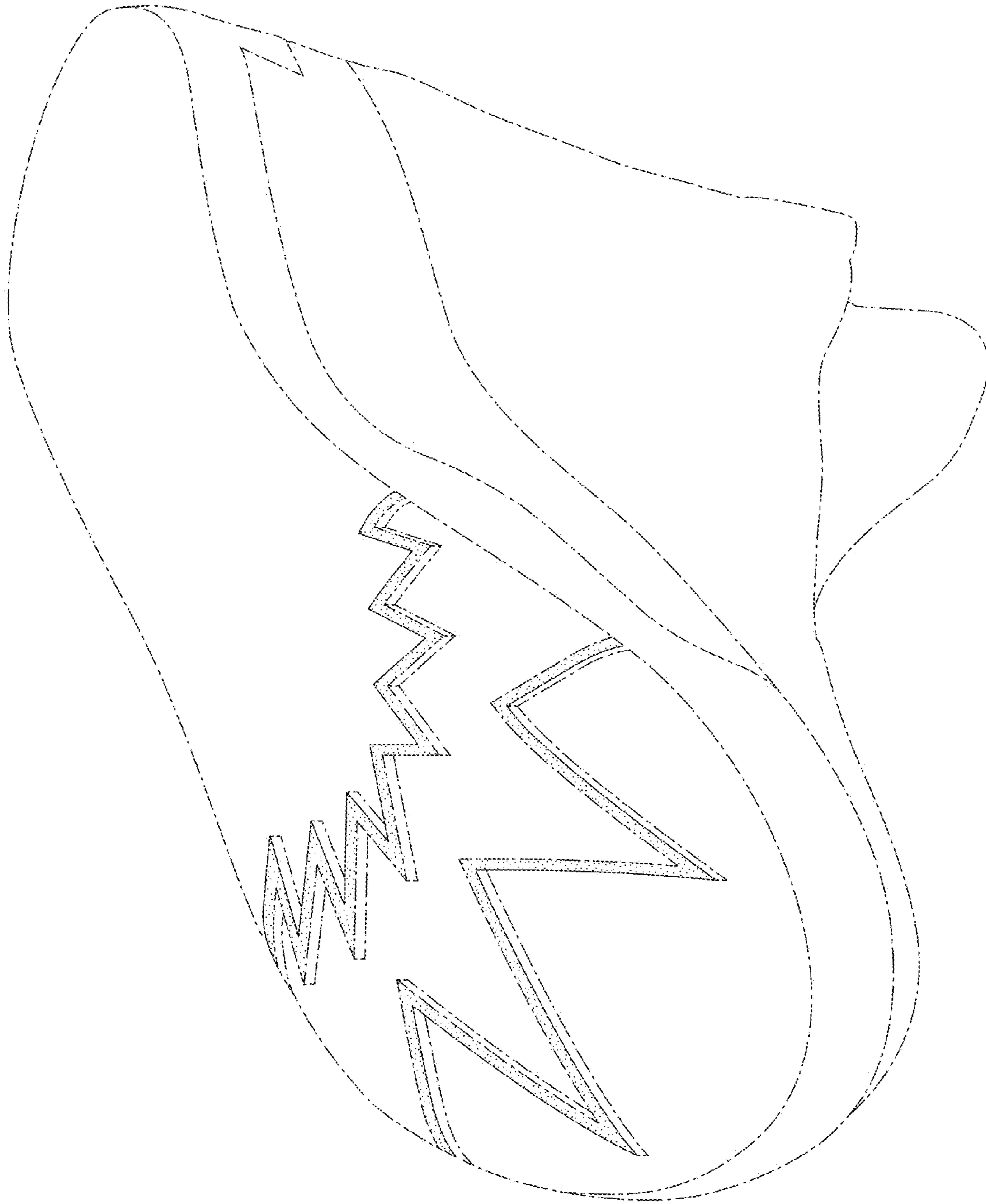

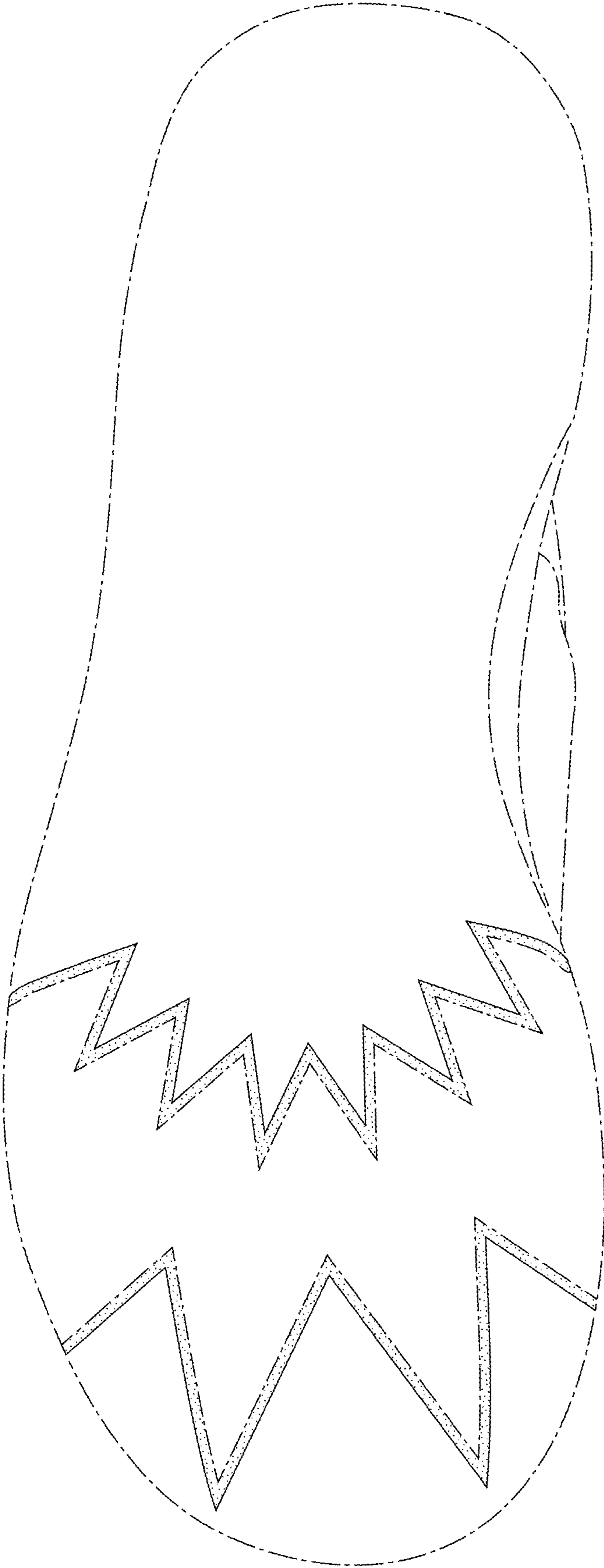

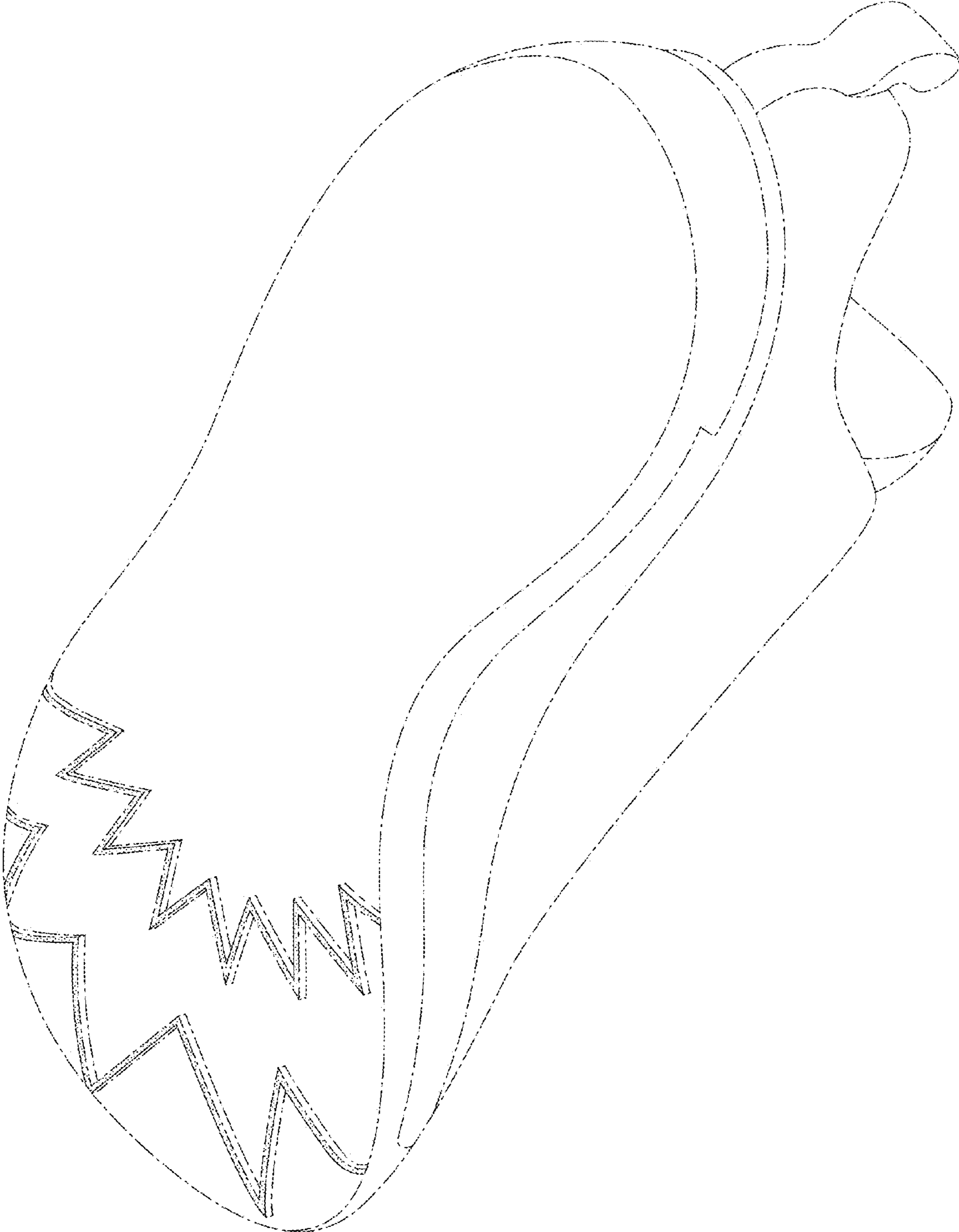
