(57) **CLAIM**

The ornamental design for a spooled item holding device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the spooled item holding device of the new design;
 FIG. 2 is a right end elevational view of the assembly of a combination of several slip-resistant features creating a spooled item holding device as shown in FIG. 1;
 FIG. 3 is a left end elevational view thereof; and,
 FIG. 4 is a front elevation view of the slip-resistant spooled item holding device of FIG. 1.

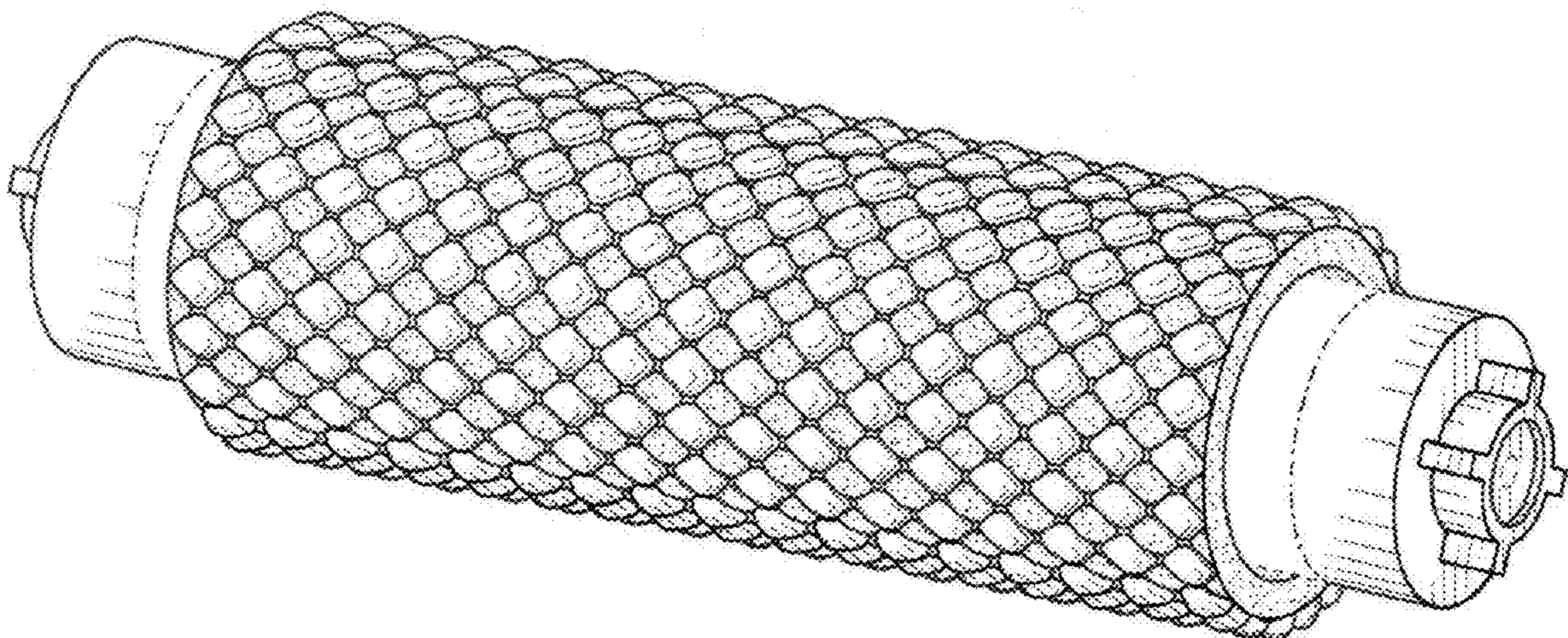
The sides not explicitly shown in the drawings are a mirror image of the sides visible in the drawings.

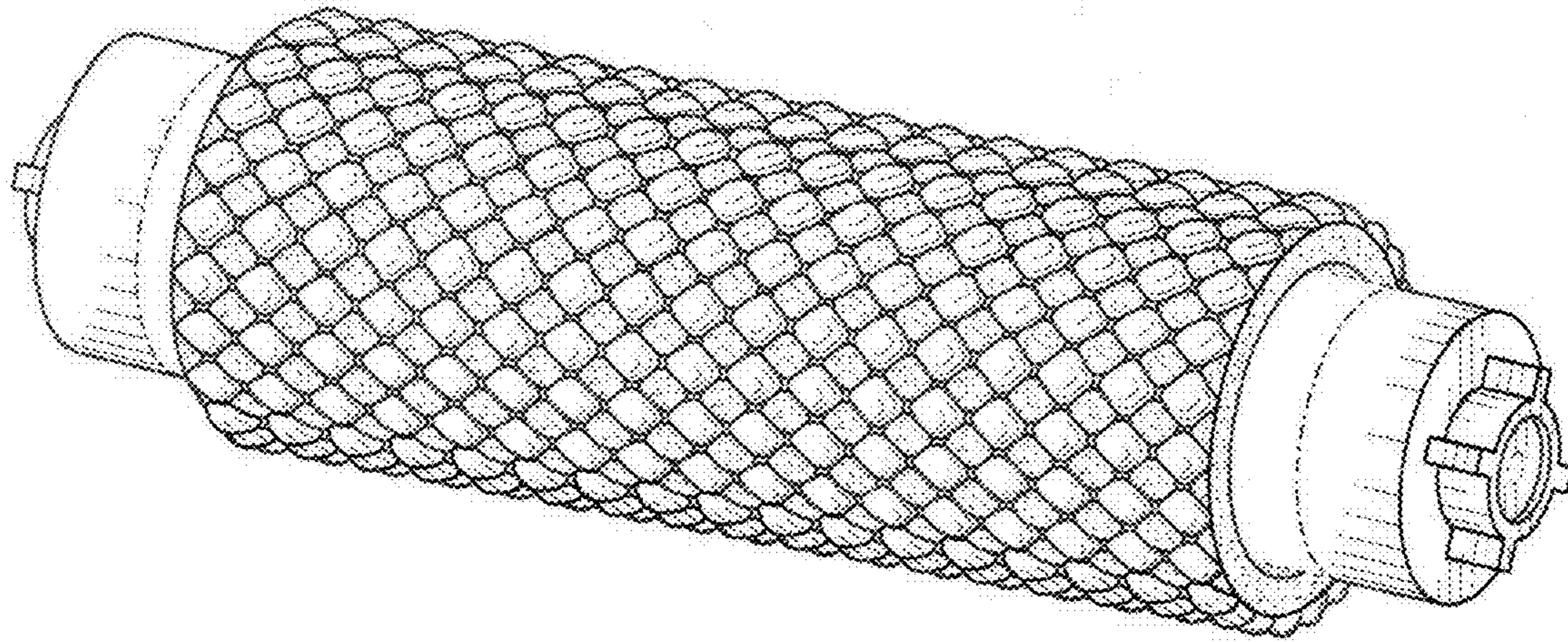

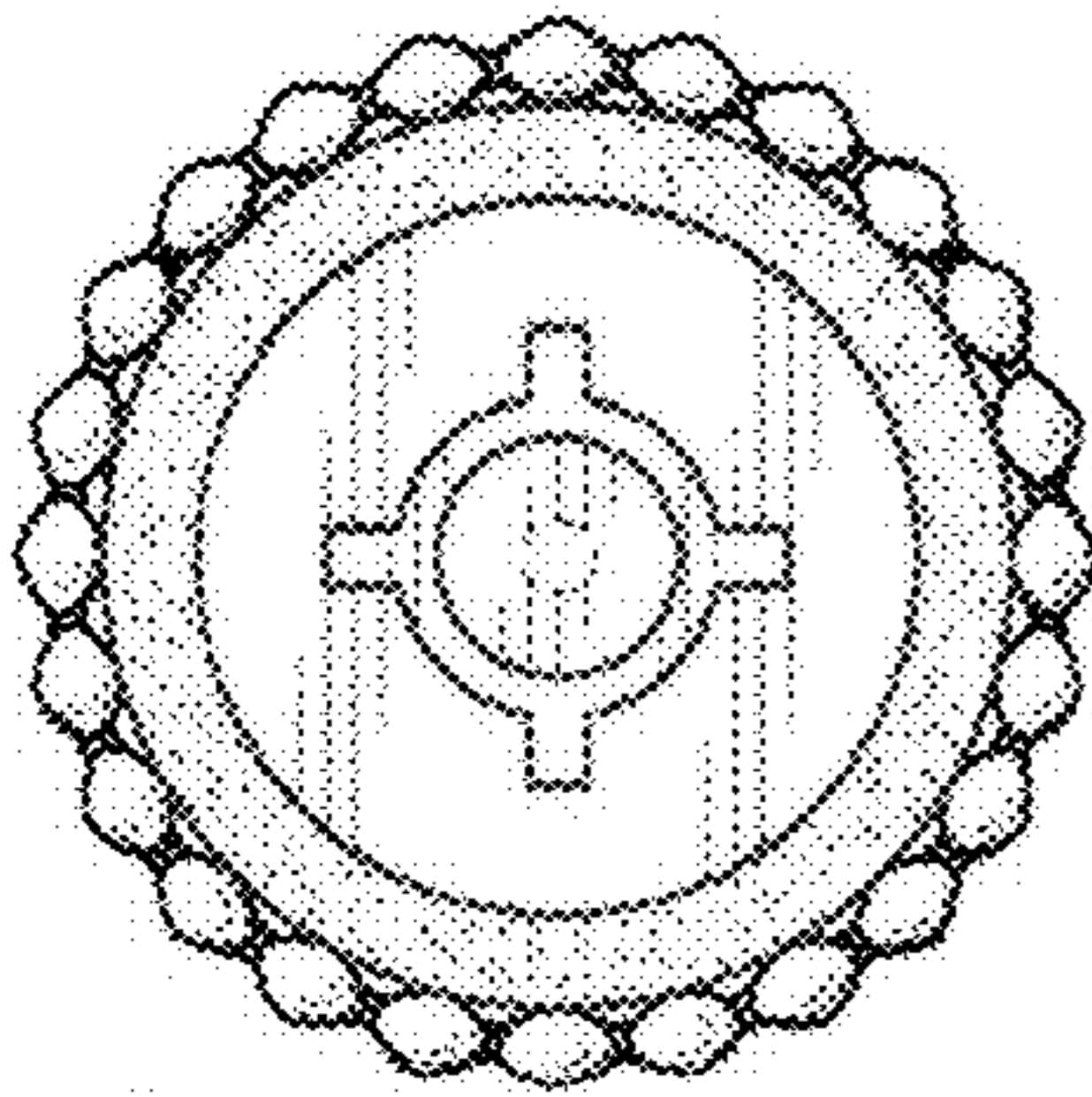

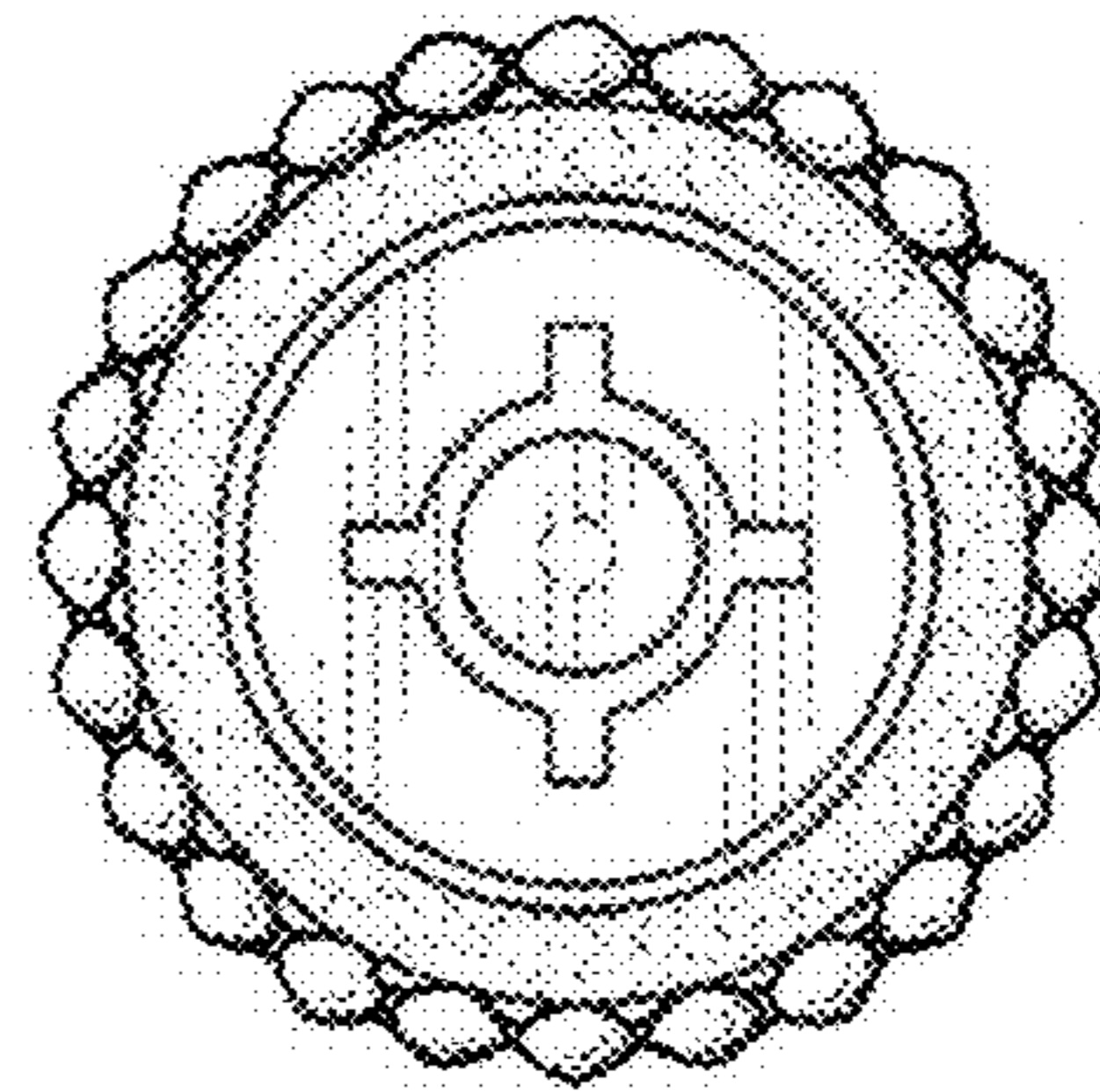

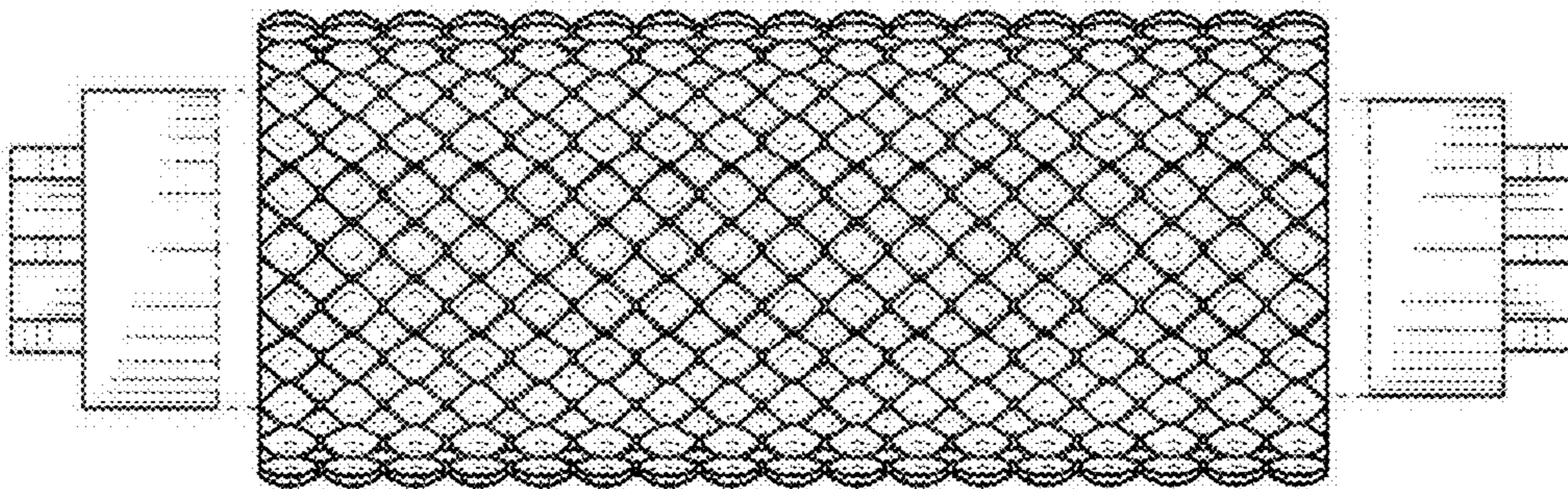
