(57) **CLAIM**

The ornamental design for a soap dish, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective side view of the soap dish showing our new design displaying the pedestal support and bottom of the dish portion;

FIG. 6 is a front elevation view thereof;

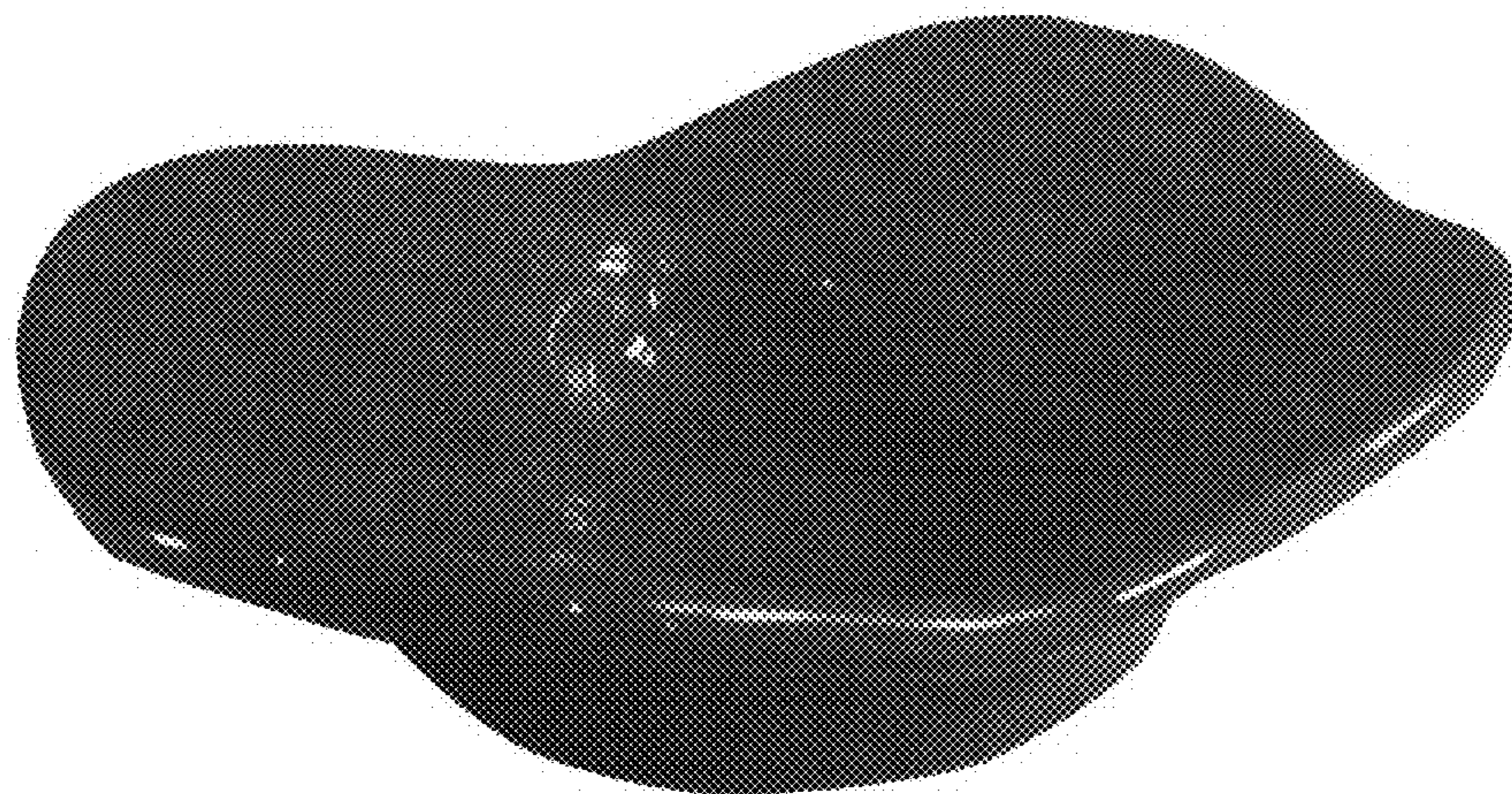
FIG. 7 is a top perspective side view thereof;

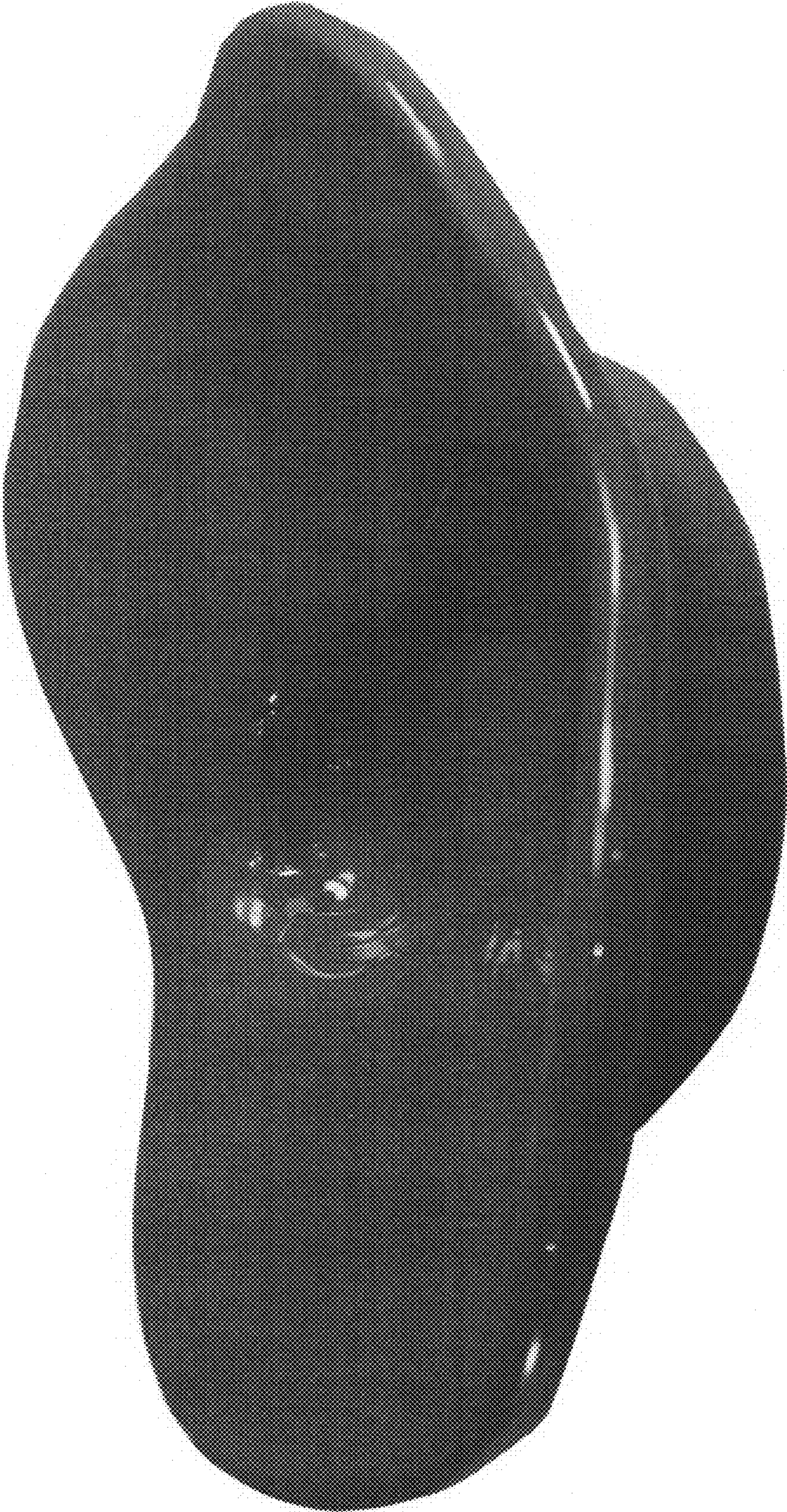

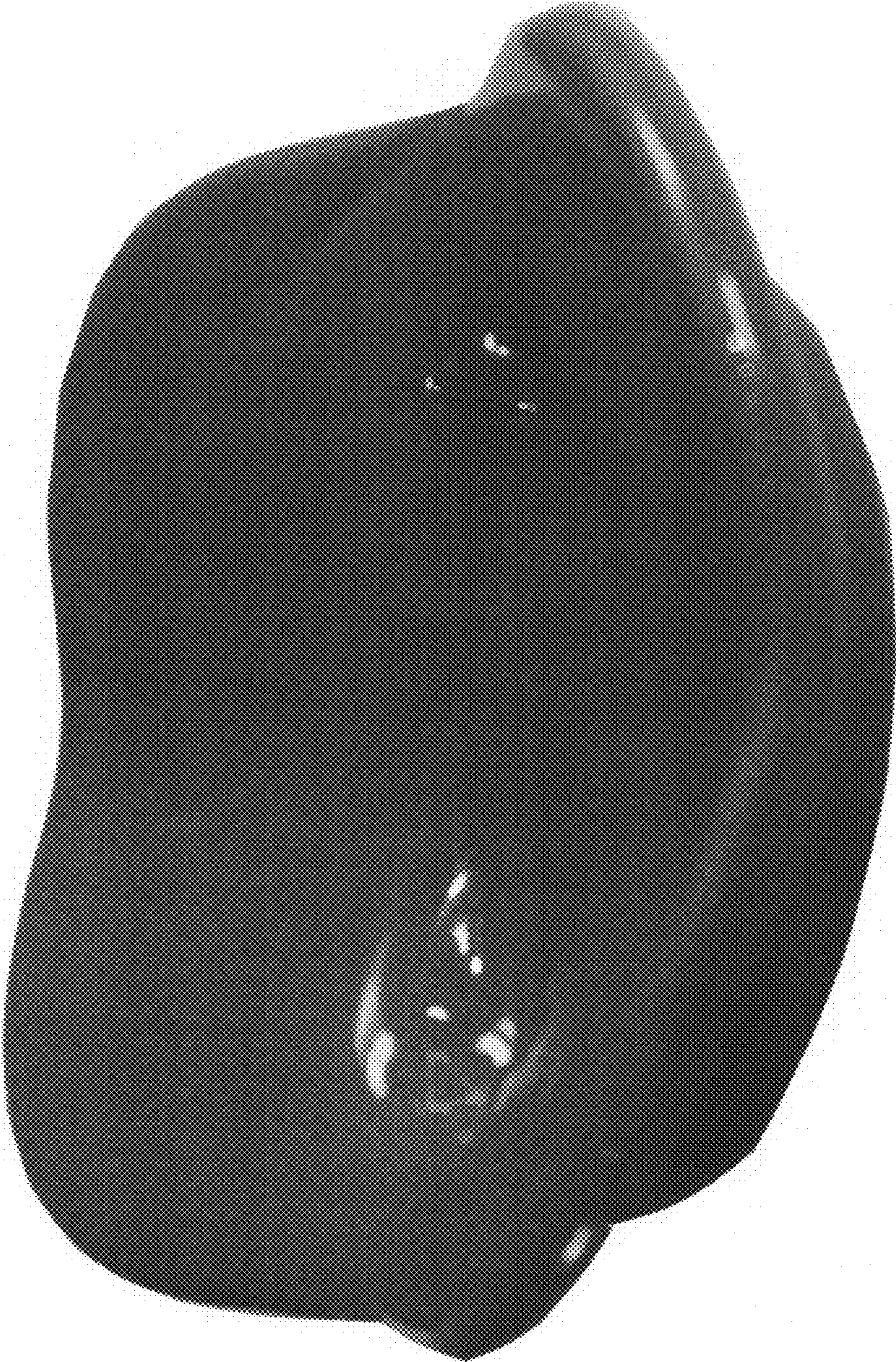

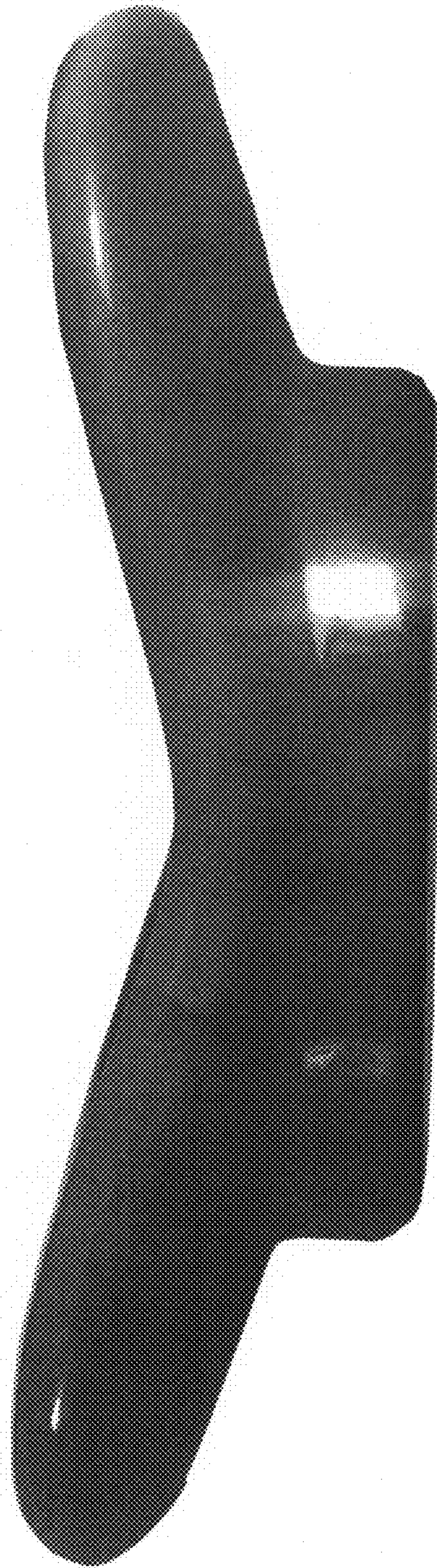

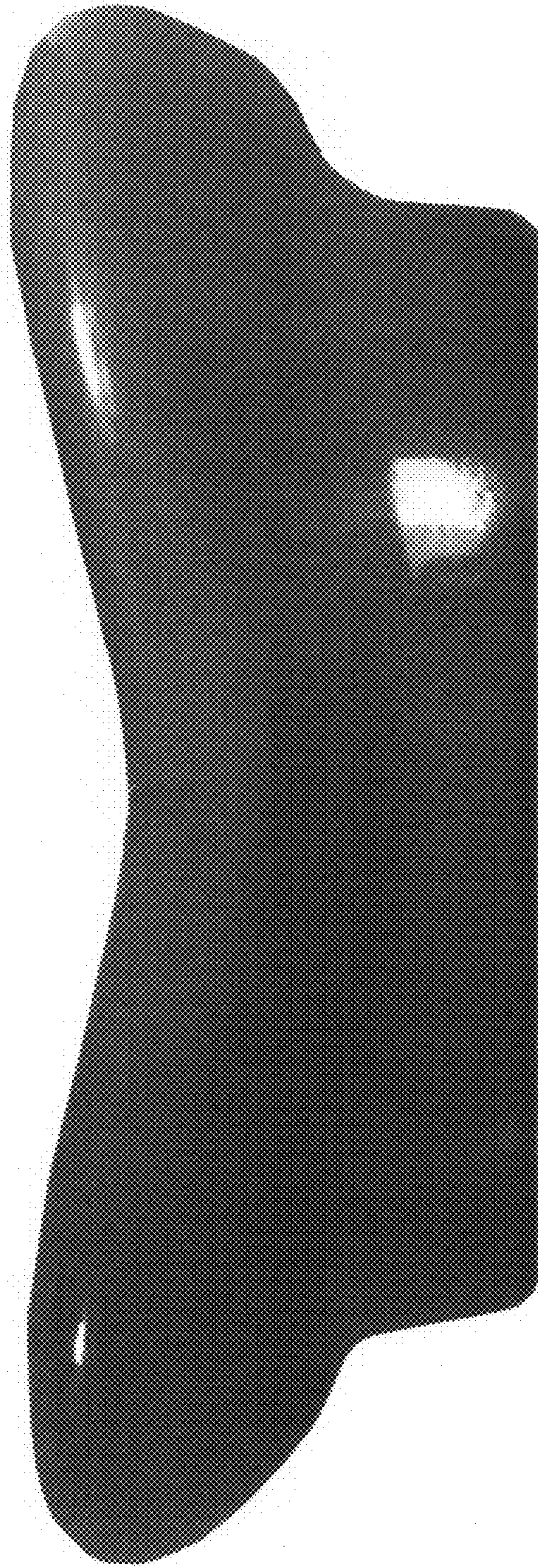

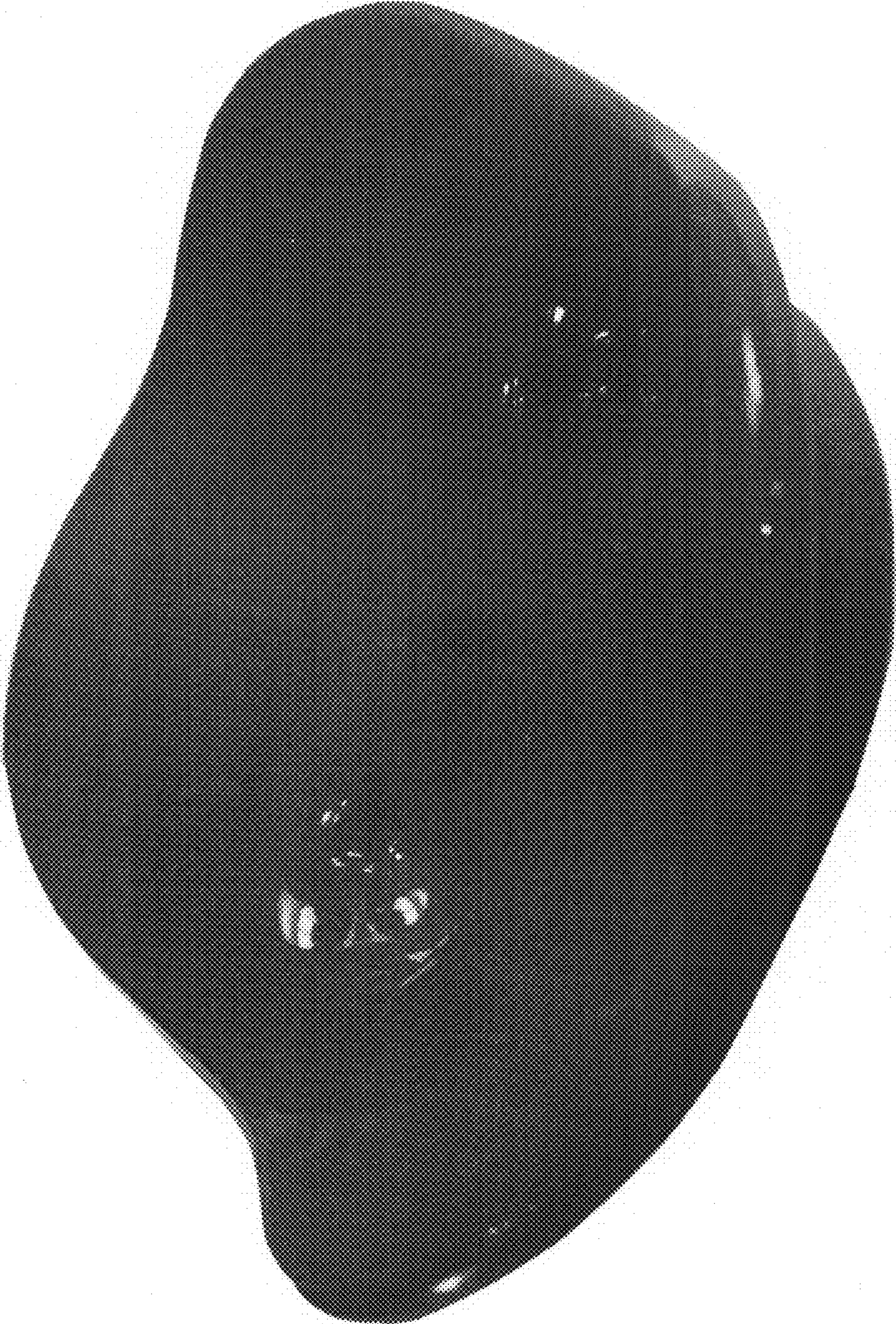

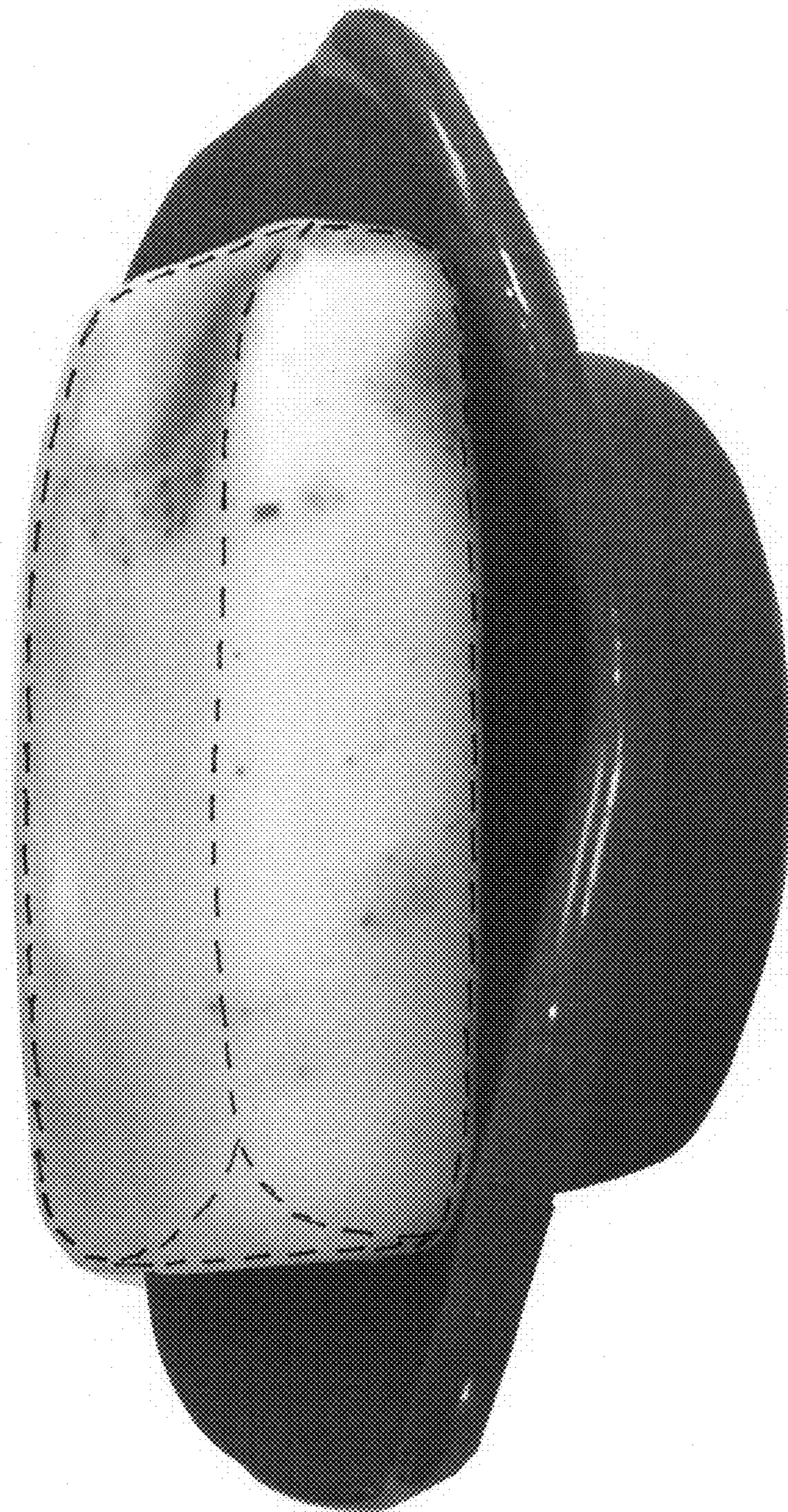

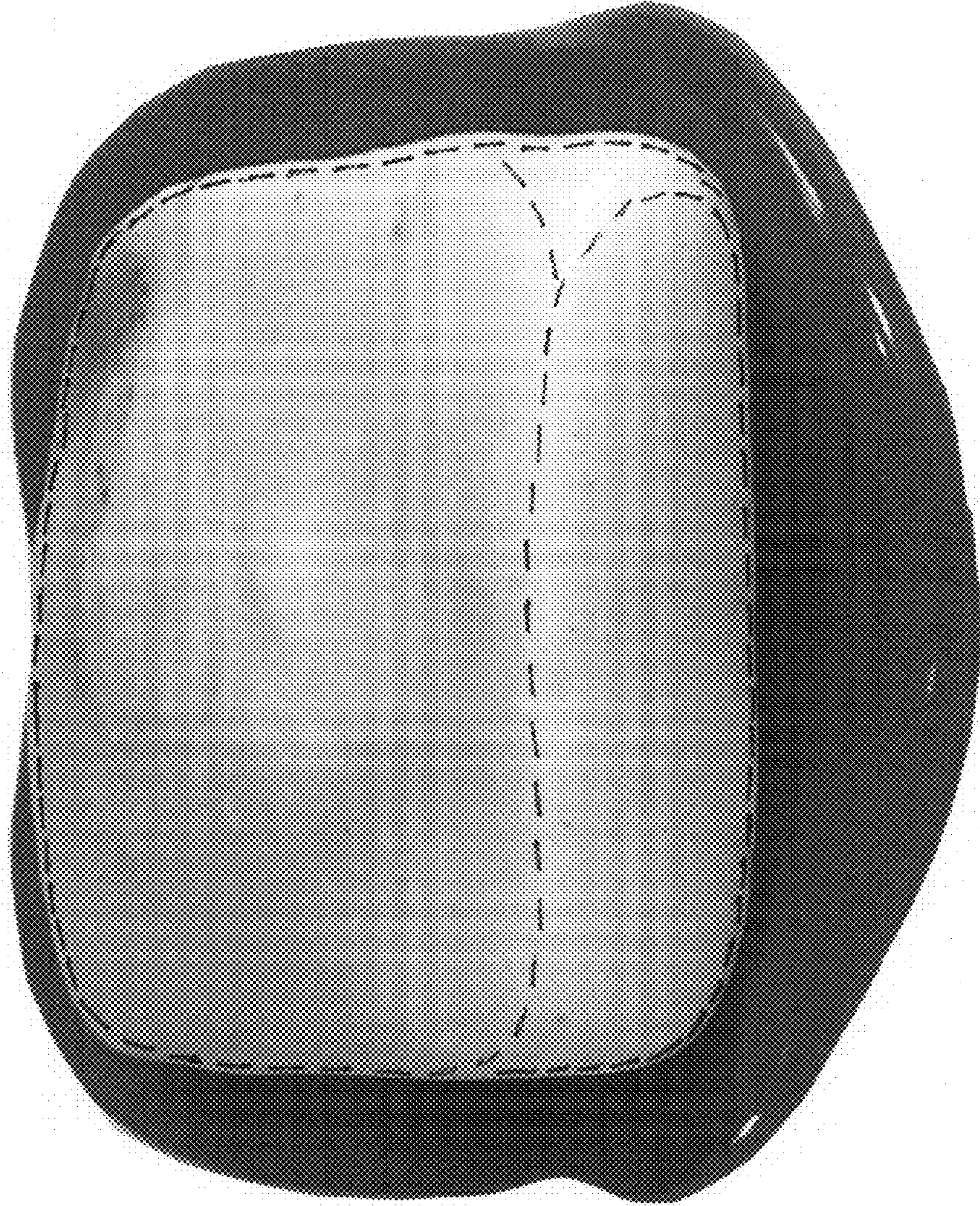
