DESCRIPTION

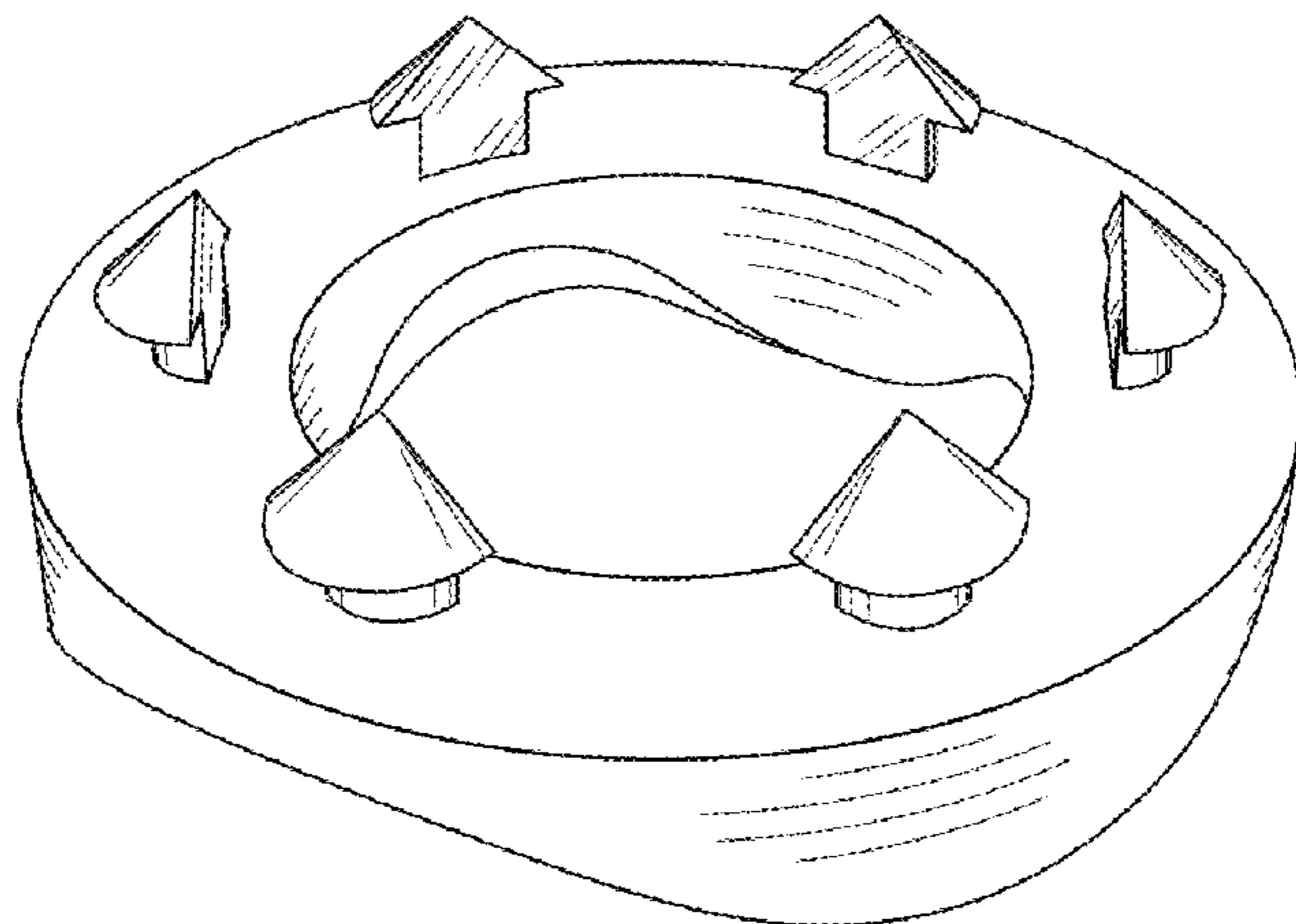
FIG. 1 is a perspective view of my new design for a soap support stand with a flat, circular profile.

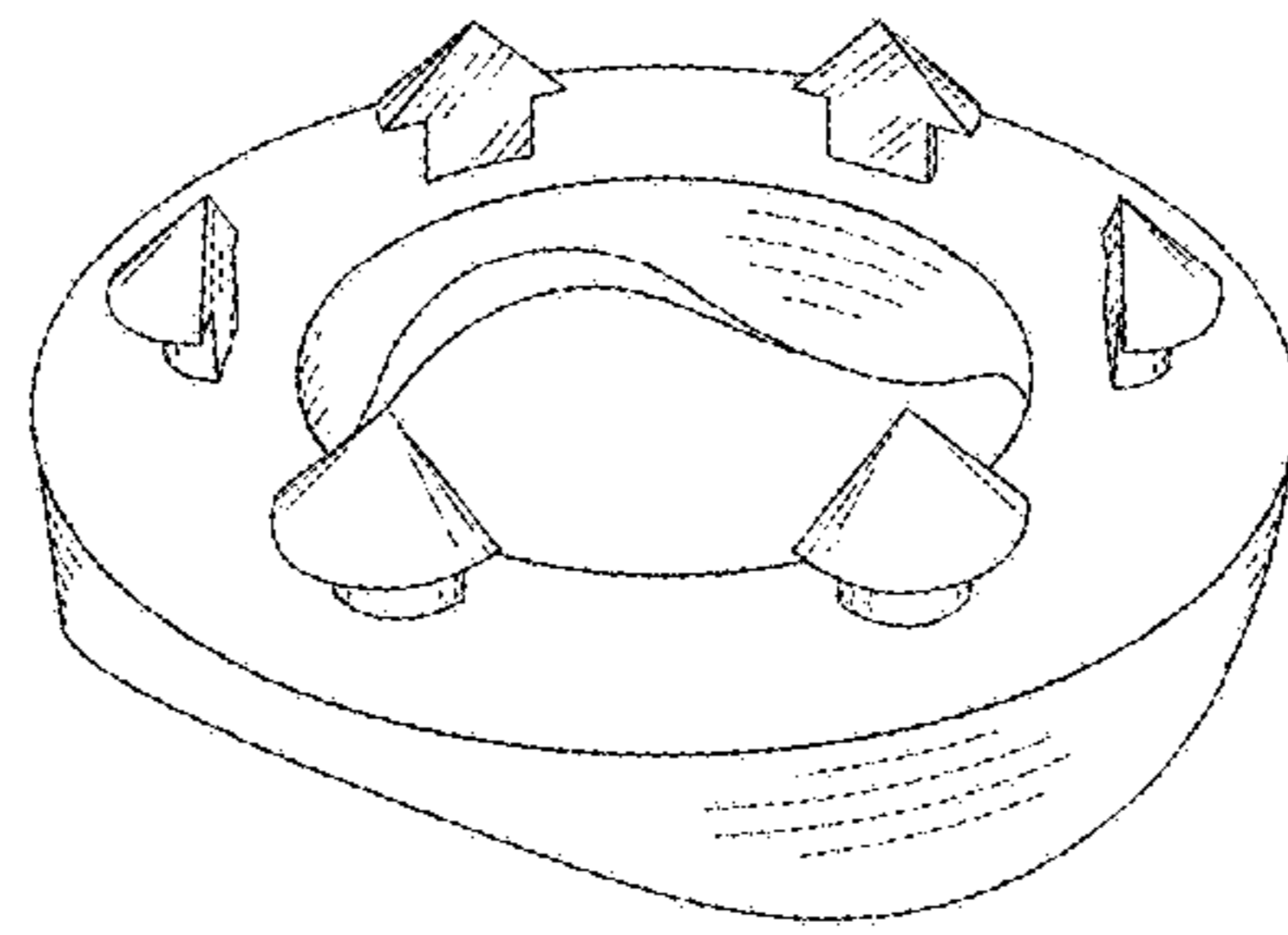

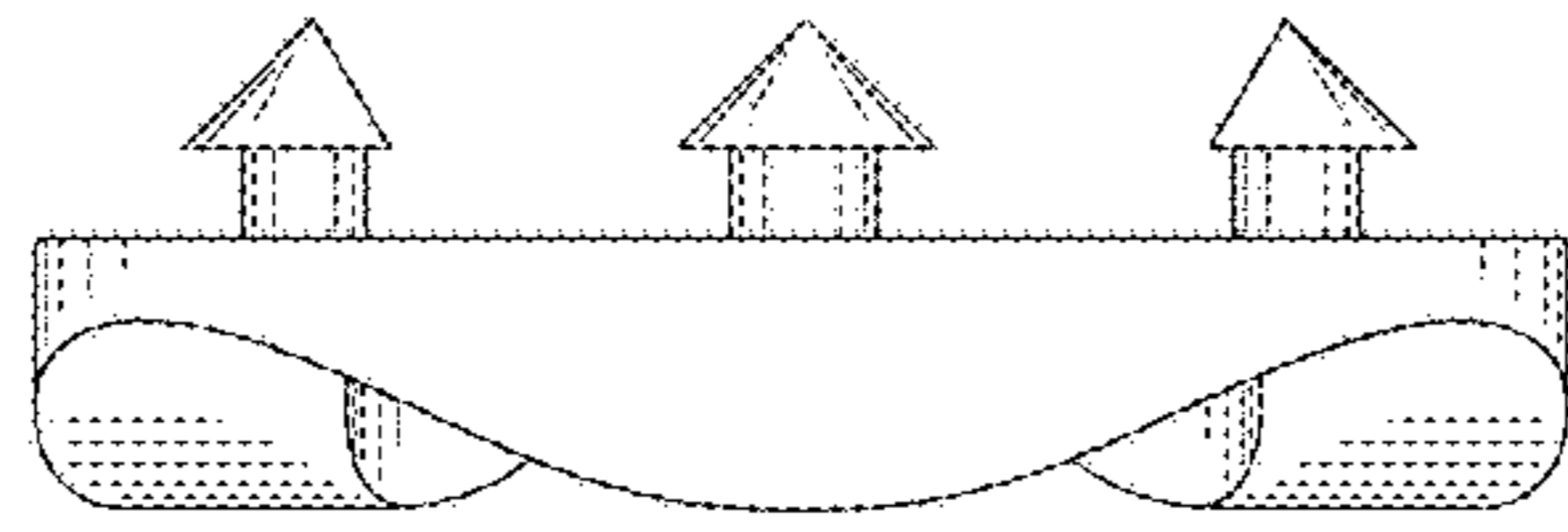

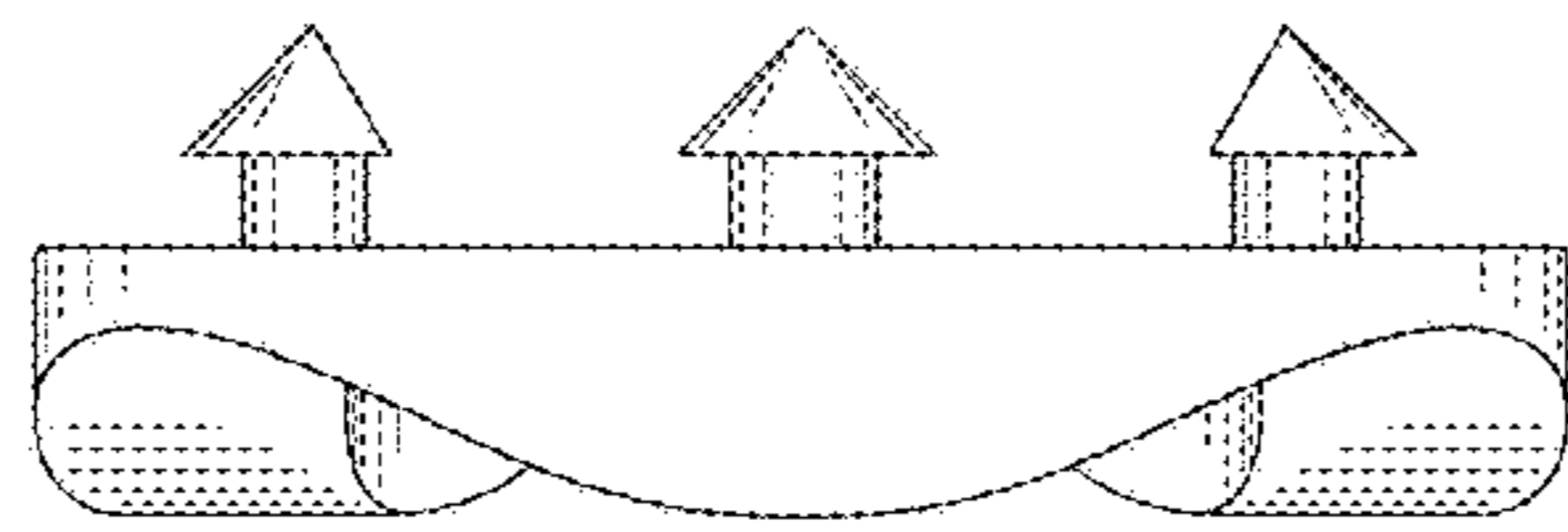

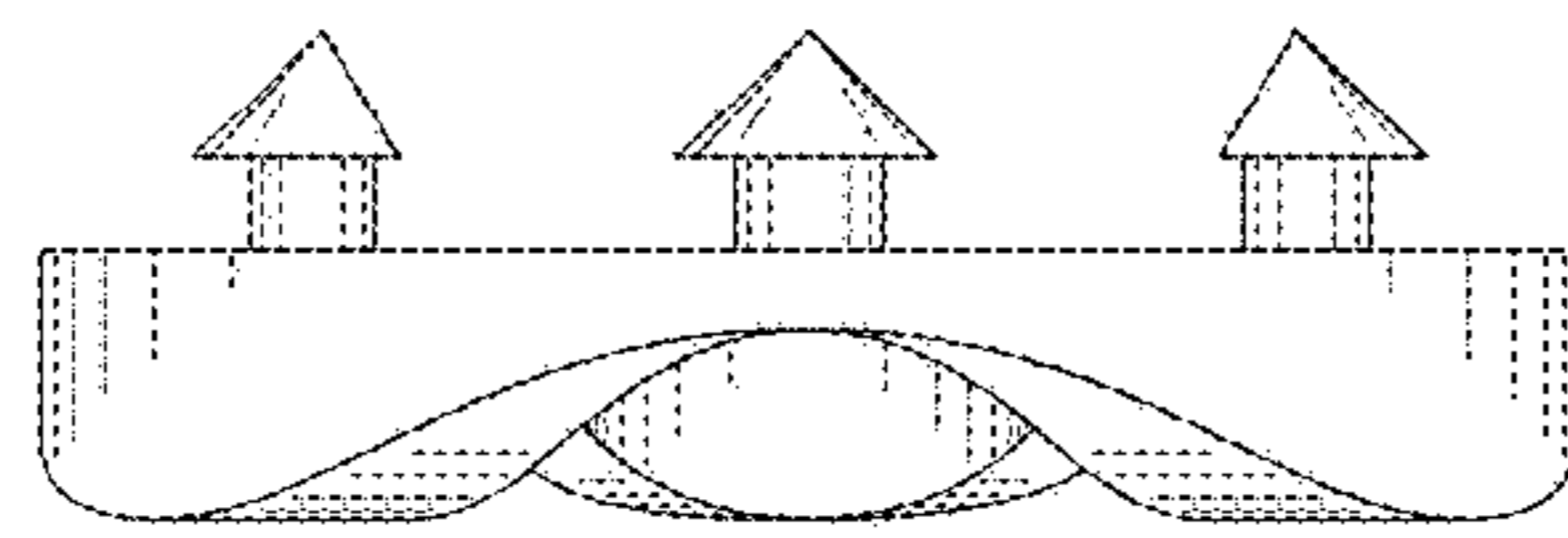

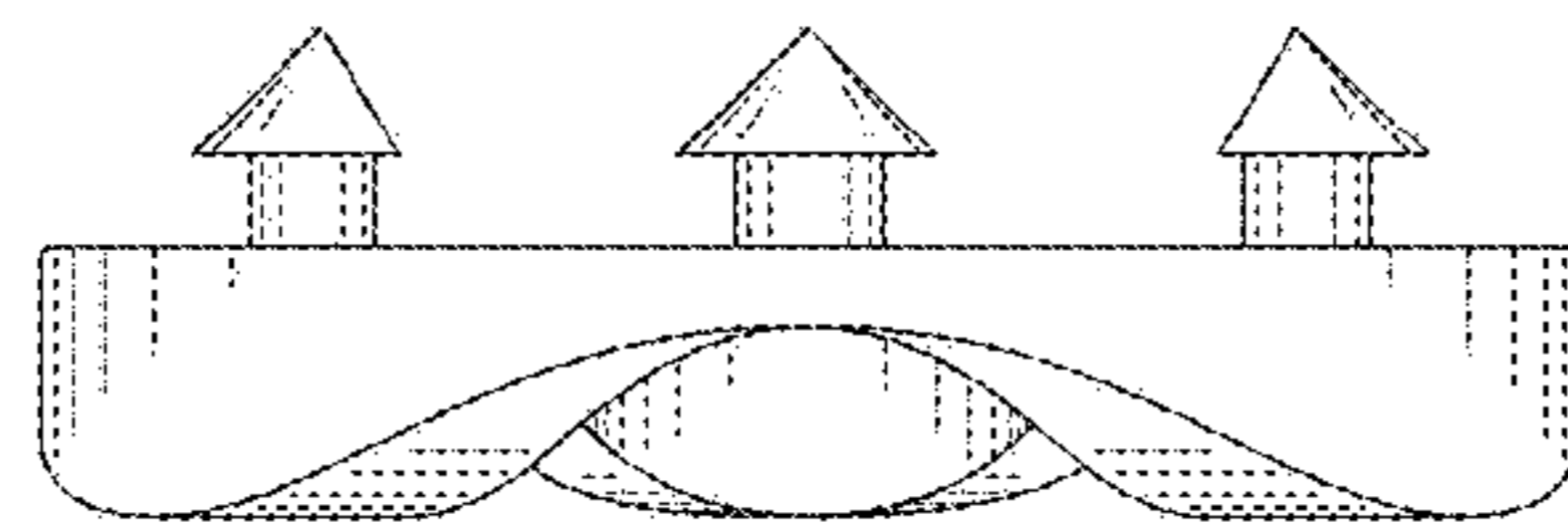

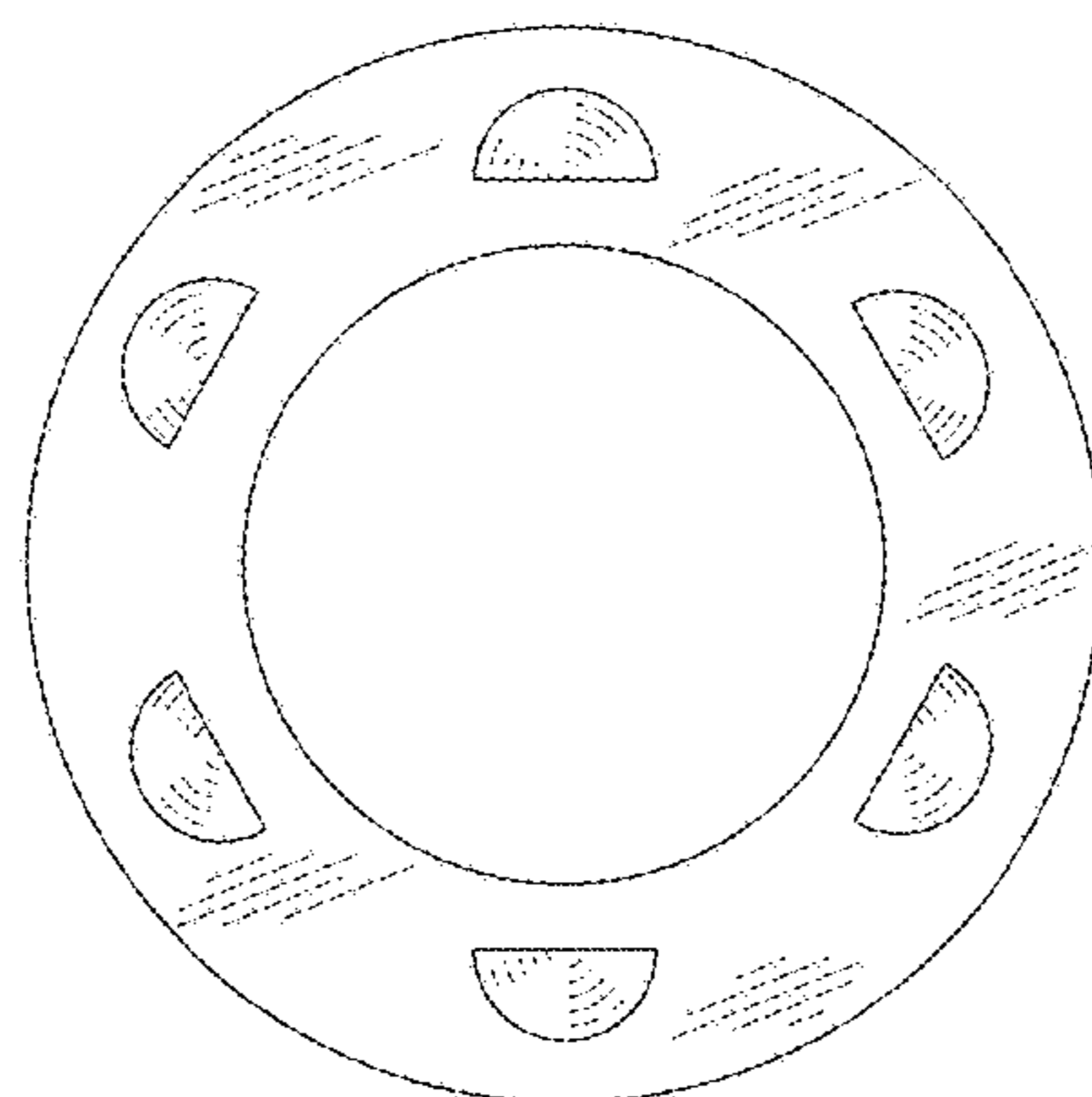

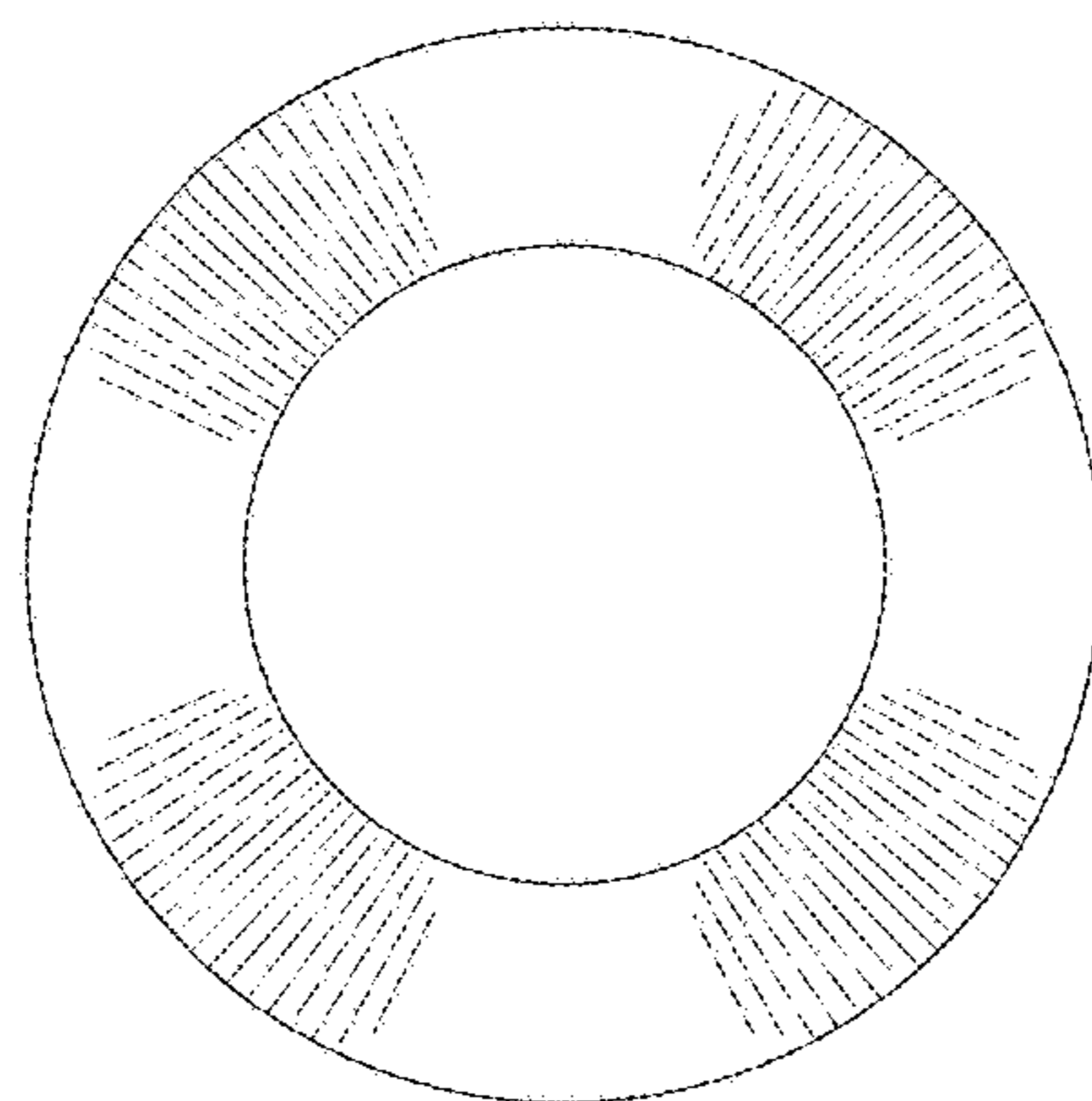
