(57) **CLAIM**

The ornamental design for a corner shelf unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a corner shelf unit according to the present invention, wherein edges of shelves of the corner shelf unit have a squared edge.

FIG. 2 is a front elevation view of the corner shelf unit illustrated in FIG. 1.

FIG. 3 is a rear elevation view of the corner shelf unit illustrated in FIG. 1.

FIG. 4 is a side elevation view of the corner shelf unit illustrated in FIG. 1.

FIG. 5 is another side elevation view of the corner shelf unit illustrated in FIG. 1.

FIG. 6 is a top plan view of the corner shelf unit illustrated in FIG. 1.

FIG. 7 is a bottom plan view of the corner shelf unit illustrated in FIG. 1.

FIG. 8 is a front perspective view of a corner shelf unit according to the present invention, wherein edges of shelves of the corner shelf unit have a rounded edge.

FIG. 9 is a front elevation view of the corner shelf unit illustrated in FIG. 8.

FIG. 10 is a rear elevation view of the corner shelf unit illustrated in FIG. 8.

FIG. 11 is a side elevation view of the corner shelf unit illustrated in FIG. 8.

FIG. 12 is another side elevation view of the corner shelf unit illustrated in FIG. 8.

FIG. 13 is a top plan view of the corner shelf unit illustrated in FIG. 8.

FIG. 14 is a bottom plan view of the corner shelf unit illustrated in FIG. 8.

FIG. 15 is a front perspective view of a shelf positioned on any one of a lower shelf position than the uppermost shelf of the corner shelf unit illustrated in FIG. 8.

FIG. 16 is a front elevation view of the shelf illustrated in FIG. 15.

FIG. 17 is a rear elevation view of the shelf illustrated in FIG. 15.

FIG. 18 is a side elevation view of the shelf illustrated in FIG. 15.

FIG. 19 is another side elevation view of the shelf illustrated in FIG. 15.

FIG. 20 is a top plan elevation view of the shelf illustrated in FIG. 15.

FIG. 21 is a bottom plan view of the shelf illustrated in FIG. 15.

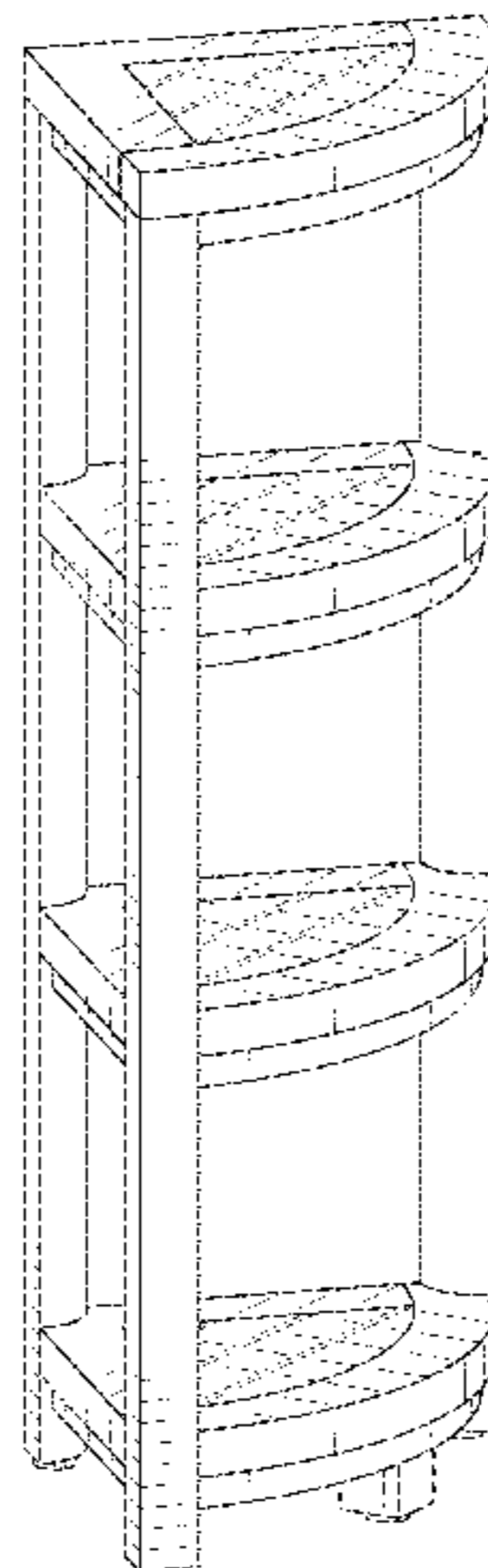


FIG. 22 is a front perspective view of a corner shelf unit according to another embodiment of the present invention, wherein the slats on the shelves of this embodiment of the corner shelf unit have a configuration different from the slats on the shelves of the embodiment of the corner shelf unit illustrated in FIG. 1, and wherein edges of shelves of the corner shelf unit have a squared edge.

FIG. 23 is a front elevation view of the corner shelf unit illustrated in FIG. 22.

FIG. 24 is a rear elevation view of the corner shelf unit illustrated in FIG. 22.

FIG. 25 is a side elevation view of the corner shelf unit illustrated in FIG. 22.

FIG. 26 is another side elevation view of the corner shelf unit illustrated in FIG. 22.

FIG. 27 is a top plan view of the corner shelf unit illustrated in FIG. 22; and,

FIG. 28 is a bottom plan view of the corner shelf unit illustrated in FIG. 22.

The broken lines in FIGS. 8-14 depict slats in each shelf of the corner shelf unit that form no part of the claimed invention.

The broken lines in FIGS. 15-21 depict slats in each shelf of the corner shelf unit that form no part of the claimed invention.

The broken lines in FIGS. 22-28 depict slats in each shelf of the corner shelf unit that form no part of the claimed invention.

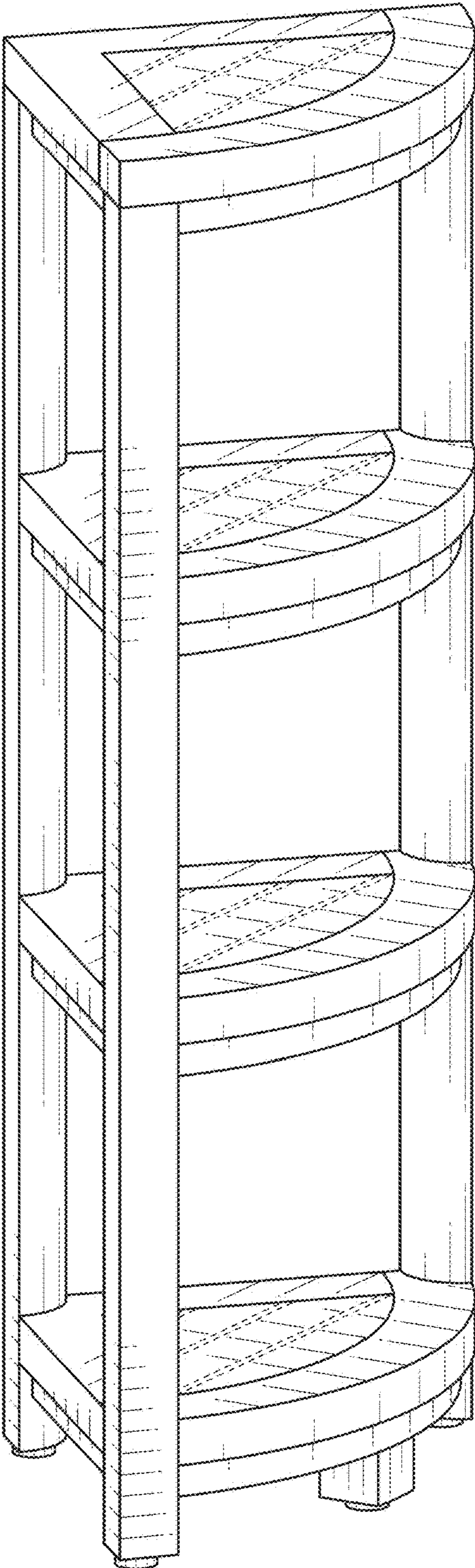

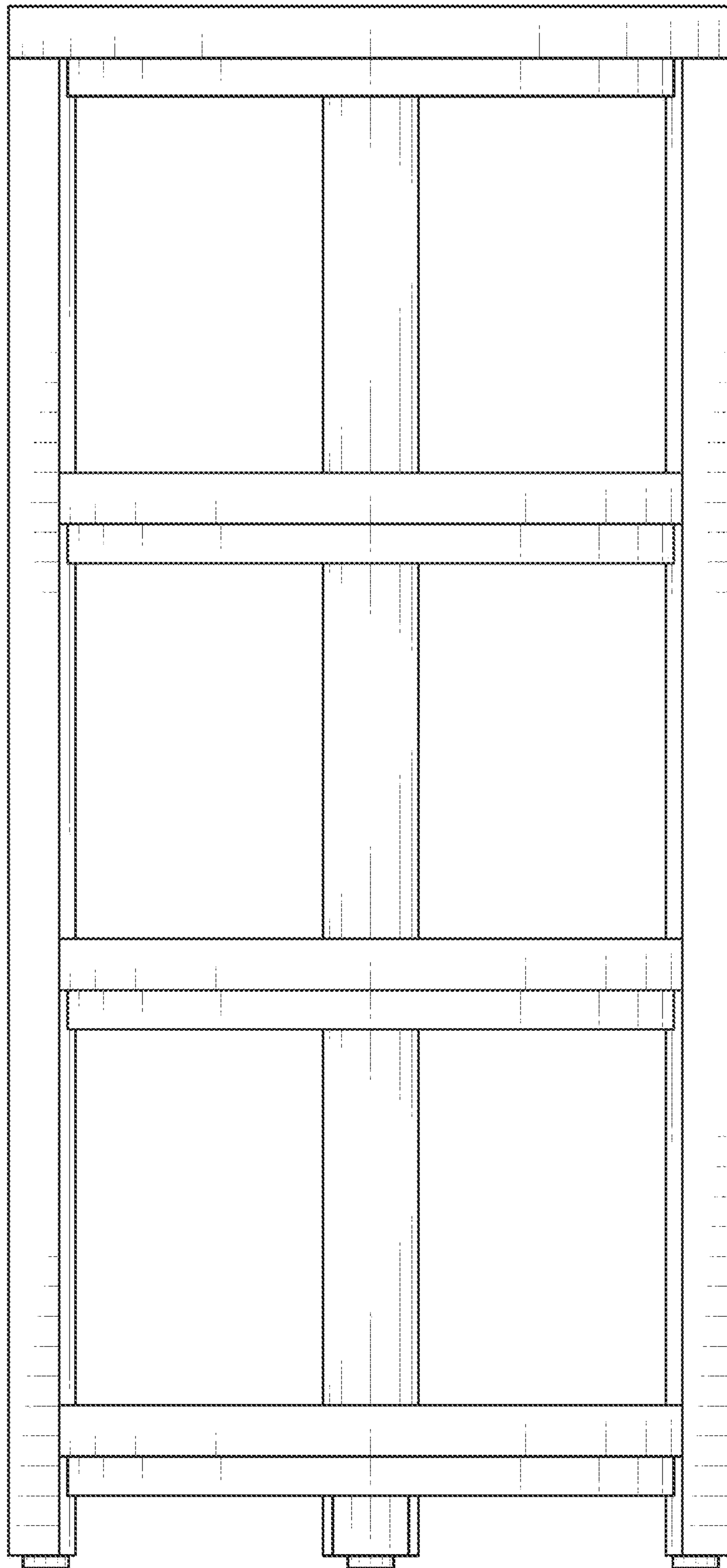

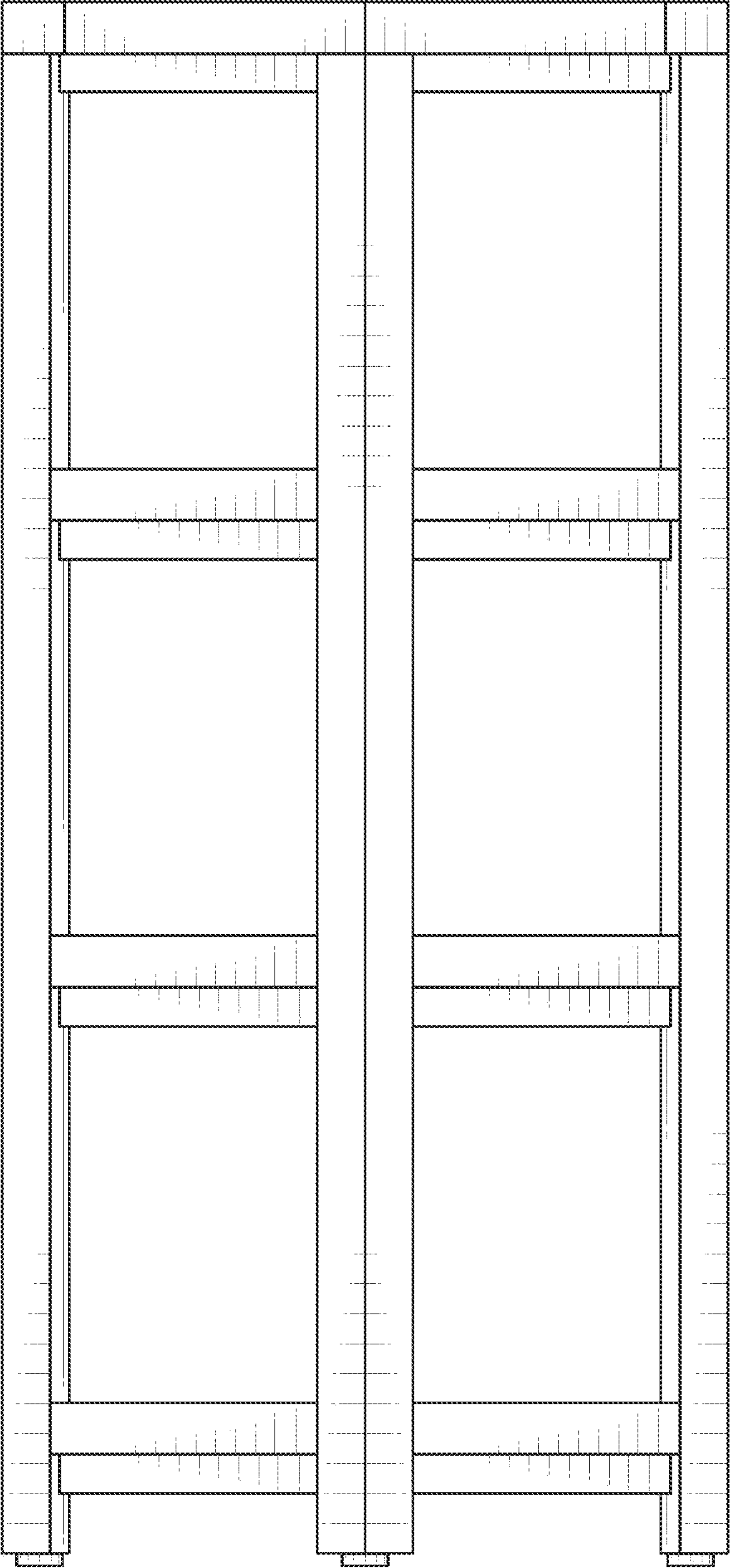

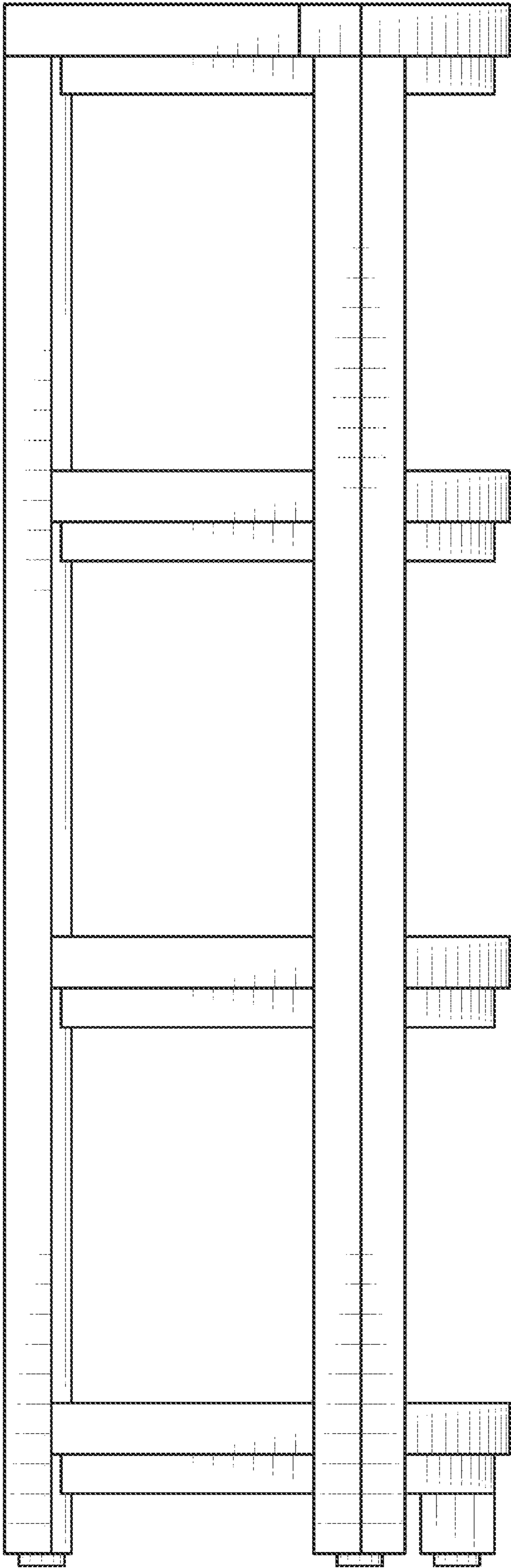

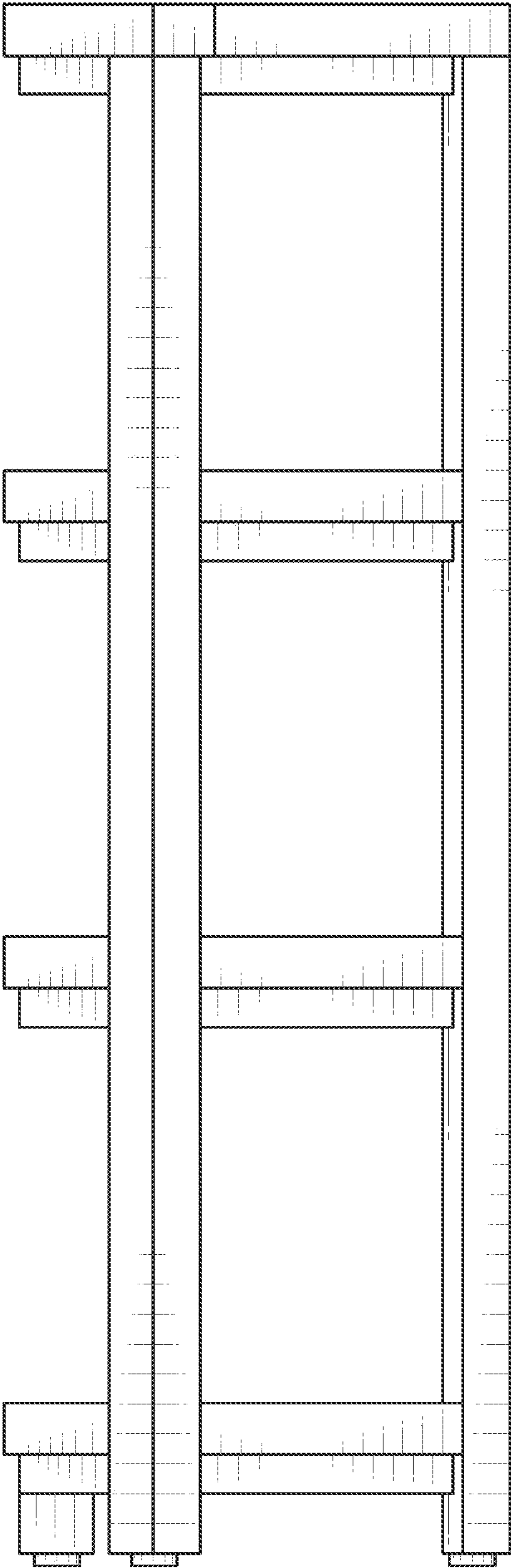

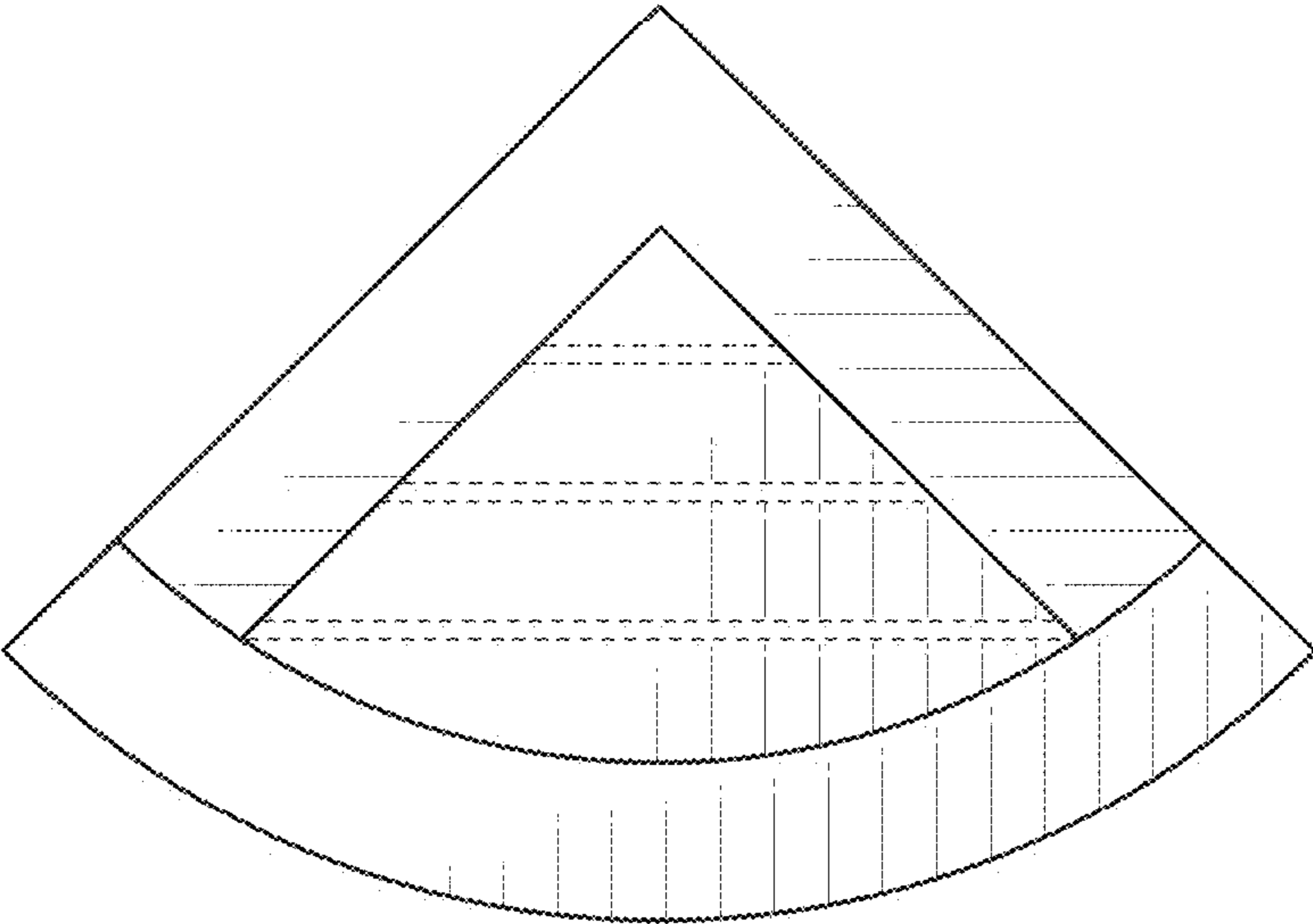

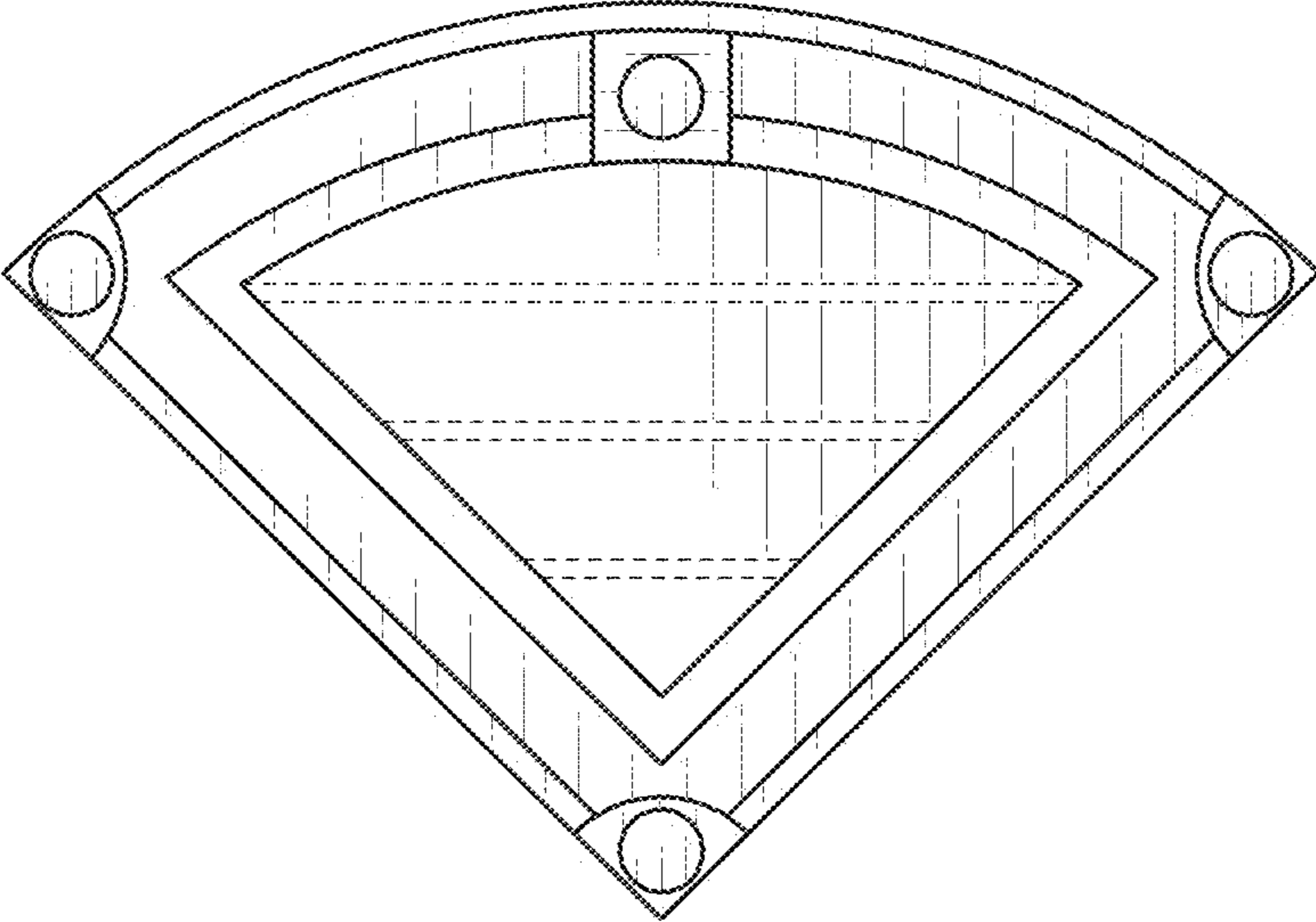

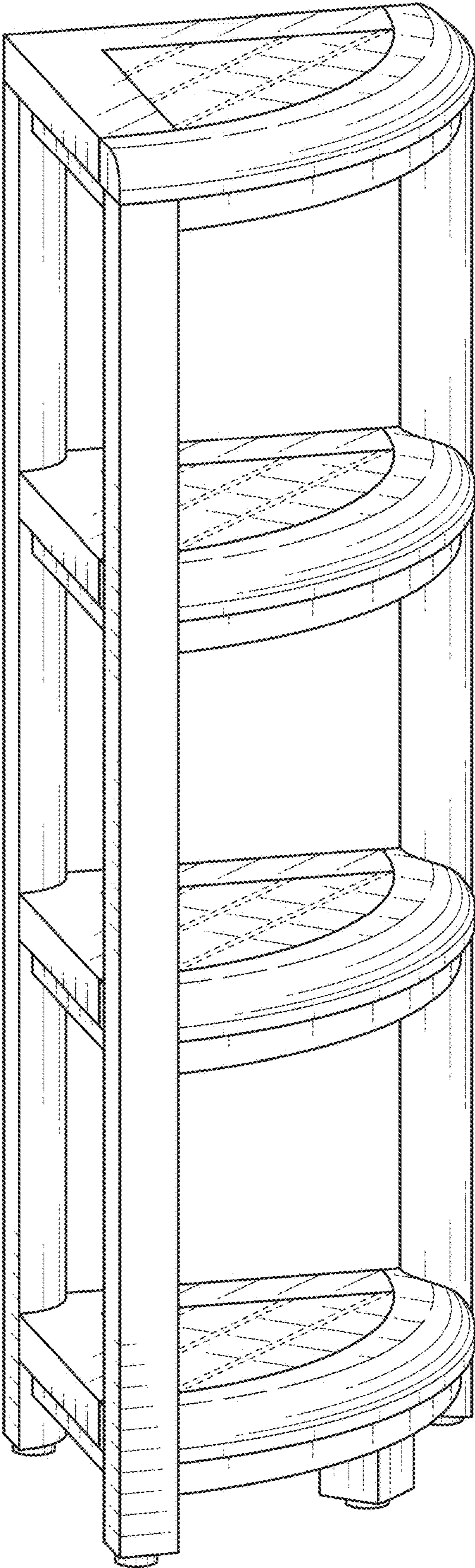

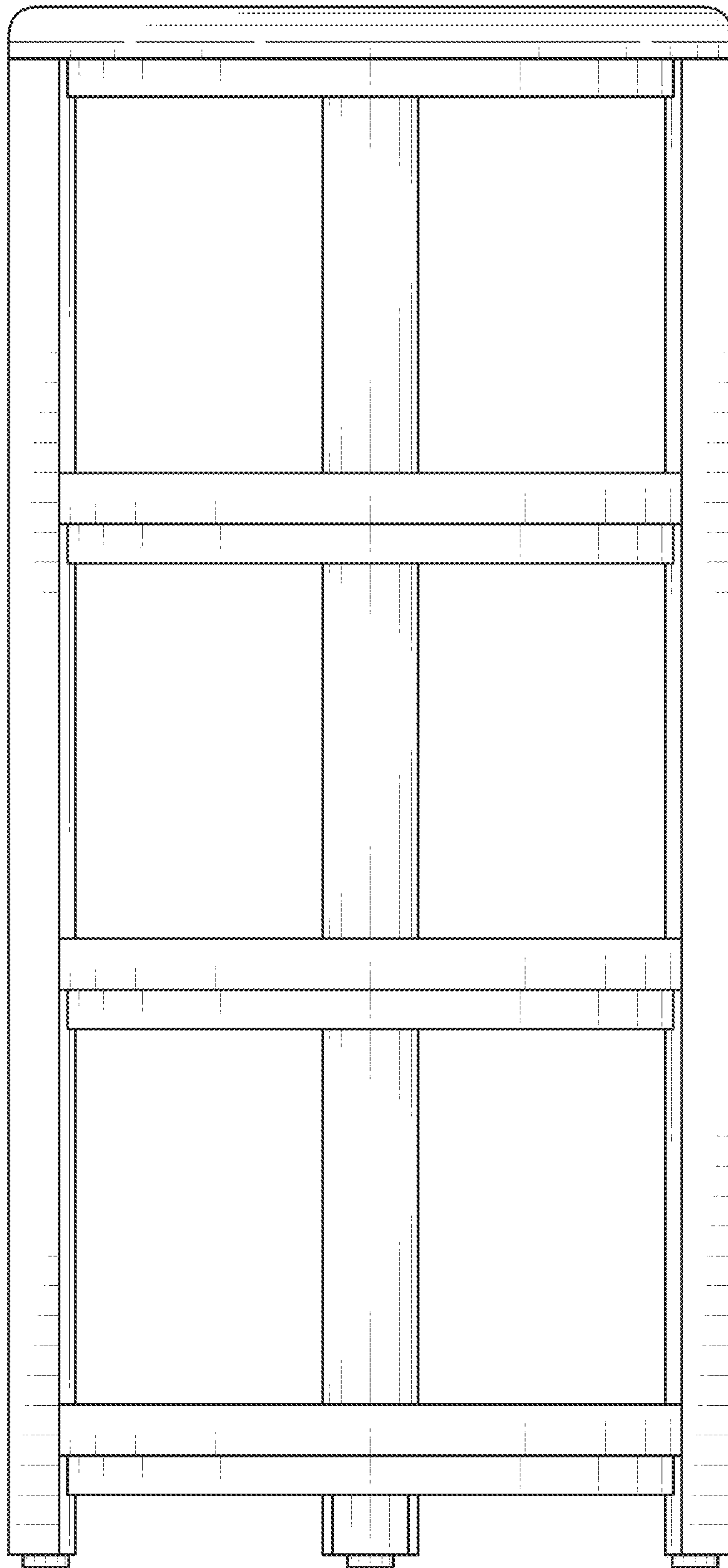

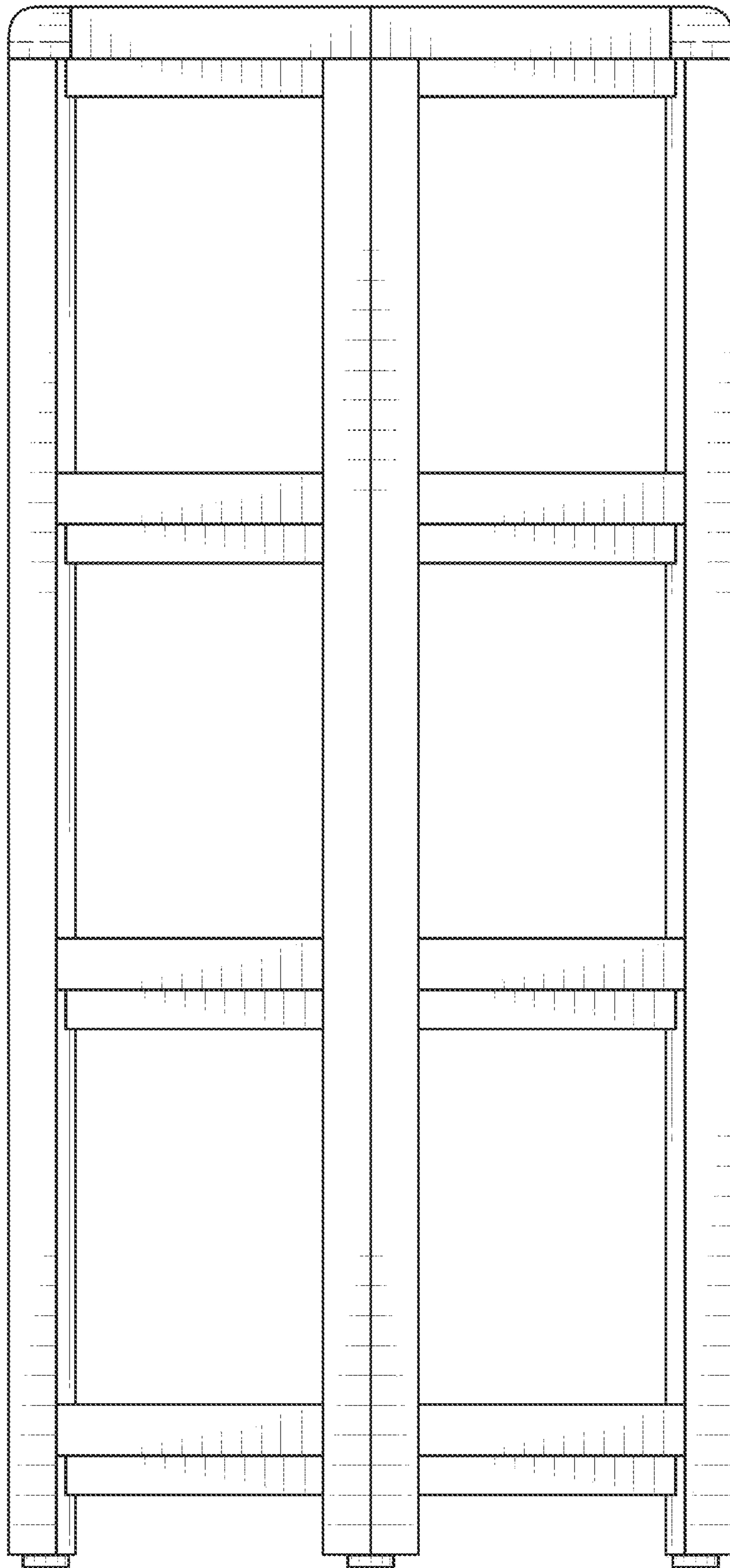

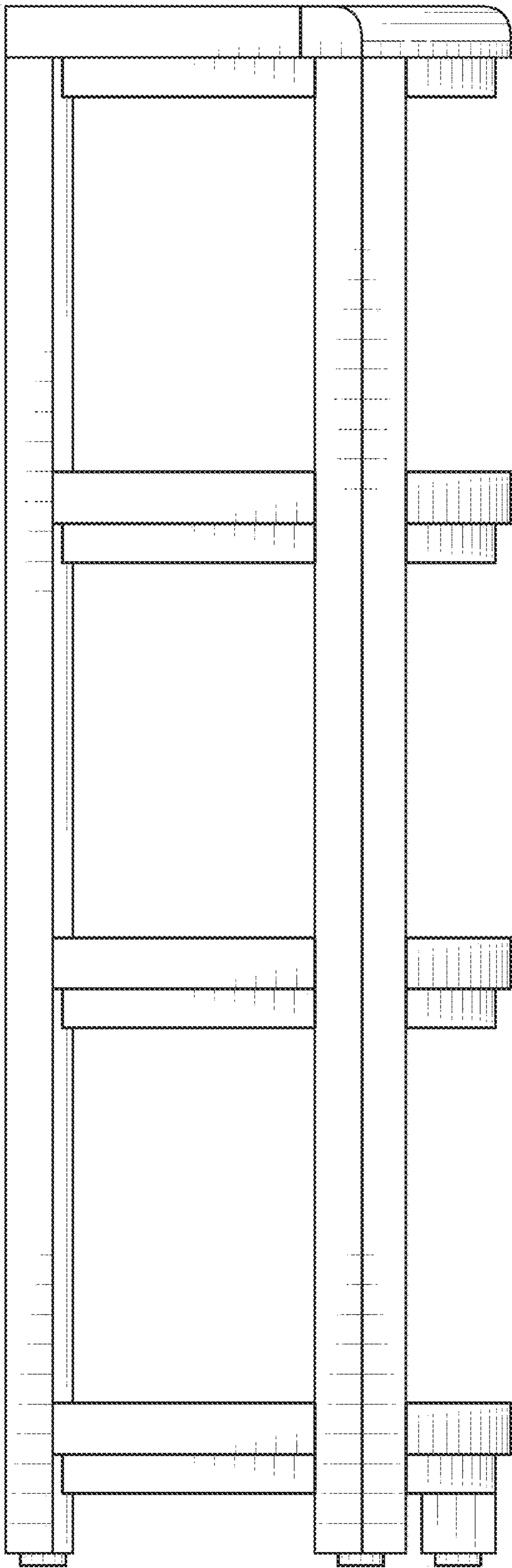

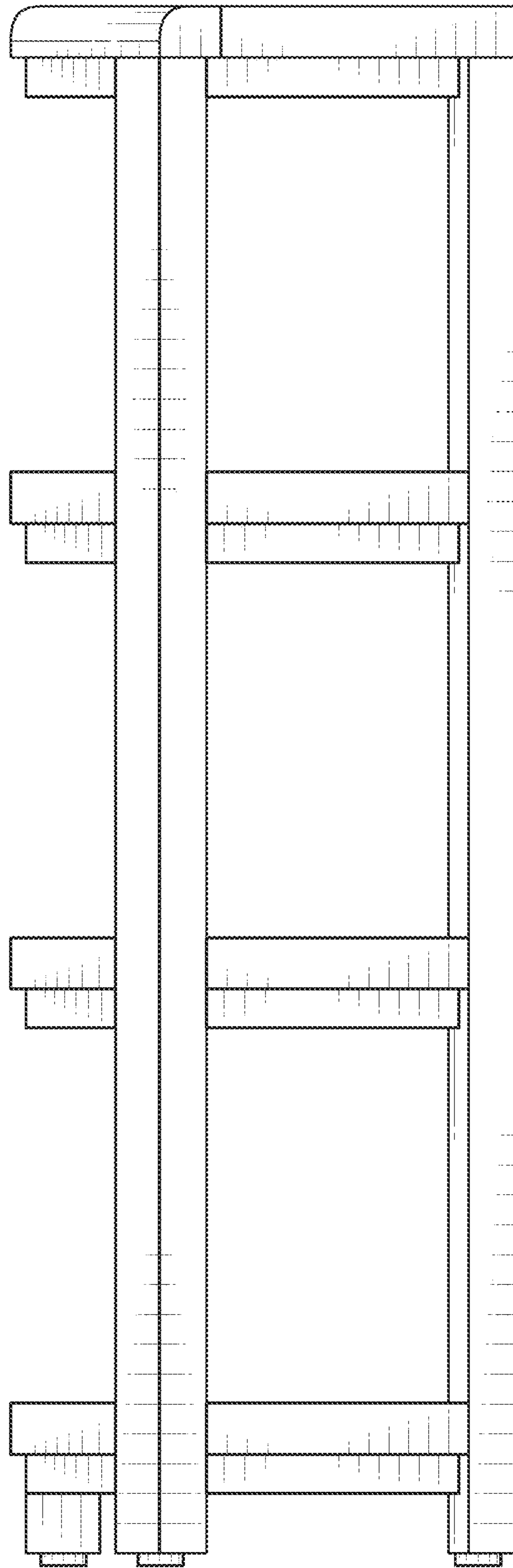

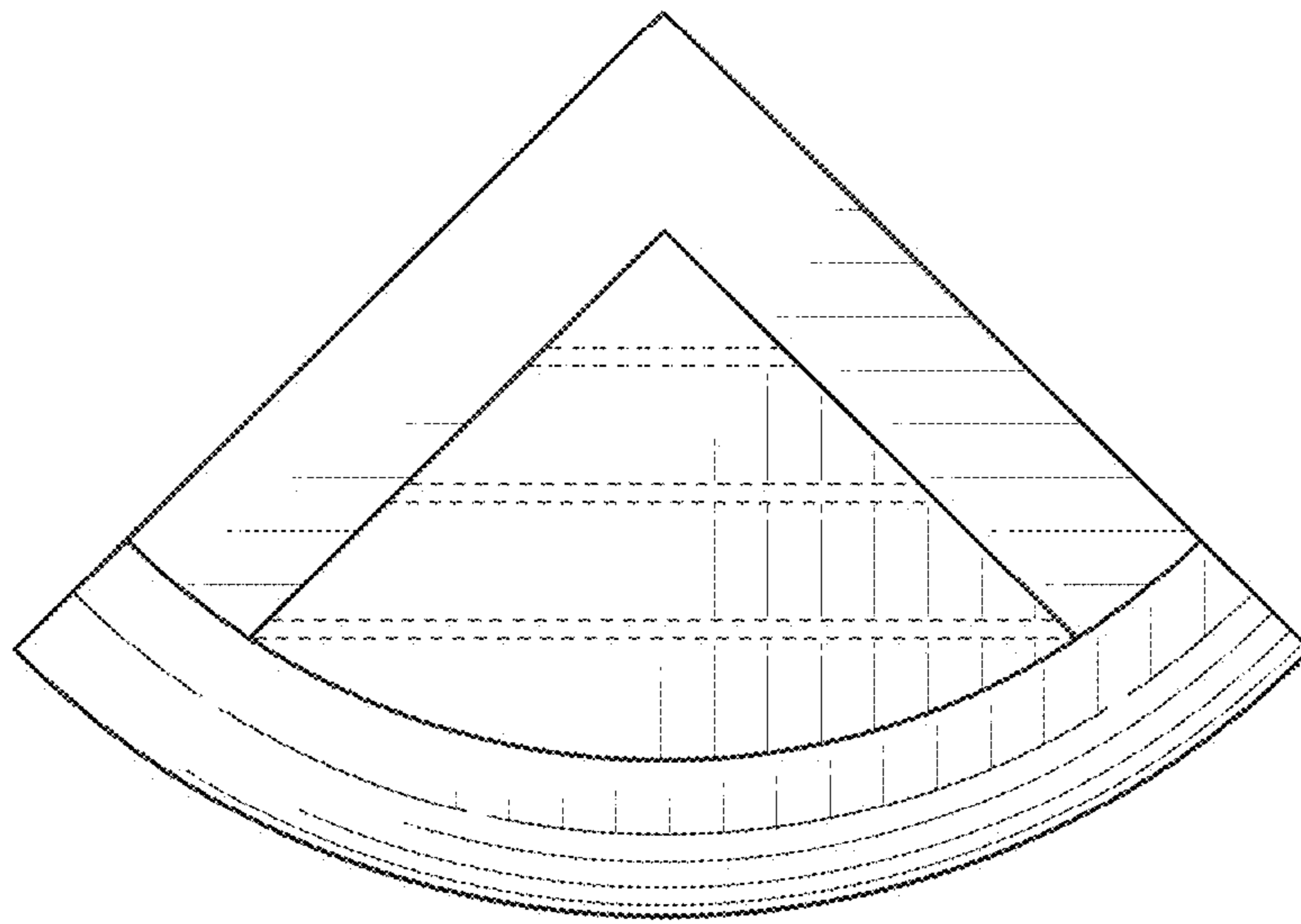

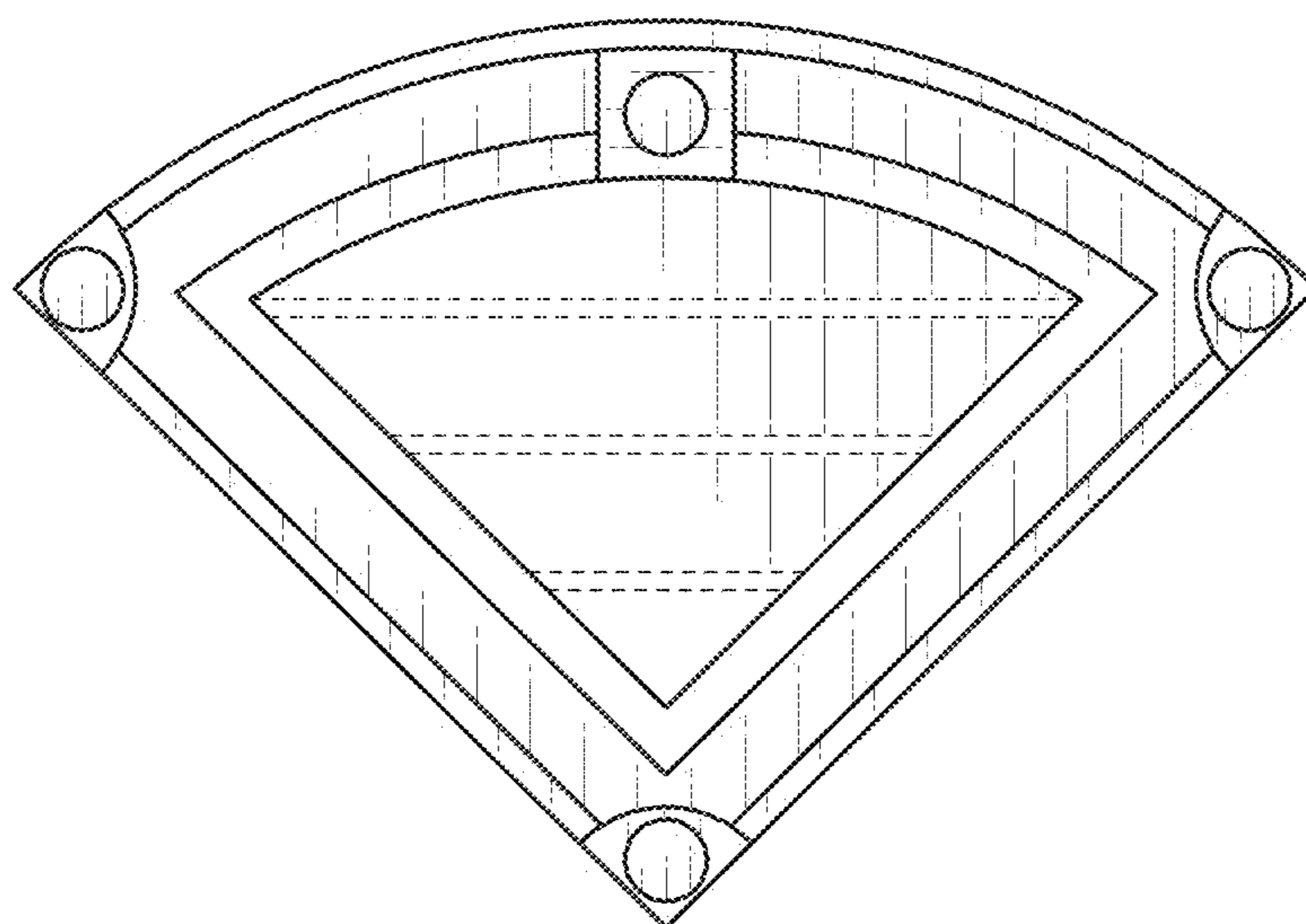

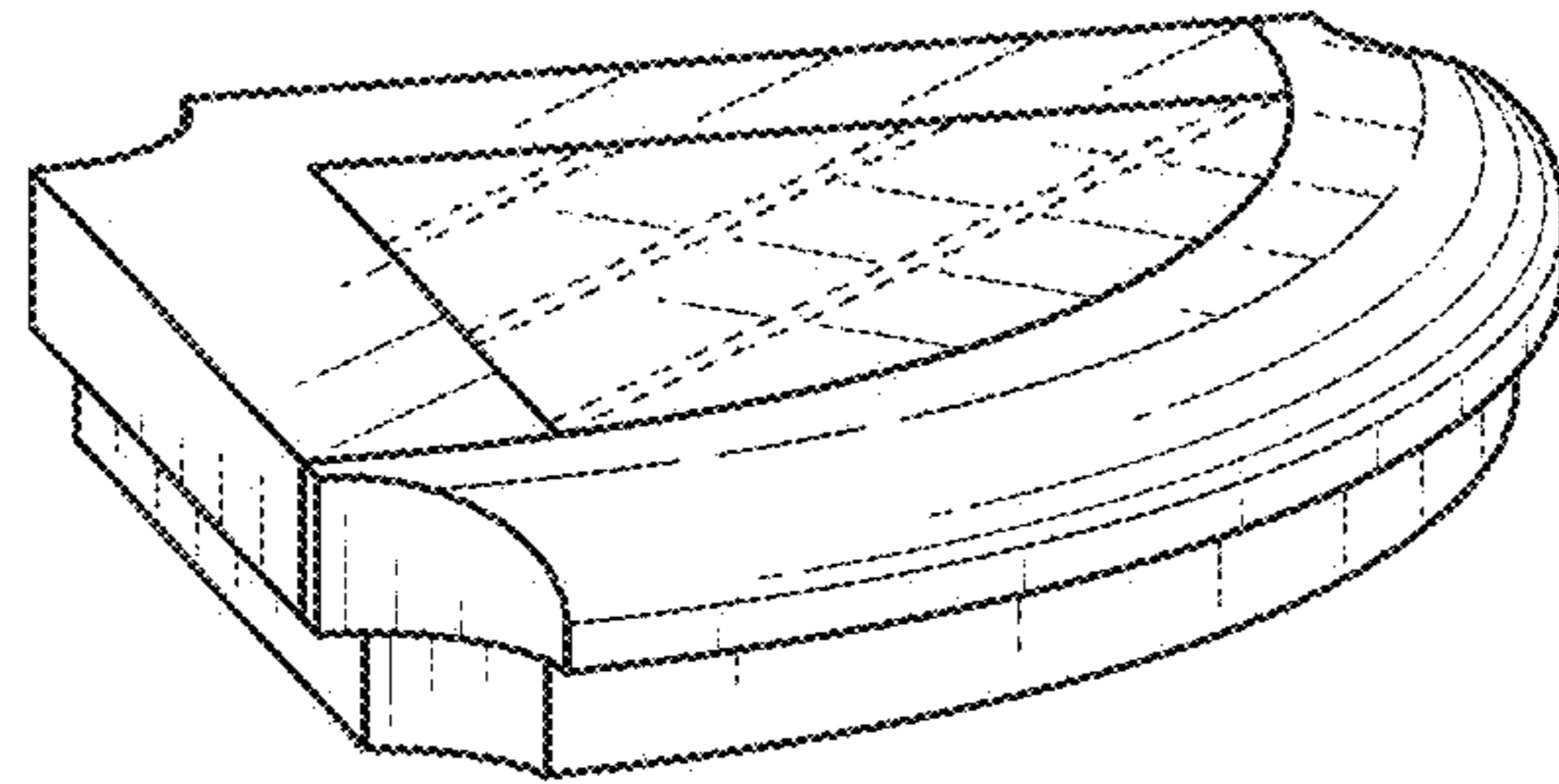

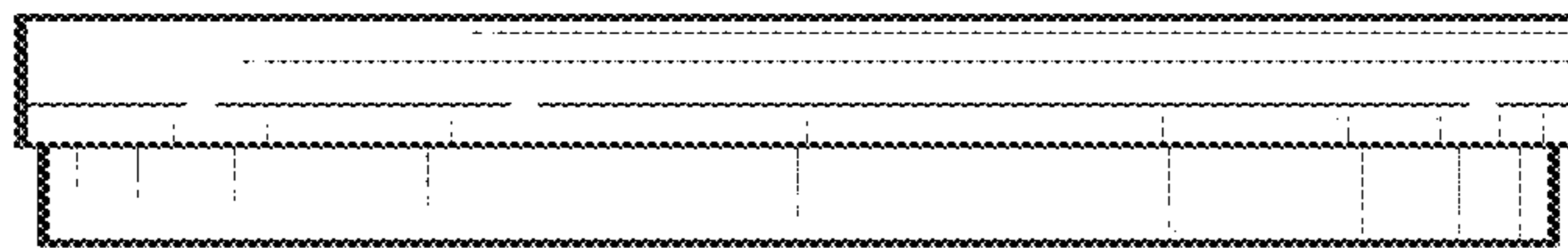

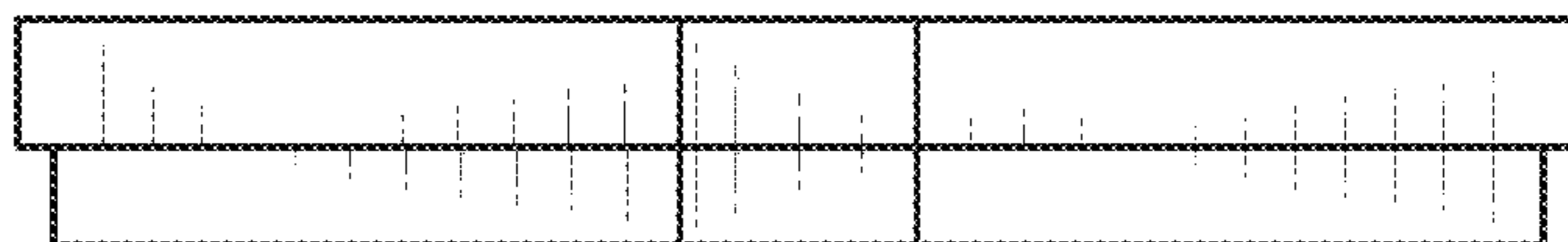

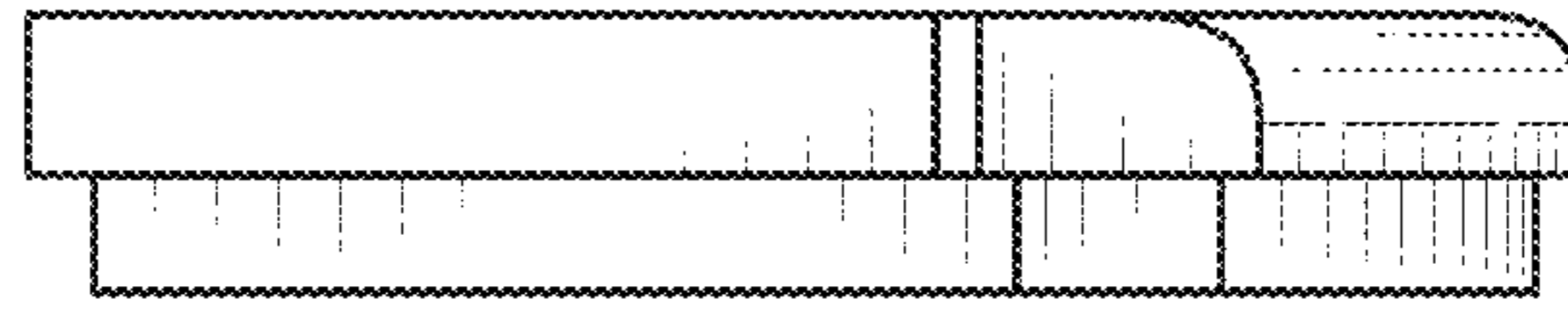

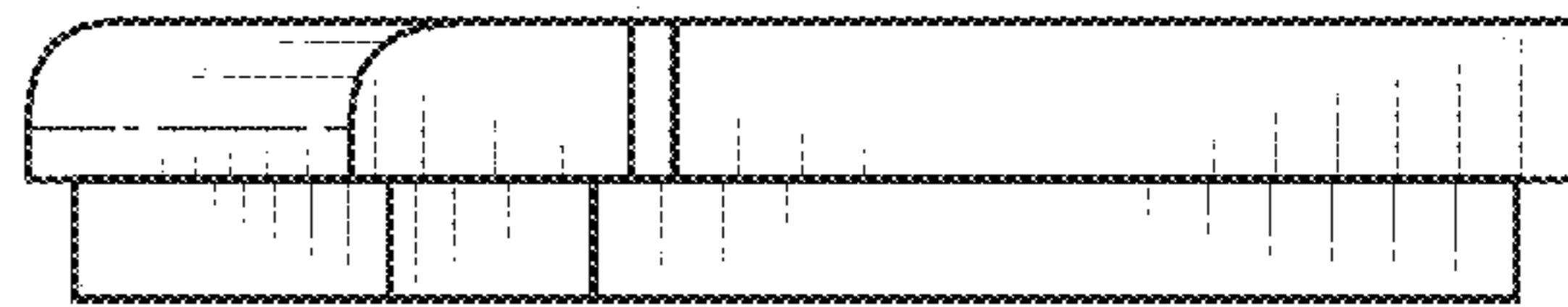

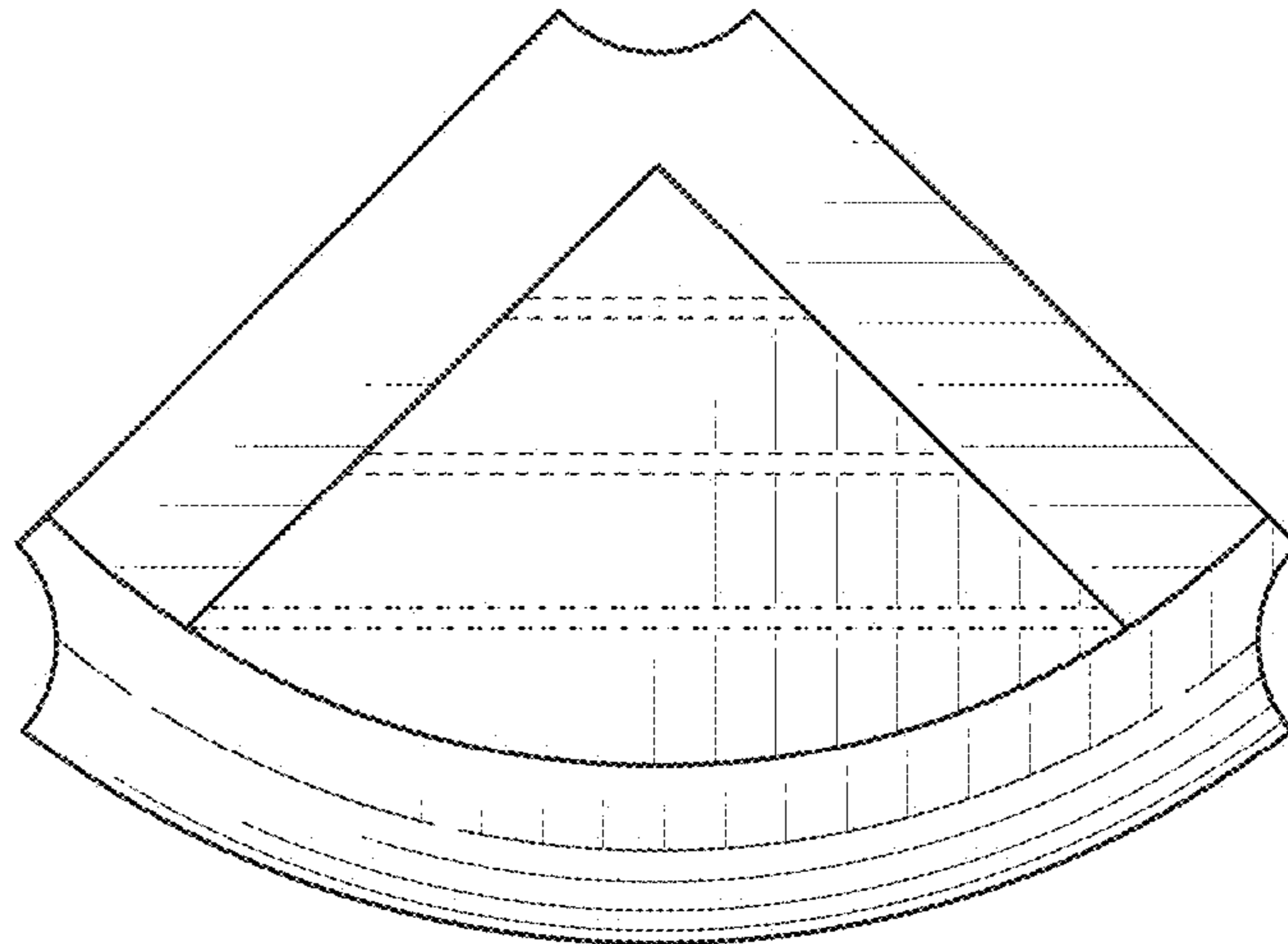

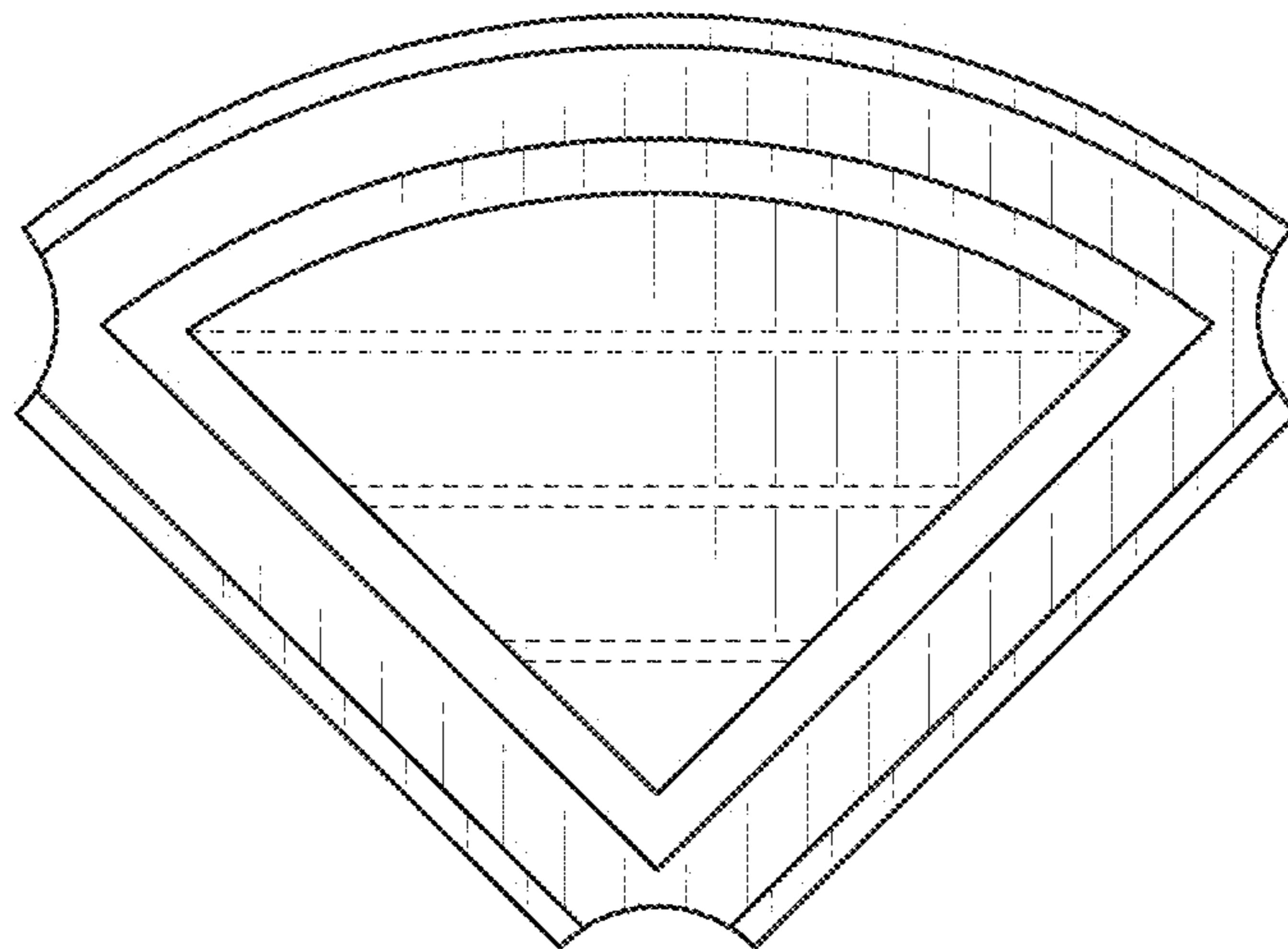

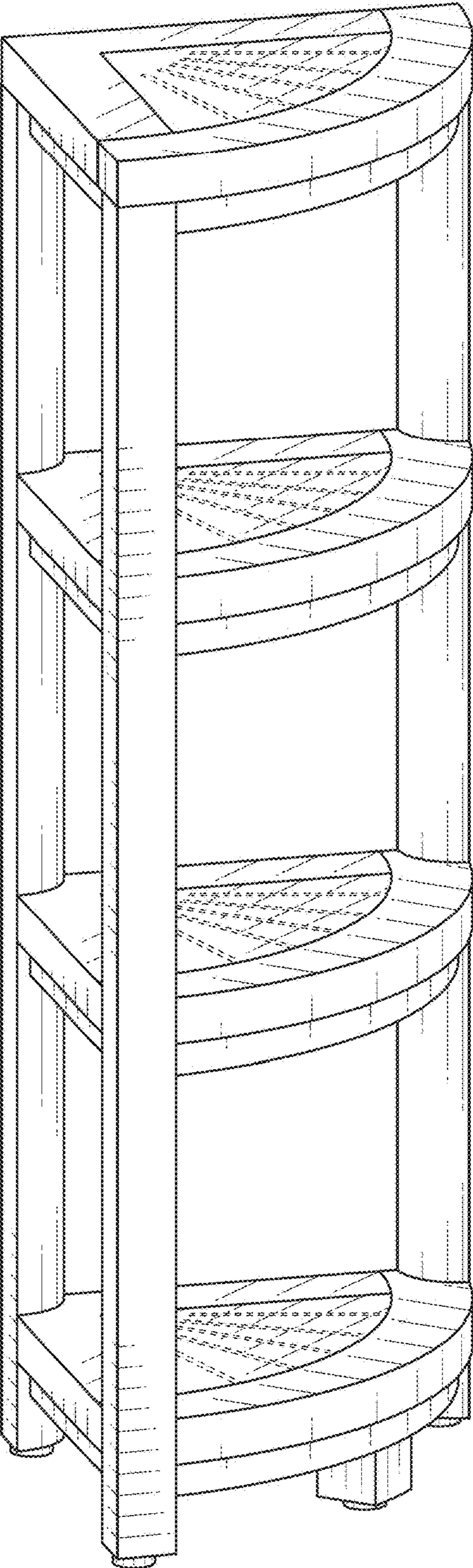

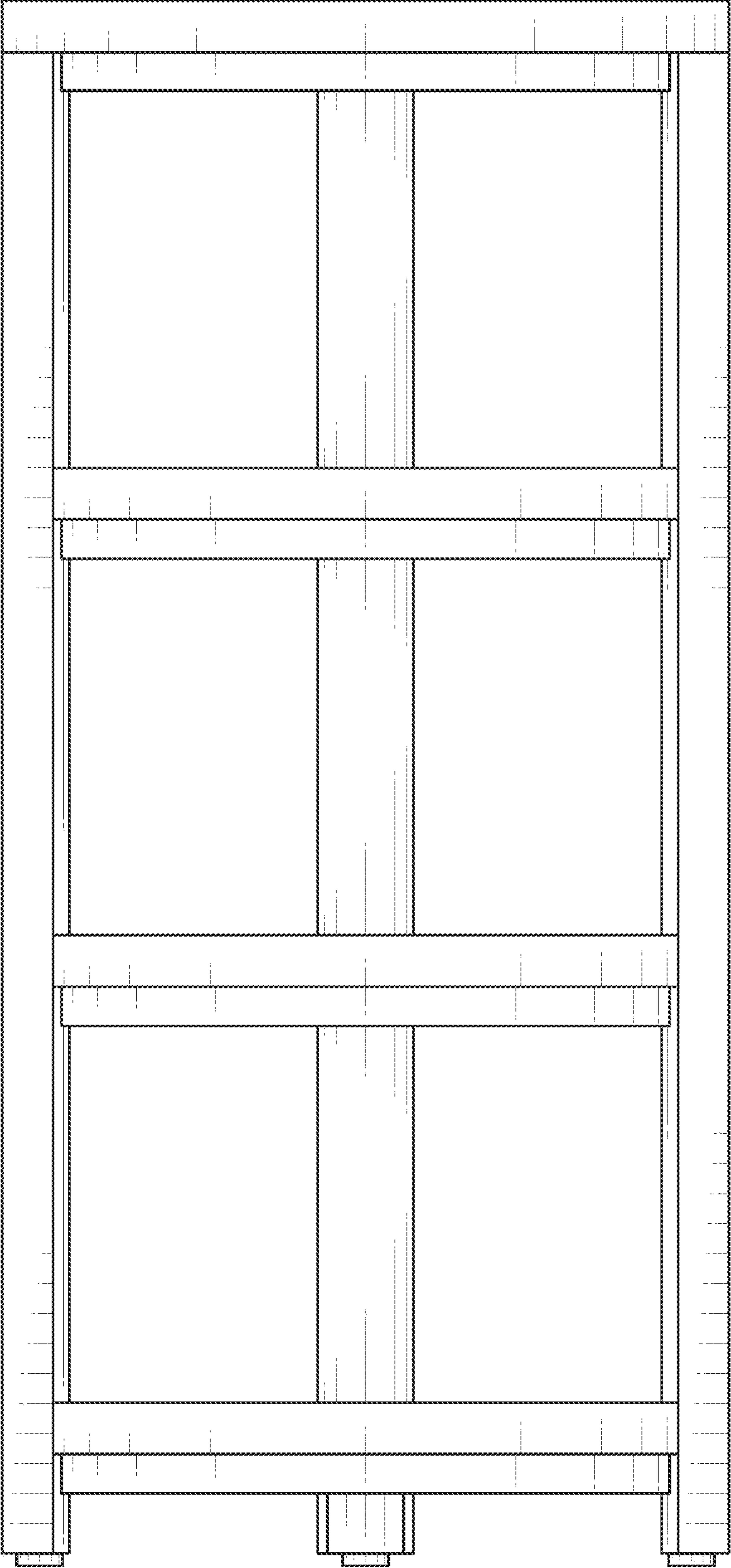

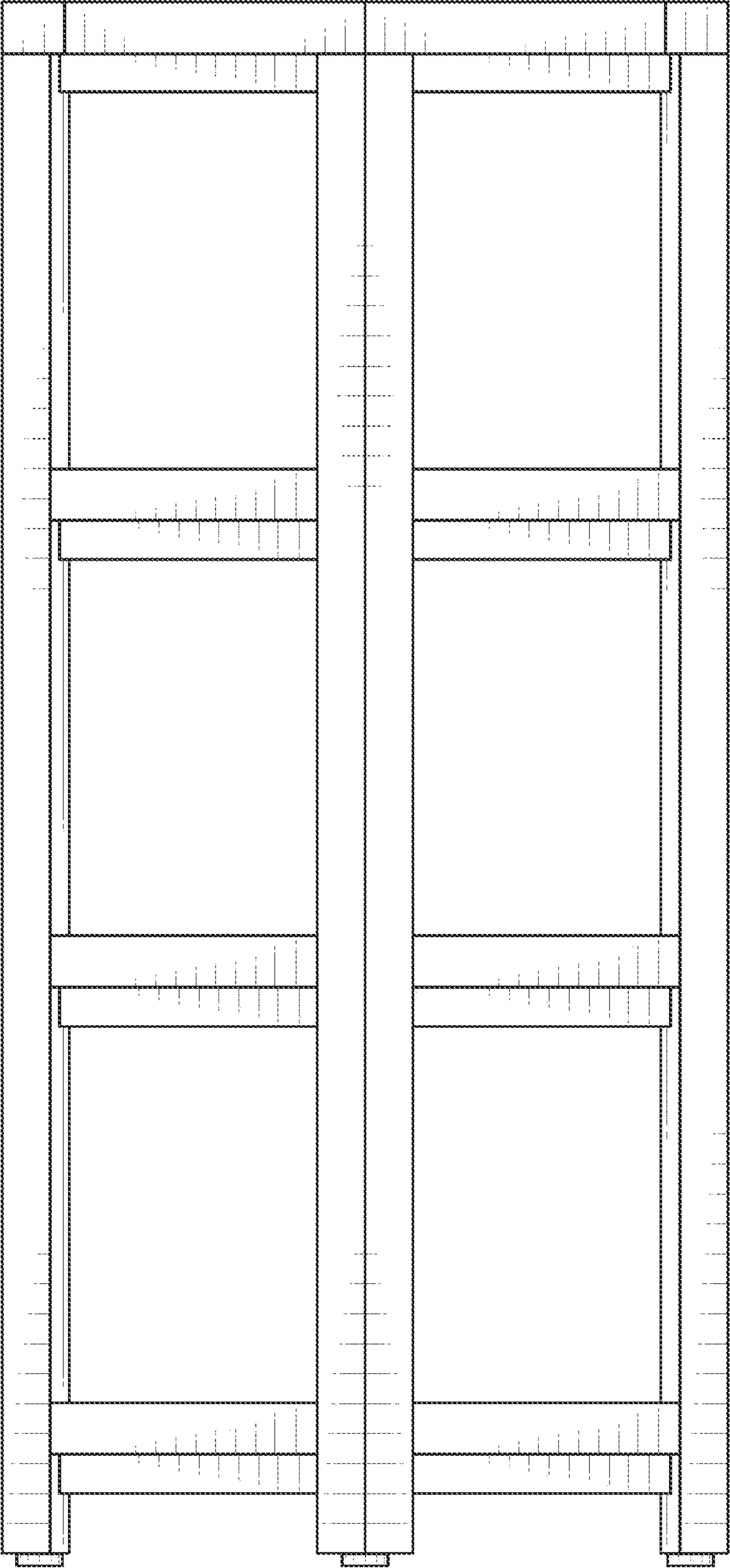

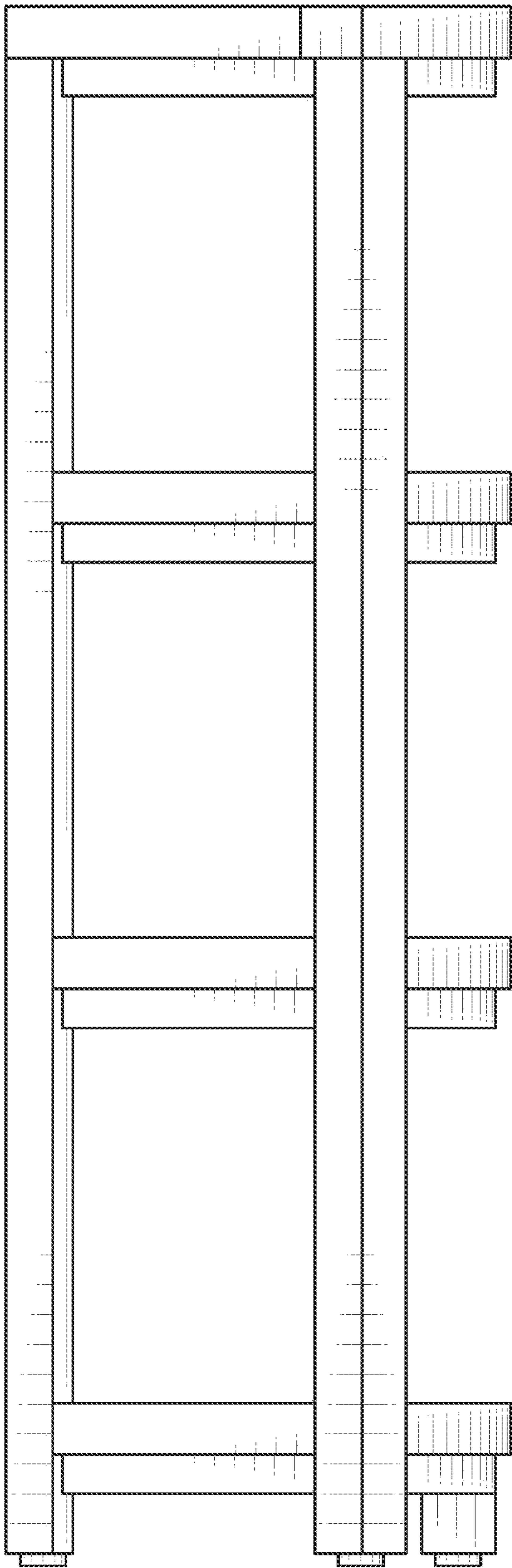

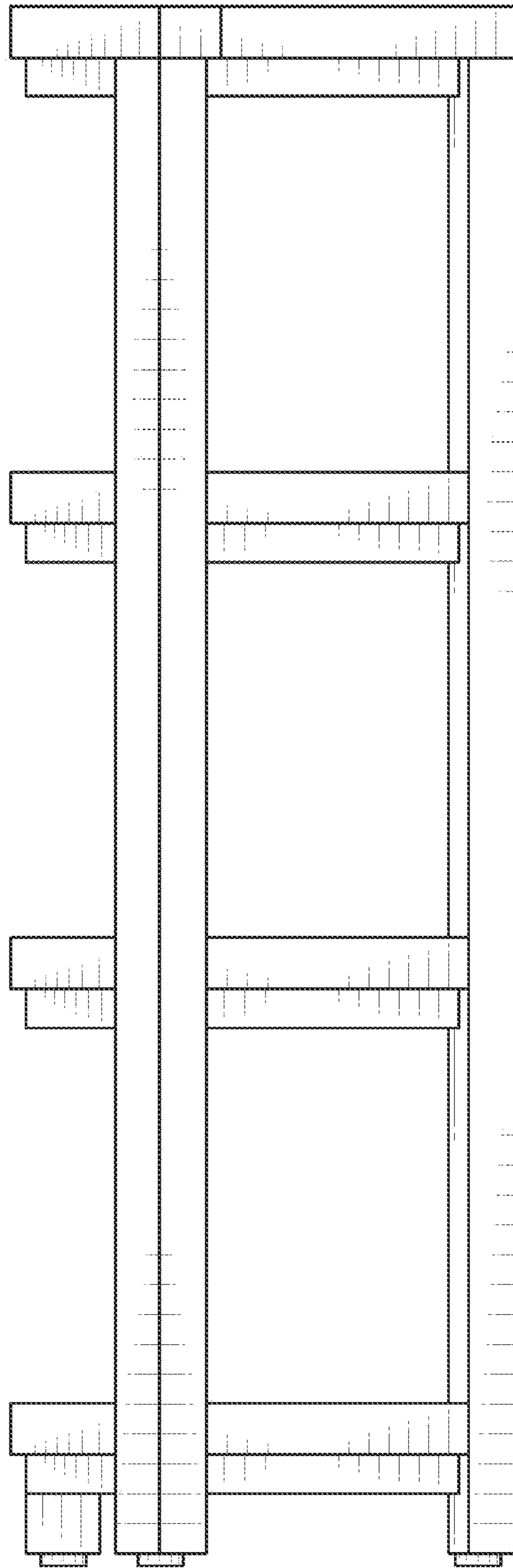

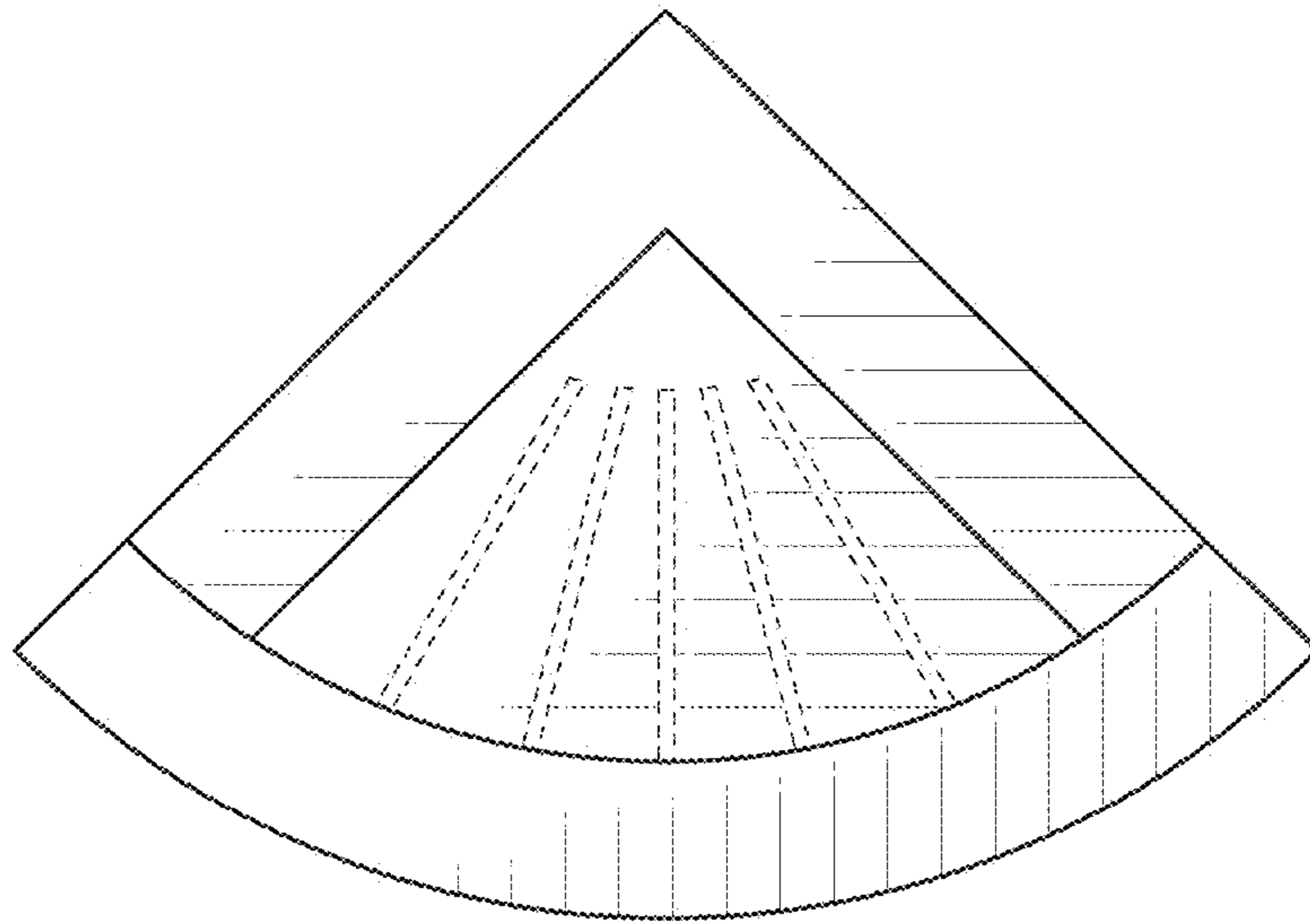

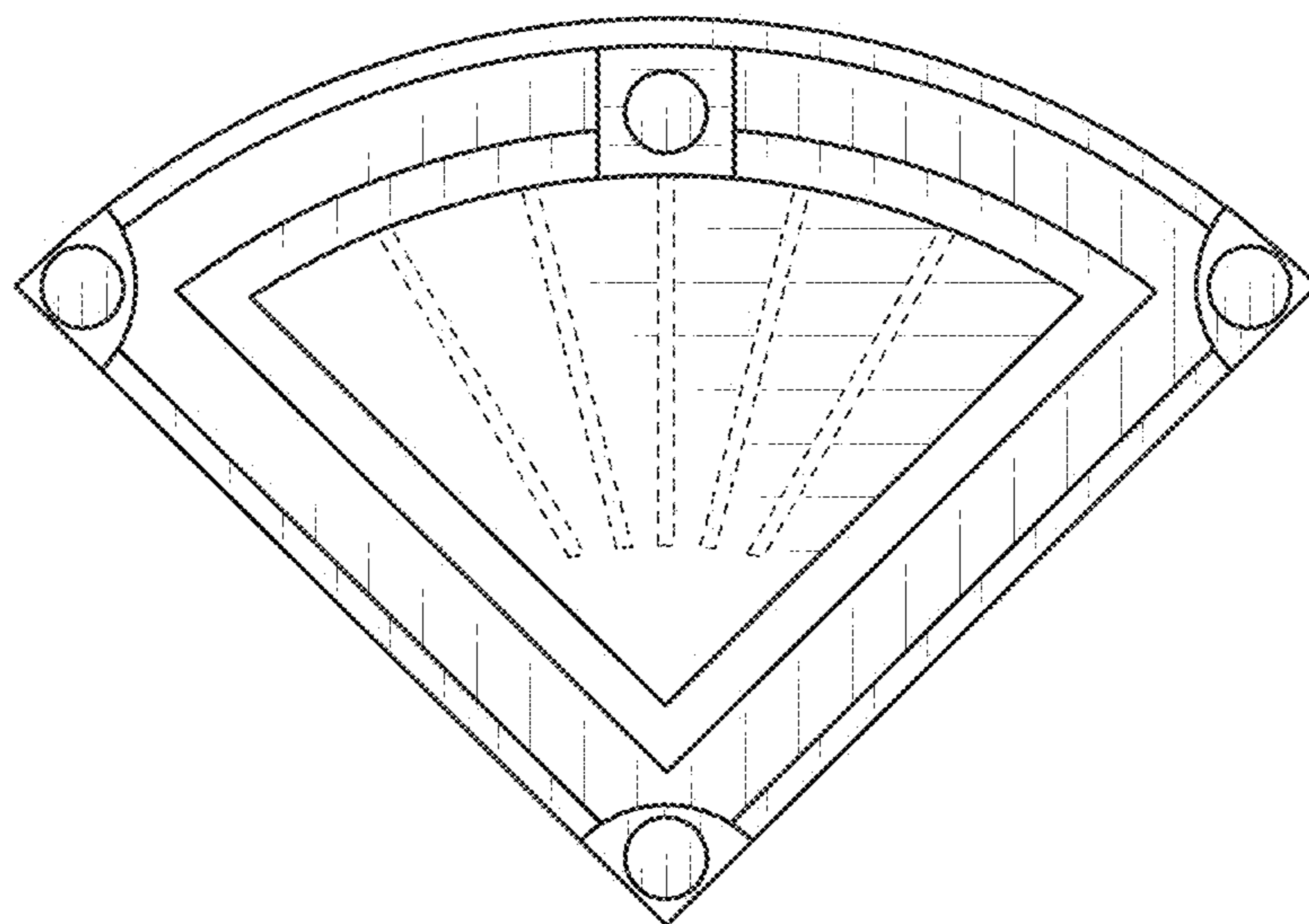
