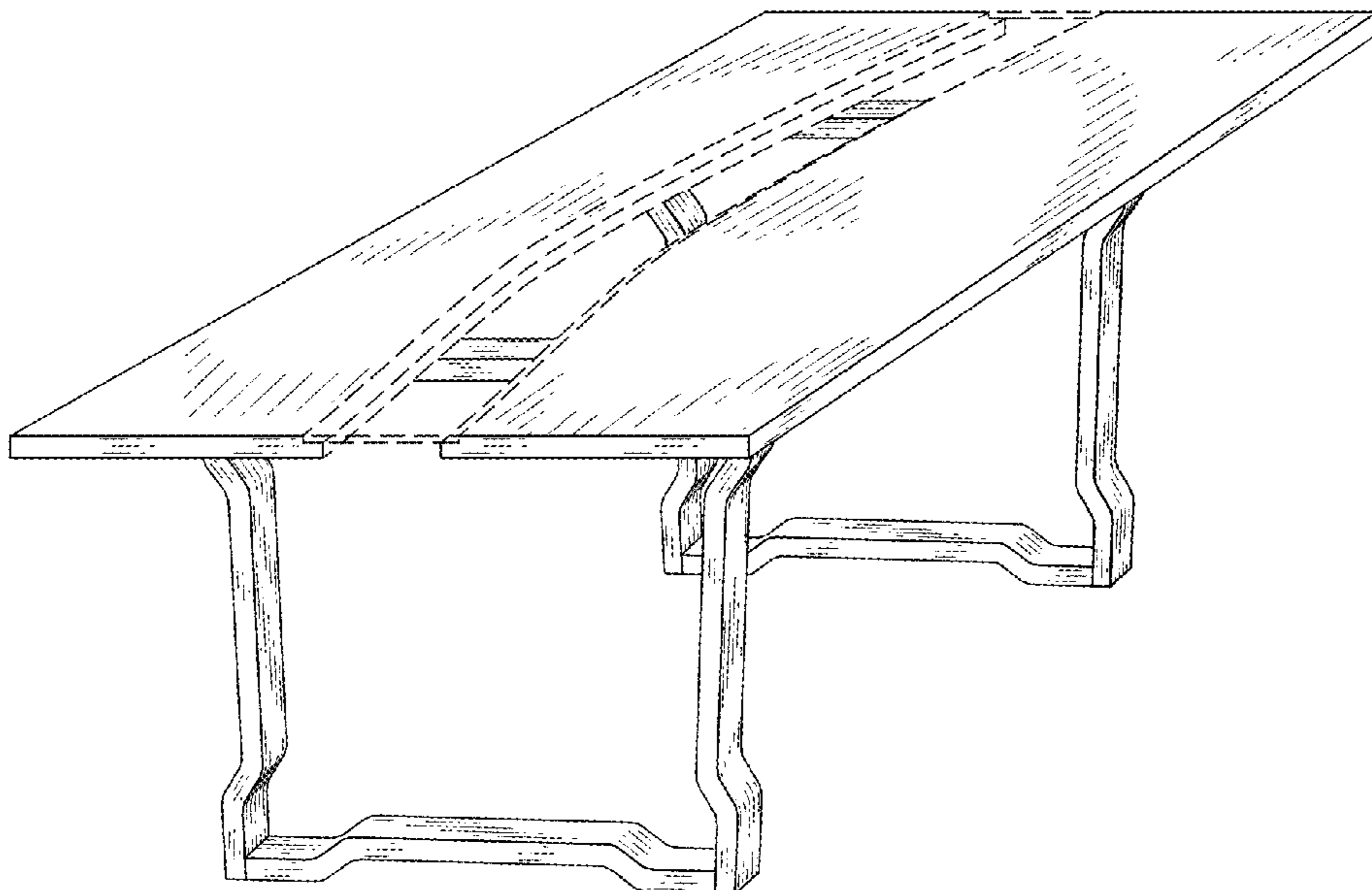
(57) **CLAIM**

The ornamental design for a table with transparent insert, as shown and described.

DESCRIPTION

FIG. 1 is a top, front left-side perspective view of a table with transparent insert, showing our new design; FIG. 2 is a front elevation thereof; FIG. 3 is a back elevation thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left-side elevation view thereof; and, FIG. 7 is a right-side elevation view thereof. The broken lines in the drawings depict portions of the table with transparent insert that form no part of the claimed design.

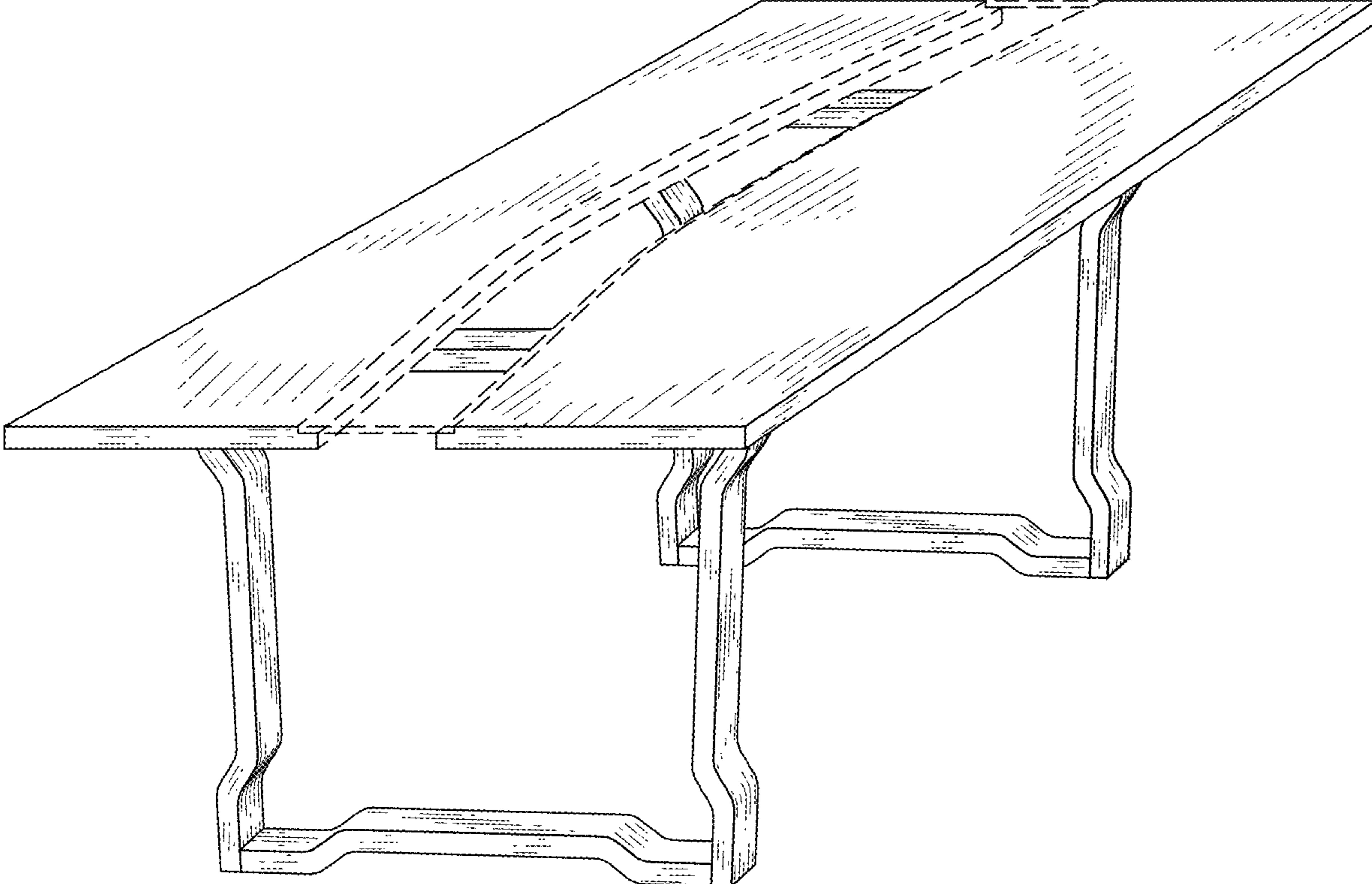

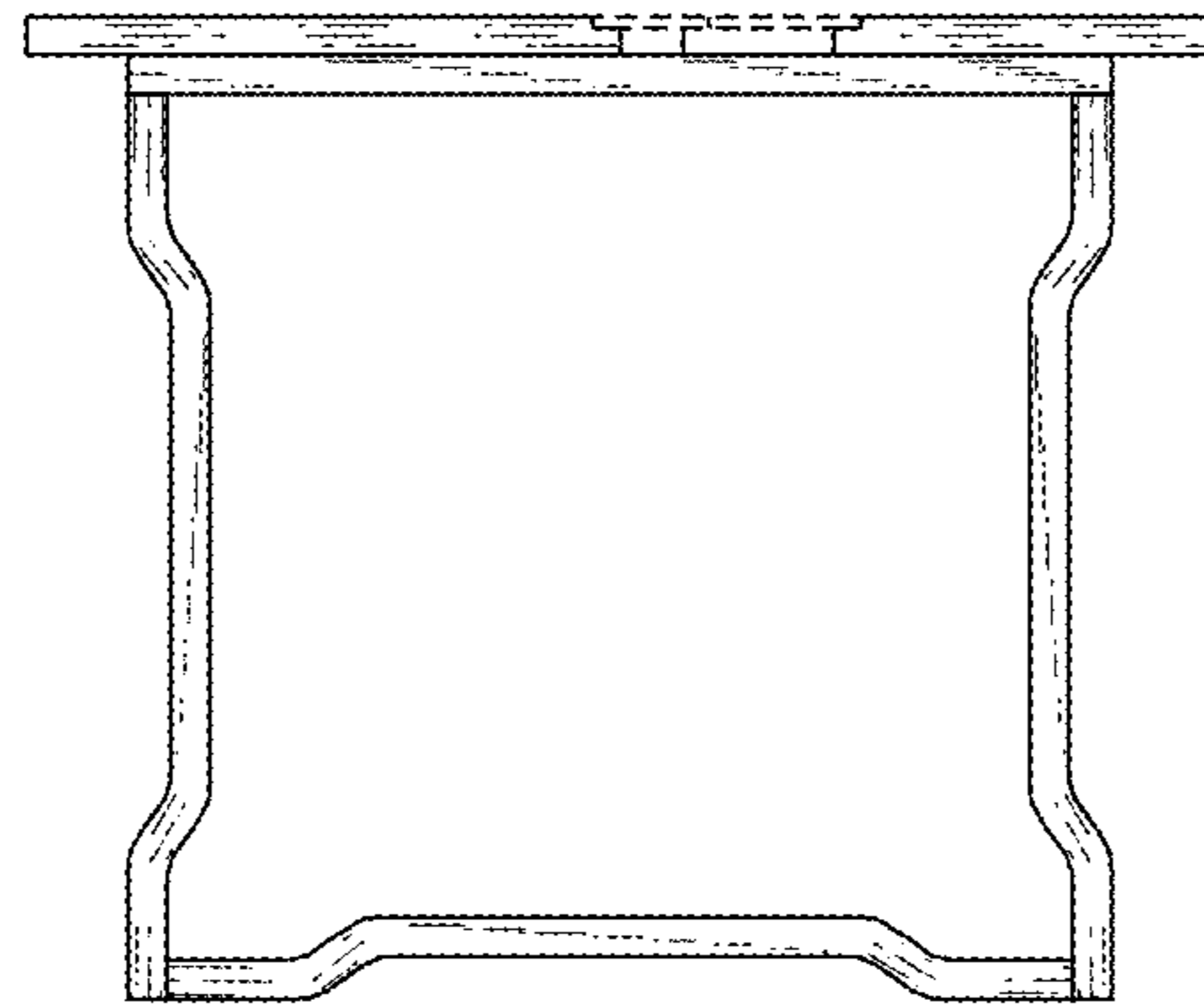

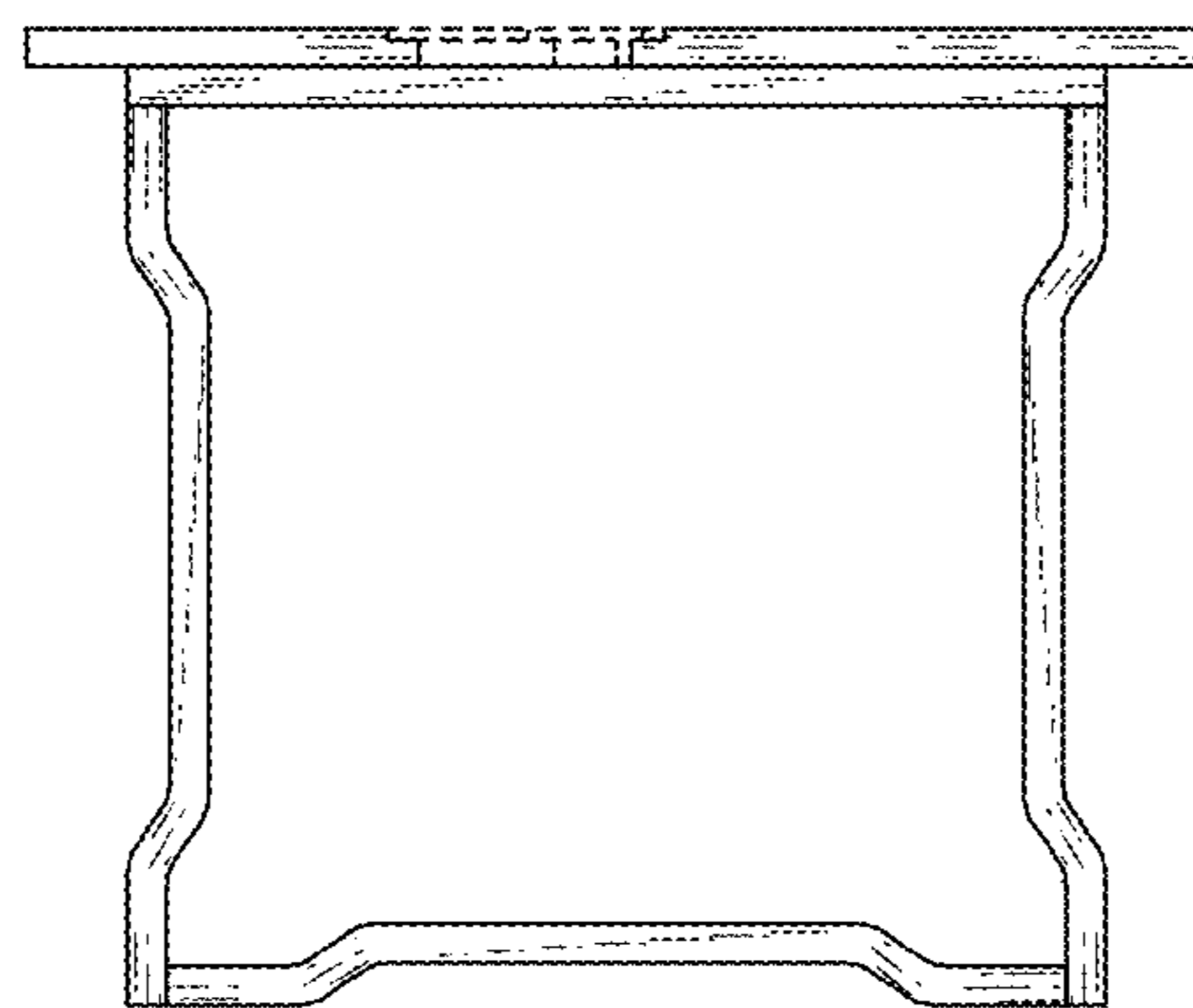

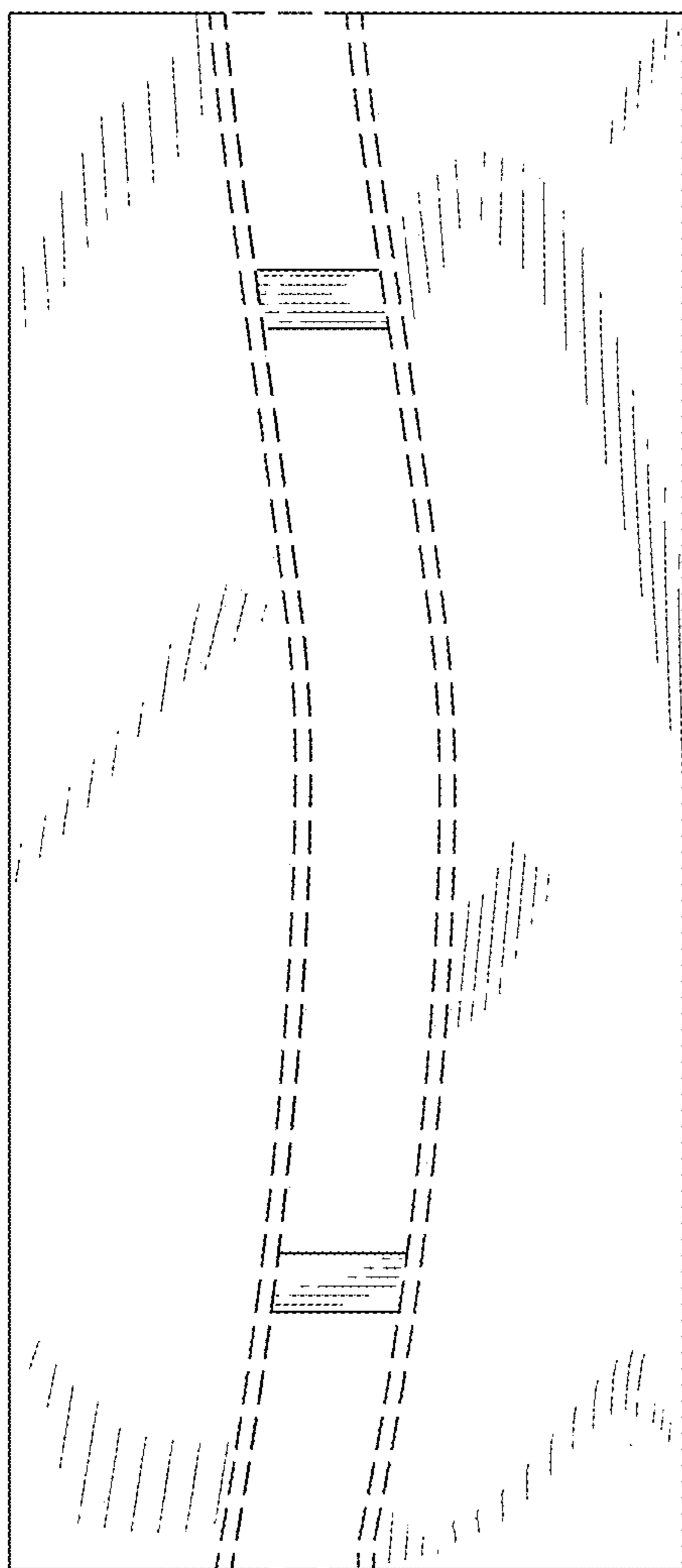

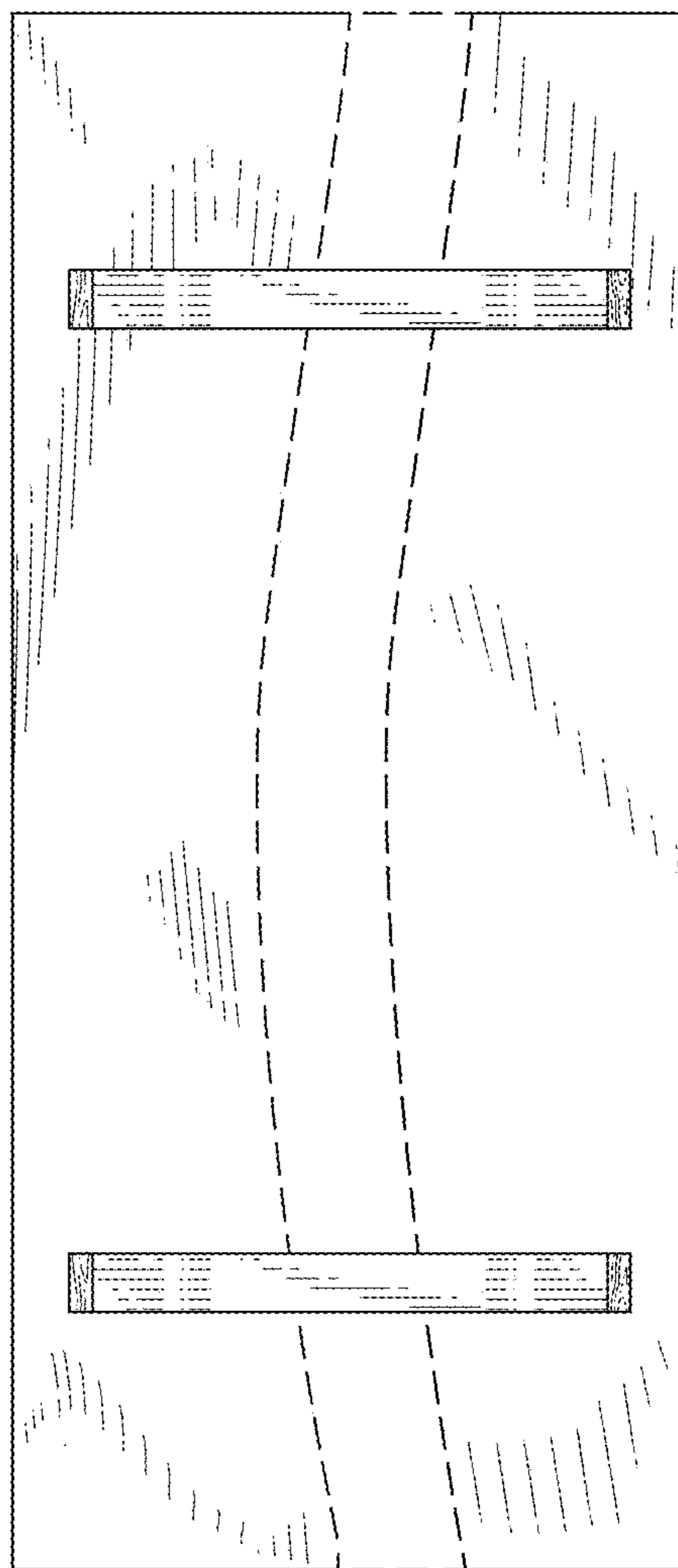

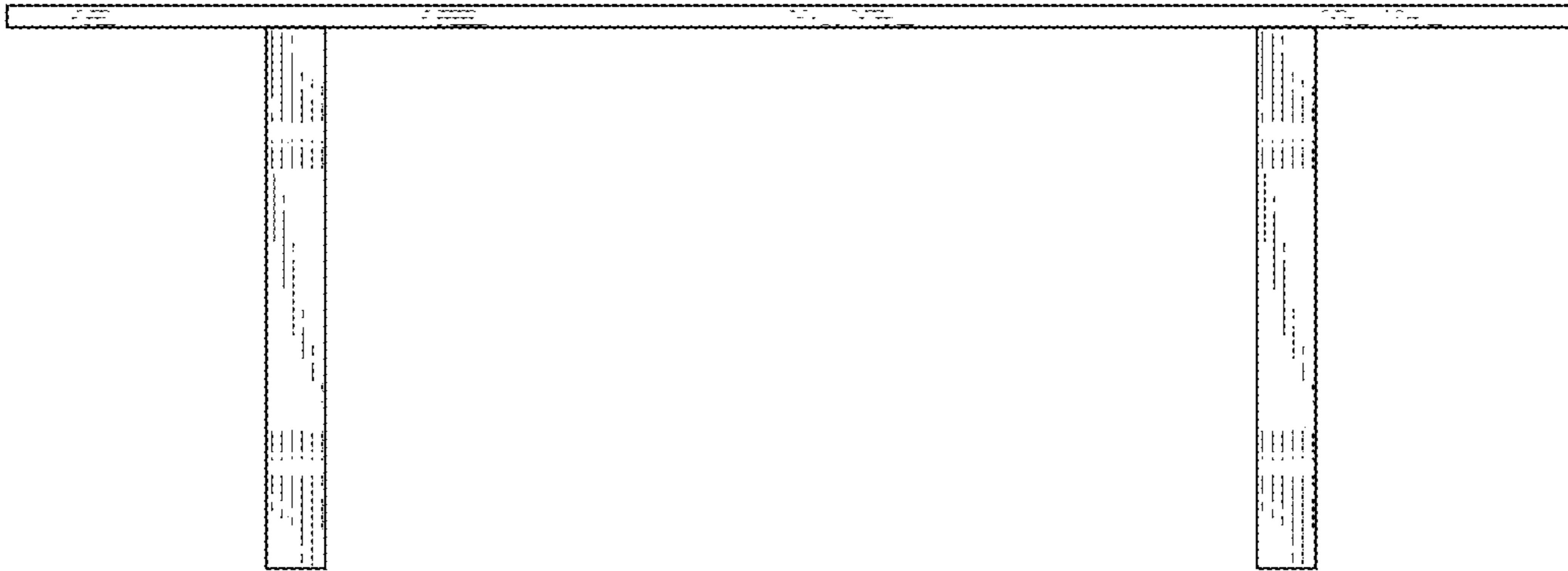

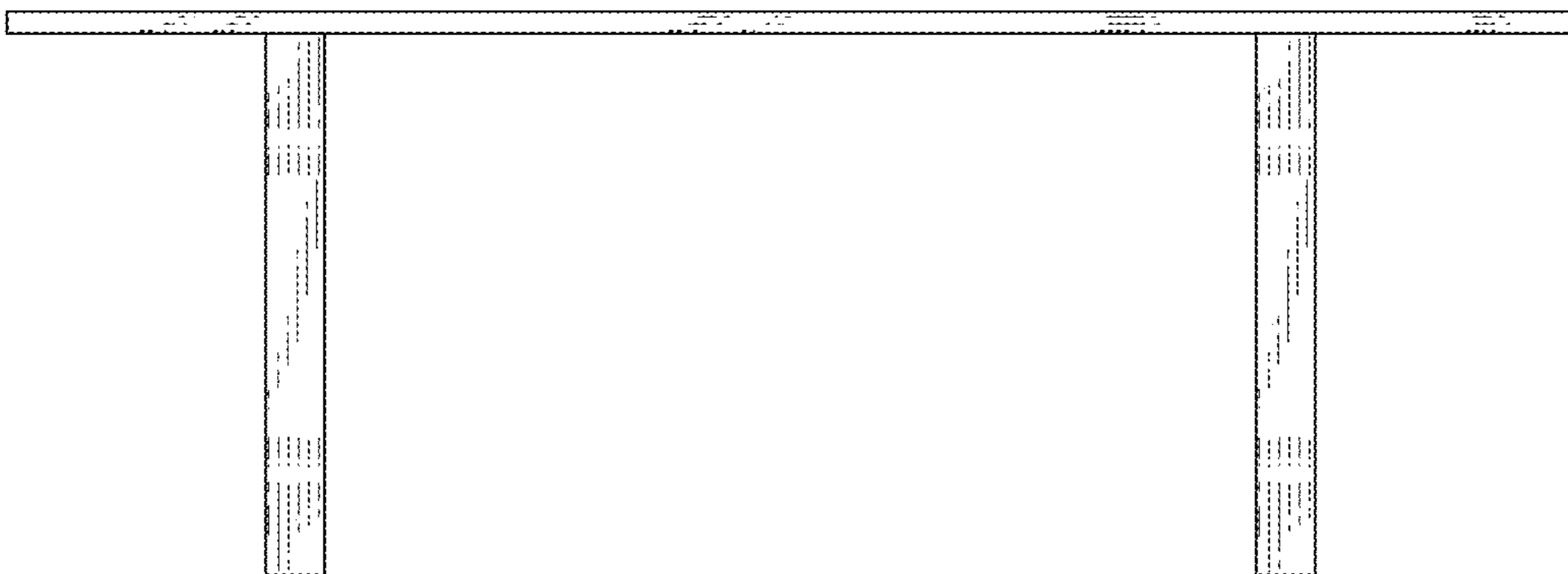
