The ornamental design for a whisk, as shown and described.

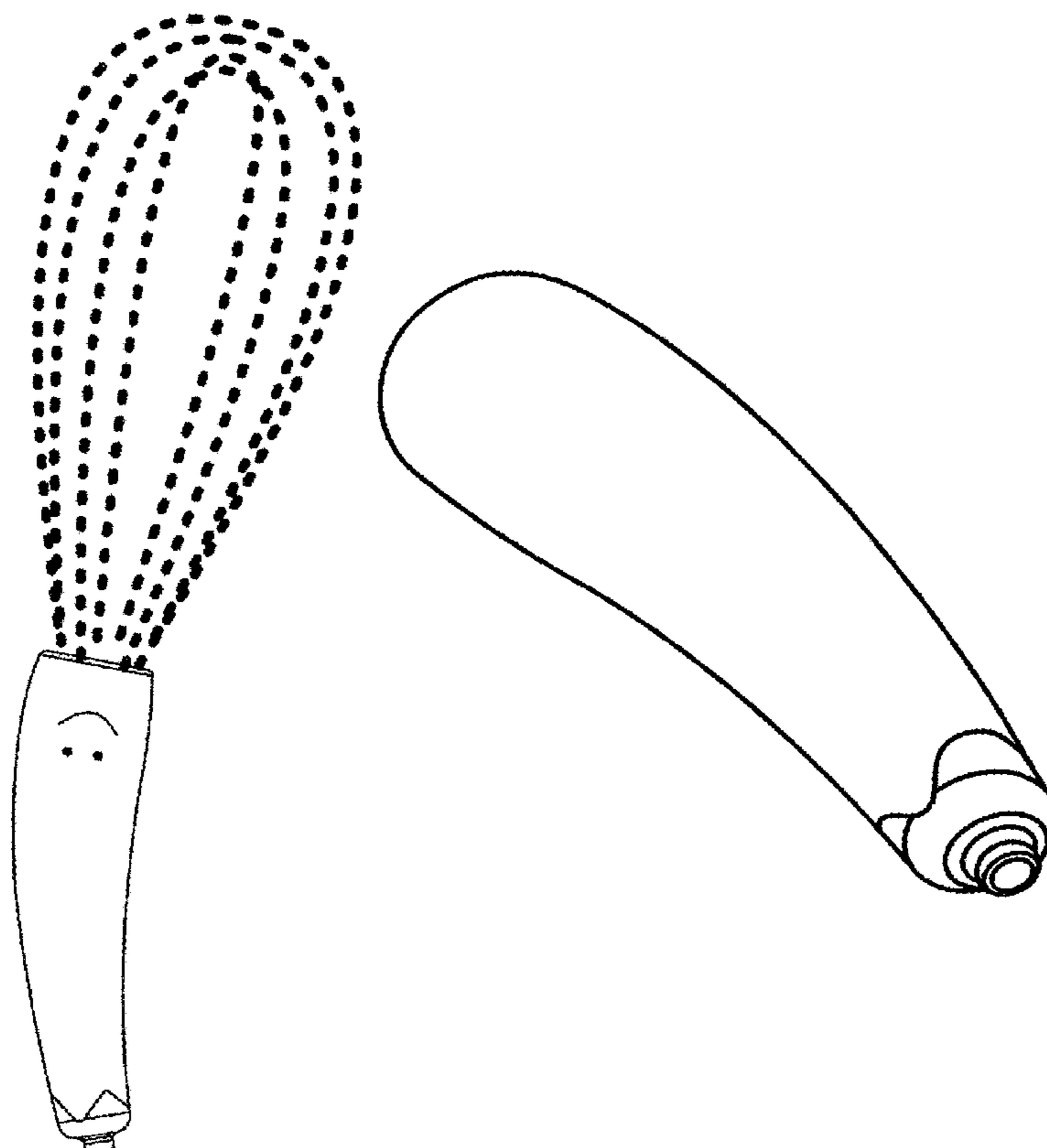
DESCRIPTION

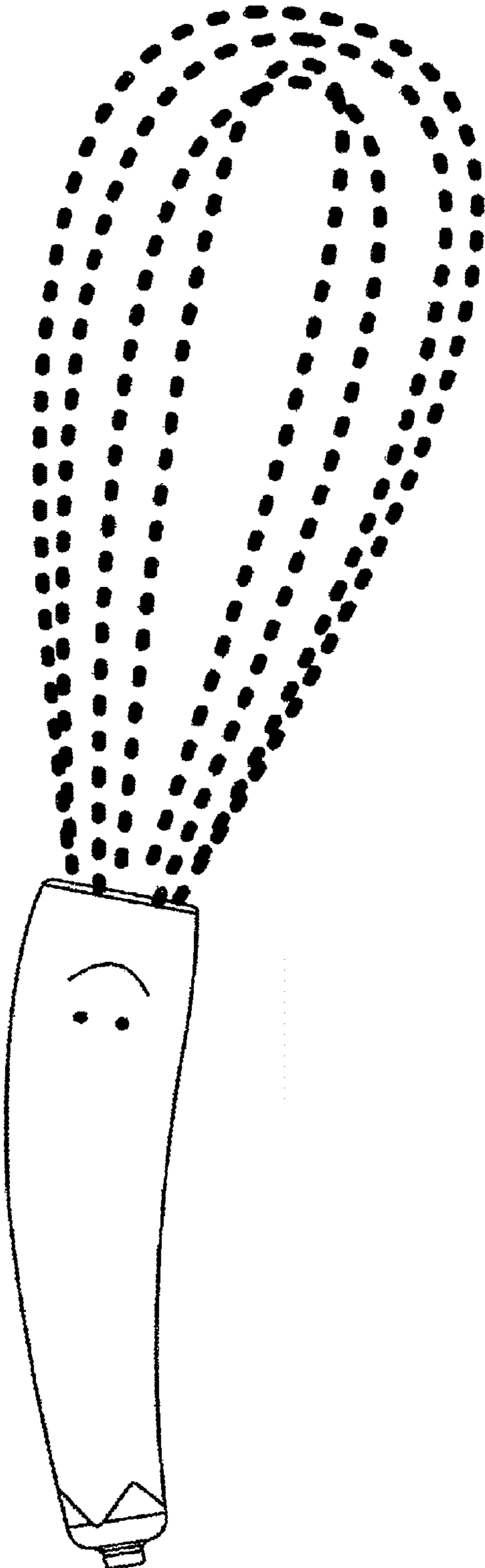
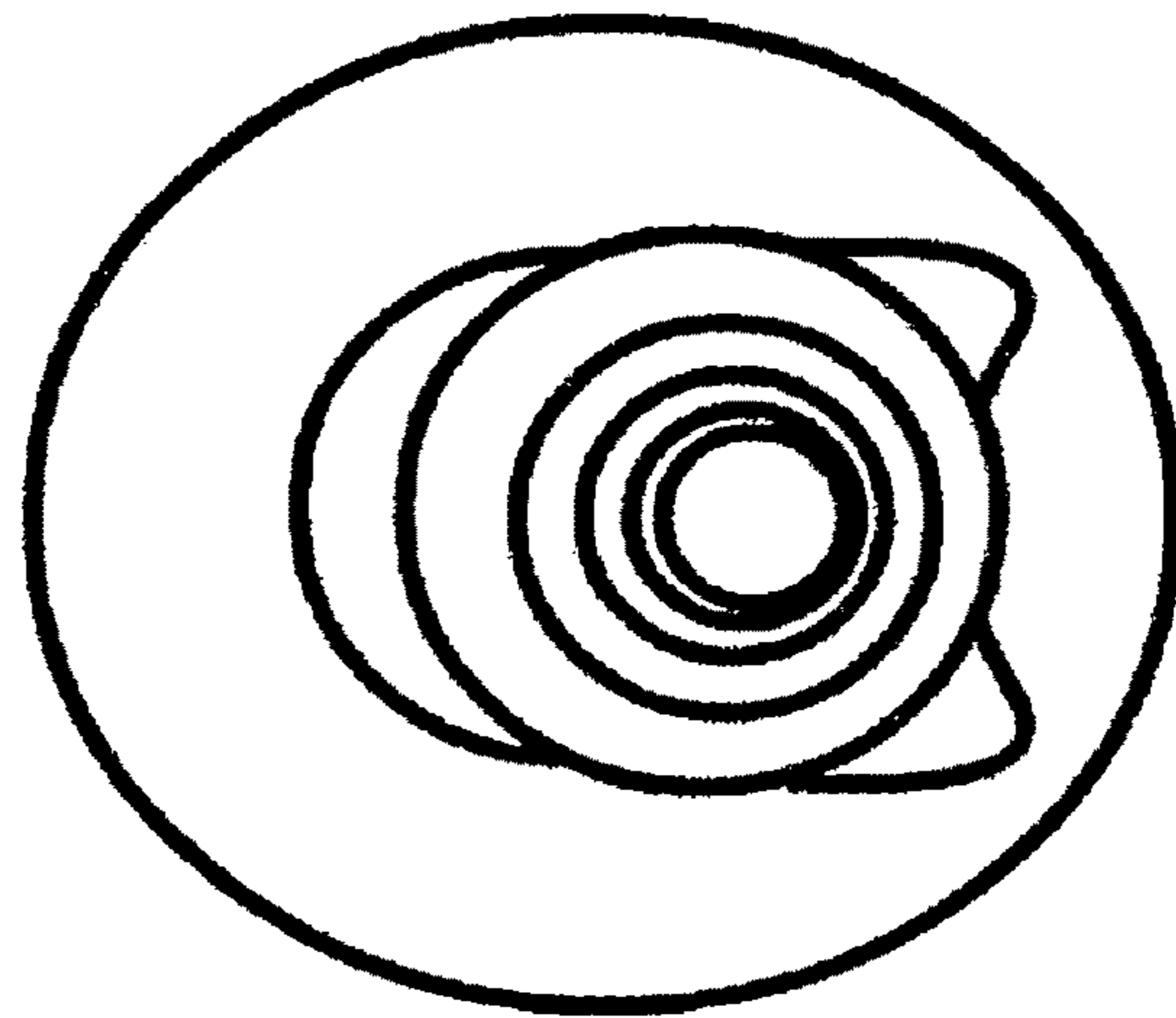

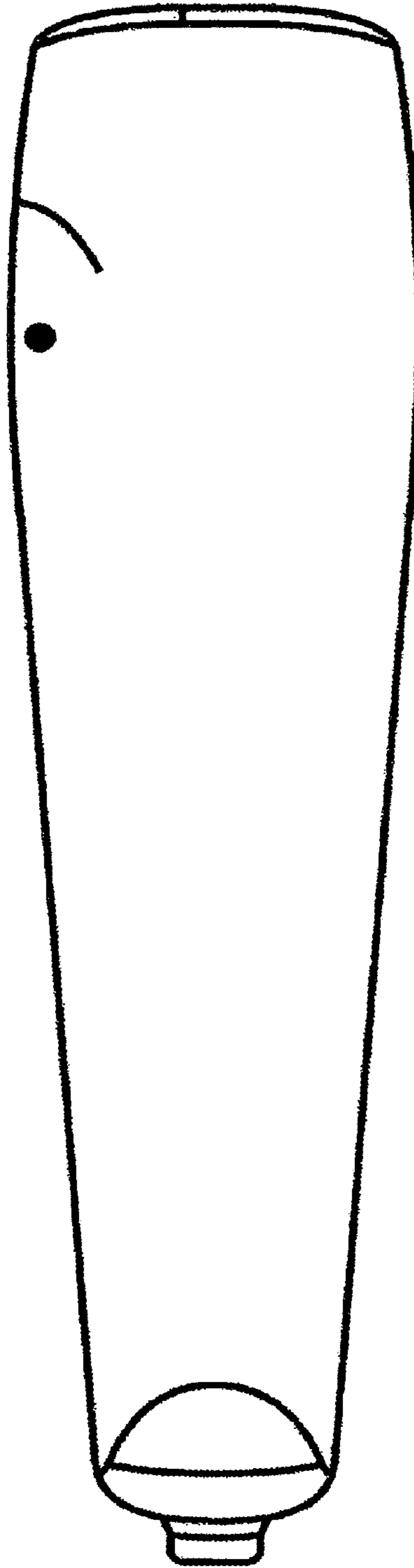

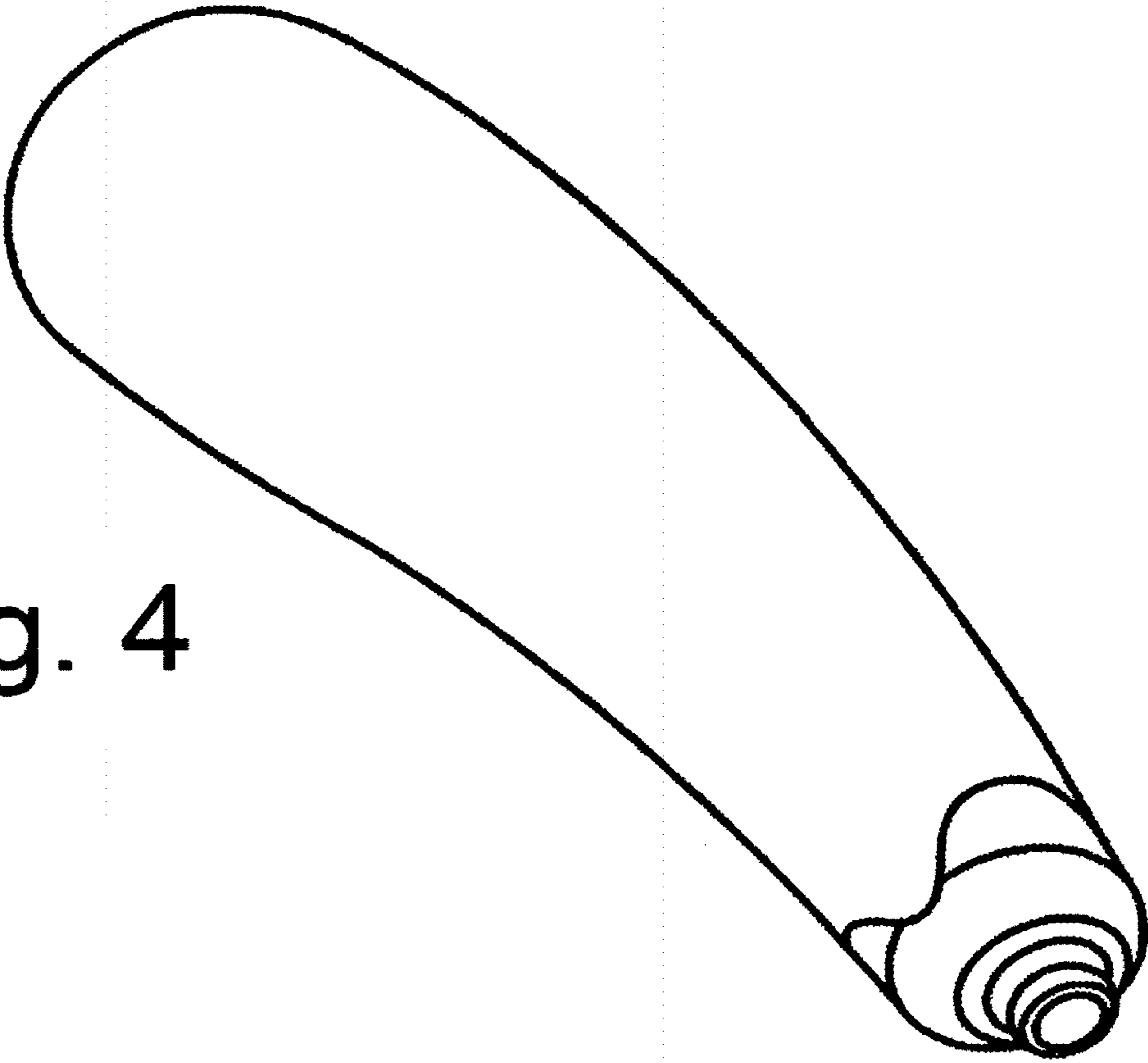

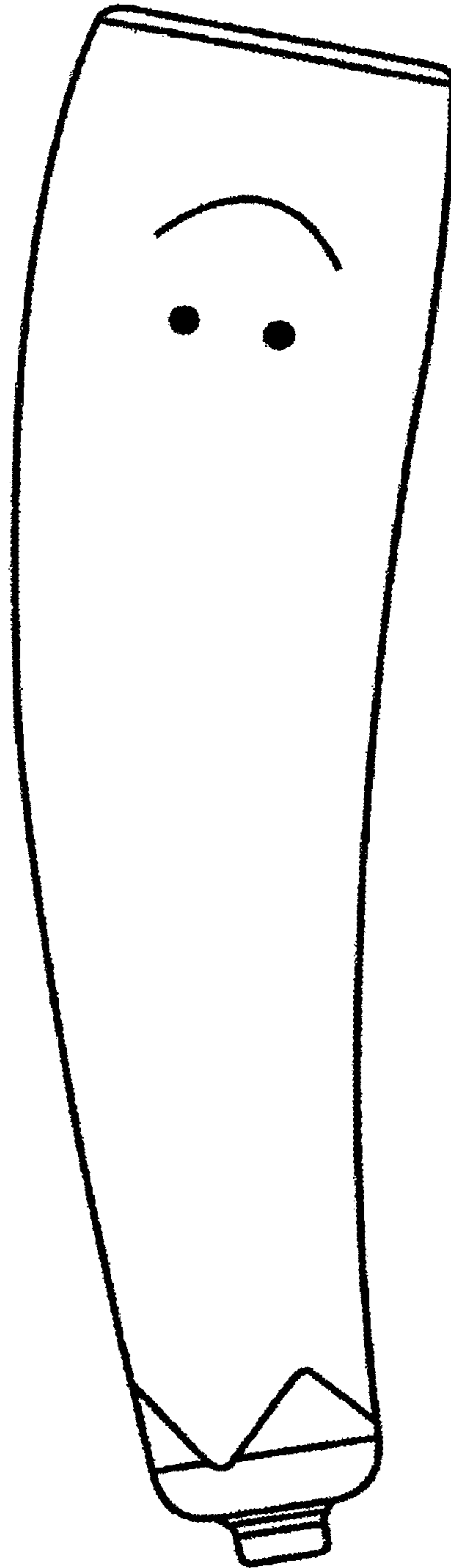

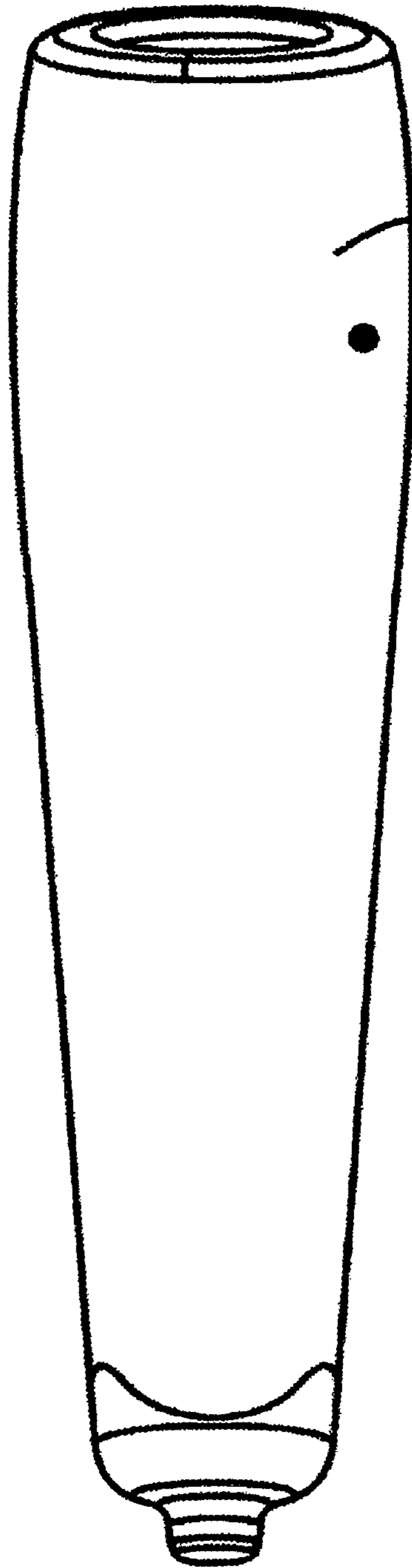
