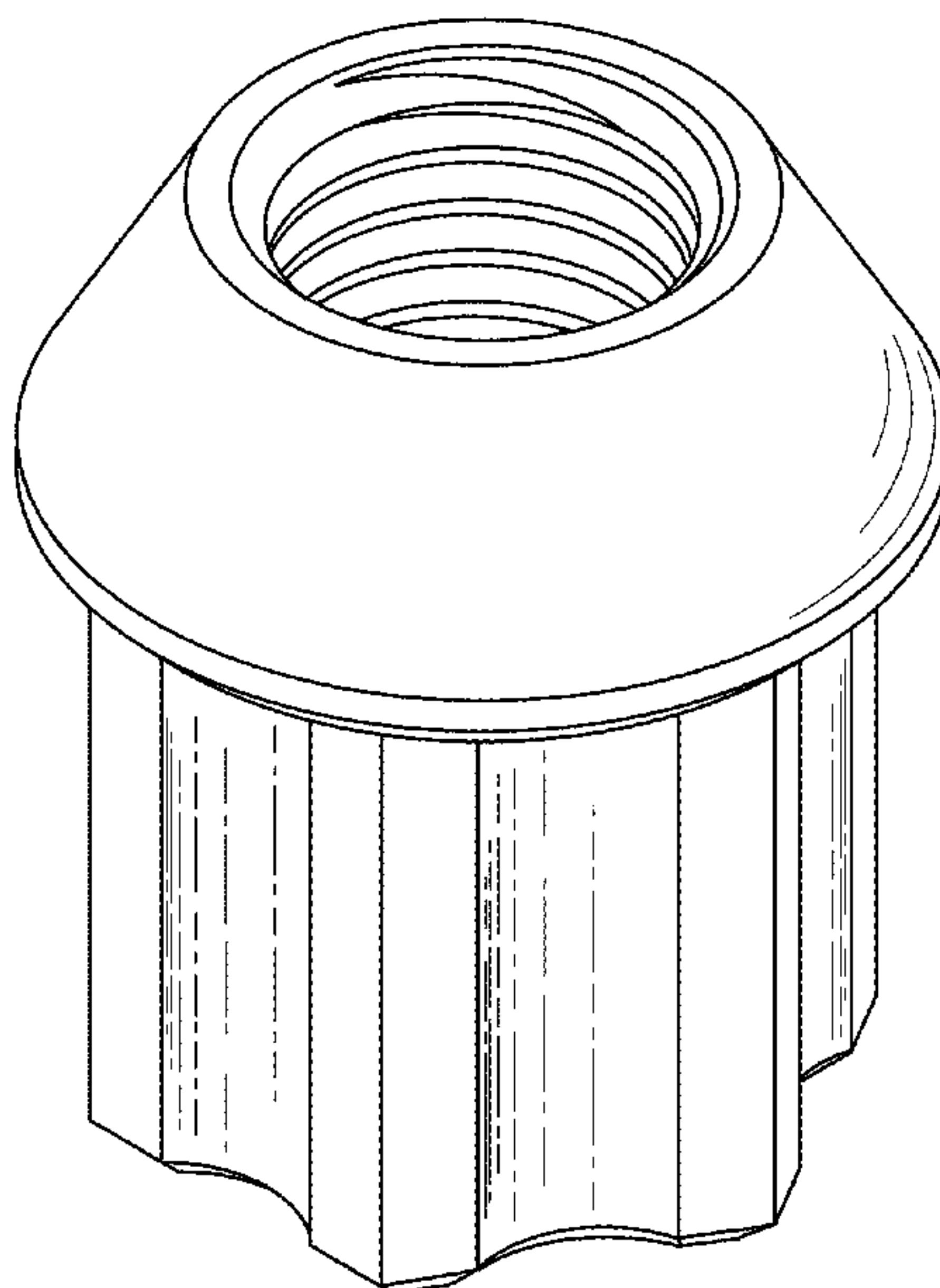
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a lug nut, showing my new design in its environment;
FIG. 2 is a left side elevation view, the right side elevation view being a mirror image thereof;
FIG. 3 is a front elevation view, the rear elevation view being a mirror image thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a front sectional view taken along lines 6-6 from FIG. 5 thereof; and,
FIG. 7 is a lower perspective view.

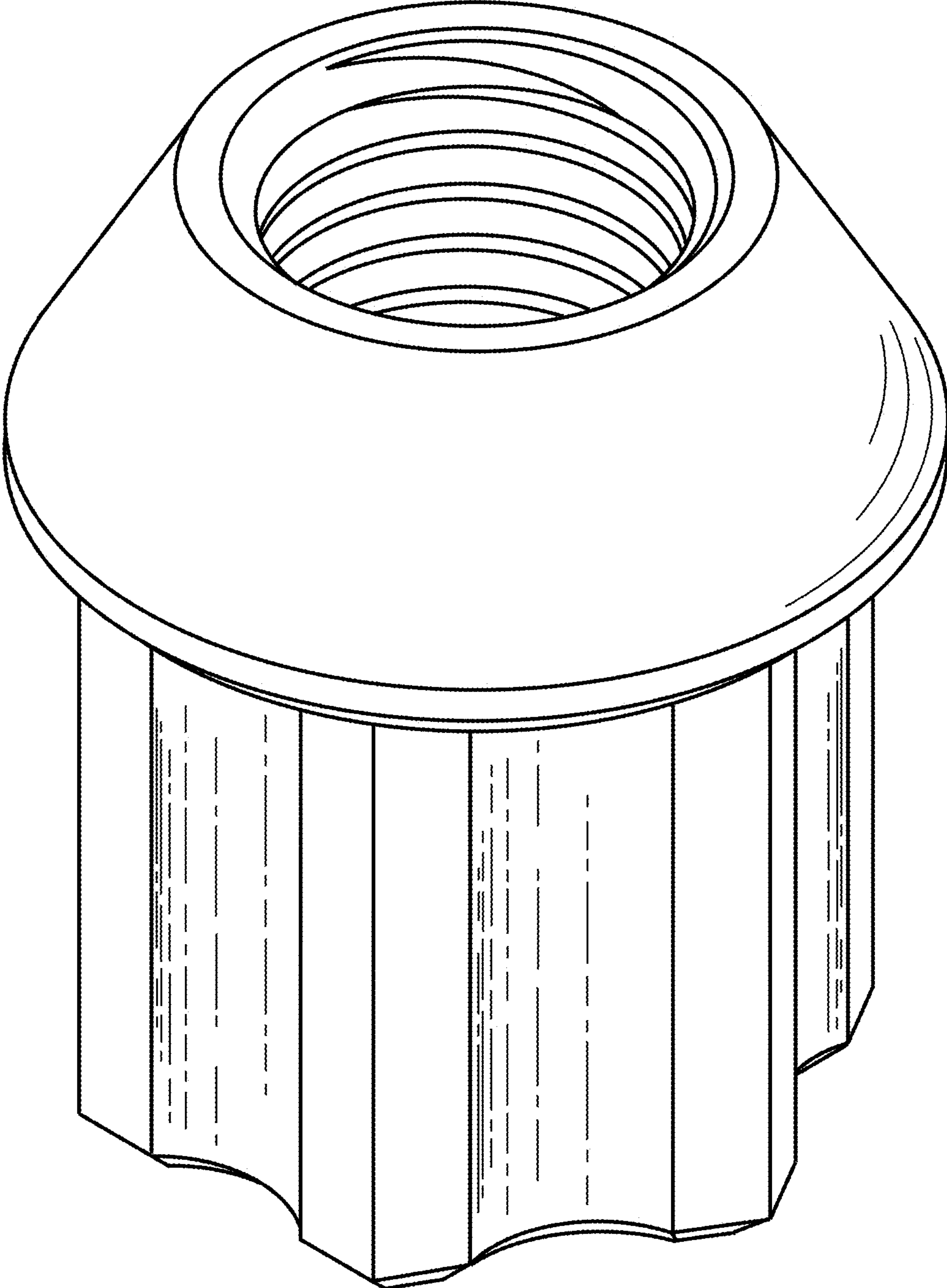

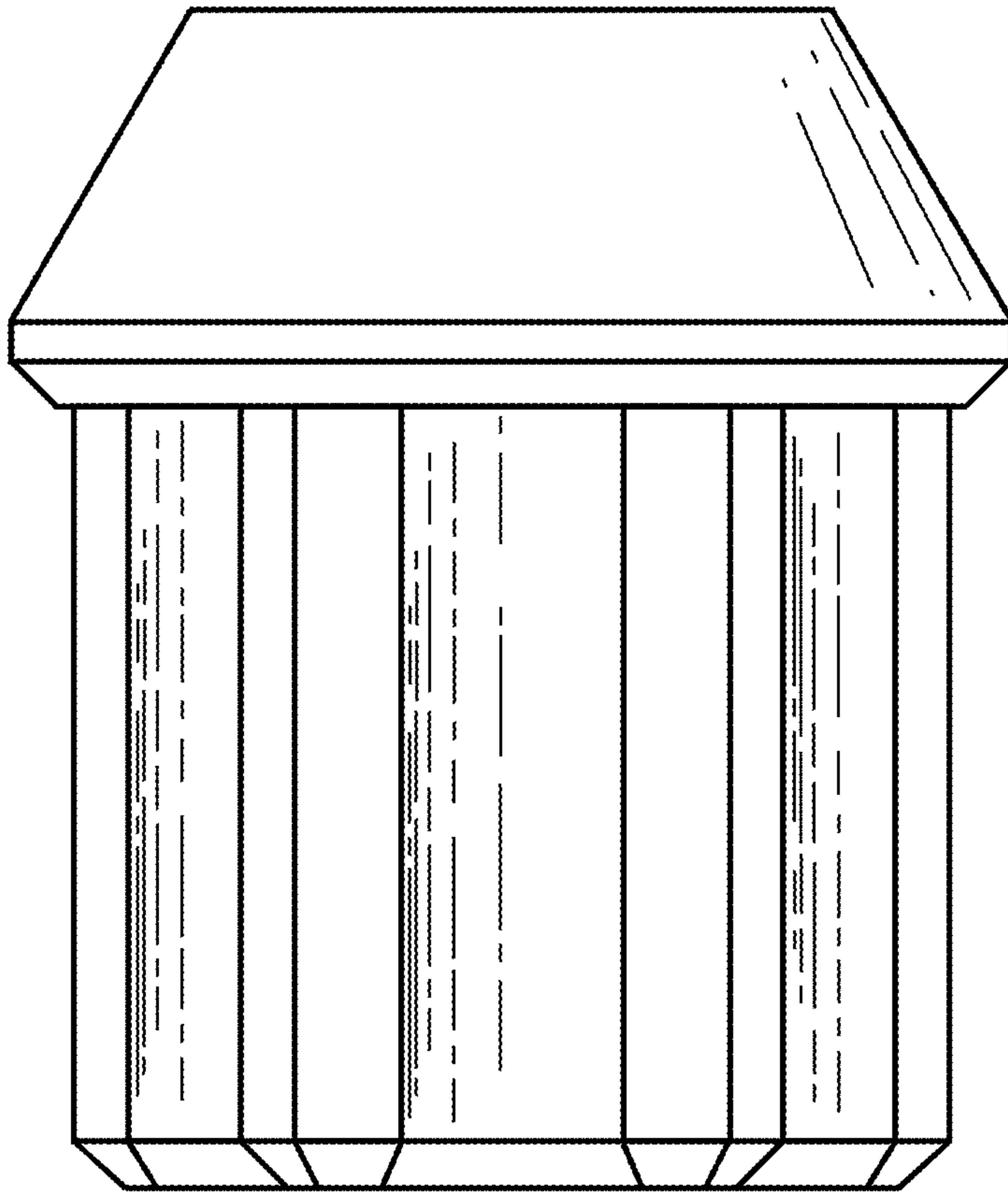

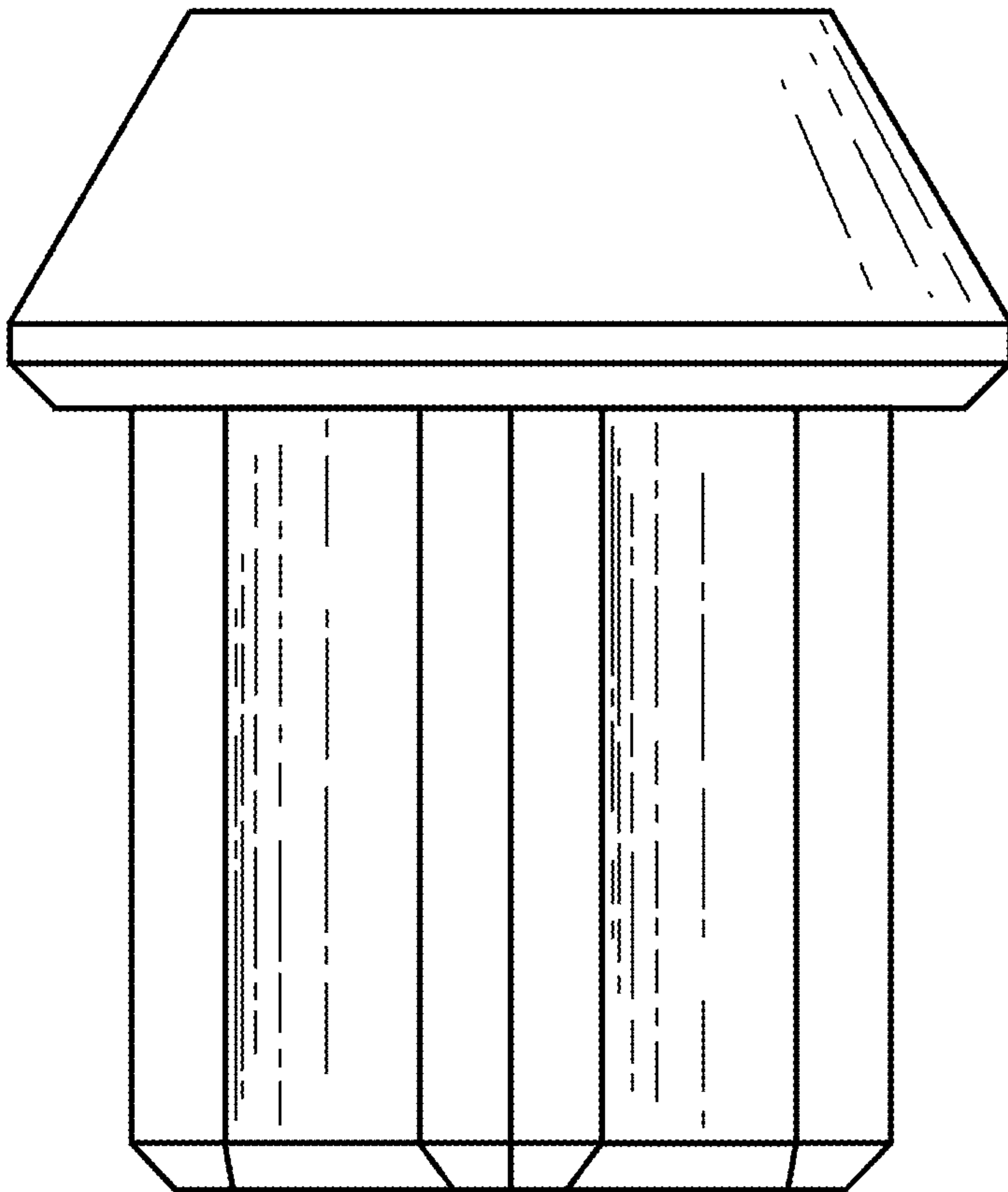

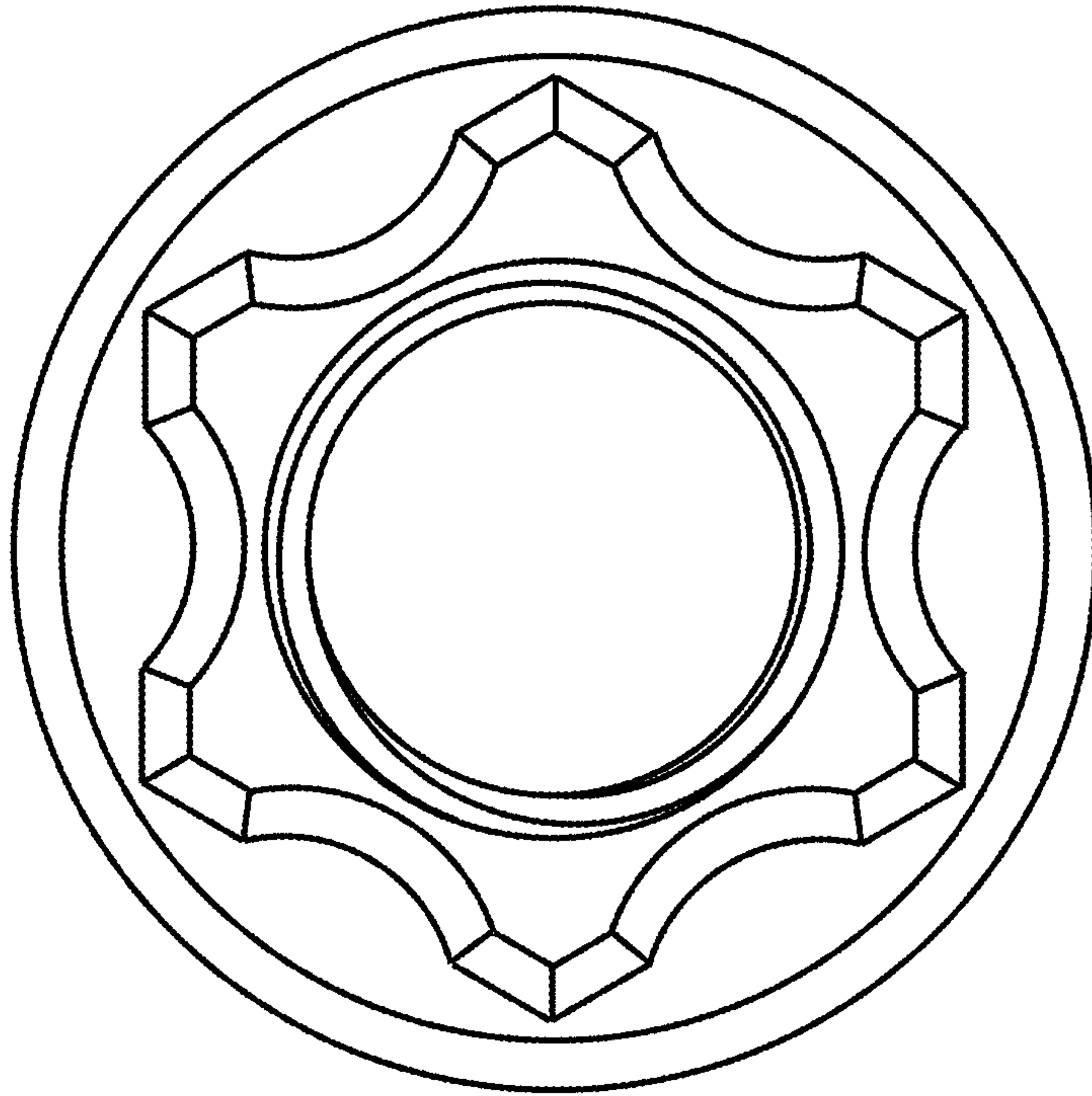

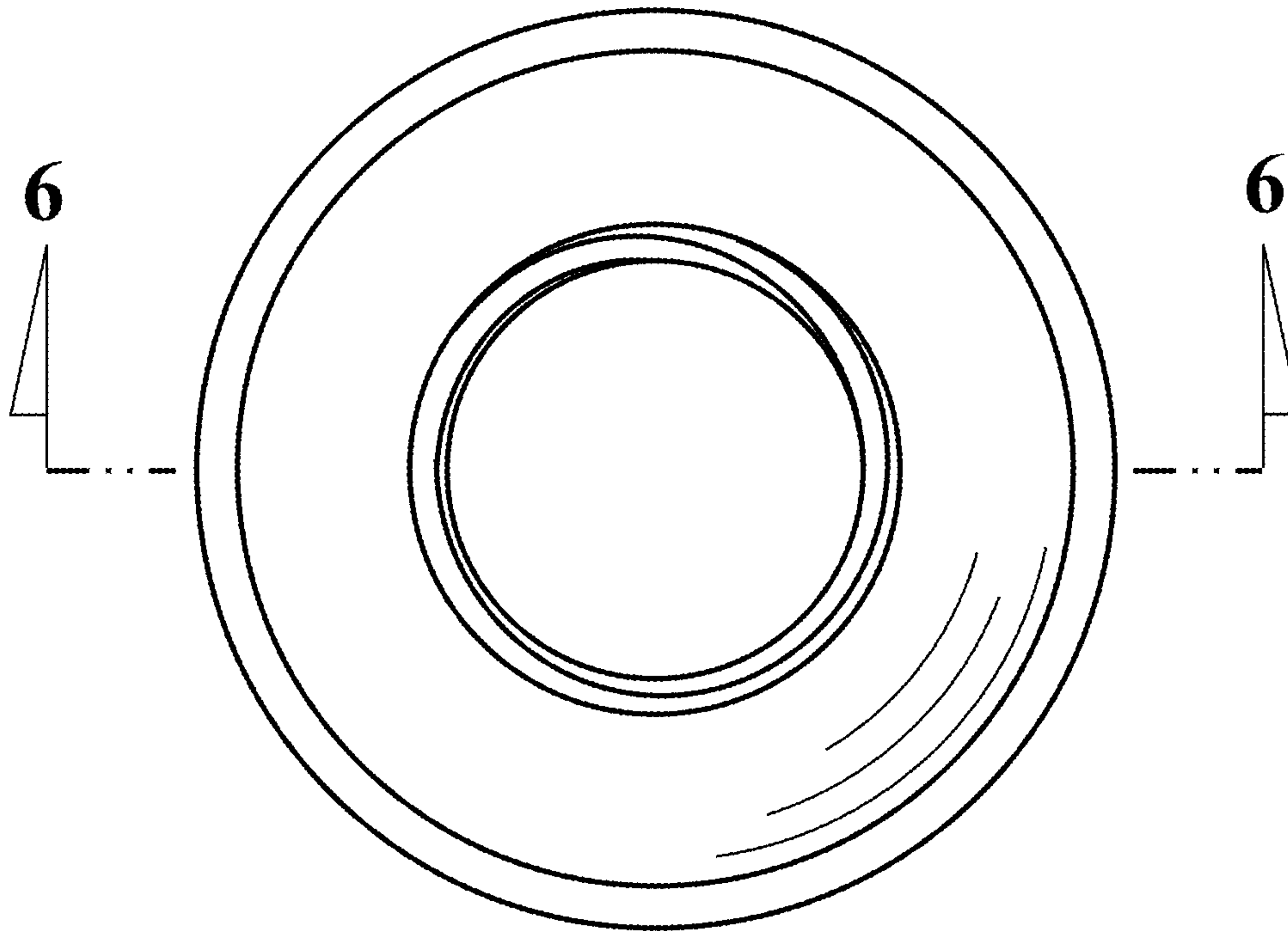

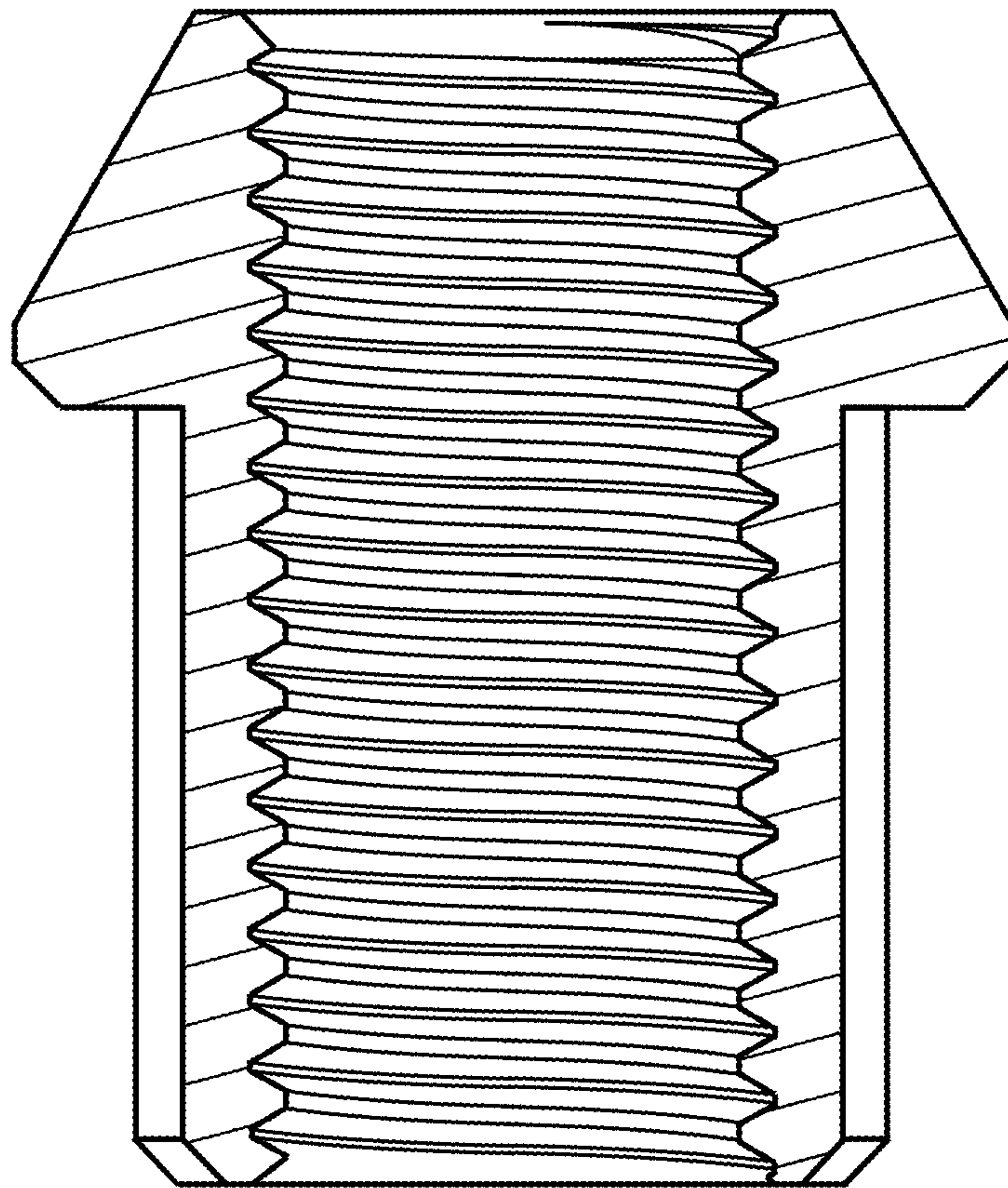

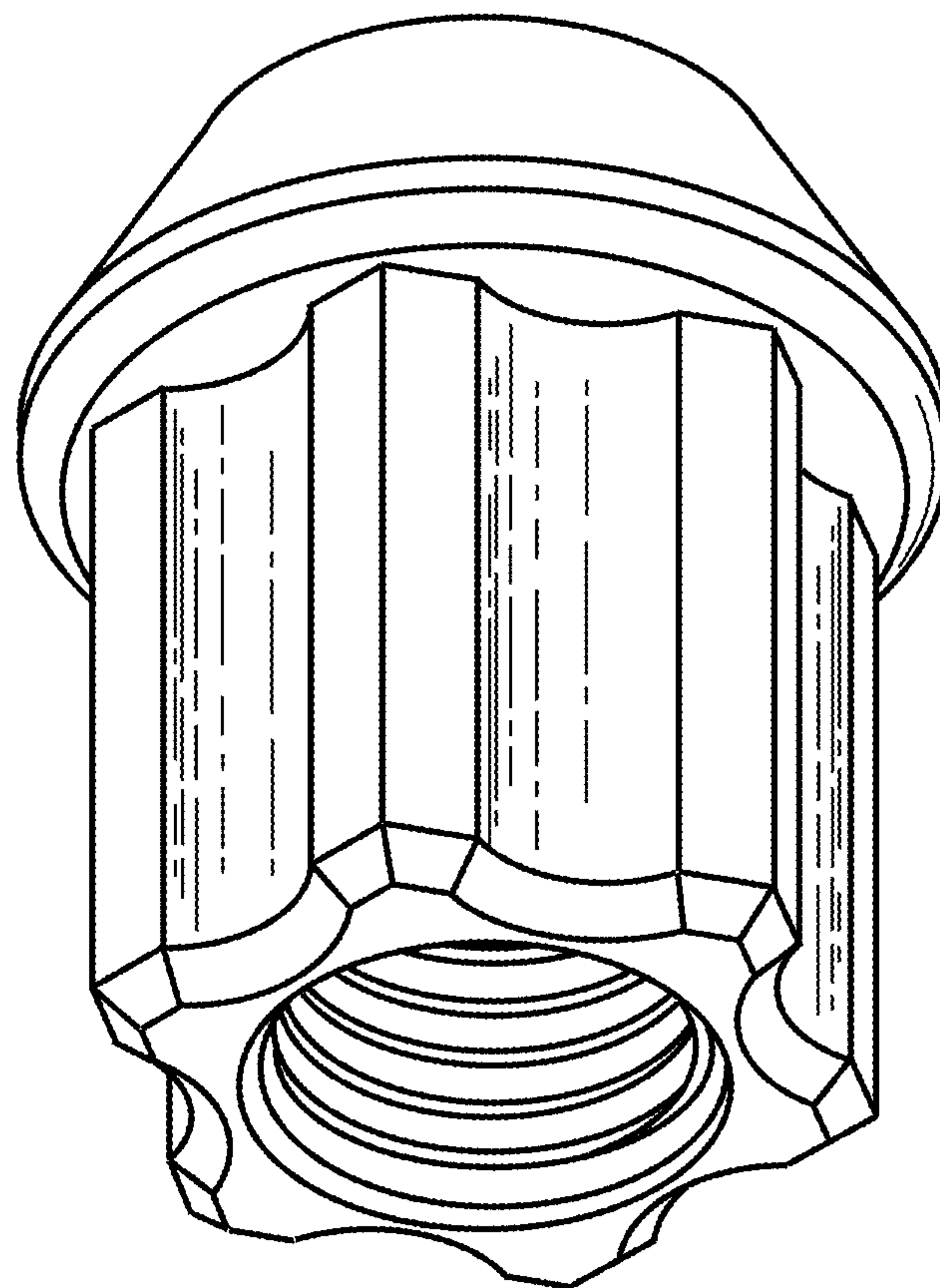
