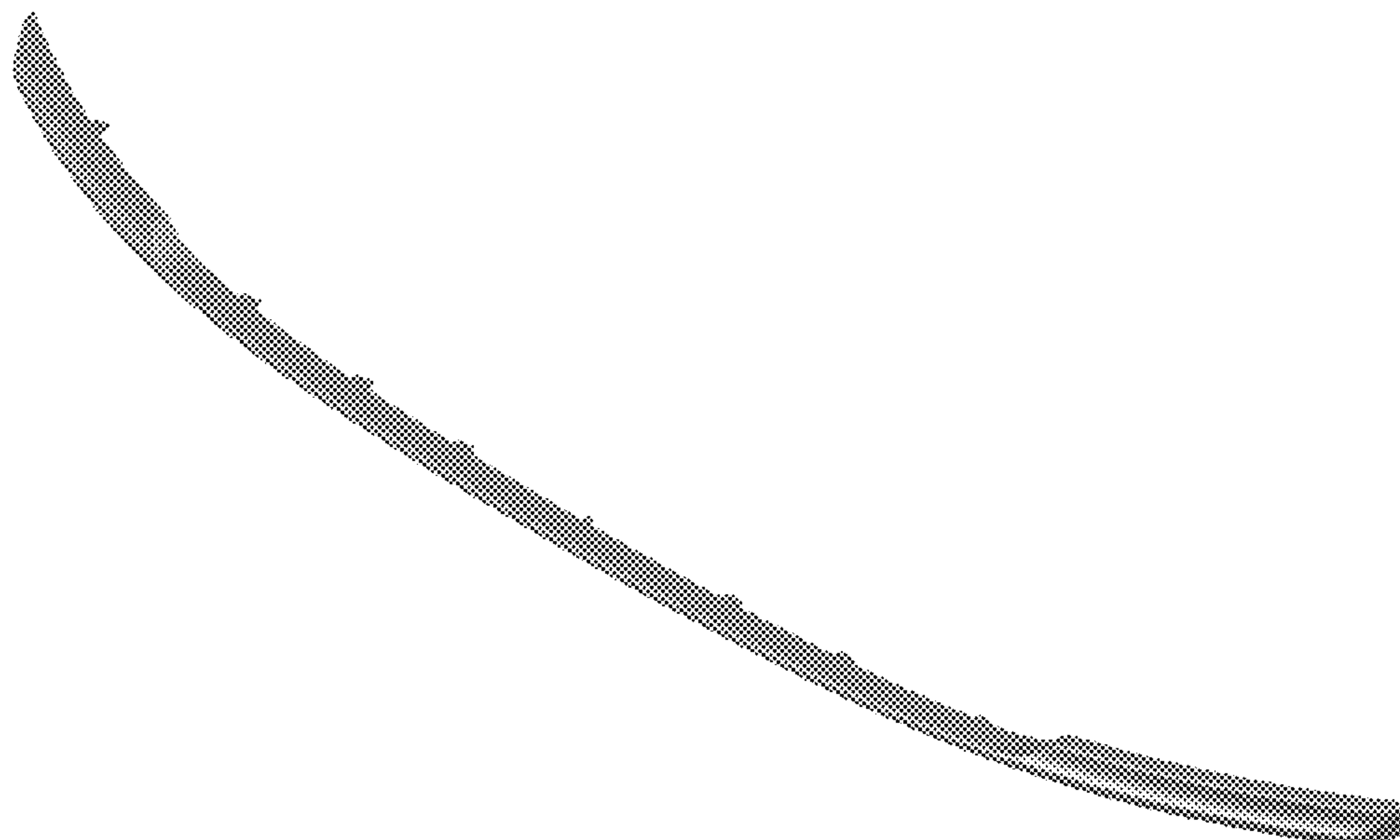
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational of a vehicle front lower grille showing our new design;

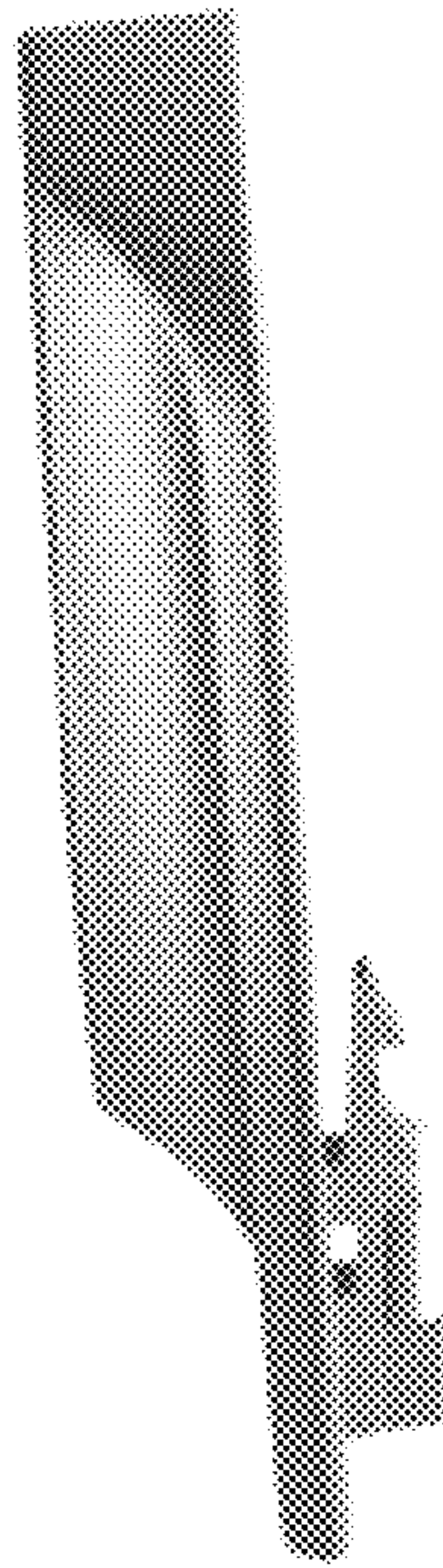

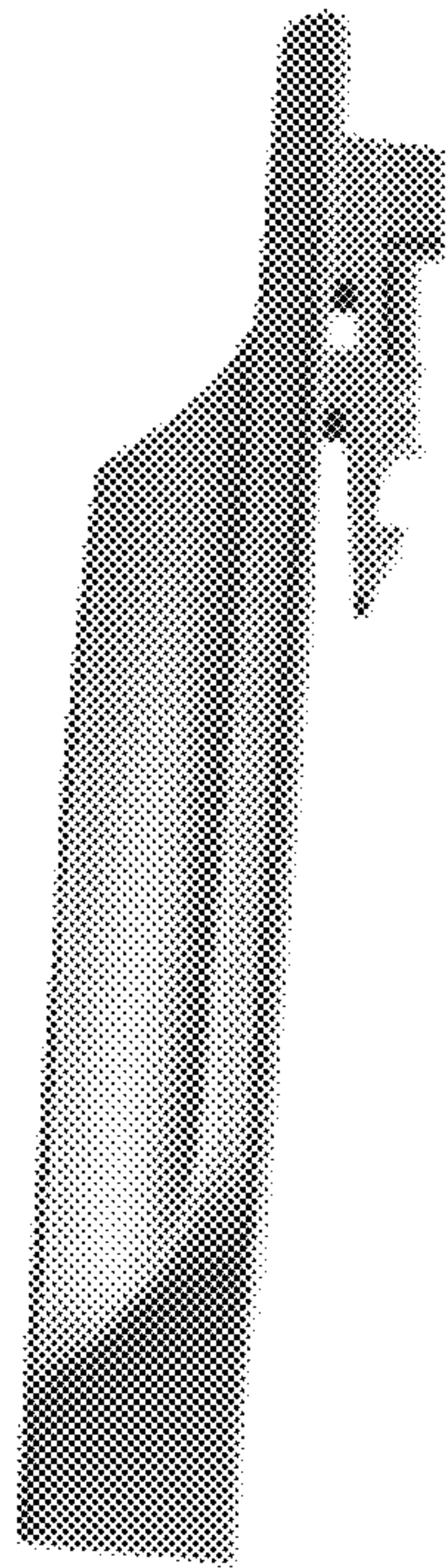

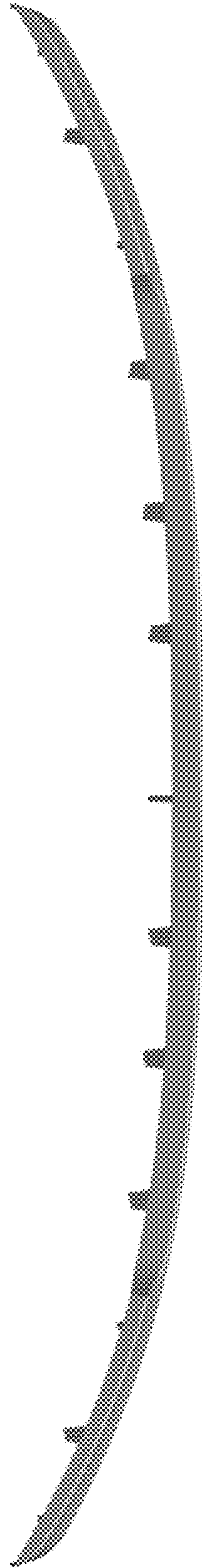
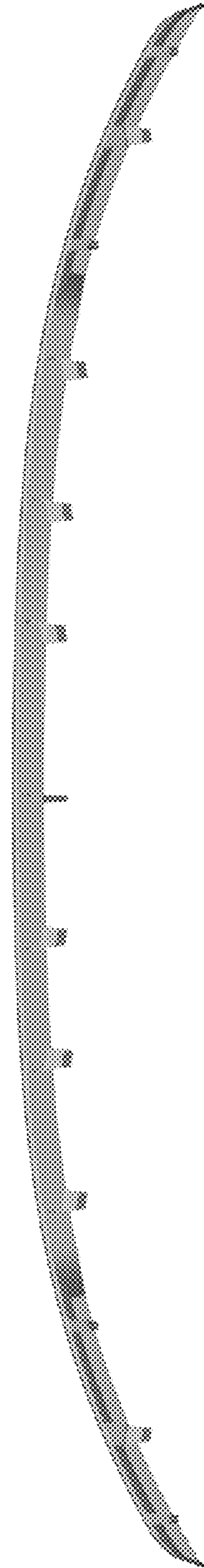

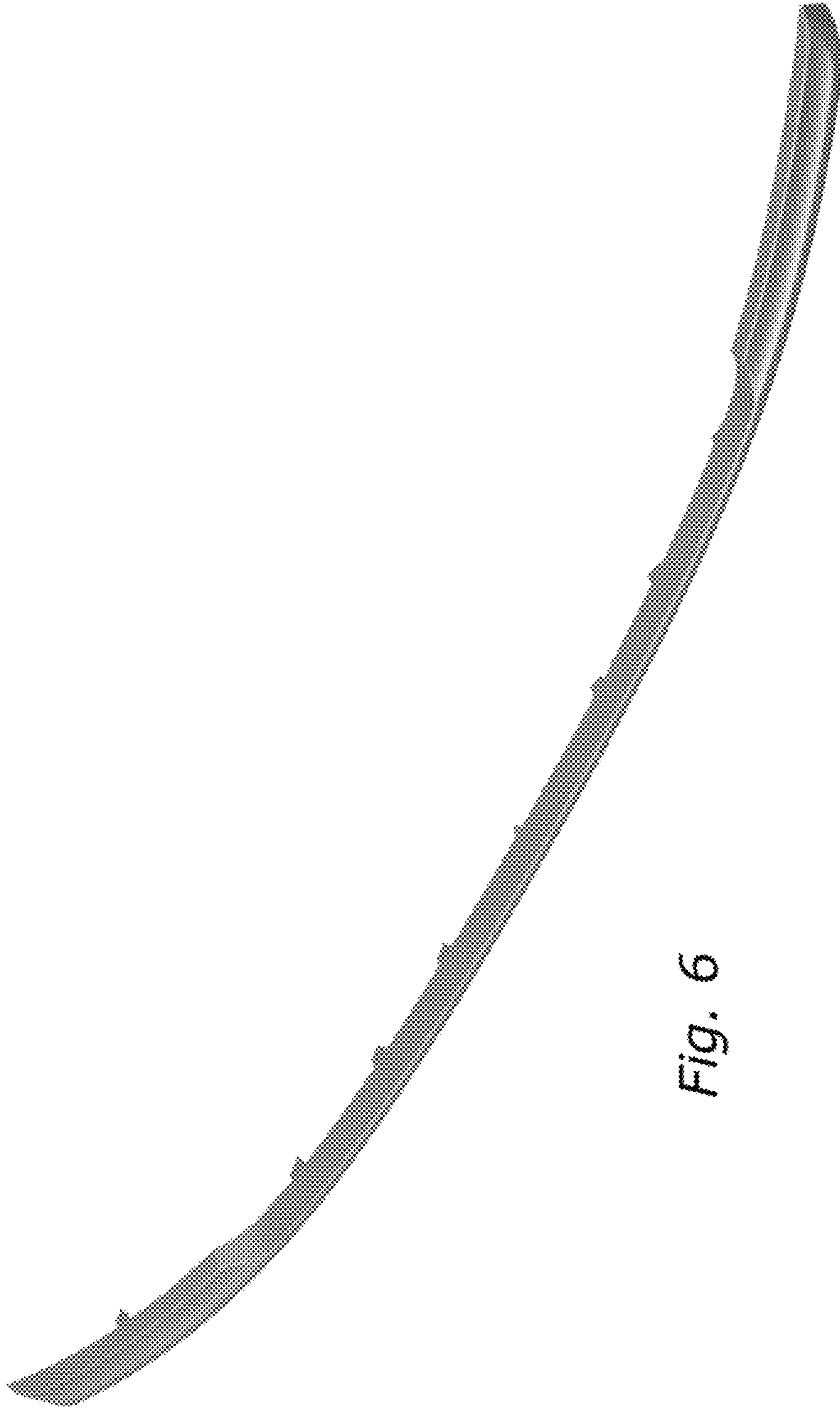

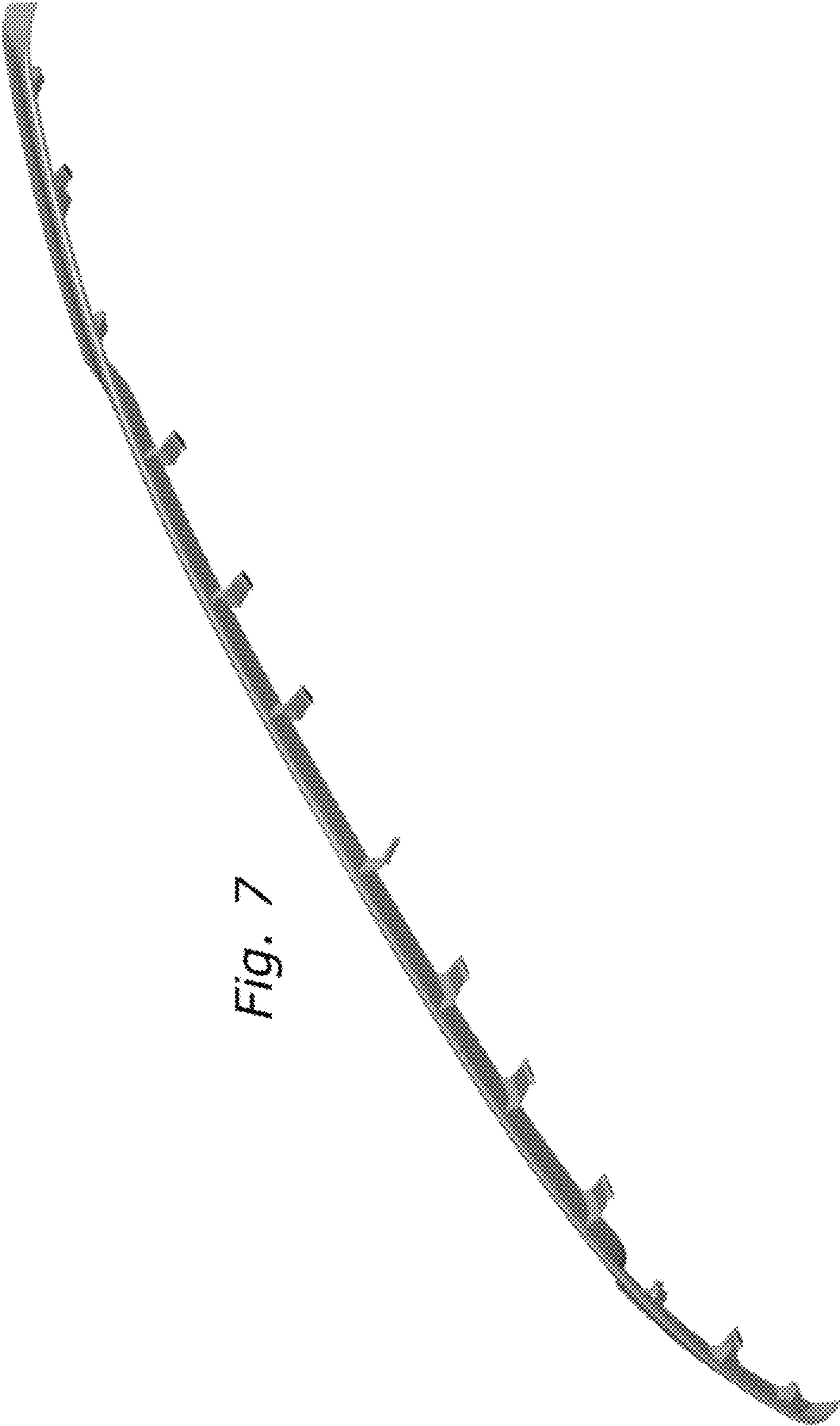
