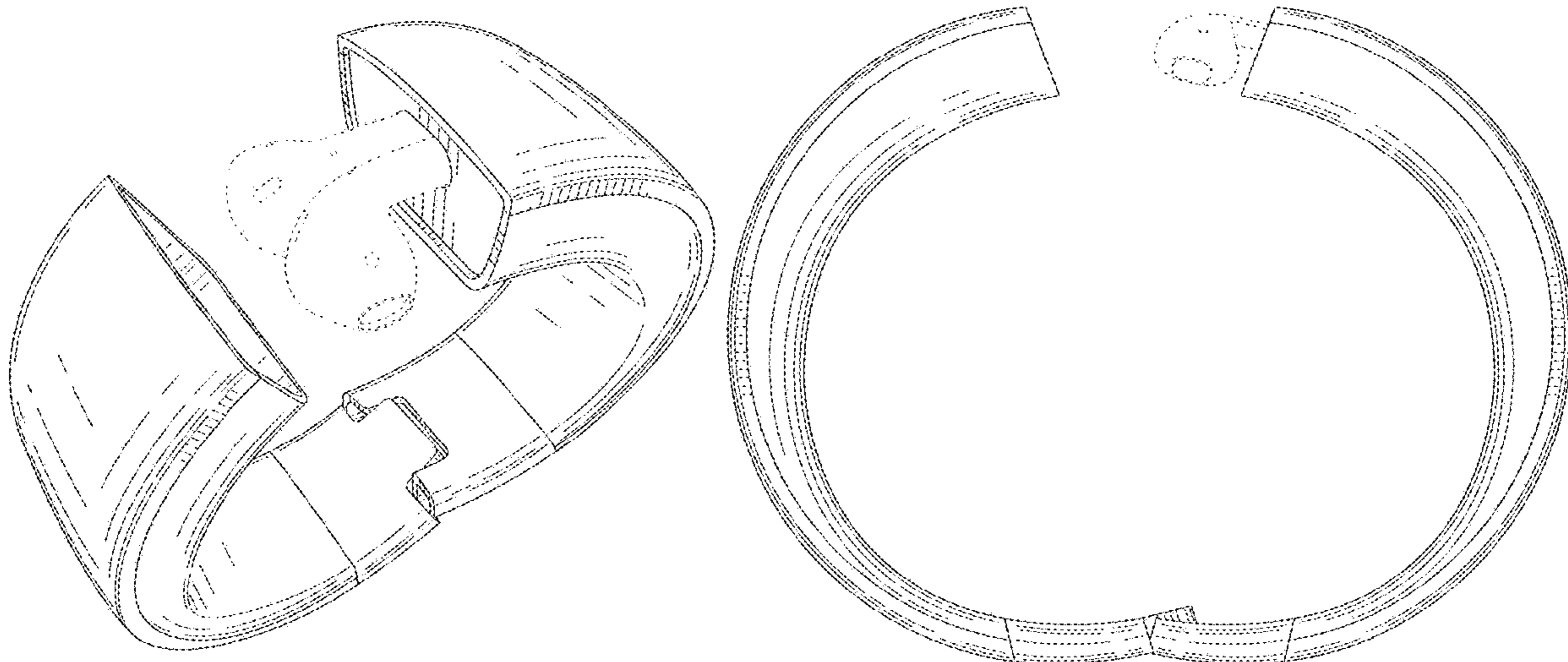
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a carrier for wireless earbuds showing our new design;

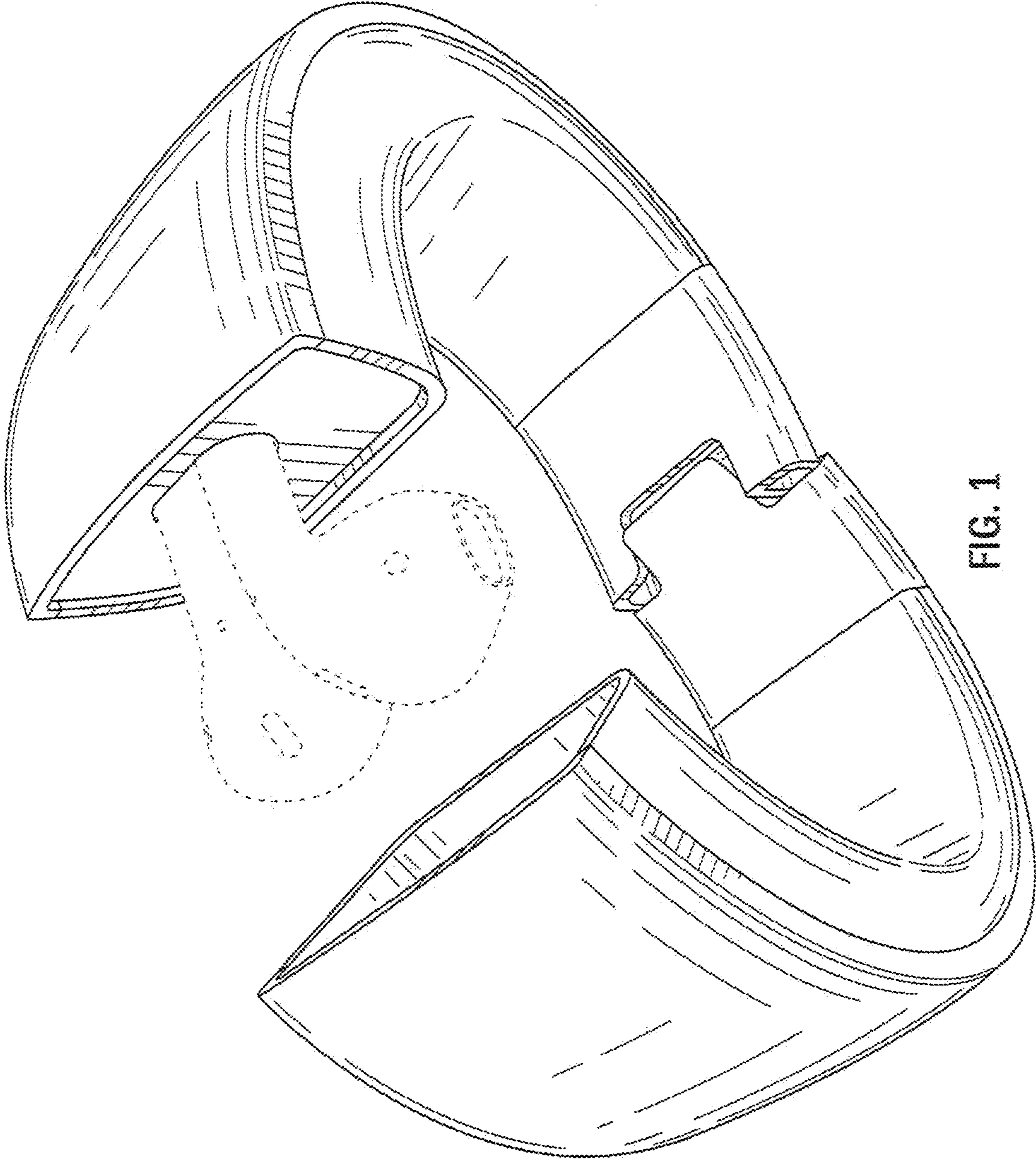

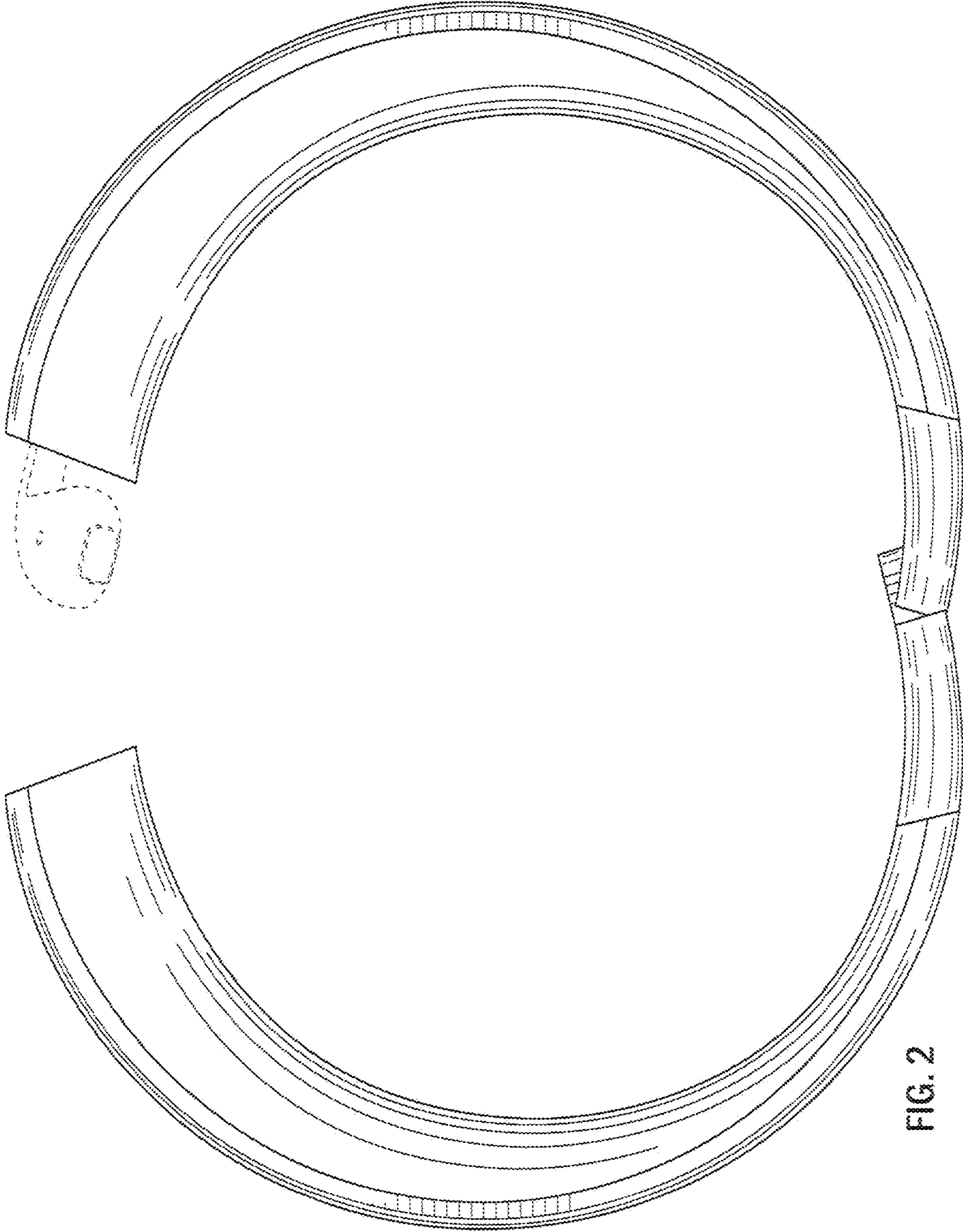

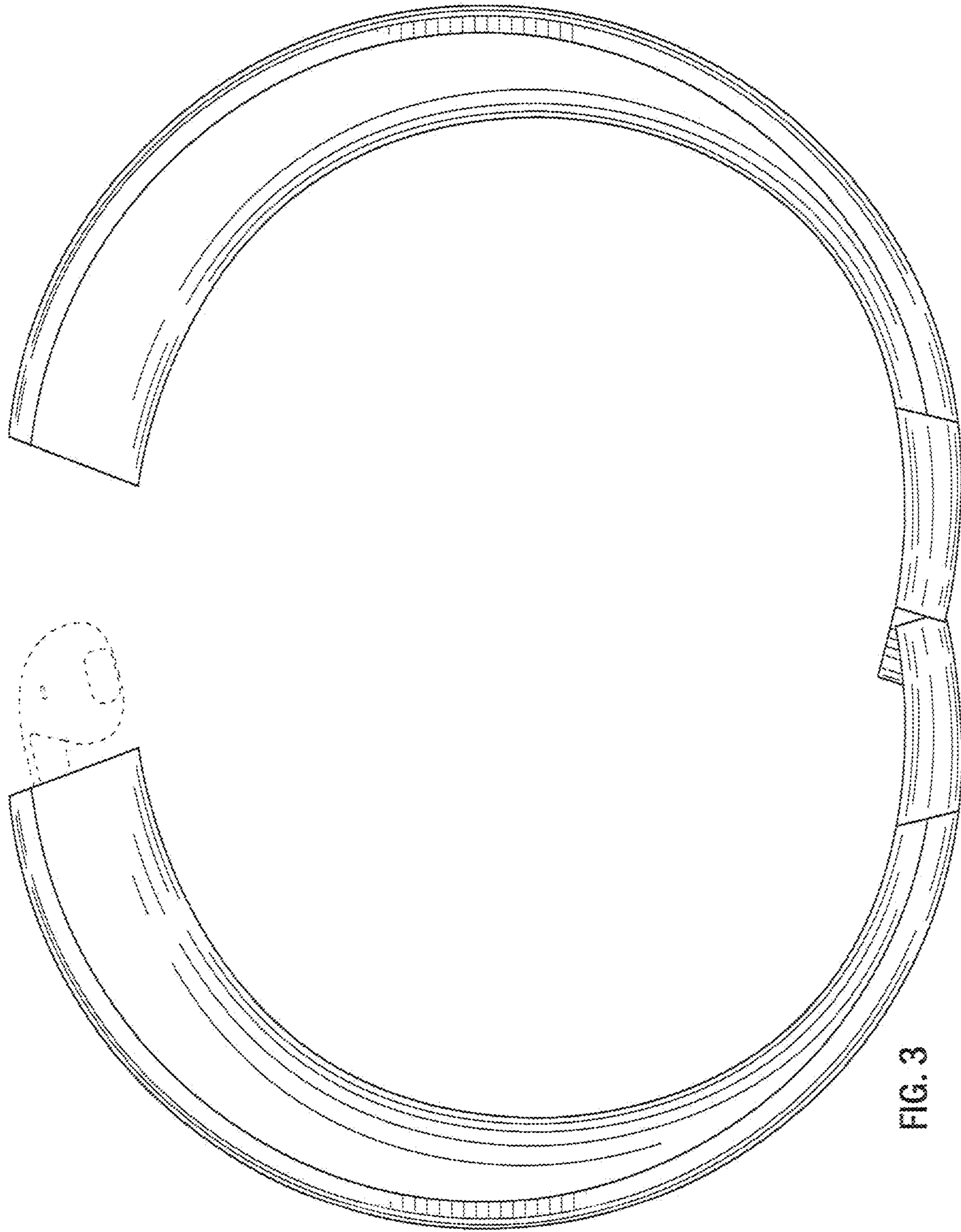

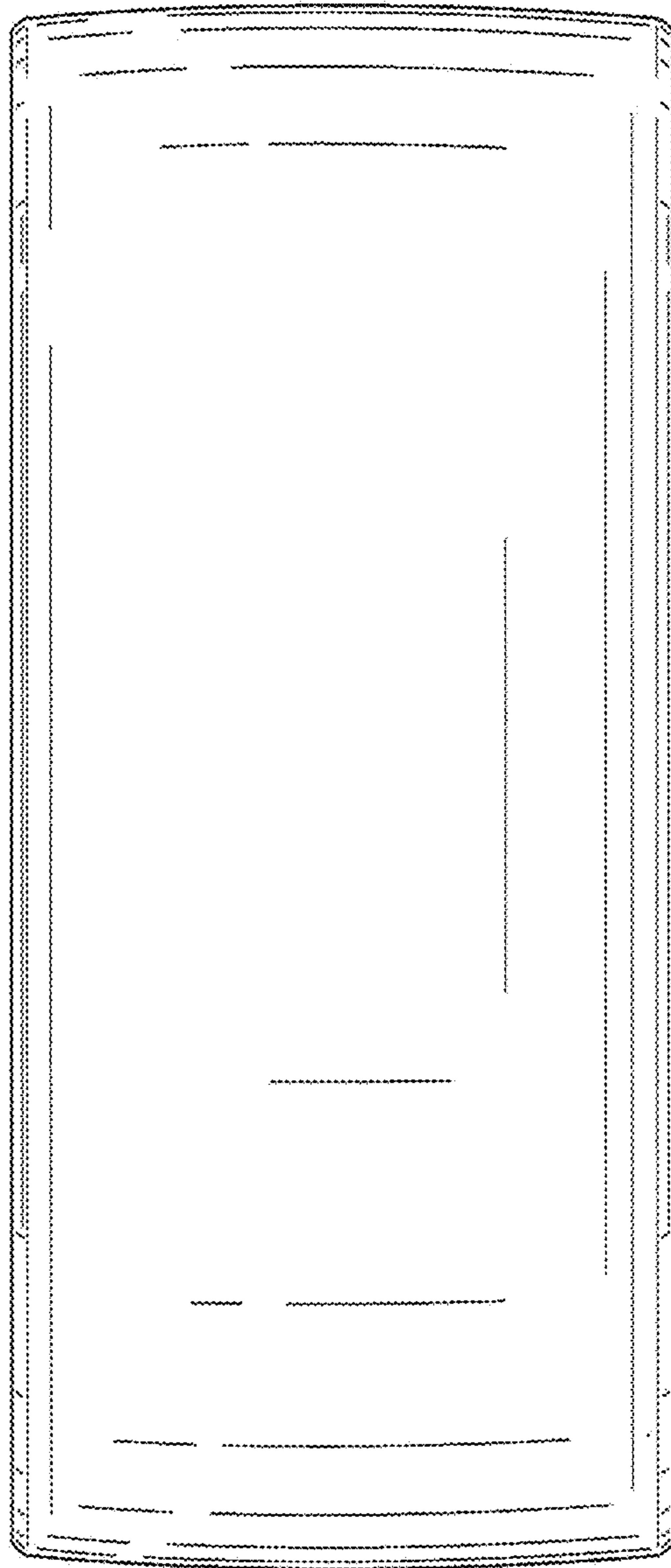

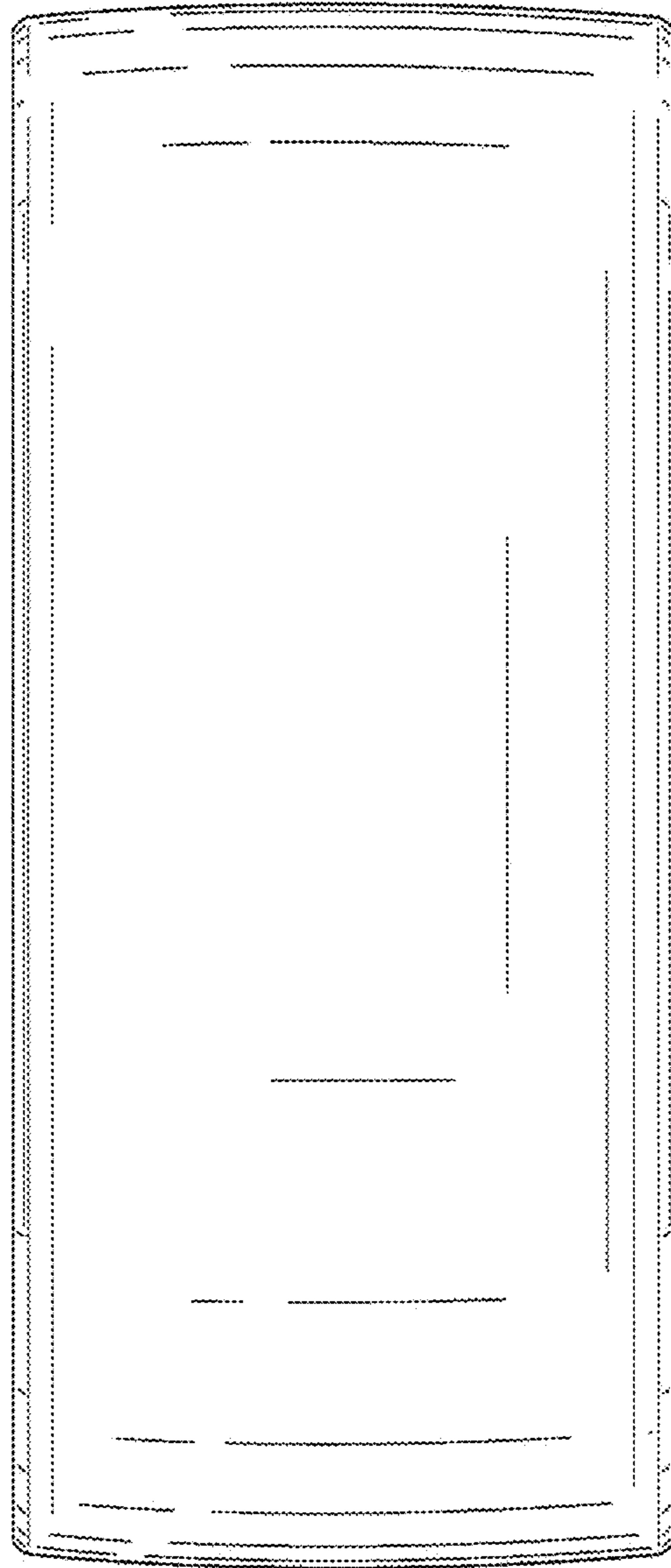

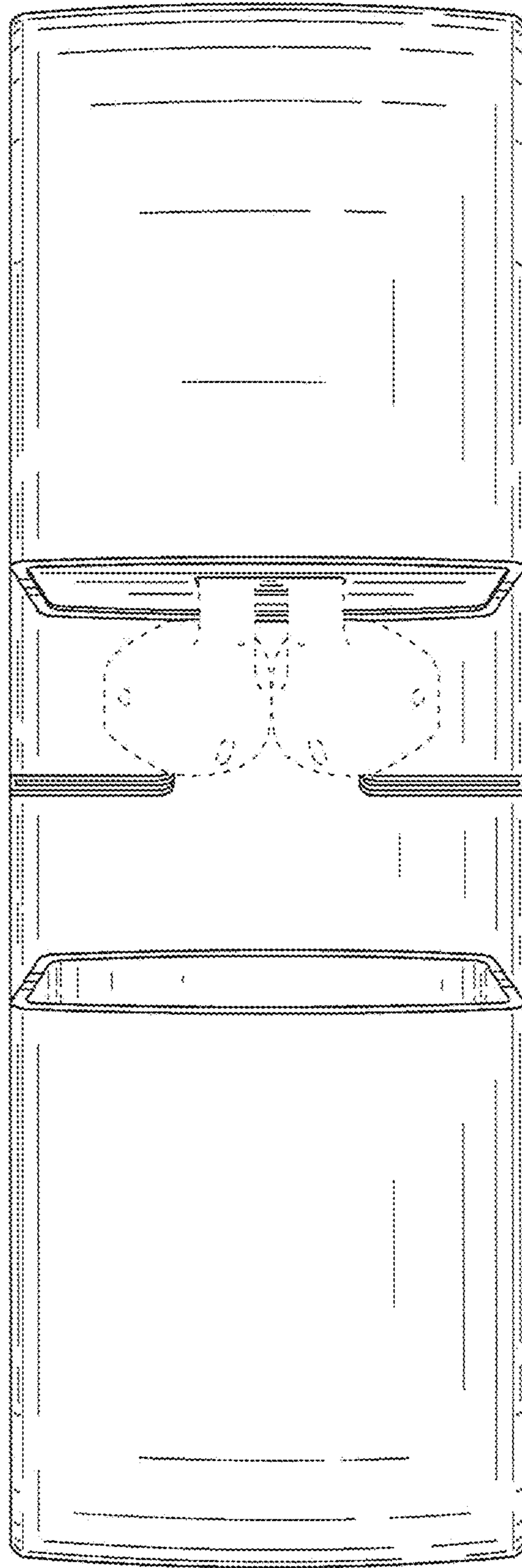

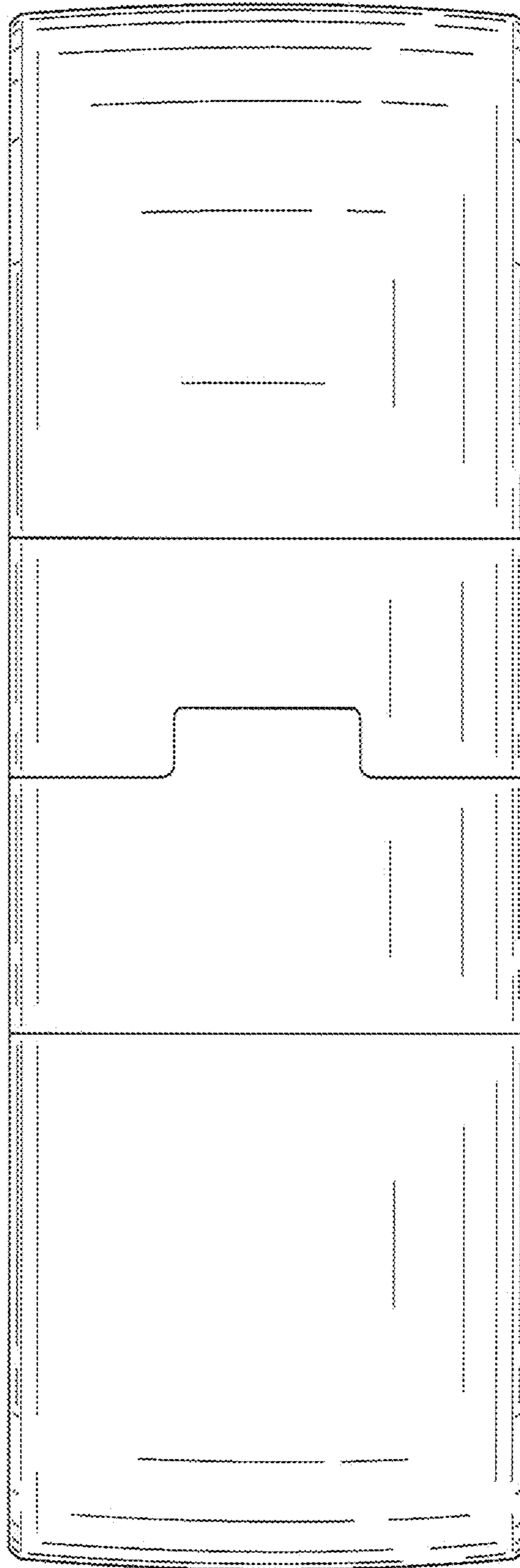
