FIG. 7 is right-side elevation view of the coin tray of FIG.

All broken lines in FIGS. 1, 4 and 5 depict environmental
subject matter only and form no part of the claim. The
broken line in FIGS. 2-3 and 6-7 consisting of unevenly
sized dashes defines the boundary of the claim, which
extends to the boundary but does not include the boundary;
while the remaining broken lines in FIGS. 2-3 and 6-7
consisting of evenly sized dashes depict portions of the coin
tray that form no part of the claim.

The unshaded surfaces shown in FIGS. 3, 6 and 7 between
the solid lines and the broken lines form no part of the
claimed design.

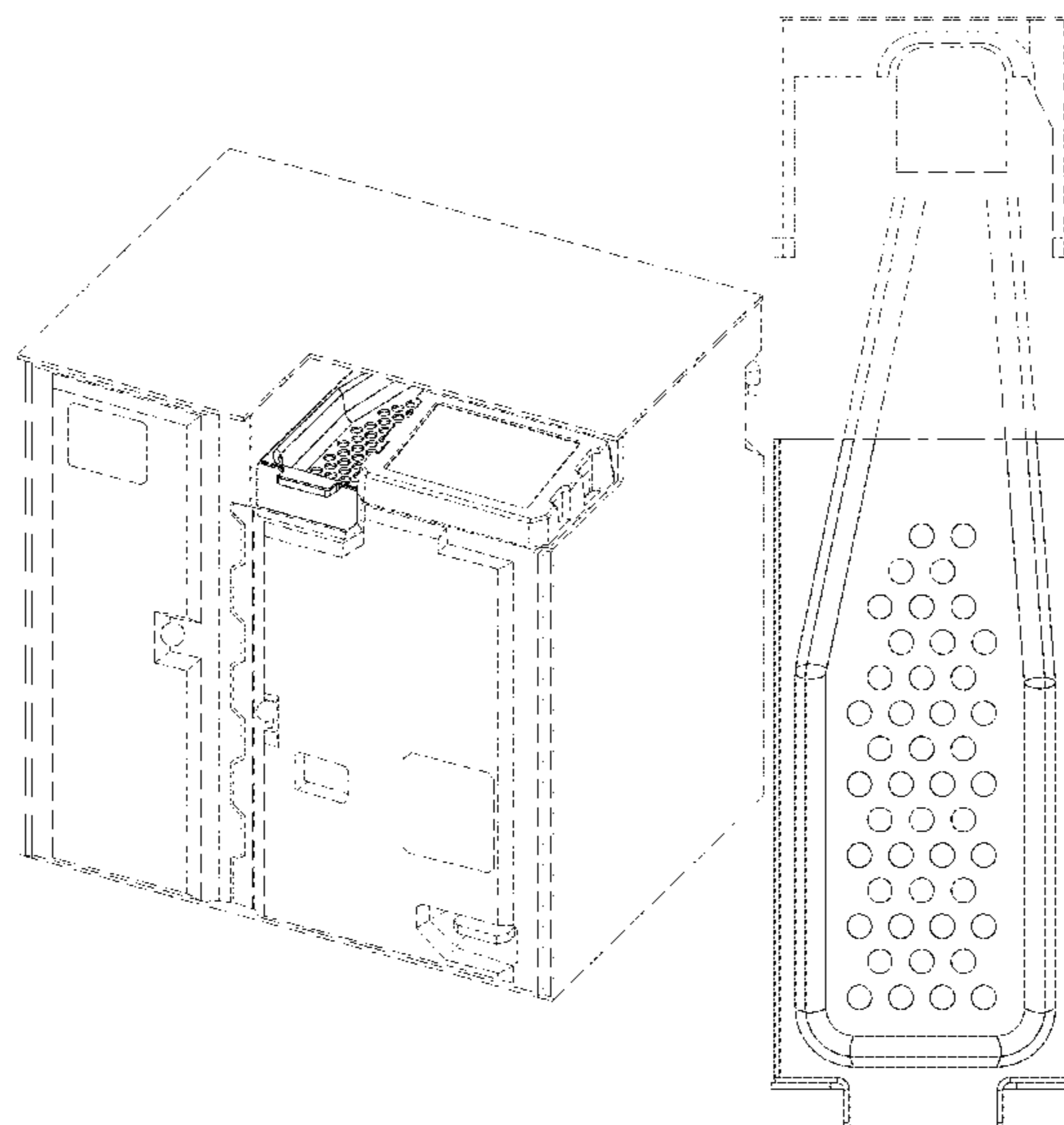

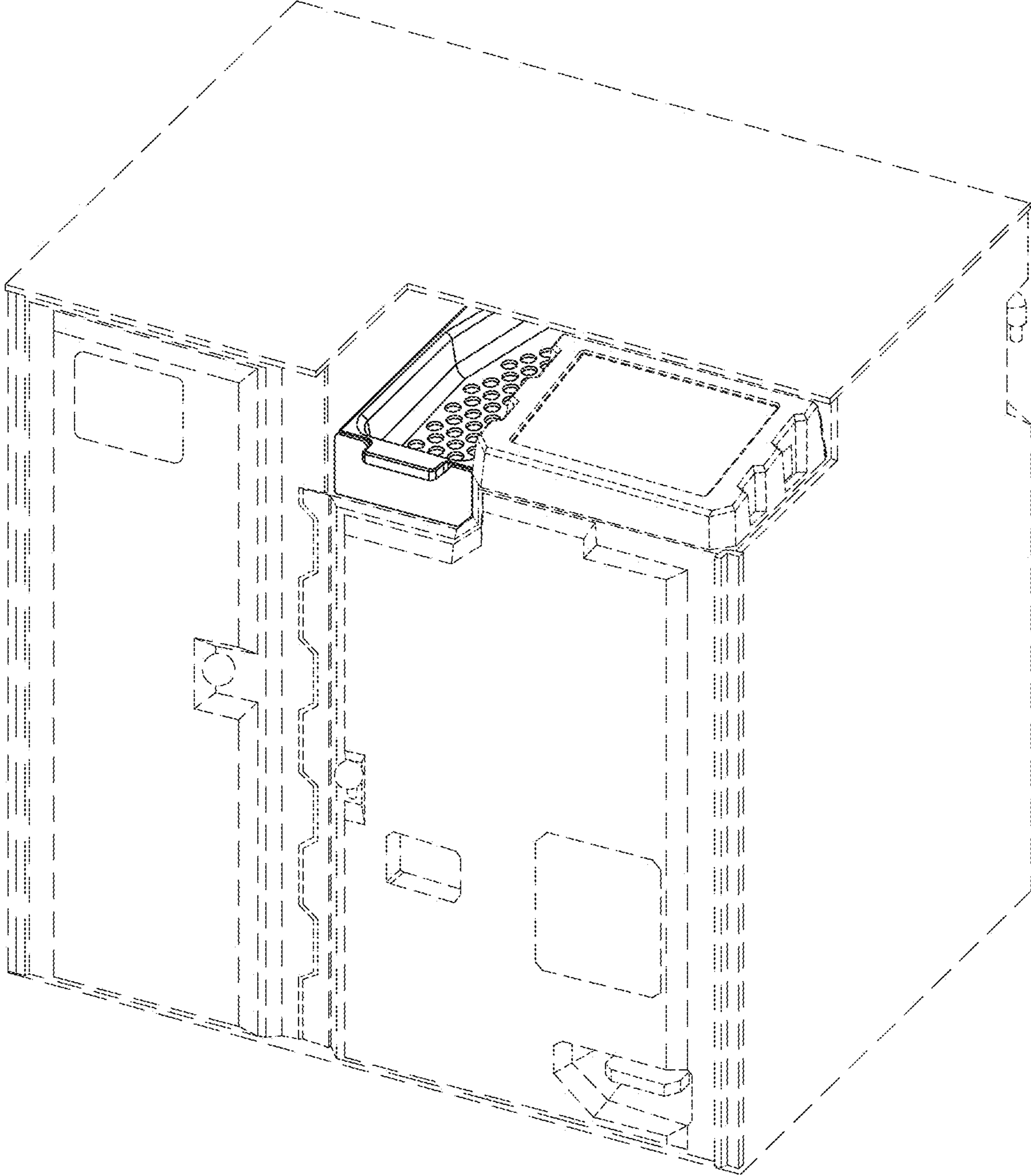

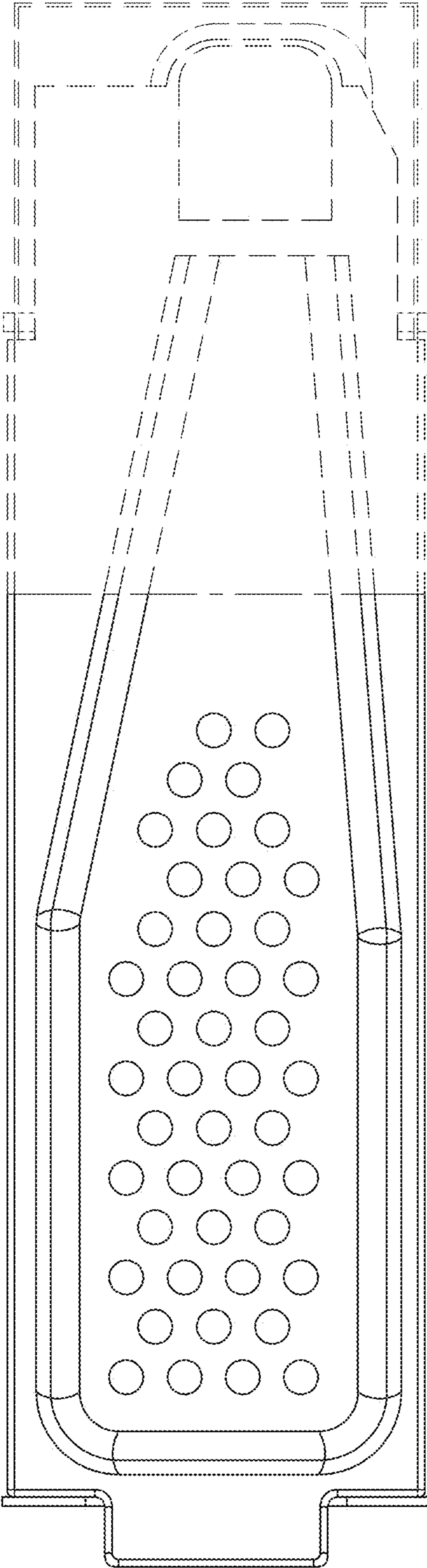

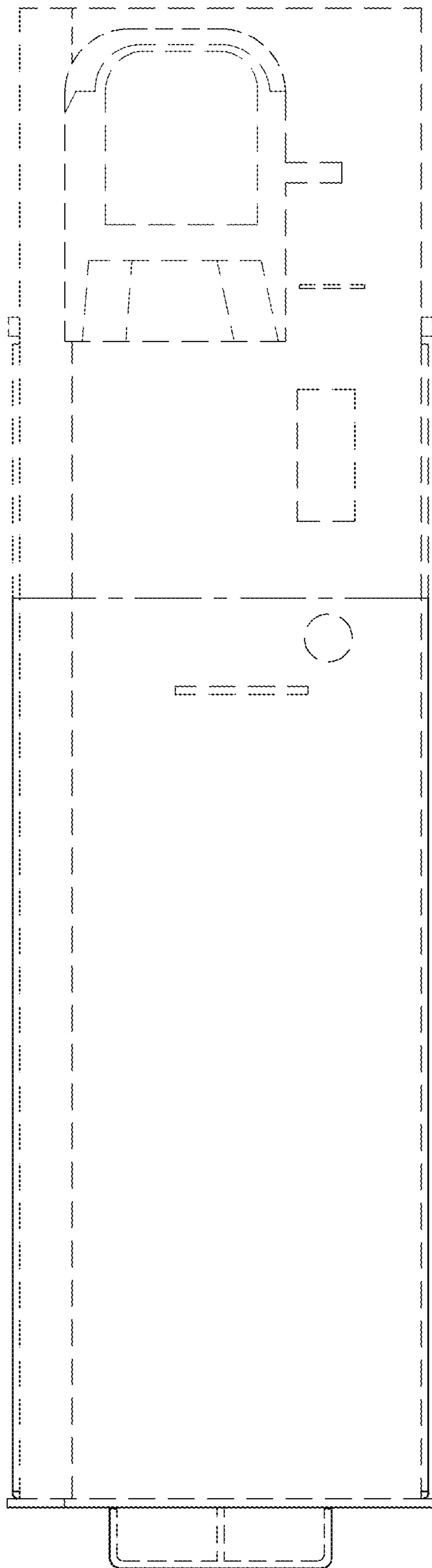

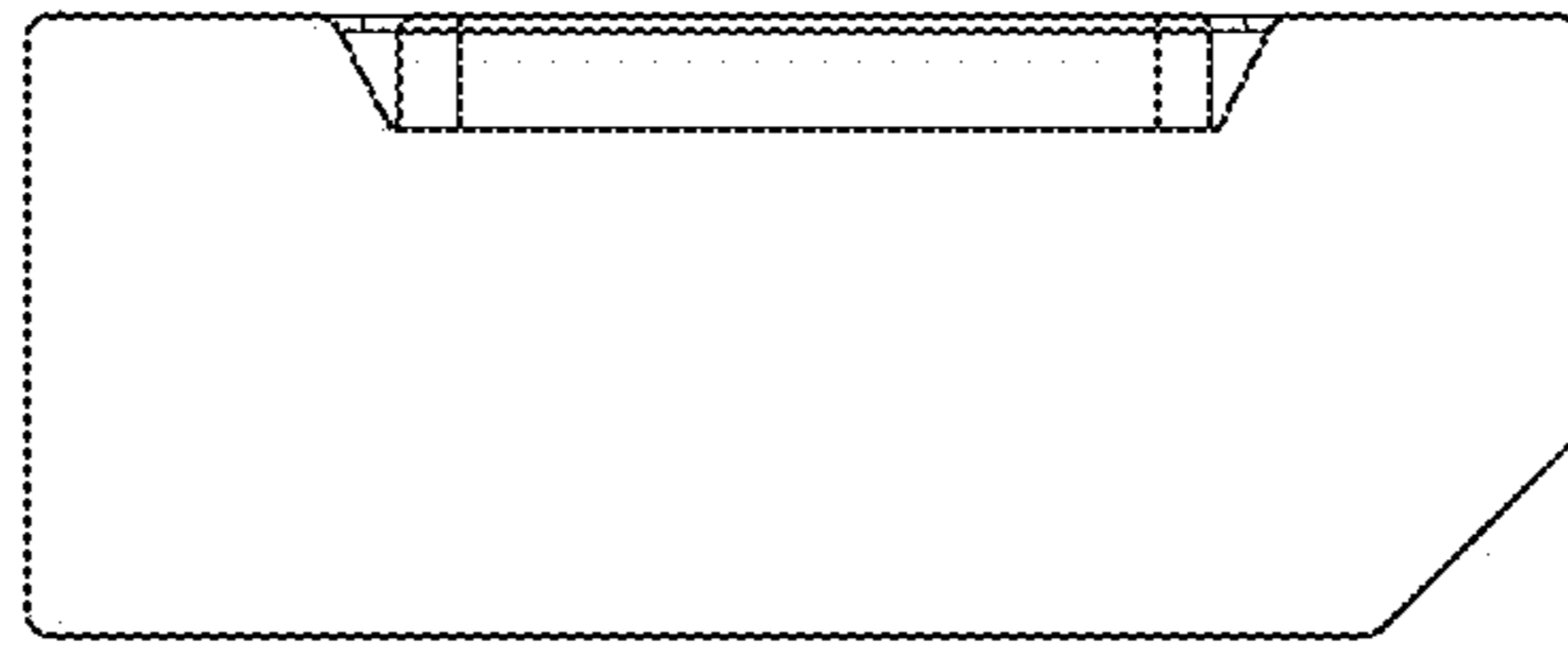

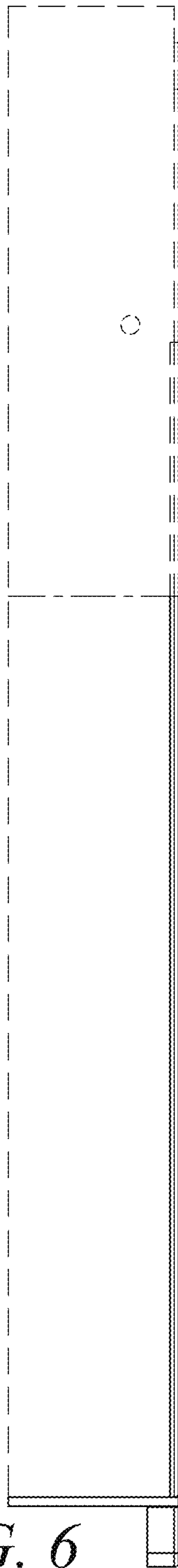

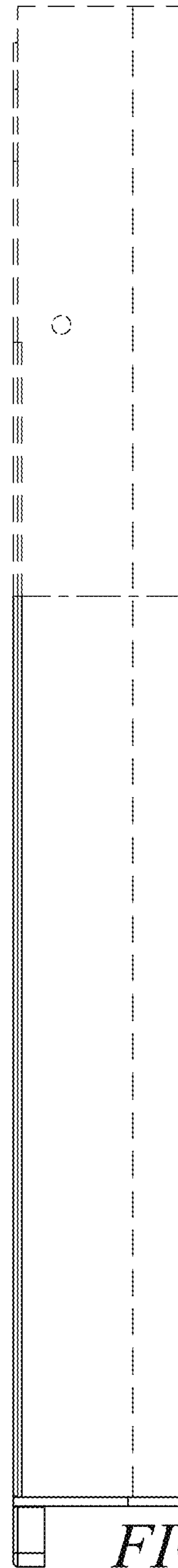
