FIG. 3 illustrates in perspective an electronic display with the gaming surface graphic of FIG. 1.

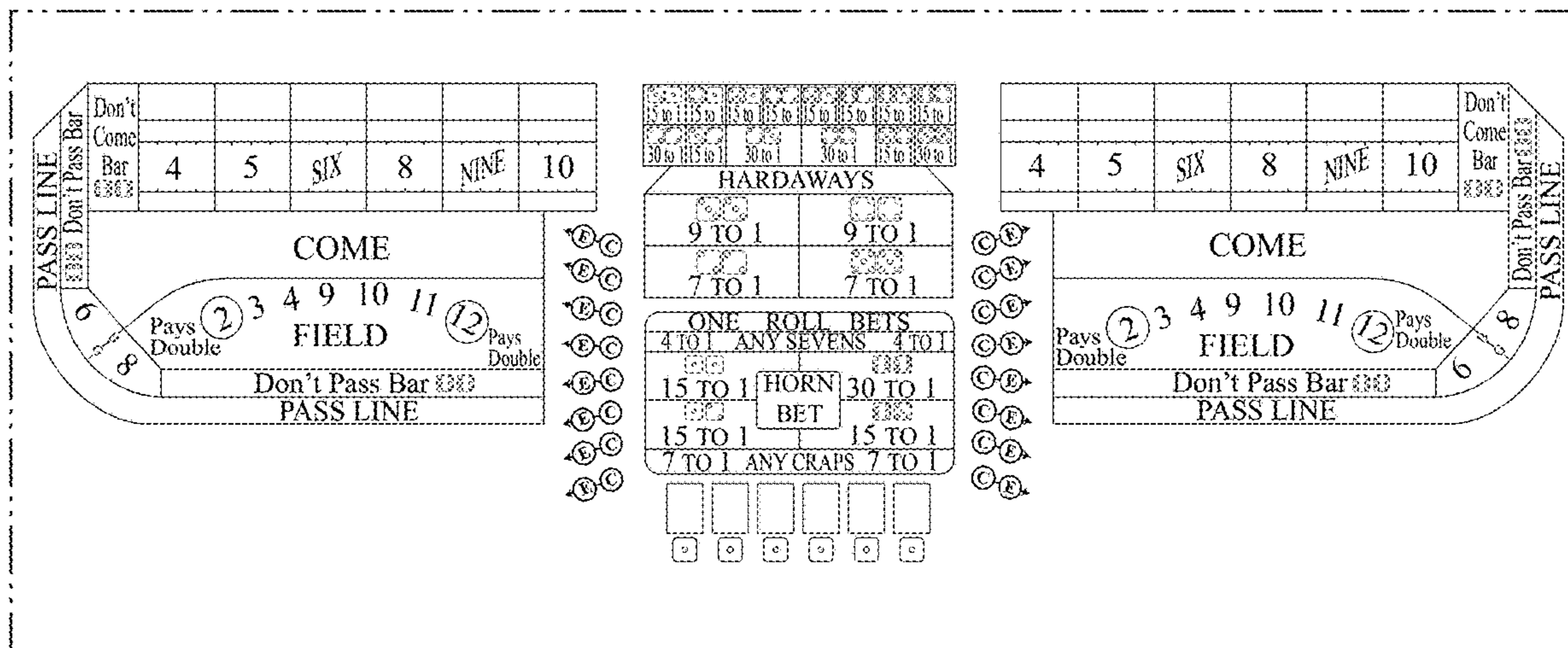

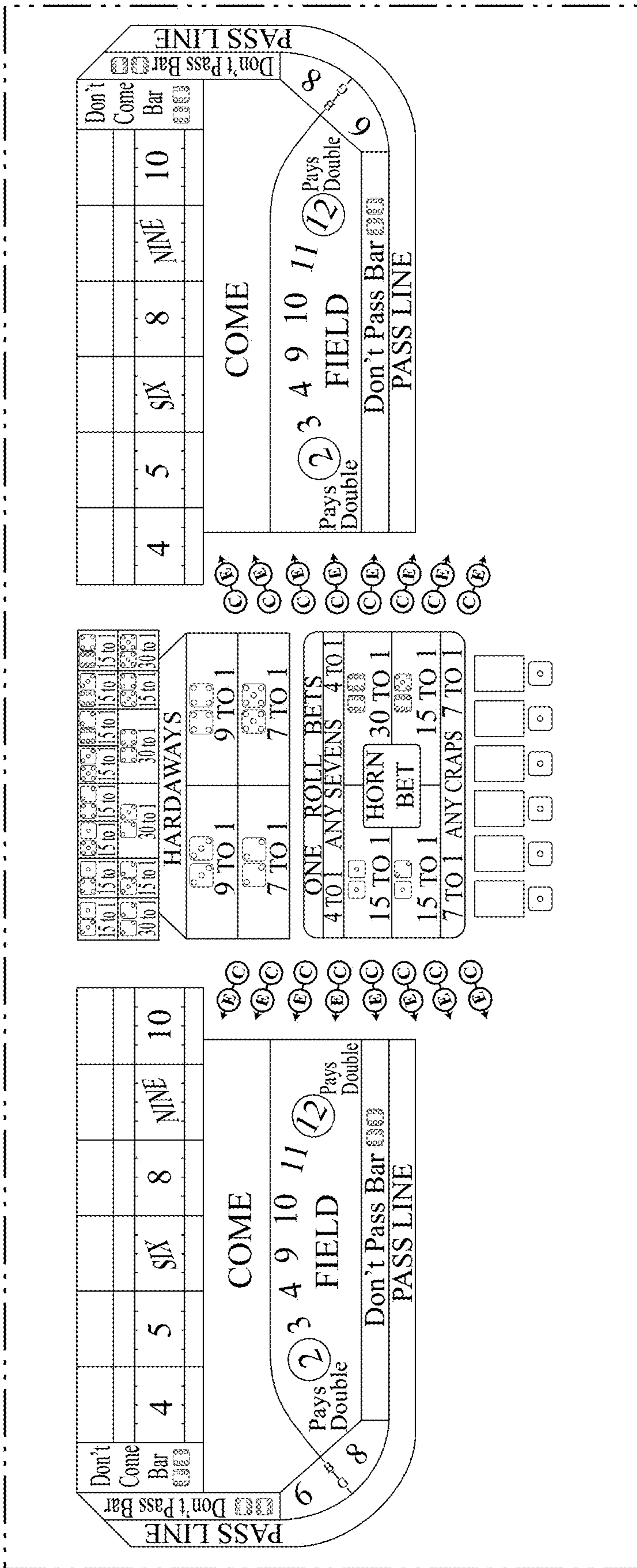

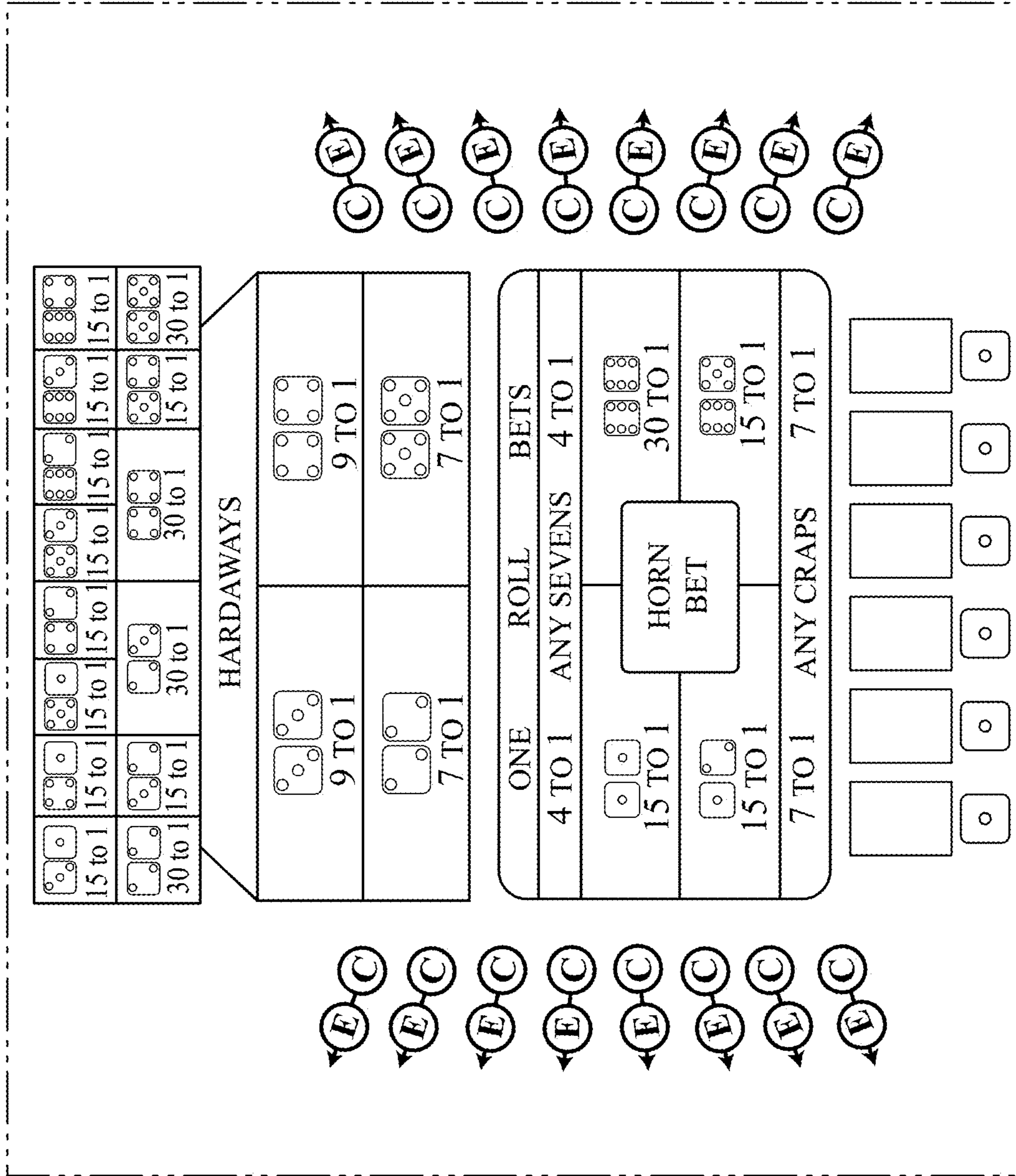

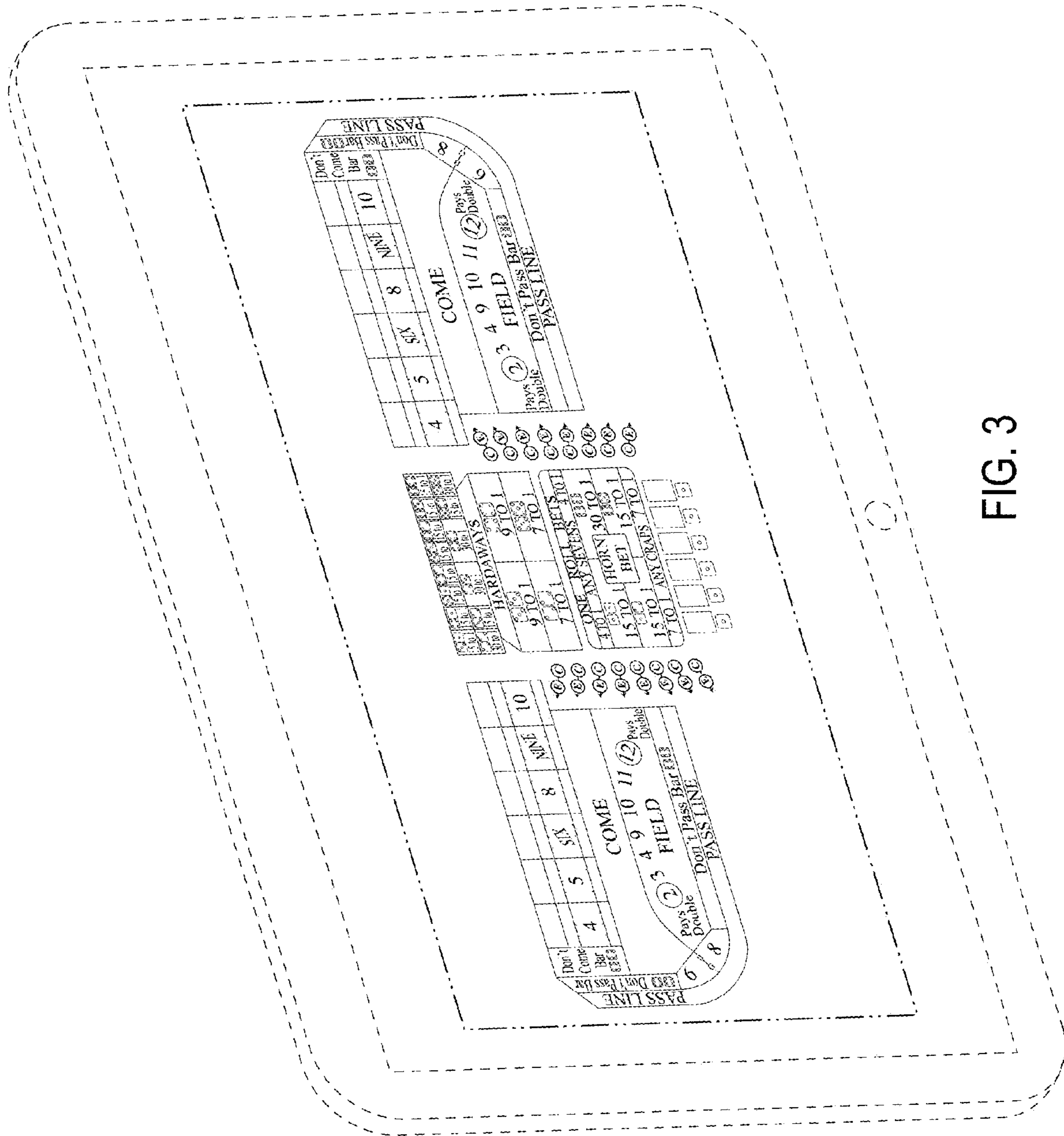
