FIG. 3 is a side view thereof.

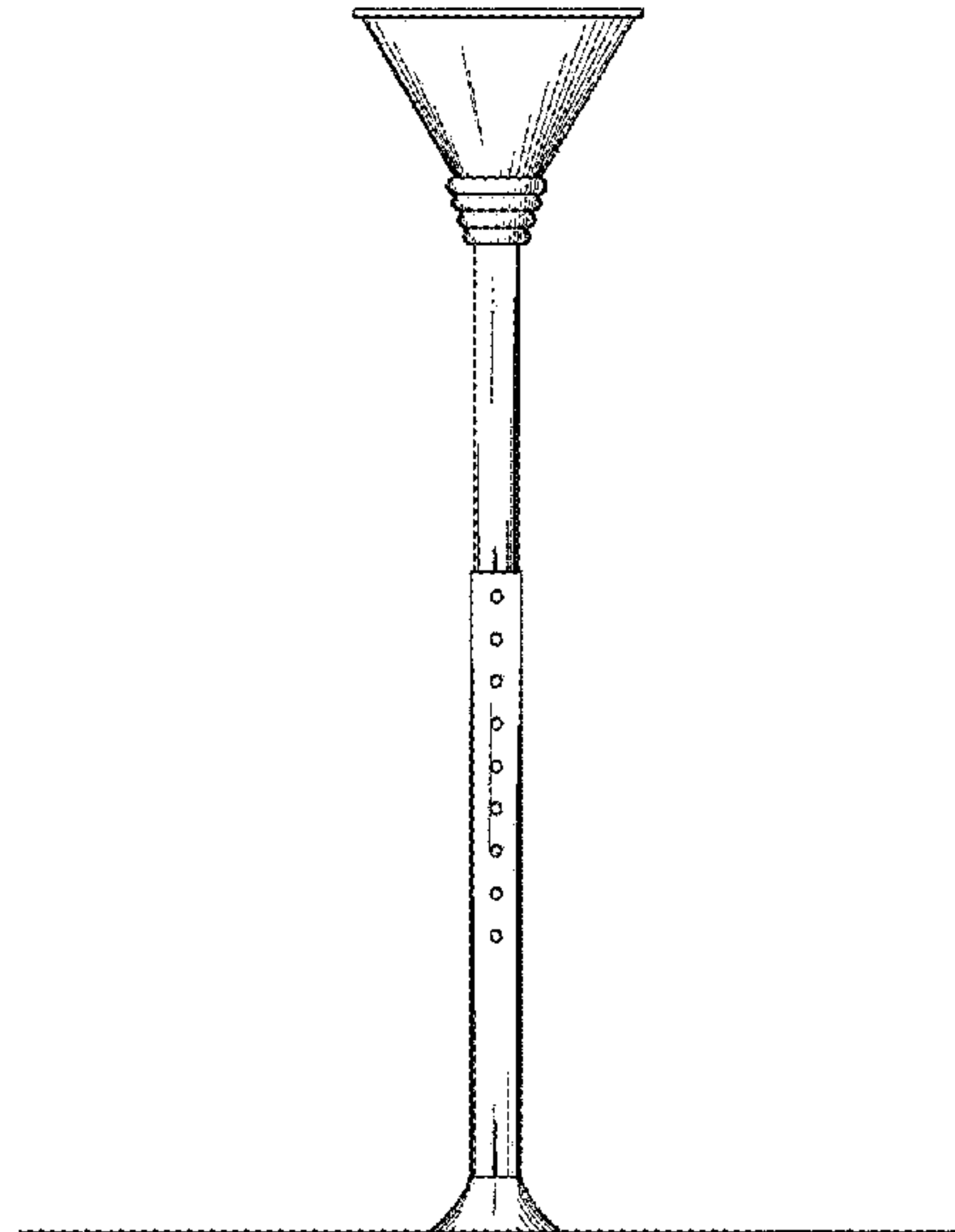
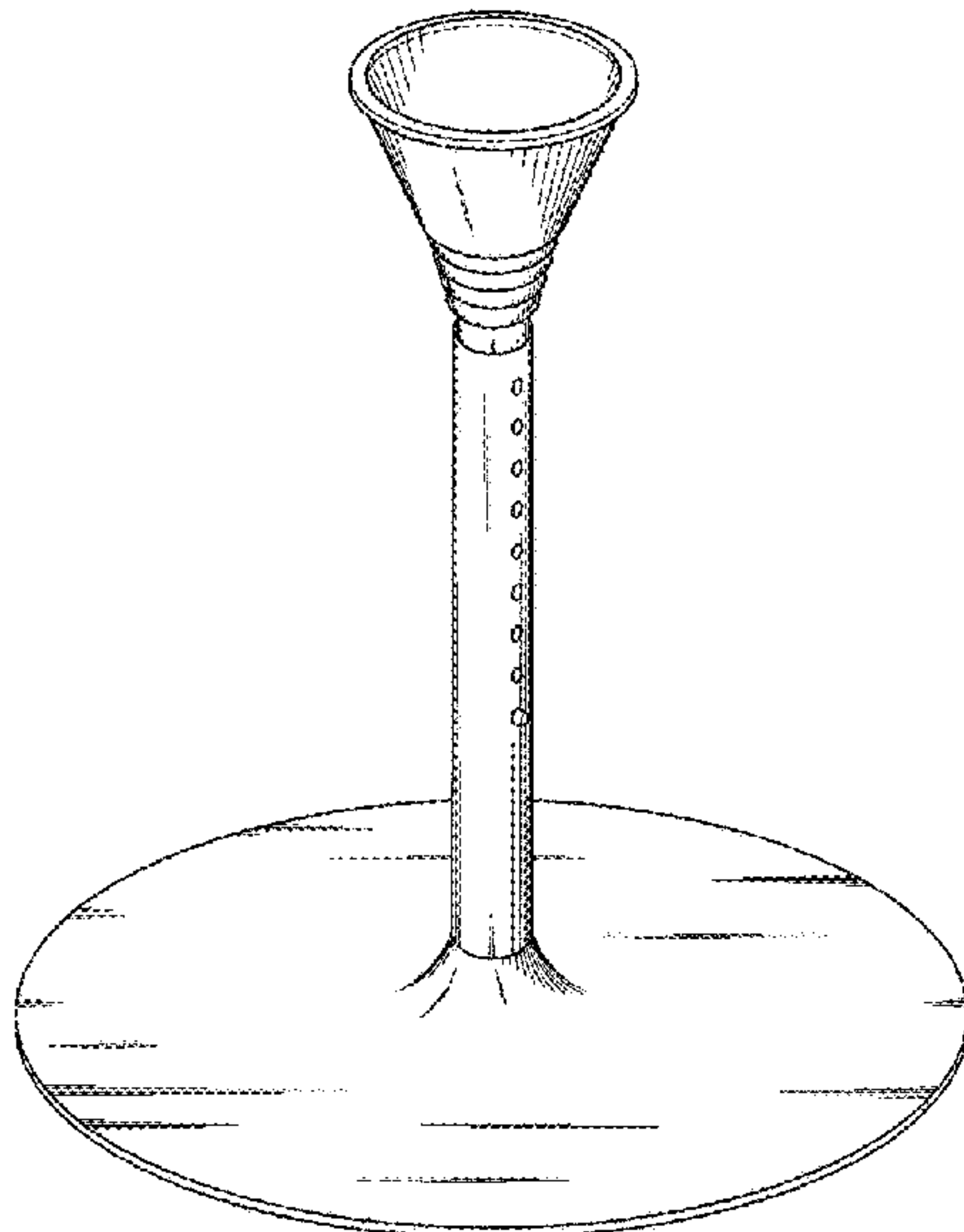
FIG. 4 is a side view thereof.

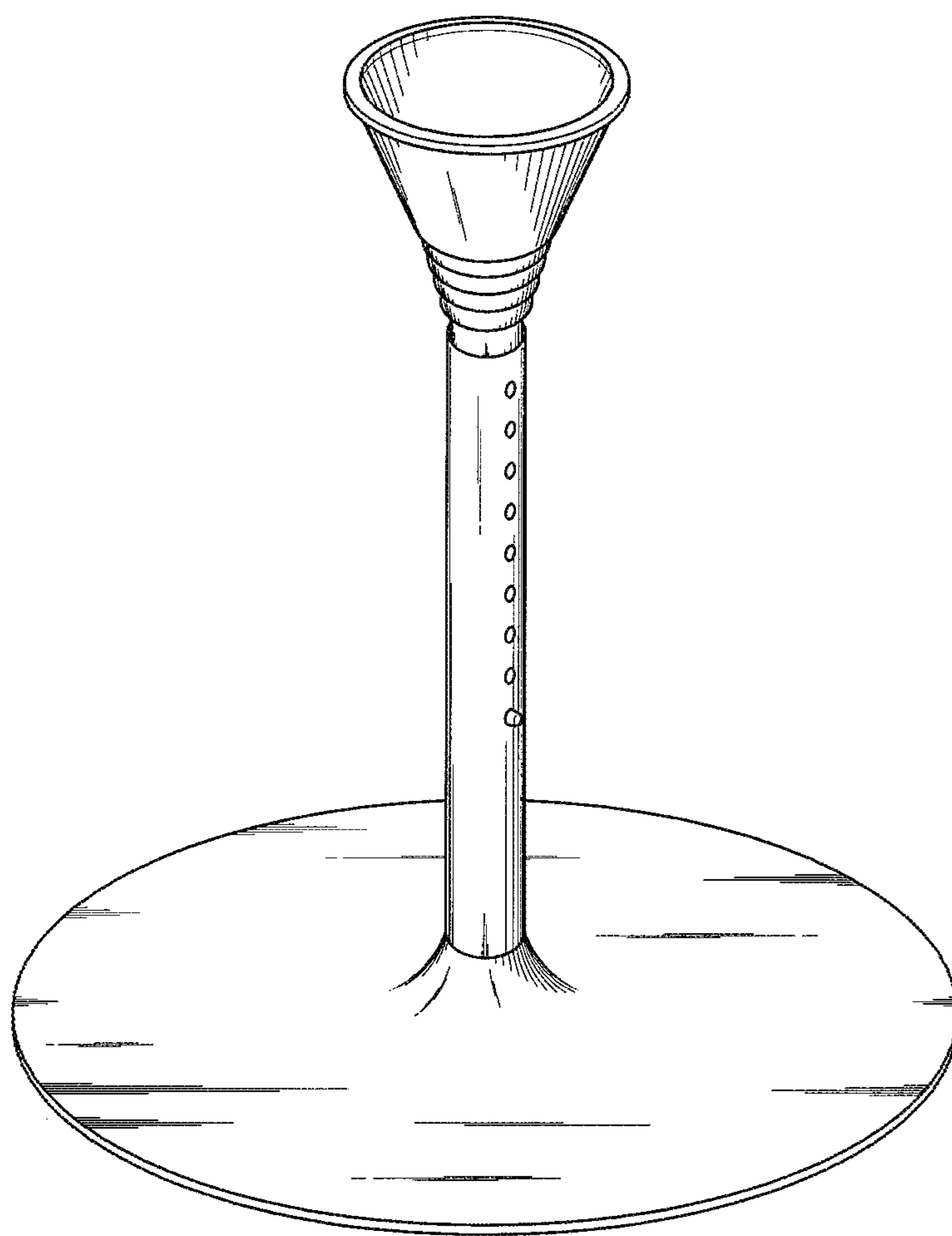

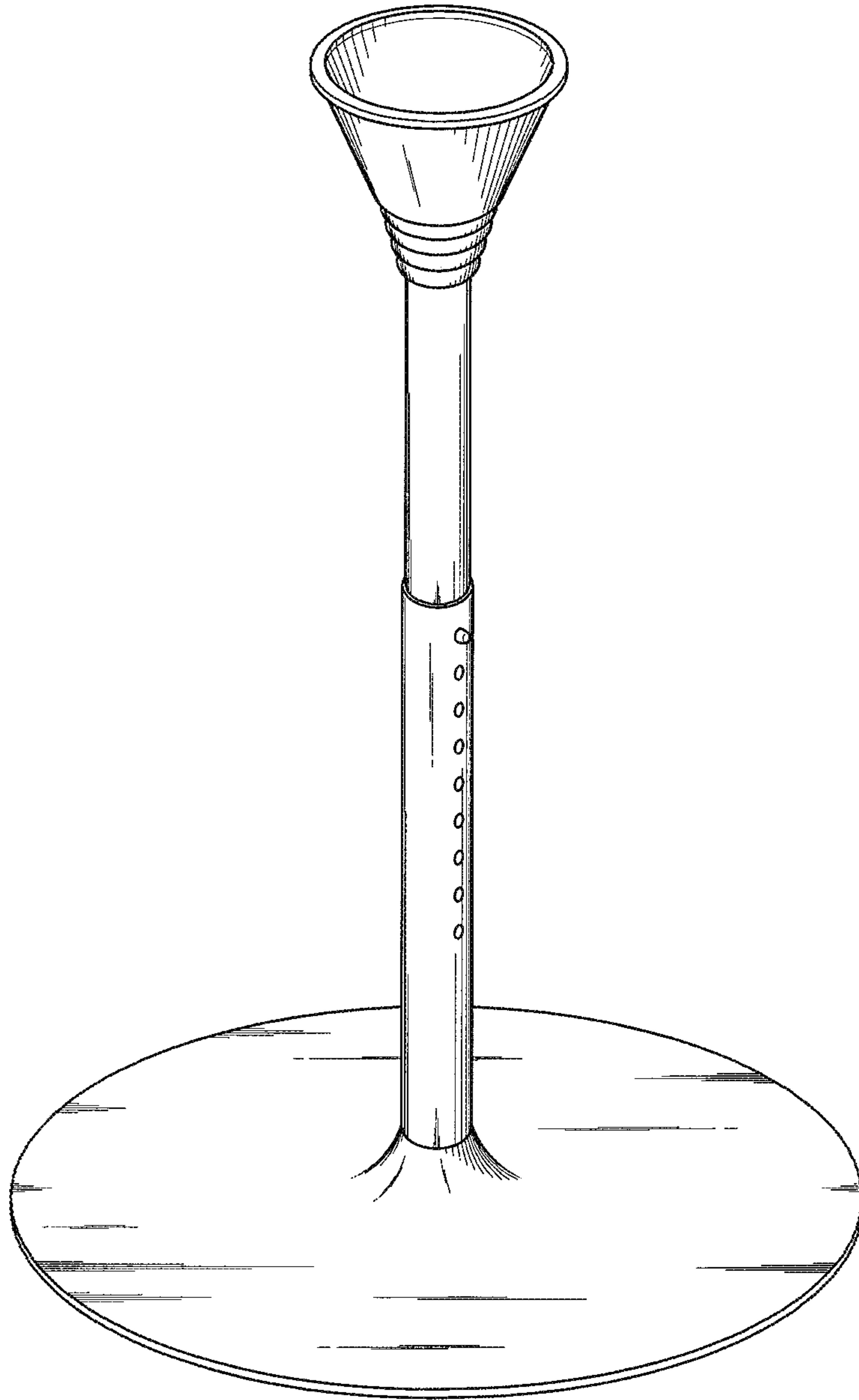

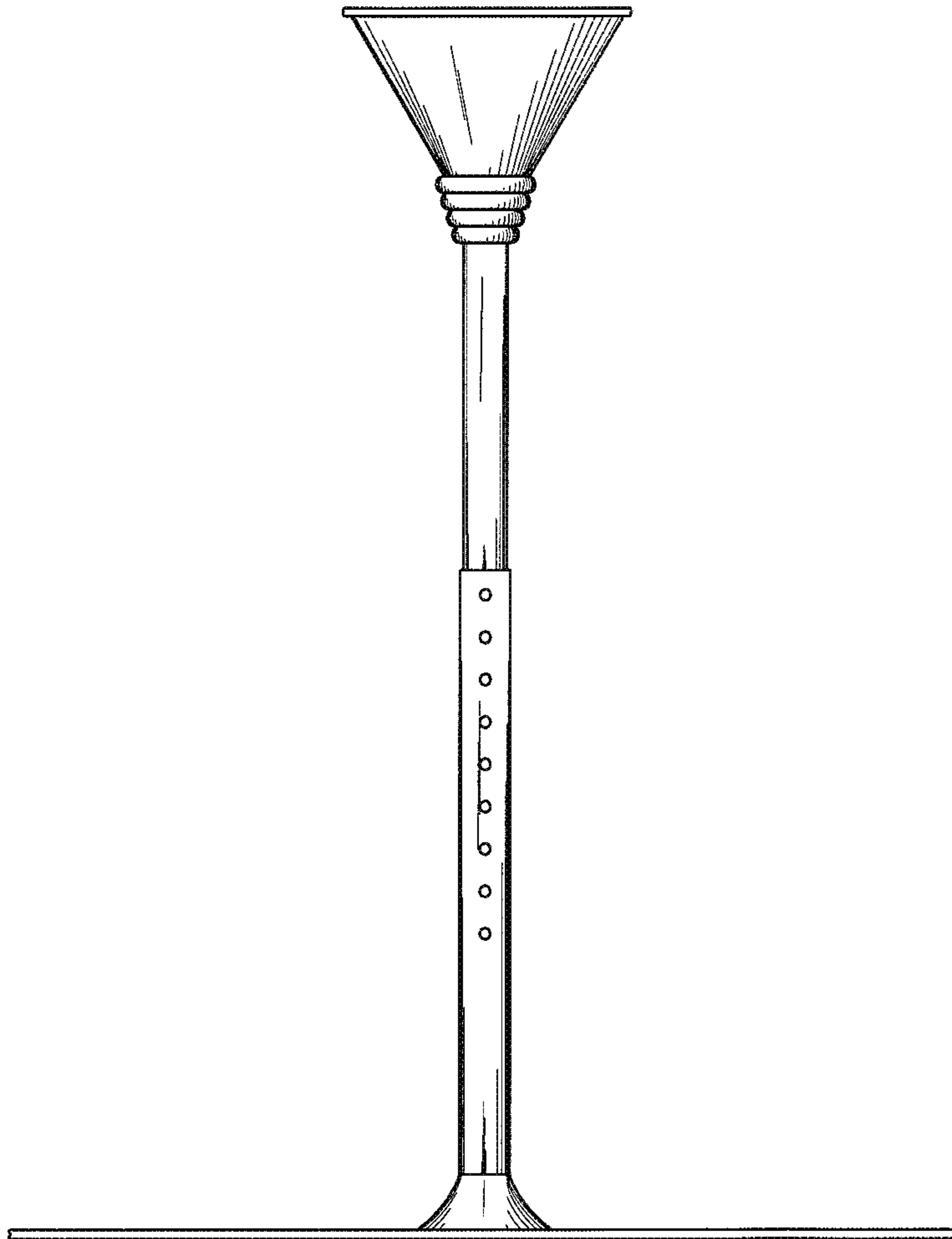

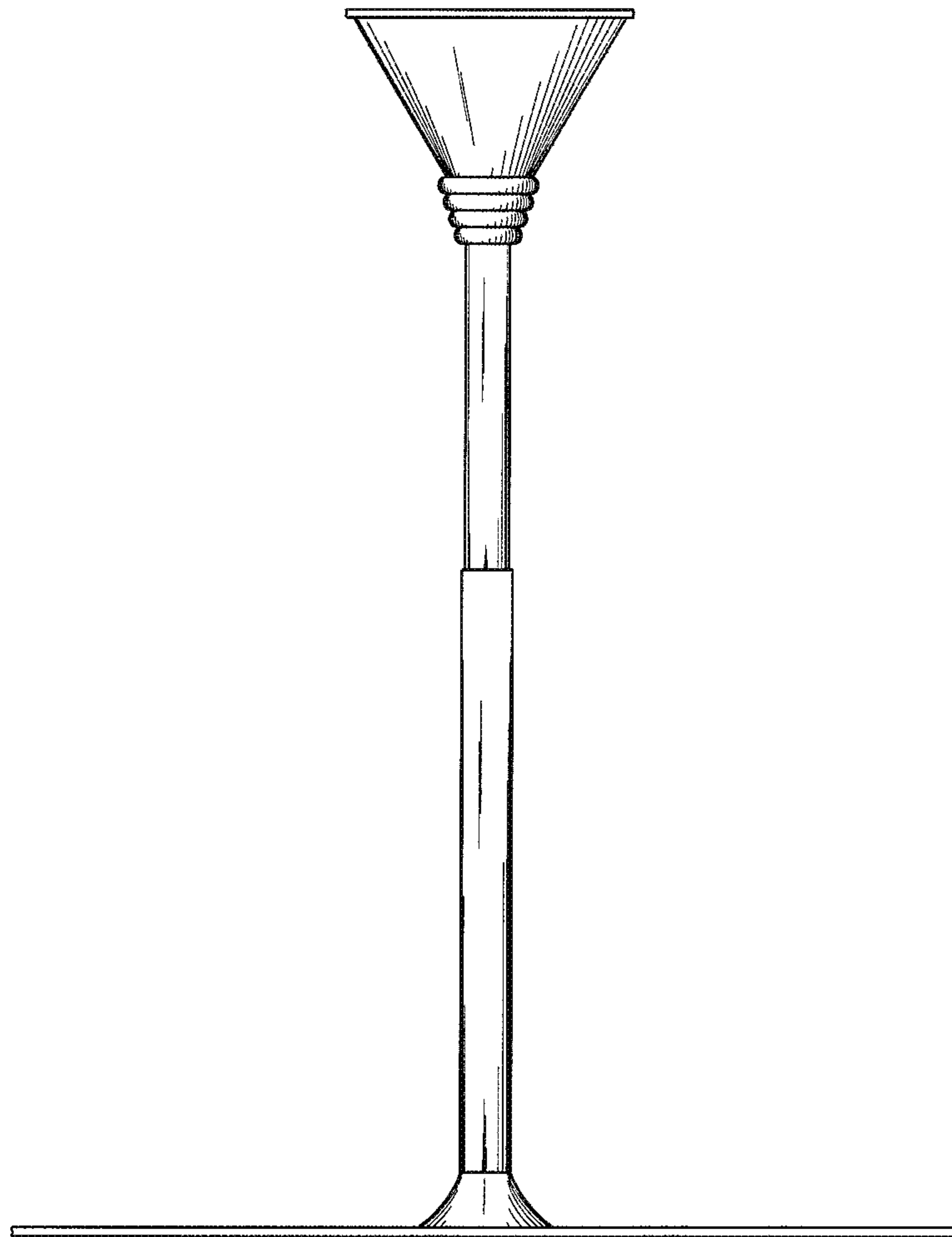

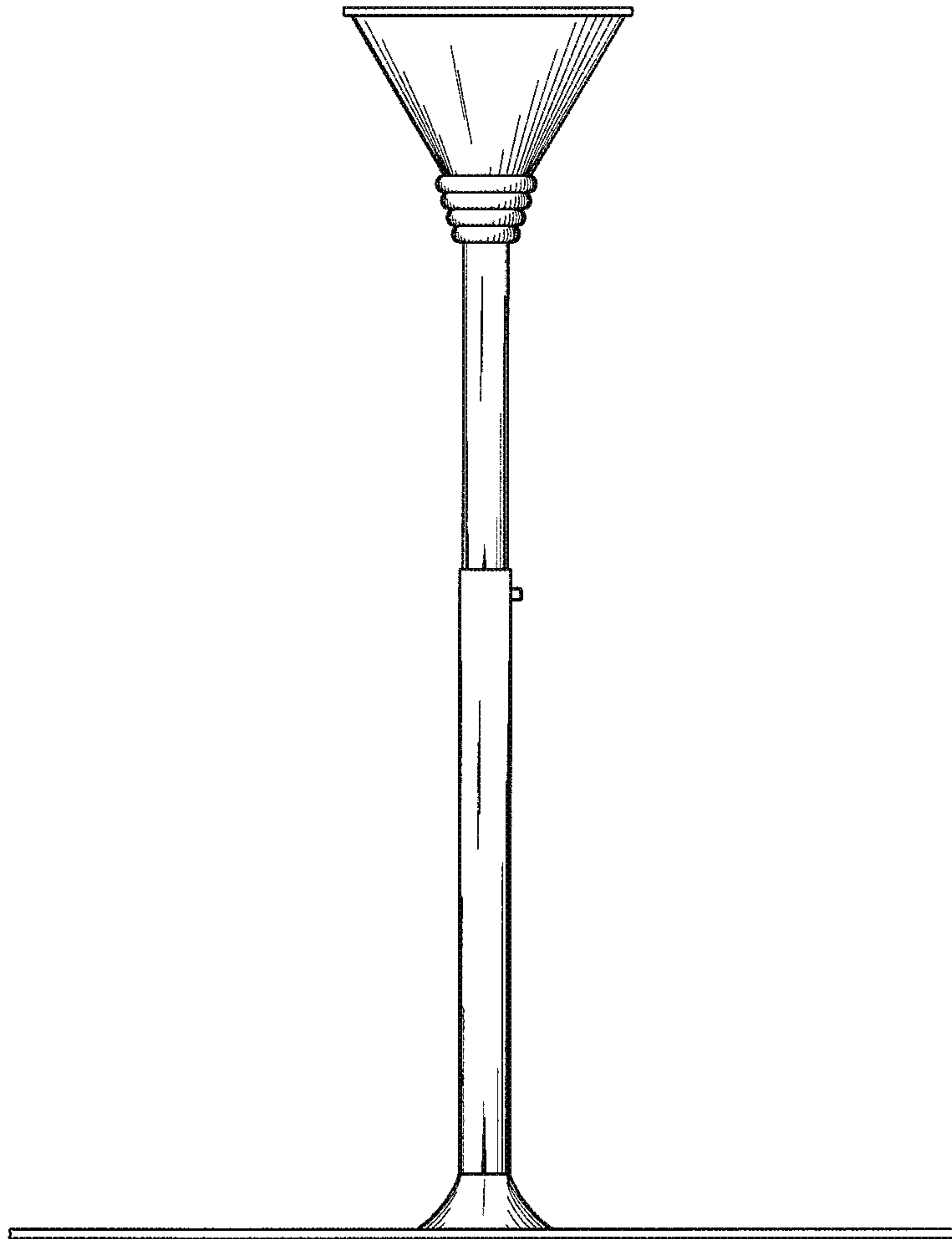

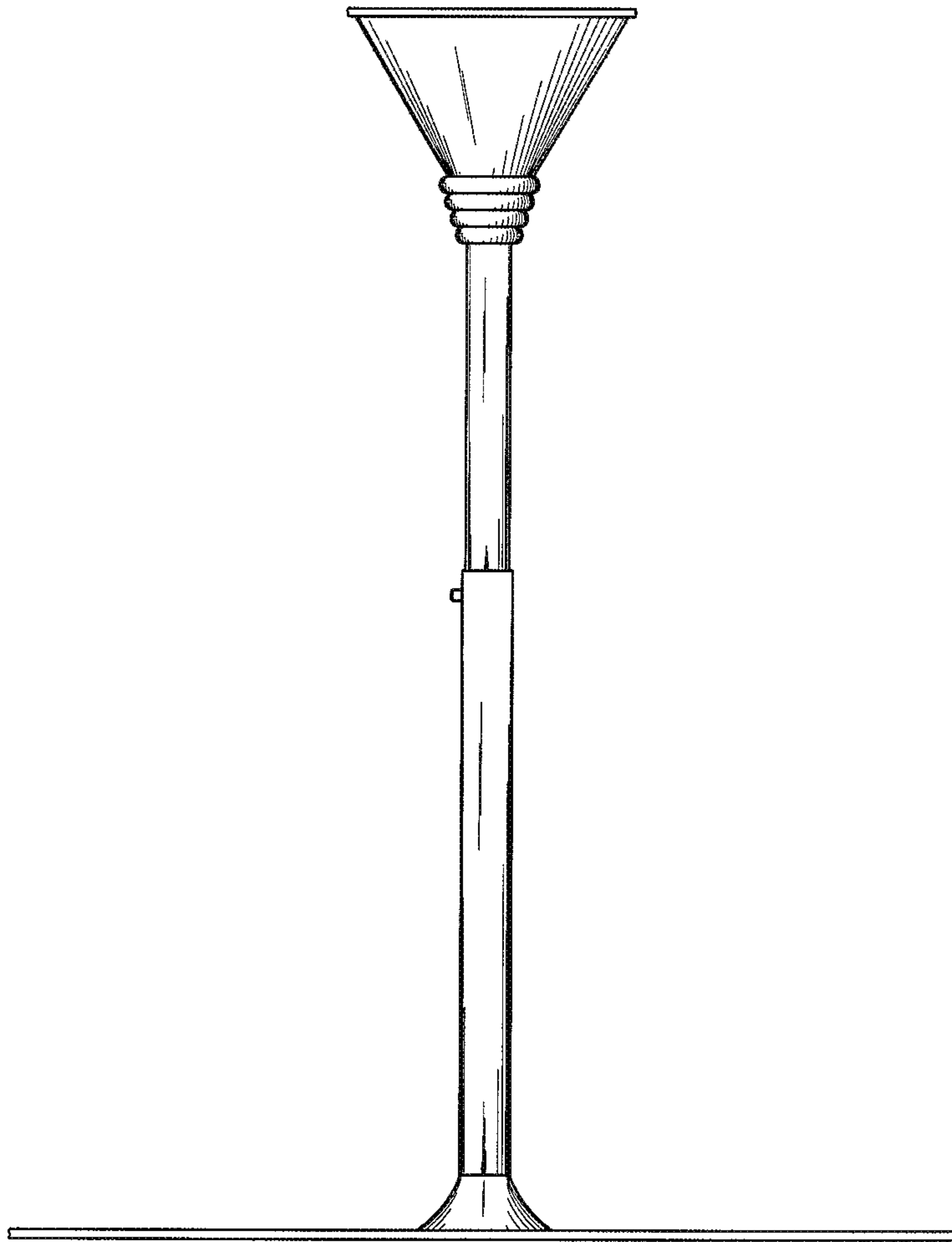

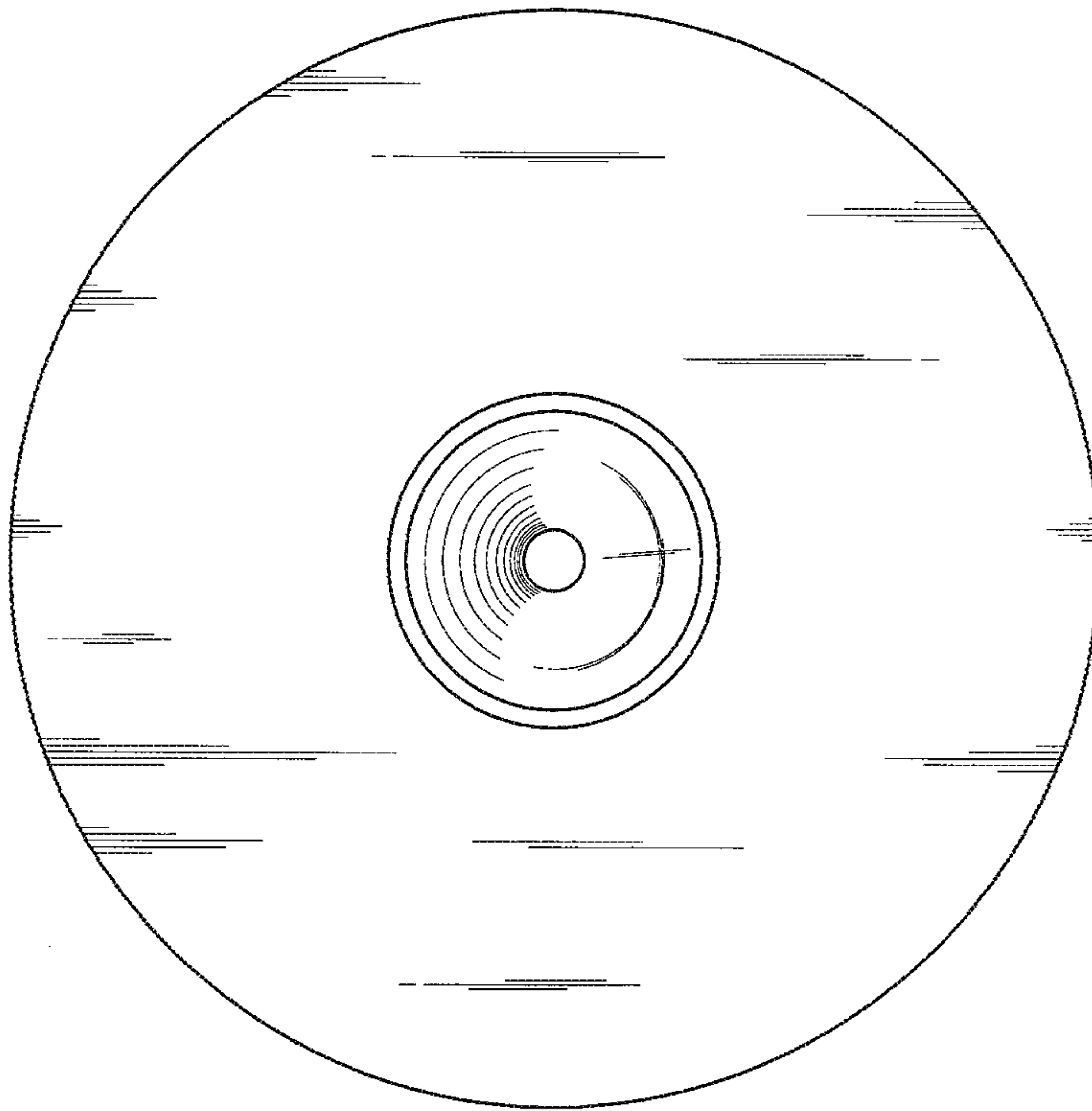
