**DESCRIPTION**

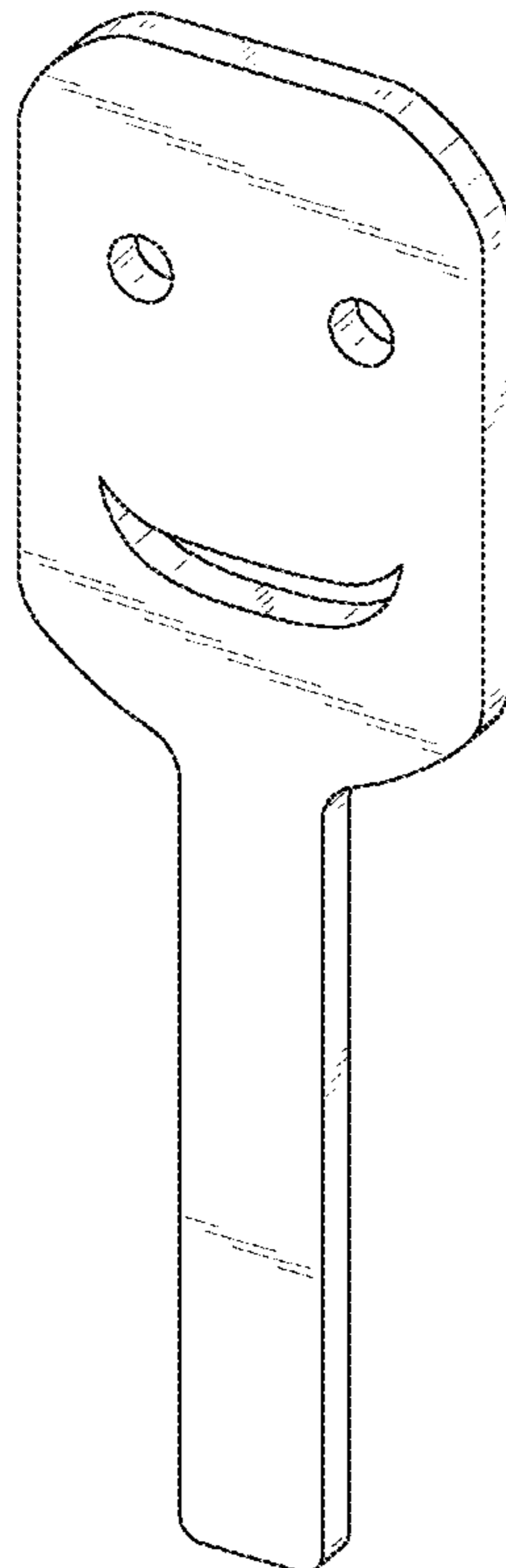
FIG. 1 is a front perspective view of a water recreation float showing my new design; and

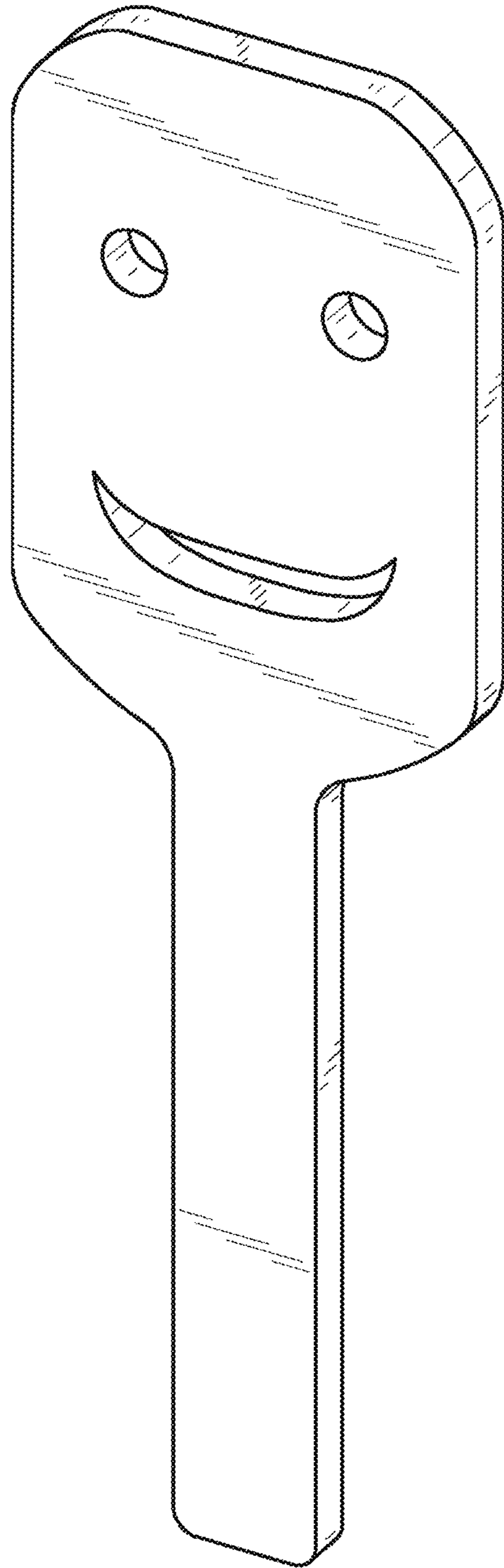

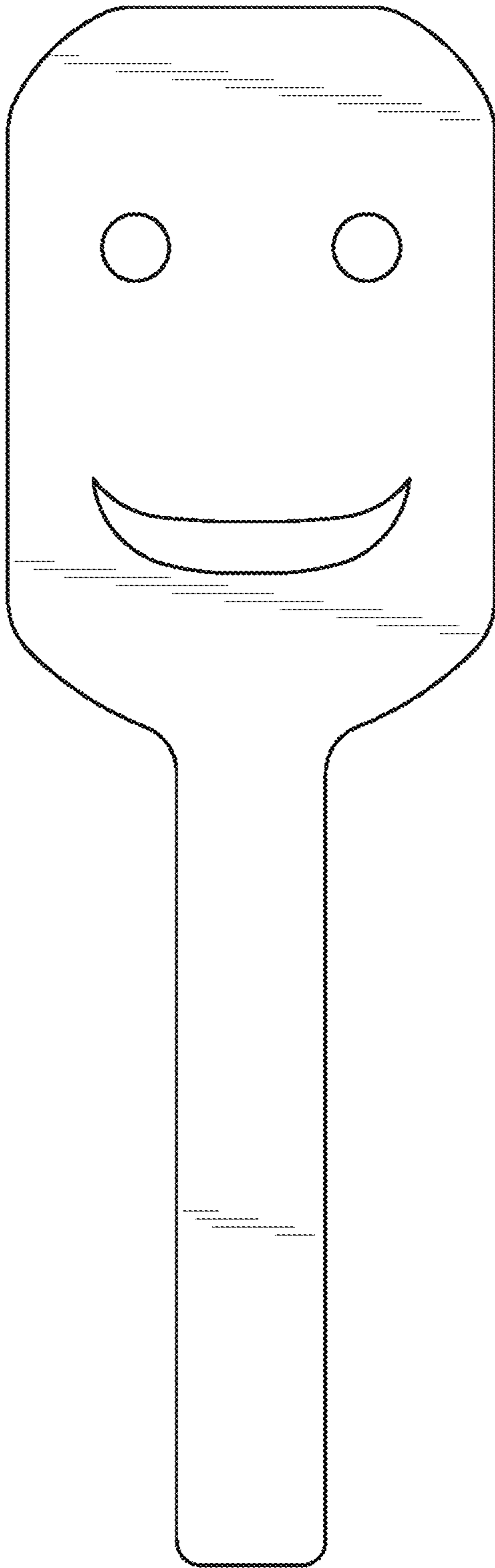

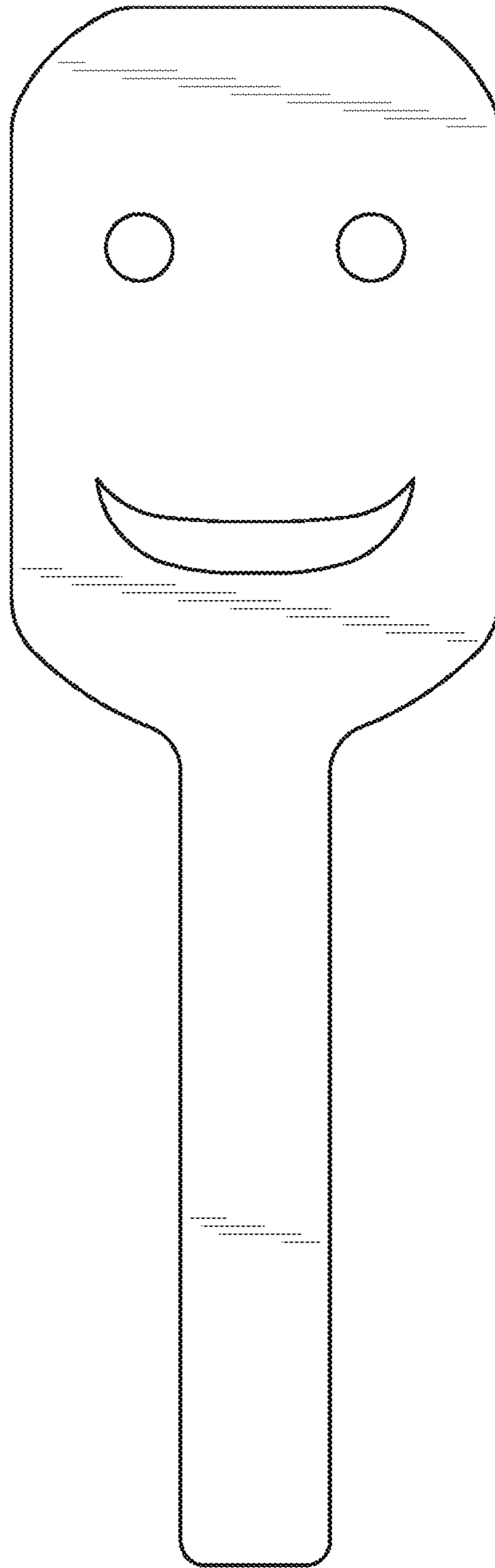

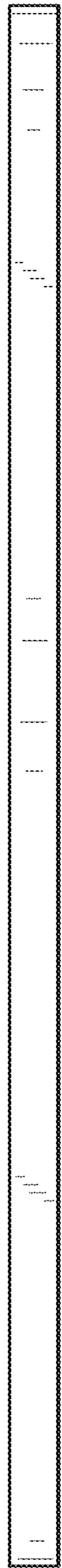

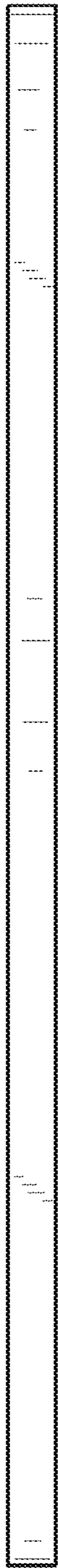
