FIG. 5 is a front view of the robotic surgical system handpiece;

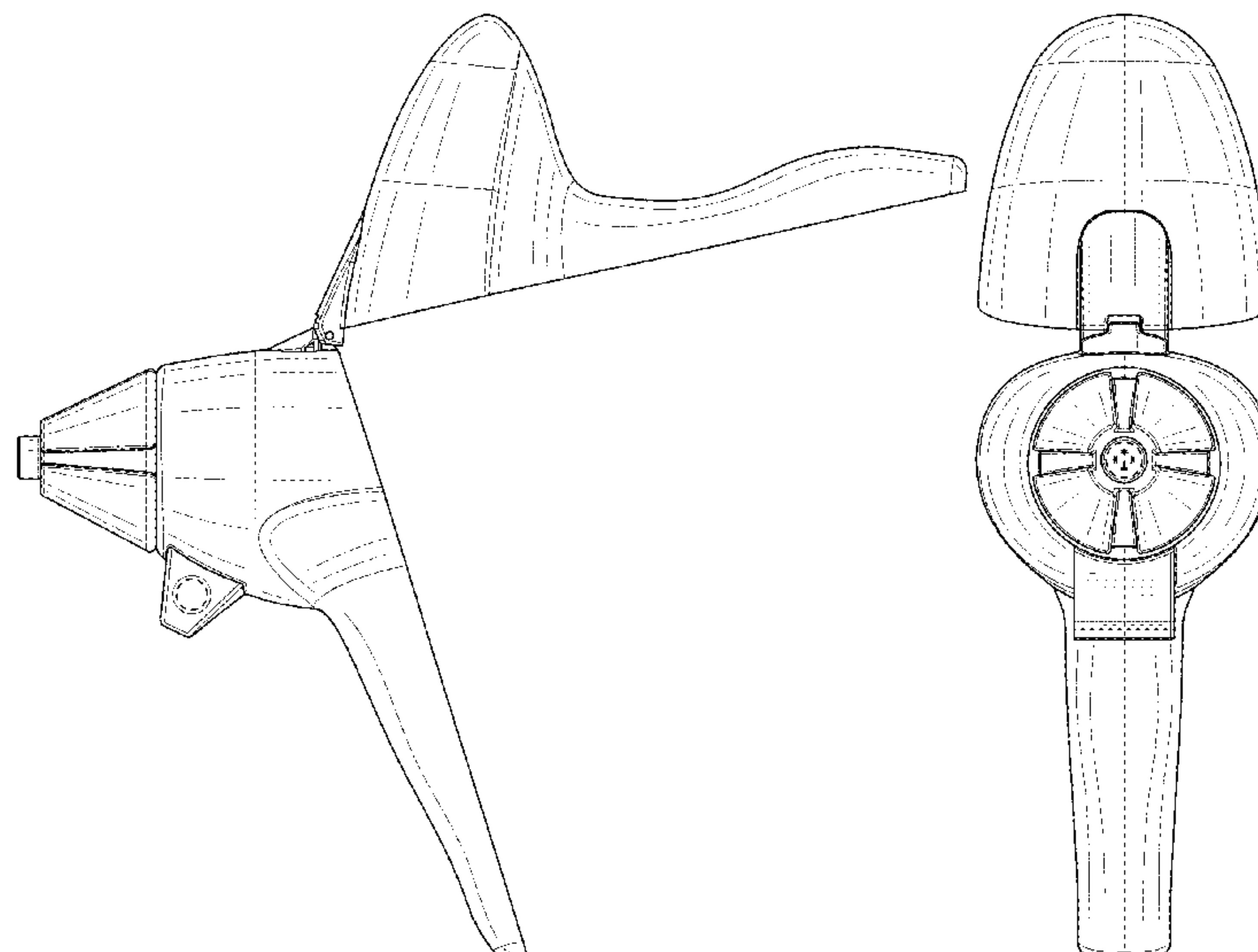
FIG. 6 is a top view of the robotic surgical system handpiece; and,

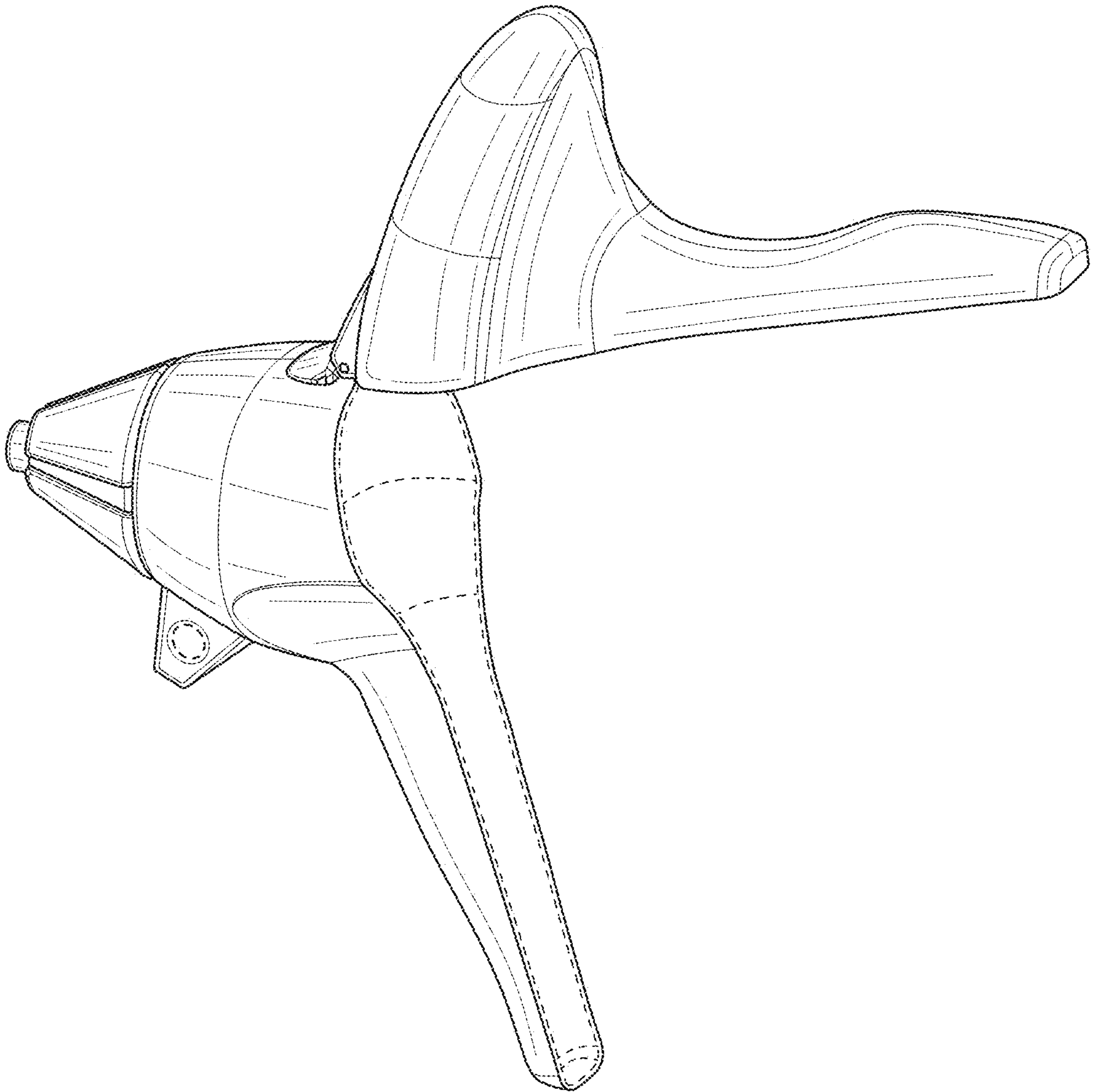

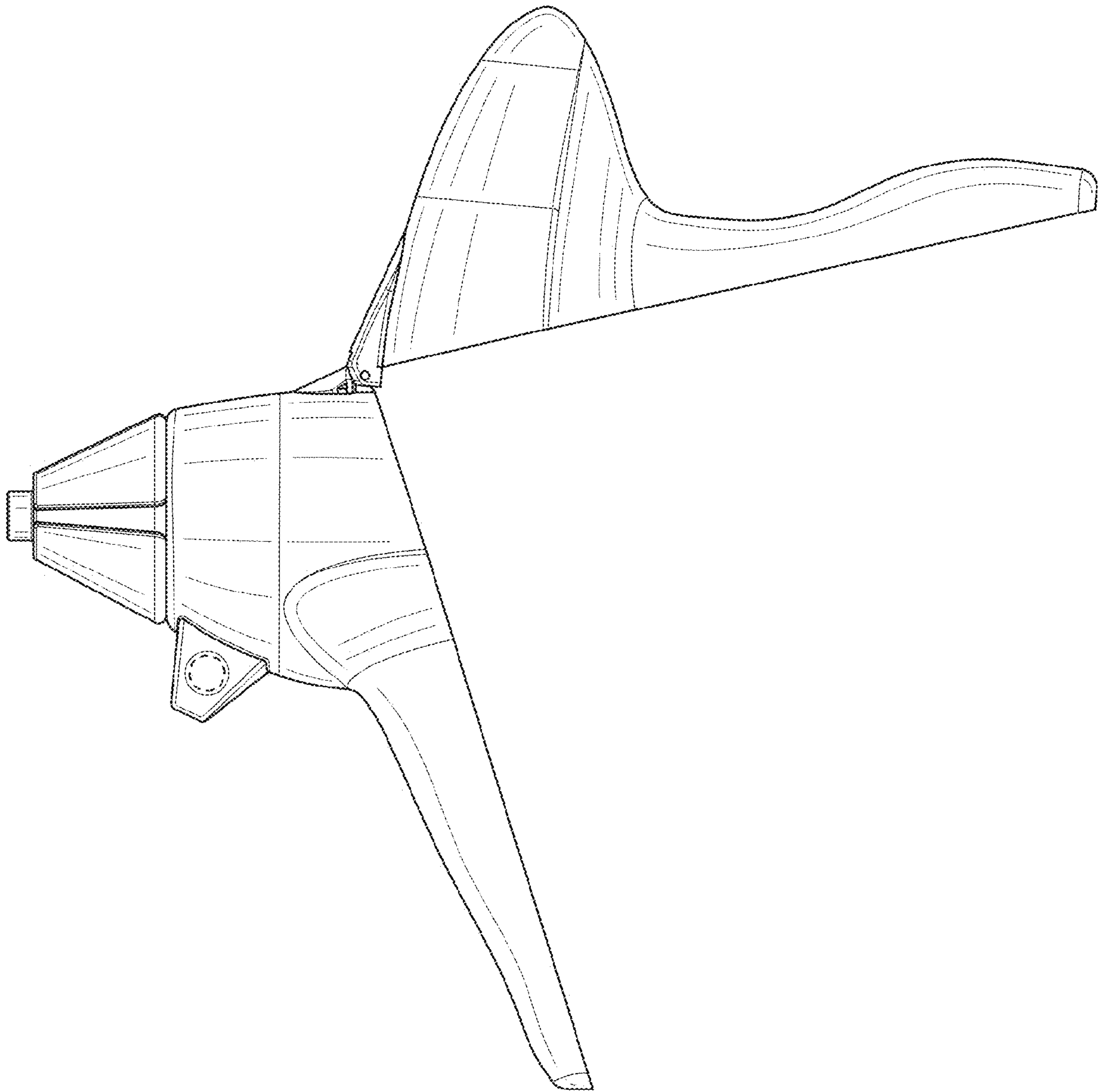

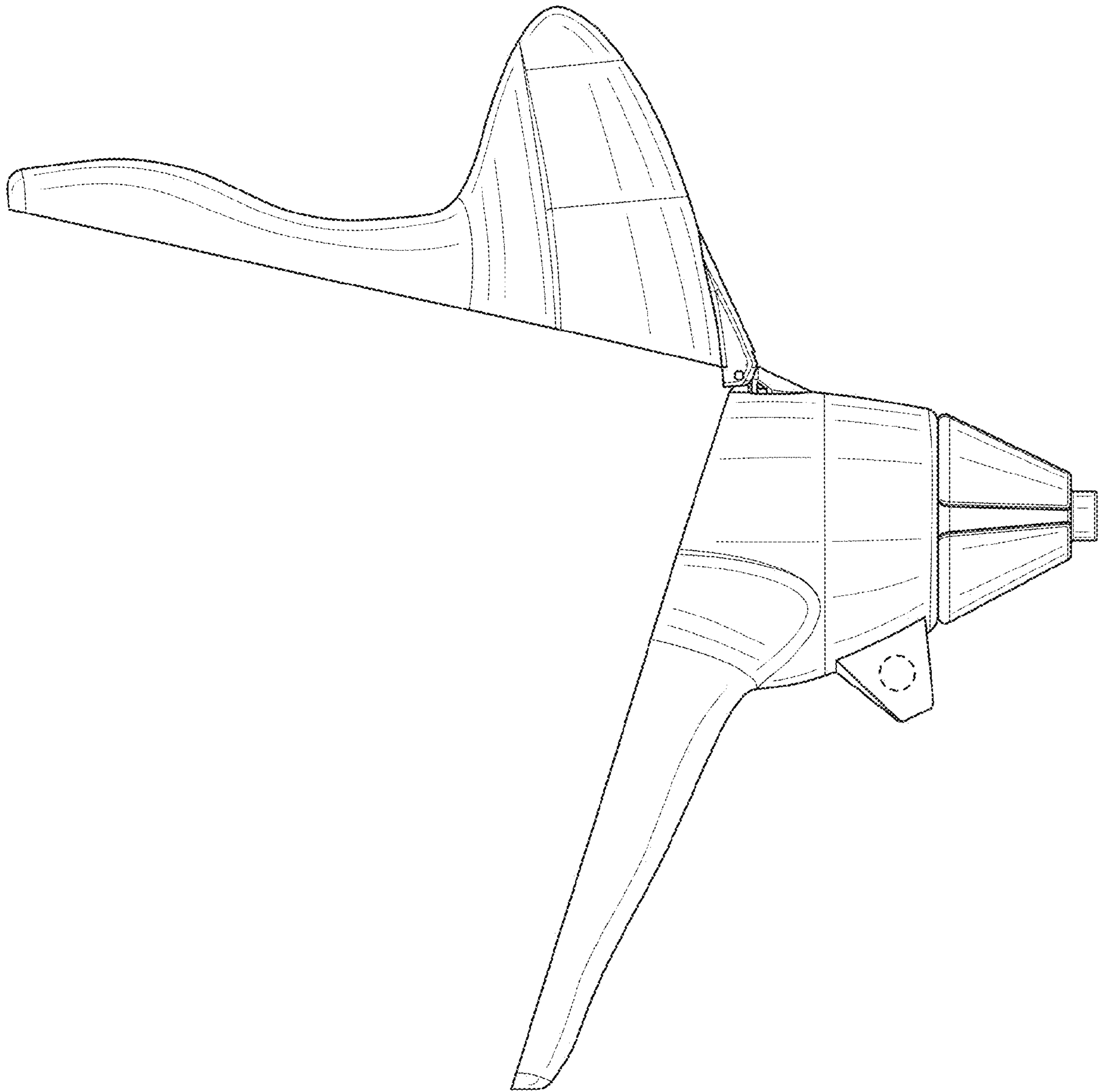

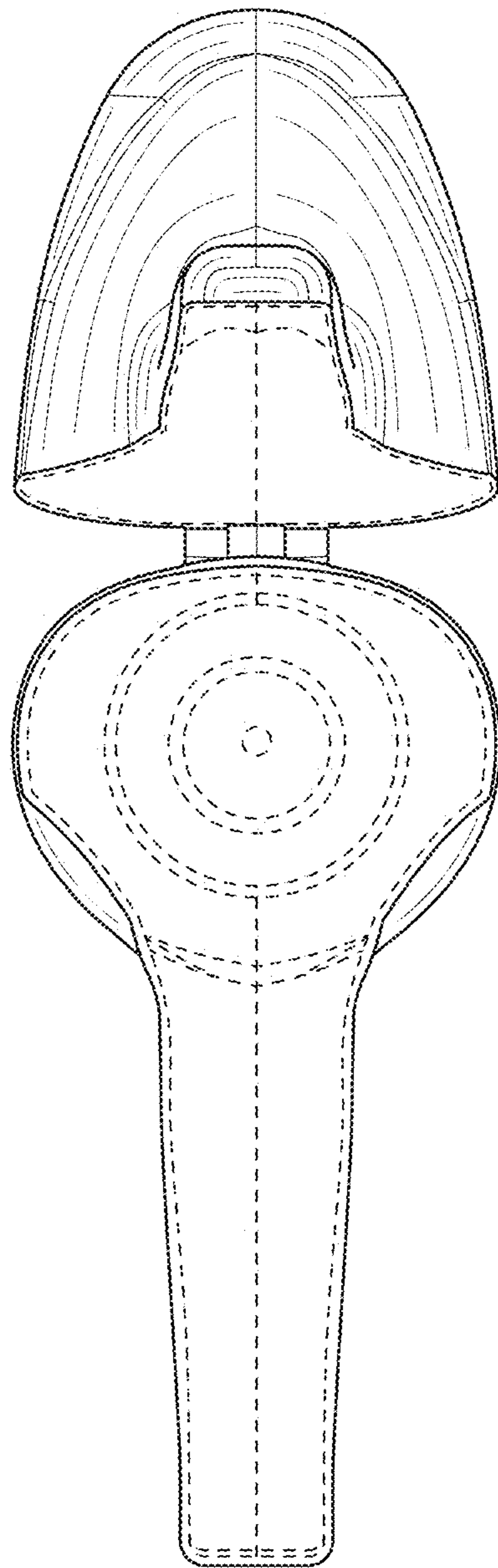

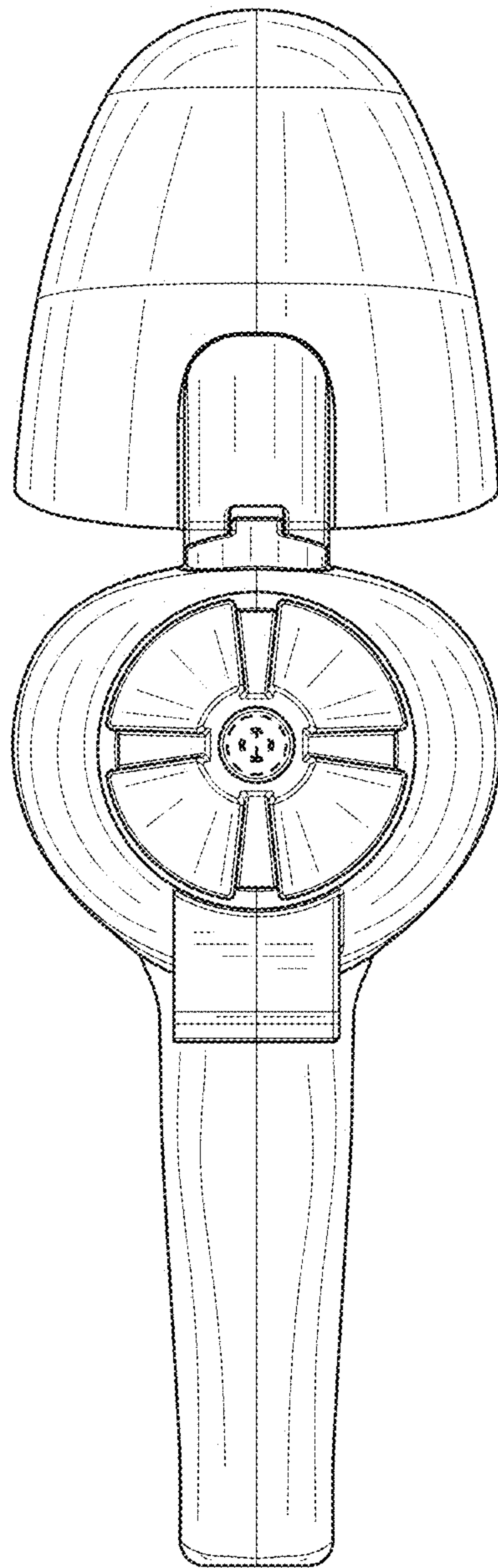

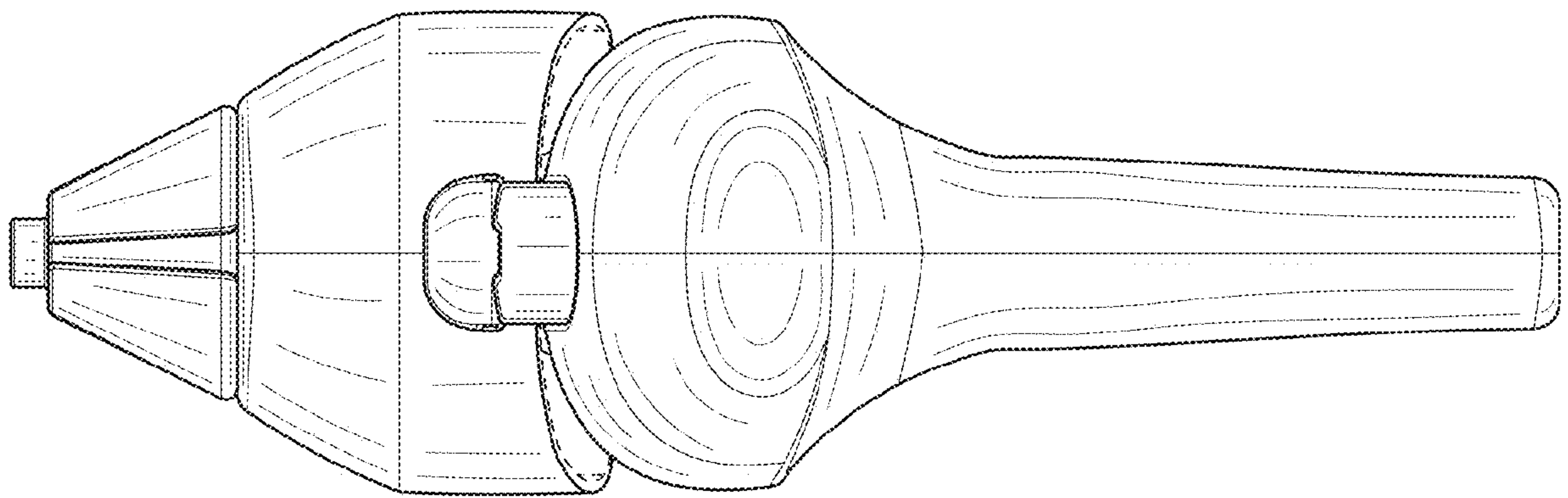

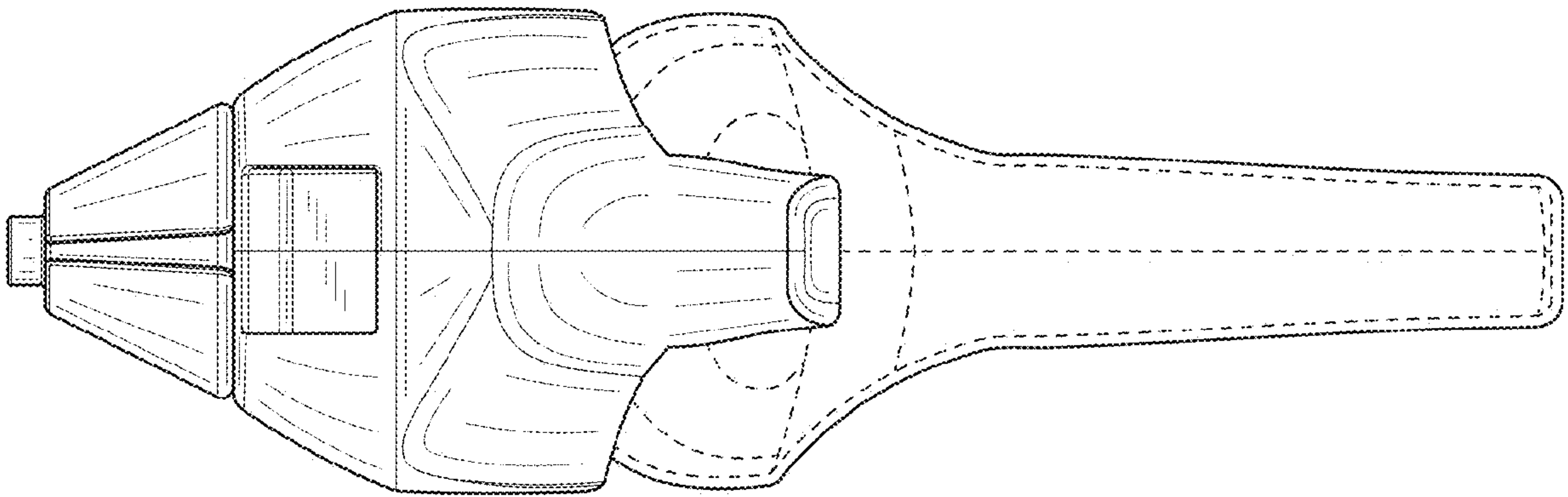
