The ornamental design for a revision stem, as shown and described.

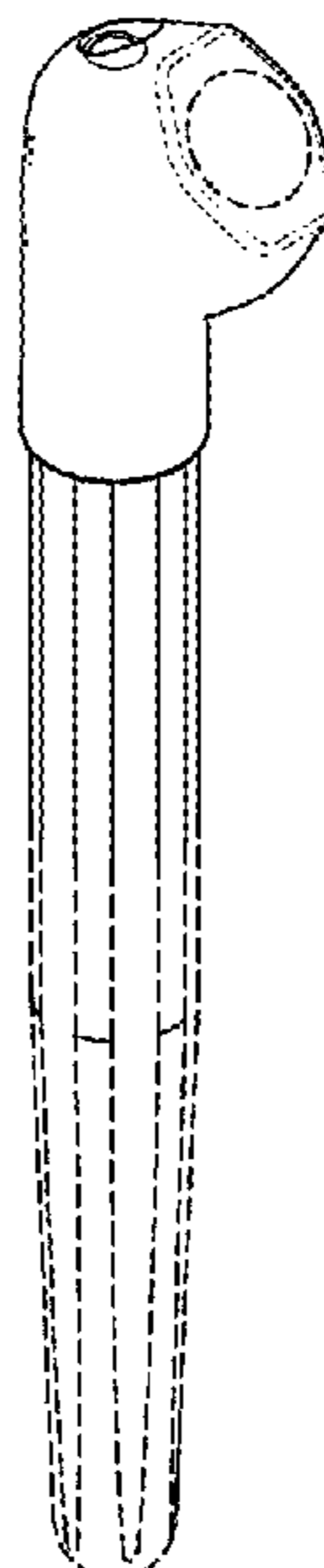
DESCRIPTION

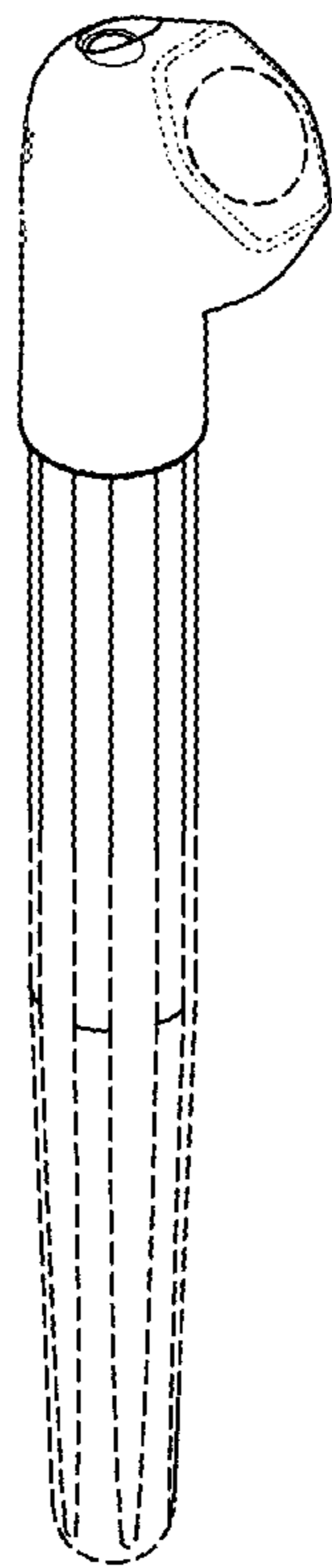

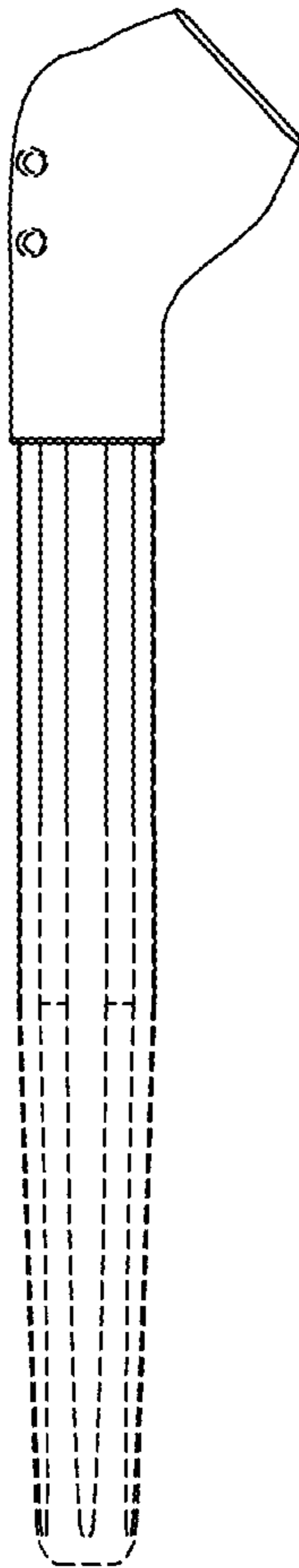

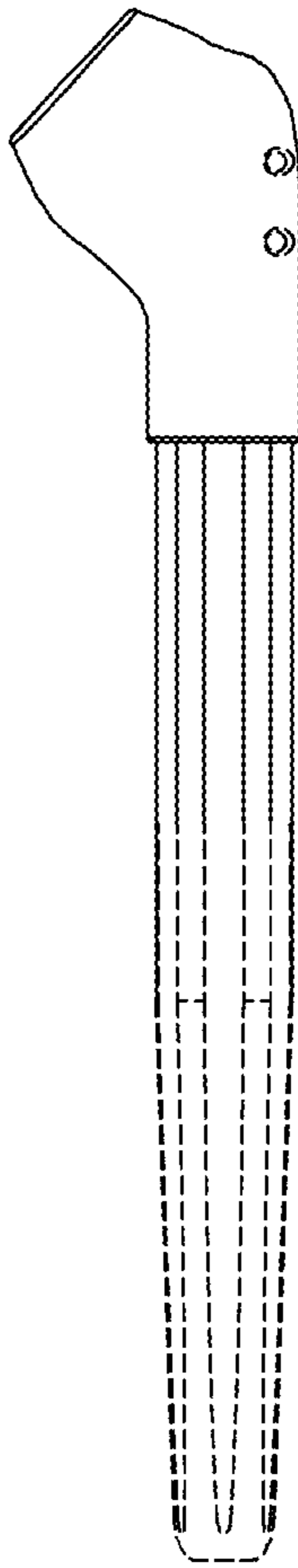

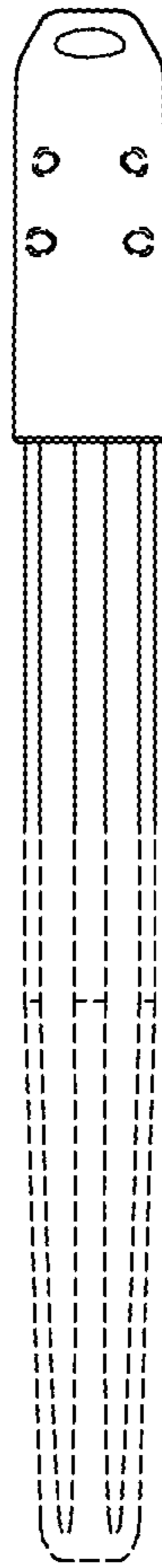

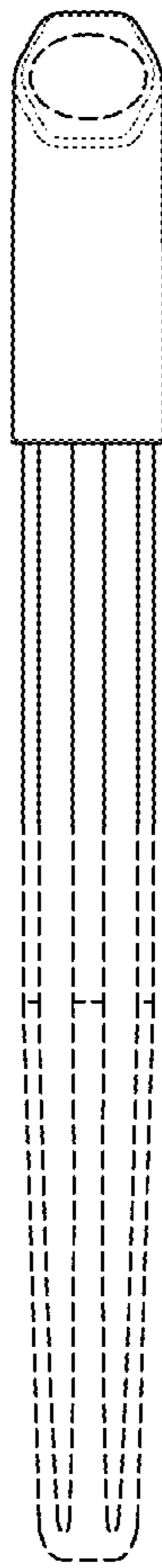

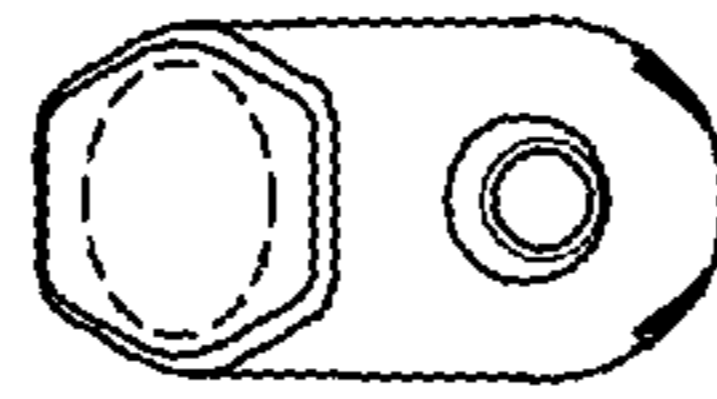

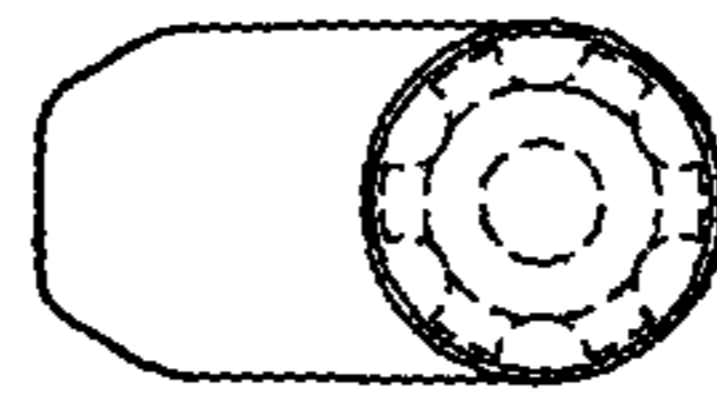
