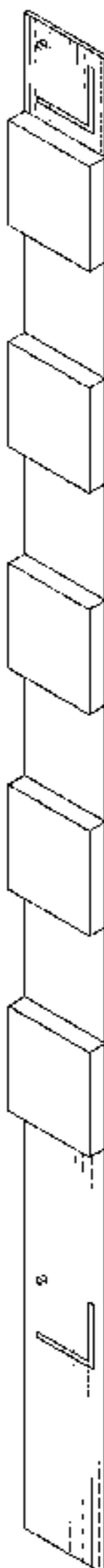
(57) **CLAIM**

The ornamental design for a test strip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a test strip showing our new design;  
FIG. 2 is a front view of the test strip of FIG. 1;  
FIG. 3 is a perspective view of another embodiment of the test strip showing our new design;  
FIG. 4 is a front view of the test strip of FIG. 3;  
FIG. 5 is a perspective view of another embodiment of the test strip showing our new design;  
FIG. 6 is a front view of the test strip of FIG. 5;  
FIG. 7 is a perspective view of another embodiment of the test strip showing our new design;  
FIG. 8 is a front view of the test strip of FIG. 7;  
FIG. 9 is a right side view of the test strips of FIGS. 1, 3, 5, and 7;  
FIG. 10 is a rear view of the test strips of FIGS. 1, 3, 5, and 7;  
FIG. 11 is a left side view of the test strips of FIGS. 1, 3, 5, and 7;  
FIG. 12 is a top plan view of the test strips of FIGS. 1, 3, 5, and 7;  
FIG. 13 is a bottom plan view of the test strips of FIGS. 1, 3, 5, and 7; and,  
FIG. 14 is an enlarged view of the area circled in FIG. 2. The broken lines forming the circle in FIG. 14 and FIG. 2 depict the bounds of the enlarged areas and form no part of the claim. The other broken lines depict coded data portions of the test strip that form no part of the claim.

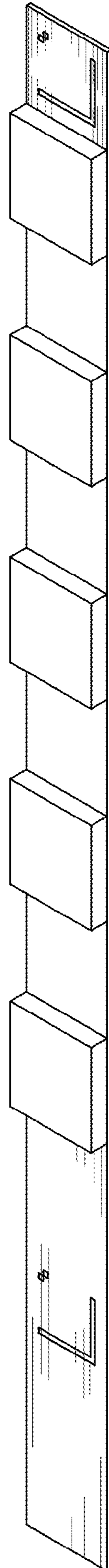

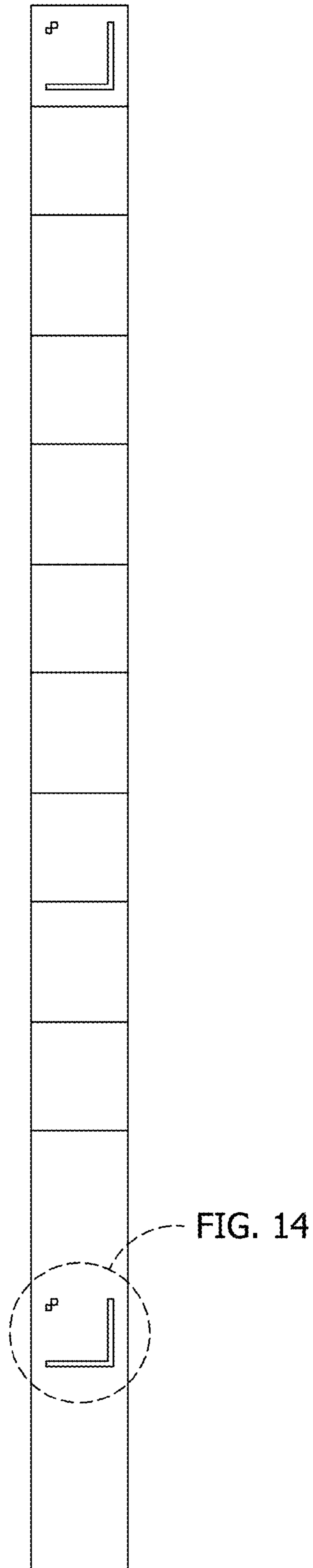

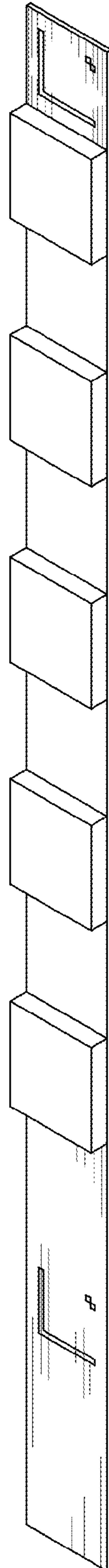

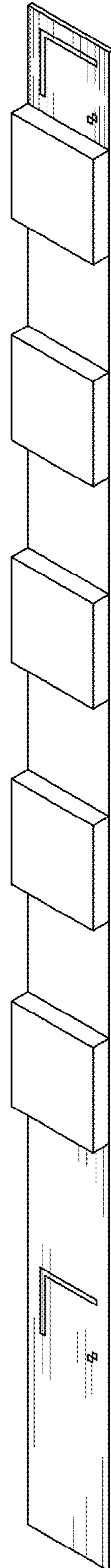

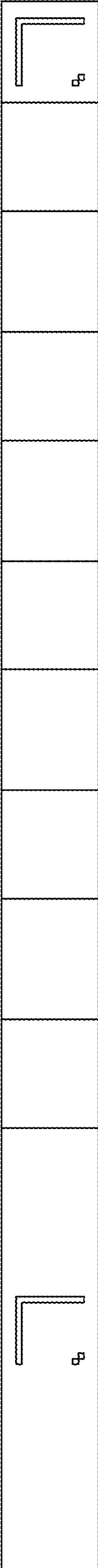

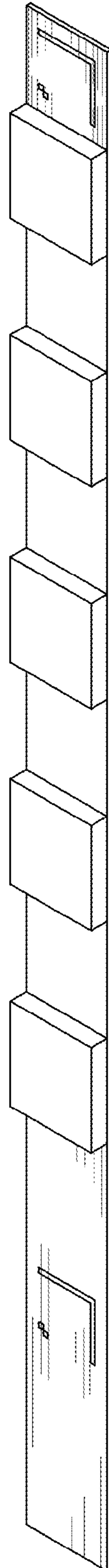

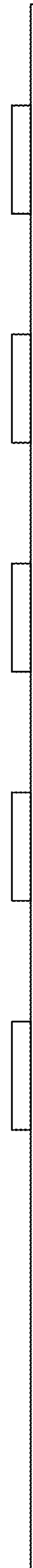

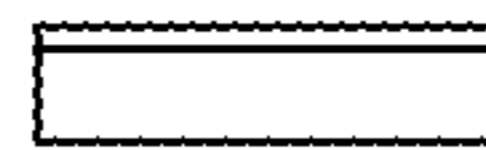

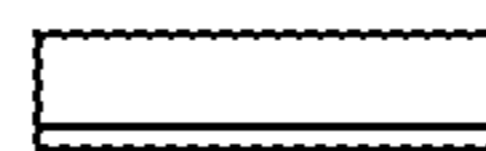
