DESCRIPTION

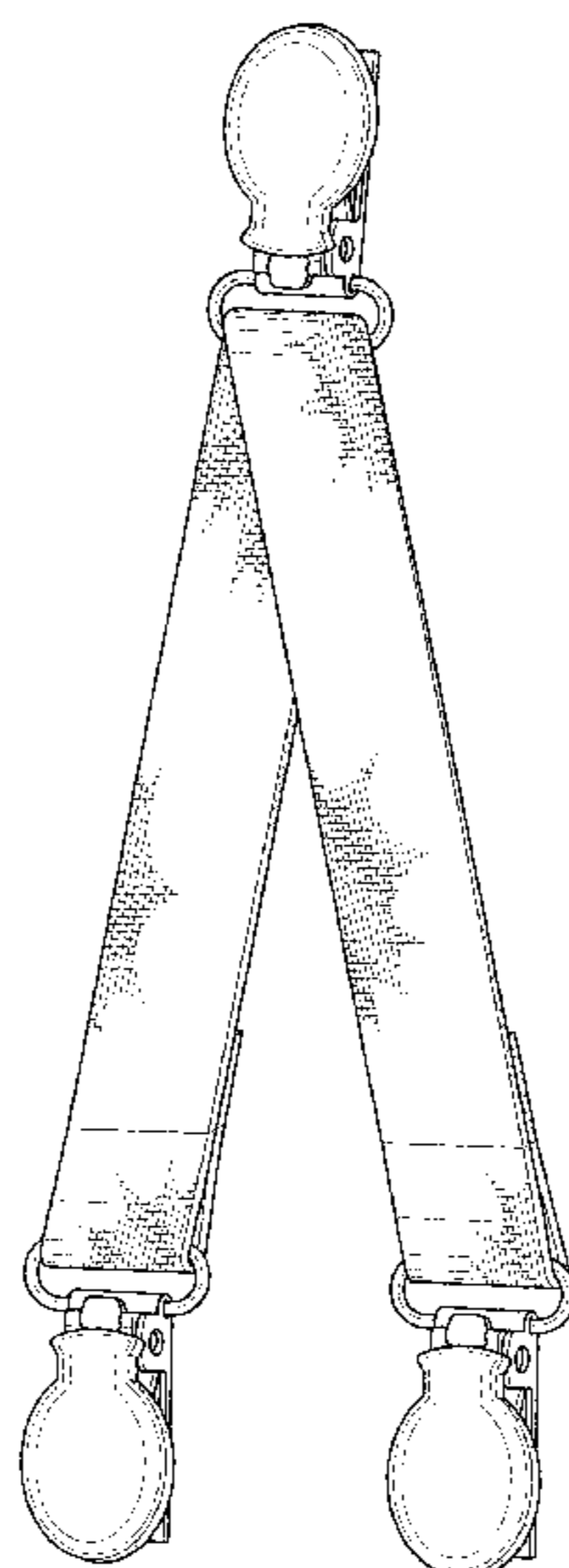
FIG. 1 is a perspective view of the ornamental design for a single-sided suspender showing my new design.

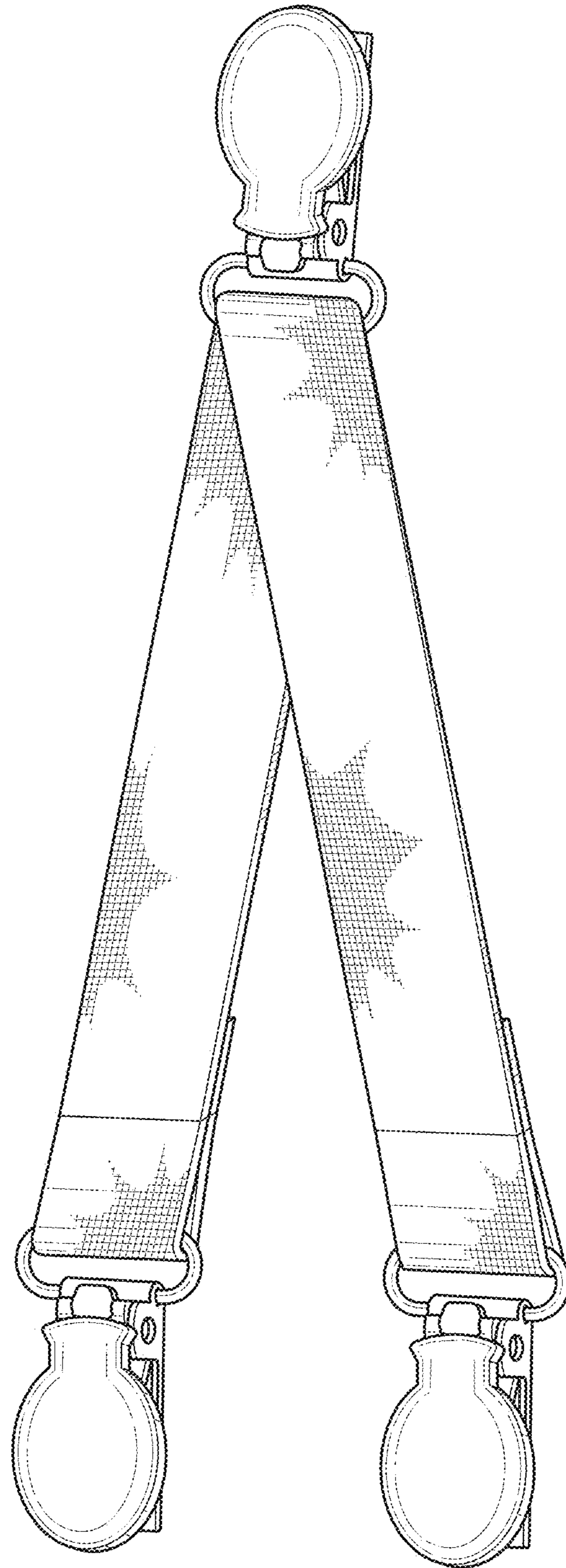

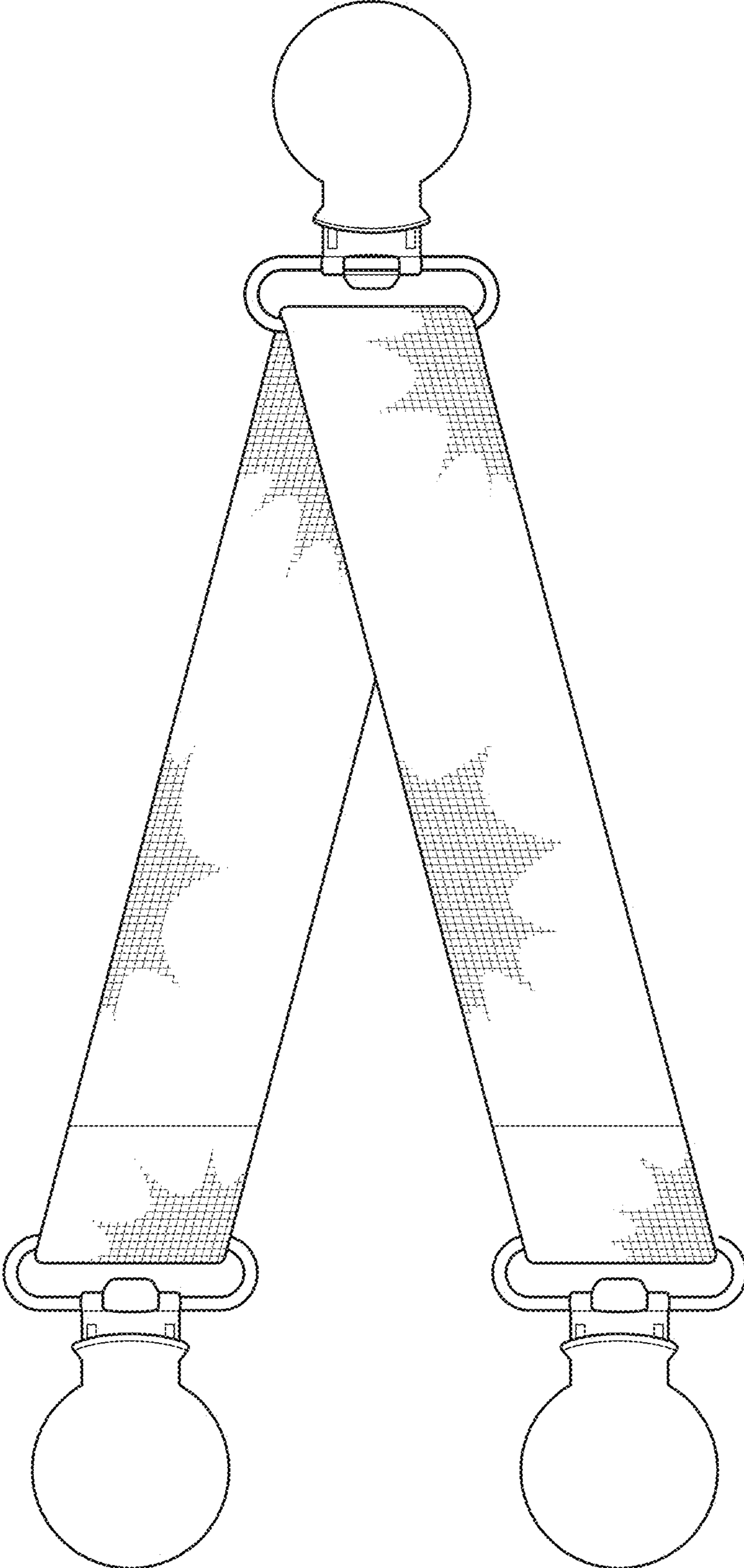

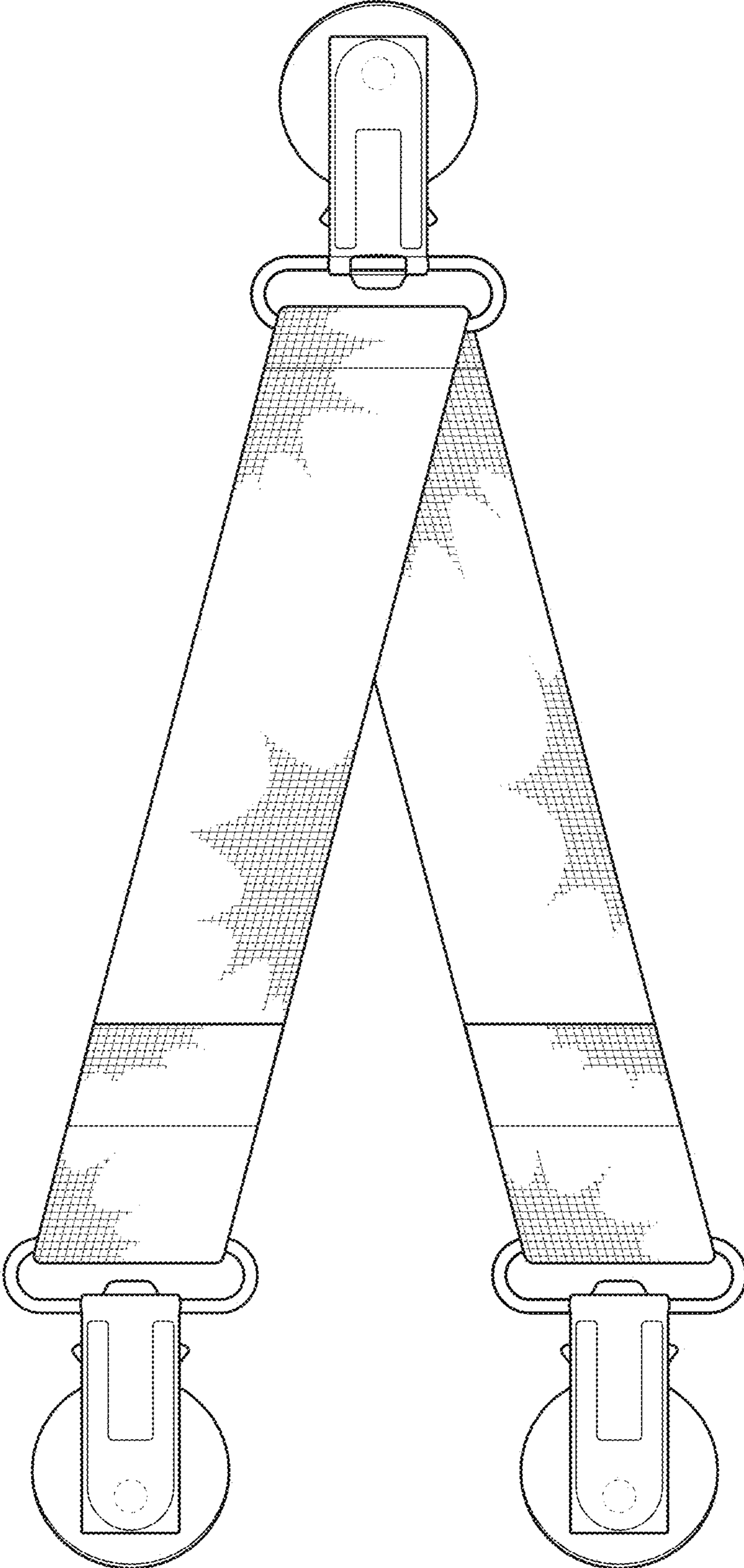

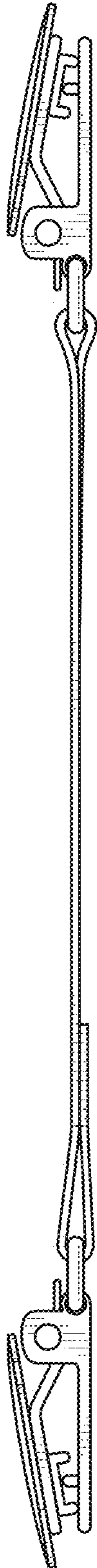

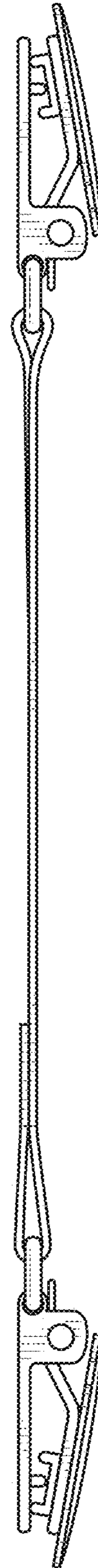

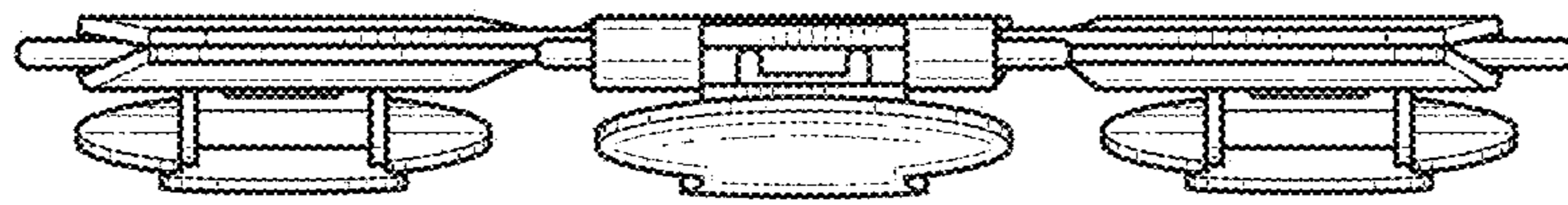

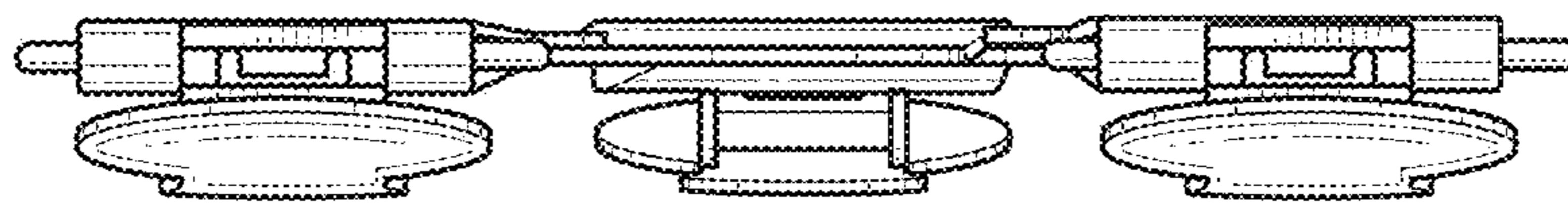
