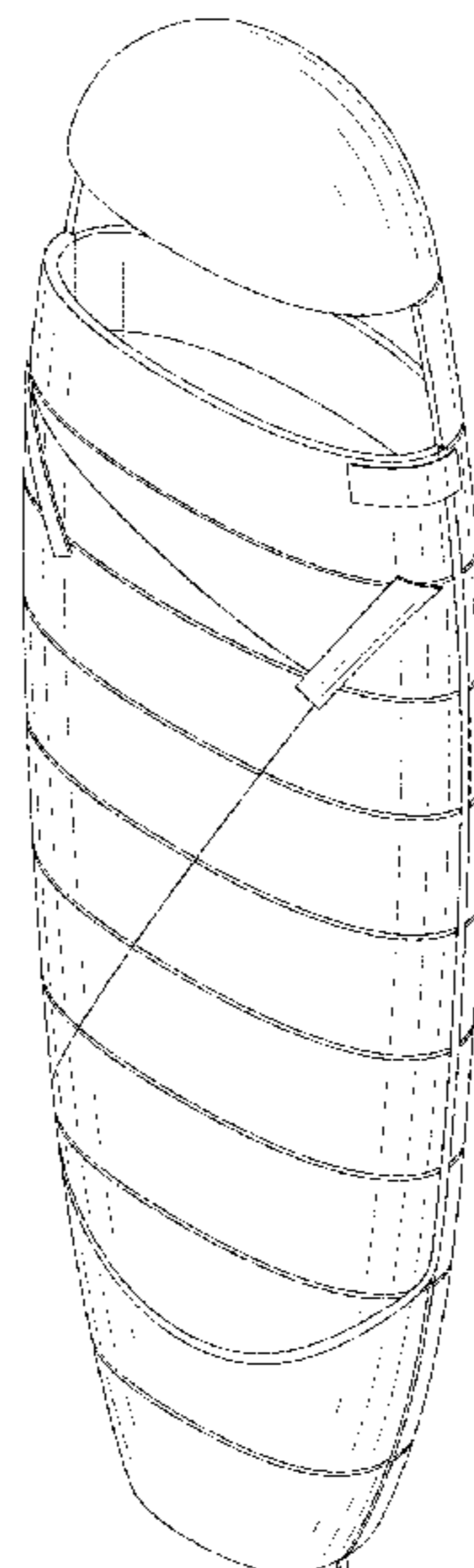
(57) **CLAIM**  
The ornamental design for a camping sleeping bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a camping sleeping bag showing my design;  
FIG. 2 is a second perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a back view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof;  
FIG. 7 is a top view thereof;  
FIG. 8 is a bottom view thereof;  
FIG. 9 is a perspective view of another state of the camping sleeping bag thereof; and,  
FIG. 10 is an enlarged view of the selected portion in FIG. 8.

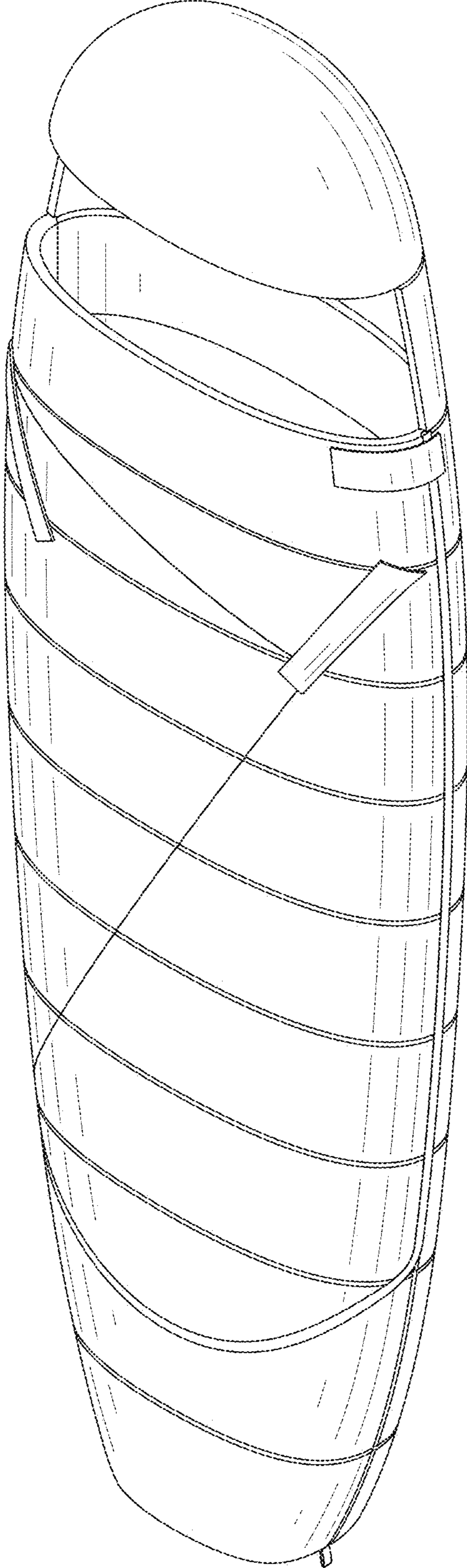

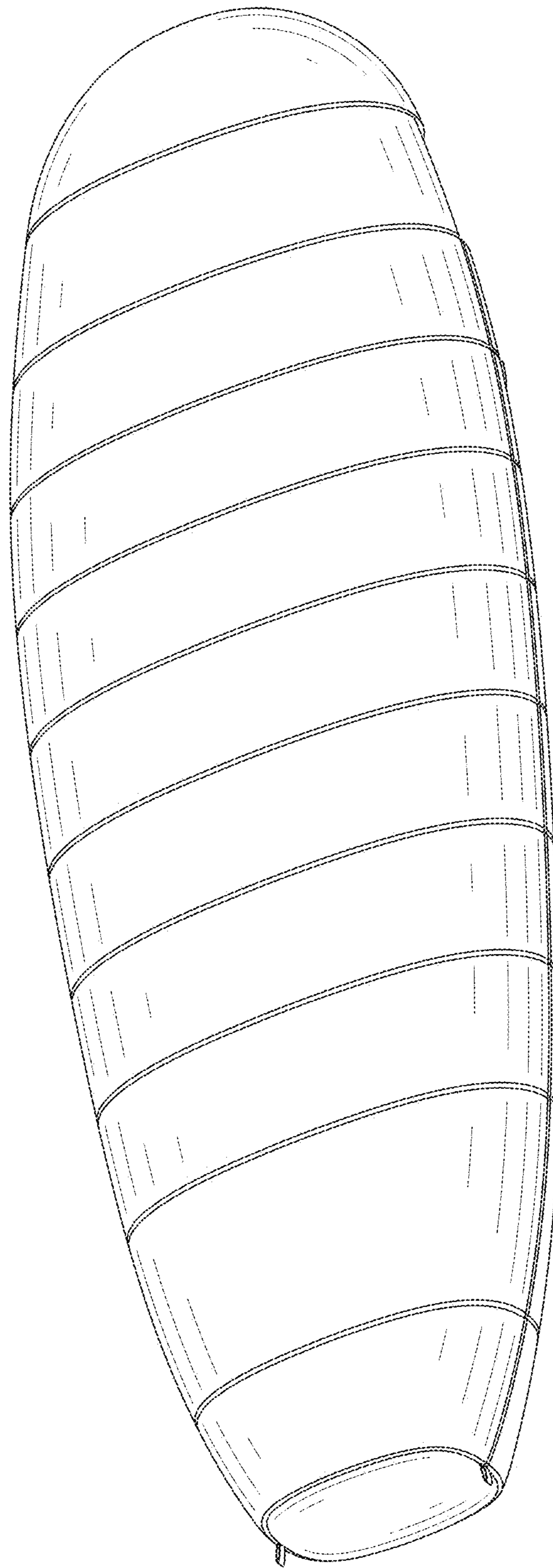

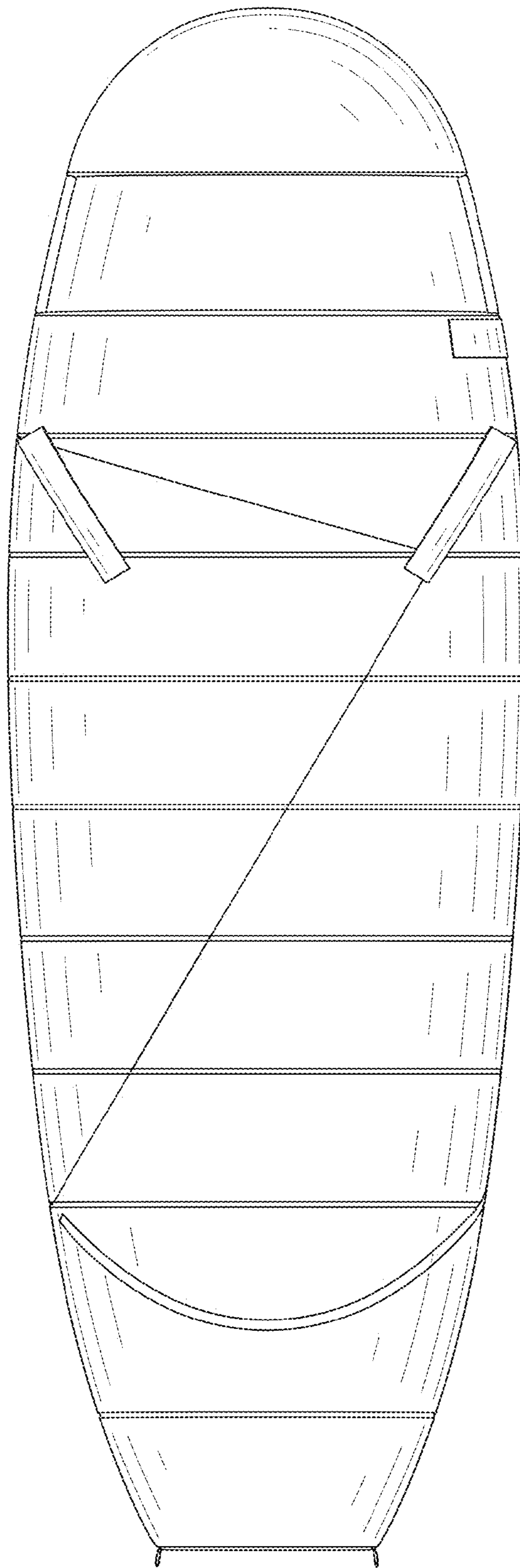

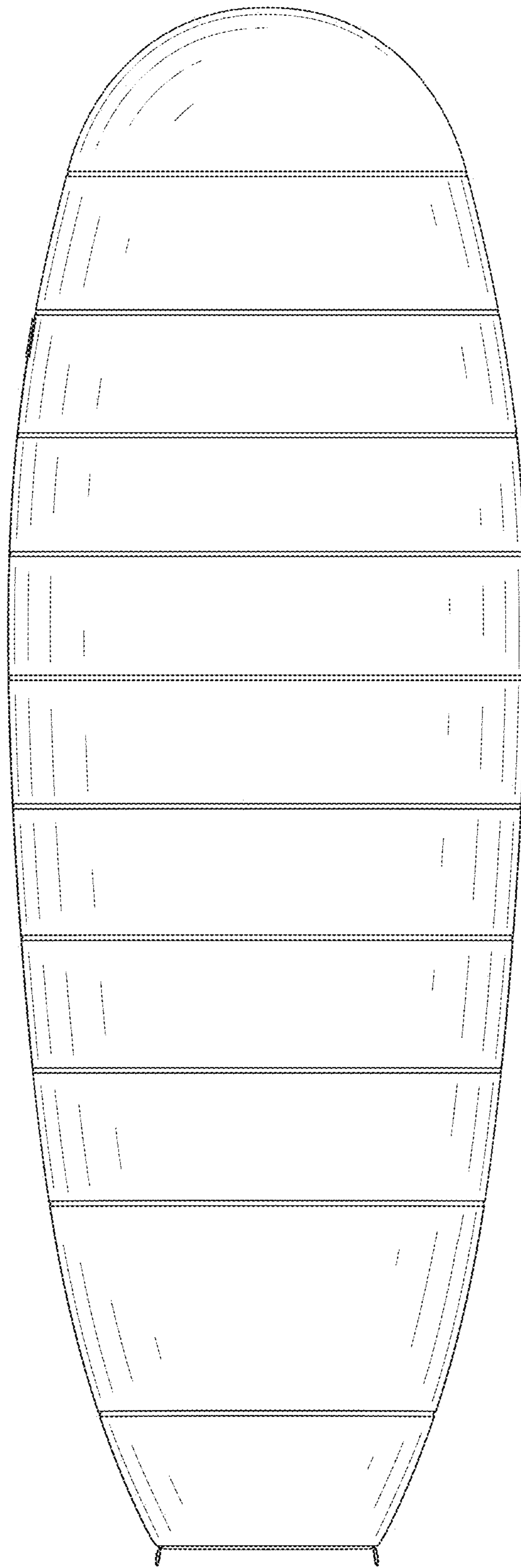

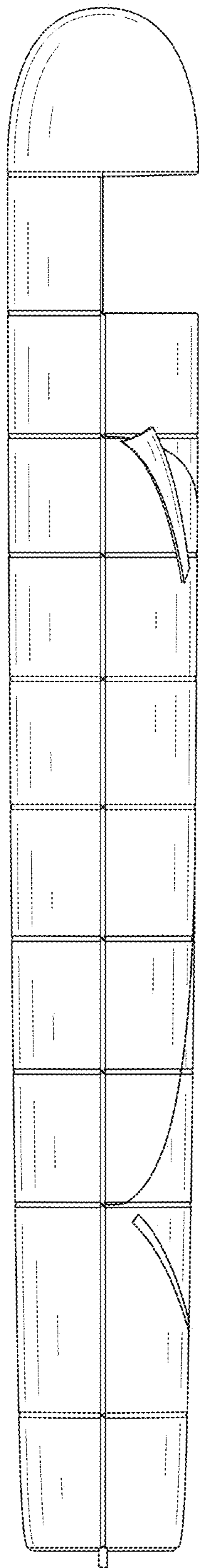

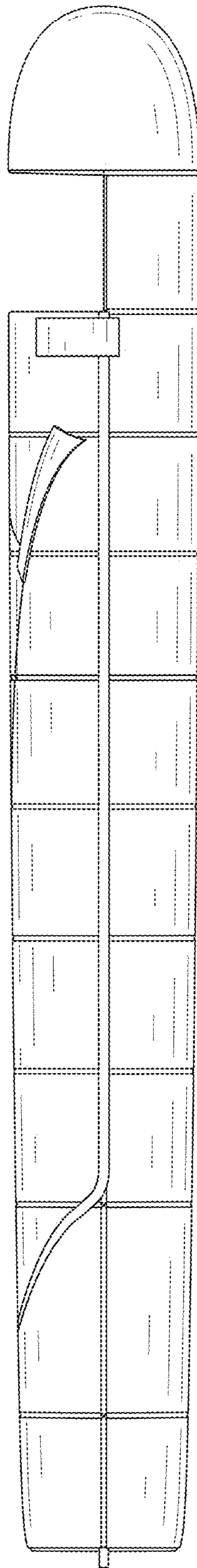

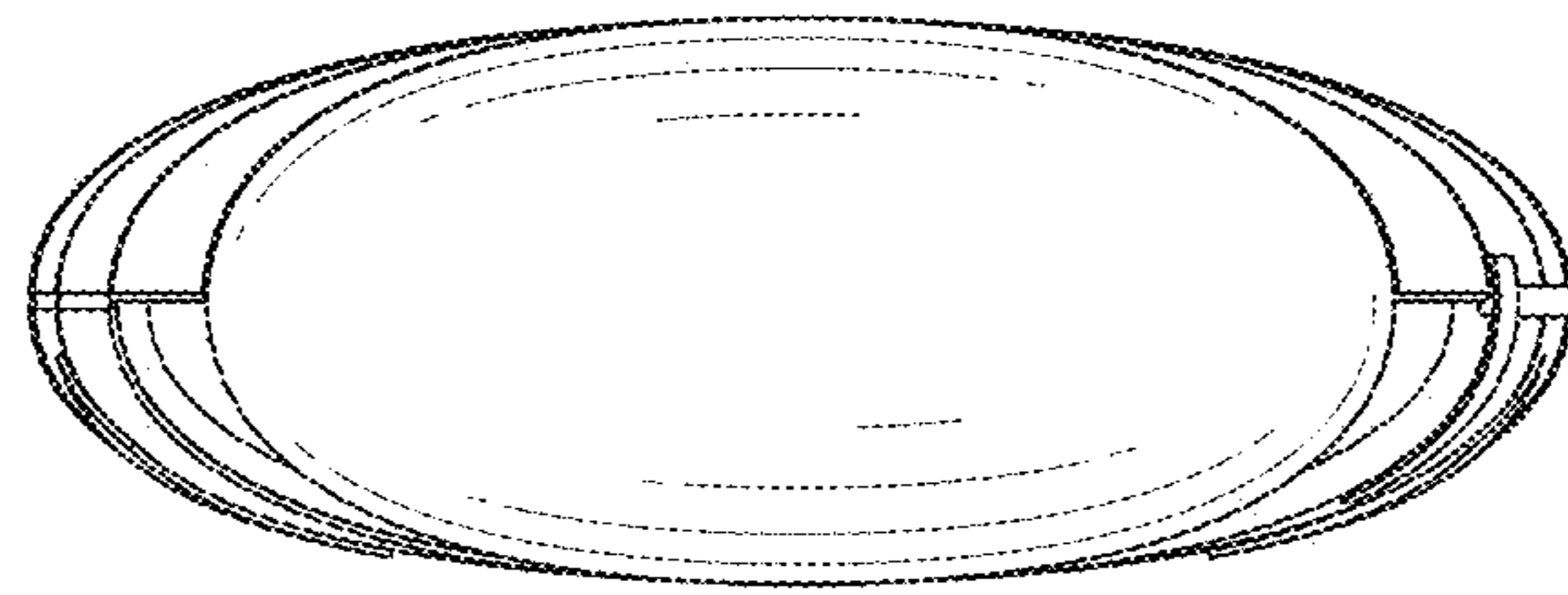

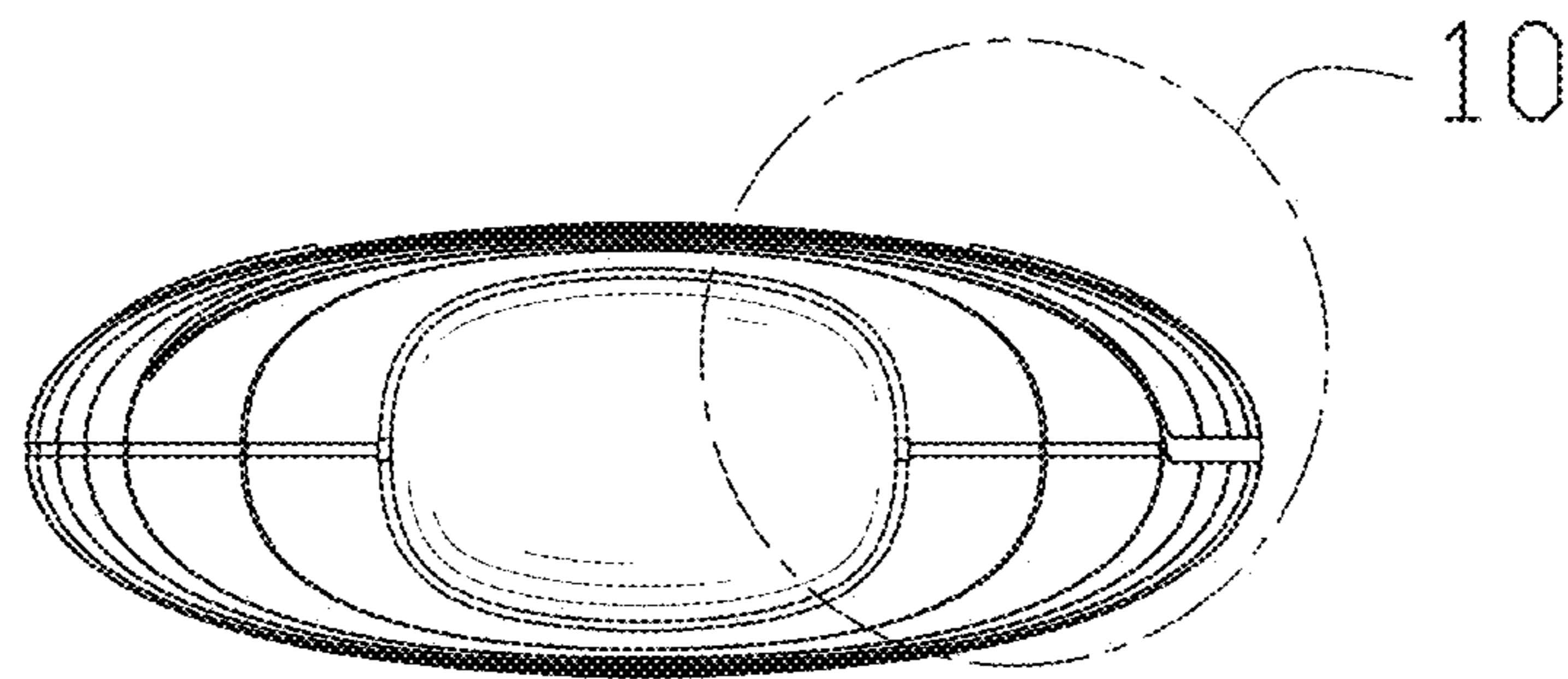

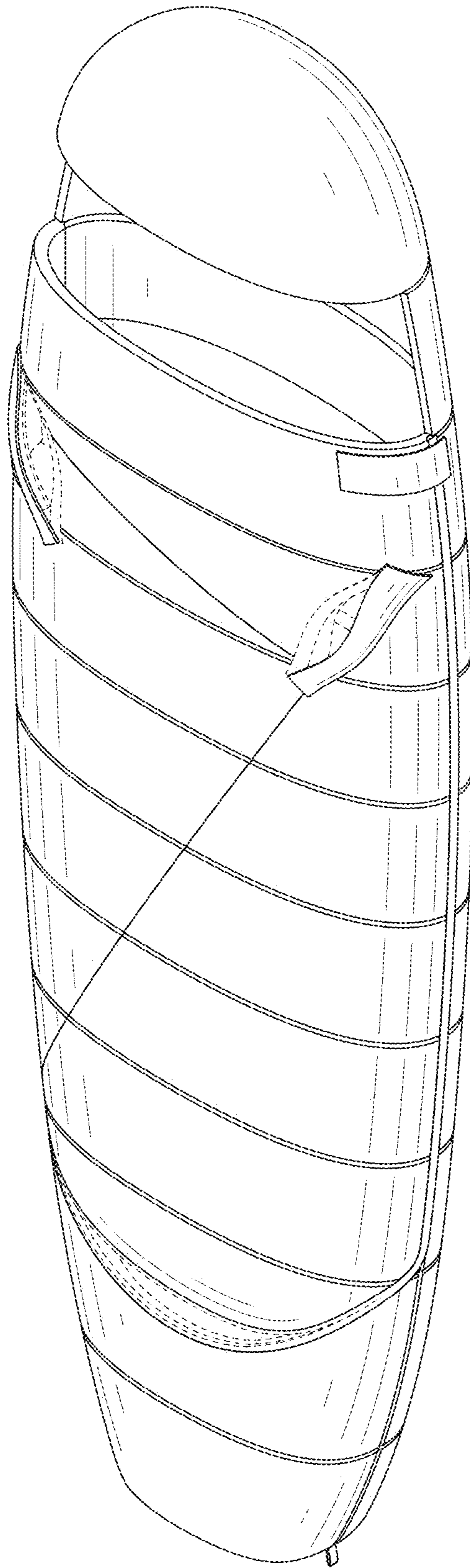

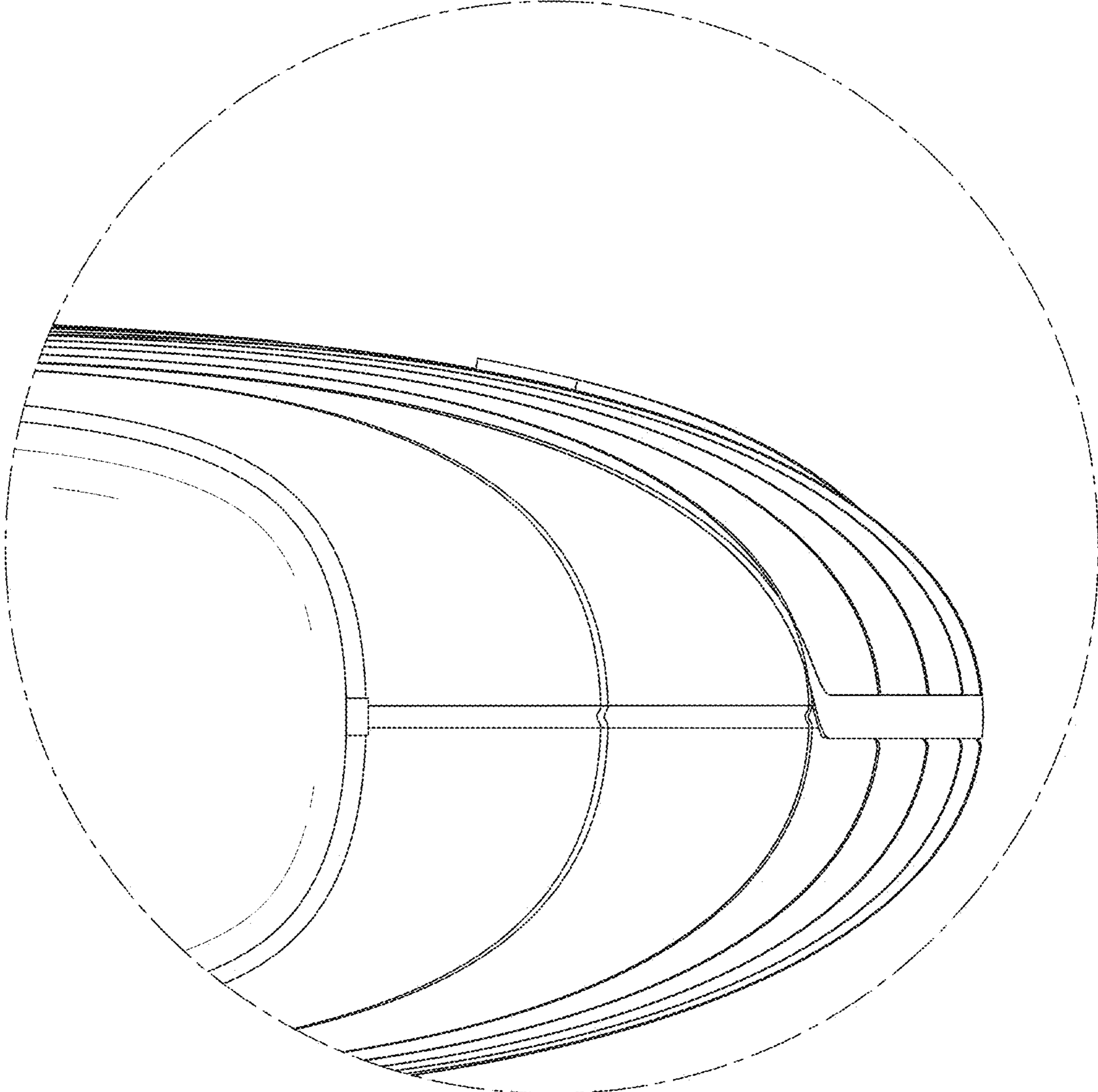
